After 28 days, Rhea Chakraborty steps out of jail MUMBAI, OCT 7 (PTI): The Bombay High Court

on Wednesday granted bail to actor Rhea Chakraborty in a drugs case related to her boyfriend Sushant Singh Rajput's death.

The court rejected the argument that celebrities deserve specially harsh treatment in such cases so as to 'send out a message'.

After spending 28 days in jail, Rhea stepped out of the Byculla women's prison here around 5.30 pm amid a scrum of mediapersons.

While granting her bail on a personal bond of Rs one lakh, the court asked the actor to appear before the Mumbai police for 10 days and before the Narcotics Control Bureau (NCB, which had arrested her) once a month for the next six

Justice Sarang Kotwal of the HC also granted bail to Rajput's domestic aides Dipesh Sawant and Samuel Miranda, but rejected the bail plea of Rhea' brother Showik Chakraborty.

The court also rejected the bail plea of alleged drug peddler Abdel Basit Parihar.

The HC observed in its order that Rhea did not have any criminal antecedents, and it was unlikely that she would tamper with evidence or affect the probe while out on bail.

Rhea, however, can't leave Mumbai without the NCB's permission and for traveling outside the country, she will need permission from the special NDPS court here, the HC said.

The NCB has charged Rhea under the stringent Section 27-A of the Narcotic Drugs and Psychotropic Substances (NDPS) Act that pertains to "financing and harbouring illegal drug trafficking". It entails imprisonment up to 10 years in prison and a bar on the grant of bail.

The HC said simply paying for a particular drug transaction does not qualify as financing drug traffic.

"The allegations against the applicant of spending money in procuring drugs for Sushant Singh Rajput will not, therefore, mean that she had financed illicit traffic," the court said.

It also noted that harbouring an offender as described under the Act would mean providing money for that person's drug consumption while also giving him shelter and food.

Rajput, for whom Rhea allegedly procured drugs, had no apprehension of arrest and therefore, the charge of harbouring too could not be applied, it said.

The court also dismissed the argument that Rhea's bail be rejected to `send out a strong message' to society.

"The learned ASG (additional solicitor general) had argued that celebrities and role models should be treated harshly so that it sets an example for the young generation...

I do not agree," Justice Kotwal said.

"Everybody is equal before law. No celebrity or role model enjoys any special privilege before the court of law.

Similarly, such person also does not incur any special liability when he faces law in the courts," he said. The HC, however, rejected the bail plea of Rhea's brother Showik.

"The applicant (Showik) was facilitating procurement of drugs from one party for supplying them to Sushant Singh Rajput. He was clearly involved in illicit trafficking or illegal trade of drugs," the court said.

"The applicant appears to be an important link in the chain of drug dealers. He was in touch with different dealers.

He had monetary transactions with the," the court said

Justice Kotwal also held that a detailed interpretation of the NDPS Act and previous judgments of the Supreme Court showed that all offences under the Act were non-bailable. Also, section 27-A can be invoked even if quantity of the drug is not "commercial", the judge said.

However, in Rhea's case, since there was no financing or harbouring (of drugs or its consumers), Section 27-A could not be applied, the HC said.

Granting bail to Miranda and Dipesh Sawant, the court said they had simply procured or collected drugs on directions of Rajput or Rhea.

Rhea's lawyer Satish Maneshinde said that "truth and justice have prevailed". "The hounding and witch-hunt by three central agencies-the CBI, ED and NCB -- of Rhea should come to an end. We remain committed to truth," he said.

Rajput, 34, was found hanging at his apartment in suburban Bandra on June 14. After a case of alleged abetment of suicide was registered against Rhea by Rajput's parents, a parallel probe into alleged drug procurement by her also began on the basis of her WhatsApp chats.

COVID death toll reaches 51

The COVID-19 related death toll has crossed the 50-mark in the State and stands at 51 with two deaths reported in Sikkim on Wednesday. A 32-year-old female from Lower Rongong in North Sikkim and a 34-year-old ITBP personnel posted in North Sikkim lost their lives today.

In the daily health bulletin on Wednesday, **Health Department State** IEC Officer, Sonam G Bhutia mentioned that a 32-year-old female from Lower Rongong in North Sikkim, who had tested positive in RT-PCR on 03 October and was admitted in the COVID ICU of STNM hospital, passed away at around 2 PM this afternoon.

He informed that the patient was undergoing treatment in a nursing home at Siliguri and was also on ventilator. The family had brought her back to Sikkim and she was found positive for COVID-19 in RT-PCR test-



ing. He added that she had comorbid conditions of sepsis, pneumonia with respiratory distress and TB meningitis.

Likewise, Mr Bhutia informed that a 34-yearold ITBP personnel from Maharashtra who was posted in North Sikkim was brought to STNM hospital this morning and was admitted in the

ICU facility but he passed away at around 3:45 PM this afternoon. He mentioned that the patient had COVID induced pneumonia and respiratory distress.

In the meantime, 18 fresh cases of novel coronavirus have been reported in the State in the last 24 hours taking the total number of confirmed cases of COVID-19 reported so far to 3234 in Sikkim.

The figure of discharged patients of COVID-19 in the State has improved to 2534 with the discharge of 14 more patients from isolation facilities. At present, there are 570 active cases of novel coronavirus in the State, in which eight are currently admitted in the ICU facility of STNM

hospital. All 18 new cases of novel coronavirus in the State were found in rapid antigen testing of 48 samples on Tuesday. There was no RT-PCR testing on Tuesday as VRD Lab has been contained, while all eight samples tested by TrueNat reported negative for COVID-19.

Out of 18 new cases, 17 have been reported in East District and 01 in South District.

While giving details of new cases, Mr Bhutia mentioned that one person from Boomtar Namchi in South District tested positive for COVID-19. He informed that two staff of Singtam District Hospital were also found COVID-19 positive.

He added that samples of a person from above Tamang Gumpa in Development Area, one from near Enchev Monastery in Chandmari, one from opposite SBC on Tadong School road, two from near Puspha Garage in Development Area, two from Daragaon, one from Deorali, one from DPH Area, one from Joredhara and two from Ranipool were also found COVID-19 positive.

Mr Bhutia informed that one person from Rhenock and one from Chujachen also tested positive for COVID-19 in

Mumbai adds record 2,848 new COVID-19 cases; 46 die MUMBAI, OCT 7 (PTI): Mumbai on Wednesday reported the highest single-day spike of 2,848 new COVID-19 cases, taking the total count of infections to 2,19,938, the Brihanmumbai Municipal Corporation (BMC) said.

With 46 fatalities, the cumulative toll went up to 9,245, it said.

The previous record spike of 2,654 cases in Mumbai was reported on September 30.

The daily number of new cases in the last two days remained below 1,900, after reporting over 2,100 infections for five consecutive days ear-

Notably, the BMC has also crossed the milestone of conducting 12 lakh tests on Wednesday.

Mumbai's case recovery rate is 83 per cent now, the BMC said, adding that the number of recoveries stood at 1,83,742 with 2,257 people being allowed to go home in the last 24

The city's average growth rate of cases is 1.04 per cent while the average doubling rate is 67 days. The number of active cases stands at 24,783, it said.

Meghalaya reports 128 new COVID-19 cases, tally 7,165

SHILLONG, OCT 7 (PTI): At least 128 people tested positive for COVID-19 in Meghalaya on Wednesday, pushing the tally to 7,165, a senior health department official said.

East Khasi Hills, of which state capital Shillong is a part, continues to be the worst-affected region with 72 new cases. The district has 1,693 active cases, and recorded 55 of the total 60 coronavirus fatalities in the northeastern state, Health Services director Aman War said.

Ri Bhoi accounted for 33 new cases, followed by West Garo Hills at 11. Four cases were registered in East Garo Hills, two each in West Jaintia Hills and East Jaintia Hills, and one in North Garo Hills.

Altogether 88 patients were found to have been cured of the viral infection on Wednesday, increasing the total number of recoveries to 4.694.



Highest single-day spike of 10,947 cases in Karnataka



BENGALURU, OCT 7 (PTI): Karnataka on Wednesday reported its highest single-day spike of over 10,900 COVID-19 cases and 113 fatalities, taking the total number of infections to 6,68,652 and the toll to 9,574.

The day also saw 9,832 patients getting discharged after recovery and the active cases stood at 1,16,153, the health department said.

The number of samples tested in the state crossed the 55 lakh mark. On Wednesday a total of 1,04,348 tests were done, taking the cumulative to 55,24,302.

Out of the 10,947 cases reported on Wednesday, 5,000 were from Bengaluru Urban alone.

The previous biggest single-day spike was recorded on September 29 with 10,453 cases.

Cumulatively 6,68,652 COVID-19 positive cases have been confirmed in the state, which includes 9,574 deaths and 5,42,906 discharges, the department said in its bulletin.

Of the active cases, 1,15,312 patients are stable in isolation at designated hospitals, while 841 are in Intensive Care Units.

Amid a spike in cases,

corded 55 of the total of 113 deaths, followed by Mysuru (9), Dakshina Kannada and Uttara Kannada (7), Hassan and Tumakuru (5), Kolar (4), Bagalkote and Ramanagara (3), Bengaluru Rural, Dharwad, Haveri and Udupi (2), and Belagavi, Bidar, Chamarajanagara, Chikkamagaluru, Kalaburagi, Kodagu and Vijayapura (1).

Most of the deceased were either with a history of Severe Acute Respiratory Infection (SARI) or Influenza-like illness (ILI), the bulletin said.

Among the districts where new cases were reported, Bengaluru Urban accounted for 5,000, Mysuru 979, Hassan 471, Uttara Kannada 462, Dakshina Kannada 447, Ballari 258, Tumakuru 250, Chitradurga 217, Udupi 209, Mandya 207, followed by others.

Bengaluru topped districts in both positive cases and discharges -- 2,62,241 and 2,00,426.

Mysuru has 39,590 positive cases and Ballari, 33,515.

MoU between ZSI & iBOL

New Delhi, Oct 7 (PTI): The Union Cabinet on Wednesday approved a Memorandum of Understanding between India's Zoological Survey of India (ZSI) and Canada's not-for-profit organisation International Bar-

code of Life (iBOL). The Union Cabinet, chaired by Prime Minister Narendra Modi gave its nod to the MoU, which was signed in June, 2020 between ZSI, a subordinate organization under Ministry of Environment, and iBOL, a statement said.

ZSI and iBOL have come together to further efforts in DNA barcoding, a methodology for rapidly and accurately identifying species by sequencing a short segment of standardized gene regions and comparing individual sequences to a reference database, it said.

iBOL is a research alliance involving nations that have committed both human and financial resources to enable expansion of the global reference database, the development of informatics platforms, and/or the analytical protocols needed to use the reference library to inventory, assess, and describe biodiversity.

The MoU will enable ZSI to participate in global level programmes like Bioscan and Planetary Biodiversity Mission, it added.

Kyrgyzstan annuls parliamentary election results amid unrest

Moscow, Oct 7 (AP): Officials in Kyrgyzstan on Tuesday nullified the results of a weekend parliamentary election after mass protests erupted in the capital of Bishkek and other cities, with opposition supporters seizing government buildings overnight and demanding a new vote.

Hundreds of people were injured, one fatally. Members of several

opposition parties announced plans to oust the president and form a new government in the Central Asian country.

The decision to cancel the results of Sunday's vote was made to prevent tension, Central Commission head Nurzhan Shaildabekova told the Interfax news agency.

Protests broke out in Bishkek and elsewhere after authorities announced early returns in favor of two parties, one of which is said be closely aligned with President Sooronbai Jeenbekov and another linked to a former top customs official, amid reports of vote-buying and other election fraud.

Boronov himself hasn't made any statements about resigning yet, and it wasn't immediately clear if the changes by the lawmakers were legal. Jeenbekov also hasn't commented on the moves, saying in an interview released Tuesday evening only that he was ready for talks with the opposition as a legitimate president.

NEW DELHI, OCT 7 (PTI): Aviation regulator DGCA issued detailed guidelines on Wednesday regarding a refund of the ticket price for the flights cancelled amid the coronavirus-triggered lock-

The guidelines came six days after the Supreme Court directed that a full and immediate refund should be given to passengers for the air tickets cancelled between March 25 and May 24. No domestic passenger flights operated in the country in this period.

The top court had, on October 1, also passed directions about the refund and credit shell formation for the bookings and cancellations done during the other time periods around the lock-Based on the court

order, the DGCA categorised passengers in three categories -- those who booked tickets between March 25 and May 24 for travelling within the same period, those who booked tickets prior to March 25 but the travel period was till May 24, those who booked tickets anytime but for a journey post May 24.

The regulator said the passengers belonging to the first category must be given a full refund by the airline concerned for the tickets cancelled.

The Directorate General of Civil Aviation (DGCA) said the airlines should "make all endeavours" to refund the passengers belonging to the second category within 15 days.

"If on account of financial stress, any airline/airlines are not able to do so, they shall provide a credit shell equal to the amount of fare collected (to the passenger)," it added

The passengers can then use the credit shells to book any ticket by March 31, 2021, the DGCA noted.

Those belonging to the third category will be given a refund in accordance with the existing DGCA rules.

The Indian aviation industry has been hit hard due to the coronavirus pandemic and as a result, all airlines in the country have opted for cost-cutting measures such as layoffs, leave without pay for the employees etc.

Scheduled domestic passenger flight services resumed in the country after a gap of two months on May 25. Currently, airlines are permitted to operate only up to 60 per cent of their pre-COVID domestic flights. Scheduled interna-

tional passenger flights continue to remain suspended in the country since March 23. However, special international passenger flights have been operating under the Vande Bharat mission since May and under air bubble arrangements formed with various countries since July.

Delhi govt allows restaurants to operate round-the-clock

(PTI): In a major relief to city restaurants amid COVID-19 outbreak, the Delhi government on Wednesday said they will be allowed to operate round-the-clock and the requirement of tourism licenses will be removed.

Setting an example of Delhi Model' of ease of doing business, the government also announced other measures such as initiation of a process to abolish police licenses and health trade licenses from local bodies for restaurants, an official statement said.

The decisions were taken at a meeting chaired by Chief Minister Arvind Kejriwal. The meeting was also attended by restaurants owners of the national capital.

The government said such steps will help the industry generate more employment in the city through higher demand, adding that this will set an example for the Delhi Model of ease of doing business.

"On the request of

NEW DELHI. OCT 7 restaurateurs to allow 24x7 business, it was agreed that the restaurants will be allowed to operate at all hours subject to the condition that they submit an undertaking that they will take care of the health and security of their entire staff," the statement stated.

> The chief minister also instructed that the health trade licenses issued by municipal corporations to the restaurant industries be abolished within 10 days, it said.

During the meeting, the excise department agreed to review the existing policy of a 10 per cent automatic increase in the license fees every

Deputy Chief Minister Manish Sisodia, who also attended the meeting, called for the restaurants to be able to pay their excise by March 31 from the existing deadline of February 28, and for them to make quarterly license fee payments without any interest, the statement added.

Reservations – Promoting Lethargy or Improving Access

Before the bouquet is increased, revisit why quotas were need

This section has discussed the issue of quotas and ■ reservations often, but given the near obsessive pursuit with which such "protection" is chased after, talking on this theme is perhaps never too much. So here goes one more. But a qualifier first - this publication believes that protection by way of reservations is still required in our country where gross inequality forced by accidents of birth and offensive prejudice directed against communities and regions still prevail. If anything, such extreme and irrationally hostile mindsets have seen a resurgence in recent years, reinforcing stereotypes and foisting easy partisanship. That is the reality we live with, but occasionally, as citizens of a free and secular nation, we can occasionally also aspire for more ideal scenarios to eventually arrive into.

This then, is as good a time as ever to delve into the near passionate ambition of all communities to get included in some category or the other. We have in our country, quite a wide range of categories to choose from - there is the Scheduled Tribes list, the Schedule Caste recognition, the OBC, now even MBC and some years ago, Bihar introduced us to the EBC grouping and one can rest assured that more such segregations will be dreamed up in the coming years as privileged communities which still dominate have someone made political currency out of their imagined persecution. It is that situation where the traditionally privileged, get frightened and feel threatened as more of the underdogs rise above the conditions of their birth through hard work and some hand-holding. To them, growing equality feels like oppression. Unfortunately, no one tells them otherwise because "reservation" has now become an aspiration that every citizen feels a right to aspire towards and has become an easy springboard to launch political careers from.

So, why the categorizations?

Given the history that India had emerged from in 1947, where caste alienation was extreme and tribals genuinely under-privileged and oppressed, a policy was required to overcome a legacy of injustice and to provide everyone in this country with a broad measure of equal opportunities. Since equal opportunities would not have been willingly granted and communities with centuries of oppression behind them could not be expected to benefit from an equal footing, reservations were eked out. Over the years, the reservations were extended to include more communities and even women. The idea was to provide these communities with the first stepping stone to equality - access. Access to education, to jobs, to positions of power and access to exposure. This target has been met relatively well and as far as access is concerned, a wide sweep has been achieved.

The obvious next step would have been to pull communities which have benefited enough out of the reserved categories and make more room for those communities which still lag behind. This is easier said than done. For one, there is no easily quantifiable way to decide when a community has "developed" enough to make it on its own steam sans reservation, and for the other, there is the vote-bank politics in which saner decisions in genuine public good would be political hara-kiri. So, the nation is left with an ever overflowing baggage of reserved sections and shrinking opportunities.

This is where the whole policy has failed. Instead of making people competitive with improved access, it has made them lazy with increased quotas. Little wonder then that more and more communities want to fit into some category or the other. In fact, in the present times, when jobs are rare and competition even for education tough, it would be foolish for community leaders not to work for a quota for their people. And so the demands keep pouring in.

This is not to belittle the aspirations of any community to find a new grouping for itself, but just a suggestion that maybe it is time the country and Sikkim paused to re-read the principles why reservations and special categories were first drafted, whether its expressed aims are being met or not, and also whether the people who genuinely deserve reservations are actually getting it or not in the first place.

Coronavirus: Is the cure worse than the disease? The most divisive question of 2020

In 1968, at the height of the last great influenza pandemic, at least a million people worldwide died, including 100,000 Americans. That year A.M.M. Payne, a professor of epidemiology at Yale University, wrote:

"In the conquest of Mount Everest anything less than 100% success is failure, but in most communicable diseases we are not faced with the attainment of such absolute goals, but rather with trying to reduce the problem to tolerable levels, as quickly as possible, within the limits of available resources..."

That message is worth repeating because the schism between those seeking "absolute goals" versus those seeking "tolerable levels" is very much evident in the current pandemic. On September 21, the BMJ reported that opinion among UK scientists is divided as to whether it is better to focus on protecting those most at risk of severe COVID, or imposing lockdown for all.

One group of 40 scientists wrote a letter to the chief medical officers of the UK suggesting that they should aim to "suppress the virus across the entire population".

In another letter, a group of 28 scientists suggested that "the large variation in risk by age and health status suggests that the harm caused by uniform policies (that apply to all persons) will outweigh the benefits". Instead, they called for a "targeted and evidence-based approach to the COVID-19 policy response".

A week later, science writer Stephen Buranyi wrote a piece for the Guardian arguing that the positions in the letter with 28 authors represent those of a small minority of scientists. "The overwhelming scientific consensus still lies with a general lockdown," he claimed.

A few days later, over 60 doctors wrote another letter saying: "We are concerned due to mounting data and real world experience, that the one-track response threatens more lives and livelihoods than Covid-lives saved."

This back and forth will undoubtedly continue for some time yet, although those involved will hopefully begin to see opposing scientific views and opinions as a gift and an opportunity to be sceptical and learn, rather than as a "rival camp".

SCIENTIFIC CONSENSUS TAKES TIME

There are issues, such as global warming, where there is scientific consensus. But consensuses take decades, and COVID-19 is a new disease. Uncontrolled experiments in lockdown are still ongoing, and the long-term costs and benefits are not yet known. I very much doubt that most scientists in the UK have a settled view on whether pub gardens or universities campuses should be closed or not. People I talk to have a range of opinions: from those who accept that the disease is now endemic, to those who wonder if it can still be eradicated.

Some suggest that any epidemiologist who does not toe a particular line is suspect, or has not done enough modelling and that their views should not carry much weight. They go on to dismiss the views of other scientists and non-scientist academics as irrelevant. But science is not a dogma, and views often need to be modified in the light of increasing knowledge and experience. I am a geographer, so I am used to seeing such games of academic hierarchy played above me, but I do worry when people resort to insulting their colleagues rather than admit that knowledge and circumstance have changed and reappraisal is necessary.

A GRIM CALCULUS

Is the cure worse than the disease? This is the question that currently divides us, so it is worth considering how it might be answered. We would have to know how many people would die of other causes, for example, of suicide (including child suicides) that would not have otherwise occurred, or liver disease from the increase in alcohol consumption, from cancers that were not diagnosed or treated, to determine the point at which particular policies were taking more lives than they were saving. And then what value should you put on those lost or damaged lives against the economic conseauences?

We do not live in a perfect world with perfect data. For children, for whom the risk of death from COVID is almost zero and the risks of long-term effects are thought to be very low, it is easier to weigh up the negative effects of not going to school or of being trapped in households with rising domestic abuse.

For university students, who are mostly young, a similar set of calculations could be made, including estimating the "cost" of having the infection now, versus the cost of having it later, possibly when the

student is with their older relatives at Christmas. With older people, though, the calculus - even in a perfect world - would become increasingly complex. When you are very old and have very little time left, what risks would you be willing to take? One elderly man famously claimed: "No pleasure is worth giving up for the sake of two more years in a geriatric home in Weston-super-Mare."

A recent paper, published in Nature, suggests that even in Hong Kong, where compliance with mask-wearing has been over 98% since February, local elimination of COVID is not possible. If it is not possible there, it may not be possible anywhere.

On the brighter side, elsewhere, elderly people have been protected even when transmission rates are high and overall resources are low. In India, a recent study found that "it is plausible that stringent stay-at-home orders for older Indian adults, coupled with delivery of essentials through social welfare programs and regular community health worker interactions, contributed to lower exposure to infection within this age group in Tamil Nadu and Andhra Pradesh."

However, minimising mortality is not the only goal. For those who don't die, the outcome can still be prolonged and severe debility. That, too, must be taken into account. But unless you are sure that a particular measure for locking down will do more good than harm, in the round, you should not do it. In 1970, shortly before he became dean of the London School of Hygiene and Tropical Medicine, C.E. Gordon Smith wrote:

"The essential prerequisite of all good public health measures is that careful estimates should be made of their advantages and disadvantages, for both the individual and the community, and that they should be implemented only when there is a significant balance of advantage. In general, this ethic has been a sound basis for decision in most past situations in the developed world although, as we contemplate the control of milder diseases, quite different considerations such as the convenience or productivity of industry are being brought into these assessments."

Current beliefs of where the balance of advantages and disadvantages lie are changing. The "rival camps" rhetoric needs to end. No individual or small group represents the view of the majority.

How does being bilingual affect your brain? It depends on how you use language

Depending on what you read, speaking more than one language may or may not make you smarter. These mixed messages are understandably confusing, and they're due to the fact that nothing is quite as simple as it's typically portrayed when it comes to neuroscience.

We can't give a simple "yes" or "no" to the question of whether being bilingual benefits your brain. Instead, it is becoming increasingly evident that whether and how your brain adapts to using multiple languages depends on what they are and how you use them.

Research suggests that as you learn or regularly use a second language, it becomes constantly "active" alongside your native language in your brain. To enable communication, your brain has to select one language and inhibit the other.

This process takes effort and the brain adapts to do this more effectively. It is altered both structurally (through changes in the size or shape of specific regions, and the integrity of white matter pathways that connect them) and functionally (through changes how much specific regions are used).

These adaptations usually occur in brain regions and pathways that are also used for other cognitive processes known as "executive

functions". These include things like language has a robust impact on the working memory and attentional control (for example, the ability to ignore competing, irrelevant information and focus on a target).

Researchers measure these cognitive processes with specifically designed tasks. One example of such tests is the flanker task, in which participants have to indicate the direction of a specific arrow that is surrounded by other arrows that face in the same or opposite direction. Being bilingual can potentially improve performance on tasks like these, typically in either faster reaction times or higher accuracy.

MIXED RESULTS?

But not all studies consistently find these performance improvements. In fact, some find that bilinguals and monolinguals perform very similarly.

The degree to which the brain adapts structurally and functionally from bilingualism also varies. Some studies suggest bilinguals and monolinguals use the brain differently to complete an executive function task, even if the performances between the two groups is similar. Other studies have found differ-

ences in brain structure, but how these differences manifest and the brain regions and pathways involved are not always consistent. This variability, especially on executive function tasks, has led some to question whether speaking more than one hrain at all

However, bilingualism comes in many shapes and forms. For example, some bilinguals learn a second language from birth and others much later. Some bilinguals constantly need to switch between their two languages, while others speak one language at home and another at work.

It would be surprising if this variability in bilingualism did not make a difference to how the brain adapts. So there is a growing case for considering bilingualism as a spectrum of experiences rather than just a binary distinction of bilingual versus monolingual. Several models have been proposed for how different brain adaptations might link to specific bilingual language experiences.

A growing number of studies have also examined specific aspects of bilingual experience, such as how long someone has been using more than one language, the regularity or diversity of use, and the amount they switch between languages. These studies crucially find that different language experiences have distinct effects on brain adaptation and performance on tasks measuring certain executive functions.

What's more, these adaptations are dynamic, meaning the brain seems to keep adapting with continued and changing experience. For instance, in the early stages of learning and using an additional language, or

if both languages are frequently used in the same setting, the brain adapts regions in frontal areas of the cortex (regions highly used for executive functions) to more effectively handle the increased effort required to select and control the languages.

However, if someone stays actively bilingual for a long time, other brain regions such as the basal ganglia and cerebellum also adapt. These regions are used to more efficiently or automatically complete a task, like your body can as you become more more physically fit or gain increased muscle memory. Such adaptations in brain structure indicate a shift towards more efficiently handling of language competition.

The next step is to figure out how much these different experiences and outcomes relate to one another. Recently, my colleagues and I have mapped what we know about the relationships between different bilingual language experiences and the different ways in which the brain might adapt to them.

What about our original question: does bilingualism benefit your brain? Well, it depends. While there is still a lot to learn about how exactly the brain adapts to the bilingual experience, it's clear that how you use an additional language makes a big difference.

Odisha reports 2,673 new COVID-19 cases, 16 fatalities



BHUBANESWAR. Ост **6 (PTI):** At least 2,673 more people tested positive for COVID-19 in Odisha on Tuesday, taking the tally to 2,38,003, while 16 fresh fatalities pushed the death toll to 940, a health department official said.

Of the new cases, 1,554 were reported from various quarantine centres and 1,119 were detected during contact tracing, he said.

Khurda district, of which state capital Bhubaneswar is a part, registered the maximum 448, followed by Cuttack at 214 and Nuapada at

"Regret to inform the demise of sixteen #COVID-19 positive patients while under treatment in hospitals," the Health and Family Welfare Department said on Twitter.

Of the 16 fatalities, four were reported from Balasore, three from Khurda, two from Cuttack and one each from Angul, Boudh, Mayurbhanj, Nawrangpur, Nayagarh, Puri and Subarnapur districts.

Ganjam district alone number of new cases at reported 221 of the 940 deaths in the state, followed by Khurda at 154 and Cuttack at 82.

The case fatality ratio (CFR) also remains at 0.39 per cent, the official said.

At least 3,817 patients were cured of the disease during the day, taking the total number of recoveries to 2,10,217, which is 88.32 per cent of the state's caseload, the official said.

The state government on Tuesday issued safety guidelines for the people who have been cured of COVID-19.

"Recovered people must wear masks and maintain social distanc-

ing norms. They should take a balanced diet with rich protein and less carbohydrate," health department's technical advisor Prof Jayanta Panda

said. Odisha currently has 26,793 active cases, which accounted for 11.25 per cent of the state's caseload.

Fifty-three coronavirus patients have died due to comorbidities, according to the official.

As many as 35.24 lakh tests for COVID-19 have been conducted so far, including 41,840 on Monday.

Meanwhile, the Odi-

sha government has allowed the use of Favipiravir tablets by coronavirus patients during home isolation.

Nearly 80 per cent of COVID-19 patients are under home isolation in the state, Panda said.

"New clinical inputs and empirical evidence about the pandemic have proved the effectiveness of Favipiravir tablet as an anti-viral medicine to treat coronavirus patients, Chief Secretary A K Tripathy said after consulting with doctors and health experts.

He also said the medicine needs to be administered with proper advice and precaution.

The chief secretary directed the health department to circulate the standard operating procedure for the use of Favipiravir tablets among doctors.

The rapid response teams (RRTs) of the state government will be trained to assess the condition of the patients in home isolation and whether they can be administered Favipiravir tablets at their residences in consultation with

No free COVID-19 test in Meghalaya from Oct 16



SHILLONG, OCT 7 (PTI): With the Indian Council of Medical Research (ICMR) withdrawing subsidy on testing kits, the Meghalaya government has announced that COVID-19 tests will be charged from next week, Deputy Chief Minister Prestone Tynsong said on Wednesday.

The samples for COVID-19 test will be examined on payment from October 16.

The deputy chief minister also said that plans are afoot to charge inmates at government Corona Care Centres for meals.

The state government has initiated the process for identifying hotels and guest houses where peo- Truenat, CBNAAT and

ple who are currently in institutional quarantine can be lodged, if they are willing to undergo paid isolation.

"Testing, be it RT-PCR, CBNAAT, Truenat or Rapid Antigen Test (RAT), will be done on payment from October 16.

BPL families or beneficiaries under National Food Security Act (NFSA) and high risk contacts are totally exempted," the deputy chief minister told PTI.

The Rapid Antigen Test for COVID-19 will be mandatory for all persons, including visitors, for an amount of Rs 500.

Rs 3,200 has been set as the capping charge for RT-PCR testing, but people under the BPL category and those carrying cartificates of having undergone the tests in the last 72 hours will be exempted, he said.

"We have already created an online facility at www.coronameg.in for those people coming to the state so that they can register for testing before entering Meghalaya," he said.

"Deputy commissioners have been asked to work out on the cost of food items provided to each person per day at government Corona Care Centres. BPL families and those who can get meals from home will be exempted from paying," Tynsong said.

13 new cases push COVID-19 tally of Andamans to 3.912

PORT BLAIR, OCT 7 (PTI): The COVID-19 tally of Andaman and Nicobar Islands rose to 3,912 on Wednesday as 13 more people tested positive for the infection, a health official said.

Five new patients have travel history, while eight fresh infections were detected during contact tracing, he said.

Nineteen more people have been cured of the disease, the official said.

The Union territory now has 180 active coronavirus cases, while 3,678 people have recovered from the disease and 54 patients have succumbed to the infection so far, he said.

The administration has so far sent 63,790 samples for COVID-19 tests, of which 63,767 reports have been received and 23 are awaited, the official added.

Ladakh records 79 new COVID-19 cases; 50 patients cured

LEH, OCT 7 (PTI): The Union Territory of Ladakh reported 79 new coronavirus cases, taking the cumulative figure to 4720, an official bulletin said on Wednesday.

With 50 more patients cured of the disease, the number of active cases in the region stands at 1195 904 in Leh district and 291 in Kargil district, the bulletin released by the directorate of health services said.

It said 72 people tested positive for COVID-19 in Leh and another seven in Kargil district during the past 24 hours.

Ladakh had reported 61 COVID-related deaths, while 3,464 patients have recovered till Tuesday evening.

The bulletin said 27 COVID patients were discharged in Kargil and 23 others in Leh on Tuesday after their successful treatment.

Bengal governor to visit family of Galwan martyr

KOLKATA, OCT 7 (PTI): West Bengal Governor Jagdeep Dhankhar will visit the family of Galwan martyr Havildar Bipul Roy on October 9, Raj Bhavan said here on Wednesday.

Eastern Army Commander Lt General Anil Chauhan will accompany him.

A cheque of Rs 5.5 lakh each will be handed over to the mother and widow of Roy at their residence at Bindipara village in Alipurduar district, Raj Bhavan said in a statement.

Two Indian Army soldiers hailing from West Bengal - Havildar Bipul Roy and Sepoy Rajesh Orang - lost their lives at Galwan Valley in the Ladakh region in a violent face-off with the Chinese Army on June 15.

The two were among 20 Army personnel killed in the clash on that day.

"The Governor has indicated that it is the prime duty of the society to stand by the families of our soldiers who have made this supreme sacrifice for the nation," the statement said.

Dhankhar and the Eastern Army Commander have already visited the family of Orang in Birbhum district and handed over a cheque of Rs 11 lakh to his mother.

Assam former DIG wanted in police examination paper leak scam detained at Indo-Nepal border



GUWAHATI, OCT 06 [PTI]: Retired Assam DIG PK Dutta, who is wanted in connection with the police recruitment examination paper leak scam, has been detained at the Indo- Nepal Border, a police spokesman said on Tuesday.

Dutta was detained by security personnel following the 'look out circular' (LOC) issued by the Assam CID, the spokesman said.

He has now been handed over to West Bengal Police and a team of Assam Police is on the way to the place to bring him back to the state, Additional Director General of Police (Law and Order) G P Singh told PTI.

Further details are awaited. Dutta was absconding along with another accused, expelled BJP leader Diban Deka who was arrested on October 1.

The state police had announced a reward of Rs one lakh each for information which would lead to their arrest.

So far, 32 people have been apprehended in connection with the paper leak scam. When Dutta is arrested, it will increase to 33.

Negative views of China rise sharply in advanced democracies

TAIPEI, OCT 7 (AP): Negative perceptions of China have increased sharply among people in several advanced democracies, especially in Australia and Britain, according to a survey from the Pew Research Center released Tuesday.

The survey comes as China is engaged in multiple trade and diplomatic disputes with its neighbors and other countries, driven in part by a more aggressive diplomatic approach.

The survey conducted in 14 democratic countries with advanced economies showed a majority of people had an unfavorable view of China. It was conducted from June 10 to Aug 3 among 14,276 adults across the 14 countries via telephone.

In Australia, 81% said they have an unfavorable view of China, according to the survey, a rise of 24 percentage points from last year.

The rise corresponds with higher tensions in the bilateral relationship after Australia led the call for an international investigation into the origins of the coronavirus.

China responded on the trade front, suspending imports of Australian beef,

putting high tariffs on barley from the country and starting an anti-dumping probe into imports of Australian wine.

While the survey showed Australia had the sharpest increase in negative attitudes toward China, other countries also showed an upward trend: Those with an unfavourable view toward China hit 74% in Britain, a rise of 19 percentage points compared to last year; 71% in Germany, a rise of 15 points; and 73% in the U.S., a rise of 13 points.

The 14 countries surveyed were the U.S., Canada, Belgium, Denmark, France, Germany, Italy, the Netherlands, Spain, Sweden, the U.K., Australia, Japan and South Korea. The margin of error for the survey ranged from 3.1 percentage points in South Korea to 4.2 percentage points in Belgium.

In most countries surveyed, those with higher income levels were equally likely as those with lower levels of income to hold the negative views. The negative views also held across education levels, as those with a postsecondary degree or more were equally likely to have unfavorable views of China as those with less education.

Nagaland's COVID-19 tally rises to 6,715



KOHIMA, OCT 7 (PTI): At least 53 more people tested positive for COVID-19 in Nagaland on Wednesday, pushing the coronavirus caseload in the state to 6,715, an official said.

The new cases were reported from Dimapur (37), Kohima (8), Peren (6) and one each from Mokokchung and Phek

"53 positive cases of COVID-19 were detected Dimapur 37, Kohima 8, Peren 6 and one each in Mokokchung and Phek district," Health and Family Welfare Minister, S Pangnyu Phom said in a tweet.

The minister said 36 COVID-19 patients were discharged on Wednesday as they had recovered from the disease.

"Also, 36 patients have been discharged Dimapur 28, Kohima 4, Zunheboto 2 and one each in Mon and Wokha districts." he said in another tweet.

Of the total 6,715 COVID-19 cases in the state, 1,194 are active cases, while 5,444 patients have recovered, said Additional Director of Health Department Dr Denis Hangsing.

So far 23 COVID-19 infected patients have died in the state, he said, adding that only 12 deaths are due to coronavirus, five are due to comorbidities and six are under investigation to find the cause of death.

Altogether COVID-19 patients have migrated to other states till date, he said.

The recovery rate of COVID-19 patients is now at 81.07 per cent, he said. The district-wise

COVID-19 cases are Dimapur (3,535), Kohima (2,133), Mon (394), Peren (282), Zunheboto (123), Tuensang (108), Mokokchung (55), Phek (36), Wokha (26), Kiphire (12) and Longleng (11).

Of the total cases, 3,153 are armed forces personnel, 1,535 are returnees from other states, 1,666 are traced contacts and 361 are frontline workers, he said.

Among the active cases, 41 patients are with mild and moderate symptoms, while four in Dimapur are critical on oxygen and ventilator support, he said, adding that 1,142 patients are asymptomatic.

A total of 83,560 samples have been sent for COVID-19 testing in the state so far, the health official said.

Our top order has failed to perform: Rajasthan Royals opener Buttler

ABU DHABI, OCT 7 (PTI): Rajasthan Royals opener Jos Buttler admitted that his side's top order has failed to perform in the last three games that has cost them dear in the Indian Premier League so far.

The Royals suffered a 57 run-loss to defending champions Mumbai Indians -- their third defeat on the trot -- with only Buttler contributing a sizeable score (70) here on Tuesday.

"We have not managed to come off as a top-order in the last three games. We have lost three wickets in the power-play a few times and in T20 cricket you never win too many games from that position," Buttler said at the media conference after the match.

"Of course, the power-play is a time you have to take advantage due to the field restrictions, but as players we have not performed but that can happen in T20 cricket, the Englishman added.

Chasing a big target of 194, the Royals were struggling at 12 for 3 in the third over and they never recovered from there despite a blazing 70 off 44 balls from Buttler. They were eventually bundled out for 136.

"We lost wickets. Mumbai bowled really well and we never got into our innings. As a batsman, you are always vulnerable early on in your innings and as a top order we didn't manage to counteract the opening bowling well enough to get through that period, the 30-year-old wicketkeeper-batsman said.

Mumbai, Suryakumar Yadav made a blazing unbeaten 79 off 47 balls to post a challenging 193 for 4. Buttler praised Yadav for using angles and his crease to perfection.

"He (Suryakumar) played a fantastic innings. We could not quite tie (him) down. He used the angles and his crease really well and he is a fantastic player. We could not execute our plans to him but full credit to him. He played a very good innings, Butter, himself a T20 specialist, said.

Talking about himself, Buttler said he would take confidence from his good show against Mumbai Indians to the games ahead.

I have not been feeling my best in the middle. It was good for me to spend time in the middle, find a bit of fluency further on in the innings. I struggled initially, but hopefully I can take some confidence from today and use that for the rest of the tournament," the right-handed batsman said.

He also had words of praise for young Karthik Tyagi, who made his IPL debut.

He is a really exciting talent. One thing the IPL always does is unearth fantastic Indian players and he impressed in the nets and worked hard to get his opportunity to make his debut. It was a great moment for him and everyone in the team when he picked up his first wicket," Buttler signed off.

From qualifying to the semis: Podoroska dreams on in Paris

PARIS, OCT 7 (AP): Nadia Podoroska has already won more matches at this French Open eight than it usually takes to raise the trophy.

That's because the 131stranked Argentine has come all the way from qualifying rounds to reach the semifinals, becoming the first woman to achieve that feat at Roland Garros in the Open era.

Having never won a maindraw Grand Slam match before last week. Podoroska could hardly believe it after her 6-2, 6-4 quarterfinal victory Tuesday over third-seeded Elina Svitolina on Court Philippe Chatrier.

Asked afterward whether she is pinching herself to make sure it's not a dream, Podoroska replied: No. I don't want to wake up.

Podoroska is only the third female qualifier to get to the semifinals at any major tournament in the Open era, which began in 1968, and the first since Alexandra Stevenson at Wimbledon in 1999.

Another qualifier, Martina Trevisan of Italy, had a chance to join that list later Tuesday but could not quite take the last step. The 159th-ranked Trevisan, who also had not won a main-draw Grand Slam match before this tournament, lost 6-3, 6-1 to unseeded 19-year-old Iga Swiatek of

Barca start process to reduce salaries due to COVID-19 losses



BARCELONA, 07 OCT (REUTERS): Barcelona have begun a process to reduce the pay of players, coaches and non-sporting staff to adapt to the huge losses suffered due to the COVID-19 pandemic, a club source said on Wednesday.

Staff have been notified by the club of the need to reduce costs after posting a loss of 97 million euros (\$113.98 million) in their annual financial report, released on Monday.

The employees, including players, have been asked to nominate a representative over the next two weeks to represent them in the negotiations over the changes to their salaries, added the source. Barca have been forced to hold all home matches without spectators since the pandemic began in March, destroying revenue from ticket sales. Income from merchandising and stadium and museum tours has also been badly affected by a huge drop in tourism to the city.

Barca's accounts on Wednesday made for grim reading, showing a 14% drop in revenue from the previous year and the doubling of their net debt to 488 million

The club enacted a temporary pay cut of 70% at the end of March in the height of the pandemic, lasting the duration of Spain's national state of alarm, which ended in June.

Barca's financial troubles also led them to spend the close season lightening the biggest wage bill in European football, offloading Luis Suarez, Ivan Rakitic and Arturo Vidal for next to nothing, while selling Arthur Melo for 72 million euros and Nelson Semedo for 30 million.

They only brought in three players, Miralem Pjanic, Francisco Trincao and Sergino Dest for a combined 112 million euros.

They failed to make any extra additions before the transfer window shut on Monday, despite showing interest in Manchester City defender Eric Garcia and Olympique Lyonnais forward Memphis Depay.

Increasing number of footballers concerned for their mental health

LONDON, 07 OCT [THEGUARDIAN]: A sharp rise in the number of footballers concerned for their mental health has continued in 2020, according to figures from the counselling body Sporting Chance.

In the year to September, 464 members of the Professional Footballers' Association accessed counselling services, compared with 653 across all of 2019. This maintains a trend in which numbers have quadrupled since 2016, when 160 members accessed the

The PFA has 4,000 members, meaning that in only nine months of the year more than 10% have sought some form of support. Of those to have done so, 42% are current players, with 55% former players and 3% family members given access to the services; 95% of the calls were made by male members of the union and 5% by female members.

These figures were released to coincide with Mental Health Awareness week. Of the concerns

cited by PFA members to have accessed counselling, the most common were "low mood" and "anxiety" followed by "addictive disorder – substance" and "addictive disorders - gambling". More traditional union issues, such as the "transition" from a playing career, came below "relationship issues" on the list.

The period covered by the Sporting Chance data includes the Covid-19 pandemic and a highly uncertain time for professional footballers, many of whom lower

The issue of mental health in sport, and among men more broadly, has substantially grown in visibility over recent years. Royals skipper Steve Smith blamed the top-order for his side's third straight loss.

"Obviously, losing wickets early does not help us. We haven't been able to get off to a good start in the last three games. So outside of Jos (Buttler) and Jofra (Archer) in the end there, we have got to do a bit of work with our batting, I'm sure, Smith said.

"I don't think we need to panic too much. It is just about implementing our plans and playing some good cricket for longer, we have not been able to do that in the last three games and we got to turn that around quickly."

Smith also informed that star England all-rounder Ben Stokes will not be available till October 10. Stokes is currently undergoing a mandatory quarantine.

2 scientists win Nobel chemistry prize for 'gene scissors'

STOCKHOLM (AP): Two scientists won the Nobel Prize in chemistry Wednesday for developing a method of genome editing likened to "molecular scissors" that offer the promise of one day curing inherited diseases and even cancer.

Working on opposite sides of the Atlantic, Frenchwoman Em-Charpentier manuelle and American Jennifer A. Doudna developed a method known as CRIS-PR/Cas9 that can be used to change the DNA of animals, plants and microorganisms with extremely high precision.

"There is enormous power in this genetic tool, which affects us all," said Claes Gustafsson, chair of the Nobel Committee for Chemistry. "It has not only revolutionized basic science, but also resulted in innovative crops and will lead to groundbreaking new medical treatments."

Gustafsson said that, as a result, any genome can now be edited "to fix genetic damage," adding that the tool "will provide humankind with great opportunities."

But he cautioned that the "enormous power of this technology means we have to use it with



Most of the world became more aware of CRISPR in 2018, when Chinese scientist Dr. He Jiankui revealed he had helped make the world's first gene-edited babies, to try to engineer resistance to future infection with the AIDS virus. His work was denounced worldwide as unsafe human experimentation because of the risk of causing unintended changes that can pass to future generations, and he's currently in prison.

In September, an international panel of experts issued a report saying it's still too soon to try to make genetically edited babies because the science isn't advanced enough to ensure safety, but they mapped a pathway for any countries that want to consider it.

"I was very emotional, I have to say," Charpentier, 51, told reporters by phone from Berlin after hearing of the award. announced Wednesday in Stockholm by the Royal Swedish Academy of

Asked about the fact that it was the first time that two women have won the chemistry Nobel together, Charpentier said that while she considers herself first and foremost a scientist, she hoped it would encourage others.

"I wish that this will provide a positive message to young girls who would like to follow the path of science," she said.

Doudna told The Associated Press about her surprise at receiving the early morning call.

"I literally just found out, I'm in shock," she said. "I was sound asleep." "My greatest hope is that it's used for good, to uncover new mysteries in biology and to benefit humankind," Doudna said.

The Broad Institute at Harvard and MIT have been in a long court fight over patents on CRISPR technology, and many other scientists did important work on it, but Doudna and Charpentier have been most consistently honored with prizes for turning it into an easily usable tool.

The prestigious award comes with a gold medal and prize money of 10 million kronor (more than \$1.1 million), courtesy of a bequest left more than a century ago by the prize's creator, Swedish inventor Alfred Nobel. The amount was increased recently to adjust for inflation.

On Monday, the Nobel Committee awarded the prize for physiology and medicine to Americans Harvey J. Alter and Charles M. Rice and British-born scientist Michael Houghton for discovering the liver-ravaging hepatitis C virus. Tuesday's prize for physics went to Roger Penrose of Britain, Reinhard Genzel of Germany. and Andrea Ghez of the United States for their breakthroughs in understanding the mysteries of cosmic black holes.

The other prizes are for outstanding work in the fields of literature, peace and economics.

Greek court rules Golden Dawn party criminal organization

ATHENS, GREECE (AP): A Greek court ruled on Wednesday that the farright Golden Dawn party was operating as a criminal organization, delivering landmark guilty verdicts following a politically charged five-year trial against dozens of defendants.

The court ruled that seven of the 18 former lawmakers, including Nikos Michaloliakos, the head of the party which had become Greece's third largest during the country's financial crisis, were guilty of leading a criminal organization. The others were found guilty of participating in a criminal organization.

As news of the guilty verdicts broke, cheers and celebrations erupted among the crowd of at least 20,000 people gathered in an anti-fascist rally outside the Athens courthouse. A small group threw Molotovs and stones, with police responding with tear gas and water cannon.

The marathon trial had been assessing four cases rolled into one: the 2013 fatal stabbing of Greek rap singer Pavlos Fyssas, physical attacks on Egyptian fishermen in 2012 and on left-wing activists in 2013, and whether Golden Dawn was operating as a criminal organization.

The 68 defendants included the 18 former lawmakers from the party that was founded in the 1980s as a neo-Nazi organization and rose in prominence during the country's decade-long financial crisis.

Prime Minister Kyriakos Mitsotakis said the verdict "ends a traumatic cycle" in the country's public life.

"Its political dimension has, fortunately, been judged by the victory of democracy, which expelled the Nazi formation from Parliament (in elections)," he said. "Now, the independent judiciary is giving its own answer."

found Giorgos Roupakias guilty of the murder of Fyssas, prompting applause inside the courtroom and among the crowd outside. Roupakias had been accused of being a party supporter who delivered the fatal stab wounds to Fyssas. Another 15 defendants — none of them former lawmakers — were con-

victed as accomplices. Leaving the courthouse, Fyssas' mother Magda Fyssa, who had attended nearly every court session over the last five years, raised her arms and shouted: "Pavlos did it. My son!"

All five people accused of attempted murder against the fishermen were also found guilty, while the four accused of attempted murder in the attacks against left-wing activists were found guilty of the lesser charge of causing bodily

Only 11 of the 68 defendants were present, with the rest represented by their lawyers. None of the former Golden Dawn lawmakers were in court.

"The ruling demonstrates that they were just a gang of knife-wielding thugs who took their orders from the top," said Thanassis Kambayiannis, one of the lawyers representing the fishermen.

After the verdicts, defense lawyers began summations ahead of sentencing, a process that could last several days. Those convicted of leading a criminal organization face up to 15 years in prison, while the others face up to 10 years. Roupakias faces a life sentence.

"Today marks a huge victory for justice and respect for Greece and the entire world," Eva Cosse, Greece researcher at Human Rights Watch, told The Assoicated Press. "It sends a strong message that hate crimes are not and should not be tolerated in a democratic society."

Security was tight The three-member at the courthouse, with panel of judges also around 2,000 police, drones and a police helicopter deployed.

The crowd at the anti-fascist rally waved banners with slogans including "Fyssas lives, crush the Nazis," and chanted "The people demand the Nazis in jail." More than 5,000 people held a similar rally in the northern city of Thessaloniki.

Outside the courthouse, protester George Kounanis, who works as an employment equality campaigner for LGBT workers, said he was relieved by the verdict.

"We have lived under the threat they posed for years. They have beaten, threatened and verbally abused same sex couples. They hate everything that is not Greek and macho," he said. "But we never cowed and never stopped speaking out against them. So it does feel like a vindication. A lot of people supported them, so we cannot be complacent."

Politicians across the political spectrum, from the governing conservative New Democracy party to Greece's Communist Party and the former governing left-wing Syriza party, also attended.

At the crux of the case was whether the string of violent attacks could be linked to Golden Dawn's leadership. During the trial, the prosecutor recommended the acquittal of many of the party members for lack of evi-

Golden Dawn denies any direct link to the attacks and described the trial and charges against the party's leadership as an "unprecedented conspiracy" aimed at curbing its rise in popularity.



Japan seeks to boost catch limits of prized bluefin tuna

MITO, OCT 7 (AP): Japan has proposed raising its catch quotas for Pacific bluefin tuna, a fish so highly prized for sushi and sashimi that its population is at less than 5% of historical levels.

An online meeting of countries that manage the Pacific bluefin that began Tuesday is studying the proposal to raise Japan's catch limits for both smaller and larger bluefin tuna by 20%.

A slight improvement in the has raised confidence that it can recover from decades of overfishing. But conservation experts say increasing catch limits too soon could undo progress toward restoring the species.

Increasing harvests of such fish could also drive prices lower, making the industry less profitable in the long run, the Pew Charitable Trusts said in a report issued Tues-

The report, Netting Billions 2020: A Global Tuna Valuation, put the market value of seven tuna species including bluefin at 40.8 billion in 2018. Despite increased catches, that was a decrease from 41.6 billion in 2012.

Just because increasing catch is sustainable does not mean it is always the right thing to do," said Grantly Galland, an officer in Pew's international fisheries team.

Prices for most species of tuna have fallen due to oversupply of caught fish, he said.

The meeting of the Western and Central Pacific Fisheries Commission and the Inter-American Tropical Tuna Commission includes more than two dozen countries that collaborate to manage fisheries on the high seas and curb spawning population for the fish illegal and unauthorized fishing and other activities that endanger highly migratory species such as the Pacific bluefin.

> The countries participating in management of the Pacific bluefin committed in 2017 to reducing their catches to help return the species to 20% of its historic size by 2034.

Japan plays a critical role in the survival of the species not just because of its huge appetite for the fish. The Pacific bluefin spawns almost entirely in seas near Japan and Korea. Japanese fishermen also capture small tuna to be farmed to maturity, although the number of traditional artisanal fishermen has fallen in recent years as younger Japanese choose not to engage in such dangerous

and difficult work.

The latest data show the spawning stock biomass of the Pacific bluefin, an indicator of the fish's ability to reproduce at a sustainable level, rising to about 28,000 metric tons in 2018 from 10,837 metric tons in 2010.

That is still less than half the estimate for 1995 of a spawning stock biomass of 62,784 metric tons. It puts the species at about 4.5% of the baseline level it would be at if there were no fishing at all, up from 4% several years ago.

Demand for bluefin tuna is such that any progress draws pressure for bigger catches. Last week, the Marine Stewardship Council granted certification for a Japanese fishery's Atlantic bluefin, over conservationists' objections that such a move might hinder its long-term recovery.

In 2019, Japan reported a catch of 3,757 tons of smaller tuna and 5,132 of larger tuna, according to documents prepared for the online meeting. To comply with its limits, it transferred 250 tons of its catch quota for smaller Pacific bluefin to its limit for the larger ones, according to documents prepared for this week's online conference.





Guitar rock god Eddie Van Halen dies of cancer at 65

NEW YORK, OCT 7 (AP): Eddie Van Halen, the guitar virtuoso whose blinding speed, control and innovation propelled his band Van Halen into one of hard rock's biggest groups, fueled the unmistakable fiery solo in Michael Jackson's hit Beat It and became elevated to the status of rock god, has died.

He was 65 A person close to Van Halen's family confirmed the rocker died Tuesday due to cancer.

The person was not authorized to publicly release details in advance of an official announcement.

With his distinct solos, Eddie Van Halen fueled the ultimate California party band and helped knock disco off the charts starting in the late 1970s with his band's self-titled debut album and then with the blockbuster record 1984, which contains the classics Jump, Panama and Hot for Teacher.

Van Halen is among the top 20 best-selling artists of all time and the band was inducted into the Rock and Roll Hall of Fame in 2007.

Rolling Stone magazine put Eddie Van Halen at No 8 in its list of the 100 greatest guitarists.
