Supplies airdropped to cut-off villages of Sakyong and Pentong



MANGAN, 25 JUL (IPR): An MI-17 Helicopter of the IAF today conducted three sorties to transport ration and essential supplies to the villages of Sakyong and Pentong in North Sikkim. The two villages were cut-off from the rest of Dzongu since 10 July owing to multiple slides and washing off of many bridges connecting these villages with the rest of the District and the continuous rainfall that followed.

100 bags of rice weighing 50 quintals, 550 litres of cooking oil, 1.5 quintals of salt, 100 packets of candles and matches and medicines were dropped.

The helicopter could not land at Pentong due to the landing zone not being conducive. Hence the consignments were dropped at Sakyong school ground . The share of ration for Pentong village would be transhipped via a manual rope-way connecting Sakyong and Pentong villages.

Nangzey Dorji becomes second Sikkimese to become President of Mahabodhi Society of India

Sikkim's COVID-19 load grows to 499; Active cases number 357

SUMMIT REPORT GANGTOK, 25 JUL:

Cikkim's active caseload of OCOVID-19 reached 357 with 21 new cases reported on Saturday. Sikkim;s cumulative COVID count is now 499. Five patients also made full recoveries and were discharged from hospital today.

These 21 new cases also included a doctor posted at the Emergency Ward of STNM hospital.

Section 144 is essentially to prohibit assembly of people [in groups of more than 4] and restrict movement of people and vehicles. The DC, while issuing the orders, also directed the police to barricade entry points to the town. The order extends to areas falling under the Namchi Municipal Council.

GANGTOK, 25 JUL:

A lady doctor posted at the Emergency Ward of STNM Hospital here at Socheygang tested positive for COVID-19 on Saturday. Following the same, the emergency ward of the hospital has been contained and will remain closed for a week.

Health Department Secretary Dr Pempa T Bhutia, while confirming the development, explained that following stated protocol, the emergency ward has been contained for a week.

He said that it is suspected that the doctor was exposed when a patient sent from the Flu Clinic to the Emergency Ward later tested positive for COVID.

Dr Bhutia added that in-patients who were already in the emergency ward cannot be discharged unless screened for the virus and will be kept at the emergency ward until then.

He further informed that three doctors have been shifted to the quarantine facility in the annexe building of the hospital and nurses and other staff to the Yatri Niwas of the hospital and will be attending to the in-

patients at the emergency ward.

He added that testing of these health workers will be conducted on 29 or 30 July.

The Secretary informed that the department has already requested the Medical Superintendent of the Central Referral Hospital, Tadong, to attend to emergency cases at least for a week that the emergency ward at STNM Hospital is closed.

Does your homemade mask work?

If a surgeon arrived at the operating theatre wearing La mask they had made that morning from a tea towel, they would probably be sacked. This is because the equipment used for important tasks, such as surgery, must be tested and certified to ensure compliance with specific standards.

But anyone can design and make a face covering to meet new public health requirements for using public transport or going to the shops.


Indeed, arguments about the quality and standard of face coverings underlie recent controversies and explain why many people think they are not effective for protecting against COVID-19. Even the language distinguishes between face masks (which are normally considered as being built to a certain standard) and face coverings that can be almost anything else.

Perhaps the main problem is that, while we know that well-designed face masks have been used effectively for many years as personal protective equipment (PPE), during the COVID-19 outbreak shortages of PPE have made it impractical for the entire population to wear regulated masks and be trained to use them effectively.

As a result, the argument has moved away from wearing face masks for personal protection and towards wearing "face coverings" for public protection. The idea is that despite unregulated face coverings being highly variable, they do, on average, reduce the spread of virus perhaps in a similar way as covering your mouth when you cough.

But given the wide variety of unregulated face coverings that people are now wearing, how do we know which is most effective?

The first thing is to understand what we mean by effective. Given that coronavirus particles are about 0.08 micrometres and the weaves within a typical cloth face covering have gaps about 1,000 times bigger



not mean reliably trapping the virus. Instead, much like covering our mouths when we cough, the aim of wearing cloth coverings is to reduce the distance that your breath spreads away from your body.

The idea is that if you do have COVID-19, depositing any virus you may breathe out on either yourself or nearby (within one metre) is much better than blowing it all over other people or surfaces.

So an effective face covering is not meant to stop the wearer from catching the virus. Although from a personal perspective we might want to protect ourselves, to do so we should be wearing specially designed PPE such as FFP2 (also known as N95) masks. But, as mentioned, by doing so we risk creating mask shortages and potentially putting healthcare workers at risk.

Instead, if you want to avoid catching the virus yourself, the most effective things to do are avoid crowded places by ideally staying at home, don't touch your face, and wash your hands often.

TWO SIMPLE TESTS

If effectiveness for face coverings means preventing our breath travelling too far away from our bodies, how would we go about comparing different designs or materials?

Perhaps the easiest way, as demonstrated by several increasingly shared pictures or videos on social media, is to find someone who "vapes" and film them breathing out the vapour while wearing a face covering. One glance at such a picture dispels any suggestion that these face coverings stop your breath escaping.

Instead, these pictures show that your breath is directed over the top of your head, down onto your chest, and behind you. The breath is also turbulent, meaning that although it does spread out, it doesn't go far.

In comparison, if you look at a picture of someone not

wearing a face covering, you will see that the exhalation goes mostly forward and down, but a significantly

further distance than with the face covering. Such a test is probably ideal for examining different designs and fits. Do coverings that loop around the ears work better than scarves? How far under your chin does a covering need to go? What is the best nose fitting? How do face shields compare to face masks? These are all questions that could be answered using this method.

But, in conducting this experiment, we should appreciate that "vaping" particles are about $0.1\ to$ 3 micrometres – significantly bigger than the virus. While it is probably fair to assume that the smaller virus particles will travel in roughly the same directions as the vaping particles, there is also the chance that they may still go straight forward through the face covering.

To get an idea of how much this might happen, a simple test involving trying to blow out a candle directly in front of the wearer could be tried. Initially, the distance coupled with the strength of exhalation could be investigated, but then face coverings made from different materials and critically with different numbers of layers could be tried. The design of face covering that made it hardest to divert the candle flame will probably provide the best barrier for projecting the virus forward and through the face covering.

Without any more sophisticated equipment, it would be difficult to conduct any further simple experiments at home. However, combining the above two tests would provide wearers with a good idea about which of their face coverings would work the best if the aim was to avoid breathing potential infection over other people.

No buyers, huge losses: COVID turns Eid underwhelming for goat sellers

NEW DELHI, JUL 25 (PTI): Shakeel Khan came from Bareilly, Uttar Pradesh, around two weeks ago to sell his employer's goats at Delhi's famous caprine market near Jama Masjid. A week away from Eid al-Adha or Bakri Eid, he has not been able to find any buvers.

With a little money left on him, the 22-yearold spends his nights outside closed shops on Urdu Bazar Road near the famous mosque.

"Had I been able to sell some of my goats and earn something, I would have found a shelter nearby," he says.

The novel coronavirus pandemic has hit businesses and people who could afford four goats till last year do not have enough money to buy even one this Eid, says a buyer who approached Khan but could not seal the deal.

Khan's employer had fixed the price of a pair of goats, each weighing around 40 kg, at Rs 30,000. "The price is reasonable," he says.

"Last year, I sold eight goats for Rs 1.6 lakh -- Rs 20.000 a goat. This year, no buyer has offered more than Rs 10,000 a goat so far," says Khan, who has been a regular to the caprine market for five years.

Safeena, 53, and her daughter-in-law have come from Filmistan area in Old Delhi to buy a goat for the festival on a 1,300-square-foot plot July 31.

"We buy a goat every year. This year, our shop remained shut for most of the period," she says. "These are tough times. We had saved some money for the festival but we cannot afford to splurge."

Fariya, the daughterin-law, says they bought a goat for Rs 15,000 last and he himself goes to

"This year, we have got only Rs 10,000. It has been hard to find a nice goat in this price range," she says, resting for a while on a bench outside a cloth shop in the market.

Zaid Malik, the cloth shop owner, says the administration did not give permission for selling of goats this year for fear of coronavirus.

"Compared previous years, there is nothing in the market this time. It would bustle with activity and you won't find any empty space. Now, you can count the number of people on your fingers," he says.

In normal times, Mohammad Izhaar would have sold around 15-20 goats on the festival of sacrifice. This year, he has sold only a pair, that too at a loss.

"We have scaled down our prices. Our asking price was Rs 18,000, we got Rs 15,500," he says.

In a world without coronavirus, the pair would have fetched 30,000-35,000, according to Izhaar.

"It takes around 18 months to prepare a goat. A lot goes into its upkeep. We spend around Rs 10,000 on food, which includes gram, wheat, maize, barley, per goat a year," Izhaar, a resident of Azadpur, says.

The goats are kept in his father has rented for Rs 7,000 a month.

Disgustingly Compromised Inadequately Incensed

We should not stop talking about sexual abuse of children

There was an incident not very long ago, could not have been ■ more than five or six years back when a septuagenarian was beaten up by his nephew. When news of the incident first arrived, most people clucked at the degeneration of our times and of how age no longer commanded respect. As more details unraveled, while the sense of degeneration was reinforced, the sympathies had shifted. Apparently, the septuagenarian was a pedophile, and among the victims he had preyed upon was his nephew's child. The incident had come to light when parents of other victims had come to know of the pedophile among them and had lodged a police complaint. But that was still not when he was roughed up. Apparently, the matter was settled out of court when the extended family negotiated a "settlement" and a "punishment". The pervert was to be socially ostracized by the village and the family. The nephew eventually "lost it" when the predator was allowed back into the village within a few months on the justification that he was of advanced age and "repentant"!

It is worrying that most people still not see the depravity of what had been engineered in this case until the High Court took notice. While the cops were all fine with the "compromise" arranged in the child molestation case, they did their job and picked up the nephew on assault charges. When the High Court was hearing an appeal on the assault case, it learned of the obnoxious negotiations which had gone sour and resulted in the assault. The Court then ordered the cops to investigate the original case. One does not know what happened of that investigation, but this one episode which got "outed", should have opened the can of worms that the society at large does very well to keep packed in Sikkim. After all, this cannot be the only POCSO Act case that has been compromised.

The horrors that visit victims of child abuse are too inadequately handled by the society and its systems. Imagine the anger, frustration and hate that a victim will grow up into when s/he realizes that the perpetrator, even after being exposed and caught, was allowed to walk free without being held to account. It should worry Sikkim that the kind of subversion carried out in the case mentioned above although shocking and disturbing for some, are not necessarily rare. Criminal acts, especially offences against women and children, are more pervasive than accepted and unfortunately less prosecuted than is necessary for women and children to be made safe in this off-balance society. The criminally-inclined will continue to commit excesses because that is a tendency they have been allowed to nurture and get away with, and every time they are 'saved' from punishment, and victims refused the justice that the society owes them, the perpetrators are emboldened and the victims further smothered.

Institutions in our country are geared to instinctively circle the wagons around their own even when though it should be the victims who command all the sympathy. This attitude makes for a dangerous mix with the patriarchal instincts in which genuine sensitivity towards women and children becomes a stillborn pursuit. The incident shared here fleshes out all that is wrong with the tokenisms being paid to women and child welfare and amplify the societal failures and failure of organizations and committees specifically tasked with looking out for them. And let's accept it, even the commissions tasked with looking after the welfare and interests of women and children were not born out of the society's realization to have specialist organizations for the job. These organizations are there because a central rule mandates them and because there are funds to sustain them. While this is not to suggest that such organizations are useless, but it also needs to be accepted that they not very motivated either. Otherwise, "compromise" of any offence against women or children should attract immediate condemnation from such organizations. But why blame the organizations when the society itself conspires against its young so often?

Given the nexus of connections which most institutions and organizations and even the society at large have become, priorities are always misplaced and reprehensive responses unleashed often. These problems cannot be corrected with more rules and more laws - what is required is wider sensitivity and a clear checklist of due processes. Since individuals are routinely failing in what is expected of them, the institution should be made such that there is a prescribed code and a transparent process which needs to be followed whenever a complaint is lodged or an incident comes to light. Personal prejudices, and we are a nation which is deeply prejudiced on all issues, need to be snuffed out, and this will happen only when guidelines are detailed and digressions severely penalized. Until that happens tokenism will rule.

How Earth's plastic pollution problem could look by 2040

During a visit to a bookstore a few weeks ago, we couldn't help but stare at a display unit featuring no fewer than ten books telling you how to rid plastics from your daily life. We're bombarded by information on the topic of marine litter and plastic pollution, but how much do we really know about the problem?

Think about other planetary challenges, like climate change or ozone layer depletion. Mature areas of research have developed around them, allowing scientists to identify where the gases that cause these problems come from, and how much reaches the atmosphere each

But when it comes to plastic pollution, we know close to nothing about how and where plastic waste is generated, managed, treated and disposed of, especially in low and middle income countries. As a result, we're struggling to limit the amount of litter accumulating in the environment.

Our research published in Science involved a herculean effort to spot, track and model the current and future flows of plastics into the world's land and waterbodies. We found that plastic entering the marine environment is set to double by 2040 and, unless the world acts, more than 1.3 billion tonnes of plastic waste will be dumped on land and in waterbodies.

By identifying the ways in which this litter is produced and distributed, we've also discovered how best to reduce the plastic deluge. In the process, we found the unsung heroes on the frontline we tested, none solved the problem

could be the world's best hope of stemming the tide.

WORLD'S PLASTIC THE PROBLEM IN NUMBERS

We developed a model called Plastic-to-Ocean (P₂O) which combines years of accumulated knowledge on global flows of plastic. It compares our current production, use and management of waste with what is projected in the future.

Do you burn your waste in the garden or in the street? Do you drop it into the river? If you answered no to both of these questions then you are possibly one of the 5.5 billion people whose waste gets collected. If you were among the remaining two billion, what would you do with your uncollected waste? Would you make use of a nearby stream, cliff edge, or perhaps squirrel the odd bag in the woods after dusk?

More often than not, uncollected plastic waste is simply set on fire as a cost-free and effective method of disposal. Our model suggests that cumulatively, more than 2.2 billion tonnes of plastic will be open burned by 2040, far more than the 850 million tonnes that's anticipated to be dumped on land and the 480 million tonnes in rivers and seas.

Having tracked the sources of plastic items through the supply chain and their fate in the environment, we explored what might help reduce aquatic pollution. We found that the single most effective intervention is to provide a service for the two billion people who currently don't have their waste collected.

But, of the nine interventions

fighting the pollution crisis who on their own. Only an integrated to recognise their tremendous increasing collection coverage includes interventions such as reducing demand for single-use and unrecyclable plastic and improving the business case for mechanical recycling, could be successful. For the countries suffering most from plastic pollution, this knowledge could offer a way forward.

> But even in our best-case scenario, in which the world takes the kind of concerted and immediate action proposed in our study, approximately 710 million tonnes of plastic waste will be released into the environment by 2040. That may sound a lot, but it would mean an 80% reduction in the levels of plastic pollution compared to what will happen with no action over the next two decades.

COULD WASTE PICKERS SAVE

Our work also cast light on the contributions of 11 million waste pickers in low and middleincome countries. These informal workers collect waste items, including plastics, for recycling, to secure a livelihood for day-to-day survival. The model estimates that they may be responsible for 58% of all plastic waste collected for recycling worldwide – more than the combined formal collection services achieve throughout all the high-income countries put together.

Without this informal waste collection sector, the mass of plastic entering rivers and the ocean would be considerably greater. Their efforts should be integrated into municipal waste management plans, not only

approach that in addition to contribution but to improve the appalling safety standards that they currently endure.

Establishing a comprehensive baseline estimate of sources, stocks and flows of plastic pollution, and then projecting into the future, has been an immense task. When it comes to solid waste, the availability, accuracv and international compatibility of data is notoriously insufficient.

Plastic items occur throughout the world in tens of thousands of shapes, sizes, polymer types and additive combinations. There are also considerable differences in cultural attitudes towards the way waste is managed, how plastic products are consumed, and the types of infrastructure and equipment used to manage it when it becomes waste.

Our modelling effort was a delicate and tedious exercise of simplifying and generalising this complexity. To understand how reliable, accurate, and precise our findings are likely to be, think of the first models that estimated how sensitive the climate is to human influence back in the 1970s.

Hopefully, the strong evidence base we have presented today will inform a global strategy and strong local preventive action. The plastic pollution challenge can be substantially controlled within a generation's time. So, is anyone ready to act?

The office is dead! Long live the office in a post-pandemic world

The future of the office has become an open ■ question after the coronavirus lockdown forced tens of millions of Americans to work from home. Will office workers flock back to their cubicles and water coolers when the pandemic ends? Or will employees want to hold on to their newfound freedom and flexibility, while employers eye the lower costs of the lack of a physical footprint?

At least a few companies have already answered this question: Twitter, for example, says most of its employees can continue working from home forever, making the office merely a place to meet clients. We asked three scholars to weigh in on the future of the office.

RELATIONSHIPS NEED PROXIMITY

BETH HUMBERD and SCOTT LATHAM, University of Massachusetts, Lowell

Although we've seen numerous office epitaphs in recent weeks, we believe the pre-pandemic workspace isn't going away anytime soon. Why?

Organizational life is founded on relationships. Sure, the current remote work experiment has demonstrated that more jobs can be done virtually than many managers previously assumed. But jobs are comprised of tasks; organizations are comprised of relationships. And relationships require ongoing – and often unintended - interactions.

Decades of research provide important insight into how effective work relationships are built. We know that they require mutual trust and cooperation, and that physical proximity is critical to fostering trusting and cooperative relationships.

This is especially true in the knowledge and creative economies, as shared space promotes information sharing and collaboration. A 2009 study found that Google employees sharing physical space exchanged information more effectively than those located even on separate floors in the same building. A similar study from 2013 showed that when scientists had to walk further from the lab to places like the restroom or the printer, they developed more research collaborations. And a more recent study found that "water cooler" socialization was critical to new idea generation at business incubators, which support the growth of startup companies.

And as robots take over more human jobs thanks to automation and artificial intelligence, these relationships will matter more than ever. Our own research has found jobs that are inherently relational are more likely to endure.



So we believe that it's not the office itself that will remain but the necessity of physical proximity to keeping the modern organization – and our work relationships - running smoothly.

WORKER FLEXIBILITY IS HERE TO STAY **DEBORAH SALON,** Arizona State University

Office employees want more flexibility in where they work. That's the main finding from a survey I'm conducting with other researchers at Arizona State University and the University of Illinois.

Our survey aims to understand how the nationwide lockdown that forced much of the professional workforce to telecommute changed employee views on going to the office, among other topics. The survey is ongoing and, if you are at least 18 and live in the U.S., you can take it online. The results reported below reflect nearly 2,100 responses collected from mid-April to mid-July and have been weighted to the U.S. population in terms of age, gender and education level.

Our data indicates that nearly two-thirds of those who still had jobs during the pandemic were almost exclusively working from home. That compares with just 13% of workers who said they did so even a few times a week pre-

Among those who had previously not regularly worked from home, 62% said they were enjoying the change, and 75% expect their employers to continue to provide flexibility in where they work after the pandemic has passed.

Of course, there may be a gap between employee expectations and the reality of what employers are willing to provide. One of the arguments companies have traditionally used in opposing offering workers more flexibility is the belief that they are less productive or efficient

working from home.

But even at a time when workers face many distractions, particularly those with young children, nearly two-thirds of our working respondents reported normal or above-normal productivity. This is consistent with prior psychological research on remote work that found that those who telecommute often perform about the same or somewhat better than their in-the-office colleagues. Workers in our survey credited not having to commute to the office and fewer distractions such as meetings for their increased productivity.

That's why I believe the future of office work is likely to be much more flexible than ever before. Overall, including those who previously worked from home, a full 26% said they plan to work remotely at least a few times each week when the pandemic is over – double the 13% that said they did so prior to it.

Only 9% of the workers we surveyed, however, said they want to completely abandon the traditional office. They seem to just want more balance. Given the option, many office workers would like to commute to a traditional office on some days and work from home on others.

With luck and a bit of good planning, I believe the U.S. workforce could become not only more productive post-pandemic, but also enjoy their lives just a little bit more.

Dewangan and other officials had gone to Malgaon for levelling work of a pond in the acquired land area when one Dilraj Singh, his brother and mother, and some locals reached the spot and tried to obstruct the work, the police official said quoting the complaint.

held them hostage for about two hours and thrashed Dewangan, Mine Manager Manoj Kumar, Mine Security Officer DK Meshram and security incharge Ugrasen with sticks before releasing them, he added.

With the fresh infections, the total number of cases rose to 1,056, State Surveillance Officer Dr L Jampa said.

Of the new cases, 30 were reported from Papum Pare district, five from Tirap, three from Lohit, two from Lower Dibang Valley and one each from Namsai and West Kameng and 23 from the Capital Complex region, he said.

"All the 30 infected people in Papum Pare are Indo Tibetan Border Police personnel and they have been in a



quarantine centre, while the 23 cases in the Capital Complex have been detected from various areas of the region," he said.

Of the five fresh patients in Tirap, two are state police personnel, he said, adding that a healthcare worker, an employee of the Water Resources Department





Camps set to open after NFL, players' union reach agreement

WASHINGTON, Jul 25 (AP): NFL training camps are set to open after the league and the players' union reached agreement on several issues, including future salary cap mechanisms and how players can opt out of the upcoming season because of the coronavirus.

The NFL Players Association's executive committee and 32 player representatives approved the offers Friday.

Players who decide they want to opt out have until Aug. 3 to do so, and they will receive a stipend from the owners. The amount of the stipend will be 350,000 for medical opt outs and 150,000 for voluntary opt outs, two people with knowledge of the decisions told The Associated Press.

The people spoke to the AP on condition of anonymity because the stipend amount was not made public.

A Texas hospital overwhelmed by the coronavirus may send some patients home to die

(CNN): Doctors at a hospital along the US-Mexico border may decide to send coronavirus patients "home to die by their loved ones" due to limited resources, officials say.

Government and health officials in Starr County announced this week they are creating committees to review patients' cases at the Starr County Memorial Hospital in Rio Grande

At least 50% of the patients admitted in the emergency hospital's room have tested positive for Covid-19, Dr. Jose Vasquez, the county's health authority, said in a news conference earlier this week.

"The situation is desperate," he said.

This rural South Texas county began seeing an increase in positive cases about a month ago, Vasquez said, and the hospital admitted its first Covid-19 patient at that

The hospital quickly filled the eight beds in its Covid-19 unit, so it expanded to 17 and then 29 beds. Vasquez



said. About 33 medical including practitioners medical and lab technicians, were deployed by the state to assist the hospital.

"Unfortunately, Starr County Memorial Hospital has limited and resources doctors are going to have to decide who receives treatment, and who is sent home to die by their loved ones," Starr County Judge Eloy Vera wrote in a Facebook post on Thursday. "This is what we did not want our community to

Vasquez said it was a difficult decision to start reviewing the cases but with limited resources, officials have to consider who has a *the best chance* of survival.

"Those patients who most certainly don't have any hope of improving, we believe they are better taken care of within their own family in the love of their own home rather than thousands of miles away, dying in a hospital room alone," Vasquez

At least 40 new coronavirus cases were reported on Thursday Starr County. bringing the county's total to 1,701. There have been 17 deaths linked to the virus and 32 others are pending state confirmation, local health officials said.

"When we about people who have died in our community, we are talking about uncles, cousins, siblings, a coworker, a relative," Vasquez said. "We are talking about people who had a close relationship with any of us one way or another."

An estimated 64,000 people live in Starr County, according to data by the US Census Bureau.

The pandemic surge has been particularly hard along the Texas-Mexico border. Starr County's neighbor. Hidalgo County, has turned into one of the state's main coronavirus hotspots.

Texas Gov. Greg Abbott announced on Sunday that five US Navy teams were being deploying to South Texas to help combat the spread of the virus.

A new shelter-athome order began Friday in Starr County, nearly three months after Gov. Abbott ended the state's stay-at-home order, businesses allowing to reopen at limited capacity. Texas was one of the first states to reopen its economy.

The county's order set to remain in place until August 10 and requires residents to shelter at home, including those who live in hotels, motels and shared rentals.

Trump talks up his rule-cutting, but courts saying otherwise

WASHINGTON, JUL 25 (AP): President Donald Trump is positioning himself as a champion regulation-cutter in the leadup to the Nov. 3 election, but in between his showy red-tapecutting events, his deregulatory agenda is taking a beating in the courts.

One day, he's hailing a massive rollback to one of the nation's most important environmental laws, which he hopes will speed up gas pipelines and all kinds of other big projects.

Another, he's holding forth between two pickup trucks being used as props on the South Lawn of the White House a blue one piled with weights identified as government regulations and a red one, of course, that has been unburdened.

But there's a sharp disconnect between the president's muscular rhetoric and the many courtroom battles he's

Trump's deregulatory victories have been shrinking in number as courts uphold many of the lawsuits filed by states, environmental groups and others in response to his administration's sometimes hastily engineered rollbacks.

Just hours before Trump's South Lawn event, for example, a federal judge reinstated an Obama-era rule that required oil and gas companies operating on public lands to take reasonable measures to stop climate-damaging methane emissions.

Those were three really huge decisions all across the span ... where the Trump administration was rebuked across the board," said Vickie Patton, general counsel of the Environmental Defense Fund, who had a role in all three cases.

Bethany Davis Noll, director of New York University's Institute for Policy Integrity, estimates the administration has emerged victorious in 15 percent of the regulatory lawsuits. Previous administrations generally won about 70 percent, she said.

To be sure, the president has had a few wins, and many important cases are not yet resolved.

Among administration's victories: It scrapped an Obama-era regulation that imposed tougher restrictions on hydraulic fracking operations. also signed Trump resolutions disapproval that passed Republican-led

Congress, overturning an array of rules issued by federal agencies in the final months of Barack Obama's presidency. But where Trump

has really made his mark is throttling back new regulations, said Cary Coglianese, a professor at the University of Pennsylvania Carey Law School and director of the Penn Program on Regulation.

There's just been much less new regulation of great consequence during the last three and a half years, Coglianese said.

With respect to peeling back existing regulations, Coglianese finds Trump efforts to be limited and mostly aimed at undoing the work of his predecessor.

throwing out Obama's legacy efforts to moderate climate change by mandating far more fuelefficient vehicles and setting the first limits on carbon pollution from U.S. power plants.

Other administration efforts would greatly weaken the scope of two laws that have served as the foundation for a half-century of public health and environmental regulation, removing federal protections for millions of miles waterways wetlands and reining in environmental reviews and public input for major projects.

Among modern-day presidents, Coglianese said, Democrat Jimmy Carter was probably the most impactful, deregulating the airline, trucking and railroad industries. Democrat Bill Clinton systematically got rid of outdated regulations through a reinventing government initiative.

With Trump, there's a lot more smokeand-mirrors to deregulatory than the administration paints, Coglianese said. It's certainly not at all the driver of economic growth during the pre-COVID period of the administration and certainly not to take us out of the economic troubles we find ourselves in. The president early in his administration directed agencies to scrap two regulations for every new one they create. The White House said last week that it has taken seven deregulatory actions for every significant new rule.

But even the White House's own records reflect that many of those rulecutting measures were minor. The ratio falls to 2 to 1 over the past two years when only significant rules are considered. The

president's pose between the two pickups was designed as a reminder to supporters not as an overture to win over new ones that if you distrust regulations, Trump is still your guy, said Daniel Bosch, who tracks regulatory policy at the conservative American Action Forum.

Australia declares 'there is no legal basis' to Beijing's claims in South China Sea

ustralia says China's Aclaims to disputed islands are 'invalid' and are not consistent with UN convention on law of the sea

Australia has declared "there is no legal basis" to China's territorial and maritime claims in the South China Sea, marking an escalation of recent tensions with Beijing and bringing Canberra further in line with Washington.

declaration, made in a submission to the United Nations on Thursday, comes after the United States hardened its position earlier this month, accusing Beijing of a "completely unlawful ... campaign of bullying" to control the sea.

Australia's shift in position comes as Australia's foreign affairs minister, Marise Payne, and the defence minister, Linda Reynolds, prepare to travel to Washington next week to meet with the US secretary of state, Mike Pompeo, and the secretary of defence, Mark Esper, for the 2020 Australia-United States Ministerial Consultations (Ausmin).

The declaration to the UN said: "Australia rejects China's claim to 'historic rights' or 'maritime rights and interests' as established in the 'long course of historical practice' in the South China Sea."

Australia's declaration mentioned the objections and complaints held by the Philippines, Vietnam and Malaysia in regards to Beijing's actions in the South China Sea, and "rejects" the validity of "land building activities" used to create artificial islands.

The declaration said Australia does not accept China's claim of sovereignty over the Paracel Islands and Spratly Islands, after



warships Australian encountered China's navy near the Spratly Islands earlier this month when taking part in drills with Japan and the United States in the Philippine Sea.

It notes "the Tribunal in the 2016 South China Sea Arbitral Award found these claims to be inconsistent with **UNCLOS** (United Nations Convention on the Law of the Sea) and, to the extent of that inconsistency, invalid".

"There is no legal basis for China to draw straight baselines connecting the outermost of maritime points features ʻisland or groups' in the South China Sea, including around the 'Four Sha' or 'continental' or 'outlying' archipelagos," it said.

"Australia rejects any claims to internal waters, territorial sea, exclusive economic zone and continental shelf based on such straight baselines.

"Australia also rejects China's claims maritime zones generated by submerged features, or lowtide elevations in a manner inconsistent with UNCLOS. Land building activities or other forms of artificial transformation cannot change the classification

feature under UNCLOS ... the Australian government does not accept that artificially transformed features can ever acquire the status of an island."

Earlier on Saturday, Payne and Reynolds said "discussions at Ausmin 2020 will centre on our shared efforts towards a stable, resilient, open, secure and prosperous Indo-Pacific, particularly in the context of the impact of Covid-19".

"Our relationship is built on our shared values, and a shared understanding importance of maintaining presence and leadership in our region.

"In the face of an increasingly complex and contested regional environment, it is vital we continue working together across the breadth of our relationship."

The joint statement also reiterated that "the United States remains by far Australia's largest of source foreign investment".

The ministers also wrote an opinion piece in Saturday's the Australian newspaper noting "coercive actions in the South China Sea, such as the escalation of disputes and militarisation of disputed features, continue to tensions that destabilises the region".


The opposition leader, Anthony Albanese, said Australia needed to defend the "national interest" when asked about the change in position on Saturday morning.

"We also need to stand up for international law," he said. "And the international law of the sea provides for freedom of navigation which is absolutely critical to international trade."

Tensions between Australia and China escalated earlier this year as Canberra pushed for an inquiry into Beijing's initial handling of the Covid-19 outbreak, with Australia's trade minister, Birmingham, Simon complaining his Chinese counterpart would not answer his calls in May.

Since then, China has issued a warning to its citizens, and lucrative international student market, not to travel to Australia out of fears of racism. In June, Chinese foreign ministry spokesman Zhao Lijian accused Australia of mass espionage and of "stoking confrontation".

Rising tensions have prompted Australian business leaders, who are worried further hostilities could damage

4 Things Mark Cuban Says You Should Do With Your MoneyThe 'Shark Tank' investor and Dallas Mavericks owner offers some surprisingly down-to-earth personal finance advice

f you're going to take personal finance 🛮 advice from anyone, you can't do much better than Mark Cuban. The Shark Tank shark and Dallas Mavericks owner sold his first startup to CompuServe in 1990 for \$6 million. Then he sold his second business to Yahoo for \$5.9 million in 1999. Since then he's started or acquired several other businesses and invested in many more. His current net worth is estimated at about \$4.2 billion.

For someone who's gotten extremely rich taking risks on a lot of investments, Cuban has some surprisingly downto-earth advice to share. The personal finance site GOBankingRates has carefully reviewed Cuban's book, blog, and interviews, distilling out 20 pieces of financial advice he's offered over the past few years. You can find the full list here. These are some of his best tips.

1. Start by paying off all debt.

"The best investment you can make is paying off your credit cards, paying off whatever debt you have." Cuban said in an interview with MarketWatch. "If you have a student loan with a 7 percent interest rate, if you pay off that loan, you're making 7 percent, that's your immediate return, which is a lot safer than picking a stock, or trying to pick real estate, or whatever it may be."

Credit cards, of course, have a much higher interest rate so there's an even bigger benefit in getting them paid off. "Using a credit card is OK if you pay it off at the end of the month," Cuban told an interviewer from Money. "Just recognize that the 18 or 20 or 30 percent you're paying in credit card debt is going to cost you a lot more than you ever could earn anywhere else." For debt that can't be quickly paid off (a mortgage or student loan, for example) he suggested taking

advantage of low interest rates during economic down times to refinance.

2. Save six months of income.

You should try to save up six months of income and keep it available, Cuban told Vanity Fair. "If you don't like your job at some point or you get fired or you have to move or something goes wrong, you're going to need at least six months income," he explained.

3. It's OK to make risky investments, but they should only be 10 percent of the total.

millionaires Self-made and billionaires got there by taking calculated risks, Cuban acknowledges. So investing in something completely risky is just fine -- so long as you limit it to only 10 percent of your overall investments. "If you're a true adventurer and you really want to throw the Hail Mary, you might take 10 percent and put it in bitcoin or Ethereum, but if you do that, you've got to pretend you've already lost your money," Cuban said in that same Vanity Fair video. "It's like collecting art, it's like collecting baseball cards, it's like collecting shoes." In other words, "It's a flyer, but I'd limit it to 10 percent."

What should you do with the other 90 percent? Put it into the cheapest index fund tied to the S&P 500 that you can find, he says.

4. Shop for discounts.Is this really personal finance advice? Yes, Cuban says. It's tough to make a high rate of return in today's investment climate, so you could be better off, say, buying two years worth of toothpaste if you find it at 50 percent off.

"Saving 15 percent on \$1,000 worth of items you know you will absolutely spend money on is a better return on your money than making 15 percent in a year on a \$1,000 investment because you don't pay taxes on it," he explained in a blog post.

You don't really think of bringing home bulk items from Costco in the same way that you do putting money into a mutual fund. But look at it the way Cuban does, and suddenly it makes
