#### West Bengal reports record 3,340 new COVID-19 cases

KOLKATA, OCT 3 (PTI): West Bengal on Saturday reported its highest singleday spike of 3,340 new COVID-19 cases, taking the tally to 2,66,974, according to a bulletin issued by the Health Department.

Sixty-two more patients died in the state, following which the toll rose to 5,132, it said.

The discharge rate in the state improved to 87.92 per cent as the state saw 3,013 recoveries.

The number of active patients stood at 27,130.

In the last 24 hours, 41,128 samples have been tested for COVID-19 in the state, the bulletin said.

WASHINGTON, 03 OCT [REUTERS]: Early in the coronavirus pandemic, U.S. President Donald Trump put his faith in a toaster-sized machine that could spit out test results in a matter of minutes.

the launch of Abbott Laboratories' ID NOW test at a Rose Garden event and embraced its widespread use at the White House to keep the deadly virus at bay. The president often skipped his own administration's public health recommendations on mask wearing and social distancing, explaining that "everyone's tested" around him using the Abbott device.

His strategy was no match for the virus.

The president announced Friday that both he and his wife, Melania, tested positive - news

that raised questions about the contain the spread of a highly health of other top U.S. officials and threw the final weeks of the presidential campaign into disarray. On Friday, Trump began an experimental treatment and checked in to Walter Reed National Military Medical Center In late March, Trump hailed as a precautionary measure, a White House official said.

"The reliance on a rapid test, with its limitations, unfortunately gave the White House and its staff a false sense of security that they were in control of the virus," said William Schaffner, a professor of infectious diseases at the Vanderbilt University School of Medicine.

"You cannot rely on that test to create a barrier between you and the virus," he said, adding that people "have to wear masks, do social distancing and not go to all these rallies."

While rapid tests can help

contagious virus, they were not designed to be used in isolation. A negative result merely captures a snapshot in time and doesn't guard against infection soon after. And a person may be infectious for days before the amount of virus in their body registers positive on a test.

Krutika Kuppalli, an assistant professor and expert on infectious diseases at the Medical University of South Carolina, said not enough is known about how these rapid tests perform in people who are asymptomatic.

"Trump was playing with fire and it was really a matter of time before something like this was going to happen," she said. "Even if Trump had been around someone who was sick, wearing a mask could have prevented him from getting the virus."

## India's COVID-19 death toll crosses one lakh



NEW DELHI, OCT 3 (PTI): India's COVID-19 death toll crossed one lakh and the infection tally climbed to 64,73,544, while the number of people who have recuperated from the disease crossed 54 lakh pushing the recovery rate to 83.84 per cent, the Union Health Ministry said on Saturday.

The total coronavirus cases mounted to 64,73,544 with 79,476 new infections being rethe death toll climbed to 1,00,842 with the virus claiming 1,069 lives in a span of 24 hours, data updated at 8 am showed. The total recov-

eries have surged to 54,27,706, while there are 9,44,996 active cases of coronavirus infection in the country which comprises 14.60 per cent of the total caseload, the data showed.

The COVID-19 case fatality rate was recorded at 1.56 per cent. India's COVID-19 tally had crossed the 20-lakh mark on August 7, 30 lakh on August 23 and 40 lakh on September 5. It went past 50 lakh on September 16 and crossed 60 lakh on September 28.

According to the Indian Council of Medical Research (ICMR), a cumulative total of 7,78,50,403 samples have been tested up to October 2, of which 11,32,675 were tested on Friday.

People who have had the COVID swab test say that it feels like their brain is being pierced by an oversized cotton bud. Recent lurid headlines will not put people at ease. "Woman's nose 'starts leaking brain and spinal fluid' after she took a Covid swab test", said the Daily Star. "Coronavirus swab test went so far up a woman's nose it caused

But where did this story come from - and should we give it any credence? The newspaper reports are based on a case study published in a respected medical journal, JAMA Otolaryngol Head & Neck Surgery. It tells of a woman in Iowa, USA, who was asked to self-swab for COVID before undergoing a hernia operation. Shortly after

swabbing, fluid began leaking from her nose. She also developed a headache and started

vomiting. The doctors at the University of Iowa hospital, where she was treated, identified the fluid as cerebrospinal fluid - a fluid that is found in the protective lining around the brain and spine.

#### RID MP moves SC challenging validity of new farm laws New Delhi, Oct 3 (PTI): RJD MP Manoj Jha has moved the Supreme Court challenging the constitutional validity of the newly enacted three agriculture laws, saying they are "discriminatory

and manifestly arbitrary"

and will expose marginal

farmers to exploitation

by big corporates. Parliament has recently passed the three Bills -- the Farmers' (Empowerment and Protection) Agreement of Price Assurance and Farm Services Act, 2020, the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020 and the Essential Commodities (Amendment) Act 2020. These have came into effect from September 27 after President Ram Nath Kovind gave his assent. Jha, a Rajya Sabha member of the Rashtriya Janata Dal (RJD), has filed the plea in the top court through lawyer Fauzia Shakil.

Besides Jha, Congress Lok Sabha member from Kerala TN Prathapan and Dravida Munnetra Kazhagam (DMK) Rajya Sabha member from Tamil Nadu Tiruchi Siva had moved the top court against the farm laws.

Jha, in his plea, said, "The impugned legislations corporatise agriculture and ushers in an unregulated and exploitative regime. A farmer would not have the knowledge to negotiate the best terms with a private company. This leads to unequal bargaining position in negotiating the farm agreement with corporates would lead to corporates monopolising the agriculture sector."

The plea said the laws have been passed by Parliament "in breach of the Parliamentary Rules and convention and the impugned acts are unconstitutional on the ground that it is discriminatory and manifestly arbitrary and further violates the Basic Structure of the Constitution."

These laws encourage "corporatisation" of Indian agriculture which is the lifeline of the poor farmers and key to the survival of the nation's agriculture sector, it said.

"The impugned Acts primarily intends to sacrifice the interest of the farmers and leave them at the mercy of the sponsors without any proper dispute resolution mechanism.

#### Centre to waive certain interest levies on loans in COVID-19 relief

NEW DELHI/MUMBAI. 03 Oct [Reuters]: The Indian government has told the Supreme Court it will waive certain interest levies on loans up to 20 million rupees (\$272,888) under a CO-VID-19 support plan, a legal filing showed, in a move that will bring relief to millions of borrowers.

While the government did not disclose the impact on the banking sector, an analyst at credit ratings firm ICRA estimated it will cost New Delhi a maximum of 50-70 billion rupees (\$682 million-\$955 million).

"We expect the impact to be minimal on profitability of lenders," said ICRA's Anil Gupta.

In a filing on Oct. 2 with the Supreme Court, seen by Reuters, the government said it had decided to waive the compounding interest component on small business and some other loans related to education and

dues. "The government bearing this burden would naturally have an impact on several other pressing commitments being faced by the nation, including meeting direct cost associated with pandemic management, addressing basic needs of the common man," the filing added.

If the government were to consider a complete waiver of interest payments over a sixmonth moratorium period, as some had sought, it would cost 6 trillion rupees (\$82 billion), the filing said.

"If the banks were to bear this burden, it would necessarily wipe out a substantial and a major part of their net worth ... this was one reason why waiver of interest was not even contemplated," the government's legal document said.

The Indian govern-"interest-on-interest" on ment's filing said that all borrowers will benefit from the decision, irrespective of whether they opted for the moratorium or not. It was not immediately clear how such relief will be provided.

> India's finance ministry did not immediately respond to a request for comment. Gaiendra Sharma, the Indian optician who filed the first case in the Supreme Court, applauded the decision.

#### No, you cannot...

Not really. The 40-year-old woman had a preexisting defect in the base of her skull (the bone at the top of the nose) and a sac of brain tissue had protruded out into the nasal cavity. This is a rare condition that we see in neurosurgery and in ear, nose and throat clinics.

About one in 10,000 babies are born with a defect like this, but the rate at which it occurs in adults is unknown. In this lady's case it was probably because the pressure inside her skull around the brain was higher than normal, creating a weak spot.

It is extremely unlikely for any person who doesn't have this pre-existing weakness in the nose to cause any damage with a swab. However, a good tip when swabbing the nose is to remember that the inside of the nose travels back, towards the back of the head, and not up. So any swabbing of the nose should involve pointing the swab towards the back of the head in the same direction as you would point the swab towards your tonsil when you swab your mouth - which is part of the same test.

Please do not be afraid of having your nose swabbed. It may be uncomfortable, but you cannot accidentally jab your brain. The swab test is our only way of telling who has and who hasn't got COVID. It's a vital public health tool to help us bring this pandemic under control.

An Abbott spokeswoman said the company's ID NOW test for the coronavirus - used by more than 11 million Americans since regulators approved it for emergency use in March - yields reliable results. The company referred questions about its use in the White House to the Trump administration.

The gold standard in diagnostic testing is known as polymerase chain reaction, or PCR, testing and is performed in a laboratory. But these tests can take hours or days to process. Abbott's ID NOW device offers two major advantages: a quick turnaround on site and portability.

The Abbott test, which involves putting a nasal swab in a liquid solution and heating it to amplify genetic material from the virus, produces results in 13 minutes or less.

"In a pandemic, the world needs all

types of testing for different settings and stages of the virus, including labbased testing and rapid point-of-care testing." Abbott said in a statement. The White House hasn't released

details on what tests were conducted in recent days on Trump and Hope Hicks, a top White House adviser who also tested positive this week. And there is no evidence that the Abbott tests routinely performed on White House staff and visitors produced inaccurate results, nor that Trump or Hicks were infected in the White House rather than in other settings.

However, despite Trump's enthusiastic endorsement of the Abbott ID NOW test, some researchers have raised doubts about its accuracy. In May, a New York University study

said the Abbott test could be missing a third to nearly half of positive cases. That same month, researchers at Columbia University Irving Medical Center found that the ID NOW test identified only 73.9% of infectious samples.

The U.S. Food and Drug Administration acknowledged there were concerns about "potential inaccurate results" from ID NOW in May. The agency reports as of Sept. 30, including numerous reports of false negatives - results showing patients were not infected when they actually were.

Tight security, many arrests for Ethiopian Irreecha festival JOHANNESBURG (AP): ETHIOPIA'S largest ethnic group, the Oromo, on Saturday celebrated the annual Thanksgiving festival of Irreecha amid tight security and a significantly smaller crowd due to political tensions and the COVID-19 pan-

Hundreds of people were arrested ahead of the festival, some accused by authorities of plotting terror attacks and a new wave of unrest.

Wearing face masks white clothes stitched with the colors of the Oromia region's flag, people in downtown Addis Ababa were subjected to at least six security checks complete with body searches and, in some areas, sniffer

"I don't know the kind of information they have but these security checks are too much," said Hassen, a participant who gave only his first name, fearing for his safety. "Added with the COV-ID-19, it really has ruined the festive mood."

The festival ally attracts hundreds of thousands of people, but only a few thousand were allowed to attend this

More than 500 people were arrested on suspicion of plotting to disrupt the festival, the Oromia police commission said Thursday. On the same day, the National Intelligence and Security Service said it had arrested people suspected of planning to carry out terror attacks and cause unrest at the celebrations in Addis Ababa and nearby Bishoftu, adding that 10 Kalashnikovs were seized.

People travelling to the capital from other regions were banned from entering the city, multiple sources told The Associated Press. Officials said they were carrying out strict security checks but did not confirm the ban.

Notably, people carrying the Oromo Liberation Front and Oromo Federalist Congress party flags were absent in this year's festival. Some of the parties' leaders are behind bars for alleged involvement in the deadly unrest that followed the killing of popular Oromo singer Hachalu Hundessa in June. On Friday, an Ethiopian court charged four people suspected in the killing, which led to turmoil that saw more than 180 people and thousands arrested.

The Oromo, while the country's largest ethnic group, traditionally have expressed frustration over perceived marginalization. Prime Minister Abiy Ahmed is the country's first Oromo leader, but he faces growing criticism by some Oromo that he hasn't done enough for them.

The Irreecha festival marks the end of the rainy season and the start of the harvest. It has seen violence in the past.

During the 2016 celebration in Bishoftu, a town 40 kilometers from the capital, several dozen people were crushed to death in a stampede after police fired tear gas and rubber bullets to disperse anti-government protesters.

#### Pope Benedict XVI approved bishop accord with China

ROME (AP): The Vatican doubled down Saturday on its intent to pursue continued dialogue with China over bishop nominations, defending a deal it did with the Chinese government in 2018 as necessary to the life of the Catholic Church there, over strong U.S. objections.

The Vatican secretary of state, Cardinal Pietro Parolin, gave the Holy See's most authoritative and comprehensive response to critics of the extended accord during a speech marking the 150th anniversary of the arrival in China of Catholic missionaries from an Italian religious order.

Parolin insisted that popes as far back as Pius XII had tried to reopen a path of dialogue with Beijing after the communists came to power and expelled foreign missionaries. And he confirmed that Emeritus Pope Benedict XVI had approved the draft accord that the Vatican under Pope Francis eventually signed in 2018.

Parolin's assertion that Benedict had approved the draft is significant and was aimed at silencing some of Francis' conservative critics, many of whom are nostalgic for Benedict's conservative papacy and have used the China agreement to undermine Francis.

The Vatican is seeking to extend the deal with China, which envisages a process of dialogue in selecting bishops. It signed it in 2018 in hopes it would help unite China's Catholics, who for seven decades have been split between those belonging to an official, state-sanctioned church and an underground church loyal to Rome.

The question of bishop nominations has long vexed Vatican-China relations, with the Holy See insisting on the pope's divine right to name the successors of the apostles and Beijing considering such nominations foreign infringement on its sovereignty.

The Vatican has defended the 2018 accord against criticism that Francis sold out the underground faithful, saying the deal was necessary to prevent an even worse schism in the Chinese church after China named bishops without the pope's consent.



#### **Politics Demands Commitment**

#### ...but slack accountability makes casual flirtations too easy

**P**olitics is an exciting engagement, one that evokes passionate stands and distracts very easily. Where Sikkim is concerned, its political milieu has been traditionally populated rather extensively by teachers and midlevel government servants. Nothing wrong with having political leanings, in fact that would be a healthy engagement in a democracy, but everyone knows that involvement here used to extend much beyond that. It is also difficult in a State as small as Sikkim for anyone of any significance to remain genuinely apolitical. And as mentioned earlier, unless politics is really "dirty", there is nothing wrong in having a political position even if your job description requires you to stay detached. What is important though is for the people concerned to keep their responsibilities (as government servants or "social workers") and interests and (political) beliefs in separate silos. Unfortunately, government servants, given the astoundingly slack concepts of accountability enforced by the administration, are easily tempted to flirt with politics. In systems where accountability is casually fixed and job-responsibilities poorly defined, it is easy to start dispensing favours and bending rules; and before one knows it, the administrators become rather deft political players themselves. Engagement with party level politics follows and then come political ambitions.

What blurs the line even more is the confusion with which politics is mixed up with administration and government mistaken for a party. Also, in a political environment thick with parties and slim on ideological differentiators, the decision to take the plunge comes easy because options never dry out and crossovers rarely need to be explained with any conviction. Not just government servants, but this situation makes it easy for everyone to 'try out' politics, move around political parties, taste all options and if nothing works out, step back into a supposedly "apolitical" life only to resurrect whenever occasion demands or opportunity arises. It is the facility with which this last option [the one of turning apolitical whenever it suits one] can be acquired that makes irresponsible dabbling in party politics so easy for most wannabes here.

Let us agree first that while ideological political positions are absolutely acceptable, and even welcome, it is the tendency to engage in 'active' politics, the one involving planning and negotiating, that vitiates work cultures and political engagements. This latter involvement diverts attention from the tasks they draw salaries for [in the case of government servants], and should they be aligning with factions opposed to the ruling party, could also lead to willful compromising of policy implementation. In the case of private people involved in "social work", simultaneous political and social pursuits come at the cost of sabotaging their responsibilities towards society. And this cannot be dismissed as inconsequential even if they are volunteering their time and energies, because when one occupies a public space, one is required to remain earnest and not allow their priorities to get colored by political exigencies.

Politicians rarely suffer the fallout of such situations and the loss, in the long run, is burdened on the people whom the politicians, the government employees and the social workers should be serving first. Politics does not compromise governance or administration; it is the ambitious politicking that robs people of deserved delivery. For that reason alone, it is advisable to maintain a healthy interest in politics and also hold opinions, but leave the politicking to politicians; and if one is to engage actively, then doing so with full commitment.

## 500 whales stranded in Tasmania – indigenous elders are best guides to understanding this tragedy

lose to 500 pilot whales beached themselves in September 2020, in what has been described as Australia's biggest mass stranding on record. Rescue efforts saved 108 of the marine mammals, which belong to the dolphin family, but scientific attempts to explain the tragedy have so far offered only theories, including sickness, navigational errors, and sudden changes in the tide.

Indigenous peoples throughout the Pacific, including the Maori of Aotearoa (New Zealand), have been raising the alarm for some time. For generations, people here have watched the movements of these whales closely to help them navigate the world's largest ocean.

For the Aborigines of Australia and indigenous communities throughout the Pacific, changes in whale behaviour are ominous. With a rich oral history to draw from, the indigenous people of the Pacific are among our best guides for making sense of the recent strandings, and the wider environmental changes they portend.

OCEAN GIANTS IN PACIFIC FOLKLORE

The slipstreams of whales and dolphins weave throughout the folklore of the Pacific Islands. The Maori tell the story of Paikea who, when faced with drowning due to the machinations of his evil brother, recited an incantation and summoned a whale to save himself.

The seaways between the Central Carolines and the Marianas would chant of Ikelap - "the big fish"

- when it was sighted by voyagers. It was a signpost that the journey was nearing the east coast of Guam. Western mariners would come to know this big fish as the pilot whale – a namesake that speaks to it being a dependable guide.

It's a common belief among many different Pacific communities that whales and dolphins are spirit transformations or carriers of ancestors. As such, whales are often sought for spiritual guidance to decide where to settle and when to avoid fishing or sailing.

Changes in whale migratory routes, songs and unusual surfacing behaviour are all instructive, and observations of distressed whales - to a degree that's far outside the norm – are interpreted as significant omens. In Tikopia, part of the Solomon Islands, the stranding of whales signified imminent spiritual danger.

Since their whaling rights are protected under the International Whaling Commission, indigenous catch reports have also been used to help track whale populations and to identify when commercial whaling was depleting populations in the past.

Indigenous accounts are invaluable as they provide a reliable, long-term record of how whale populations have changed over time according to changes in their environment.

WHAT THE WHALES FORETOLD

Environmental change in the Pacific is not new. Oral history recalls when, at the end of the last ice age, fenua imi (an island-eating demon), swallowed the land and forced the migration of its peoples across Oceania. The history of the Pacific is a

history of migration, and the whales and dolphins have accompanied these movements, guiding voyagers across the vast ocean.

Climate change could be considered the modern return of fenua imi. But it comes with additional barriers. Political and legal borders now restrict the free movement of people across the Pacific, even as climate change threatens to inundate these vulnerable islands with storms, rising tides and the destruction of vital habitat such as mangroves and coral reefs.

While much international attention has focused on what sea level rise will mean for the lowlying lands of the Pacific, deep changes within the oceans are just as urgent. One of the North Pacific's worst marine heatwaves on record killed one million seabirds between the summer of 2015 and the spring of 2016. Hotspots of marine biodiversity are threatened by overfishing and deep-sea mining. And while many people have heard of the Great Pacific Garbage Patch, fewer know about the poisons that this floating plastic waste produces, killing microorganisms that produce oxygen and feed marine life. The recent whale strandings, historic in scale, are a reminder that problems in the biosphere cannot be treated in isolation.

Listening to indigenous communities throughout the Pacific about environmental change is not only important, but it is also vital in our attempts to correct the damage done to marine ecosystems.

## Belly fat linked to higher risk of premature death, regardless of your weight

I fat around your waist can be harmful to your health, bringing greater risk of developing illnesses such as type 2 diabetes and heart disease. But a recent study found that, regardless of weight, people who carry more fat around their abdomen had a higher risk of dying sooner - in fact, there was an 11% increase in death during follow up with every extra 10cm of waist circumference.

The researchers included 72 studies in their review, which contained data on 2.5 million people. They then analysed the combined data on body shape measures, looking at waist-tohip ratio, waist-to-thigh ratio, and waist and thigh circumference - in other words, all the areas where a person naturally stores fat.

Beside the finding on belly fat, the researchers also found that people who tend to store more fat on the hips and thighs - instead of their abdomen - had a lower risk of dying sooner, with each extra 5cm thigh circumference associated with an 18% reduced risk of death during the follow-up period (between 3-24 years, depending on the study). But why might this be the case? The answer has to do with the type of fat tissue we tend to store in certain areas of our body.

Body fat (known as adipose tissue) plays an important role in our physiology. Its main purpose is to take glucose from the blood and safely store this energy as lipid inside our fat cells, which our body uses later for fuel. Our fat cells also produce hormone signals that influence many body processes, including appetite. Adipose tissue is therefore important for good metabolic health.

But having too little adipose tissue can affect how well blood sugar levels are regulated in the body. Insu-

It's thought that in some people storage space (or the ability to make new fat cells) sooner than in others. This means more fat will be stored in the less safe visceral depots. Visceral fat can cause inflammation, eventually leading to metabolic and cardiovascular disease. And if fat can

> no longer be stored in adipose tissue, eventually lipid can accumulate elsewhere - including the heart, muscles, and liver - which again can lead to disease.

As with height, your genes play a large part in weight and body shape. Large genetic studies have identified over 400 of the tiniest genome differences that might contribute to body-fat distribution. For example, people who have a mutation in the LRP5 gene carry more fat in their abdomen and less in their lower body. However, these tiny genetic differences are common

in the population, affecting most of us in one way or another - and may explain why humans have such a range of different body shapes.

Unfortunately, this means that it might be more difficult for a person who naturally stores fat around their waist to maintain good health. But research also shows that weight loss can reduce visceral fat and improve metabolic health. So what is important to remember is that body shape is only a risk factor, and even with these differences you can still lower your risk of chronic disease if you maintain a healthy lifestyle.

VISCERAL VERSUS SUBCUTANE-

Body shape is influenced by where fat is stored in our body. For example, "apple shaped" people store more fat around their waist and are likely to store more fat deeper in the body surrounding their organs as visceral fat. "Pear shaped" people have larger thighs, and store more fat more evenly around their body just

stored around the waist also releases more blood triglycerides in response to stress hormone signals compared to hip and thigh fat. High blood trigylceride levels are associated with greater risk of heart disease. This is partly why visceral fat is seen as as more harmful than subcutaneous fat.

On the other hand, hip and thigh subcutaneous fat can better take up these triglycerides from the blood and store them safely, preventing the body from incorrectly storing them in the muscles or liver, which can cause liver disease. Subcutaneous fat tissue can even develop specialised "beige" fat cells that are able to burn fat. For these reasons, subcutaneous fat is

were to ply on Monday, Wednesday and Friday, while even numbered vehicles were to ply on Tuesday, Thursday and Saturday. The restriction was not enforced on Sun-

However, on October 1, wide-eyed traffic cops were seen penalizing odd numbered vehicles along the NH-29, while on October 2, even numbered vehicles were penalized.

Gregory Thejawelie NCS had promptly issued an order on September 30 extending the 'oddeven' system, except on Sundays, till October 31, whereas the Dimapur police had not issued any such order till date. However, eager traffic cops along NH-29 were seen issuing challans to commuters for breaking the odd-even rule, which is illegal since the rule has not been extended to October.

While it is not known whether the district Police authorities had authorized traffic cops in the highway to enforce the odd-even rule and collect fines, Police authorities ought to come clean on whether the odd-even system is still in force in the district or

Besides, since the aforesaid August 14, 2020 order on the oddeven vehicular system expired on September 30, at Dimapur, those challaned in this district on October 1 & 2 also ought to be refunded.

## Left, Congress protest in Kolkata over Hathras incident



KOLKATA. OCT 3 (PTI): Left and Congress activists protested in Kolkata on Saturday against the alleged gang rape of a Dalit woman in Uttar Pradesh's Hathras that has triggered a nationwide outrage.

Carrying placards having slogans such as "Defeat fascist BIP at Centre and TMC in Bengal" and "Down with fascists who throttle democracy", around a 1,000 members of the CPI(M), Congress and their affiliates marched from Moulali to Esplanade in the heart of the city in the afternoon.

As they tried to break

a barricade at Esplanade. trying to go towards a UP government office to protest, a scuffle broke out with the police.

The activists claimed that several of them received injuries in the scuffle, which was denied by the police. Later, they torched effigies of Prime Minister Narendra Modi and Chief Minister Mamata Banerjee at the Esplanade crossing.

"We burnt Modi's effigy for the attack on democratic forces and his failure to curb the rise in the number of rape cases in the country, mostly in UP. We are also burning the effigy of the Trinamool Congress chief for the law and order breakdown in the state and increase in attacks on women," SFI leader Subhajit Sarkar said.

The 19-year-old Dalit woman was allegedly raped at a village in Hathras by four men on September 14. After her condition deteriorated, she was referred to the Delhi's Safdarjung hospital where she breathed her last on Tuesday.

She was cremated in the early hours of Wednesday, with her family alleging the local police forced them to conduct the last rites in the dead of the night.

#### 69 new COVID-19 cases in Ladakh; tally reaches 4,429

LEH, OCT 3 (PTI): The Union Territory of Ladakh has reported 69 fresh COVID-19 cases, raising its tally to 4,429, while 42 patients were cured of the disease in the last 24 hours, officials said on Saturday.

The region has recorded 61 deaths -- 35 in Kargil district and 26 in Leh district -- since the outbreak of the pandemic while 3,274 patients have so far recovered from the infection, the officials said.

Of the 69 new cases -- 64 were reported from Leh and five from Kargil.

Thirty-one COVID patients in Leh and 11 more in Kargil were discharged after successful treatment, the officials said, adding that the number of active patients in Ladakh stands at 1,094 -- 766 in Leh and 328 in Kargil.

#### Mamata takes out rally in Kolkata against Hathras rape

KOLKATA, OCT 3 (PTI): West Bengal Chief Minister Mamata Banerjee on Saturday took out a rally in the city in protest against the Hathras gang rape case in Uttar Pradesh.

The march began at the Birla Planetarium and ended at the Gandhi statue at Mayo Road, about 2 km away.

She had hit out at the BJP government in Uttar Pradesh on Thursday and said just as Goddess Sita had to go through 'Agni Pariksha' in the Ramayana after being abducted by King Ravana, the Dalit woman who died after being allegedly gang-raped and brutalised in Hathras was cremated in the dead of the night.

#### **Tripura reports 190** new COVID-19 cases



Agartala, Oct 3 (PTI): Tripura's COVID-19 tally rose to 26,552 on Saturday as 190 more people tested positive for the virus, a health department official said.

The COVID-19 death toll climbed to 286 with six more people succumbing to the infection, he said.

West Tripura district, of which state capital Agartala is a part, has accounted for 156 of the 280 COVID-19 deaths, the official said

Tripura currently has 5,369 active coronavirus cases, while 20,874 people have recovered from the disease. Twenty- three patients have migrated to other states, the official said.

At least 301 patients were discharged from G B Pant hospital, the main referral hospital for the COVID-19 patients on Friday after they were cured of the disease, he said.

As many as 3,96,416 samples have been tested for COVID-19 in the state so far, the official added.

### Short supply, high demand push egg prices up in Bengal

KOLKATA, OCT 3 (PTI): After onion and potato, eggs, another kitchen staple, became dearer in West Bengal due to a shortage in supply and rising demand, and consumers may not get respite soon from soaring prices of the poultry product with upcoming festive season, traders said on Saturday.

Retail price has shot up to Rs 7 apiece, while branded eggs are sold over Rs 10 per unit, they said.

"Consumers, who had shunned poultry products due to the scare of coronavirus earlier, are now consuming eggs to meet their nutritional requirement in the fight against the virus. This has led to a rise in demand," traders in

Retail egg prices had soared by nearly 60 per cent in the last six months from about Rs 4 apiece in April and birds on a large scale. It will take time May, and it has gone up by about 20 per to normalise production and supply," cent in September mainly due to supply shortages, they said.

"I am selling eggs at Rs 7 apiece now, while I had sold at Rs 4 per unit in April," a grocery store owner said.

Prices of branded eggs in large format stores have increased to over Rs 10 per piece, while brown and other speciality ones are sold at higher prices.

"About 25 per cent of birds had been culled before time in the initial months of the lockdown due to disruption in feed supply and labour issues.

"Given the shortage in supply, price may rise further and is likely to stay firm at least for another three months," Saguna south Bengal head Balaji R told PTI.

About 2.7-2.8 crore eggs are consumed daily in West Bengal, while the per-day production stands at 1.8 crore. Arambagh Hatcheries managing

director Prasun Kr Roy said poultry industry has lost around Rs 50,000 crore due to the pandemic. "Both eggs and poultry meat prices

are ruling high due to early culling of he said.

With hotels and restaurants resuming their operations, demand for eggs has been increasing and will rise further during the festive season, an official of the West Bengal Poultry Federa-

## Dimapur sees spike in COVID-19 cases as nightlife comes alive

Dimapur continues to have the highest number of COVID-19 active cases in Nagaland at 730 (699 asymptomatic cases & 31 symptomatic cases), which is over 67% of the total active cases (1078) in the State as on October 1. While the surge in COVID positive cases in the district should have pushed the authorities here to step up vigil to control the pandemic from creating havoc, the opposite is being seen

Indifference towards implementing guidelines seems to have crept in with Unlock-4 since September and with imple-

**DIMAPUR, OCT 02 [NA-** mentation of Unlock-5, which is vet to be enforced in the State, the situation is only bound to worsen.

In offices and markets, social distancing is not being observed while most people carry masks but don't wear them. And when simple guidelines like wearing masks, washing hands and maintaining distance is not observed during daytime, consider the situation at night.

Almost all bars/booze joints masquerading as restaurants, lounges, etc., in 'Dry Nagaland' have opened since Unlock-4 and are operating in full swing everyday past midnight in Dimapur right under the very nose of the district authorities.

These booze joints, cramped with young people, could be superspreaders of the Coronavirus but authorities prefer to turn a blind eye to them. Authorities cannot claim lack of knowledge of the operation of such joints in Dimapur town, as the loud music, number of vehicles lined on the road and the motley crowd of inebriated young people outside such joints give them away.

Last week the State COVID-19 weekly bulletin indicated that the increase in number of young adults and students reporting COV-ID-19 infections in Nagaland could be due to mobility of young people to their workplaces, friends hanging out in restaurants/close settings with no regard to the 3Ws wash hands, wear mask and watch distance. Complacency, it rued, appears to have set in after the Unlock-4 with nonadherence to standard safety measures.

However, it appears complacency have set in not just among young adults but in the administration as well.

#### Manipur: HC asks state to set up spl courts to try cases against MPs, MLAs

IMPHAL, OCT 02: The High Court of Manipur Thursday directed the state government to create two exclusive special courts for trials of cases against former and sitting MPs and MLAs.

The directive was issued by a Division Bench in compliance with a recent directive of the Supreme Court, seeking updated information from states, union territories and the high courts about the status of cases pending against MPs and

The exclusive special court, to be known as Special Court (MP/MLA), will be based in Imphal at the sessions and magisterial levels jurisdiction over entire Manipur.

Till the special courts are created, the High Court also directed to designate additional sessions court and chief judicial magistrate, Manipur, to function as special courts.

For effective operation of the special courts, The high court further asked the state govern-




ment to create two posts of Manipur Judicial Services and sanction funds for creating the infrastructure for the two proposed courts and their staff.

The High Court said a nodal prosecution officer not below the rank of adof police shall be designated to ensure production of accused persons before the respective courts

The officer shall also be responsible for the service of summons to the witnesses and their appearance and deposition in the courts. Any lapse on the part of the nodal prosecution officer will make him/her liable to disciplinary proceedings apart from initiation of contempt of court proceedings.

The High Court also issued a directive to the Director General of Police (DGP), Manipur to designate a senior officer not below the rank of Inspector General of Police ditional superintendent to be present in the court in each hearing to collect and provide requisite information as and when the case is listed for hearing.

Special agencies such as CBI and NIA among others were also asked to ensure that pending investigations of criminal cases against MPs and MLAs were completed as soon as possible and their reports are submitted promptly. [Courtesy: IE]

#### Warner may skip Big Bash, says his manager

## London Marathon hopes to retain spirit in St James's Park laps and virtual runs

LONDON, 03 OCT [THEGUARDIAN]: For almost 40 years it has become a familiar sight on the streets of the nation's capital: a joyous and sweaty caravan of elite and everyday runners, Super Men and Wonder Women, cheered on by 750,000 people. But while Sunday's 2020 London Marathon will be strange and socially distanced, and global not local, organisers believe the spirit of the race will rage brighter than ever.

At 7.15am on Sunday the world's best athletes will be chasing world records and Olympic qualifying times on a special closed course in St James's Park. But 45,000 runners from 109 countries will run the race "virtually" by themselves on a course of their choice, using a special app to track their route and time, rather than on the normal 26.2-mile route from Greenwich to the Mall.

It is not a usual London Marathon. But these are not normal times. And by staging the race in the teeth of a global pandemic the race director, Hugh Brasher, hopes it will offer a beacon of light for a troubled world – and raise millions for charities who are struggling to survive. "This event really is about society coming together," he says, "and in circumstances that we believe are entirely fitting for where we are in our fight against Covid-19."

When the marathon was initially postponed from April, Brasher and his team rustled up 12 scenarios to stage it this autumn. Initially the ambition was to use Bluetooth technology to stage a socially distanced marathon for 45,000 people in London – before UK coronavirus cases



surged again. Within a few weeks organisers had to scramble to build an app for the virtual race and find a biosecure hotel big enough to allow the elite athletes to complete their final preparations without leaving the grounds.

During the summer Kenenisa Bekele, arguably the greatest distance runner in history, asked organisers whether he could train in the British Embassy in Addis Ababa because of the heightened tensions in Ethiopia. Then on Friday he pulled out of his clash with the Kenyan Kipchoge, which had been billed

as the "race of the century", with a calf injury. Another Ethiopian, Degitu Azimeraw, withdrew from the women's field after testing positive for Covid-19.

The fact the race is being staged at all, says Brasher, is a minor miracle. At one point things got so difficult he began to adjust his running route to pass the grave of his father, Chris, who co-founded the event in 1981. "I had quiet little chats with him on my runs," he says. "He didn't answer, obviously. But I was telling him just how crazy the situation is. It's been mind-boggling."

And yet, out of all the chaos and uncertainty, organisers believed they have put on an event that preserves the spirit of the event - with lots of extra touches they hope will make a difference. All entrants received their race numbers in a gold-tinged envelope containing a good-luck card signed by the Kenyan world record holder Eliud Kipchoge, for instance, while the app will not only allow friends to follow and donate to their chosen charity but also carry encouraging messages from the former world champion Paula Radcliffe to inspire them.

been finalising their preparations at a secret hotel where masks are compulsory except at mealtimes and in their rooms. They also have to wear a device that emits a red light and a sharp beep if they get too close to each other. "Conversations over dinner are interesting because you're not quietly chatting, you're projecting," says one insider.

That attention to detail will carry on during race day, with every athlete having their own dedicated changing area and a toilet. And as they run around the 19.6 laps of St James's Park before finishing on the Mall, they will see cutouts of past winners and people wearing fancy dress to remind them of the history of the race – while the big screens in the park will show videos of the virtual runners across the globe.

Providing rain stays away on Sunday morning there is optimism that a world record could be set in the men's race, with Kipchoge, in particular, said to be in amazing shape. Meanwhile Brasher is optimistic for another significant milestone. In 1981 fewer than 300 of the 6,255 finishers were women - but for this year's race he expects more women to finish than men for the first time.

"Of course this is a very different event than normal," says Brasher. "But the ethos of the London Marathon hasn't changed. As always it is about the 45,000 everyday runners being inspired by the gods of the sport. We want to do things together but separately, and that's what the virtual event allows us to do. It is a race for the world at the moment."

The 25-year-old Brazilian, who was joint top goalscorer in Portugal's Primeira Liga last season with 18 in 32 matches, will stay with the north London club for the full campaign.

Spurs will pay a loan fee of three million euros ( 3.5 million) with the option of buying Vinicius for 45 million euros (53 million) permanently at the end of the season.

Vinicius' move means Tottenham finally has another forward to ease the workload on Harry Kane. Vinicius will replace Fernando Llorente, who left the club last year.

Jose Mourinho's side missed out on qualifying for the Champions



League but secured a place in the Europa League group stage on Thursday. Another striker on the move was Rhian Brewster joining Sheffield United from Liverpool.

Brewster, who spent the second half of last season on loan at Swansea, agreed to a five-year deal after the Blades paid a club record fee exceeding 23 million pounds ( 30 million). As part of the deal, Liverpool negotiated a 15% sell-on clause and a buy-back option that will be active for the next three seasons.

Brewster's last appearance for Liverpool was in the Community Shield against Arsenal at the end of August, with his missed penalty in the shootout giving the London club the victory. While highly rated at Anfield, his pathway to the

first team has been hindered. Liverpool's front three of Mohamed Salah, Roberto Firmino and Sadio Mane play virtually every week and Divock Origi and new signing Diogo Jota remain ahead of him in the pecking order.

Meanwhile, Leicester signed France Under-21 defender Wesley Fofana from Saint-Etienne.

The 19-year-old Fofana has played only one full season at senior level and joins versatile full back Timothy Castagne, who moved from Atalanta, in strengthening Leicester's defense.

## Unnerved by virus denial, survivors mourn their dead

SARAJEVO, Bosnia-Herzegovina (AP): Denis Zekic was on his daily video call with his parents in Bosnia in early August when his father said he might be coming down with a fever. Less than a month later, both of Zekic's parents were dead, joining the people who would be counted as the coronavirus pandemic's global toll climbed toward 1 million.

Zekic says his mother, Sefketa, and father, Muharem, both were comparatively healthy before they died at age 68. They were rule followers who practiced social distancing in the city of Zenica. Before his father was hospitalized, his mother wore gloves and a face mask while caring for him, but she ended up as a COVID-19 patient in the same intensive care wing, Zekic said.

"I saw her walk into the hospital on her own feet. From a distance. With protective masks covering our faces," he said. "Honestly, I believed that she would pull through."

Yet Zekic and his sister soon discovered that some neighbors and acquaintances had little sympathy for their sudden double loss, but plenty of opinions and, at times, cruel disdain. One time, a random man taunted the siblings in a store, alleging that authorities had paid them to say the coronavirus killed their parents.

"How to respond to that?" Ze-

Bosnia's coronavirus rebels have grown increasingly vocal, and hostile, in recent months as the number of confirmed virus cases rose in the small, impoverished Balkan nation of 3.5 million. Social media and the comment sections of news websites have become platforms for vicious arguments that occasionally have spilled over



into invasive confrontations

Several recent studies of coronavirus-related media content in Bosnia conducted by the independent organization Mediacentar Sarajevo concluded that pandemicrelated comments on news sites are dominated by "offensive and disparaging" remarks.

"We are now paying the price for years of neglect of our education system, our political system, for our media illiteracy," said Elvira Jukic Mujkic, editor-in-chief of its online magazine, Media.ba.

A conference in Bosnia sponsored by the European Union this week brought together fact-checkers, science journalists and experts from the Balkans and the EU, to discuss disinformation during the pandemic. One of the conclusions from the event stated: "The damage inflicted by fringe 'scientists' is pervasive and grave. The scientific community in the (Balkan) region does not currently feel empowered to respond to this."

While other countries around the world also have outspoken contingents of coronavirus conspiracy theorists, the voices of the virus deniers have the potential to echo farther in Bosnia, which bears economic, political and social scars from the fratricidal ethnic war fought there during 1992-95.

The pandemic has amplified the country's many problems, including an extreme shortage of doctors and nurses, and rampant public corruption. A number of prominent public and government officials are under investigation on suspicion of malfeasance in the procurement of desperately needed medical equipment.

"After years of declining trust in government and public institutions, public response to the perceived incompetence of our authorities in the early days of the coronavirus pandemic was to put in doubt everything they say," psychologist Tanja Tankosic-Girt said.

The allegations further undermine the public trust on which government efforts to curb the spread of the infection in Bosnia depend. The country has a low number of confirmed virus cases compared with countries with a lot more people, but nearly 60% of its nearly 28,000 confirmed cases were reported since the end of July.

More people around the country nevertheless are bending or ignoring social distancing rules, gathering in uncomfortably close

quarters and ditching face masks. At the same time, public discourse around the coronavirus, like around many other issues in the country, is growing increasingly divisive, Tankosic-Girt said.

"Black-and-white thinking is becoming so prevalent that we are reaching the point of a complete loss of empathy," she said.

The death in early August of 37-year-old philanthropist Belma Soljanin, the director of a maternal and child health organization in the capital, Sarajevo, triggered days of heated online discussions that unraveled quite a few long friendships.

Just hours after news of Soljanin's death broke, people were sifting through her mother's personal Facebook account and sharing a post in which she alleged her

daughter, who had been hospitalized in a COVID-19 isolation ward while in late pregnancy, died because of doctors' negligence.

The post became fodder for virus deniers, who quickly took over the conversation.

"Coronavirus is a hoax. Even her mother says she wasn't infected, but you just go on wearing your face masks and believing the lies they serve you," one person wrote. "While you hide from the inexistent virus, they are ripping you off, remove face masks and be free."

The head of the Institute of Emergency Medical Care in Sarajevo, Dr. Adem Zalihic, said he is certain that "virus deniers are contributing to the spread of the infection and the number of deaths" by convincing people they should not wear face masks and maintain social distance.

"The virus is among us. It infects and kills people, I do not understand how they can deny it despite all the evidence. How can they sleep at night?" Zalihic said.

Pulmonologist Besim Prnjavorac, the director of the COVID-19 hospital in the central city of Tesanj, said people tend to dismiss COVID-19 as "something that happens to others" or is "nonexistent" until it is too late. "It is only when their loved ones get sick or even die that they realize the coronavirus is real and very, very dangerous," Prnjavorac said.

Emira Telic, 38, who is currently recovering from a severe case of COVID-19 in the Tesanj hospital, has all the proof she needs to refute the deniers: the breaths she struggles to take.

"I was the first to think COV-ID (-19) was a lie, but look at me now," Telic said. "Now, I am sure that it is not a lie."

## **Nobel Prizes and COVID-19:** Slow, basic science may pay off

While the world wants flashy quick fixes for everything, especially massive threats like the coronavirus and global warming, next week's Nobel Prizes remind us that in science, slow and steady pays off.

It may soon do so

Science builds upon previous work, with thinkers "standing on the shoulders of giants," as Isaac Newton put it, and it starts with basic research aimed at understanding a problem before fixing it. It's that type of basic science that the Nobels usually reward, often years or decades after a discovery, because it can take that long to realize the implications.

Slow and steady success in science has made researchers hopeful in the fight against the pandemic. It even offers a glimmer of climate optimism.

Many years of advances in basic molecular science, some of them already Nobel Prizewinning, have given the world tools for fast virus identification and speeded up the development of testing. And now they tantalize us with the prospect of COVID-19 treatments and ultimately a vaccine, perhaps within a few months.

"This could be science's finest hour. This could be the time when we deliver, not just for the nation but the world, the miracle that will save us," said geophysicist Marcia McNutt, president of the National Academy of Sciences.



The coronavirus was sequenced in a matter of weeks, testing became available quickly, and vaccines that would normally take years may be developed in a year or less, and "it's all been built on the back of basic science advances that have been developed in the past three decades," McNutt said.

She pointed to gene sequencing and polymerase chain reaction, which allows for multiple copying of precise DNA segments. That latter discovery won the 1993 Nobel in chemistry.

And even further back, in 1984, the Nobel in medicine went to a team for theories on how to manipulate the immune system using something called monoclonal antibodies. Now those antibodies are one of the best hopes for a treatment for the corona-

of the American Association for the Advancement of Science. "That was made possible by basic research." Basic research comes

first. The benefits are typically reaped only later, in what is called applied science. "Without basic science, you won't have

cutting-edge applied science," said Frances Arnold, a Caltech chemical engineer who won the 2018 Nobel in chemistry.

Nobel-winning basic research has allowed us to see the world in a whole new light.

Do you like white, efficient LED light to replace the nasty fluorescent hum of industrial lighting or energy-gobbling incandescent bulbs? A key part of those lights are blue light-emitting diodes, and their discovery won the 2014 Nobel in physics, said astrophysicist Neil deGrasse Tyson, head of the Hayden Planetarium.

How about seeing better, without glasses, thanks to LASIK surgery? That stemmed from research into precise lasers that led to the 2018 Nobel for physics, but was also the product of an accident in which a researcher got lasered in the eye, said microbiologist Rita Colwell, former head of the U.S. National Science Foundation.

And those lasers used concepts that date back to Albert Einstein, said British Royal Astronomer Martin Rees.

John Mather, who won the 2006 physics Nobel for cosmology, which is the study of the origin of the universe and is thus the ultimate basic science, said nearly everything we use around us is there because of basic science.

"Engineers and entrepreneurs use this knowledge to build commercial empires," he said. "Doctors use what we find to develop new cures. Architects build houses with modern materials. Airplanes are designed at the very edge of what is possible. Even cars are completely dependent on basic science."

But some people don't make that connection. Adam Riess, who won the 2011 Nobel in

physics, and Tyson said this is especially noticeable when people who deny climate science or vaccine effectiveness do so while reaching felnonbelievers on smartphones and Google searches made possible because of basic science research.

"Maybe, maybe science needs a PR agent, OK?" Tyson said in an interview. "Maybe with a new discovery in science in a way that affects your life outcomes, the TV commercials say, 'Did you know this? This thing that you're using was invented here in this lab by this person. And it was brought to market by this company. And now you're using it and enjoying it.' Stop in si-

lence. 'You're welcome.'" As for fixing climate change, Mexican chemist Mario Molina has hope that the world will be able to solve the problem because of the work that led to his 1995 Nobel Prize.

He and others discovered that industrial chemicals known as chlorofluorocarbons were reaching high into the atmosphere and eating away at Earth's protective ozone layer. He discovered this many years before an ozone hole developed over Antarctica.

His work and the opening of the hole led to a 1987 international agreement to ban those ozone-depleting chemicals, and the hole has started shrinking. Now Molina hopes that kind of action can be applied to what he calls "the climate emergency."

Merkel acknowledged that the celebrations "will be quieter than the occasion would actually deserve."

## **Drugs case: Kshitij Ravi Prasad** remanded to judicial custody

"Prasad was produced before the special Narcotics Drugs and Psychotropic Substances (NDPS)Act court on Saturday on the expiry of his NCB custody. The court remanded him in judicial custody till October 6," said special public prosecutor Atul Sarpande.

Prasad's lawyer Satish Maneshinde had earlier told the court that the accusedwas harassed and blackmailed to make a statement against filmmaker Karan Johar by NCB officials.

The agency had denied the allegations.
