The Chief Minister then proceeded towards the celebration venue at Soreng Playground.

Petrol, diesel prices surge to record-high levels

(PTI): Petrol and diesel prices on Tuesday surged to all-time high levels as rates were increased again after international oil prices hit the highest mark since 2014.

Petrol price was hiked by 25 paise a litre and diesel by 30 paise, according to a price notification of state-owned fuel retailers.

This sent the petrol price in Delhi to its highest-ever level of Rs 102.64 a litre and to Rs 108.67 in Mumbai. Diesel rates too touched a record high of Rs 91.07 in Delhi and Rs 98.80 in Mumbai.

Prices differ from state to state depending on the incidence of local taxes.

The sixth increase in fuel rates in a week's time has sent petrol prices above Rs 100 in most major cities of the country.

Similarly, the ninth increase in prices in less than two weeks has shot up diesel rates above Rs 100 mark in several cities in Madhya Pradesh, Rajasthan, Odisha, Andhra Pradesh and Telan-

NEW DELHI, OCT 5 gana. International oil prices rallied to a near seven-year high following a decision by OPEC+ to maintain its planned gradual increase of supply, despite the market facing an energy crunch.

Global benchmark Brent jumped to USD 81.51 per barrel, while West Texas Intermediate rose to USD 77.76 a barrel.

Being a net importer of oil, India prices petrol and diesel at rates equivalent to international prices.

A month back Brent was less than USD 72 per barrel.

With international crude oil prices moving in both directions during July and August, no price increase was carried out by oil marketing companies (OMCs) from July 18 to September 23. Instead, petrol price was cut by Rs 0.65 a litre and diesel by Rs 1.25.

However, with no respite from surging international prices, OMCs have started to increase the retail selling price of petrol and diesel with effect

He added that Rural Development Department has been making tremendous progress in implementing various schemes and also cited examples of Jal Jeevan Mission and Swatchh Bharat 2.0.

The Chief Minister commended the work being conducted under Jal Jeevan Mission as the Department has successfully managed to increase functional tap connections for drinking water at most of the GPUs of the State.

He also praised the Department for carrying out work in Swatchh Bharat Mission and added that the Rural Development Department with combined efforts of officials, public and community has resourcefully generated awareness regarding this mission to bring about a behavioural change at grassroot level as embedded in this mission.

Keeping in mind Swatchh Bharat Mission, the Chief Minister informed that a Women's College will be established in the cleanest district of the State. Further, he also encouraged the Department to suitably enforce the schemes and transform Sikkim into a model state.

The Chief Minister

also announced that the State Government will soon start a Women's Welfare initiative named

'Aama Yojna'. He also added on various developmental works that the State Government has undertaken in Jorethang and its surrounding areas, namely constructing of Nepali Sanskrit Bhawan, Auditorium Hall at Jorethang Senior Secondary School, Cancer Hospital at Karfectar and many more other expansions.

Moreover, he updated that foundation of Gymnasium at Jorethang will be virtually laid on 20th October 2021 from Bhaichung Stadium as well.

Speaking during the programme, Principal Secretary RDD C.S. Rao briefed about the Block Administrative

(BAC) at Baiguney, which will cater to four different territorial jurisdictions, namely, Gelling Baiguney GPU, Samsing Pipalay GPU, Zoom GPU and Mabong Segeng GPU.

Mr Rao stated that the proposal for establishing of BAC at Baiguney was approached in the year 2019 during a Self Help Group convention for South and West District but due to the pandemic, setting up of Baiguney BAC took longer then usual.

Moreover, he also highlighted on various schemes under Rural Development Department and explained about People's Plan Campaign (PPC) which is an effective strategy for ensuring the preparation of plans in campaign mode. During the campaign, structured Gram Sabha/ Ward Sabha/ Block Sabha/District Sabha meetings will be held for preparing Gram Panchayat Development Plan, Block Panchayat Development Plan and District Panchayat Development Plan.

He further reiterated the recent announcement made by the Chief Minister, wherein the cleanest Gram Panchayat will receive a cash prize of Rs. 5 lakh, second and third cleanest Gram Panchayat will get Rs. 3 lakh and Rs. 2 lakh, respectively and added that there are 185 Gram Panchayat in Sikkim, which can vie for the cleanest award.

"Presently I am not going into the details of the completely illegal physical force used on my colleagues and me at the time of my arrest as this statement serves merely to clarify the continuing illegality of my confinement at the PAC compound in Sitapur, UP," she said.

"I have not been served with any order or notice. Nor have they shown me an FIR. I have not been produced in front of a magistrate or any other judicial officer either. I have also not been allowed to meet my legal counsel who has been standing at the gate since morning," the Congress leader also said.

Gandhi Vadra has been kept in detention since Monday morning after she wanted to meet the families of the victims of the Lakhimpur clashes. She said she has seen a portion of a paper on social media in which the authorities

including eight who were retary Priyanka Gandhi not even present at the time she was arrested. In fact they have even

Vadra said she has been placed under arrest as verbally informed to her by the arresting officer DSP Piyush Kumar Singh, CO City, Sitapur, under Section 151 at 4.30 am on October 4.

"At the time I was arrested I was travelling within the district of Sitapur, approximately 20 km from the border of district Lakhimpur Kheri which was under section 144. However to my knowledge section 144 was not imposed in Sitapur," she said.

She said she was travelling in a single vehicle with four other persons, two local Congress workers, Rajya Sabha MP Deepender Hooda and Sandeep Singh and no security car or Congress workers other than the four persons were accompanying her.

"I was then driven to the PAC compound, Sitapur accompanied by two female and two male constables. Having been brought to the PAC compound, no further communication regarding the circumstances or the reasons, or the sections under which I have been charged have been communicated to me by the UP Police or administration until now-38 hours later at 6.30 pm on Octo-

ber 5, 2021," she said.

GANGTOK, 04 OCT [IPR]: The 3rd District Level Committee Advisory (DLAC) meeting under the Health and Family Welfare Department was held at the District Magistrate's office, District Administrative Centre, Gangtok, today.

The meeting was chaired by District Magistrate (East) and Chairman of District Level Advisory Committee (DLAC), Ragul K.

Under the banner of the Eat Right campaign, the officials discussed the progress of action taken till now, and put forward their agendas to work for further improvements.

In the meeting, a brief report on the progress of Eat Right Challenge Campaign was shared by Pratima Ghimirey, Food Safety Officer.

Activities like Registration and licensing, Inspection using phosphorous, Surveillance Sample Collection, Special Camps, Digital Media Outreach, Providing Eat Right in public places, Food Safety Training & Certification, (FoSTaC), Eat Right Campus, Eat Right Schools, Repurposed Oils for cooking initiates which is being started recently etc was put before the chair and the representatives of all the allied departments.

She also informed that the Committee had recently started the Hygiene Ratings for which they require a thirdparty auditor from the Central Government Agency and till now they had conducted fifty audits of food business operator in GMC area and Gangtok comprising of twenty-five meat shops and twentyfive sweets shops.

Ragul K, District Magistrate East took stock of the various programmes implemented by the DLAC and suggested areas of improvement for food safety.

During the briefing session, Chairman Ragul K. stressed on the need to raise awareness regularly about these initiatives of the Government of India and Food Safety and Standards Authority

of India (FSSAI) to make individuals, food producers and marketers aware about the most basic thing that eating and serving healthy foods.

He highlighted that the awareness campaign should reach out through social media platforms too and asked officials to create a pool of information under Eat Right Campaign in the form of an online site where every information and guideline can be laid out.

He further asked the officials to prepare an action plan to cover all the GMC areas in cooperation with the other departments in the coming few months to achieve the target.

The meeting was attended by Additional Director cum Nodal Officer for Food Safety Standard Cell, Dr. Yudok Bhutia, officials from Agriculture Department, Social Justice & Welfare Department, Gangtok Municipal Corporation, Education Department, and Eat Right Campaign Cell officials.

from September 28 and September 24 respectively.

Since then, rates have gone up by Rs 2.45 paise per litre and petrol price has increased by Rs 1.50.

Prior to the July/August price cuts, the petrol price was increased by Rs 11.44 a litre between May 4 and July 17. Diesel rate had gone up by Rs 9.14 during this period.

The relentless increase in fuel prices has been criticised by opposition parties who have demanded that the government cut record excise duty on the two fuels to give relief to consumers.

The government has so far not agreed to the demand.

Oil Minister Hardeep Singh Puri on Saturday refused to even comment on the high fuel prices.

Asked about the fuel prices at his ministry's event in the national capital on Saturday, Puri said, "chodo (please leave it)" before walking away.

"Curran complained of back pain after Chennai Super Kings Indian Premier League fixture on Saturday against Rajasthan Royals. Results of the scan revealed the injury," the ECB stated.

Curran's brother, Tom, has been drafted into England's squad for the World Cup. In addition, Surrey's left-arm seamer Reece Topley has been added as a travelling reserve. Topley will join the England party in due course.

The 23-year-old Curran had a forgettable IPL, scoring only 56 runs from nine games and picking up nine wickets at an expensive economy rate of 9.93.

"Unfortunately I have received a gutting news that I will unfortunately be missing the remainder of the IPL season and the World Cup. Extremely gutted...absolutely loved my time with Chennai this season," Sam Curran told CSK.

"It hasn't really sunk in yet but I'm leaving the team in a fantastic space. The boys are playing really good cricket. I want to be supporting them from where I am in the next few days.

"Once it's all sunk in, I'll definitely be supporting the team and I'm sure they can go all the way and lift the trophy." Curran, 23, has played 24 Tests, 11 ODIs and 16 T20Is for England. He was a part of the England Test squad that played India in England prior to the IPL.

"Just want to say a massive thank you to all the Chennai Super Kings fans, I've absolutely loved all your support in the last two seasons I've been playing. It won't be long until I'm back running, bowling and batting in front of all you guys.

"I'll be back stronger, until then stay safe. Cheers guys," the allrounder added.

Insularity is unfortunately a national malaise. Address it

dentity, as in the perceptions of the outside, is a ■ touchy issue among the marginalized communities. The ill-informed clichés, the pedantic, and almost always offensive generalizations remain sore points for the offended communities, and we live in a region that has lived with such broad-brush impoliteness for ever since we started interacting with the plains. And the brush paints both ways, one may add here.

While it is easy to take affront and fine to draft fresh introductions to correct the offending perceptions, it is definitely not okay to allow the chip on the shoulder to burden any heavier than is healthy. The more this perceived slight is allowed to fester, the more it diverts energy from pursuits that take communities forward. One refers to a "perceived slight" here because the clichés that hurt are products of ignorance and one should not really allow ignorance of others to justify withdrawals into cocoons by the othered. And defensive shells are not the best habitations from which to plan ahead because they keep thoughts and ideas rooted in a past that has lost its relevance for everyone except those who swoon in its fermented confusion. Also, while so enclosed, one fails to recognize changes

That said, it is important that the ignorance which has degenerated into disdain, mutual suspicion and distasteful stereotyping is lifted. One could argue that perceived slights are by nature pointless obsessions since they are born out of, well, perceptions which cannot really be tackled because, well again, they rest in perceptions and those are more difficult to address than actual instances of discrimination. They do, however, become worries when the perceptions start manifesting as actual attacks, like ones which triggered the exodus of NE people from the metros or the lynching which occurred in Nagaland a few years ago. And then there is the continuing parochialism everywhere else in the country and the reprehensible attempts at justifying such targeted attacks born out of Hate seeded in prejudices and stereotypes. These will repeat unless this country makes some earnest efforts at celebrating its much-vaunted diversity. 70 years as one nation and the citizens still don't behave as One People! This obviously needs to change, and the Supreme Court recently cracked the whip with its slew of directions, including the setting up of a three-member panel to "enhance the sense of security and inclusion of the people from the north-eastern states who faced violence and hate crimes". The SC directive is the first step, an acceptance of sorts of a problem that exists. For it to be of any real consequence, wider, more collaborative initiatives will need to be taken.

The students provide the best opportunity to build the bridges which can span the chasms of mutual ignorance which feeds insularity among us. A simple and easily achieved course would be for the community/ state representative organisations of the students to become mediums which link communities. not strive to make them self-ensconced unit of self conscious groups. Take the freshers' welcome parties for instance. Instead of each community, each state or region hosting a welcome party for its own kind, they should use the funds to introduce the freshers to 'others' in the student community. Host the parties for 'your own' but invite guests from all other groups. Make celebrations the medium to proffer more congenial introductions and strike new friendships. Use the organisations to speak more often about the concerns of other groups and engage more earnestly in issues and challenges which face other communities. This openness is possible only with the idealism of youth, but is currently being stifled because student groups remain obsessively insular.

Environmentalists Must Pressure the Indian Government to Take Action on Climate

Scorching heat waves, torrential rains and other extreme weather events make India one of the Indian cities recorded temperatures as high as 48 C, in 2020. And by 2100, an estimated 1.5 million

are expected to become unlivable in the next 80 years. The Intergovernmental Panel on Climate Change's recent report stated that India is likely to experience more extreme weather events such as heatwaves, droughts and floods in the next

few decades that will lead to ir-

reversible climate impacts. India pledged to reduce its emissions intensity (emissions per unit of GDP) by 33 to 35 per cent from 2005 levels by 2030, yet the government fails to generate emissions data to monitor these targets and validate claims that it will meet the Paris objectives on time.

Non-governmental organizations play an important role in India because of their ability to provide feedback and act as harbingers of change for economic and social systems to thrive. But instead of pres-

suring the government, many NGOs are increasingly putting pressure on the public to mitigate climate change. For instance, NGOs promote lower meat consumption, cloth shopping bags, reusable straws, LED lightbulbs and so on.

Actions like these feed the "green me fallacy," a term coined by American writer and filmmaker Eleanor Goldfield, which is the belief that an individual's lifestyle choices will be enough to resolve climate problems and restore ecological health. But these solutions cannot work without institutional or policy-level support.

Instead of focusing on symbolic gestures or actions that raise one's social capital, Indian activists need to pressure the government to establish effective environmental policies and programs. They should protest, picket corporate offices, petition the government and stage sit-ins, hunger strikes and vigils to strengthen climate action and spread awareness about the urgency of the climate crisis in India. As a climate scholar and activist I have participated in environmental campaigns in New Delhi and Bengaluru to understand the objectives of NGOs and how they operate.

ACTING WITH A SENSE OF URGENCY

India is already experiencing the negative effects of climate change. Yet it is the world's thirdlargest emitter of carbon dioxide, and its electricity and heating sector produces more than 1.1 billion tonnes of carbon emissions annually. With coal still central to the country's energy sector — and more coal-fired plants planned — emissions are set to rise with economic growth. Additionally, 22 out of the world's 30 most polluted cities are in India.

Except for a few NGOs, environmental advo-



cacy groups in India have failed to campaign for the shutdown of coal-fired power plants and other industrial projects. Instead, many NGOs have introduced trivial campaigns such as "Monsoon Wooding" and "Pedh Lagao" (Plant Trees).

These initiatives act as weak solutions to India's aggrieved environmental condition, at a time when environmental activists need to probe and have clarity on the most effective responses to climate change. These campaigns become problematic when they fail to ground themselves in science and begin to assert that they can resolve imminent threats, such as air pollution and climate change.

When poorly planned, tree planting can have negative consequences on ecosystems and climate change. For instance, planting trees in areas that have never been forested before, such as on grasslands, savannahs and dry lands, reduces carbon sequestration and increases air temperatures.

With the climate crisis at India's front door, climate activists are being sloppy if they don't hold industries accountable for their carbon output. and instead look to citizens to reduce their relatively minuscule carbon footprint.

CLIMATE GUILT AND SHAME

The capitalist system induces our ideological guilt: If we cannot plant trees in our neighbourhood, buy solar-powered products or make green lifestyle choices, then we are not green enough. It heightens the individual's sense of responsibility.

Yet changing our lifestyles may not meaningfully impact the environment, because individual lifestyle choices are not the problem, mass production and consumption are.

> Even when we act with what we believe to be the best of intentions, our efforts are often at cross purposes with our goals. For example, low energy emitting light bulbs may lead us to keep the lights on more. Planting trees allows deforestation by corporations to continue by claiming reforestation elsewhere will make up for it. No matter what green initiatives we take, there is always encouragement to consume more.

Governments and corporations should not be let off the hook. NGOs must demand action from governments. They should engage in everyday forms of resistance and rights-based activism, campaign against poor and ineffective envi-

ronmental policies and demand climate justice and

Only a handful of Indian environmental NGOs are challenging this mainstream narrative and speaking truth to power. One example is the Pathalgadi movement, which defies private sector advocacy by challenging the government over the management of Adivasi (Indigenous) resources in the state of Jharkhand. Pathalgadi activists emphasize their constitutional rights to landholdings by imposing blockades on outsiders and promoting self-reliance.

NGOs could reach out to other groups in solidarity and collectively pressure the government to restore the environment. Instead of the feel-good token gestures that exacerbate the climate crisis, Indian activists need to frame environmental inequities in ways that pressure governments to institute effective policies and programs. This is only possible by leveraging public opinion and avoiding a system where individual responsibility is seen as having more environmental impact than the state taking ownership of the problem.

Pandora Papers: 'it's time to pursue lawyers and accountants **Yho enable tax evasion*** - onsnore tax expert y&a

m any \ of \ the \ world's \ richest \ and}$ the spotlight once more for using secretive tax havens and corporate structures to hide wealth and avoid paying taxes. The Pandora papers is the third in a series of huge leaks of documents to the media following the Panama papers in 2016 and the Paradise papers in 2017 - and little seems to have changed in the interim.

Those included so far in the new revelations include the leaders of the Czech Republic, Cyprus, Jordan and Ukraine, plus members of the ruling family in Azerbaijan and figures close to Vladimir Putin. In all, more than 100 billionaires are reportedly involved in the revelations, with transactions ranging from properties worth millions of pounds to slush funds and superyachts.

We asked Professor Ronen Palan, a specialist in offshore tax havens at City, University of London, about the story so far.

WHAT ARE YOUR INITIAL THOUGHTS?

I'm afraid I'm not surprised by these papers. There's no evidence to suggest that the volume of transactions taking place through these offshore centres is declining, so the same financial structures that we heard about in the Panama and Paradise papers are still clearly being used.

It's fascinating that so many of these people in the public eye must have known that eventually their activities would become common knowledge, and yet they opted for offshore secrecy anyway. I suppose

any concerns may be overcome perhaps by greed and the knowledge that they will not be prevented from

In some cases we are talking about (illegal) tax evasion and in some cases it's (legal) tax avoidance: the difference comes down to whether the people in question had fully notified the authorities in their home countries about the offshore structures they are using. In instances when I read that they are asked by the media to comment and they decline to respond, it creates the appearance that we are talking about evasion - although this remains unproven.

WHY DOES THE SITUATION NOT APPEAR TO BE IMPROVING?

Over the past 20 or 30 years, international regulation has focused on creating tools that allow tax authorities to ensure that taxpayers are not evading taxation. Systems were introduced that focus on "know your customer" or KYC – requiring people transacting in particular jurisdictions to fully identify themselves so that this information can be shared with other jurisdictions.

This essentially creates transparency so that you know who has money where, so that tax authorities can use this information to make sure that their citizens are not evading taxation. But while that can be effective in countries where the tax authority is operating independently of the government and politics, it's not going to work in Russia or China or many other developing countries. It's therefore not surprising to me that many of the revelations are about activities outside of the developed world.

BUT WHY HASN'T TRANSPAR-ENCY FORCED TAX HAVENS TO CHANGE?

It has brought about change, but some jurisdictions comply more than others. So you have got some British jurisdictions such as Jersey or the Cayman Islands that are much more transparent than they used to be. On the face of it, they can claim to be more regulated than, say, Denmark or Sweden.

But the professionals who have the expertise to create structures that enable tax evasion are still often based in these places, and they create structures with different layers that will be partly registered in these jurisdictions but partly in those with looser transparency rules such as the British Virgin Islands or Panama following the letter but not the spirit of the law. This makes it very difficult to see what is happening and whose money is involved.

HOW DO WE IMPROVE THE CUR-**RENT SITUATION?**

The Pandora papers show we are reaching the limits of what can be done with data transparency. Unless we find ways to tighten the net, this won't be the last leak of its kind. This is recognised at least implicitly by the OECD (Organisation for Economic Co-Operation and Development) and other international bodies in their increasing interest in going after the enablers, rather than just focusing on the tax evaders themselves.

Maybe it's time to create something similar to what applies in medicine, so that, if enablers contravene certain standards, they can be prosecuted - even in countries who are not directly affected by their activities. If they went to such a country, they could be arrested on arrival.

SHOULD WE CREATE A NEW IN-TERNATIONAL INSTITUTION DEDI-CATED TO STAMPING OUT TAX EVA-

In practical terms, the three places that matter when it comes to creating international regulations are the US, EU and China. Unfortunately they are not agreeing with one another on much right now, so it will be difficult to reach an agreement about such an institution. Even if they did agree, they would be accused of imperialism by smaller countries, or of acting as dictators.

Of course, these three players would still need to agree on an initiative to really go after enablers, so you can make the same criticism of this strategy, but it is at least more modest in its scope and therefore potentially more realistic.

ARE ALL THESE REVELATIONS ACTUALLY HELPFUL?

There's certainly a danger of media saturation, in which the public knows about these kinds of activities and may be less interested by now. But we need to emphasise that the consequences are not going away: to run a modern state, it's very expensive. To pay for a good education system, a good health system, properly functioning infrastructure and so forth, somebody has to pay for it.

If the rich are avoiding paying their share, somebody else is picking up the tab, and that's either the poor or the squeezed middle classes. So if the public are tired of all this scandal, it doesn't change the fact that they are suffering because of it.

His son, Jawad Sharif, said as per his father's last wishes his burial would be in the graveyard at the Abdullah Shah Ghazi shrine in Clifton Karachi.

"His body will be flown from Germany to Karachi tonight and his funeral prayers will be held in a mosque in Clifton followed by his burial at the Mazar," he added.

Sharif's third wife, Zareen, had accompanied him on the air ambulance and will return with the body.

Umer Sharif was one of Pakistan's most celebrated comedian, actor and television personality with his iconic plays such as "Bakra Qiston Pe" and "Budha Ghar Par Hain".

Taliban killed 13 members of Hazara ethnic group: Report

killed at least 13 members of the Hazara to "inhumane mass killings" carried ethnic group, including a 17-year-old girl, in the central province of Daykundi, shortly after they took power in Afghanistan, according to a new report from Amnesty International.

On August 30, a convoy of 300 Taliban fighters entered Khidr district and killed at least 11 former members of the Afghan National Security Forces (ANSF), nine of whom were taken to a nearby river basin where they were executed shortly after having surrendered, the rights group said in its report published on Tuesday.

A teenager, identified by the name of Masuma, was killed in crossfire after the Taliban targeted Afghan forces who were attempting to flee the area. Another civilian, Fayaz, a newly-wed in his 20s, was also among those killed in the crossfire.

The ANSF members who were killed ranged in age from 26 to 46, Amnesty said. All the victims were Hazara, who were persecuted during the Taliban's first stint in power between 1996 and

It is the second killing of Hazaras documented by Amnesty. At least nine Hazara men were killed by Taliban fighters in Ghazni province in July before the group captured power, Amnesty reported on August 19.

Both the Taliban and their rivals, the Islamic State Khorasan Province, ISKP (ISIS-K), an ISIL affiliate, have been accused of targeting the Hazara people, who make up the majority of Afghanistan's Shia population.

By September 1, the Taliban had denied the killings. Saidqullah Abed, the Taliban appointed police chief for Daykundi, would only confirm that one of their fighters had been injured in the crossfire.

KABUL, 05 OCT [ALJAZEERA]: The Taliban ing the events of August 30 amounted out by the Taliban. She said what transpired in Khidr was in direct violation of the Taliban's claims of a nationwide general amnesty for former security forces and government workers.

"These cold-blooded executions are further proof that the Taliban are committing the same horrific abuses they were notorious for during their previous rule of Afghanistan," said Agnes Callamard, Amnesty International's secretary-general.

During their five-year rule in the 1990s, the Taliban were accused of massacring hundreds of Hazaras in the provinces of Balkh and Bamiyan.

Zaman Sultani, South Asia researcher at Amnesty International, said the killings in Daykundi follow a clear pattern by the Taliban.

He points to a statement that interviewees attributed to a senior Taliban official as proof: "I have killed people for the past 20 years. Killing is easy for me. I can kill again," the official reportedly told Daykundi residents.

Azad, the former MP, said the Taliban's abuses in Daykundi do not end with the killings.

She says that since the Taliban captured the province on August 14, a day before former President Ashraf Ghani fled the country, thousands of families have been forced from their homes in the Gizab and Pato districts of the mountainous province.

A list compiled by residents shows that as many as 20,000 families were forcibly displaced across at least 10 different villages over the last month and

Daykundi residents speaking to Al Jazeera said that when the Taliban came to their homes, the fighters claimed that the families had been illegally occupying the land or that a Taliban shura had decided the land "belongs to the

Man held for printing pirated NCERT books



NEW DELHI, OCT 5 (PTI): A 38-year-old man has been arrested for his alleged involvement in printing pirated NCERT books, police said Tues-

The accused, Manoj Jain, a resident of Shahdara, was arrested Monday following a raid at his printing unit at Mela Ram Farms in outer Delhi's Mandoli here on September 18, Deputy Commissioner of Police (Crime) Rajesh Deo said.

According to police, Jain has been into the printing business for over eight years and started the unit in Mandoli in January 2020.

During the Covid-induced lockdown, he suffered heavy losses in his business, they said.

And to cover up the losses, he started printing pirated NCERT books since these books are in large circulation across the country, they added.

The DCP said around 5,000 pirated books and printed material of NCERT valued at approximately Rs 35 lakh was recovered from the unit along with watermark of NCERT and latest offset printing machines.

A case was registered under relevant sections of the Indian Penal Code and the Copyright Act fol-

lowing the raid on September 18, police said, adding Jian had been absconding since then.

The raid was conducted along with vigilance officer and production officer of NCERT, New Delhi after a tip off, they said.

These poor quality pirated books were being supplied in the market at cheaper rates, causing huge revenue loss to NCERT. The offset unit was publishing pirated NCERT books of class 6th to 12th of different subjects, the DCP said, adding further investigation is underway.

"Won't bend to pressure": Taiwan's President amid China incursions

TAIPEI, 05 OCT [AFP]: Taiwan's President Tsai Ing-wen warned of "catastrophic consequences" if the island were to fall to China and vowed to "do whatever it takes" to guard against threats in an article published on Tuesday.

Taiwan lives under the constant threat of invasion by China, which views the self-ruled democratic island as its territory to be re-taken one day, by force if necessary.

President Xi Jinping has described the seizure of Taiwan as "inevitable" and Beijing has ramped up military, diplomatic and economic pressure since Tsai's 2016 election, as she views the island as "already independent" and not part of a "one China".

Nearly 150 Chinese warplanes had breached Taiwan's ADIZ since Friday when Beijing marked its National Day with its then-biggest aerial show of force, buzzing the island with 38 planes.

Tsai warned a failure to defend Taiwan would be "catastrophic" for both the island and the wider region in an article she wrote for Foreign Affairs published on Tues-"They should remem-

ber that if Taiwan were to fall, the consequences would be catastrophic for regional peace and the democratic alliance system," Tsai said.

"It would signal that in today's global contest of values, authoritarianism has the upper hand over democracy.'

Taiwan hopes for peaceful coexistence with China, she said, but "if its democracy and way of life are threatened, Taiwan will do whatever it takes to defend itself."

Tsai's government on Monday urged Beijing to stop "irresponsible provocative actions" after a record 56 Chinese jets including nuclear-ca-


pable bombers crossed into Taiwan's air defence identification zone.

"Amid almost daily intrusions by the People's Liberation Army, our position on cross-strait relations remains constant: Taiwan will not bend to pressure." Tsai added.

The ADIZ is not the same as Taiwan's territorial airspace but includes a far greater area that overlaps with part of China's own air defence identification zone and even includes some of the mainland.

In the last two years, Beijing has begun sending large sorties into Taiwan's defence zone to signal dissatisfaction at key moments -- and to keep Taipei's ageing fighter fleet regularly stressed.

Last year, a record 380 Chinese military jets made incursions into Taiwan's defence zone. The number as of October this year has already exceeded 600.



England will only play Ashes series if best players in squad

LONDON, OCT 4 (AP): England will only travel to Australia for the Ashes series across December and January if its leading players are in the squad.

That was the message from the England and Wales Cricket Board on Monday, with the governing body saying it will announce this week if the tour will go ahead amid concerns about restrictions in place in Australia due to the pandemic.

An ECB statement said there has been "regular and positive dialogue" with Cricket Australia about arrangements for Ashes series, one of the biggest occasions in cricket.

However England's players are concerned about the conditions they will have to live in after arriving in Australia, such as the quarantine arrangements and whether family members can travel.

The ECB said the priority was to ensure the tour can take place "with conditions for players and management to perform at their best."

"We will continue talking to our players this week to share the latest information and seek feedback," the ECB said.

Tellingly, the governing body added that the squad selected needed to be "befitting a series of this significance."

With the World Twenty20 competition taking place in the United Arab Emirates and Oman from Oct. 17-Nov. 14 and the five-test Ashes series beginning on Dec. 8 until mid-January, plus quarantine either side and before the Ashes, some players could be away from home for more than three months.

Ben Stokes, England's star all-rounder, is currently missing for England because he is taking a break from cricket to protect his mental health.

England captain Joe Root hasn't committed to taking part in the Ashes amid the ongoing talks, and Australia captain Tim Paine said last week "the Ashes are going ahead ... whether Joe is here or not."

The ECB statement suggests this is not the case and that England will not countenance taking a weakened squad to Australia.

England's international schedule has undergone repeated changes during the pandemic.

The team returned home early from tours of Sri Lanka and South Africa in 2020 while the fifth test against India in the countries' recent series in England was abandoned on the morning of the match after the Indians decided not to play due to fears over a COVID outbreak in its touring group.

England also canceled white-ball visits to Bangladesh and Pakistan that were scheduled to take place this month ahead of the World T20.

The extraordinary talent of Mohamed Salah and how to quantify it

LONDON, 05 OCT [THEGUARD-**IAN]:** There were 76 minutes gone at Anfield as Mohamed Salah took a pass from Curtis Jones near the right touchline. Three blue shirts loomed close by. Salah was facing the crowd. Shortly before Manchester City had levelled the score at 1-1, and could claim, on the metrics, to have dominated the game to that point: more shots, passes, crosses and dribbles, albeit without seeming to have any preferred method of actually putting the ball in the Liverpool goal.

Through all of that there was a familiar sense of one player in red operating under a different gravity. Salah does this. Shane Warne famously damned Monty Panesar with the comment that he hadn't played 33 Test Matches, but the same Test 33 times. The same could be said of Salah, who has effectively played the same game for Liverpool 212 times. Except happily, in Salah's case, it is an astonishingly good game.

Sunday afternoon was already significant in other ways. This week marks the six-year anniversary of Jürgen Klopp's appointment as Liverpool manager. There is an air of familial permanence about Klopp these days. By the turn of the year he will have outlasted every postwar Liverpool manager bar Bob Paisley and Bill Shankly, fitting company for a man who has performed a remarkable twin feat of modernising the present while still tending to the past.

Success, wider attachments, the Covid experience have all created an indissoluble bond. Klopp seems less angsty on his clothesline these days, more weathered, more thickly-bearded, and an agreeably nautical presence in his overalls, steering that seasoned title-winning crew on instinct and ship's biscuits.

Hockey India withdraws from 2022 Commonwealth Games due to Covid concerns

NEW DELHI, 05 OCT [PTI]: India on Tuesday pulled out of next year's Birmingham Commonwealth Games' hockey competition, citing CO-VID-19 concerns and UK's discriminatory quarantine rules for travellers from the country. Hockey India President Gyanandro Ningombam communicated the federation's decision to Indian Olympic Association (IOA) President Narinder Batra.

Hockey India reasoned that there is only a 32-day window available between Birmingham Games (July 28-August 8) and the Hangzhou Asian Games (September 10-25) and it can't risk sending its players to the UK which has been one of the worst affected countries by the coronavirus pandemic.

"You will appreciate that the Asian games is the Continental qualification event for the 2024 Paris Olympic Games and keeping the priority of the Asian Games in mind, Hockey India can not risk any members of the Indian teams contract-

ing COVID-19 during the Commonwealth Games." Ningombam wrote. The UK recently refused to recognise India's CO-VID-19 vaccination certificates and imposed a 10-day hard quarantine on travellers from the country even if they were fully vaccinated.

HI's move comes a day after England pulled out of the FIH Men's Junior World Cup to be held in Bhubaneswar next month, citing a number of COVID-related concerns and taking "note" of the Indian government's mandatory 10day quarantine protocol for all UK nationals.

India imposed reciprocal curbs on all British nationals arriving in the country after UK's restrictions.

Anxious wait for Afghan girls as opening of high schools stalled

KABUL, 05 OCT [ALJAZEERA]:

Millions of teenage girls across Afghanistan are anxiously waiting to return to the classroom, as high schools continue to remain closed, raising fears about the future of female education under Taliban rule.

The country's new rulers allowed boys in the same age group - seven to 12 - to attend classes last month, but said that "a safe learning environment" was needed before older girls could return to school.

At that time, the Taliban's Deputy Minister of Information and Culture Zabihullah Mujahid said the group was working on a "procedure" to allow teenage girls back into the classroom.

In the Taliban's first news conference after taking over Afghanistan on August 15, Mujahid had pledged to "allow women to work and study," as it tried to allay fears of its rule between 1996-2001 that was marked by a curb on women's rights.

The continued exclusion of girls from schools has only exacerbated fears among the Afghan people that the Taliban could be returning to their hardline rule of the 1990s. Those five years had the distinction of being the only time in modern Afghan history where women and girls were legally barred from education and employment.

In the month and a half since they came to power, the Taliban has told female government workers to stay at home, announced an all-male cabinet, closed down the Ministry of Women's Affairs and faced accusations of harassment



and abuse of female protesters across the nation's cities.

Toorpekai Momand, an education advocate, said the delay, coupled with the Taliban's actions, have led adolescent girls to contend with dangerous questions, "Why do the Taliban have a problem with us? Why is it our rights that are being taken?"

Momand, who has spent 10 years working as a school administrator, is among hundreds of women in Afghanistan and abroad who are trying to ensure that the Taliban live up to their promises to allow girls and women back into schools and offices.

For many of these women, this struggle means dealing with what they see as unpopular, but necessary realities of life in a Taliban-controlled Af-

ghanistan.

Jamila Afghani, another education advocate, said that the Afghan people are left with little but to try and engage with the Taliban, especially as the international community has refused to recognise the group.

"I didn't bring them. You didn't bring them, but they're here now, so we have to keep pushing."

But both Afghani and Momand and dozens of others have experienced first-hand the difficulty of trying to get answers out of the Taliban. When their colleagues met officials from the Taliban-run Ministry of Education, they were told that the group is working "very hard" to adhere to conservative norms in the education of teenage girls.

Momand said the Taliban references to a review of the

is particularly careful with its wording, "They never just come out and say 'no,' they keep saying 'we're working on it,' but we have no idea exactly what it is they're working on."

All of the women Al Jazeera spoke to said that in the 100 years since the Afghan government established official schools for girls, those institutions have always adhered to religious principles. Primary and secondary schools were always gendersegregated and dress codes were always in place.

Momand, in particular, said she has a hard time accepting the Taliban's claims of religious reasoning for the continued wait, saying, "In a girls' school, everyone, down to the cleaning staff, are women."

The Taliban has also made

curriculum, something Afghani said could further delay the education of school children.

"Redoing a curriculum takes a lot of time and a very detailed understanding of educational models," Afghani said.

All of the sources Al Jazeera spoke to shared Afghani's scepticism of the Taliban's actual understanding of the complexities of establishing an education system for 9.5 million schoolchildren.

Last month, the group's acting minister of education, Mawlawi Noorullah Monir, caused a social media uproar when he said, "No PhD degree, Master's degree is valuable today. You see that the mullahs and Taliban that are in the power, have no PhD, MA or even a high school degree, but are the greatest of all."

French clergy sexually abused 'over 200,000 children' since 1950

Paris, 05 Oct [al]azeera]: About 216,000 children are estimated to have been sexually abused by thousands of French Catholic priests, deacons and other clergy since 1950, an independent inquiry has found, alleging the phenomenon was covered up by a "veil of silence".

The details made public on Tuesday are the latest to rock the Roman Catholic Church after a series of sexual abuse scandals around the world, often involving children, over the past 20 years.

Jean-Marc Sauve, head of the commission that compiled the report on the investigation, said the abuse in France was "systemic" and had been carried out by some 3,000 priests and other people involved in the church.

About 80 percent of the victims were boys.

Speaking at a public, online presentation of the report, Suave added that the Church had shown "deep, total and even cruel indifference for years", protecting itself rather than the vic-

The Church not only failed to take necessary preventive measures, he said, but also turned a blind eye to abuse and sometimes knowingly put children in touch with predators.

"The consequences are very serious," Sauve said. "About 60 percent of men and women who were sexually abused encounter major problems in their sentimental or sexual life."

Victims voiced their disgust over the findings.

"You are a disgrace to our humanity," Francois Devaux, who set up victims' association La Parole Liberee, meaning chives.

The Liberated Word, told church representatives at the presentation. "In this hell, there have been abominable mass crimes ... but there has been even worse, betrayal of trust, betrayal of morale, betrayal of children."

Pope Francis thanked victims for coming forward.

"First of all his thoughts go to the victims, with great sorrow, for their wounds," a Vatican statement said. "(His thoughts go to) the Church of France, so that, in the awareness of this terrible reality ... it may embark on a path of redemption."

The 2,500-page document prepared by the independent commission comes as the Catholic Church in France, like in other countries, faces up to shameful secrets that were long covered up.

Speaking after Sauve at the presentation, Eric de Moulins-Beaufort, the archbishop of Reims and head of the Conference of Bishops of France, asked for forgiveness. He called the report a "bombshell" and promised action.

The commission was established by Catholic bishops in France at the end of 2018 to shed light on abuse and restore public confidence in the Church at a time of dwindling congregations.

It worked independently from the Church during its two-and-ahalf-year lifetime, listening to victims and witnesses and studying church, court, police and press archives starting from the 1950s.

Sauve said the commission itself had identified approximately 2,700 victims through a call for testimony, and thousands more had been found in ar-

Biden eager to get out of DC, push benefits of spending plan

WASHINGTON, OCT 5 (AP): President Joe Biden is shifting strategy to sell his ambitious social spending plans by travelling outside Washington and courting Democrats who have complained they felt left out of the process.

With his agenda in jeopardy on Capitol Hill, Biden on Tuesday will visit the Michigan district of a moderate Democratic lawmaker who has urged him to promote his proposals more aggressively to the public. Back in Washington, negotiations continue on a pair of bills to boost spending on safety net, health and environmental programs and infrastructure projects.

While there is cautious optimism about recent progress, no deal had been struck to bridge stark divides between moderates and progressives in the Democratic Party on the size and scope of the package. In recent weeks, as House Speaker Nancy Pelosi worked unsuccessfully to secure passage of the bills, Biden stayed in Washington to cajole lawmakers and work phones.

Now, he's trying to put the public focus on popular components of the bills rather than the inside-the-Beltway debate over their price tag.


The president will appear with Democratic Rep. Elissa Slotkin when he visits a union training center in Howell, Michigan, a reflection of the importance of securing moderates' votes. Next to Biden, the Democrats with the most on the line over the shape and success of his spending plans are House members from swing districts whose reelections are essential if his party is to retain control of Congress.

The uptick in travel is meant to build public support for a wide range of initiatives packaged under the im-

Moderate Democrats, meanwhile, are pushing for the bipartisan infrastructure bill to get a House vote first and some are wary about the size of the far larger social spending bill.

That leaves Biden and his Democratic allies in Congress at a crossroads, islating and remind voters what they are trying to accomplish. The president held a virtual meeting with 12 progressive House members on Monday and plans a similar session with moderates later in the week.

With considerable attention focused on winning over two key Democratic senators, Joe Manchin of West Virginia and Kyrsten Sinema of Arizona, rankand-file lawmakers could benefit from the high-profile backup that comes from Biden making the case for his vision to the public.

House members are fanning out to their home districts this week as public views of Biden's agenda are being shaped. Senators remain in Washington but are working on another tangle, the legislation needed to raise the nation's debt limit by midmonth to avert a devastating credit default.

Pelosi, Senate Majority Leader Chuck Schumer and White House officials huddled late Monday in a room off the Senate floor to discuss the next steps for passing Biden's agenda.

Those behind-the-scenes talks are intense as Biden lowers the size and scope of the 3.5 trillion social spending package to win over Manchin, Sinema and a small band of conservative Democrats in the House without alienating progressives, who are fighting to keep their priorities in the bill.

Jamie Spears was removed from the conservatorship by a California judge on September 29. A hearing has been set for November 12 to determine if the conservatorship will be terminated entirely.

The conservatorship was established in 2008 when Britney began to have public mental struggles as hordes of paparazzi aggressively followed her everywhere and she lost custody of her children.

Russian film crew blasts off to make 1st movie in space

Russian actor and a film director member it with a smile. Arocketed to space Tuesday on a mission to make the world's first movie in orbit. Actor Yulia Peresild and director Klim Shipenko blasted off for the International Space Station in a Russian Soyuz spacecraft together with cosmonaut Anton Shkaplerov, a veteran of three space missions. Their Soyuz MS-19 lifted off as scheduled at 1:55 pm from the Russian space launch facility in Baikonur, Kazakhstan and successfully reached the designated

Space officials reported that the crew was feeling fine and all spacecraft systems were functioning normally.

Peresild and Klimenko are to film segments of a new movie titled Challenge, in which a surgeon played by Peresild rushes to the space station to save a crew member who suffers a heart condition. After 12 days on the space outpost, they are set to return to Earth with another Russian cosmonaut.

Speaking at a pre-flight news conference Monday, 37-year-old Peresild acknowledged that it was challenging for her to adapt to the strict discipline and rigorous demands during the training.
