Youth dies after brutal assault, mother demands justice

AARON RAI GANGTOK, 15 OCT:

The family of a youth who was brutally assaulted and succumbed to his injuries later have demanded justice.

On 19 Sept, 22-year-old Prem Kumar Ramudamu was beaten up by seven boys.

The next day, the family took him to CRH Tadong for treatment, but he succumbed to his injuries on 07 Oct.

The deceased and his family are residents of Sadhatam village under Martam Rumtek constituency in East Sikkim.

According to the youth's mother, she was told that her son had gone to a nearby shop where he asked for the phone number of a girl who was there. Soon after that, the brother and friends of the girl attacked her son and took him to a nearby jungle where they assaulted him through the

night, the mother has alleged.

Speaking to Summit Times, DIG Range, Pravin Gurung informed that two FIRs were received by Sadar Thana on 20 Sept from Ranka. One was about the assault on Prem Kumar Ramudamu and the other was about an assault on one Sangay Wangchuk Bhutia. The two cases were of assaults that took place at different locations, one near Ranka Senior Secondary School and the other at Sama Lingdum, he said.

However, according to Prem Kumar's mother, her son and Sangay Wangchuk were together and were both assaulted by the same gang of boys.

The DIG-Range meanwhile informs that after receiving the FIRs, cases under sections 325, 341, 34 of the IPC was filed against unknown persons. Later, the seven accused

were identified through CCTV to get the statement from the footage and arrested. However, after Prem Kumar succumbed to his injuries, the charges against the seven accused has now changed to murder i.e section 302 of IPC.

"The seven accused are aged between 17-22 years. Out of the 7, six have been sent to judicial custody while the 17-year-old has been sent to Association president, Shekjuvenile detention," informed Mr Gurung.

Post mortem reports suggest that no weapons as such were used in the attack and the accused used blows and kicks to batter the victims.

Prem Kumar had sustained severe injuries to his internal organs especially his liver and

"We couldn't get a dying declaration from Prem Kumar since he was not in a condition to speak. However, we hope other victim," said the DIG.

He added that the other victim is also in a serious condition and is on dialysis since his kidneys have been damaged in the assault.

From what we know, the incident took place on 19 Sept between 6-7 pm, said Mr Gurung.

All Sikkim Scheduled Caste har Sewa met with the mother of the deceased today. Speaking to media persons, he said they are trying to find out if this was a case of discrimination against SC community since the deceased belonged to SC community.

"Right now all I can do is appeal to the authorities to provide justice to the victim and if need be, our association is ready to take the matter to the central leadership of our association as well," he stated.

Proper school reopening to finally begin 02 Nov

Ctarting in a graded • manner on 02 November, schools across the State are projected to reopen for students by 23 November. The State Government has also done away with the winter vacations, but this is still going to be an extremely truncated school year with the next academic session, which would have begun in normal times on 02 February, now resuming on 15 February, 2021.

The current academic session will now end on 13 February, 2021.

The Education Department has prepared a calendar for reopening as per which, Classes IX to XII will continue on voluntary basis and with written permission of the parents/ guardians to attend school. Classes VI to VIII will resume with students attending only on voluntary basis with the consent of their parents from 02 November onwards.

Primary Further. classes [Classes III to V] "may be started from November 23, 2020 subject to COVID-19 Pandemic situation prevailing at that time," the depart-

ment has conveyed. The Department has also listed various activities like formation of groups, compiling contact details of parents/ informing guardians, groups about SOPs and other arrangement like hand washing, cleanliness etc. which have been assigned to the respective district heads and school-heads to be completed by 19 October.

As per a press communiqué issued by Nodal Officer for Public Relations and Publicity, Education Department, Bhim Thatal, the standard operating procedures prescribed by the Union Ministries of Education and Health and the SOPs prepared by the **Education Department** here will be the basic guidelines for schools and will have to be followed strictly.

The winter break has already been done away with completely and classes will function on all working days and half days on Saturdays, with the remaining half of Saturdays to be kept for cleaning etc.

The next academic session which was supposed to begin on February 02, 2021, will now begin on February 15, 2021. The current academic session shall end on February 13, 2021.

The release adds that the decision on reopening of schools was taken in line with instructions issued by the Ministry of Home Affairs to open schools in a graded manner from 15 October onwards.

It may be recalled that Government Schools have already been functioning since 21 September with 50% staff and students from classes IX to XII attending on a voluntary basis.

COVID-19 tally in India breaches 73lakh mark

New Delhi, Oct 15 (PTI): India's COVID-19 tally of cases climbed to 73.07 lakh with 67,708 new cases in a day, while 63,83,441 people have recuperated so far pushing the national recovery rate to 87.35 per cent on Thursday, according to the Union Health Ministry data.

The total coronavi rus cases mounted to 73,07,097 and the death toll climbed to 1,11,266 with the novel coronavirus virus claiming 680 lives in a span of 24 hours in the country, the data updated at 8 am showed.

The COVID-19 case fatality rate has further declined to 1.52 per cent. There are 812390 active cases of coronavirus infection in the country which comprises 11.11 per cent of the total caseload, the data stated. According to the ICMR, a cumulative total of 9,12,26,305 samples have been tested up to October 14 with 11,36,183 samples being tested on Wednesday.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 30 lakh on August 23 and 40 lakh on September 5. It went past 50 lakh on September 16, 60 lakh on September 28 and crossed 70 lakh on October 11.

The 680 new fatalities include 158 from Maharashtra, 75 from Karnataka, 64 from West Bengal, 52 from Tamil Nadu, 44 from Delhi, 33 from Chhattisgarh, 31 from Punjab and 28 from Andhra Pradesh.

A total of 1,11,266 deaths have been reported so far in the country including 40,859 from Maharashtra followed by 10,423 from Tamil Nadu, 10,198 from Karnataka.

With 41 new cases, Sikkim's **COVID** count reaches 3500

GANGTOK, 15 OCT: Cikkim recorded 41 Stresh cases of novel coronavirus and the discharge of 54 COVID-19 patients in the 24 hours ending 8 AM Thursday. With this, the State's tally of the confirmed COVID-19 cases reached 3,500, of which 3,048 patients have already been

Hospital Dara in DPH area, one from near Janta Bhawan in DPH area and one from MG Marg were also reported COVID-19 positive.

Likewise, samples of two persons from Rhenock, one from Tarpin and one from Aritar taken at Singtam District Hospital returned positive for COVID-19 in RT-PCR testing, he added.

Mr Bhutia informed that a 23-year-old female who had given her address as Tathangchen and a 30-year-old female from Manan Kendra, who were found COVID-19 positive in RT-PCR could not be contacted on the phone numbers provid-

ed by them. On the same, he urged them to contact health authorities on the toll-free number or text on the Health of Sikkim Facebook page.

He informed that one person from near primary school in Rolay, one from below the power house at Kazi Road and one from Rhenock in East District tested positive in rapid antigen testing.

Similarly, one person from Ralong, one from power colony in Jorethang and one from near power office in Namchi and a security staff of Gyalshing District Hospital in West District also tested positive in RAT, he said.

Night curfew along Indo-Bangla border in Cachar

GUWAHATI, OCT 15 (PTI): Night curfew clamped along the Indo-Bangladesh border in Cachar district of Assam with immediate effect on Thursday after movement of extremists were detected besides unauthorised transportation of commodities, an official release said.

Cachar Deputy Commissioner Keerthi Jalli promulgated the night curfew under Section 144 Cr PC along the Bangladesh border in the district for the next two months, an official release said.

"In view of the movement of extremist elements out to create law and order problems in the district and also unauthorised movement of commodities, including cattle from the district through areas surrounding the district borders, the order has been promulgated," it added.

Movement of individ-



ly prohibited between sunset and sunrise within one km radius of Indo-Bangladesh border, the order stated.

"No person shall move on Surma river and on its high bank within the limit of the territory in actual control of India in the district of Cachar between the hours of sunset to sunrise," it added.

The order stated that no person will be allowed to ply any boat in Surma even for fishing purposes and the permission for fishing has to be obtained from the circle officer of Katigorah.

The prohibitory order further stated that no person shall carry any vehicle, handcart, rickshaw or in any other mode of transport, sugar, rice, wheat, edible oil, salt and other commodities between sunset and sunrise within five km inside the district boundary of Cachar along the Bangladesh border.

"Permit may be issued in this regard by the Katigorah circle officer, who will only provide relaxation for specific purpose after verification from the local supply officials," the release added.

Why Caste Defines Indian Life?

Chashi Tharoor has become India's popstar **J**author and politician who has glorified a bombastic version of the English language in India. His prominence went to the next level after his Oxford Union debate. He used the English language in England's most famous debate to lacerate British colonialism by his brilliant argumentation laced with the rarest of indubitable facts and figures. Later his speech was modified into a book - An Era of Darkness: The British Empire in India. It is a masterclass for sure but I have a few objections.

In his passionate attack on the British colonialists, he argues that the caste system in the Indian subcontinent was not as divisive and harmful before the colonialists "helped solidify and perpetuate the inequities of the caste system in India". He romanticizes the pre-British India where "caste had not been a particularly stable social structure". This is one of his weakest arguments which, among other things, exculpates the contemporary campaigners of the caste system. Holding the British responsible for scaling up the caste system in India diverts national frustration and anger to foreigners while the desi custodians and merchandisers of the caste system will, not only go scot free, but will get ample socio-cultural manure to flourish. Sadly, this is happening on an ongoing basis. India must generously concede that the caste system had always been an exceedingly and awfully dehumanizing practice which crippled Indian civilizational growth in remarkably subtle ways. There are, quite possibly, very few other instances of human wisdom, knowledge, capacities and dignity being so thoroughly misused and wasted. Mahatma Gandhi realized that untouchability was a greater enemy than colonialism itself and appealed to his supporters to eliminate it before aspiring to independence. Ramachandra Guha, arguably the boldest historian of India says, "If you compare the Indian civilization with European or African civilizations, we historically perfected discrimination, stratification and hierarchy much more rigorously and systematically. There is no equivalent of the caste system anywhere". The ugliness of this inglorious system was never milder in the past. Its heinous-

ness is as old as its antiquity. Manusmriti, the most perniciously racist book ever conceived by the human mind was written in 2nd century BC. The book mirrors the civilizational inheritance, cultural technologies, social formation and religious wisdom that existed hundreds and hundreds of years before white racists landed on Indian shores.

I argue that the caste system in India is only going to worsen and here are my five reasons.

First, the religious underpinning of the caste system is the strongest reason why the Indian caste system will never leave Indian life. The exclusive privilege of priesthood, bestowed upon the highest Brahmanical sect, has deeply divided humanity at its core. As preposterous as it turn to pg 02

In open spaces, keeping the size of the ground/ space view, and with strict observance of social distancing, mandatory wearing of face masks, provisions for thermal scanning and hand wash or sanitizer. Public gatherings and rallies can be conducted subject to strict adherence to existing COVID-19 guidelines, the Chief Secretary's or-

The order asked the Deputy Commissioner of the respective district to identify in advance dedicated grounds for public gathering with clearly marked Entry/ Exit points and also put markers to ensure social distancing norms by the attendees. Chief Medical Officer/District Health Officials should be involved in the process to ensure that all COVID-19 related guidelines are adhered to by all concerned in the district, it said.

Deputy Commissioner and Superintendent of Police should ensure that the number of attendees does not exceed the limit prescribed in Point No.1 above, he said.

The Deputy Commissioner should give suitable instructions and strictly monitor for ensuring that all COVID-19 related requirements like face masks, sanitizers, thermal scanning, etc. are fulfilled by the political parties and candidates concerned during each of these activities, he said.

On the Door to Door Campaign, the Chief Secretary said subject to any other restriction(s) including extant COVID-19 guidelines, a group of 5 persons including candidates, excluding security personnel, if any, is allowed to do door to door campaigning.

may seem, India didn't bother to intervene until five years ago. Only in 2015 did the Supreme Court hold that caste and birth must never be considered a determining factor in the induction of priests in temples. Whether anyone is actually giving any heed to this court order is another issue. Religion is highly sacrosanct in a deeply religious country like India and it is therefore no wonder that Indian rationality hasn't outgrown some religious delusions. That Indian purity and impurity is based on caste is an amicably accepted religious reality.

Curiously, Indian Buddhists and Christians are intensely caste conscious. Buddha's renunciation of Hinduism was triggered by his skepticism and rejection of the authority of the Veda and caste system and yet his followers are happily hanging onto it. Sikkim Buddhism is one stark example. Caste is the single most important factor when it comes to doing rituals and choosing life partners. Many Christians as well are suffering from the ills of casteism indelibly ingrained in their racial genes while at the same time professing faith in Christ who taught that all humans are created equal in the image of God.

Secondly, cultural constructs necessitate the persistence of the caste system. An IIT professor, in a casual chat, told me that new generation students are open to having a romantic relationship with any caste but the vast majority will ultimately abandon that relationship to marry the person of their parents' choice (read 'same caste partner'). This trend is prevalent in non-Hindu Indian families as well. If that is the case in an elitist university, the situation in other universities can easily be construed. The dowry system is just as pervasive and rigorously practiced across the religious spectrum of the Indian population. Ironically, the most educated men fetch the highest dowry. Call it a 'gift' or whatever - the driving force is the

Our social mindset, political ploys and the administrative structure are the last three points which enable and advance the caste simple but they need a much large space than the few lines the word limit of this article provides. We can continue to ponder and discuss the issue. In my future articles, I will discuss why India, as a nation, loves the caste system.

Politics Demands Commitment

...but slack accountability makes casual flirtations too easy

nolitics is an exciting engagement, one that evokes passionate stands and distracts very easily. Where Sikkim is concerned, its political milieu has been traditionally populated rather extensively by teachers and midlevel government servants. Nothing wrong with having political leanings, in fact that would be a healthy engagement in a democracy, but everyone knows that involvement here used to extend much beyond that. It is also difficult in a State as small as Sikkim for anyone of any significance to remain genuinely apolitical. And as mentioned earlier, unless politics is really "dirty", there is nothing wrong in having a political position even if your job description requires you to stay detached. What is important though is for the people concerned to keep their responsibilities (as government servants or "social workers") and interests and (political) beliefs in separate silos. Unfortunately, government servants, given the astoundingly slack concepts of accountability enforced by the administration, are easily tempted to flirt with politics In systems where accountability is casually fixed and job-responsibilities poorly defined, it is easy to start dispensing favours and bending rules; and before one knows it, the administrators become rather deft political players themselves. Engagement with party level politics follows and then come political ambitions.

What blurs the line even more is the confusion with which politics is mixed up with administration and government mistaken for a party. Also, in a political environment thick with parties and slim on ideological differentiators, the decision to take the plunge comes easy because options never dry out and crossovers rarely need to be explained with any conviction. Not just government servants, but this situation makes it easy for everyone to 'try out' politics, move around political parties, taste all options and if nothing works out, step back into a supposedly "apolitical" life only to resurrect whenever occasion demands or opportunity arises. It is the facility with which this last option [the one of turning apolitical whenever it suits one] can be acquired that makes irresponsible dabbling in party politics so easy for most wannabes here.

Let us agree first that while ideological political positions are absolutely acceptable, and even welcome, it is the tendency to engage in 'active' politics, the one involving planning and negotiating, that vitiates work cultures and political engagements. This latter involvement diverts attention from the tasks they draw salaries for [in the case of government servants], and should they be aligning with factions opposed to the ruling party, could also lead to willful compromising of policy implementation. In the case of private people involved in "social work", simultaneous political and social pursuits come at the cost of sabotaging their responsibilities towards society. And this cannot be dismissed as inconsequential even if they are volunteering their time and energies, because when one occupies a public space, one is required to remain earnest and not allow their priorities to get colored by political exigencies.

Politicians rarely suffer the fallout of such situations and the loss, in the long run, is burdened on the people whom the politicians, the government employees and the social workers should be serving first. Politics does not compromise governance or administration; it is the ambitious politicking that robs people of deserved delivery. For that reason alone, it is advisable to maintain a healthy interest in politics and also hold opinions, but leave the politicking to politicians; and if one is to engage actively, then doing so with full commitment.

How do pandemics end? History suggests diseases fade but are almost never truly gone

When will the pandemic end? All these months in, with over 37 million COVID-19 cases and more than 1 million deaths globally, you may be wondering, with increasing exasperation, how long this will continue.

Since the beginning of the pandemic, epidemiologists and public health specialists have been using mathematical models to forecast the future in an effort to curb the coronvirus's spread. But infectious disease modeling is tricky. Epidemiologists warn that "[m]odels are not crystal balls,"

and even sophisticated versions, like those that combine forecasts or use machine learning, can't necessarily reveal when the pandemic will end or how many people will die.

As a historian who studies disease and public health, I suggest that instead of looking forward for clues, you can look back to see what brought past outbreaks to a close – or didn't.

WHERE WE ARE NOW IN THE COURSE OF THE PANDEMIC

In the early days of the pandemic, many people hoped the coronavirus would simply fade away. Some argued that it would disappear on its own with the summer heat. Others claimed that herd immunity would kick in once enough people had been infected. But none of that has happened.

A combination of public health efforts to contain and mitigate the pandemic - from rigorous testing and contact tracing to social distancing and wearing masks - have been proven to help. Given that the virus has spread almost everywhere in the world, though, such measures alone can't bring the pandemic to an end. All eyes are now turned to vaccine development, which is being pursued at unprecedented speed.

Yet experts tell us that even with a successful vaccine and effective treatment, COVID-19 may never go away. Even if the pandemic is curbed in one part of the world, it will likely continue in other places, causing infections elsewhere. And even if it is no longer an immediate pandemic-level threat, the coronavirus will likely become endemic meaning slow, sustained transmission will persist. The coronavirus will continue to cause smaller outbreaks, much like seasonal flu.

The history of pandemics is full of such frustrating examples.

ONCE THEY EMERGE, DISEASES RARELY

Whether bacterial, viral or parasitic, virtually every disease pathogen that has affected people over the last several thousand years is still with us, because it is nearly impossible to fully eradicate them.

The only disease that has been eradicated through vaccination is smallpox. Mass vaccination campaigns led by the World Health Organization in the 1960s and 1970s were successful, and in 1980, smallpox was declared the first – and still, the only - human disease to be fully eradicated.

So success stories like smallpox are exceptional. It is rather the rule that diseases come to stay.

Take, for example, pathogens like malaria. Transmitted via parasite, it's almost as old as humanity and still exacts a heavy disease burden today: There were about 228 million malaria cases and 405,000 deaths worldwide in 2018. Since 1955, global programs to eradicate malaria, assisted by the use of DDT and chloroquine, brought some success, but the disease is still endemic in

Plague is caused by the bacterium Yersinia pestis. There have been countless local outbreaks and at least three documented plague pandemics over the last 5,000 years, killing hundreds of millions of people. The most notorious of all pandemics was the Black Death of the mid-14th century.

Yet the Black Death was far from being an isolated outburst. Plague returned every decade or even more frequently, each time hitting already weakened societies and taking its toll during at least six centuries. Even before the sanitary revolution of the 19th century, each outbreak gradually died down over the course of months and some-



many countries of the Global South.

Similarly, diseases such as tuberculosis, leprosy and measles have been with us for several millennia. And despite all efforts, immediate eradication is still not in sight.

Add to this mix relatively younger pathogens, such as HIV and Ebola virus, along with influenza and coronaviruses including SARS, MERS and SARS-CoV-2 that causes COVID-19, and the overall epidemiological picture becomes clear. Research on the global burden of disease finds that annual mortality caused by infectious diseases - most of which occurs in the developing world - is nearly one-third of all deaths globally.

Today, in an age of global air travel, climate change and ecological disturbances, we are constantly exposed to the threat of emerging infectious diseases while continuing to suffer from much older diseases that remain alive and well.

Once added to the repertoire of pathogens that affect human societies, most infectious diseases are here to stay.

PLAGUE CAUSED PAST PANDEMICS - AND STILL POPS UP

Even infections that now have effective vaccines and treatments continue to take lives. Perhaps no disease can help illustrate this point better than plague, the single most deadly infectious disease in human history. Its name continues to be synony-

times years as a result of changes in temperature, humidity and the availability of hosts, vectors and a sufficient number of susceptible individuals.

Some societies recovered relatively quickly from their losses caused by the Black Death. Others never did. For example, medieval Egypt could not fully recover from the lingering effects of the pandemic, which particularly devastated its agricultural sector. The cumulative effects of declining populations became impossible to recoup. It led to the gradual decline of the Mamluk Sultanate and its conquest by the Ottomans within less than two centuries.

That very same state-wrecking plague bacterium remains with us even today, a reminder of the very long persistence and resilience of pathogens.

Hopefully COVID-19 will not persist for millennia. But until there's a successful vaccine, and likely even after, no one is safe. Politics here are crucial: When vaccination programs are weakened, infections can come roaring back. Just look at measles and polio, which resurge as soon as vaccination efforts falter.

Given such historical and contemporary precedents, humanity can only hope that the coronavirus that causes COVID-19 will prove to be a tractable and eradicable pathogen. But the history of pandemics teaches us to expect otherwise.

Coronavirus: Superspreading events could help make COVID-19 endemic

The COVID-19 coronavirus is not **■** your average virus. During the pandemic, it has become increasingly clear that averages do not apply in understanding the paths the virus takes or when or where it attacks. What some scientists and specialists in infectious diseases may say in the morning will be ridiculed before sunset. Consequently, we must be scientifically humble in predicting what is likely to happen over the next year or two.

But from the limited data that we have have, it appears that clusters of transmission from one person to a potentially large group are particularly important to maintaining the virus's spread. In fact, these so-called superspreading events could be so significant that - without highly effective testing and contact tracing - they could cause COVID-19 to become a constant feature of our lives, even if case numbers are brought to manageable lows.

Scientists and politicians have so far relied heavily on the calculated average contagiousness of the virus to track progress in dealing with the pandemic. This is represented by the "R number", which basically indicates how many people an infected individual will pass the virus on to. If they infect more than one, then the number of cases will grow and we have a problem. If they infect less than one, we are safer because the number of cases will decrease as people recover.

But being an average measure, R tends to obscure the real picture of

a virus that typically spreads in clusters rather than from one person to one or two others. Indeed, sometimes an infected person will cause virtually no spread of the virus while another will infect almost everyone in a crowded room. When so many factors are involved outbreaks are not always predictable and this provides the basis for a future with endemic COVID-19 spread.

For example, a preprint (not yet peer reviewed) study has shown that some outbreaks in nursing homes only occurred after several new introductions of infection. This indicates that what can look like a single outbreak actually is a situation with multiple concurrent but independent introductions of COVID-19.

Another preprint study carried out in New Zealand used genetic sequencing to track how individual strains of the virus were being transmitted. It found that only one in five infections entering the country led to additional cases and most cases were linked to a single transmission cluster. Meanwhile, a single person in South Korea is thought to have infected more than 5,000 people in a large church cluster.

Such clusters of transmission appear to take place under certain conditions that enable the virus to disperse rapidly through a crowd. Crowded indoor places that are badly ventilated and where people are physically or vocally active for a relatively long period seem to create a particular risk. This may be because virus can accumulate in the air in rooms without proper ventilation and allow transmission even when social distancing is taking place.

Research from China has confirmed that ventilation is particularly important. Buses that recirculated air were found to be linked with more cases than those not using recirculation. And, in one case of a transmission cluster in a restaurant, those who sat closest to the ventilation outlet all contracted COVID-19 while none of the customers near the venti-

lation inlet were infected. However, what's puzzling is that this doesn't explain why some potential superspreading events don't cause an outbreak, and why there are outbreaks that do not have the known characteristics of a superspreading event. This suggests there are other unknown factors. It looks as if some clusters provide valuable information while others don't.

Our analysis is skewed by the fact that we only have data for relatively well-defined outbreaks where everybody involved were easily identified, such as tourists on cruise ships, choirs, Zumba dance groups or church congregations. But in real life most outbreaks occur without a clear social setting or in groups where some members are difficult to track down. Further genetic surveillance of outbreaks will probably help us develop our understanding.

It's also harder to obtain the necessary information to track clusters of infections that come from certain social or cultural groups. For example, stigma or fear of the authorities could discourage some people from reporting their illness. Those taking part in secret or illicit parties might

underestimate the risk and consequences of their catching the virus. **BAD LUCK**

Some of the worst initial outbreaks in Italy, China, Ecuador and other places may have been due to sheer bad luck: too many of the known factors occurring in the same place at the same time. It's not a verv clever or scientifically satisfying explanation, but that's probably a feature of COVID-19 that we must live with for now.

But as Italy and Ecuador have shown, COVID-19 has the potential to turn bad luck into a disaster. This means that even if control measures such as social distancing help us to bring R below 1 and reduce ongoing community spread to relatively low levels, superspreading events can can turn comfort into chaos in a few days.

Those countries that have successfully contained epidemic for significant periods of time, such as New Zealand, have done so through very rigorous contact tracing of the person that starts a cluster of transmission combined with strategic testing. But even in these cases, new outbreaks have occurred.

Countries that fail to develop adequate test and trace systems will have to live with low-grade spread and cluster outbreaks for years to come. In this way, the virus will become endemic, adding a further challenge to global efforts to tackle poverty and improve healthcare. It would be a shame if we let COVID-19 do that when we know how to prevent it.

10,000 ineligible names to be deleted from final NRC in Assam

GUWAHATI, OCT 14 [PTI]: Around 10,000 names will be deleted from the final NRC in Assam as many "ineligible persons" and their descendants were included in the list, according to a directive issued by its state coordinator Hitesh Dev Sarma and officials in the know of the decision.

Sarma wrote to all the Deputy Commissioners and District Registrar of Citizen Registration (DRCR) on Tuesday, directing them to issue speaking orders for the deletion of such names.

"...as per the reports received from your end through Webform, some names of ineligible persons belonging to the categories of DF (declared foreigners)/DV ('D' voters)/PFT (pending in Foreigners Tribunals) along with their descendants have found entry to the NRC," he said.

Sarma directed the district officials to issue orders for deletion of such names from the NRC as per Clause 4(6) of the Schedule under the Citizenship (Registration of Citizens and Issue of National Identity Cards) Rules, 2003 after "specifically ascertaining the identity of the person".

Explaining the rule



and some other relevant clauses, Sarma pointed out that the authorities concerned can verify and include or exclude any name at any time before the publication of the final NRC.

Though the final National Register of Citizens for Assam was made public in August last year, it is yet to be notified by the Registrar General of India, leaving the historic and controversial document without any official validity.

"You are, therefore, requested to submit the list of such persons who are not eligible for having their names in the NRC along with speaking order justifying reasons for each cases for necessary action for deletion of such names," Sarma said in the letter.

A software application for submission of the reviewed results of such persons along with mechanism for uploading of the scanned freshly written speaking orders will be rolled out shortly, he added.

Few Bengal cinemas reopen after nearly 7-month hiatus

Only a few multiplexes and cinema halls in West Bengal reopened for movie-goers on Thursday after nearly a seven-month hiatus.

Authorities of the cinemas said they are strictly maintaining the COVID-19 protocol.

Other facilities will reopen gradually from Friday till October 21, a day before the commencement of the Durga Puja festivities.

"Two of our facilities have reopened today with strict adherence to the COVID-19 protocol, which includes movie screening with 50 per cent capacity of the halls by keeping alternate seats vacant, and marking circles on the floor near the ticket and food counters to ensure social distancing," a spokesperson of multiplex chain INOX said.

Other facilities will be gradually reopened as per the operational readiness, she said.

Movie-enthusiasts are entering the halls using e- tickets and QR code scanners in the facilities in Swabhumi in Kolkata and Madhyamgram in North 24 Parganas district, she said.

Thermal screening is being conducted at the entrance and those with fever symptoms are not being allowed to enter, the INOX spokesperson said.

The show timings, intermissions and movie-goers' exit from halls are in a staggered man-

> The SVF Cinemas, which owns 13 multiplexes in the city, will reopen its facilities from Friday with a contactless ticket purchasing system, seating arrangements ensuring social distancing and regular sanitisation before and after the shows, a spokesperson said.

Regional multiplex Jaya will start screening movies at its facilities in Kolkata's Lake Town area and Barasat in North 24 Parganas district from Friday.

Sourav Bose, the owner of Basusree Cinema in Kalighat area, said Sushant Singh Raiput-starter 'Kedarnath' will be screened from Friday with strict adherence to the COVID-19 protocol.

A maximum of 500 tickets will be sold against the seating capacity of 1,020, he said.

"During Durga Puja, we will screen new Bengali film 'SOS Kolkata'," Bose said.

Satadeep Saha, a prominent film distributor, said 22 single-screen theatres across the state are screening 'Kedarnath' from Thursday.

Navin Chokhani, the owner of Navina Cinema on Prince Anwar Shah Road in south Kolkata, said the popular single- screen theatre will reopen on October 21 as work is in progress to ensure all safety protocols.

There will be separate entry and exit, contactless ticketing system and movie-goers will be allowed to enter the hall after exhibiting an SMS sent to their mobile phones with details like price of the ticket and seat number, he said.

"There will be a gap of 30 minutes between each of the three shows to avoid crowding. Tickets will be sold for 400 seats, half of the hall's capacity," Chokhani said, adding 'Dracula Sir', a Durga Puja release, will be one of the films that will be screened.

Ratan Saha, the owner of Ajanta Multiplex and an office-bearer of the Eastern India Motion Pictures Association (EIMPA), said, "We will reopen from October 21 by adhering to the safety measures. The seating capacities in our two multiplexes have been reduced to 200 and 100."

Most of the 250 single-screen theatres in the state will gradually reopen before October 22, when the Durga Puja festivities will begin, an EIMPA spokesperson said.

A total of 12 Bengali films have been lined up for screening during Durga Puja, with several of them being re- releases of movies that got decent footfalls before the imposition of the nationwide lockdown.

The cinemas the state were shut on March 18 following the COVID-19 outbreak.

However, I am pretty sure that we have held consultations with all civil society organisations and political parties on the issue. No consensus has been reached yet," she told PTI. The Mizoram government is making all kinds of efforts to settle the border disputes with the neighbouring states, she added.

Mizoram reports 8 new COVID-19 cases; tally 2,220

AIZAWL, OCT 15 (PTI): Mizoram's COVID-19 caseload on Thursday reached 2,220 as eight more persons tested positive for the virus, an official statement said.

Of the eight fresh cases, seven were reported from Aizawl city area while one case was reported from Kolasib district near the Assam border, the Information and Public Relations department said. Seven cases were locally transmitted while one patient has returned from Assam.

According to the health department, the number of active cases in the state now stands at 112, while 2,108 people have recovered from the virus. The COVID-19 recovery rate is 94.96 per cent.

Mizoram has not reported any fatality due to COVID-19 so far. A total of 92,151 samples have been tested for COVID-19 till date.

10 new cases push COVID-19 tally of Andamans to 4,046



PORT BLAIR, OCT 15 (PTI): The COVID-19 tally of Andaman and Nicobar Islands rose to 4,046 on Thursday as 10 more people tested positive for the infection, a health official said.

Three new patients have travel history, while seven fresh infections were detected during contact tracing, he said.

Fourteen more people have been cured of the disease, taking the total number of recoveries in the archipelago to 3,796, the official said.

The Union territorv now has 195 active COVID-19 cases, while 55 patients have succumbed to the infection so far, he said.

The administration has so far sent 71,624 samples for COVID-19 tests, of which 71,620 reports have been received and four are awaited, the official added.

Son drives Spurs to the top of South Korean popularity stakes

SEOUL, 15 OCT (REU-TERS): Son Heung-min has helped Tottenham Hotspur past Manchester United to become the most popular foreign club in South Korea with more than 20% of the nation now allied to the North London side, according to Nielsen Fan Insights.

In a graphic illustration of the selling power of a big name player, five years of Nielsen Fan Insights surveys show that Spurs had negligible support in the nation of 52 million before Son joined the club in 2015.

Since then, Son's rise to the top of the English game has been matched by the popularity of his club in his homeland Spurs moving steadily past Arsenal, Chelsea, Real Madrid and Barcelona before eclipsing United in late 2018.

They have remained the most popular overseas club since and the most recent survey of South Koreans aged 16 to 69 gives them 21.4% support -- representing



some 11 million fans -compared to 6.1% for the second most popular club, United.

"The popularity of Tottenham Hotspur in South Korea perfectly illustrates the positive impact a standout player can have on a sports franchise in a market halfway around the world," said Marco Nazzari, Managing Director, International at Nielsen Sports.

United's previous popularity was also driven by a player, with midfielder Park Ji-sung's arrival at Old Trafford in 2005 sparking major South Korean interest in the English top flight.

Although Park won a Champions League and four Premier League titles in seven years in Manchester, Son's individual profile has far outstripped his fellow South Korea international both in England and back home.

Son has scored 59 goals in 164 Premier League matches for Spurs and last month became the first player from Asia to score four goals in an English top flight match

with a brilliant display against Southampton.

With figure skater Kim Yuna retired and swimmer Park Tae-hwan out of the picture, Son is now South Korea's number one sports personality and his face in advertisements and goals in the Spurs shirt are ubiquitous on local TV screens.

Delhi's Nortje bowls fastest ball in IPL history

DUBAI, 15 OCT [REU-TERS]: South African pace bowler Anrich Nortje bowled the fastest ball in Indian Premier League (IPL) history on Wednesday during his team Delhi Capitals' 13-run victory over Rajasthan Royals.

The 26-year-old eclipsed compatriot Dale Steyn's effort of 154.40 km per hour set in 2012, clocking 154.74 kph and 155.21 kph in the game at Dubai before his best effort of 156.22 kph was scooped for a boundary by Rajasthan's Jos Buttler.

Nortje responded immediately with another fiery delivery in the third over to bowl out the England batsman. He finished the match with figures of 2-33 from four overs to take his wicket tally for the season to 10 from eight games.

"I didn't know about it (the fastest ball). I've been working really hard to get the pace up ... but obviously you want to land it in the right areas. That's the most important thing," Nortje said in

Jota makes up for Ronaldo's absence as Portugal beats Sweden

LISBON, OCT 15 (AP): Diogo Jota scored two goals and set up another as Portugal defeated Sweden 3-0 in the Nations League in its first game since Cristiano Ronaldo had to be dropped from the squad after testing positive for the coronavirus.

Ronaldo went back to Italy earlier Wednesday to finish his isolation period after testing positive for COVID-19 on Monday.

Ronaldo had played in the national team's 0-0 draw at France on Sunday, and in the 0-0 draw against Spain in a friendlv last week.

"We are not better without Ronaldo, but the team had shown before that it is capable of succeeding without him," Portugal coach Fernando Santos said.

"We were well-organized offensively."

The Juventus forward, who was said to be asymptomatic, posted a photo on his social media accounts with him wearing Portugal's jersey in front of a television set with the game on.

"It's as if I was there," he wrote.

Jota, who came into the lineup to help make up for Ronaldo's absence, set up Bernardo Silva's opening goal in the 21st minute and scored himself in the 44th. The new Liverpool forward finished off the scoring after going past a defender inside the area in the 72nd.

Some 5,000 fans were allowed to watch the match at the Jos Alvalade Stadium in Lisbon.

Nearly 2,500 had been in the stadium for the team's 0-0 friendly against Spain last week as authorities try to evaluate whether to allow fans back in local soccer competitions. The victory left defending Nations League champion Portugal at the top of Group 3 with 10 points.

Liverpool and Everton braced for Merseyside derby with a difference

LONDON, 15 OCT [THEGUARDIAN]: For most of the last 30 years Liverpool have gone into Merseyside Stanley Park as Premier League champions they are having to deal with Everton getting most of the pre-match attention.

We know enough about Carlo Ancelotti's side's perfect start, not just four league wins out of four but seven victories out of seven in all competitions. We know about Dominic Calvert-Lewin's goals. James Rodríguez's unlikely rehabilitation and Jordan Pickford's erratic displays. But what can be expected of Liverpool based on their season so far?

This time last year, back when things were normal and eight matches had been played, the prospective champions had recorded eight consecutive league wins and were just about to drop their first points of the season in being held to a draw at Old Trafford. It would be the end of February before Liverpool dropped any more, falling to unexpected defeat at Watford with the title all but confirmed after an incredible 26 wins plus the point from Manchester United.

So unanswerable was that sort of form and consistency that most people assumed it would be more of the same this season, with only Manchester City likely to be able to stay with the pace, but so far it has not quite turned out that way. The first defeat of the season arrived early, for a start, and anyone surprised at the 3-0 scoreline at Watford last season would have been flabbergasted by the 7-2 outcome at Villa Park.

There were some extenuating circumstances, Liverpool were missing Alisson through injury and Sadio Mané through testing positive for Covid-19, but not enough to wholly explain such a mauling

for newly crowned champions playing a side that only narrowly avoided relegation a few months earlier. While Liverpool's relentderbies as favourites, so it is ironic less consistency was their chief that now they are finally crossing asset last season, their unique selling point when even sides as strong as Manchester City and Tottenham were wavering, the illusion of impregnability evaporated at Aston Villa.

> Perhaps there were signs that all was not functioning completely correctly on the opening day of the season, when Liverpool shipped three goals in a 4-3 victory over newly promoted Leeds. Yet when that was followed by a clean sheet at Chelsea and a tidy home win against Arsenal a fairly testing start to the campaign seemed to have been successfully negotiated. The way things looked before a ball had been kicked Villa would be one of the less troublesome of the early fixtures, a respite between the two London clubs and the derby. Now the derby itself has taken on greater significance, with Everton top of the league and confidence high in the blue camp, the idea that Jürgen Klopp's Liverpool are a win machine switched to a permanently high setting no longer seems quite as persuasive.

> Not that Liverpool are alone in falling to heavy defeats this season. Both Manchester clubs have also conceded five goals or more, amid a general feeling that this odd, spectator-free football has still to settle down into a pattern, never mind a predictable pattern. Adding to the uncertainty around Anfield have been no fewer than four coronavirus positives, two of them to key first-team performers in Mané and Naby Keïta, and one to limit the contribution thus far by new signing Thiago Alcântara.

Liverpool have been unlucky also in losing their first choice goalkeeper - although the initial prognosis was just a few weeks,

shoulder injuries are never good news for goalkeepers - while off the field the club's owners have been revealed as central plotters in the dismal Project Big Picture scheme, something that will almost certainly sit uncomfortably with Klopp's egalitarian instincts.

In short, though it is only 12 weeks since Liverpool picked up their well-deserved prize at an empty Anfield, the landscape has already altered around the champions in ways that few would have anticipated. Suddenly there are questions to be asked and answered, with most Everton fans keen to commence the interrogation. Once again a Merseyside derby is being hyped as a potentially cataclysmic event when everyone knows they are usually nil-nil draws, or dull games enlivened by mere moments.

The last Goodison derby was supposed to see Liverpool win their long-awaited first Premier League title on their rivals' patch. Supporters had been counting down the days and working out the permutations for weeks nervously or excitedly, depending on allegiance - though of course it didn't work out like that. A goalless draw simply cost Liverpool the chance to reach 100 points for the season and the opportunity to clinch the title in the next game at Anfield. Instead there was an off-stage coronation when Manchester City stumbled at Chelsea.

Derby matches are often like that, prosaic rather than pivotal. While the Merseyside version has managed to be more colourful than most in its long and proud history, the reality for the last few decades is that it has been essentially a private scrap, a localised issue of limited relevance to the rest of the game. This time, with Liverpool champions and Everton top of the league, it is different.

History suggests the derby will not be as open or as freakishly compelling as events at Villa Park last month - a game apparently responsible for convincing Premier League officials they should be charging for such rich entertainment rather than airing it for free - though outside interest will still be high. It is not often you see Liverpool beaten 7-2, defending champions or not, and anyone who missed it will be just as keen as those who watched it to see how they are going to react.

EU leaders divided over new climate goals for 2030

BRUSSELS (AP): European Union leaders remain divided about a more ambitious target for cutting greenhouse gas emissions and will not reach an agreement at their summit starting Thursday.

According to a draft of the meeting's findings seen by The Associated Press, leaders will at this summit only start discussing the proposal to reduce emissions by at least 55% by 2030, as put forward by the EU's executive Commission.

The goal is to reach an agreement in December ahead of the adoption of the first ever European climate law.

In proposing a reduction target of at least 55% by 2030 compared with the current target of 40%, EU commission President Ursula von der Leven predicted in September that the new target would be "too much for some and not enough for others.

Supported by Germany, Von der Leyen's revised target needs to be endorsed by the 27 EU countrie to make it legally binding. On Wednesday, a group of 11 countries including Denmark, Estonia, Finland, France, Ireland, Latvia, Luxembourg, the Netherlands, Portugal, Spain and Sweden embraced her ambition in a joint statement published ahead of the summit in Brussels.

"Let us, as a Union, deliver a strong and credible response to the climate crisis and increase our 2030 climate target to at least 55%, leading to climate neutrality by 2050," they said in the statement.

But officials said there is no agreement across the bloc.

While the Eu Parliament pushes for an even greater 60% reduction in emissions, some eastern EU countries that depends on coal for much of their energy needs are less enthusiastic. They worry about the social, environmental and economic costs of the transition to a greener economy. Poland last year did not commit to the EU's 2050 climate neutrality goal and is asking for more details about the measures.

Von der Leyen has said she wants 37% of the 750 billion euros in the coronavirus recovery fund to be given to EU countries to spend on environmental objectives, while 30% of the bloc's regular budget should be used to tackling climate change.

World leaders agreed five years ago in Paris to keep global warming below 2 degrees Celsius (3.6 degrees Fahrenheit), ideally no more than 1.5 degrees C (2.7 F) by the end of the century. Scientists say countries will miss both of those goals by a wide margin unless drastic steps are taken to begin cutting greenhouse gas emissions. Under the Paris Agreement, countries are due to submit updated climate targets by the end of the year.

Armenia, Azerbaijan tensions rise amid claims of new attacks

YEREVAN, OCT 14 (AP): The conflict between Armenia and Azerbaijan escalated Wednesday, as both sides exchanged accusations and claims of new attacks over the separatist territory of Nagorno-Karabakh, where heavy fighting continues for a third week despite a Russia-brokered cease-fire deal.

Russian President Vladimir Putin spoke by phone with his Turkish counterpart Recep Tayyip Erdogan, emphasizing the need to respect the truce that was violated immediately after taking effect Saturday. Putin also voiced concern about the involvement in the conflict by militants from the Middle East a reference to Turkey deploying Syrian fighters to combat Armenian forces in Nagorno-Karabakh.

Erdogan denied the deployment of combatants to the region in separate comments, but a Syrian war monitor and Syria-based opposition activists have confirmed that Turkey has sent hundreds of Syrian opposition fighters to Nagorno-Karabakh.

In a sign that the conflict was widening, Azerbaijan's military said it destroyed an Armenian missile system on the territory of Armenia that was positioned to target civilian areas. Armenia's Defense Ministry responded by stating that it reserves the right to target Azerbaijani military

objects and troop movements. So far, Armenia and Azer-



baijan have denied targeting each other's territory in the fighting over Nagorno-Karabakh, although each of the parties often contested the denials.

An expansion of hostilities beyond the separatist region could trigger a dangerous escalation of the decades-old conflict over Nagorno-Karabakh, which is inside Azerbaijan but has been under the control of ethnic Armenian forces backed by Armenia since the end of a separatist war in 1994. The Armenian forces also have controlled significant chunks of Azerbaijani territory outside the separatist region.

Armenia's Foreign Ministry condemned Azerbaijan's attempt at military aggression towards Armenia's sovereign territory and warned of irreversible military and political consequences. The mutual accusations and threats raised concern about the safety of a strategic pipeline that carries Azerbaijan's Caspian Sea crude oil to Turkey and on to Western markets.

Azerbaijani President Ilham Aliyev threatened very heavy response, should Armenia carry out its plans to destroy oil and gas pipelines in Azerbaijan.

Officials in Nagorno-Karabakh accused Azerbaijan of firing at a hospital in the region and called it a war crime," but didn't elaborate on whether there were any casualties. Azerbaijan's military rejected the Armenian claim.

The recent fighting between Armenian and Azerbaijani forces erupted on Sept. 27 and marked the biggest escalation of the conflict in more than a quarter-century.

It has killed hundreds despite numerous calls for peace.

Russia, which has a security pact with Armenia but also has cultivated warm ties with Azerbaijan, hosted top diplomats from Armenia and Azerbaijan for more than 10 hours of talks that ended with Saturday's cease-fire deal.

But the agreement buckled immediately, with both Armenia and Azerbaijan accusing each other of breaching it with continued attacks.

Russian Foreign Minister Sergey Lavrov voiced hope for a peace deal that would see Armenian forces surrender control over the regions of Azerbaijan outside Nagorno-Karabakh, while Azerbaijan would lift its blockade of Armenia. He suggested that Russia could deploy military observers to help end the hostilities, adding that both warring sides obviously must accept it. Azerbaijan, however, has insisted it has the right to reclaim its land by force after efforts by the so-called Minsk group of international mediators that comprises Russia, the United States and France failed to yield any progress. It has actively pushed for its ally

Turkey to take a prominent

role in future peace talks.

What matters is for Turkey to be at this table. And it already is, Aliyev said in an interview broadcast Wednesday, pointing out that he discussed the conflict over Nagorno-Karabakh with both the Russian and the Turkish presidents, and Russia's defense minister has recently talked about it to the Turkish defense minister.

Turkey has publicly sided with Baku and vowed to help Azerbaijan reclaim its territo-

ry. Turkey's newly assertive role reflects Erdogan's ambitions to expand his nation's clout. In Wednesday's call with Putin, Erdogan accused Armenia of trying to make its occupation of Azerbaijan's lands "permanent, according to a statement from the Turkish leader's office.

Erdogan spokesman Ibrahim Kalin said an in interview Tuesday that Ankara would favor four-way peace talks involving Russia, Turkey, Armenia and Azerbaijan. The Minsk group is not able to produce a solution for the past 30 years. Are we to wait another 30 years? In this case we need to think of another mechanism," Kalin said.

Turkey's highly visible role in the conflict raised painful memories in Armenia, where an estimated 1.5 million died in massacres, deportations and forced marches that began in 1915. The event is widely viewed by historians as genocide, but Turkey denies that.

Armenian Prime Minister Nikol Pashinian accused Azerbaijan and Turkey of continuing Turkey's genocidal policy toward Armenians.

U.S. Secretary of State Mike Pompeo said Washington was making diplomatic efforts to help achieve a sustainable settlement to the conflict. We call on both countries to implement their agreed-upon commitments to a cease-fire, and stop targeting civilian areas, he said.

Some European officials use virus as a cover to target Roma

BURGAS, BULGARIA (AP): In Bulgaria, Roma communities were sprayed with disinfectant from crop dusters this spring as coronavirus cases surged in the country. In Slovakia, their villages were the only ones where the army conducted testing. And across Central and Eastern Europe, reports of police using excessive force against Roma spiked as officers were deployed to enforce lockdowns in their towns.

Human rights activists and experts say local officials in several countries with significant Roma populations have used the pandemic to unlawfully target the minority group, which is Europe's largest and has faced centuries of severe discrimination. With COVID-19 cases now resurging across the continent, some experts fear the repression will return, too.

To make matters worse, activists say such discrimination often draws little opposition from other Europeans and the Roma are reluctant to speak about it, fearing repercussions.

One afternoon, Azime Ali Top-

chu, 48, said the police-enforced lockdown of her village in Burgas, on Bulgaria's Black Sea Coast, made her family "really sad."

"It was hard. Hard. For my whole family to go to work — for my husband and son they had to go, fill in the papers, so they could go through the police checks," she said, as her three grandchildren played near piles of neatly stacked wood.

But Topchu, who lives in a one-story brick house next to her son and daughter-in-law, was unwilling to go much further than that. The streets of their village were sprayed with disinfectant though not from the sky — several months earlier.

Topchu said she considered the disinfecting "something that had to be done.'

But other Roma villages — in Yambol, Kyustendil and elsewhere activists. "That was clearly racist, because it was only done in Roma neighborhoods," said Radoslov Stoyanov of the Bulgarian Helsinki Committee, a human rights group. "The broader message that was sent to the non-Roma population was that the Roma are dangerous."

The Roma people are descendfrom tribes in northern India, and centuries of persecution and marginalization have left them some of the poorest and least educated people in Europe. Known pejoratively as "gypsies," many live in segregated neighborhoods, often with limited access to electricity, running water and health care. Many face discrimination in getting jobs, getting medical care and have a shorter average lifespan than non-Roma.

The stringent measures used against Roma communities come even though no big outbreak was navirus cases among the Roma.

European lawmakers won't be back in Strasbourg this month

BRUSSELS (AP): European lawmakers won't be returning to the French city of Strasbourg for next week's plenary session because of the COVID-19 resurgence in France, the European Parliament president said Thursday.

David Sassoli tweeted that the session will be held remotely. "The situation in France and Belgium is very serious and traveling is not advised," he said.

Plenary sessions scheduled in Strasbourg, which is the official seat

of the European Parliament — have been scrapped since March because of concerns related to the coronavirus. Staff and parliamentarians are mostly based in Brussels but almost all Strasbourg, much to the chagrin of many legisla-

But French President Emmanuel Macron is a strong supporter of the Strasbourg sessions and recently said that the EU is "screwed" if the Euro-





Glenn Close, Amy Adams Star in Trailer for **Upcoming Adaptation of 'Hillbilly Elegy'**

Netflix has released the new trailer for Ron Howard's adaptation of the second Howard's adaptation of J.D. Vance's memoir about growing up in Appalachia, Hillbilly Elegy. The film will premiere on the streaming service November 24th.

The film stars Gabriel Basso as Vance and is set at the moment when the former Marine and current Yale Law student is on the cusp of getting his dream job. He's unfortunately forced to return home to southern Ohio to tend to a family crisis. As the trailer teases, the film seems to jump between past and present as Vance tries to help his mother, Bev (played by Amy Adams), who struggles with addiction, while drawing on the memories of his grandmother Mamaw (Glenn Close), who raised him.

Vance — who works primarily as a venture capitalist and got his start working at a firm owned by Peter Thiel — published Hillbilly Elegy in August 2016. While it became a bestseller upon its initial arrival, it saw a significant resurgence several months later, following the election of President Donald Trump.

The book earned plenty of plaudits for its depiction of life in Appalachia, and many turned to it as a way to understand what forces propelled Trump to victory in states like Ohio, Pennsylvania, Michigan, and Wisconsin.

Company behind SKorean hit band BTS soar in trading debut

Big Hit Entertainment, the company that manages global pop sensation BTS, had a dynamite trading debut Thursday in Seoul, helped by the zeal of its loyal fans. Big Hit's shares nearly doubled

after their initial public offering netted more than \$800 million. The strong start was widely expected by analysts given the huge fan base for the seven-member boy band that has been dominating Billboard charts. Its market value stood at about \$7.5 billion by the end of trading.

Despite the concert-killing COVID-19 pandemic, Big Hit has prospered thanks to huge demand for its online content, including livestreamed BTS concerts that reportedly attracted more than 1.7 million fans.

The company's shares opened at 270,000 won (\$236), about double their initial public offering price. They surged 30%, hitting the daily trading limit, before falling back and closing at 258,000 won (\$225), bringing the company's valuation to 8.7 trillion won (\$7.5 billion).

Big Hit has a tight grip over its revenue streams, with BTS merchandise and other products exclusively sold through its "Weverse" e-commerce platform.

Big Hit raised 926.6 billion won (\$841 million) in what was South Korea's largest IPO since 2017.

"The company has managed to grow beyond the traditional revenue sources of album sales and concerts and diversify its business through online channels," wrote Ahn Jin-ah, an analyst from South Korea's E-Best Investment and Securities, in a report that described Big Hit's stock market entrance as a "drop of dy-

SEOUL, South Korea (AP): South Korea's namite." BTS accounted for more than 80% of the company's revenue during the first half of 2020, according to a separate report by Samsung Securities.

BTS launched in 2013 and has a legion of global supporters who call themfans through social media and often write their own lyrics. That personal touch is a huge part of their appeal, music experts say. BTS fans who apparently follow everything and anything about the band naturally took an interest in



selves the "Army." It became the first K-pop act to top Billboard's Hot 100 chart last month with their first all-English song "Dynamite."

The band — consisting of J-Hope, RM, Suga, Jungkook, V, Jin and Jimin - has performed in sold-out arenas around the world and was even invited to speak at the U.N. General Assembly last month.

BTS is a source of national pride, with some lawmakers even arguing that its members should be exempted from the 2-year military service that's mandatory for most able-bodied males, saying that the singers have already done much for the country.

Unlike many other K-pop artists whose carefully cultivated images are shaped by their management agencies, BTS members actively engage with their Big Hit's stock market debut.

Sara Ali, a BTS fan from Sudan, said she had been talking with fellow Army members about Big Hit's business prospects and was hoping to buy a few shares herself. "I believe this is an excellent opportunity," she said through a text message. The company's shares began trading just days after Chinese nationalists erupted in anger at BTS after its leader RM thanked Korean War veterans for their sacrifices while receiving a reward for promoting U.S.-South Korea relations.

Chinese internet users and state media took RM's comments as a slap at China, whose soldiers fought alongside North Korea against South Korea and U.S.-led allied forces during the 1950-53 war that was halted by an armistice but no peace treaty. BTS has yet to respond to the comments.

Post Malone owns Billboard Awards, Legend shines onstage

NEW YORK (AP): Walking into the show with 16 nominations, Post Malone won nine honors at the 2020 Billboard Music Awards, where John Legend gave a heartfelt performance that was dedicated to his wife.

With his voice aching as he sang passionately from the piano, Legend told viewers "this is for Chrissy" before singing "Never Break," which includes the lyrics "we will never break." The performance comes two weeks after Chrissy Teigen announced she had a miscarriage, explaining in a heart wrenching social media post that she and Legend drove "home from the hospital with no baby."

"John, that was so beautiful," host Kelly Clarkson said following his performance. "All my love to you and Chrissy."

It was one of several performances that were pre-taped for Wednesday's show. Other musicians attended and performed at the empty Dolby Theatre in Los Angeles during the three-hour event, which aired on NBC.

After announcing that Malone won the show's biggest honor, top artist, Clarkson wheeled out eight more trophies for the hitmaker.

"I'm honestly blown away by the love everyone's shown to me," said Malone, artist and top rap album. "It's kind of big

He beat out Eilish for the top prize,

but she was still a winner, taking home top Billboard 200 album, top female artist and top new artist. The 18-yearold, wearing a face mask, told viewers to "please vote, please wear a mask, please wash your hands.'

Others had similar messages. Khalid, who won five honors, told fans "your voice matters now more than ever." And Lizzo wore a black dress with "vote" printed across it.

She also gave an encouraging speech, telling viewers to find their voices and don't change to meet society standards.

"I just want to say I've been thinking a lot about suppression and the voices that refused to be suppressed. And I wonder, 'Would I be standing here right now if it weren't for the big Black women who refused to have their voices be suppressed?' And I just want to say right now, if you're at home watching this and you were thinking about changing yourself to feel worthy, this is your sign to remain true to who you are," Lizzo said onstage after winning top songs sales artist.

"Let me tell vou all something when people try to suppress something, it's normally because that thing holds power. They're afraid of your power. There's power in who you are. There's power in your voice. So whether it's through music, protest or your right to vote, use your power, use your voice and refuse to be suppressed."

Other winners included Lil Nas X,

who took home four honors and was onhand to accept top Hot 100 song for "Old Town Road," which set the record for most weeks at No. 1. Kanye West, who released two gospel albums last year, also won four prizes: top gospel artist, top gospel song, top gospel album and top Christian album.

Luke Combs followed with three wins, and after his performance he offered positive words to his fans and the crew working on the Billboard Awards.

"I know that everybody has been through so much this year. I wanna thank the crew that is working on this show tonight because they have gone through some insane stuff to make this happen for you guys. I hope everybody is staying safe there at home," he said.

Garth Brooks accepted the Icon Award from Cher, who called the country star "a true music legend and my friend." Brooks, who is the only artist to have nine of his albums sell more than 10 million units each and reach diamond status, performed a medley of his hits.

Other performers included BTS, Alicia Keys, Kane Brown, Khalid, Swae Lee, Sia, Brandy, Bad Bunny, Doja Cat, SAINt JHN, En Vogue and Demi Lovato, who sang her new song aimed at President Donald Trump called "Commander In Chief."

Clarkson kicked off the show singing Steve Winwood's "Higher Love," which became a dance hit last year after Whitney Houston's cover of the song was remixed by Norwegian DJ-producer Kygo.
