COVID-19 caseload in India rises to 98.57 lakh with 30,254 new cases

New Delhi, Dec 13 (PTI): India's COVID-19 caseload rose to 98.57 lakh, while the number of people who have recuperated from the disease surged to 93.57 lakh pushing the national recovery rate to 94.93 per cent, according to the Union Health Ministry data updated on Sunday. The total coronavirus

cases mounted to 98,57,029 with 30,254 infections being reported in a day. The death toll rose to 1,43,019 with 391 new fatalities, the data updated at 8 am showed.

The number of people who have recuperated from the disease surged to 93,57,464 pushing the national recovery rate to 94.93 per cent, while the COVID-19 case fatality rate stands at 1.45 per cent.

The COVID-19 active caseload remained below 4 lakh for the seventh consecutive day. There are 3,56,546 active coronavirus infections in the country which comprises 3.62 per cent



of the total caseload, the data stated.

COVID-19 India's tally had crossed the 20lakh mark on August 7, 30 lakh on August 23 and 40 lakh on September 5. It went past 50 lakh on September 16, 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, and surpassed 90 lakh on November 20.

15,37,11,833 samples have been tested up to December 12 with 10,14,434 samples being tested on Saturday. The 391 new fatalities include 80 from Maharashtra, 47 from Delhi, 44 from West Bengal, 32 from Kerala, 31 from Uttar Pradesh and 21 from Punjab.

A total of 1,43,019

deaths have reported so far in the country including 48,139 Maharashtra from followed by 11,939 from Karnataka, 11,883 from Tamil Nadu, 9,981 from Delhi, 9,010 from West Bengal, 8,056 from Uttar Pradesh, 7,052 from Andhra Pradesh and 5,057 from Punjab.

The health ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

The session brought together 40 MPs and MLAs from the Himalayas and featured deliberations on key policy issues and was moderated by the IMI president, former Sikkim MP, PD Rai, and was chaired by Lok Sabha MP from Shillong, Vincent Pala.

Keeping COVID-19 as a focus topic, the speakers discussed health and vaccination issues along with employment and green recovery, an

Funding, arrangements for testing for COVID-19 in the country, the mindset of tourists who visit the Himalayan region and logistics to transport vaccines over rough terrain and whether the Centre would keep this in mind while rolling out the vaccine, featured prominently during the discussion.

Legislators tabled questions on the role of organic diet in treating COVID-19 and exploring medicinal plants from the Himalayas to battle the pandemic.

Nawin Kiran announces dharna against irregular appointments

 $S_{\text{Committee}}^{\text{ikkim}}$ Subject viceconvener, Nawin Kiran Pradhan, announced plans to sit on a peaceful demonstration on 20 December in front of the East District Collectorate here at Sichey to protest what he sees as "illegal" appointment of around 1,600 people government jobs by the state government in the past year and a half.

He explained that the 100-day ultimatum he had given the State Government to address his demands has already expired and hence SSC has decided to take its protest to the next level starting with a dharna on 20 December.

With 22 new cases, Sikkim's Covid count rises to 5,338

GANGTOK. 13 DEC:

Cikkim registered 22 fresh cases of novel Coronavirus in the 24 hours ending 8 AM Sunday, taking the state's tally of confirmed COVID-19 cases

In the meantime, the number of discharged Covid patients in Sikkim has further improved to 4,770.

There are now 356 active cases in the State, of whom three are currently in ICU facility of the COVID-dedicated STNM Hospital here.

In the daily health bulletin on Sunday, Health Department State IEC Officer, Sonam Gyaltsen Bhutia. informed that of the 22 new cases, 20 were reported from East District and two from South Sikkim.

The new cases were picked up from the testing of 183 samples on Saturday - 18 testing positive from RT-PCR testing of 122 samples, two in TrueNat testing of 15 samples and another two in rapid antigen testing of 46 samples.

Of the 22 new cases, four were admitted to STNM

in West Sikkim and 17 sent to home isolation in East Sikkim.

While providing details of the new cases reported from in and around the capital, Mr Bhutia mentioned that three persons from Development Area, four from Upper Shyari, three from Sichey, one from near the Forest check-post in Chandmari and one from Lal Bazaar have tested positive for COVID-19.

There are four new cases reported from Tadong, of whom one person is from Metro Point, one from the Housing Colony at 5th Mile, one from Baha'i School Road and one from near Tadong government

Further, one person from Duga and one from Sakyong-Sang in East District and two from Namchi and one from near Mamring JHS in South District have also tested positive for COVID-19.

Mr Bhutia adds that one person from Siliguri has also tested positive and the concerned authority in Siliguri been informed about the test result.

"No Farmers, No Food": 9-year-old Climate Activist joins farmer protest

NEW DELHI, 13 DEC: Licypriya Kangujam, the nine-year-old climate activist, has come out in support of the farmers protesting centre's new agricultural laws for the last 18 days. Licypriya Kangujam told the farmers that climate activists across the world are with them. Ms Kangujam has been posting videos will reach all over the world. No farmers, No food. No justice, No rest," the activist wrote on Twitter along with a video in solidarity with farmers.

She also urged the farmers to stop stubble burning as it increases "Our air pollution. farmers are the biggest victims of climate change. Frequent floods, droughts and

other extreme weather events like cyclones, typhoons, locusts, etc are destroying their crops...,

Licypriya Kangujam said. "Thousands farmers are dving every year. Our leaders must listen to the voice of the farmers. We want climate justice for our farmers and also should take out a permanent solution to solve the ongoing farmers' crisis at the earliest," she added.

5th On the Anniversary of Paris Agreement on Saturday, Ms Kangujam protested with the farmers as a part of global climate against strike inaction by the world leaders following the 2015 signing Climate Agreement, legally which binds international treaty on climate change.

"Stubble burning is being practised for the last many years and hundreds of thousands of years ago. There was no air pollution before. It came only in the last 5-6 years. So, our leaders have to find out how to solve the air pollution crisis permanently. We can't blame only farmers," she told news agency ANI.

"The farmers who gave the dough for pizzas can also afford to have one themselves," says Shanbir Singh Sandhu, who organised the 'pizza langar' with his four friends for the peasants protesting at the Delhi-Haryana border against the contentious agrimarketing laws.

"We didn't have much time to organise a regular lentils-chapatti langar.... So we came up with this idea," says Sandhu, who is himself a farmer and an economics student at Guru Nanak Dev University in Amritsar.

The farmers have been protesting at several border points into Delhi for over two weeks over their demands to repeal new legislations, the which they claim would benefit the corporates, and end the traditional

wholesale markets and the minimum support price regime.

Sandhu's friend, Shahnaz Gill, underscored that people get bored eating the same thing everyday. "We thought we should bring them (farmers) something else to keep their spirits up," he said.

The 21-year-old student of agriculture says this is first time they have organised a 'pizza langar', expressing happiness that people have appreciated their efforts.



Empowerment for Equality is a No Brainer

So why should only women fight for women's issues?

 $\mathbf{D}^{ ext{espite}}$ a Supreme Court verdict, most of the women are still denied entry to Sabarimala temple. When the judgment arrived, it was welcomed by "women activists". Every woman of menstruating age who has made failed attempts to offer prayers at Sabarimala and verify whether the State and the society will allow a Court verdict to be obeyed is introduced as an "activist." The many voices getting heard on the issue are again of "women activists' and "well-meaning" men-folk. And therein lies one of the root causes of a variety of problems plaguing the country this acceptance that women's empowerment is the look-out of only these two segments.

It is unfortunate that gender equality battles are led almost exclusively by women, leading to this weird situation where even when women speak of equality, we, by and large, see them as being feminist. Even those who don't see feminism as the handiwork of over-ambitious women, and may even support it, slot efforts towards equality as "feminist" moves. To see how embarrassingly offensive such responses, even if subconscious, are, compare it against the male equivalent for feminism - chauvinism. The dictionary definition of a Male Chauvinist reads: "A man whose behavior and attitude toward women indicate a belief that they are innately inferior to men". By contrast, women, even when pursuing the basic right of equality (and not superiority), are seen as feminist. We have even co-opted grammar to perpetuate male superiority. The problem lies in this whole mentality in which even the language has been hamstrung in chauvinistic lexicon where the only female equivalent for a male "stud" is a "slut". It is this subliminal conditioning of our minds that has inured us to the many depressing realities of our country. It is in this zombie-like acceptance that things have always been like this that the many woes of our society, and not only the ones regarding women, are born. It all starts at home with how we grow up getting used to the almost continuous reinforcement of gender biases. Before we know it, we have been brainwashed. So, when guests arrive, the son will tell the jokes and the daughter will serve water.

Any practice which discriminates people on the basis of gender, caste, community, color or faith should immediately repulse people. Revulsion can be the only response to news that women are being refused access because of their gender. But such news does not revile us anymore. Even when most of us do not agree with such practices, we do not feel offended enough because we have been conditioned at home, in school and in the work places to see women as somehow not equal. Worryingly, very few people are embarrassed for holding on to such attitudes. Of course, one could argue that most women are comfortable with such hierarchies, but those comfort levels are akin to the Stockholm Syndrome where a kidnapped person starts being grateful towards the kidnapper. What choice do they have? Give women economic and decision-making powers and see if they slip back to being submissive, allsuffering daughters, wives and daughter-in-laws. We need to change our vocabulary. Equality issues cannot be painted as empowerment because that is an already existing right that is being reinforced. Empowerment needs to be about much, much more. Attitudinally, we need to at least reach a level where we do not fight for just a quota in jobs or elected posts for women, but reach a place where we see ambition in women as normal. And the process, because the brainwashing started at home, needs to begin at home. Parents need to consciously repair the damage. Then we will have to move to schools, because it is there that the stereotypes, instead of getting demolished, are reinforced. We do this much, and we will not have to worry about the workplaces because "empowerment" would have happened by then. We could then reach a situation where, when a journalist needs to get feedback on the HC verdict on Haji Ali, does not call up only women groups, and can just step out an ask random people, all of whom will welcome it with headline-making phrases. We could reach a situation where, even when regressive mindsets try to deny women, they are forced to capitulate because the men, instead of waiting for women groups to file a case, instinctively boycott such places themselves. With patronage, by way of donations and presence, taken away, the offensive mindsets which look down on women will quickly become genuine liberals. And all of this is not about "empowering" women, it is about making the society more compassionate and responsive, because that is what we will achieve with such a turnaround in attitudes.

Which Age Group Should Get the COVID-19 Vaccine First May Depend On Timing

OVID-19 vaccines are on the horizon. Lately, it seems like each week brings news of another clinical trial demonstrating vaccine efficacy. But if supplies are initially limited, decision-makers will need to make hard choices about who should get them first.

One approach is to prioritize groups who are most vulnerable serious outcomes hospitalization and death, such as the elderly. Another approach is to prioritize groups who are most responsible for spreading the infection. The question is which approach will work best in a given population.

Our team decided to study this question using our combined 30 years of experience in population modelling, including the 2003-04 SARS outbreaks and the 2009 H1N1 pandemic. We developed a mathematical model of COVID-19 transmission and vaccination in Ontario, published as a preprint (a manuscript yet to be checked for errors). The types of models we employ are not mere mathematical abstractions or theories, but rather have been validated for many similar respiratory infections over the past three decades.

We found that if vaccination starts sufficiently early in 2021, a strategy of vaccinating individuals 60 years of age and older will prevent the most deaths. But more surprisingly, we found that if the vaccine is not available until later in 2021, we might be able to prevent more deaths by first vaccinating younger age groups — working-age adults and children — who have more contacts with others.

VACCINES CAN PROTECT THE UNVACCINATED

To understand this result, we must first explain that vaccines work in two ways. First, they provide direct protection: the vaccinated person doesn't get infected. Second, they also provide indirect protection: the vaccinated person does not pass infection on to others. We do not yet know if the COVID-19 vaccines will prevent the passing of infection to others, but such transmission-blocking effects



are a common feature of most licensed vaccines.

If enough people are vaccinated, the level of indirect protection in a population can be high. And indirect protection can be very powerful. Had it not been for indirect protection, smallpox would never have been globally eradicated in 1977. Once a sufficient number of individuals are vaccinated, herd immunity is achieved. But it is achieved through a kinder, gentler means than letting everyone become infected, and the virus is thereby eliminated from the population. Hence, indirect protection can have very strong effects in real populations.

This is not just the prediction of a mathematical model. This effect has been observed in empirical data on influenza vaccination from Japan, where vaccination of schoolchildren was found to reduce deaths in the elderly. Similarly, some jurisdictions practice cocooning, where if a vaccine does not work in a vulnerable person due to their advanced age or an immature immune system, we vaccinate the people around them instead. This approach is also recommended for the COVID-19 vaccines.

CONDITIONS WILL CHANGE LATER IN THE PANDEMIC

We think the switch in strategy between early and late 2021 predicted by our model occurs because indirect protection from vaccines will become stronger, later on in the pandemic.

In the early stages of a under the various scenarios explored

pandemic, most people are still susceptible. Therefore, if a few individuals are immune because of the vaccine, they don't protect their contacts since there are too many other ways their contacts could get infected, as illustrated on the left side of the diagram.

However, as time goes on, more individuals will become infected and gain immunity. Under these conditions, adding more immune individuals to the population by vaccination can work more effectively to protect their contacts, as seen on the right side of the diagram. In other words, chains of transmission are replaced by chains of protection. At some point, more deaths can be prevented through indirect protection instead of direct protection.

TO HOW APPLY THIS APPROACH

Our model was designed to provide insight into how vaccines work, and not to comment on specific policy recommendations. There are also important caveats to our study. For instance, we did not study a strategy of prioritizing residents of long-term care facilities, most of whom are older than 60 years of age. We also assumed that COVID-19 immunity is long-lasting, although evidence on this is still accumulating. However, the effect we identify relies upon well-validated principles of infectious disease epidemiology, and we found the effect persisted

To apply these ideas in practice, public health authorities would first need to assess population immunity through a survey that tests population blood samples for COVID-19 antibodies a few months before vaccination starts. They could then plug these numbers into a mathematical model to determine whether they should prioritize the elderly, or instead prioritize groups that spread the infection the most.

We think this approach could be feasible. Standard mathematical modelling frameworks could be used, and their predictions are more reliable when predicting months ahead instead of an entire year. Also, antibody surveys are a more accurate way to determine a population's infection history than case notifications, which would make the model predictions less subject to uncertainties.

ETHICAL DIMENSIONS, AND LOOKING TO THE FUTURE

Some might argue that the clear ethical choice is to give the vaccine first to those who are most vulnerable to fatality from the disease. We argue that decisions should be based on best available evidence and consider both direct and indirect effects. If the evidence suggests we can prevent more deaths in the elderly by vaccinating other age groups first, then that is the ethical decision. In other words, the right thing to do requires careful and sometimes nuanced thinking, but always evidence.

Indirect protection may seem like an abstract concept in the grip of a fast-moving pandemic. However, looking ahead, and with hope, we think it will be practically impossible to globally eradicate COVID-19 without it, just as in the case of smallpox. Vaccination policies will have to take advantage of indirect protection sooner or later, in one context or another.

The truth about much 'casual' work: it's really about permanent insecurity

The federal government's industrial relations ■ "reform" bill offers a new definition of "casual" employment that creates more problems than it

It effectively defines a casual job as anything described that way by the employer at the time a job commences, so long as the employer initially makes "no firm advance commitment to continuing and indefinite work".

Anyone defined as such loses any entitlement to leave they might otherwise have got through two recent Federal Court decisions.

Fair enough, you might think. Casual jobs are meant to be flexible. There can't be an ongoing commitment.

But that's not what the data on "casual employment" tell us.

I've drilled into previously unpublished data from the Australian Bureau of Statistics to get a better sense of what "casual employment" means for those employed as such.

Overall, what I've found suggests the "casual" employment relationship is not about doing work for which employers need flexibility. It's not about workers doing things that need doing at varying times for short periods.

The flexibility is really in employers' ability to hire and fire, thereby increasing their power. For many casual employees there's no real flexibility, only permanent insecurity.

The federal government's new bill will not solve this. It will reinforce it.

CASUAL DEFINITIONS

Technically the ABS does not routinely estimate the numbers of casual employees. For a few years (to 2013) it published data on workers who received a casual loading, and it occasionally asks people to self-identify whether they are casuals. But mostly its data on "workers without leave entitlements" (collected quarterly) is used as a proxy measure of casual employment.

About 24% of Australian employees were in

this boat in 2019 – a high proportion compared with most other industrialised countries.

THEORY VERSUS REALITY

The ABS data I've analysed includes statistics collected before 2012. But since the proportion of employees without leave entitlements has been relatively stable since the mid-1990s, the results remain relevant. They show:

about 33% of "casuals" worked full-time hours

about 53% had the same working hours

from week to week, and were not on standby about 56% could not choose the days on which they worked

almost 60% had been with their employer

for more than a year about 80% expected to be with the same

employer in a year's time. Very few (6% of "casuals") work varying hours or are on standby, have been with their employer for a short time, and expect to be there for a short

There are many reasons to question whether an employee without leave entitlements could really be defined as a genuinely flexible casual worker. It's better to just call them "leavedeprived" employees.

A COMMON FEATURE: POWERLESSNESS

The common features of all leave-deprived employees are permanent insecurity and low power.

Leave-deprived employees are about twice as likely as "permanent" workers (with leave entitlements) to have variable hours. But almost all "permanent" workers with variable hours have a guaranteed number of minimum hours. Yet less than a third of leave-deprived employees have that guarantee.

Overall, 27% of leave-deprived employees have variable hours and no minimum guarantee of hours. That is the case for only 2% of "permanent" workers.

We can think of variable hours as reflecting employers' flexibility needs, and a guarantee of

minimum hours as reflecting employees' power. The big difference between leave-deprived employees and "permanents" is in the power

employees have. Sometimes you hear the term "permanent casuals". They should more accurately be called "permanently insecure".

CASUAL LOADING

Another sign of low power is how few leavedeprived workers receive the casual loading – the 25% extra pay meant to compensate them for their lack of leave entitlements.

When the ABS used to ask about casual loading, less than half of leave-deprived workers said they got it. That's hardly surprising, given how often breaches of awards have been uncovered.

A study published in 2019 found low-paid leave-deprived workers in Australia, on average, were paid less than equivalent "permanent" employees.

Low power is what should be expected when an employment contract only lasts as long as the current shift. A worker might not even get formally

terminated, just not be given any more hours.

WHY HAVE CASUAL EMPLOYMENT?

There may be good reasons to have casual employment when work is genuinely intermittent and uncertain.

But that's not the case for most leave-deprived jobs. They are, instead, long-term and stable - yet still insecure for the employee. The only flexibility in them lies with the employer's power to withhold

Allowing employers to overrule previous court decisions and define who is and is not a casual, as proposed in the current bill, will not overcome any of these problems.

Instead, it will just entrench the practice of employers using "casual employment" to increase

Real Madrid ease to derby win over Atlético after Casemiro opener

SID LOWE MADRID, DEC 13 [THEGUARDIAN]: Real Madrid's grand week came to a perfect end on Saturday. If these three games in seven days are to define their season as the narrative had declared, far from coming to a premature end it looks set to turn out nice again. Zinedine Zidane was on edge and on an ultimatum, his team threatened with elimination from the Champions League group stage for the first time ever and with being left so far adrift domestically as to be virtually done. But they did what they always seem to do in situations like these and rose again, beating Sevilla, beating Borussia Mönchengladbach and doing what no one had done since February by beating Atlético Madrid

On Friday afternoon Zidane had declared Atlético favourites to win the league; on Saturday night his team defeated their city rivals 2-0 with a first-half goal from Casemiro and then an own goal by Jan Oblak. Diego Simeone's team had not lost for 26 matches - going back to the last time they faced Real Madrid - and although they remain top, the title race was opened up at Valdebebas. It is one that includes Real now, too. Not just because of the score, but also because of the script this game followed. As for Zidane, here was more evidence that the only reason to doubt him is that it is precisely that doubt, that danger, which brings the best from his players.

On Saturday, they did it again; Atlético had swept almost everyone winning aside, eight of their 10 games, but against Real they managed only a single shot on target. And if Real's opening goal was an act of simplicity, Casemiro leaping alone to head in Toni Kroos's corner, there was a logic to their lead and to the victory that it set up. The derby was only 14 minutes in, but a pattern had emerged already and Real had taken a control they never really looked like relinquishing.

Oblak had already dived to deny Karim Benzema, pushing his shot against the near post, and Atlético were struggling to get possession. In previous seasons that might not have mattered; this year, when the ball is a more integral part of their identity, it did. Now they had a new scenario to confront: struggling to escape their own half, denied the breathing room to pick out a pass. 914 After minutes, Simeone's side trailed for the first time this season. Worse, they were almost two down soon after, when Lucas Vázquez's speared delivery evaded Benzema at the far post.

Tyson Fury all bluster and brickbat but Anthony Joshua refuses to bite

13 LONDON, DEC [THEGUARDIAN]: It was a nice trv. "Boxing's about less talk, more action," an uncharacteristically wired-up Anthony Joshua barked in the immediate afterglow of his finest performance since the night three years ago when he ended Wladimir Klitschko's career.

Unfortunately, it's not, AJ. Without the talk, nobody walks. Fighters fight, but only when the deal is done.

Yet, even as Kubrat Pulev's shredded remains wriggled in front of him on the canvas after Saturday night's doomed but energetic challenge at Wembley Arena, the old Bulgarian's conqueror was not in the mood for cliches or platitudes.

perfunctory tap of gloves. brief acknowledgment of their excellent, tense and entertaining struggle, but little more. No smiles or hugs. Nor did the winner give his paymasters the quotes they wanted. Sky Sports was fishing for soundbites about the fight that mattered way more than this one: against Tyson Fury, next door in front of a full house at Wembley Stadium in high summer, with Covid-19 a fading memory – and maybe a second one in Cardiff. This had been an hors d'oeuvre; what everyone wants is la grande bouffe.

The champion was not in the mood. After nearly half an hour of throwing and dodging health-threatening leather, putting opponent down



the third, jabbing and uppercutting him to shreds then levelling him for a full count in the ninth, Joshua hurled the easy questions back. "I don't really want to do an interview," he said.

The most cooperative celebrity in the business, a smiling, friendly guy who asks as many questions of journalists as they ask of him, who opens supermarkets in his sleep, was not going to perform. Not tonight. "I just want the fans to appreciate the hard work," he said. "Everyone go home and have a lovely Christmas, and we'll reunite in 2021."

It was left to Eddie Hearn to fill in the gaps. You could almost hear Joshua saying to himself, "You better, pal." Within an hour, Fury was on social media to tell the world he would knock Joshua out in three rounds. "Anthony Joshua just shit himself live on television," Fury said in a video uploaded to Instagram. "He got asked did he want the the fight and he went around the bushes." At least one of the principals was playing his part in this pantomime.

Whatever Joshua did or did not mean in that emotional moment standing in front of a ringside microphone, he is as desperate to put his IBF, WBA, WBO and IBO belts on the line as Fury is to pony up his WBC title. And that might be the source of Joshua's post-fight irritability.

Hearn has said Joshua is happy to split the proceeds 50-50, which is a serious carrot to seal a deal. Maybe Joshua is not so keen on that division of a pot that is likely to soar past £200million on the way to creating boxing history - with a bit of help from Sky, Fury and the media.

Perhaps he reckons this hugely impressive win - his 24th, his 22th by stoppage, his 10th champion, and a statement victory after the doubts that infected his brand when Andy Ruiz had the impertinence to temporarily stop his run in 2019 - entitles him to something like 60-40. "Less talk, more action," he repeated. Was that a nod towards the negotiating table?

F1 star Hamilton vows to fight to improve human rights

SAKHIR, DEC 13 (AP) World champion Lewis Hamilton vowed not to ignore pleas to improve human rights in Bahrain and other countries where Formula hosts races, after reading letters from alleged torture survivors and being sent a drawing from the young son of a Bahraini man on death

Hamilton received addressed personally from three letters alleged torture victims in Bahrain ahead of a race there two weeks ago, and has since read them.

"I think there's definitely work to be done in the background and I definitely won't let it go unnoticed," the seven-time F1 champion said on Saturday.

Included with the letters to Hamilton was a photo of 11-year-old Ahmed, who is proudly holding up his drawing of Hamilton's Mercedes F1 car.

The drawing, which was sent by email to The Associated Press, came with the boy's personal written plea: Lewis, Please save my father.

"When I was drawing the car I thought that it could save my father," the boy said. "We struggle every day without him, I really hope he comes back to us."

He is the son of Mohammed Ramadhan, who in his letter to Hamilton said he was arrested after supporting Bahrain's pro-democracy uprising and then allegedly framed in a murder case and beaten with iron bars in order to extract his confession. He is facing execution.

"I think the saddest thing for me was that there's a young man on death row and it's not clear ... and when his son writes me a letter it really hits home. All Grand Prix.

"When I get some time now, I will definitely try and speak to (people) and see how I can positively impact that (F1) weekend as a sport moving forwards.

Hamilton said he wanted to address the human rights issue with Bahrain's Crown Prince Salman bin Hamad Al Khalifa last week in Bahrain the second of two races to be held there but had to sit out that race after contracting the coronavirus.

"I'd hoped after the first race to have had time to sit and address it with the Crown Prince. but I was bed-ridden for most of the week and I wasn't able to see anybody," Hamilton said.

After fires, Australia gets ready for floods

(REUTERS): Iust days after bushfires threatened an Australian World Heritage site, thousands were bracing for floods on the subtropical east coast on Sunday, with beaches closed and the authorities urging people to sandbag their homes.

With as much as 475 millimetres (18.7 inches) of rain in the previous 24 hours, the Bureau of Meteorology issued a "severe weather warning" for the border area between New South Wales and Queensland heavily states. populated area that includes the Queensland state capital Brisbane.

A week earlier, nearby Fraser Island was evacuated due to bushfires, dashing hopes that wetter weather would make seasonal fires less catastrophic people travelling for

weather in the early Australian summer to a La Nina pattern - which typically features strong rain - combined with climate change.

Fraser Island, the world's largest sand island, is now under the flood warning, includes urging drivers to avoid roads where waters were already rising.

"These are dynamic weather systems and you should always expect the unexpected," bureau senior flood hydrologist Justin Robinson told a news conference.

The warning comes soon after Queensland opened its border to the neighbouring state after months of closure due to COVID-19. The authorities urged

Chinese capsule with 2kg of moon rocks begins journey to Earth

13 DEC [AL]AZEERA]: A Chinese space capsule is bringing back the first moon rocks in more than 40 years after orbiting the moon for about a week.

The Chang'e 5 lunar probe started its threeday return to Earth by firing up four engines for about 22 minutes to move out of the moon's orbit, the China National Space Administration said in a social media post on Sundav.

The craft's lander touched down on the moon earlier this month close to a formation called the Mons Rumker, an area believed to have been the site of ancient volcanic activity. It collected about 2 kilogrammes pounds) of samples.

is expected to land in northern China after separating from the rest of the spacecraft and floating down on parachutes. The material would be the first brought back since the Soviet Union's Luna 24 probe in 1976.

Survivors recount horrific details of Mai Kadra massacre

ZECHARIAS ZELALEM Дирочити, 13 DEC [ALJAZEERA]: communications gradually being restored to parts of Ethiopia's war-hit Tigray region, survivors and residents in the town of Mai Kadra have been able to share harrowing accounts of the slaughter of civilians more than a month ago, the worst confirmed atrocity in a weekslong conflict between government forces and the now-fugitive regional government.

On November 12, nearly two weeks after the start of the fighting in the northern region, an Amnesty International investigation cited witnesses as saying that forces linked to the embattled Tigray People's Liberation Front (TPLF) had gone on a rampage in the small town three days earlier.

Armed with weapons including machetes and knives, the attackers hacked and stabbed residents to death, the witnesses told Amnesty, which said it could confirm "the massacre of a very large number of civilians" after examining and verifying gruesome photographs and videos from the scene.

Days later, preliminary investigation а governmentrights appointed watchdog stated that there may be as many as 600 victims, saying the killings were committed by a local youth group with the support of other Tigrayan civilians, police

Home to up to 45,000 people of Tigrayan, Amhara and other ethnic origins, Mai Kadra had been under the control of the TPLF until its forces retreated from the town a day after the massacre as Ethiopian government troops made advances in western Tigray.

Despite the Ethiopian government's capture of the Tigrayan capital of Mekelle on November 28, fighting between the TPLF and Ethiopian army units is believed to be continuing in parts of rural Tigray. Swaths of the region remain inaccessible to journalists and aid workers, making it hard to verify claims from all sides and leaving observers fearing that additional war crimes may yet be uncovered.

The federal government imposed communications blackout when it began its military operation on November 4, but Mai Kadra has had its phone services restored for a little more than a week now. Al Jazeera has been able to communicate with a total of six witnesses survivors. and relatives of victims who were in Mai Kadra on November 9 and said

Solomon Chaklu said he had come to Mai Kadra from the town of Dansha to inspect a vehicle he had intended to buy.

"Police and TPLF vouth militias went all over town searching for non-Tigrayans to kill," Solomon told Al Jazeera on the phone. "At around 3pm, police and the youths with machetes came to the home we were hiding in," he said.

"They dragged me outside, where I saw maybe 20 or 30 bodies of people who lay dying or were dead. I thought it was the end for me."

Ethiopian government maintains that a TPLF-backed Tigrayan youth militia dubbed the "Samri" singled out men like Solomon and Ferede, who are of ethnic Amhara descent. There have been long-standing between tensions Tigrayans and Amhara and militia members the Amhara region neighbouring Tigray have taken part in fighting against the TPLF's forces alongside the Ethiopian army.

Solomon said he, his friend Ferede Leu and a third man were asked to produce ID cards that would identify their ethnic group. The third man was left alone after he pleaded for his life in Tigrinya, the language of the assailants, according to Solomon.

"They tried to kill me," he said. "I was surrounded by four men and one of them struck me in the head and back with his machete. I remember the others laughing as they watched him."

When he regained consciousness, Solomon was informed that his friend, Ferede, had been hacked to death. He himself was bleeding profusely and the next day was taken to hospital in the city of Gonder some 260km (162 miles) away. Discharged after two weeks, he is currently recovering from multiple machete blows and a broken leg in his home in Dansha.

In the Sudanese refugee camps, a number Tigrayan refugees have told journalists they escaped after Tigrayan civilians in Mai Kadra had been killed by Ethiopian federal forces and members of an Amhara militia. Some said they had seen hundreds of bodies and described scenes of ethnically motivated attacks, including killings with knives and beatings.

Amid the divergent accounts,

Gebremichael dismissed accusations of his forces' involvement in any mass killings as "baseless", while Ethiopian Prime Minister Abiy Ahmed has said the federal forces have not killed a single civilian during their operation against the TPLF.

When probed by Al Jazeera, TPLF official Fesseha Tessema said the group is aware of killings involving Tigrayan victims. "The heinous crime committed against Tigrayans in Mai Kadra is just one among similar crimes that should be investigated by an international body," he said.

Earlier this week, the UN High Commissioner for Human Rights Michelle Bachelet said there is "an urgent need" for independent monitoring of developments in Tigray, warning that exceedingly worrying" and volatile" situation "is spiralling out of control, with appalling impact on civilians".

Amnesty, meanwhile, concurs there may be victims of additional atrocities among people of both ethnicities during the fighting, but its lead Ethiopia researcher said the organisation has no doubt as to who was behind the killings of November 9.

"We have had followup interviews with victims, who say the killers were provided support by armed local [TPLF] militia," Fisseha Tekle, Amnesty's lead Ethiopia researcher, told Al Jazeera. "Youth groups were armed with axes, machetes and knives and told to go home to home in search of Amhara men."

While officials say the conflict is dwindling down and reject what they describe as outside "interference", the United Nations continues to press the government to grant it access to people in war-torn areas to provide much-needed humanitarian aid.

Israelis maintain anti-Netanyahu protests in wintry weather



JERUSALEM, DEC 13 (AP): A few thousand Israelis protested against Prime Minister Benjamin Netanyahu, demanding that he resign in the face of corruption charges and the pandemic.

Some 2,000 people demonstrated outside Netanyahu's official residence in Jerusalem. The size of the crowds has shrunk in recent weeks with the arrival of wintry weather.

Protesters held signs reading Go and Everyone is equal under the law.

They also carried an inflatable submarine, alluding to a USD 2 billion purchase of German submarines that critics allege Netanyahu

was implicated in.

The protesters say Netanyahu must resign because of the corruption charges against him, saying he has lost the public's trust and can't properly manage the country under charges of fraud, breach of trust and accepting bribes.

Netanyahu denies wrongdoing on all charges, which revolve around a series of scandals involving media moguls and billionaire associates. His trial is set to begin evidentiary

hearings early next year. The protests have been a nuisance for Netanyahu, who has seen his popularity plummet during the coronavirus outbreak, with Israel on the verge of what may be a third national lockdown with cases again trending upward.

With Israel appearing to be headed toward its fourth national election in two years, the longserving Netanyahu may be banking on recently arrived vaccines to give him a boost in the polls.



FKA twigs sues Shia LaBeouf over alleged abusive relationship

m ritish}$ singer FKA twigs has filed a lawsuit against Hollywood actor Shia LaBeouf, claiming that he was physically and emotionally abusive when she dated him from 2018 to 2019.

As per the documents, filed in Los Angeles Superior Court on Friday, the 32-year-old British singer, whose real name is Tahliah Debrett Barnett, alleged that LaBeouf, 34, left her in a constant state of fear and humiliation and knowingly gave her a sexually transmitted disease.

FKA twigs further alleged that LaBeouf physically assaulted her numerous times and once threatened to crash a car with her in it unless she told him she loved him, reported Entertainment Weekly.

She revealed that she started LaBeouf after she was cast in a supporting part in his 2019 movie "Honey Boy", which was based on the actor's childhood and his relationship with his abusive father.

LaBeouf persuaded her to move in with him, FKA twigs

claimed, but soon isolated her from family and friends. She alleged that she was subjected to constant verbal abuse from LaBeouf, who was also jealous of everyone she met, including actor Robert Pattinson, whom she dated from 2014 to 2017.

Describing one key incident in the lawsuit, FKA twigs said just after Valentines Day in 2019, LaBeouf was driving recklessly on their return to Los Angeles and threatened to crash the car unless she professed her love for him.

After he pulled into a petrol station, she claimed that the actor assaulted her as she tried to get away and forced her

that he resisted, but he later ended the relationship himself.

The singer said that she wants to raise awareness of "the tactics that abusers use to control you", and will donate a significant amount of any financial damages she receives to domestic abuse charities.

In an email to the New York Times, LaBeouf said that "many of these allegations are not true," but acknowledged that he owed his accusers "the opportunity to air their statements publicly and accept accountability for those things I have done".
