Today, six days into his fast-unto-death, the Akhil Bharatiya Gorkha League (Bharati Faction) general secretary, SP Sharma, ended his fast following the Darjeeling MP, Raju Bista's announcement that a tripartite meeting with the Central Government will be held by the first week of September to discuss a permanent political solution for the Darjeeling Hills.

Ending his fast, Mr Sharma highlighted that this was for the first time in the history of Darjeeling that an MP informed that the Central Government will be officially communicating the convening of a meeting to discuss the Darjeeling

"In the past, such meetings used to be called over phone calls, but this time, information will released through the Press Information Bureau, and because of this achievement we ended the Fast Unto Death," he

9 consecutive days with Covid deaths and second with more recoveries than new cases in Sikkim

SUMMIT REPORT GANGTOK, 06 AUG:

in Sikkim in the 24 hours ending 8AM Friday, taking Sikkim's COVID toll to 352. The State has now reported a Covid death ever day for the past nine days. The last time that no deaths were reported in the preceding 24 hours was 29 July. In the nine days since, Sikkim has seen 16 Covid deaths. The latest Covid death was reported from Central Referral Hospital, Tadong.

Meanwhile, on a more reassuring note, Sikkim recorded more recoveries than new cases for the second consecutive day today. While 215

people had made full recoveries against the 184 new cases **C**ovid claimed one more life reported yesterday, the Daily Report of Covid-19 in Sikkim released by the Integrated Disease Surveillance Programme of the Health Department this morning informs that another 245 people have since made full recoveries compared to the 126 new cases detected in the last 24 hours.

> Sikkim's count of recovered cases of Covid-19 has now reached 23,772.

> The 126 new cases reported today were picked up from the testing of 1,593 samples on Thursday giving Sikkim a daily test positivity rate of 7.9%, a figure considerably lower than the positivity rate

being reported of late.

Of the new cases, 48 were registered in East District, 39 in West District, 37 in South District and 02 in North District.

Sikkim's tally of confirmed cases of COVID-19 has now reached 27,652.

There are currently 3,250 active Covid cases in Sikkim, only 109 of whom have symptoms severe enough to require hospitalization while the rest are recovering either in home or facility isolation.

Among those in hospital, six were admitted in the last 24 hours while nine are admitted in the intensive care units at STNM Hospital and

IT Deptt advisor reaches Rayong with promise of establishing reliable internet connectivity within 90 days

Tenzin Lamtha, advi-**I** sor to the Information Technology Department, arrived at the hamlet of Rayong near Rabongla on Friday with the promise of reaching internet connectivity to the village within 90 days.

Mr Lamtha explained that he was at Rayong on the directions of Chief Minister PS Tamang who wants the connectivity issues there to be addressed at the earliest.

Students living in Rayong have been especially disadvantaged by the lack of internet coverage in the area and have had to walk long distances to be able to at-

tend online classes.

Today, Mr Lamtha, accompanied by senior officials from the Forest and IT Departments, conferred with the villagers to take stock of the situation.

Following the meeting, Forest officials agreed to allot a suitable site to install a mobile telecom tower to establish proper connectivity for the village.

"Chief Minister Prem Singh Tamang is giving top priority to the IT sector so that people can benefit from opportunities provided by online and digital services. We came here to Rayong because people and students here are facing various problems because

internet connectivity is weak in the area. After discussions, the Forest department has decided to allot a suitable site in the nearby forest area where a Jio tower will be installed to boost internet coverage," Mr Lamtha

informs. The entire process from allotment of site to construction of a telecom tower - will take 90 days at the most, he added.

Mr Lamtha was accompanied to the visit by the Forest Department secretary, ML Srivastav, and senior officials from the IT Department along with Zilla Adhakshya South, Tshering Dem Bhutia, SKM party functionaries and Jio representatives.

MLA convenes coordination meet to discuss Soreng's water storage and distribution problems

SORENG. 06 AUG [IPR]: A coordination meeting to discuss the overall water distribution and storage problems within rural and urban areas of Soreng Sub-Division was held at the conference hall of Sub- Division Administrative Centre, today.

The meeting was chaired by area MLA Aditya Golay and attended by ADC (Development), Gayas Pega, SDM- Soreng, Ranjan Rai, SDPO- Soreng, Mahendra Pradhan, BDO Sabina Limbu, RO/AD, BB Rai along with engineers and other concerned officials.

The meeting commenced with a welcome speech by Ranjan Rai wherein he extended his warm greetings to all the individual dignitaries and the participants. A scheduled power point presentation was made by the Engineering cell Officers for their respective departments.

Assistant Engineer, BSE, Rakesh Sharma firstly started



his presentation by giving a brief introduction on current water distribution, it's conservation, source of water during water shortage and emergencies and the prime water reservoir in and around Soreng Block. He said that the existing water schemes of the Government for both urban and rural areas will be implemented and that the sanctioned budget for the same will be utilized under the Jal Jeevan Mission (JJM)

The main objective of today's meeting was to discuss whether or not there will be any water scarcity problem in near future for areas under the Soreng- Chakung Constituency. The officials from PHE gave an in-depth presentation regarding the current water demand, usage and its distribution and also emphasized the fact that there is a steady growth on water con-

sumption along with the rise in population. They also assured that the current water supply is sufficient for the increasing number of households within the vicinity of the water source.

A short discussion between the participants took place wherein the concerned department cleared some queries from the audience such as water shortage and insufficiency during winter season. The Hon'ble MLA suggested that the department can regulate the water flow and distribution especially during seasons where the problem of water shortage is inevitable.

Then, Devendra Sharma, H.O.D, Civil Engineering Department, CCCT, Chisopani presented his thorough research on water capacity, it's discharge and distribution network mapping along with water requirement zonation map. He also made

Know all about e-RUPI, the new digital payment instrument

(Prime Minister Narendra Modi on 02 August launched digital payment solution e-RUPI, a cashless and contactless instrument for digital payment. Prime Minister said that the eRUPI voucher is going to play a huge role in making Direct Benefit Transfer (DBT) more effective in digital transactions in the country and will give a new dimension to digital governance. He said e-RUPI is a symbol of how India is progressing by connecting people's lives with technology.)

What is e-RUPI and how it works?

e-RUPI is basically a digital voucher which a beneficiary gets on his phone in the form of an SMS or QR code. It is a prepaid voucher, which he/she can go and redeem it at any centre that accepts its.

For example, if the Government wants to cover a particular treatment of an employee in a specified hospital, it can issue an e-RUPI voucher for the determined amount through a partner bank. The employee will receive an SMS or a OR Code on his feature phone / smart phone. He/she can go to the specified hospital, avail of the services and pay through the e-RUPI voucher received on his phone.

Thus e-RUPI is a onetime contactless, cashless voucherbased mode of payment that helps users redeem the voucher without a card, digital payments app, or internet banking access.

e-RUPI should not be con-



fused with Digital Currency which the Reserve Bank of India is contemplating. Instead e-RUPI is a person specific, even purpose specific digital voucher.

How is e-RUPI advantageous to the Consumer?

e-RUPI does not require the beneficiary to have a bank account, a major distinguishing feature as compared to other digital payment forms. It ensures an easy, contactless twostep redemption process that does not require sharing of personal details either.

Another advantage is that e-RUPI is operable on basic phones also, and hence it can

be used by persons who do not own smart-phones or in places that lack internet connection.

What are the benefits of e-RUPI for the sponsors?

e-RUPI is expected to play a major role in strengthening Direct-Benefit Transfer and making it more transparent. Since, there is no need for physical issuance of vouchers, it will also lead to some cost savings as

What benefits accrue to the Service Providers?

Being a prepaid voucher, e-RUPI would assure real time payments to the service pro-

Who has developed the e-RUPI?

The National Payments Corporation of India (NPCI), which oversees the digital payments ecosystem in India, has launched e-RUPI, a voucher-based payments system to promote cashless transactions.

It has been developed in collaboration with the Department of Financial Services, Ministry of Health & Family Welfare and National Health Authority.

Which Banks issue e-RUPI? NPCI has partnered with 11 banks for e-RUPI transactions. They are Axis Bank, Bank of Baroda, Canara Bank, HDFC Bank, ICICI Bank, Indian Bank, IndusInd Bank, Kotak Mahindra Bank, Punjab National Bank, State Bank of India and Union Bank of India.

The acquiring Apps are Bharat Pe, BHIM Baroda Merchant Pay, Pine Labs, PNB Merchant Pay and YoNo SBI Merchant Pay.

More banks and acquiring Apps are expected to join the e-RUPI initiative soon.

Where can e-RUPI be used

To begin with NPCI has tied up with more than 1,600 hospitals where e-RUPI can be re-

Experts say, in the days to come the user base of e-RUPI is expected to widen, with even private sector using it to deliver employee benefits and MSMEs adopting it for Business To Business (B2B) transactions. [PIB]

The battle cannot be won top-down, wider collaborations required

Drug busts form a staple of the diet of news consumers in Sikkim. A substantial drug haul on a chance routine inspection at the check-posts is a routine occurrence, and increasingly, bigger caches are being traced based on some investigative attention.

Prescription drugs continue to be the preferred substances of abuse even though more hardcore "drugs" are also obviously being peddled. The former is in much higher circulation and continues to remain the more pressing concern for Sikkim due to its easy availability and deep percolation among the youth. In fact, because the peddling of these prescription drugs was not covered under the then laws against "drugs", like the Narcotic Drugs and Psychotropic Substance Act, the Sikkim Government framed the Sikkim Anti-Drugs Act in the year 2006.

SADA was envisioned as a law to strengthen the hands of the law enforcement agencies in their effort to curtail the supply and peddling of these substances. Until SADA came about, a peddler could not even be kept locked up overnight since the pre-SADA laws, even on conviction, delivered only a minor fine as punishment... not even a slap on the wrists. All that the confiscation of big hauls at the check-posts succeeded in achieving was pushing up the street price of the prescription drugs of abuse because the peddlers would try to make up for profits lost to seized consignments. When SADA arrived, peddlers faced a jail-term and stiff punishments. In its original form, SADA tried to make a clear differentiation between peddlers and addicts and also took on a social responsibility by working in rehabilitation of addicts into sections of the law. In the ten years that SADA has been around, however, more people than anyone could have imagined to be peddlers have been convicted and it will not come as a surprise if some addicts have also become history-sheeters as peddlers.

The nature of addiction, however, is such that there is a very fine line dividing peddlers from addicts and it is not rare for the latter to sometimes crossover to the peddling business to finance their addictions. The original draft of SADA appeared to understand these nuances. Unfortunately, in the past slightly over a decade, it has become only a policing tool and has lost all its more humane aspects. It would however be wrong to blame the police for this Frankenstein. Like the State's drug problem, even SADA becoming so much lesser than what it had potential for, is because the society continues to fail its young. It is worrying that the only agency involved in the battle against drugs is the Police. Cops are responsible for law & order and invariably treat the people who come to them or whom they chase down, as victims or criminals. Substance abuse, unfortunately, is not as black & white as the police is trained to see cases. It is for the grey areas to be addressed with empathy and long-term impact that one needs the society at large to step up. Social organizations need to have a more involved presence in the efforts against addiction. One should read more about counseling and awareness sessions than drug-busts and arrests.

No, the cops should not stop what they are doing, but that cannot be the only thing Sikkim is doing to address the problem of substance abuse. Addiction cannot be solved by locking up all the peddlers and addicts. Sikkim should have understood that by now because ten years since a specialist law was brought in to address a Sikkim-specific drug problems, there has not been any dip in either addiction levels or peddling or the cost that addiction extracts from families, homes and the State.

And all this failure because the social engagement, the wider collaborations and the community feeling required to build more resolute defences against substances of abuse have not be created.

Sexism and Sport: Why Body-Baring Team Uniforms Are Bad For Girls and Women

Team outfits and fashion were not supposed to be a big talking point at the 2020 Olympics in Tokyo. But protests over skimpy uniforms by two women's teams in the months before the games have brought bikinis and high-cut leotards into the spotlight. Now these high-profile campaigns are leaving Olympians, fans and aspiring young athletes wondering: why are women expected to bare their bodies while men cover up?

In April, the German women's gymnastics team ditched the traditional, high-cut leg-baring leotards for ankle-length unitards, protesting the "sexualisation" of their bodies. This dissent was intended to highlight and prevent sexual abuse in the sport, following recent high-profile cases in the US and UK. They continued their protest at the Tokyo Olympics.

In a similar move, the Norwegian women's beach handball team were fined for defying the uniform rules at the European championships in July. In Tokyo, they too continued their protest by wearing fitted shorts. The team claimed bikini bottoms made them feel uncomfortable, made it difficult when managing their periods, and turned young athletes off their sport. For many, the last point is key to understanding the impact of sexist uniform policies.

Uniform rules in sport are designed for an idealised western femininity. These standards fail to understand that girls quit sport over body-baring uniforms, overlook different hair and skin types, ignore curvy and muscular body shapes and wilfully ignore the realities of periods. What these policies suggest is that women's bodies are expected to be perfectly thin, perfectly hairless, able-bodied and period-free.

British runner Jessica Ennis-Hill wrote a heartfelt essay about her fear of exposing herself and how "skimpy kit" can traumatise young athletes. From body shaming to sexualisation, her experience exposes the unseen struggles of girls and women in sport and echoes research on girls in sport.

OVERLOOKED AND UNDER-DRESSED

These campaigns reject sexist norms prevalent in sports and object to women's uniforms being designed for the "male gaze", leading to women being judged for their aesthetic appeal alongside their

athletic talent.

Undoubtedly, these women are taking a brave and laudable stance. Yet their voices carry an influence that women of colour and advocates for athletes in non-western countries are often denied. With much less fanfare and media attention, they have been lobbying for changes to kit for decades, often on behalf of Muslim athletes and/or people of colour.

In table tennis, a rule change for full-length sportswear and head coverings – as opposed to shorts and T-shirts which leave arms and legs bare – was successfully lobbied to increase participation by Muslim athletes. This victory went largely unnoticed in the west, despite the fact that table tennis is a mainstay of the Olympics. Campaigns led by Muslim athletes led to similar rule changes in basketball and judo, where women were finally allowed to wear head coverings and long-sleeved tops underneath, as their faith required.

In contrast, swimming has rejected proposals to adapt uniforms for Muslim and black athletes, including a ban on "burkinis" and prohibiting use of the "soul cap" swim hat designed for natural black hair.

Athletes with disabilities also face different standards, which was made clear recently when a British Paralympian was criticised by an official who called her outfit too "revealing". It was the standard runner's brief worn by most women.

WHO MAKES THE RULES?

Modern sport was designed for and by white men. Globally, men are still making most of the rules, including those which police girls' and women's bodies. Regulations about uniforms vary by international federation, which is why the Norwegian team faced fines but the Germans did not.

Although the International Olympic Committee (IOC) does not directly control uniform policies, it has advocated fairer rules in its 2018 Gender Equality Review to "ensure competition uniforms reflect the technical requirements of the sport and do not have any unjustifiable differences". This statement raises the question: what is the justifiable reason for requiring women to wear skimpy uniforms while men can cover up?

What does this mean for athletes and young girls with Olympic dreams? Beyond the general sexualisation of women athletes, there are six identifiable consequences that potentially harm girls and women in sport:

1. Girls drop out of sport – adolescent girls feel too uncomfortable because of unflattering/exposing uniforms.

2. Embarrassment – cameras can catch athletes accidentally exposing underwear, body hair and more. Mocking and body shaming on social media poses a real concern.

3. Period panic – fear of leaking menstrual blood or exposing period products in skimpy or white clothing is common.

4. Excluding athletes from non-western cultures – skin-exposing uniforms make it impossible for girls and women from Islamic and other religious communities to compete.

5. Promoting racial prejudice – uniform standards often make assumptions about body types and hair built around white physical stereotypes.

6. Battles over body hair – women and girls are pressured into waxing/shaving bikini lines, legs and any "unfeminine" body hair or risk ridicule and body shaming on social media.

WE NEED MORE WOMEN IN LEADERSHIP

These uniform policies put women under added pressure to conform to western feminine ideals when they should be concentrating on their athleticism. This constricting paradox leaves little room for agency among athletes to challenge traditional, negative conceptions about muscular femininity.

International federations need to adjust technical rules to allow for athletes to choose clothing that suits their performance, personal comfort and cultural preferences. These choices can motivate adolescent girls to remain in sport, support athletes of colour and encourage participation from more conservative cultures.

Recruiting more women from diverse backgrounds to leadership positions in sport is a key step. Broadcasters and marketers should take note – in the same way athletes feel uncomfortable, many women viewers do not enjoy watching sports with objectified bikini-clad players.

Generations of athletes and advocates have struggled to make these changes. More recently, the movement has gathered strength to band together across cultures and sports. The Olympics should be a place for inclusion, cultural exchange and equality. Let's start dressing the part.

Narcissists: There's More Than One Type – and Our Research Reveals What Makes Each Tick

Chances are you've met a narcissist. Someone who thinks they're better than everyone else, dominates the conversation and loves the limelight. But scientists are increasingly realising that not all narcissists are the same – some are, in fact, extremely insecure.

In our new paper, published in Personality and Social Psychology Bulletin, we describe the distinct types – and what motivates them.

In classical Greek mythology, the hunter Narcissus was the son of the river god Cephissus and the nymph Liriope. He was known for his exceptional beauty and physique. One day when Narcissus was walking in the forest, the beautiful nymph Echo saw him and fell in love with him. However, he rejected her affections, leaving her heartbroken.

As a punishment, Nemesis, the goddess of revenge, lured him to a pool of water where he encountered his own reflection for the first time. Narcissus fell in love with his reflection, and, eventually realising that his love could not be reciprocated, pined away to his death.

The myth of Narcissus warns us of the dangers of excessive self-love, selfabsorption and lack of empathy for others. It has had a profound influence on western culture, art and literature.

in psychology. The English physician Havelock Ellis first identified narcissism as a mental disorder in the late 19th century. Sigmund Freud considered narcissism to be a normal part of a child's development, but argued that it could become a disorder if it persisted after puberty into adult-

In modern psychology, narcissism is usually conceptualised as a personality trait, which lies on a spectrum. Some people are more narcissistic, others less so. Narcissism typically involves an inflated view of oneself, a sense of superiority and entitlement and a lack of concern for others. The above portrait of a narcissist is a familiar one. But it isn't the only one.

GRANDIOSE VERSUS VULNER-

ABLE

In our research, we investigated two types of previously identified narcissism: grandiose and vulnerable. Grandiose narcissists are arrogant, dominant and extroverted. They tend to have high self-esteem, be bold and assertive and feel happy and confident about their lives.

Vulnerable narcissists, on the other hand, are withdrawn, neurotic and insecure. They tend to have low self-esteem, be hypersensitive and feel anxious and depressed. However, these two types of narcissists also have something in common. Both are selfish, feel entitled to special treatment and privileges and relate to others in antagonistic ways.

You might be able to recognise the two types of narcissists by how they behave in social situations. Grandiose narcissists are socially competent. They are likely to be dominant and charming. Vulnerable narcissists, on the other hand, are less socially skilled. They are likely to be shy and anxious in social situations. What's more, while grandiose narcissists are forthright and assertive in pursuing in their goals, seeking to maximise success, vulnerable narcissists are timid and defensive, seeking to minimise failure.

In our research, we examined the social motives and perceptions of both grandiose and vulnerable narcissists. In particular, we investigated their desires to attain social status and social inclusion. We also looked at whether they felt they had been successful in attaining social status and social inclusion.

Social status refers to being respected and admired by others. It involves standing out and being seen as an important person in the social hierarchy. In contrast, social inclusion refers to being liked and accepted by others. It involves fitting in well with others as part of the social community.

Any given person may have or desire both status and inclusion, only one of the two, or neither. For example, in the TV show The Simpsons, the character of Mr Burns has high status but is not particularly liked and

accepted, whereas the character of Homer Simpson is well liked and ac-

cepted but does not have high status. We conducted two studies, recruiting 676 adults based in the United States. We assessed their levels of both grandiose and vulnerable narcissism. We also assessed the extent to which they desired status and inclusion as well as the extent to which they felt they had attained their goals.

We found that both grandiose and vulnerable narcissists strongly desired social status. Interestingly, whereas grandiose narcissists felt they were successful in attaining this status, vulnerable narcissists felt they did not get the status they deserved.

What's more, grandiose narcissists did not feel they had attained social inclusion but did not particularly desire it either. In contrast, vulnerable narcissists also did not feel they had attained social inclusion but strongly desired it. Grandiose narcissists therefore felt they had met their social goals, but vulnerable narcissists did not.

Both types of narcissists crave the respect and admiration of others. But while grandiose narcissists may be stars on the interpersonal stage, triumphantly capturing the spotlight, their vulnerable counterpart may be a bit player lurking on the sidelines, resentfully seeking, but failing to obtain, the applause they crave.

Calcutta HC orders deportation of Bangladeshi woman

KOLKATA, AUG 6 (PTI): The Calcutta High Court has ordered the deportation of a Bangladeshi woman by air to her country on her request as she is languishing in a correctional home well after the completion of her detention period for staying in India beyond the visa period.

Justice DebangshuBasak directed the superintendent of the correctional home at which the woman is lodged to take appropriate measures for the purpose of her deportation forthwith.

The court on Thursday directed that the superintendent of the correctional home will, if necessary, depute police personnel to accompany the Bangladeshi woman to the airport as she claimed that she wanted to travel to her country by air, till such time the petitioner is cleared by security for boarding.

The woman, who worked at a dance bar in Mumbai, came to India with a valid passport



and visa, but could not go back in time owing to Covid restrictions, her lawyer Soumyajit Das Mahapatra said.

She was apprehended by the Border Security Force (BSF) while trying to go back to Bangladesh illegally earlier this year and was handed over to Swarupnagar police station in North 24 Parganas district.

On pleading guilty, a district court sentenced the woman to imprisonment for 66 days and the detention period was completed on June 19.

However, owing to lengthy administrative issues in the procedure of sending her back to her native country, the woman has been languishing in the correctional home despite having completed her sentence causing her to move the high court for redressal, Mahapatra said.

The court noted that a special secretary to the West Bengal government had on July 13 requested the central government for immediate deportation of the petitioner by

ATHENS, AUG 6 (AP): Thousands of residents fled to safety from a wildfire that burned for a fourth day north of Athens early Friday, during an overnight battle to stop the flames reaching populated areas, electricity installations and historic sites.

In heat wave conditions, the blaze tore through forest areas 20 kilometers (12.5 miles) north of the capital, destroying more homes. Ground crews of several hundred firefighters dug fire breaks and hosed the flames.

Traffic was halted on the country's main highway connecting Athens the flames advancing before water-dropping planes could resume at first light. But sparks and burning pine cones carried the fire across the highway at several

Several firefighters and volunteers were hospitalized with burns. health officials said.

Bangladeshi Woman To Be Deported **After Completion Of Detention: High Court**

 $T^{\text{he woman, who}}_{\text{worked at a dance}}$ bar in Mumbai, came to India with a valid passport and visa, but could not go back in time owing to Covid restrictions, her lawyer said.

Kolkata: The Calcutta High Court has ordered the deportation of a Bangladeshi woman by air to her country on her request as she is languishing in a correctional home well after the completion of her detention period for staying in India beyond the visa period.

Justice DebangshuBasak directed the superintendent of the correctional home at which the woman is lodged to take appropriate measures for the purpose of her deportation forthwith.

The court on Thursday directed that the superintendent of the correctional home will, if necessary, depute police personnel to accompany the Bangladeshi woman to the airport as she claimed that she wanted to travel to her country by air, till such time the petitioner is cleared by security for boarding.

The woman, who worked at a dance bar in Mumbai, came to In-



dia with a valid passport and visa, but could not go back in time owing to Covid restrictions, her lawyer Soumyajit Das Mahapatra said.

She was apprehended by the Border Security Force (BSF) while trying to go back to Bangladesh illegally earlier this year and was handed over to Swarupnagar police station in North 24 Parganas district. On pleading guilty, a

district court sentenced the woman to imprisonment for 66 days and the detention period was completed on June 19. However, owing to

lengthy administrative issues in the procedure of sending her back to her native country, the woman has been languishing in the correctional home despite having

completed her sentence causing her to move the high court for redressal, Mahapatra said.

The court noted that a special secretary to the West Bengal government had on July 13 requested the central government for immediate deportation of the petitioner by air.

"Petitioner will purchase the air ticket for her flight and produce the same before the Superintendent of the Correctional Home at which she is presently lodged," Justice Basak directed in the order on Thursday.

2 coaches removed from Tokyo Olympics in Belarus case

TOKYO (AP): Two Belarus team coaches have been removed from the Olympics, four days after they were involved in trying to send sprinter KrystsinaTsimanouskaya back to their country.

The International Olympic Committee said Friday it has canceled and removed the credentials of ArturShimak and YuryMaisevich.

"The two coaches were requested to leave the Olympic Village immediately and have done so," the IOC said.

It was done as an interim measure during a formal investigation "in the interest of the wellbeing of the athletes," the Olympic body said.

Shimak and Maisevich continued to have contact with Belarusian athletes since Sunday after the IOC linked them to taking Tsimanouskaya in a car to the airport to put her on a plane to Be-

Tsimanouskaya had criticized team coaches on social media and is now in Poland with a humanitarian visa.

The IOC said Shimak and Maisevich "will be offered an opportunity to be heard" by its disciplinary commission investi-

gating the case. It was unclear if the men have stayed in Japan or will leave for Belarus, an authoritarian former Soviet republic that relentlessly pursues its

Belarus has been in turmoil for a year since AleksanderLukashenko claimed a sixth presidential term after a state election widely viewed as rigged in his favor.

Lukashenko also led the Belarusian Olympic committee since the 1990s until this year. His son. Viktor, was elected to replace nim.

The IOC banned both Lukashenkos in December from attending the Tokyo Olympics after investigating complaints from athletes they faced reprisals and intimidation in a security crackdown after the election.

Still, the IOC's slate of sanctions against Belarus was criticized by activists there and international groups representing athletes who urged a full suspension of the national Olympic committee.

That would have let Tsimanouskaya and the rest of the 103-member Belarus team compete as independents under the Olympic flag.

Asked Friday about how Olympic officials had handled Belarus, IOC President Thomas Bach said it was "not in a position to change the politi-

cal system in a country." "What our responsibility and our remit is is to protect the athletes as much and as far as we can," Bach said, describing the incident in Tokyo as a "deplorable case."

Alexander Lukashenko was unable to attend the 2012 London Olympics because of a European Union visa ban imposed during a previous crackdown that followed a disputed election.

Bronze lost but hearts won: Indian women's hockey team signs off 4th at Olympics after narrow loss

Токуо, Aug 6 (РТІ): The history-making Indian women's hockey team's dream of securing its maiden Olympic medal remained unfulfilled as it lost 3-4 to Great Britain in a hardfought bronze play-off but the stout-hearted side managed to record its best ever finish at the Games here on Friday.

The team had already created history and surpassed all expectations by entering the semifinals of the Games for the first time.

But the maiden Olympic medal remained out of bounds as world no.4 Great Britain, who were gold-winners in the 2016 Rio Games, came out on top in the pulsating encounter.

India's best performance in the Olympics before this was a fourth-place finish in the 1980 Moscow Games but there were no semifinals in that edition as only six teams competed in a round-robin format and the top two featured in the final.

The heartbreak came a day after the Indian men's team ended a 41-year-old medal drought by clinching bronze with a 5-4 win over Germany.

The Indians played their hearts out and overcame a two-goal deficit to lead 3-2 at half time. But a desperate Great Britain gave their everything in the second half and scored two goals to snatch the match from India's hands.

India scored three goals in a span of five minutes through GurjitKaur (25th, 26th minutes) and VandanaKatariya (29th) to stun Great Britain.

But the Britishers found the net four times through



Elena Rayer (16th), Sarah Robertson (24th), skipper HolliePearne-Webb (35th)and Grace Baldson (48th) to emerge winners.

As expected, Great Britain started strongly and had the lion's share of ball possession and chances in the first quar-

The Indians made some circle penetrations but failed to create any clear cut chances and were also guilty of los-

ing possession at the midfield. India goalkeeper Savita-

Punia stood out in the first

quarter, denying Great Britain on at least three occasions.

She first made a fine save from Great Britain's first penalty corner in the second minute and then pulled off a double save in the 12th minute to keep India in the hunt.

In between Great Britain also wasted another penalty corner.

Britain began the second quarter on the same pace and took the lead when Elena Rayer's push went into the net after getting a deflection of Deep Grace Ekka's stick.

Minutes later, the former gold-medallists secured their third penalty corner which vielded no result.

Lalremsiami came close to equalising for India only to be denied by the experienced MaddieHinch, who brilliantly kept away the Indian striker's reverse hit.

India got their first penalty corner soon but wasted it.

Great Britain doubled their lead in the 24th minute when Robertson scored with a powerful reverse hit from top of the circle.

A minute later, India got two back-to-back penalty corners and Gurjit converted the second chance to reduce the

Two minutes later, SalimaTete's brilliant run from last one with a flick that went the left flank earned India another penalty corner and Gurjit was once bang on target to draw parity.

The momentum shifted completely in India's favour as they started to attack with numbers and threatened the Great Britain goal frequently thereafter in the second quar-

Good day on beach and courts

After Sharmila Devi hit wide from a one-on-one situation, the Indians stunned Great Britain when Vandana tapped in an open ball inside the circle to go into half time with a 3-2 lead.

Down by a goal, Great Britain were expected to come out hard after resumption and they did exactly that forcing the pace of the game, securing a penalty corner two minutes into the third quarter but India defended well.

But a minute later, Great Britain drew level through skipper HolliePearne-Webb.

The Indians then secured two more penalty corners but couldn't utilise them.

Savita stood like a wall in front of the Indian goal and pulled off some brilliant saves to deny Great Britain.

A second from the end of third quarter, India secured the seventh penalty corner but to no effect.

The fourth quarter completely belonged to Great Britain as they pressed hard on the Indian defence in search of goals.

The ploy worked as the Indian backline wilted under pressure and conceded four quick penalty corners, three of them in succession and Baldson scored from the through Savita's legs.

India had one more chance in the form of a penalty corner in the last eight minutes but Great Britain defended stoutly to deny Gurjit a hat-trick.

Thereafter, Great Britain did just enough to keep India at bay and to ensure a finish on the podium.

Americans win beach gold medal, and Ross completes the set



Токуо, Aug 6 (AP): April Ross now has the complete set of Olympic beach volleyball medals: silver in London, bronze in Rio de Janeiro and a gold she won with AlixKlineman at the Tokyo Games on Friday with a victory over Australia.

The Americans beat MariafeArtacho del Solar and Taliqua Clancy of Australia 21-15, 21-16 under a blazing sun in a match that was mercifully quick for the biggest crowd yet at Shiokaze Park about 60 people in the temporary stadium that seats 9,600.

Playing in 92-degree Fahrenheit (33 Celsius) temperatures under the hot Tokyo sun, the Americans finished off the Aussies in 43 minutes. In the bronze medal match earlier Friday, Joana Heidrich and Anouk Verge-Depre of Switzerland cruised to a straight-set victory over

The silver for Australia was its first beach volleyball medal since Natalie Cook and Kerri Pottharst took gold on Bondi Beach in 2000. But they were never really close against the Americans, who tied for the top spot in the Olympic qualification points race and lost just one set in seven matches in Tokyo.

With side changes every seven points and technical timeouts every 14, the players retreated to benches, where an awning was rolled up over their heads for shade. A towel covered the seat so they wouldn't stick to the hot cushion; support staff put icepacks on their heads, or wrapped them in wet towels.

And then there was hydration. So much hydration.

Klineman, a first-time Olympian, and Ross, who has three medals in as many trips to the Summer Games, needed just 20 minutes to claim the first set. They fell behind 2-0 in the second before scoring 10 straight points to pull away.

That silenced the chants of Aussie! Aussie! Aussie! Oi! Oi! Oi! from the Australians in their bright yellow shirts and

brought out the cheers of U-S-A! from those in the red, white and blue. Australia survived three championship before Artachodel Solar served into the net to seal the U.S. victory.

After a long hug. Klineman went to the bench to douse herself in water, then the pair went over to the stands and posed with an American The Swiss cruised to a

straight-set victory over Latvia to claim the first Olympic medal ever for their country's women on the beach. They edged Tina Graudina and AnastasijaKravcenoka 21-19 in the first set before opening a 5-1 lead in the second and pulling away to win 21-15.

Graudina was the first person to make the Olympics after coming up through an NCAA beach volleyball program that started in 2012. She played at Southern California, where she was the 2019 national player of the year and led the Trojans to the 2021 national championship.

for US women in Tokyo TOKYO (AP): American

women had a good day at the beach and on the courts in Tokyo on Friday, with one Olympic gold medal won and a couple more set up for the taking.

The United States beach volleyball team of April Ross and AlixKlineman won gold in beach volleyball and the American women's basketball and volleyball teams won to advance to the gold medal finals in both sports.

For Ross, the gold medals she and Klineman draped around each other's necks completes a full set. She won silver in London in 2012 and bronze in Rio de Janeiro in 2016. Klineman won gold in her first Olympics. "That was a product of COVID, but it actually feels really special when you're up there. I was like, 'We get to award the medals to each other' and in my head I was like, 'Thank you Alix," Ross said of the medal ceremony

"It's kind of a fairytale story like, 'Oh, you know I'm going at 39 to try and get my gold medal,' and the fact that it actually happened feels so special and surreal," Ross said.

The U.S. pair was dominant throughout the Olympic tournament. They lost just one set in seven matches and swept Australia 21-15, 21-16 in 43 minutes in the final.

The U.S. women's volleyball team avenged a gold-medal match loss to Serbia in 2016 with a 25-19, 25-15, 25-23 victory that sends them back



previous gold medal finals, but have never won.

"It wasn't like, 'Oh we have to get redemption of this or that," U.S. star FolukeAkinradewo Gunderson said. "It was we just want to win a gold medal and whatever that's going to take, we're going to do that."

The U.S. has been one of the top teams in the world for much of the past two decades, but has been unable to attain the ultimate prize, losing to Brazil in the gold medal match in both 2008 and '12. The U.S. also lost the gold medal game to China in 1984.

BOXING Heavyweight Julio

César La Cruz won Cuba's third gold medal in boxing in a final 5:0 victory over Russian athlete Muslim Gadzhimagomedov. La Cruz won the eighth heavyweight gold medal for the vaunted Cuban team, but the first since Odlanier Solis claimed the glamour division's title in 2004.

DawidTomala of Poland won what might be the last 50-kilometer race walk at the Olympics. Tomala won in 3 hours, 50 minutes and 8 seconds in Sapporo for the gold medal. He won only the second 50-kilometer race he had ever completed.

50-kilometer The walk has been dropped from the schedule for the next Olympics in Paris in 2024 and may not return. It was first introduced at the 1932 Los Angeles Olympics and has been held at every Games since with the exception of Montreal in 1976.

Data raises concerns as Brazil's forest fire season begins

RIO DE JANEIRO, AUG 6 (AP): Severe drought and early data are raising concerns that this forest fire season in Brazil will see the same high levels of destruction recorded in the past two years, despite efforts to tamp down the blazes.

With Brazil's forest fire season underway, the government space agency that uses satellites to monitor fires reported more area burned in the month of July than in any July since 2016, according to data released Thursday. The same was true for June.

Most Brazilian blazes are manmade, often started illegally by land-grabbers clearing forest for cattle or crops. Fires tend to begin increasing in June and peak in September, according to historical data. They can easily get out of control during the dry season, burning large swaths of forest to the ground.

Brazil is home to the world's largest rainforest and tropical wetlands the Amazon and Pantanal which saw dramatic fires in 2019 and 2020, respectively, that caused the greatest annual forest loss since 2015. That drew global criticism of the response from the administration of President JairBolsonaro, who has repeatedly called for development of the region.

This year, it's the Cerrado savanna stretching across Brazil's center-west region that is suffering more than usual. An area almost as big as Connecticut and New Jersey burned there in the first seven months of 2021.

AneAlencar, science director at the Amazon Environmental Research Institute, said in a July 27 online panel that there have been fewer Amazon fires this year due to cool weather, which limits fire's potential to spread. But deforestation remains on par with the last two years, so much



dry material remains on the ground waiting to be burned, she added.

I am afraid about the coming months, said Alencar, who is also coordinator of Map-BiomasFogo, which compiles data on deforestation and fires across the region.

When this cold front goes away, the vegetation will be drier and then we will have warmer temperatures. ... I'm not sure that the people who cut down the forest will not light it.

Citing heightened hazard due to Brazil's worst drought in nine decades, the Justice and Environment ministries on July 22 announced a task force to prevent and investigate fires in 11 states of the Amazon, Pantanal and Cerrado biomes. Some 6,000 people, including federal and state police and firefighters, as well as state public security and environmental officials will participate in the effort, according to a statement.

On June 29, Bolsonaro decreed redeployment of sol-

diers to the Amazon to combat fires and deforestation, and also issued a 120-day ban on unauthorized outdoor fires.

Similar measures in previous years didn't prevent illegal fires, however. More than 90% of the Pantanal hot spots detected in 2020 came after a similar presidential ban, according to VinciusSilgueiro, coordinator of territorial intelligence at the Center of Life Institute in MatoGrosso state.

The sense of impunity is very high. Enforcement is well below what is necessary, Silgueiro said.

In MatoGrosso state, half of whose territory is in the Amazon, the federal and state governments last year began coordinating actions to put an end to overlap that frequently left other areas unmanned and vulnerable, according to MaurenLazzaretti, the state's environment secretary.

The state is also purchasing a helicopter and plans to deploy dozens of planes loaned by Pantanal farmers and businesses to drop fire retardant onto blazes.

Last year, over 4 million hectares (about 15,000 square miles) of the Pantanal went up in flames, or about 27% its area by far the most since official record-keeping began in 2003. While the biome regenerates quickly, unlike rainforest, fires often kill local wildlife, such as jaguars, caimans and giant otters.

The size of the fires last year drew society's attention to the component of individual responsibility, Lazzaretti said. The engagement of cities, farmers and even traditional and Indigenous communities is much greater this year.

The year before, fires in the Amazon roused global concern, and several European governments openly criticized Bolsonaro's administration. Bolsonaro countered that fires nationwide and in the Amazon, while up from 2018, were roughly in line with the average of the preceding several years and were down sharply

from 15 years earlier. He called on European leaders to mind their own backyards.

Earlier studies showed the Amazon absorbs about 2 billion of the 40 billion tons of carbon dioxide the world emits into the atmosphere each year, making it an important part of the global effort to curb climate change. But a study led by the Brazil's Ministry of Science, Technology and Innovation, published in Nature on July 14 spanning 10 years and involving nearly 600 flyovers found the dry season's intensification and increased deforestation had caused more fires and higher carbon emissions. The southeastern part of the Amazon, particularly ravaged by logging, has become a net source of carbon.

Paulo Artaxo, professor of environmental physics at the University of Sao Paulo and a member of the Intergovernmental Panel on Climate Change, said other recent studies have shown even the more preserved western Amazon region is now carbon neutral in terms of emissions, while a few years ago, it was a carbon sink.

Carlos Nobre, a prominent climatologist, says Brazil's Amazon is nearing a tipping point," after which the thick jungle will cease to generate enough moisture to sustain its current form and will begin transforming into tropical savanna.

Nobre said Bolsonaro's government has yet to demonstrate any encouraging change in approach to help save the rainforest.

The federal government continues incentivizing organized crime in the Amazon that is responsible for the theft of timber, illegal deforestation and fires, he said. Those who practice these crimes haven't given any sign of worry that enforcement will become rigorous. They continue to feel rather empowered.

Thousands jam Philippine vaccination sites over false news

MANILA, AUG 6 (AP): Thousands of people jammed coronavirus vaccination centers in the Philippine capital, defying social distancing restrictions, after false news spread that unvaccinated residents would be deprived of cash aid or barred from leaving home during a two-week lockdown that started Friday.

Officials placed Metropolitan Manila backed under lockdown until Aug. 20, as a new spike in COV-ID-19 infections that health officials say could be due to the highly contagious delta variant threatens to overwhelm hospitals. Three other regions, including nearby Laguna province, were also placed under lockdown until Aug. 15.

Only authorized workers for essential businesses and residents on medical emergencies or food-buying errands can venture out. An eight-hour curfew was imposed in the capital region starting at 8 p.m. and police checkpoints were set up in city boundaries.

A day before the lockdown, false news spread on social media that unvaccinated residents would either be prohibited from leaving their homes to go to work or deprived of 1,000 pesos (20) aid. It sent large crowds heading for vaccination centers in the cities of Manila, Las Pinas and Antipolo even without prior registrations.

Thousands lined up for several blocks in designated government centers and shopping malls to get the jabs, at times sparking arguments and complaints and snarling traffic.

In Manila alone, up to 22,000 people showed up outside vaccination centers before dawn. People descended in groups and arrived in vans from nearby provinces, some rowdily removing barricades, city officials said, citing police reports. Many were not registered under Manila's immunization program.

Police were forced to stop vaccinations in at least one of the shopping malls and asked the crowds to return home.

Critics partly blamed President Rodrigo Duterte for the confusion. The brash-speaking leader warned Filipinos last week that those who refuse to get vaccinated will not be allowed to leave their homes as a safeguard against the spread of the delta variant. He acknowledged that there was no specific law for such a restriction.

For people who refuse to receive COVID-19 vaccine, Duterte said, well, for all I care, you can die anytime. We cannot allow our national immunization program to become superspreader events, especially given the threat posed by the delta variant, the Department of Health said in a statement following the chaotic scenes. Officials later stressed that even unvaccinated residents could venture out in case of medical emergency. They can also obtain village permission to buy food, medicine or other essential items. They cautioned the public not to fall for fake news on social media and urged them to follow official government announcements.

HEZBOLLAH SAYS IT FIRED ROCKETS AFTER ISRAELI AIRSTRIKES

BEIRUT (AP): The militant Hezbollah group said it fired a barrage of rockets near Israeli positions close to the Lebanese border on Friday, calling it retaliation for Israeli airstrikes on southern Lebanon a day earlier.

Israel said it was firing back after 19 rockets were launched from Lebanon, and Prime Minister Naftali Bennett swiftly convened a meeting with the country's top defense officials.

"We do not wish to escalate to a full war, yet of course we are very prepared for that," said Lt. Col. AmnonShefler, spokesman for the Israel Defense Forces. It was the second straight day of rocket fire from Lebanon. But where Hezbollah took responsibility for Friday's shelling, it was unclear who was responsible for the attacks early Thursday, Shefler said.

Friday's exchanges were a significant escalation between Israel's new government and Iran-backed Hezbollah, and comes amid rising tensions between Israel and Iran that has played out in the Persian Gulf.

Israel's defense minister warned Thursday that his country is prepared to strike Iran, issuing the threat against the Islamic Republic after a fatal drone strike on a oil tanker at sea that his country blamed on Tehran.

The U.N. peacekeeping force deployed along the Lebanese-Israeli border said it has detected rocket launches from Lebanon on Friday, and return artillery fire by Israel.

"This is a very serious situation and we urge all parties to cease fire," the force known as UNIFIL said. Force commander Gen. Stefano Del Col, said the force was coordinating with the Lebanese army to strengthen security measures in the area and called on the parties to cease fire immediately.

Sirens blared across the Golan Heights and Upper Galilee near the Lebanon border Friday morning. Hezbollah said in a statement that it hit "open fields" near Israeli positions in the disputed Shebaa farms area, with "dozens" of rockets. No casualties were reported. The group said it fired 10 rockets, calling



it retaliation for Israeli airstrikes the day before. Those strikes were in retaliation to rocket fire from south Lebanon, which was not claimed by any group.

Shebaa Farms is an enclave where the borders of Israel, Lebanon and Syria meet. Israel says it is part of the Golan Heights, which it captured from Syria in 1967. Lebanon and Syria say Shebaa Farms belong to Lebanon, while the United Nations says the area is part of Syria and that Damascus and Israel should negotiate its fate.

The escalation comes at a sensitive time in Lebanon, which is mired in multiple crises including a devastating economic and financial meltdown and political deadlock that has left the country without a functional government for a full year. Hezbollah's response, rocketing open fields in a disputed area rather than Israel proper, appeared calibrated to limit any response.

Shefler told reporters Friday that 19 rockets had been fired into Israel, of which three fell within Lebanese territory. Ten of the remaining 16 rockets were intercepted by the defense system known as the Iron Dome.

It is also a politically sensitive time in Israel. Israel's new eight-party governing coalition is trying to keep peace under a fragile cease-fire that ended an 11-day war with Hamas' militant rulers in Gaza in May.

Israel has long considered Hezbollah its most serious and immediate military threat. It estimates the group possesses over 130,000 rockets and missiles capable of striking anywhere in Israel. In recent years, it also has expressed concerns that the group is trying to import or develop an arsenal of precision-guided missiles.

The attack sparked tensions between locals and Hezbollah. Videos circulated on social media after the rocket attack showing two vehicles, including a mobile rocket launcher, being stopped by villagers in the southeastern village of Shwaya in Hasbaya region near the border with the Golan Heights. Some


angry villagers, who belong to the Druze sect, could be heard saying: "Hezbollah is firing rockets from between homes so that Israel hits us back."

Hezbollah later issued a statement saying that the rockets were fired from remote areas, adding that the fighters were stopped in Shwaya on their way back. "The Islamic Resistance was and will always be most keen about the safety of its people and avoiding any harm to them through its acts of resistance," the statement said.

Hezbollah, which in recent years has been fighting alongside Syrian President Bashar Assad in the neighboring country's civil war, named Friday's operation after two of its fighters who were killed by Israeli fire.

Ali Mohsen was killed in July last year in an Israeli airstrike near the Syrian capital Damascus. Mohammed Tahhan was shot dead by Israeli troops along the Lebanon-Israel border in May during a protest in support of Gaza during this year's Israel-Hamas war.

CNN fires three employees for coming to work unvaccinated



NEW YORK (AP): CNN has fired three employees who violated company policy by coming to work unvaccinated against the CO-VID-19 virus.

CNN chief Jeff Zucker told staff members of the firing in a memo sent Thursday that reminded them that vaccines were mandatory if they report to the office or out in the field where they come into contact with other employees.

"Let me be clear — we have a zero tolerance policy on this," wrote Zucker, chairman of news and sports for WarnerMedia.

The memo was obtained by The Associated Press after its contents were first tweeted by CNN media reporter Oliver Darcy. CNN offered no details on the firings, or where the employees were based.

Most of CNN's offices are already open on a voluntary basis, and Zucker said more than a third of news staff members have returned. • Proof of vaccination has been left to the honor • system, he said, but that may change in coming weeks.

Illinois sees record pot sales, with boost from Lollapalooza



CHICAGO (AP): Illinois dispensaries sold a record \$127.8 million in recreational marijuana in July, with a big boost coming from out-of-state fans who converged on Chicago for the Lollapalazoo music festival.

The month's sales were 10% higher than May's record of \$116.4 million, which were slightly higher than June's \$115.6 million, according to a monthly report by the Illinois Department of Financial and Professional Regulation.

Business boomed at Chicago-area cannabis dispensaries during the four-day Lolwhich returned after last year's event was canceled due to the coronavirus pandemic.

Because recreational marijuana was legalized in Illinois in January 2020, pot was legal in the state during Lollapalooza for the first time in the festival's 30-year history. Although it's illegal to smoke or otherwise consume the drug in public or around crowds at Grant Park boosted sales by as much as 50% at nearby dispensaries in River North and the West Loop, operators told the Chicago Tribune.
