Returnees to be screened with antigen testing at Rangpo starting today WITH ONE NEW CASE AND ONE RECOVERY, COVID COUNT HOLDS STEADY AT 49 IN SIKKIM

SAGAR CHHETRI GANGTOK, 09 JUL:

Health Department DG-cum-Secretary, Dr Pempa T Bhutia, informed today that returnees will receive Antigen testing, the quickest reliable test available to screen for Novel Coronavirus, upon arrival at Rangpo starting Saturday.

Antigen testing exists for the flu, in which doctors can administer "rapid influenza diagnostic tests" that deliver results in 15 to 30 minutes.

Since a reasonably reliable screening will be done upon entry itself, and results ready in less than half an hour, those who test positive will be shifted directly to STNM Hospital where they can then be put through more detailed testing like RT-PCR, it is expected.

Those who test negative will proceed to quarantine facilities.

Given the recent spike in COVID cases among the army and paramilitary



personnel, Dr Bhutia informs that even returning soldiers will be screened through Antigen testing and those who test positive will be sent back to Siliguri where the forces have their own quarantine arrangements.

It may be recalled that the forces claim to have quarantine facilities in Siliguri and that soldiers returning to proceeding to the state.

Dr Bhutia believes that Antigen testing will also be advantageous for dialysis patients returning to Sikkim. Those who test negative can be then be taken directly to the dialysis unit in West Sikkim while those who test positive can receive medical attention quicker.

Meanwhile, when it comes to the COVID count in Sikkim, it held steady at 49 active cases with one more patient making a full recovery to cancel out the one new detection reported in the

A 25-year-old returnee from Bihar tested positive for COVID-19 taking the State's overall tally of COVID-19 cases to 134 on Thursday. Of these, 49 are active cases, 72 people have recovered and 13 have migrated out.

The one positive case was detected from 178 samples tested by RT-PCR at the VRD Lab at STNM Hospital. He added that all 14 samples tested by TrueNat yesterday also tested negative for COVID-19.

Out of the 134 COVID-19 cases reported so far in Sikkim, 73 are from

from South and one from North Sikkim. All 49 patients are under treatment at the isolation ward of STNM Hospital.

Speaking on the new positive case, Dr Bhutia informed that the 25-yearold returnee from Patna, Bihar and was lodged at a paid quarantine facility. He, along with three others, travelled from Patna to Siliguri on 29 June in a bus and then onwards to Rangpo in an SNT bus. From rangpo, they took another vehicle to the quarantine centre in Gangtok.

He informed that a total of 46 samples were tested by RT-PCR at STNM hospital this morning and all reported negative and 61 more samples will be tested overnight.

Meanwhile, addressing confusion regarding the price fixed for COVID testing, Dr Bhutia informed that Residential Certificate holders and Voter ID holders of Sikkim will continue to receive the testing for free

The privatization of Railways would be like selling blood veins

The Indian Railways, which were in **I** the news due to the accidents, are now in the grip of the financial crisis arising out of Corona. To bring the world's fourth-largest rail network back on track, the government is preparing to change its form. In addition to cutting thousands of posts, steps are being taken to stop new appointments and to hand over trains on several routes in the country.

Indian Railways has been playing a lifeline for most of the country's population. The unusual increase in fares compared to facilities after going into private hands is believed to be fixed. Rail is the highest employment institution in the country. Currently, it employs over 12 lakh employees.

It is important to understand how this will affect the country's general public life. It is necessary to consider how good or how bad this privatization is for the country. After the operationalization of Tejas Express, India's first private train, Indian Railways has now started the process of allowing private companies to operate passenger trains on its network through 151 new trains. While all these passenger trains are a small part of the entire railway network, the process of privatization initiated by the government marks the beginning of private sector participation in passenger train operations.

Privatization refers to a process in which ownership of a particular public property or business is transferred from a government organization to a private entity. Therefore, it can be said

that through privatization it is possible to develop a new industrial culture. In recent times, there have been attempts to use this experiment with the Indian Railways, which has done the work of provoking some sections, While some sections have also been affected by this move of the government.

It is important to understand how this will affect the country's general public life. It is necessary to consider how good or how bad this privatization is for the country. Commercial train travel in India started in the year 1853, after which the Indian Railways came under the then government in 1900. The largest cooperation in the Indian economy is from this region.

The first electric train of the country was run between Bombay to Kurla in the year 1925. After independence in the year 1947, India inherited an old rail network but about 40 percent of the previously developed railway network went to the part of Pakistan. Then some lines were repaired for the development of railway and some new lines were laid so that Jammu and some areas of North-East India can be connected to other parts of the country.

In 1952, it was decided to convert the Railway into zones to modernize and develop the railway network and a total of 6 zones of the railway came into existence. At that time, railway-related needs were met from abroad, but as the country developed, railway-related needs also started to be met from within the country and our railway continued to progress progressively.

The number of railway zones was increased to 12 in 2003 due to the new era and increasing pressure on railways. And over time, the number of railway zones increased to 17 on other occasions. But as the railway network developed in the country, the challenges related to the operation and management of railways also came up and new options were being discovered. When governments could not increase the profits of railways much, economic experts began to see privatization of railways as an alternative to profit.

Today the biggest question is why the railway which has been the chariot of the poor, why is it being privatized. It is believed that after the privatization of the railways, cleanliness will be better, due to the smooth running of trains, there will be a lot of time savings, better comfort facilities will be provided inside the train. Railways will be able to keep pace with the modernization of their infrastructure and services.

But if we look at the other aspect of privatization, something can be seen. The main objective of private companies is to earn money and they will also use the railways for their profits. Instead of amenities, there will be a sudden increase in fare, which will make rail travel very expensive and difficult for poor people. A section of Indian society depends only on railways for travel, they will lose it due to this privatization.

The biggest thing is that such a large railway sector cannot be operated by any private company. And handing over different parts in different hands would be the equivalent of selling the railway chopped off. Simultaneously,

there will also be a lack of uniformity. Who will take responsibility in case of an accident? When everyone cites their respective regions, they will turn away. After all, it will hit the common poor man who will not be in a position to travel by other means. Private contractors will see their

profits. Where only a poor section would travel by rail, those routes would be closed because they would not be getting money from them and with this step people living in such parts would remain untravelled there. If the railway remains owned by the Government of India, then its biggest advantage is that it provides nationwide connectivity regardless of profit.

Private companies are partnered with foreign companies, so if private companies are given the task of operating rail, then it is likely that its security is compromised and India's image is tarnished in the whole world.

If the Indian government privatizes the railways by recklessly violating the rights of citizens, it would be unfair to them, like selling India's blood veins. For the strengthening of the economy, the government can look for any alternative other than privatization or it can look at the complete privatization of buses.

As a result of railway privatization, a country like Britain had to face a lot of opposition and faced heavy opposition from the public. Profit of the country's economy should not be seen everywhere by the privatization, after all, the government is for the public interest, for small gains we cannot do daily loss of the population.

Sikkim's Eye is on Melli

Tt's not that Melli was a totally I nondescript town outside the range of the local media radar. The principal supply source of poultry products in Sikkim, Melli has become the hot and happening place for entrepreneurially minded and driven localities in the state. However, the latest reason that has shot it into prominence is singularly regrettable. The well-founded public rage has every right to rise to the highest degree until a detailed and thoroughly investigated explanation is provided, leading to all-round public satisfaction.

How the Sikkim Police will satisfactorily solve 'mystery" of the alleged illegal entry of five individuals, defying the protocols and screening in place at the Melli check post, will be of intense interest for more reasons than just the legal one. politicians, activists and Facebookers who are questioning this defiance are raising suspicions about the involvement of Sikkim's chief secretary and the Director General of Police. The privatization of Railways would be like selling blood veins

the financial crisis arising out of Corona. To bring the world's fourth-largest rail network back on track, the government is preparing to change its form. In addition to cutting thousands of posts, steps are being taken to stop new appointments and to hand over trains on several routes in the country.

Indian Railways has been playing a lifeline for most of the country's population. The unusual increase in fares compared to facilities after going into private hands is believed to be fixed. Rail is the highest employment institution in the country. Currently, it employs over 12 lakh employees.

It is important to understand how this will affect the country's general public life. It is necessary to consider how good or how bad this privatization is for the country. After the operationalization of Tejas Express, India's first private train, Indian Railways has now started the process of allowing private companies to operate passenger trains on its network through 151 new trains. While all these passenger trains are a small part of the entire railway network, the process of privatization initiated by the government marks the beginning of private sector participation in passenger train operations.

Privatization refers to a process in which ownership of a particular public property or business is transferred from a government organization to a private entity. Therefore, it can be said that through privatization it is possible to

some sections, While some sections have also been affected by this move of the government.

Commercial train travel in India started in the year 1853, after which the Indian Railways came under the then government in 1900. The largest cooperation in the Indian economy is from this region.

Awaiting Collaborations If people don't network, their issues will get hijacked angtok is cleaner than most State capitals in India,

Umuch cleaner than any other hill station. And the Gangtokians appear happy with that much because one is yet to see any community-level initiative to improve civic conditions any further. For instance, it had to be the State Government which gave the nod to a proposal which came from a foreign funding agency to declare MG Marg a "litter & spit free zone". The declaration was easy, it was the implementation that tested the patience of the enforcers. It has succeeded, but again as a top-down initiative, and with it, much before the rest of India was told to go swachch, Sikkim had added another USP to its appeal. Of course, no tourist is going to come to Gangtok only to see a litter & spit free zone (which, admittedly, is under some stress already), but it will be initiatives like this that will add up to provide that larger argument which will convince visitors to choose Gangtok over, say a Shimla for their summer vacations. It would, however, have been so much more palatable and welcome if such a "zone" had come about on public initiative. Why did it have to be the State which had to enforce the new stipulations? Why couldn't a local NGO have pursued the concept and convinced the locals to stop littering and spitting at MG Marg?

The problem lies with the fact that Gangtok, although it is the most urban of spaces in the State, is still also closed and uninvolved, populated by Gangtokians who are closeted not only in their lifestyles, but also their thinking. They complain that the UD&HD garbage collection trucks do not detour to their residences often enough, but will never come together to work out a solution for locality garbage disposal problems on their own. They will be scandalised when reports of a fire in a school in South India hits the headlines and will worry about the safety of their children, but will wait for the State Government to draw up a legislation to make the schools safer. And then they will forget to keep track. They will not come together as parents and pressure the respective school managements to install the safety mechanisms. They will complain of drunken driving on weekends until one of their own gets challaned for driving under the influence of alcohol and then it will be about how overbearing the cops have become. And through all this, they will not convince their neighborhood bars to collect car keys and refuse to hand them over to inebriated drivers or unless the group has a sober hand for the wheels. They know that substance abuse is a problem as is juvenile delinquency and also suicides, but remain cocooned in the belief that all that is happening to someone else until the hammer hits home and then they will convince themselves it was an aberration.

What Gangtokians do not realize is that it does not take a rocket scientist to identify the problem areas and suggest remedial measures when it comes to working out how communities can work together to make living better. The oft-expressed need for a civil society in Gangtok is not misplaced, the problem is, it does not appear to be forming; not until Gangtokians stop reacting only to personal discomforts and ignoring community issues. The problem with such an attitude is that when real issues crop-up, because the people are not interested in understanding them in their entirety, they get hijacked by people we all know commonly as "vested interests." When this happens, there is a lot of noise, but no resolution. It is for the people to decide whether they want to continue living in this cacophony or opt for saner collaborations.

How Coronavirus Affects the Brain

m pandemic,\ we're\ still\ learning}$ what the disease can do. There are now detailed reports of brain illness emerging in people with relatively mild lung illness, in those who are critically ill and also in those in recovery.

One key thing we're seeing is that severity of lung illness doesn't always correlate with severity of neurological illness. Having only minor lung illness doesn't protect against potentially severe complications.

When it comes to the brain and nerves, the virus appears to have four main sets of effects: "A confused state (known as delirium or encephalopathy), sometimes with psychosis and memory disturbance."

- 1. Inflammation of the brain (known as encephalitis). This includes a form showing inflammatory lesions – acute disseminated encephalomyelitis (ADEM) – together with the effects of low oxygen in the brain.
- 2. Blood clots, leading to (including in younger patients).
- 3. Potential damage to the nerves in the body, causing pain and numbness (for example in the form of post-infectious Guillain-Barré syndrome, in which your body's immune system attacks your nerves).
- 4. To date, the patterns of these effects seem similar across the world. Some of these illnesses are fatal and, for those who survive, many will bear long-term consequences.

This raises an important question: will COVID-19 be associated with a large epidemic of brain illness, in the same manner that the 1918 influenza pandemic was linked (admittedly somewhat uncertainly) to the epidemic of encephalitis lethargica (sleeping

sickness) that took hold until the 1930s? At this stage, it's hard to say - but here's what we know about the virus's effects on the brain so far. WHAT'S HAPPENING INSIDE

PEOPLE'S HEADS? Firstly, some people with COVID-19 experience confused thoughts and disorientation. Thankfully, in many cases it's short-lived. But we still don't know the long-term effects of delirium caused by COVID-19 and whether long-term memory problems or even dementia in some people could arise. Delirium has been mostly studied in the elderly and, in this group, it's associated with accelerated cognitive decline beyond what's expected if patients already suffer dementia.

The virus also has the potential to infect the brain directly. However, most of the physical effects we've seen in survivors look like secondary impacts of the virus being present in the brain rather than the effects of direct infection. For example, our immune system can appropriately fight the virus, but may start to attack our own cells - including our brain cells and nerves. This may be through the actions of immune cells and antibodies via an inflammatory mechanism known as a cytokine storm, or through mechanisms we don't vet understand.

There are also COVID-19 having ischaemic strokes, where a blood clot blocks the flow of blood and oxygen to the brain. Some of these patients have stroke risk factors (for example high blood pressure, diabetes or obesity), though their strokes have been particularly severe. It seems that this is because the blood rapidly becomes thickened in COVID-19 and, in these patients, there have been multiple blood clots in the arteries feeding blood to the brain, even in patients already receiving blood thinners. In others, there is brain bleeding due to weakened blood vessels, perhaps inflamed by the effects of the virus.

Where infection with the coronavirus is associated with inflammation or damage to the nerve endings themselves, individuals may develop burning and numbness and also weakness and paralysis. Often it's difficult to know if these are the effects of a critical illness on the nerves themselves or if there's brain and spine involvement.

and nervous system have the potential for long-term damage and can stack up in an individual. But we need to know more about what's going on in people's nervous systems before we can accurately predict any long-term effects.

One way of finding out more is to take a look inside patients' heads using brain-imaging techniques, such as MRI. So far, brain imaging has revealed a pattern of previously unseen findings, but its still very early days for using it in this pandemic.

In one study, patterns found included signs of inflammation and a shower of small spots of bleeding, often in the deepest parts of the brain. Some of these findings are similar to those seen in divers or in altitude sickness. They might represent the profound lack of oxygen being delivered to the brain in some patients with COVID-19 – but we are only starting to understand the full scope of the brain's involvement in the disease. Brain-imaging and postmortem studies for those killed by COVID-19 have been limited to date.

PARALLELS WITH THE PAST

The 1918 influenza pandemic may have killed 50-100 million people – one in 50 of those infected, and three to six times the number killed in the first world war. Yet it has faded from our collective memory. It's not often mentioned that this pandemic was linked to

an outbreak of brain disease - the "sleeping sickness" encephalitis lethargica.

Encephalitis and sleeping sickness had been linked to previous influenza outbreaks between the 1580s to 1890s. But the 20thcentury epidemic of encephalitis lethargica started in 1915, before the influenza pandemic, and continued into the 1930s, so a direct link between the two has remained difficult to prove.

In those who died, postmortems All of these effects on the brain revealed a pattern of inflammation in the seat of the brain (known as the brainstem). Some patients who had damage to areas of the brain involved in movement were locked in their bodies, unable to move for decades (post-encephalitic Parkinsonism), and were only "awakened" by treatment with L-Dopa (a chemical that naturally occurs in the body) by Oliver Sacks in the 1960s. It is too early to tell if we will see a similar outbreak associated with the COVID-19 pandemic, though early reports of encephalitis in COVID-19 have shown features similar to those in encephalitis lethargica.

> The aftermath of this global event has many lessons for us now in the time of COVID-19. One, of course, is that we may see widespread brain damage following this viral pandemic.

But importantly, it's also a reminder to consider the political and societal impact of pandemics, and the need to help vulnerable people who have illness afterwards. COVID-19 has already exposed disparities in access to healthcare. Societies will remain judged on how they protect and treat those most at risk from - and sustain the health consequences of - this virus. This will include people with neurological disease arising from COVID-19.

How can we stop people wanting to buy illegal wildlife products?

onservationists have been working for decades to save species such as pangolins and rhinos from illegal hunting and trading. And, with fears that the coronavirus pandemic originated from the wildlife trade, there's never been more pressure to find solutions.

One approach is to try and reduce demand for wildlife products so that the market effectively dries up. Persuading people to stop eating pangolins or using rhino horn in medicine is likely to be difficult, but perhaps easier than enforcing a global ban on the international trade and less heavy-handed than stopping poachers.

Since 2015, 32 countries have pledged to eradicate the market for illegal wildlife products and provided funding for projects aimed at encouraging customers to change their behaviour. But how effective are these likely to be?

It's a relatively new approach – and not one that scientists have thoroughly tested. We decided to review research on behaviour change in public health to give us an idea of what works and what doesn't. These ranged from efforts by community workers to improve sanitation in rural India, to education programmes on avoiding steroids among high school American football players in the US.

Money, motivations and mores

Projects designed to persuade people to change their behaviour rarely affect everyone they target. A study of health campaigns that used mass media channels, from television to billboards, showed that, on average, just 8% of the target audience changed their behaviour. One project which ran public television advertisements and distributed cheap devices able to estimate blood alcohol levels to shops and bars resulted in a 5% decrease in drink-driving

But campaigns that tried to get people to do something new, such as use seat belts regularly, were more successful than those that tried to get people to stop doing something, such as quit smoking. So conservationists may have more success by promoting a safe and acceptable alternative to a wildlife product than just telling consumers to stop altogether.

The most effective projects target a specific audience and consider the other factors competing with their message too - like anti-obesity projects aiming to overcome TV adverts for unhealthy food. But even then, success is not guaranteed. Another recent study found that less than half of high-quality health campaigns have positive results.

Other fields attempting to change the behaviour of their viewers, such as advertising, tend to have more money and experience than people trying the same methods in conservation. This all suggests that



progress in reducing demand for wildlife products will be slow. A single campaign aimed at rhino horn buyers in Vietnam might reduce demand, but it probably won't stop it altogether.

Research also shows that behaviours change when projects account for a person's motivations and desires. This is why incentivising people to quit smoking with cash prizes (so-called "quit and win" contests) rarely work in the long term. Fewer than one in 500 smokers maintained their good habits when the rewards stopped, because the underlying reasons for smoking weren't addressed,

The same issue applies to conservation. Projects are likely to fail or have unintended consequences if they don't tackle the things motivating people to buy wildlife products. In Japan, the horns of rhinos and saiga antelopes are believed to have similar medicinal effects. When the 1980 international trade ban on rhino horn came into effect, the Japanese traditional medicine industry just switched to saiga horn instead. Unfortunately, the saiga antelope is now classified as Critically Endangered, due in part to illegal hunting for

Luckily, market research can help us understand these motivations, and work out who may be most receptive to change. For instance, a status-conscious consumer in Vietnam might be set on buying wild meat, but farmed meat will be more acceptable to those concerned about price.

Tread carefully

Campaigns can also make things worse if they accidentally change a person's perceptions and values. One drug prevention programme aimed at teenagers in the US actually increased illegal drug taking this way. It involved uniformed police officers visiting schools to warn students about the harmful

effects of drugs, making drug use seem more common than it actually was, and so more socially acceptable.

Equally, many illegal wildlife products, such as pangolin meat and scales, are used by a relatively small proportion of people. Mass media campaigns give the impression that eating pangolins is more much common, and could unwittingly encourage others to follow suit.

No single approach or project is going to work on its own. If conservationists want to save a species through reducing demand for wildlife products, we must plan for the long term and think about what could go wrong.

We don't want to undermine public support and create tensions in communities by acting without fully considering the consequences. This is what happened when a ban on wild meat in Sierra Leone turned people against expert advice. During the 2013-2016 Ebola outbreak, the government told villagers that wild meat was risky, but this contradicted the everyday experiences of people who had safely eaten it for generations. Communities became suspicious

and suspected a sinister motive behind the ban. Changing people's behaviour is possible if we can promote new habits, tackle the core motivations behind buying illegal wildlife products, consider the cultural context of using those peoducts and focus on a target audience without making the illegal behaviour seem more widespread than it actually is. Armed with this knowledge, there is hope for turning the tide against this destructive trade.



There has been thinning out of troops from Finger areas in Pangong Tso as well, they said. Pangong Tso has been a major face-off site between the two sides.

The two militaries are set to hold extensive talks on finalising modalities for restoring normalcy and bringing peace tranquillity in the region after the verification of the disengagement exercise is completed, they added.

Government sources in New Delhi said the Chinese military has already removed tents and withdrew its personnel from patrolling point 14 in Galwan Valley, the site of violent clashes between the two armies on June 15 that left 20 Indian soldiers dead.

The Chinese side also suffered casualties but it is yet to give out the details. According to an American intelligence report, the number of casualties on the Chinese

Air pollution increases risk of COVID-19, deaths: Study



BENGALURU, JULY (PTI): Air pollution in Bengaluru is linked to the loss of an estimated 6,300 lives in the first half of 2020 and 3.7 per cent decline in the city's annual GDP despite strictly enforcing COVID-19 related lockdown, a study has revealed.

According to new online tool by IQAir AirVisual and Greenpeace-Southeast Asia, research shows that long-term air pollution exposure increases the risk of severe COVID-19 infections and death.

Bengaluru is linked to the loss of an estimated 6,300 lives in the first half of 2020 despite a COVID-related strict lockdown," the two organisations claimed in a statement.

It is also revealed that

air pollution took a major toll on the citys economy at a cost of approximately Rs 6,973 crore over the last six months, an equivalent of 3.7% of Bengalurus total annual GDP, the statement said.

The study claimed that the health damage from air pollution is expected to cost 1-5.8% "Air pollution in of cities GDP in the major

metropolitan cities of the world in the first half of this year.

Of all the 28 cities studied, Delhi bears the highest economic cost of air pollution as a percentage of GDP due to the impacts of PM2.5 and NO2 pollution.

While some cities have seen a temporary return of blue skies as a result of COVID-19 related restrictions, these gains were reversed as soon as lockdowns ended, the organisations observed.

Chronic air pollution exposure is associated with diseases such as hypertension,

diabetes, cardiovascular disease and chronic lung disease. Patients with these conditions are at a greater risk of hospitalisation COVID-19," they claimed.

The study observed that it is more important than ever that investments are directed towards green, just and sustainable sectors of society.

"Now is the time for a rapid shift away from polluting fossil fuels for our health, community, and for our economies, Greenpeace India's Avinash Chanchal was quoted as saying.

MLS returns to action after poignant moment of silence

KISSIMMEE (US), JUL 9 (AP): Nearly 200 players took the field for an 8-minute, 46-second moment of silence to protest racial injustice before Major League Soccer's return to action.

Players wore black T-shirts, black gloves and black facemasks emblazoned with Black Lives Matter on Wednesday night. The shirts had varying slogans that included Black And Proud, Silence Is Violence and Black All The Time.

The players walked toward midfield, raised their right arms one at a time and held the pose so long that some could be seen stretching fatigued muscles afterward.

It was a poignant moment that put two of the nation's most prominent changes over the last four months masks and movements at the forefront of the sport's return.

The group was formerly called the Black Players Coalition of MLS but changed its name this week to Black Players for Change. Originally announced on Juneteenth, the group started in the wake of George Floyd's death with the hope of combating systemic racism both in soccer and the players' communities. The league and the players' union endorsed the organization.

Several other players from Orlando City and Inter Miami took a knee near midfield during the demonstration. Orlando's Nani scored in the seventh minute of stoppage time and held on for a 2-1 victory over expansion Miami.

The two in-state teams delivered their own moment of silence by taking a knee along with the referee and the line judges just before the opening

The national anthem was not played before or after the demonstration. MLS previously said it would not be played because no fans were in attendance.

Floyd, a Black man, died May 25 after a white Minneapolis police officer pressed his knee on Floyd's neck for nearly eight minutes. Prosecutors said that a police officer had his knee on the neck of Floyd for 7 minutes, 46 seconds not the 8:46 that has become a symbol of police brutality.

MLS players had weeks to decide what to do prior to the MLS is Back tournament at ESPN's Wide World of Sports complex at Disney World.

The league's teams are sequestered in resorts for the duration of the World Cup-style tournament, which began with a Group A match that was the first meeting between two Sunshine State teams.

The NFL, the NBA and Major League Baseball surely have a close eye on what's happening outside Orlando.

The NBA should get an up-close look. The league already has part of its bubble established at the ESPN venue. NBA team flags fly on every flagpole, and some areas have been sanitized and cordoned off for basketball's return later this month.

MLS is using three fields near the back of the complex, two of the ones the NFL used for Pro Bowl practices the last four years. The league mandated masks for everyone other than players. Coaches, support staff and media donned masks during the game. Miami star Rodolfo Pizarro, who wasn't in the starting lineup, also wore one during warmups.

Miami's Andres Reyes left the field on a stretcher early in the second half after a scary collision with Orlando's Dom Dwyer. Replays appeared to show Dwver hitting Reves in the throat as they went for a 50-50 ball.

Reyes had trouble breathing as teammates and the referee called for help. Adding to the growing concern on the field, the emergency crew got hung up trying to gain access to him.

Security personnel struggled to open a gate, delaying the medical team's response. It was slow enough that one of Reyes' teammates, Juan Agudelo, ran across the field to help and ended up assisting in pulling the stretcher across the soggy grass.

Chris Mueller scored the equalizer for Orlando, getting a sliding toe on a perfect cross from Nani to the back post in the 70th minute.

Agudelo scored the first goal of MLS' return, drilling a left-footer past Pedro Gallese to cap a play that started with two teammates on top of each other in the box.

MADRID, JUL 9 (AP): Barcelona kept its title hopes alive with a 1-0 win in the city derby against Espanyol in the Spanish league, sealing the rival's relegation for the first time in nearly three decades.

Luis Su rez scored the winning goal early in the second half on Wednesday to move Barcelona within a point of leader Real Madrid and send Espanyol to the second division after 26 straight seasons in the top flight.

Real Madrid can reclaim a four-point lead with three rounds left with a home win against relegation-threatened Alav s on Friday. Madrid, seeking its first league title in three years, has a perfect record since the league resumed following the coronavirus break.

"We knew it would be a difficult match because of Espanyol's situation,"

Barcelona wins derby against Espanyol, relegates city rival

"We are going to keep trying to win

our matches and see if Madrid falters." Only a win in the city derby could have kept last-place Espanyol with a chance of staying in the top tier. The club owned by Chinese businessman Chen Yansheng hasn't played in the second division since the 1993-1994 season. It had been among the teams with most consecutive seasons in the top flight, along with Barcelona, Real Madrid and Athletic Bilbao.

"We have to apologise to our fans for what we have made them go through," Espanyol captain Javi L pez said.

"This is a difficult moment. Nothing went right for us this season. We are committed to coming back stronger."

It was the sixth straight loss for Espanyol, and its 11th consecutive league defeat away to Barcelona at the Camp

Nou Stadium. It has 24 points from 35 matches 11 points from safety.

Both teams went a man down to a straight red card early in the second half. Barcelona forward Ansu Fati was sent off after a hard foul on Fernando Calero in the 51st, and Espanyol midfielder Pol Lozano was ejected after a tough foul on Gerard Piqu in the 54th.

It didn't take long for Barcelona to take advantage of the extra space, and Su rez broke the deadlock from close range in the 56th after an exchange between Antoine Griezmann and Lionel Messi inside the area.

Griezmann, a starter for the second consecutive match after a lengthy period without getting many minutes, had already successfully teamed up with Messi in the team's 4-1 win at Villarreal in the previous round.

It was Su rez's 195th goal for Barcelona, moving him past Ladislao Kubala to become the club's third alltime highest scorer, behind C sar Rodr guez (232) and Messi (630).

Barcelona was in control from the start but Espanyol had some significant chances to open the scoring in the first half, hitting the post once and forcing goalkeeper Marc-Andr ter Stegen to make a tough save.

Barcelona, a two-time defending champion, next visits Valladolid on Saturday. OTHER RESULTS

Villarreal kept alive its chances of qualifying for the Champions League with a 3-1 win at Getafe, moving within three points of fourth-place Sevilla.

SAO PAULO (BRAZIL), 9 (AP): Social media giant Facebook said Wednesday that it has removed dozens of accounts linked to supporters or employees of Brazilian President Jair Bolsonaro as part of an investigation into the spread of false news online.

Nathaniel Gleicher, the company's head of cybersecurity policy, said in a statement that 73 Facebook and Instagram accounts, 14 pages and one group were removed. Brazilian courts have been investigating the spread of false news in connection with Bolsonaro.

There was no immediate comment from the presidential office about Facebook's action.

Facebook's executive said the accounts were linked to the Social Liberal Party, which Bolsonaro left last year after winning the 2018 presidential election, and to employees of the president, two of his sons. Sen. Fl vio Bolsonaro and congressman Eduardo Bolsonaro, and two other lawmakers.

This network consisted of several clusters of connected activity that relied on a combination of duplicate and fake accounts some of which had been detected and disabled by our automated systems to evade enforcement, create fictitious personas posing as reporters, post content, and manage pages masquerading as news outlets, Gleicher said in the statement.

He added that some of the content posted by the accounts had already been taken down for community standards violations, including hate speech.

International probe launched into facial recognition firm that scrapes images from the internet

Privacy regulators in the U.K. and Australia have announced a joint probe into Clearview Al's "data scraping" practices. The New York-headquartered company has built a facial recognition database by taking images from social media platforms and other websites without the consent of the people featured. It is reported that Clearview has "scraped" more than 3 billion images from the internet to build its database, which law enforcement agencies use to try and identify criminals.

"The Office of the Australian Information Commissioner (OAIC) and the UK's Information Commissioner's Office (ICO) have opened a joint investigation into the personal information handling practices of Clearview Inc., focusing the company's use of 'scraped' data biometrics individuals," reads a statement on the ICO's website.

"The investigation highlightstheimportance enforcement cooperation in protecting the personal information of Australian and UK citizens in a globalized data environment."

CNBC contacted Clearview for comment but did not immediately hear back.

Clearview's platform allows clients to upload a photo of an individual and match it to photos of that person that are stored in Clearview's database.

in News reported February that it had worked with 2,200 law enforcement agencies, companies, individuals worldwide. Macy's, Walmart, Bank of America, and Target have all reportedly used the service.

In May, Clearview said it would stop working with non-law enforcement entities and private companies amid regulatory scrutiny and potential

law suits.

pulled Clearview out of Canada earlier this week after privacy protection authorities launched an investigation into the firm. As a result, a contract between Canadian the Royal Mounted Police and Clearview has been terminated.

Canadian authorities said they will continue their investigations into Clearview.

"An ongoing issue investigation by the authorities is the deletion of the personal information of Canadians that Clearview has already collected as well as the cessation of Clearview's collection of Canadians' personal information," the Office of the Privacy Commissioner

have sent ceaseand-desist letters to Clearview after they learned it was scraping images from platforms.

Last month, the European Data Protection Board warned that Clearview technology was likely to be illegal in Europe.

"The use of a service such as Clearview by law enforcement authorities in the European Union would, as it stands, likely not be consistent with the EU data protection regime," it said.

In February, BuzzFeed that reported company has expanded into 26 countries outside the U.S. including Belgium, Denmark, Finland, France, Ireland, Italy, Latvia, Lithuania, Malta, the Netherlands, Norway, Portugal, Slovenia, Spain, Sweden, Switzerland, and the United Kingdom. The report stated that Clearview had national law enforcement agencies, government bodies, and police forces in those countries.

Worsening U.S. outbreak prompts tough actions as new coronavirus cases hit record

NEW YORK (Reuters) - New Jersey adopted a stringent coronavirus face-mask order on Wednesday, and New York City unveiled a plan to allow public school students back into classrooms for just two or three days a week, as newly confirmed U.S. COVID-19 cases soared to a daily global record.

Officials in New Jersey and New York, the hardest-hit states at the outset of the U.S. outbreak, are trying to preserve progress in curtailing spread of the virus in the face of a resurgence elsewhere across the country, especially the South and West.

More than 47,000 people have died of COVID-19 in the two northeastern states, accounting for more than a third of the 132,000plus Americans killed by the virus, according to a

More than 60,000 new COVID-19 infections were reported across the United States on Wednesday, the greatest single-day tally of cases by any country since the virus emerged late last year in China. And U.S. deaths rose by more than 900 for the second straight day, the highest level seen since early June.

New Jersey Governor Phil Murphy unveiled an executive order requiring face coverings outdoors where social distancing is not possible, citing a rise in the state's coronavirus transmission rate.

"It's about and death," Murphy, a Democrat, said at a briefing.

Many states require masks in public indoor settings and recommend them outside but have stopped short of mandating their use outdoors.

"I think that's the right thing to do," said Jordan Grant, 23, a real estate accountant who expressed dismay at seeing people congregating without masks. "It's what we should have been doing months ago."

Republican Senator Michael Doherty, however, accused Murphy of "exploiting a public health crisis for power," calling the new mask directive "oppressive."

In New York City, Mayor Bill de Blasio announced a plan for 1.1 million students in the nation's largest public school district to return to classes in September. Pupils would alternate attending school two or three days weekly and spend the remaining time at home under the "blended learning" schedule, which requires state approval.

Donald Trump, who has exhorted Americans to return to their daily routines, threatened to cut off federal funding to schools that fail to reopen on their normal schedule due to the coronavirus outbreak.

States are chiefly responsible primary and secondary education, but the federal government provides some supplementary funding.

Vice President Mike Pence said the U.S. Centers for Disease Control and Prevention would soon issue new back-toschool protocols after Trump criticized current recommendations as too strict and costly. But Pence stressed that CDC guidelines are advisory.

Coronavirus cases have been on the rise in 42 of the 50 states over the past two weeks, according to a Reuters analysis. Meanwhile, the percentage of people testing positive among those who are screened has climbed above 5% - to levels health experts deem concerning in some two dozen states.

On Tuesday, the number of confirmed U.S. cases crossed the 3 million mark, roughly equivalent to 1% of the population and about 25% of infections known all worldwide.

UN Council rejects Russia bid to limit Syrian aid deliveries

UNITED NATIONS, JUL 9 Belgium, Estonia and the (AP): The UN Security Council on Wednesday overwhelmingly rejected a Russian resolution that would have cut back the delivery of humanitarian aid to Syria's mainly rebel-held northwest to just one crossing point from Turkey.

Western countries voted against that resolution have the insisted on keeping the two current crossings Turkey, strong backing from Secretary-General Antonio Guterres and humanitarian groups.

humanitarian chief Mark Lowcock has called the two crossings from Turkey a lifeline for millions of civilians whom the UN cannot reach by other means.

The Russian resolution needed a minimum of nine yes votes in the 15-member council for approval, but Moscow got support from only three other countries China, Vietnam and South Africa.

Its failure to get the nine votes meant the US, UK and France didn't need to consider using their veto. Those three permanent council members voted along with Germany,

Dominican Republic.

Four abstained Tunisia, Niger, Indonesia and St. Vincent and the Grenadines.

Russia, Syria's closest ally, circulated the draft resolution after it joined China on Tuesday in vetoing a draft resolution co-sponsored by Germany and Belgium to maintain aid deliveries through two border crossing points from Turkey for a year. It received 13 yes votes. The current Security

Council mandate for UN cross-border aid deliveries expires Friday, Germany Belgium are expected to circulate a new proposal, likely to authorize the two current crossings from Turkey for six months. In a joint statement after the vote, Germany and Belgium said that millions of people are counting on the Security Council to allow for as much humanitarian access as possible ... (and) we will keep on working to this end.

Whether the differences between the five veto-wielding council members can be resolved in the next 48 hours remained to be seen.

Russia has argued against the resolution that aid should be delivered from within

Syria across conflict lines. But the UN and humanitarian groups say aid for 2.8 million needy people in the northwest can't get in that way.

Ambassador US Craft accused Kelly Russia and China of breathtaking callousness and dishonesty and distorting the realities on the ground.

Their actions in both resolutions underscore a harrowing truth that Russia and China have decided that millions of Syrian lives are an insignificant cost of their partnership with the murderous Assad regime, she said in a statement.

Moutaz Adham, the Syria director for the humanitarian group called Oxfam. the council's failure to reach agreement a devastating blow to the millions of Syrian families who rely on this aid for clean water, food, health care and shelter.

Cross-border aid is needed now more than ever, as Syrians face the threat of COVID-19, All available avenues

for delivering aid will be critical in helping the more than 11 million people in need of assistance across Syria.

In January, Russia scored a victory for Syria, using its veto threat to force the Security Council to adopt a resolution reducing the number of crossing points for aid deliveries from four to just two, from Turkey to the northwest.


It also cut in half the yearlong mandate that had been in place cross-border since deliveries began in 2014 to six months, as Russia insisted.

The defeated German-Belgian resolution had dropped a call for the re-opening of an Iraqi crossing to the northeast to deliver medical supplies for the COVID-19 pandemic.

In May, Russia's UN Ambassador Vassily Nebenzia said: Do not waste your time on efforts to reopen the cross-border closed points. The German-Belgian

resolution would have extended the mandate for the two border crossings from Turkey to the northwest Bab al-Salam and Bab al-Hawa for a year.

The Russian-drafted resolution would only authorize cross-border deliveries through the Bab al-Hawa crossing for six months.

Lady Antebellum sue black singer Lady A over name change

ountry music trio claim Anita White has 'demanded a \$10m payment' over the stage name she has used for 20

The US country group Lady A - known until recently as Lady Antebellum, before changing their name to shed slavery-era connotations - is suing the black female artist Lady A over use of the name.

When the trio first announced the name change in June out of respect for black Americans, it appeared that they were unaware that Anita White had been performing as Lady A for 20 years. "This is my life," White said at the time.

The two parties shared an image of a Zoom call and said they were "moving forward with positive solutions and common ground". The talks appear to have broken down. In a statement, the members of Lady A said that representatives for White "demanded a \$10m [£7.79m] payment".

The group is not seeking financial damages from White, nor that she change her stage name, but is instead suing her for recognition of a trademark it claims "we have held for many years" and to avoid further litigation.

Hillary Scott, Charles Kelley and Dave Haywood formed Lady Antebellum in 2006, and say that they faced no opposition, including from White, when they registered "Lady A" as a trademark

"We are sad to share that our sincere hope to join together with Anita White



in unity and common purpose has ended," the group said in a statement. They added that with White they had "shared our stories, listened to each other, prayed and spent hours on the phone and text writing a song about this experience together.

They added: "We can do so much more together than in this dispute."

White had told Newsday she felt "the group's camp is trying to erase me". In June, she told Rolling Stone: "They're using the name because of a Black Lives Matter incident that, for them, is just a moment in time. If it mattered, it would have mattered to them before. It shouldn't have taken George Floyd to die for them to realize that their name had a slave reference to it."

She has not commented directly
