MP inspects facilities at Gyalshing Dist Hospital, returns satisfied



GYALSHING, 24 JAN [IPR]: Lok Sabha MP, PD Rai, today visited the District Hospital to assess the progress and the state of the health facilities available there. He led a thorough inspection of the hospital along with District Collector Dr AB Karki, CMO Dr T Namgval and other officials.

He interacted with the patients and Medical staff whilst checking the various facilities, the Chief Medical Officer informs.

He then explained that his surprise visit to the District Hospital was to check on the ground reality of treatment provided to patients and the various medical tests available for the public.

He mentioned that the State has always given priority to Health and Education hence the visit was necessary.

The MP took assessment of the exist ing facilities, which are as per the Indian Public Health Standards (IPHS) norms and after a thorough assessment, stated that significant im-provement has been made by the Department of Health while keeping West District on priority.

He expressed satisfaction with the available infrastructure, manpower and equipment in the District Hospital Gyalshing.

The MP later visited the 8th Mile area of Gyalshing to inspect the recently constructed water distribution chamber there.

The MP also interacted with the residents of 8th Mile area whilst handing over drinking water connection orders to them in the presence of DC West, Chairperson (GMC), DE (PHE) and the local gentry.

The water-distribution chamber, funded under the Member of Parliament Local Area Development Scheme is all set to cater to the needs of around 70 households.

Gangtok Chalo dharna shifts to DAC premises

GANGTOK, 24 JAN:
The Gangtok Chalo protest in
the capital organised by Sikkim Progressive Youth Forum continued into day-2 today with a peaceful dharna at District Ad-

ministrative Centre area here.

The protestors, it may be recalled, undertook a 110 KM trek from Gyalshing to Gangtok, arriv-ing here yesterday, to voice their demand seeking improved services at the District Hospital at Gyalshing, something required as per Ministry of Health guidelines, and something which the authorities have failed to deliver, they insist.

The protestors, who had gathered at Titanic Park at MG Marg yesterday and intended to continue their protest there, inform that they have been asked by the police to shift to the DAC premises.

They have also stated that they want to continue with the protests until all their de-



mands are met.

Last night, Health Department officials called on the protestors for

a dialogue at Titanic Park but the neiations ended inconclusive.

A protestor, Rupen Karki, stated

that they want to see their demands met 100% and will not budge until then. "There is confusion in depart-

ment, some say 99% some say 95% of our demands have not been met," says Mr Karki.

Addressing a press conference here today, execu-tive member Yogesh Shar-ma informed they had met the Chief Minister last year and that the CM had recommended their case for resolution to the HRDD but the Department has not paid any heed to the recomme ndation

ly in Gangtok today press-

ing for the same demand.
Other demands of the association include 50 to 60% relaxation for teachers who have served on adhoc basis in other government

service recruitment.

The protestors also presented a memorandum enumerating their de-mands to Special Secretary, DR Subba, HRDD.

Excecutive member Rajesh Dahal informed that they have given a three-day ultimatum to the Department to resolve their issues or face a dharna and a rally on 29 January.

After the rally, if their

demands still remain unre-solved, they plan to proceed to Delhi with their protest and if even that does not help, take legal recourse.

Sikkim Berojgar Sangrash Samiti demands written commitment on regularisation of OFOJ jobs

Sikkim Berojgar San-grash Samiti [SBSS] has thanked the State government for providing government jobs to the unemployed under the 'One Family. One Job' scheme during the re-cent Rojgar Mela. However, the organisation has demanded that the gov ernment give a written assurance on regularisation of employment after five years and about their salaries and other finan-

cial benefits.

Addressing a press conference here today, SBSS member Man Bahadur Karki from Yangang, who also got a job under this scheme, questioned the terms and conditions mentioned in the appointment letter provided to candidates under

the OFOJ scheme.

He stated that the specifying that "the appointment is purely temporary and does not confer right to regular appointment" runs counter to the announcement that the employment will be regular-ised after five years.

On the same, he urged the government to give a proper, legally-binding written assurance for regularisation and not issue only verbal assurance.

While mentioning that the government has allocated funds in the supplementary budget to pay salaries to OFOJ employees only for two months, Mr Karki ques-tioned this provision and said that many youth have left their private jobs and even studies for this job and deserved a more durable assurance.

Another member, Milan Gautam from Yangang mentioned that a circular from the Finance Department last year asked Heads of Departments not to engage extra manpower. On the

same, he questioned how the government would provide salaries to these 20,000 youths.

He alleged that the

government had distributed allotments of housing scheme and other benefits just before the 2014 elections, but had not honored the commitments later.

"Jobs given under OFOJ scheme should not be like the benefits distributed just before 2014 election," he said. He also alleged that

many genuine candi-dates have been left out of this scheme while many undeserving can-didates who already have family members in government service were given appointment letters. He also stated that many candidates have not got jobs matching their qualifications.

Another member, Saraswati Sherpa, stated that OFOJ was a good scheme but the way of its execution has raised lots of doubts and confusion

among youths.

"We are not protesting this scheme but we are just asking the government for better execution and scrutiny process before providing jobs," she expressed.

Northeast to have exclusive Regional Data Centre

New Delhi, 24 Jan (PIB): Northeast will soon have an exclusive Regional Data Centre, which will be a state-ofthe-art institution to be set up with the support of Government of India's National Informatics Centre (NIC). At present, NIC is running National Data Centres at Delhi. Hyderabad, Pune and Bhubaneswar.

Disclosing this here today, Union Minister of State (Independent Charge) Development of North Eastern Region (DoNER), MoS PMO, Personnel, Public Grievances & Pensions, Atomic Energy and Space, Dr Jitendra Singh said, the proposed Centre will be set up at Guwahati and the land for it has been provided by the Government of Assam.

The proposed North-east Regional Data Centre at Guwahati is expected to be set up at a budget of approximately over Rs 300 crore and while the Department of North Eastern Region (DoNER) and North Eastern Council (NEC) have in-principle agreed to support the project, the exact quantum of support and the share of fi-nancial assistance will be mutually worked out depending upon feasibility and available resources.

A team of Nation-

Informatics Centre (NIC), comprising among others Deputy Direc-tor General, DC Mishra, State Informatics officer, Suchitra Pvarelal and Regional Technical Director, Ashish Vikram Asthana, briefed the DoNER Minister about the project. It was stated that with the establishment of Northeast Regional Data Centre, the implementation of key flagship projects of the government can be fast tracked and optimum utilization can be ensured of the man-power as well.

This initiative, Dr Jitendra Singh said, will also play an integral role in building digital North-east India as a part of "Digital India". This, he said, shall also provide impetus to increased use of e-governance services, geo-spatial ap-plications and development related activities. In addition, there will be confidentiality and strategic control of data as well, he said.

National Girl Child Day celebrated in North Sikkim



Finnish First

Let's learn some things from Finland

Finland is today (as ranked by independent **T** agencies on a range of international indices), the most stable, the safest and the best governed country in the world. With a population of 55 lakh, it is also ranked the third wealthiest, the third least corrupt, the second most socially progressive and the third most socially just. Its judicial system is recognized as the most independent and the highest levels of personal freedom is lavished on its citizens, and hence it should come as no surprise then that in these times of shrinking trust and ugly profiteering, Finland's police is the most trusted, its banks the most stable and companies the second most ethical. Sitting as it does, among a clutch of Scandinavian countries which ace these rankings, this is a major achievement for Finland because geography has been harsh to the land and history rather vicious to its people. The last ever famine in Europe was 150 years ago, and in Finland, then a backwater under the Russian empire, the famine wiped out 10% of the population. This must have been a staggering setback and the country has been independent only for a 100 years, meaning, it could begin pulling itself out of its privations only a century back, a time by when its neighbours had leaned ahead while Finland's human resource was at its lowest. And yet, the country has done so handsomely well for itself and its people.

Most people, Sikkim included, look at Finland and see its primary school education system and want to learn from it, which is good, but rather incomplete. When one looks at Finland, its experience and its indices, one realizes that excellence does not come in isolation or piecemeal. Once the right environment has been created to install the best primary education systems in place, it is not just schools that are touched but everything else benefits as well - from the environment to social justice to democracy. Yes, that last one as well. Finland, did we mention, is the third most gender-equal country in the world and has the second freest elections.

Researchers and other societies have been trying to get a handle on what makes Finland so excellent. Even accepting that the Finnish experience cannot be replicated, understanding it will at least tag the societal instincts necessary to deliver so well. One does realize that these things are not packaged and delivered top-down and are instead manifestations of how the larger community behaves and responds to situations. Tarja Halonen, Finland's president from 2000 to 2012, was quoted in a recent report as saying, "We live in a cold, harsh and remote place. Every person has to work hard for themselves. But that is not always enough. You have to help your neighbours." He was responding to a query on what contributed to the Finnish Miracle. But it is not just instinctive cooperation, but also perseverance and complete commitment to common pursuits. Their geography and challenges are not kind to fickleness and the Finns clearly know this well. They also have a name for the "dogged, courageous persistence regardless of consequence" that defines them - "sisu". A historic manifestation of "sisu" was in 1939-40, when 3.50 lakh Finnish soldiers twice fought off Soviet forces three times their number, and inflicted losses five times heavier than those they sustained. And this attitude has served them well in peaceful times as well. Their survival has traditionally depended on working together, collaborating, but interestingly, not by subsuming individuality, but by allowing equal expression and representation. The Finns have leveraged the absence of traditional hierarchies (within themselves) to ensure that while collaborations and community participation was quick and genuine, ideas can be freely shared and individuality safely expressed without running the risk of being judged or scoffed. This attitude celebrates excellence and allows ideas to germinate and merit an expected outcome. In such environments, while mediocrity is tolerated, it is not celebrated as is common in more feudal settings of even democratic societies; people believe in each other and are not second-guessing every gesture and don't allow their prejudices to rule their judgment. Such a people look ahead and not stare into the past. That is a nice place to be. And it is not as if everyone is happy and smiling all the time in Finland. Their free society means that free expression is genuinely on offer and criticism, even ridicule, is frequent and harsh. But

there is also trust and faith.

What can the kingdom of Bhutan teach us about fighting corruption

ighting corruption is supremely difficult, as it is proved by the recent expulsion of UN anti-corruption mission in Guatemala, the jail sentence of a former Korean President or the murder of an African journalist investigating corruption.

Considering the huge cost of corruption, many xperts and observers would recommend looking at public policy or business practices in place in countries such as Denmark or Finland, known for being transparent and accountable societies. Yet countries such as Bhutan in the heart of the Himalayas can provide original approaches in dealing with anti-cor-

ON THE PATH OF THE THUNDER DRAGON

Known as the Thunder Dragon Kingdom, Bhutan has embarked on the path of democracy in recent years, bringing on a series of social-economic changes while opening up to the world. Yet, it ranks among the poorest countries in the world with 12% of its population below national poverty line.

Bhutan is also surrounded by South Asian states with high level of corruption, in particular India and Bangladesh. Despite its own challenges and accord-ing to the Corruption Perception Index 2017 of the NGO Transparency International, Bhutan ranks 26th out of 180 countries, while much richer countries do not fare so well: Poland (36th), Spain (42nd), China (77th) or India (81st).

The results indicate that Bhutan may be a good example in a quest for effective anti-corruption pol-icies. How did it manage so well despite the odds? And what can we learn from its experience?

LOSS OF PERSONAL POWER FOR THE PUBLIC

In the fight against corruption, it's essential to avoid hypocrisy – preaching good while acting badly. To avoid such behaviour, in Bhutan real actions and accomplishments are celebrated rather than mere words. There as in many countries, corruption is usually defined as the abuse of power for private gain against the public good. Bhutanese history offers some explanations that are linked to the Wangchuck sovereigns, called Druk Gyalpo or Dragon Kings.


King Jigme Singye Wangchuck (reign 1972-2006) has been able to demonstrate how a leader acts without corruption and how he embodied ethical principles. Indeed, in 2006, he abdicated in favour of a democratic process in which most of the monarch's power was transferred to a Council of Ministers and an elected Parliament. The first democratic elections were held in 2007.

The monarchy sustained through the fifth and current Druk Gyalpo King Jigme Khesar Namgyel Wangchuck, who followed the same ethics as his father. In doing so, he also embodied what is ant-onymic to corruption: the loss of personal power

MAKING CORRUPTION A COLLECTIVE ISSUE

Involving the population in public life through elections marked a crucial change for Bhutan. In this Buddhist country, acting collectively is part of the culture, especially in the fight against corruption.

While compliance programs today often stress the importance of paying attention to leaders, the Bhutanese approach the fight against corruption as

EVIDENCE-BASED ANTI-CORRUPTION POLICY

In general, most countries and organisations do not conduct research themselves and don't base their anti-corruption decisions on research. While corruption has been shown to have a negative impact on economic growth, academic investments are made to deeply understand it.

In Bhutan, however, decision makers are working to build data-driven strategies in many areas. Bhutan has conducted several scientific inquiries to understand the causes, consequences and ways of reducing corruption. For example, the ACC studied corruption in the public road construction with a collaborative survey assisted by Ministry of Works and Human Settlement, Ministry of Finance and the Royal University of Bhutan. Findings detailed issues involving dishonesty, problems with monitoring and enforcement, undue influence and un-

ETHICAL INDICATORS

To ensure the success of any anti-corruption action, indicators are necessary to follow its prog-ress. The strategy set up by the King of Bhutan, the politicians and civil servants is part of the original policy of achieving the population's Gross National Happiness, which puts happiness rather than wealth as the main objective of the country. Thus, the country has managed to develop its own overall performance index not on Gross Domestic Product but rather on (Gross National Happiness

The GNH index includes several measurements of corruption, thus making anti-corruption policy is part of the national well-being strategy. Bhutanese leaders and other stakeholders have designed some holistic "key performance indicators" to monitor the

anti-corruption policy and its results.

For example, the regular National GNH Survey seeks to clarify areas in which the conditions for happiness exist. It includes questions about corruption, including where public action is required. For example, the Ministry of Education regularly evaluates integrity levels in its programmes and trainings. The success of an anti-corruption policy is thus due to its integration in a broader ethical vision as well as having specific targets.

While Bhutan still faces some corruption problems, including 2018 case of irregularities in construction bids, the country's success in the fight against corruption has been impressive. It is time for other countries to both learn from their inspiring ideas and apply them

We can't save everything from climate change - here's how to make choices

Recent reports have delivered sobering messages about climate change and its consequences. They include the Intergovernmental Panel on Climate Change's Special Report on Global Warming of 1.5°C; the fourth installment of the U.S. government's National Climate Assessment; and the World Meteorological Organization's initial report on the State of the Global Climate 2018.

As these reports show, climate change is already occurring, with impacts that will become more intense for decades into the future. They also make clear that reducing greenhouse gas emissions from human activities to a level that would limit warming to 2 degrees Celsius (3.6 degrees Fahrenheit) or less above preindustrial levels l pose unprecedented challenges. Today, however, there is a large and

growing gap between what countries av they'd like to achieve and what they have committed to do. As scholars focused on climate risk management and adaptation, we believe it is time to damage in terms of triage.

Hard choices already are being made about which risks society will

attempt to manage. It is critically important to spend limited funds where they will have the most impact

TRIAGING CLIMATE CHANGE

Triage is a process of prioritizing actions when the need is greater than the supply of resources. It emerged on the battlefields of World War I, and is widely used today in fields ranging from disaster medicine to ecosystem conservation and software development.

The projected global costs of adapting to climate change just in developing countries range up to US\$300 billion by 2030 and \$500 billion by

mid-century. But according to a recent estimate by Oxfam, just \$5 billion to \$7 billion was invested in projects specific to climate adaptation in 2015-2016.
Triaging climate change mea

placing consequences into different

buckets. Here, we propose three.

The first bucket represents impacts that can be avoided or managed with minimal or no interventions. For example, assessments of how climate change will affect U.S. hydropower indicate that this sector can absorb the impacts without a need for costly interventions

The second bucket is for impacts that are probably unavoidable despite all best efforts. Consider polar bears, which rely on sea ice as a plat-form to reach their prey. Efforts to re-duce emissions can help sustain polar bears, but there are few ways to help them adapt. Protecting Australia's Great Barrier Reef or the Brazilian Amazon poses similar challenges.

The third bucket represents impacts for which practical and effective actions can be taken to reduce risk. For example, cities such as Phoenix, Chicago and Philadelphia have been invest-ing for years in extreme heat warning systems and emergency response strategies to reduce risks to public health. There are a variety of options for making agriculture more resilient, from precision agriculture to biotechnology to notill farming. And large investments in in-frastructure and demand management strategies have historically helped supply water to otherwise scarce regions and reduce flood risk.

In each of these cases, the challenge is aligning what's technically feasible with society's willingness to pa WHAT TRIAGE-BASED PLANNING LOOKS LIKE

Other experts have called for climate change triage in contexts such as managing sea level rise and flood risk and conserving ecosystems. But so far, this approach has not made inroads

How can societies age-based planning? One key step is to invest in valuing assets that are at risk. Placing a value on assets exchanged in economic markets, such as agriculture, is relatively straightforward. For example, RAND and Louisiana State University have estimated the costs of coastal land loss in Louisiana owing to property loss, increased storm damage, and loss of wetland habitat that supports commercial fisheries.

Valuing non-market assets, such as cultural resources, is more challenging but not impossible. When North Carolina's Cape Hatteras lighthouse was in danger of collapsing into the sea, heroic efforts were taken to move it further inland because of its historic and cultural significance. Similarly, Congress makes judgments on behalf of the American people regarding the value of historic and cultural resources when it enacts legislation to add them

to the U.S. national park system.

The next step is identifying adaptation strategies that have a reasonable chance of reducing risks. RAND's sup-port for the Louisiana Coastal Master -Plan included an analysis of \$50 billion in ecosystem restoration and coastal protection projects that ranked the benefits those projects would generate in terms of avoided damages.

This approach reflects the so-called "resilience dividend" – a "bonus" that comes from investing in more climate-resilient communities. For example, a recent report from the National Institute of Building Sciences esti-mated that every dollar invested in federal disaster mitigation programs - enhancing building codes, subsidiz-ing hurricane shutters or acquiring flood-prone houses - saves society \$6. Nevertheless, there are limits to the level of climate change that any investment can address.

The third step is investing enough

financial, social and political capital to meet the priorities that society has agreed on. In particular, this means including adaptation in the budgets of federal, state, and local government agencies and departments, and being transparent about what these organizations are investing in and why.

Much progress has been made in

improving disclosure of corporate exposure to greenhouse gas reduction policies through mechanisms such as the Task Force on Climate-Related Disclosures, a private sector initiative working to help businesses identify and disclose risks to their operations from climate policy. But less attention has been given to disclosing risks to businesses from climate impacts, such as the disruption of supply chains, or those faced by public organizations,

such as city governments.

Finally, governments need to put frameworks and metrics in place so that they can measure their progress.
The Paris Climate Agreement calls on countries to report on their adaptation efforts. In response, tools like InformedCity in Australia are emerg-ing that enable organizations to measure their progress toward adaptation goals. Nevertheless, many organizations – from local governments to cor-porate boardrooms – are not equipped to evaluate whether their efforts to adapt have been effective.

There are many opportunities to manage climate risk around the world, but not everything can be saved. Delaying triage of climate damages could leave societies making ad hoc deci-sions instead of focusing on protecting

the things they value most.

Centre reconstitutes tribunal to adjudicate ban imposed on 8 Manipur insurgent groups

New Delhi, Jan 24 (PTI): The Centre on Thursday reconstituted a tribunal to adjudicate matters related to exten-sion of ban imposed on eight insurgent groups in Manipur for five more years over continued involvement in unlawful and violent activities.

In a notification, the

Home Ministry said the tribunal has been set up under the Unlawful Activities (Prevention) Act. 1967 and will be head-ed by Delhi High Court

judge Justice G S Sistani.

The tribunal will adjudicate whether or not there is sufficient cause for declaring the Meitei extremist organisations of Manipur as "Unlawful Associations", the notification said.

On December 12. 2018, the central government had constituted the tribunal headed by Delhi High Court judge Justice Sangita Dhingra Sehgal. However, due to certain reasons, Justice Sehgal could not continue with the tribunal and hence the tribunal has been reconstituted with Jus-

IIT Kharagpur, Japan's AŌTS sign MoU for research centre KOLKATA, JAN 24 (PTI): IIT Kharagpur (IIT KGP) and Japan's Association for Overseas Technical Cooperation and Sustainable Partnerships (AOTS) have signed an MoU to explore opportunities for a research centre that will facilitate collaborative projects.

The two organisations shall focus on "state-ofthe-art joint certification courses in the domains of technology and management to be co-taught by faculty/experts in both countries, including visit to the host institutions, an IIT KGP statement said here Thursday.

The partnership will have a strong focus towards professional development of students, it added.

Japan is a glob-leader in domains such as urban science and infrastructure, advanced manufacturing, high-speed railways semi-conductors, while India has emerged as domain experts in infor-mation technology, data science, artificial intelligence and the startup culture, IIT KGP Director P P Chakrabarti said.

The proposed centre at IIT KGP will facilitate collaborative projects and training modules in these areas in accor-dance to the work culture of India and Japan, which have their unique styles of management and leadership, he said.

The home ministry said the eight Meitei ex-tremist organisations of Manipur were involved in 756 violent incidents in the past five years from January 1, 2013 to July 31, 2018 during which they killed 86 people, including 35 security personnel.

The groups have been indulging in acts of in-

looting of civilian population for collection of funds, making contacts with sources abroad for influencing public opin-ion and securing assistance by way of arms and training for the purpose of achieving their secessionist objective, the ministry said.

They are also indulg-

NAPIER, JAN 24 (PTI): Cricketers from and New Zealand should be tough enough to deal with a "bit of sun in their eyes", said Napier's May-or Bill Dalton and wondered if players would have walk off if a similar situation arose in India.

The first ODI between India and New Zealand here on Wednesday was halted for about half an hour due to players being blinded by a setting sun, a bizarre first in international cricket which is otherwise no stranger to rain-related interruptions.

"I wonder if in India they go off the field because they have sun in their eyes," Dalton was quoted as saying by 'stuff.co.nz'.

"To be absolutely honest with you, my view is that these guys are sportsmen who play outside. If they get bit of sun in their eyes that's part of the game. It's an outdoor sport and they've got to toughen up... It's all a bit weird to

me," he added. New Zealand Cricket spokesman Richard Boock said there was no immediate remedy in sight for the problem.

"It's something we need to have a talk about and review in the course of time, but there isn't any immediate remedy that's obvious," he said. Indian captain Virat Kohli, whose side's eight-wicket demolition of New Zealand was somewhat overshadovershadowed by the bizarre turn of events, said after the match that he had never experienced a sun-induced stop-page in his life. "It was funny. In 2014, I got out once with the sun in my eyes and this rule wasn't there then." Kohli said at the post-match presentation ceremony.

The decision to halt proceedings was taken after the dinner break of the day-nighter, keeping the players' safety in mind, on-field umpire

Shaun George said.

New Zealand skipper Kane Williamson took a lighthearted view on the situation.

China clones five gene-edited monkeys for human disease research

KIM VARMA BEIJING, JAN 24 (PTI): Scientists in China have cloned five monkeys af-

ter editing genes to in-duce several human diseases like Alzheimer's that they claim will help in medical research, an advance which is likely to raise fresh ethical con-cerns about gene-editing.

The announcement follows the recent confirmation that the world's first gene-edited human babies have been born in China, following an "unauthorised experiment" that has caused wide-spread disquiet in the scientific community.

Chinese scientists
have cloned five monkeys from a gene-edited macaque with circadi-an rhythm disorders that are linked to sleep depression problems, depression and Alzheimer's disease, the official Xinhua news agency said on Thursday.

It is the first time multiple clones had been made from a gene-edited monkey for biomedical research, the news agen-cy said. Chinese Scientists made the announcement of the monkey clon-ing on Thursday with two articles published in National Science Review, a top Chinese journal in English.

The cloned monkeys were born in Shanghai at Institute of Neuroscience of Chinese Academy of Sciences. Researchers said that the advance

dian rhythm are associated with many human diseases, including sleep disorders, depression, diabetic mellitus, cancer and neurodegenerative diseases, such as Alzhei-

mer's disease.

Previously, mice and flies were widely used for the research of such diseases, but these animal models differ greatly from human beings in terms of activity routines, brain structure and metabolic rate.

The announcement with photographs of the newly born monkeys in incubator comes in punishing a scientist He Jiankui whose experiments resulted in the birth of twin gene edited babies. A special investigation team held that He defied the ban and carried out unautho-

rised experiments.

He had announced their birth in November. after China launched a probe. The investigating team has confirmed that while one volunteer delivered twins Lulu and Nana another lady is pregnant. The cloned monkeys, closer to human in physiology, make better models for re-search on disease pathogenesis and potential therapeutic treatments.

In order to create an ideal donor monkey, re-searchers knocked out BMAL1, a core circadian regulatory transcription

factor, using gene editing at the embryo stage.

They selected one of the gene-edited monkeys with the most severe disease phenotypes as the donor. Jakarta ex-governor freed from prison after blasphemy sentence

JAKARTA, JAN 24 (AFP): Jakarta's former gover-nor has been released from prison, his assistant said Thursday, nearly two years after his blasphemy conviction fanned fears over religious intolerance in the world's biggest Muslim-majority nation. Basu-ki Tjahaja Purnama -- the Indonesian capital's first non-Muslim governor in half a century and its first ethnic Chinese leader -left Mako Brimob prison in Depok, outside Jakarta, at around 7:30 am local time,

Ima Mahdiah told AFP. Supporters of the former governor, who is popularly known as Ahok, gathered outside the prison, chanting and cheering his new-found freedom. The release ends one of the most tumultuous chapters in Indonesian politics in recent memory.
Purnama had been a

popular politician who won praise for trying to clean up the traffic-clogged megacity and clamp down on corrup-tion before his imprisonment. But his downfall came quickly after com-ments he made on the campaign trail during a re-election bid saw him accused of insulting Islam. The filmed remarks, which went viral online, sparked mass protests in Jakarta, spearheaded by radical groups opposed to a non-Muslim leader and encouraged by his political rivals.

He lost the election to a Muslim challenger and was then sentenced to two years' jail in May 2017. It was an unusually harsh sentence -- prosecutors had only recommended probation the now 52-year-old.

"He was picked up by his son Nicholas Sean Purnama" after being released, his assistant Mahdiah said. "He will spend time with his family first, resting." Purnama's case drew international headlines and a wave of criticism, including from the United Nations, which urged the country of 260 million to revise its decades-old blasphemy law. The charge against him centred on a re-mark he made to voters about his Muslim rivals using a Koranic verse to trick people into voting against him, which judges ruled amounted to blasphemy against Islam.

The huge demonstrations calling for Purna-ma's jailing fuelled concerns about the growing influence of religious hardliners and that the Southeast Asian country's much-vaunted tolerant brand of Islam was under threat.

Indonesia's phemy law states that anyone found guilty of "expressing feelings of hostility" towards reli-gion can be jailed for up to five years.

It applies to any of the six officially recognised religions, including Christianity. Buddhism and Hinduism, but most prosecutions are brought against people accused of blaspheming Islam, which is followed by nearly 90 percent of the population.

Among them was an ethnic Chinese Buddhist woman found guilty in August of insulting Islam for asking her neighbourhood mosque to lower the volume on its sound system. She was sentenced to 18 months in iail.

The woman's com-ments about the mosque noise triggered riots in 2016 that saw angry Muslim mobs ransack Buddhist temples.

Some ethnic Chinese in the area fled in fear.

MAKASSAR, JAN 24 (AFP): The death toll from flash floods and landslides in Indonesia jumped to 26, a disaster agency official said Thursday, as rescuers race to find still-missing victims.

Thousands have been evacuated from their homes as heavy rain and strong winds pounded the southern part of Su-lawesi island, swelling rivers that burst their banks and inundating dozens of communities in nine southern districts. Parts of the pro-vincial capital Makassar have also been affected.

"As of this morning, 26 people are confirmed to have died and 24 others are missing," said Syamsibar, the head of the local disaster mitigation agen-cy, who like many Indonesians goes by one name.

Sports-loving sultan picked as Malaysian king after shock abdication

KUALA LUMPUR, JAN 24 (AFP): Malaysia's royal families on Thursday picked a sports-loving sultan as the country's new king after the last monarch abdicated in a historic first following his reported marriage to a ssian ex-beauty queen. The previous king, Sultan Muhammad V. stepped aside this month following just two years on the throne after reports surfaced he had married the former Miss Moscow while on medical leave. There was great shock across Malaysia at the first abdication of a monarch in the Muslim-majority country's history.

Sultan Abdullah Sultan Ahmad Shah, a keen athlete who holds a string of positions on sporting bodies, including at world football governing body FIFA, was elected as the new king during a special meeting of Malaysia's Islamic royalty. Sultan Abdullah "has been chosen as the 16th Yang di-Pertuan Agong (king) for a period of five years starting from Janu-ary 31, 2019," said a statement from the Keeper of the Rulers' Seal, Syed Danial Syed Ahmad. Malaysia is a constitutional monarchy, with a unique arrangement where the national throne changes hands every five years between rulers of the country's nine states headed by Islamic royalty.

Eight of the state sultans earlier met at the national palace in Kuala Lumpur for the so-called "Conference of Rulers" to select the new king. The only one absent was Muhammad V, who remains the sultan of the northeastern state of Kelantan despite having abdicated as the national monarch.

Abdullah was widely

expected to become king as the central state of Pahang was next in line to provide the monarch The 59-year-old was named Pahang's new ruler -- replacing his elderly, ailing father -- several days after Muhammad V's abdication, paving the way for him to become the next national monarch.

The deputy king was named as Sultan Nazrin Shah of Perak state according to the statement. As well as being a



Of Siachen soldiers and glacier captains: Nat Geo docu captures remarkable stories of survival

New Delhi, Jan 24 (PTI): How do soldiers survive at minus 50 degrees Celsius in Siachen and glacier captains carry out evacuation flying over relentless ice-fields in the world's highest battlefield?

These and few other lesser-known stories of the Indian Air Force's opera-tions in the toughest climatic conditions in the country will be unveiled through a special documentary that premiers Fri-day on National Geographic channel to

mark the 70th Republic Day.

Titled 'Extreme Flight: Indian Air Force', the 44-minute film with its stunning visuals, captures the story of selfless service rendered by personnel of the Army who guard the nation at high altitude border. the nation at high-altitude border posts, and men and women of the IAF who rush relief material and succour to soldiers in helicopters flown in very harsh weather conditions.

Narrated by actor Kabir Bedi, the Republic Day special documentary in English, will also be broadcast on the channel on January 26 at 12 noon and 8 pm and available on Hotstar. Shruti Takulia, Creative Director and

Vice President, India productions at the National Geographic, says, the project had many challenges, but the IAF provided valuable guidance and technical and logistic support to help tell the un-told or lesser-known stories to people, while ensuring the safety of the crew.

Siachen Glacier is a place where wind speed could reach 160 kmph, temperature sometimes falls below minus 50 degrees Celsius and has low oxygen level, and at such high-altitude areas mere survival itself is a challenge. Soldiers face several risks, including suf-fering frost bite, depression, sleep loss, diminished appetite, hypoxia or even memory loss, the film says. "As with all our projects, idea was to

tell these lesser-known stories and IAF's partnership made the film so powerful in capturing the various narratives, whether it is challenges faced by the first woman glacier captain of the Air Force, Sq Ldr Khusboo Gupta, at the Leh Air Base, to the risk involved in flying a helicopter in extreme weather conditions," Takulia told PTI in an exclusive interview.

Gupta is part of the Siachen Pioneers, a helicopter unit assigned to support the

glacier's least-accessible posts.

Takulia said the idea for the film first germinated in 2016 and "then we took it further and then officials from the IAF also offered a lot of suggestions. Then the research phase began for which we consulted various de-fence and medical experts".

"The actual shoot began last year in February and the final shoot end-ed in May. From Jammu and Kashmir to Northeast, we have showcased the amazing stories of survival that not many know about. In the film, we can see defence personnel in deep snow.

sometimes three feet-deep or pilots and others wearing battery-heated boots to ward off frostbite. We tried to capture these microscopic details to show how

difficult the survival is there," she said.

According to the documentary, Sia chen has the world's highest battlefield and the film also captures the Leh Air Base located in picturesque Leh town with largely Buddhist population. At 10,682 ft, it is a crucial base for high-aling, said many crew members had suf-
