Fatalities due to COVID, however, keep Sikkim under a pall of gloom with three more Covid deaths reported in the last 24 hours taking Sikkim's COVID toll to 260. All three deaths were reported from STNM Hospital.

Meanwhile, there were 29 Covid patients were hospitalised today after they reported severe symptoms. There are currently 228 patients in Covid wards of hospitals across the State, of whom 34 are in ICU. Also over the same 24 hours, 18 patients responded well to care received in hospitals and were discharged into home

At present, there are 339 Covid-positive people in Covid Care Centres being run by the State Government, 15 in paid quarantine centres and 3,422 in home isolation.

In the latest set of recoveries, 136 were discharged from home isolation after making full recoveries, taking the number of recovered cases of COVID-19 in Sikkim to 11,299.

The number of active cases of novel coronavirus in Sikkim currently stands at 4,103 while Sikkim's tally of confirmed cases of COVID-19 recorded thus far has now reached 15,876.

#### After 6-year-old's appeal, J&K administration issues new online learning guidelines

SRINAGAR, 02 JUN [PTI]: A day after Jammu and Kashmir Lieutenant Governor Manoj Sinha assured a policy in 48 hours to ease the burden of homework on school children, the administration on Tuesday came out with fresh guidelines limiting daily online classes to half-an-hour for pre-primary students and 90 minutes for primary and middle students.

guidelines came within 24 hours of Mr Sinha's directions to the school education department to come out with a policy in 48 hours after a video of a six-yearold girl went viral on social media in which she appealed to Prime Minister Narendra Modi to ease the burden of homework.

"The school education department has decided to limit daily online classes for a maximum one and half hours for class 1 to 8, spread across two sessions. For class 9 to 12 online synchronous learning will not be more than 3 hours," the L-G said on his official Twitter han-

He said in the case of the pre-primary students, the interaction with their teachers on a given day shall be only of half-an-hour and also asked the teachers to avoid assigning homework to students of classes up to 5.

"Concerned thorities to ensure the strict implementation. Homework up to class 5th should be avoided. Authorities and schools should plan joyful learning experience engaging parents as well," he said in another tweet.

Mr Sinha said the children need more time to play and interact with parents which is "the biggest learning experisued by Principal Secretary, School Education Department, BK Singh, said. The teachers have also been asked to occasionally organise brief and casual meetings with the parents and children through video conferencing and give

them a chance to nar-

rate their feelings and

experiences. "Encourage the parent to document the child's work through a photo or a short video in order to stay connected to the child's early learning experience without making it stressful or going for rote learning. Guide parents regarding monitoring TV program viewing, about what cartoons/programs are being watched by children," the guidelines

said. For the senior students, the teachers have been asked to give 10-15 minutes break between two consecutive classes for the students to freshen up, relax and re-energise themselves to focus on the next class.

"Encourage peer discussion and interaction during online classes," they said.

#### "Irrational": SC on Centre's vaccination policy for 18-44 group



NEW DELHI, 02 JUN [NDTV]: The Centre's policy of giving free vaccination to 45-plus age group and a paid system for those below is "prima facie, arbitrary and irrational", the Supreme Court said today in its detailed order on the issue.

Calling the issue of vaccination "absolutely crucial" the court said, "Reports indicate that persons between 18-44 years of age have not only been infected by COVID-19, but have also suffered from severe effects of the infection, including prolonged hospitalisation and, in unfortunate cases, death. Due to the changing nature of the pandemic, we are now faced with a situation where the 18-44 age group also needs to be vaccinated, although priority may be retained between different age groups on a scientific ba-

"Hence, due to the importance of vaccinating individuals in the 18-44 age group, the policy of the Central Government for conducting free vaccination themselves for groups under the first 2 phases, and replacing it with paid vaccination by the State/UT Governments and private hospitals for the persons between 18-44 years is, prima facie, arbitrary and irrational," the order

### To beat Covid, provide universal access to vaccines

ajority of world's population today is plagued by the fear of infection with Corona. ### Indian traders seek import quota to stem influx of soybean oil

KATHMANDU, 02 JUN [KATHMAND**uPost**]: Indian traders have again complained to the Indian government that a huge influx of soybean oil from Nepal in violation of the rules of origin under the South Asian Free Trade Area (SAFTA) was hurting refineries and farmers in India.

SAFTA is the free trade arrangement of the South Asian Association for Regional Cooperation of which Nepal and India are founding members.

The Solvent Extractors' Association of India, one of the oldest organisations of vegetable oil and trade, has asked the Indian government to fix quotas on imports, saying that soybean oil has become Nepal's top export commodity even though the country does not produce it commercially.

According to Nepal's Trade and Export Promotion Centre, soybean oil shipments reached Rs35.75 billion in the first 10 months of the current fiscal year, a year-on-year jump of more than four times.

"Nepal has violated the rules of origin privilege granted under SAFTA," the association said.

Exports of soybean oil amounted to Rs8.36 billion in the first 10 months of the last fiscal year.

The trade data of the Department of Customs showed that Nepal imported crude soybean oil worth Rs39.46 billion in the same period.

Soybean oil exports alone make up 32.96 percent of Nepal's total trade.

The country imported 355.29 million litres of crude soybean oil during the review period. Nepal bought most of its soybean oil from Argentina, Egypt, Paraguay and Ukraine.

In March, following a huge increase in the export of refined soybean oil from Nepal, the Indian government wrote to Nepal's Ministry of Foreign Affairs to "confirm the genuineness and authenticity" of the product originating criteria or the certificate of origin issued by Nepali authorities for the export of edible oil to India under SAFTA.

Dinesh Bhattarai, secretary of the Ministry of Industry, Commerce and Supplies, told the Post that the ministry had replied to most of the issues raised by the Indian government regarding the authenticity of the certificate of origin of the

product through the Foreign Ministry.

He said that his ministry, after a proper study, investigation and discussion with the concerned stakeholders, had sent proof and data regarding the authenticity of the certificate of origin of the product, including the value addition to the product in Nepal. "The ministry has not received any further communication from the Indian government."

Bhattarai said that the export of soybean oil was being done according to international trade norms, but that some traders had been exploiting the zero tariff privilege in a negative way.

"As long as it generates employment by adding some value and helps the government to raise revenue, it is worth trading." Indian traders have the right to raise concerns over the certificate of origin with their government, he added.

A certificate of origin is a document declaring in which country a commodity was produced or manufactured. The paperwork contains information regarding the product, its destination and the country of export.

It is required by many treaty agreements for cross-border trade, and can help determine whether certain goods are eligible for import, or whether goods are subject to duties.

Tariff exemptions on Nepali exports to India under the SAFTA agreement give domestic traders an advantage. Countries outside of South Asia are slapped with tariffs of 54 percent on palm oil and 45 percent on soy-

A proof of origin is required to claim preferential tariff treatment. The government has authorised three associations—the Federation of Nepalese Chambers of Commerce and Industry, Confederation Nepalese Industries and Nepal Chamber of Commerce—to issue the certificate of origin.

The Solvent Extractors' Association of India said that massive imports of soybean oil from Nepal was hurting refiners in eastern and northern India and Indian farmers, besides incurring loss of revenue to the government.

"It is harming the interests of oilseed farmers as it distorts the domestic market. Thus, the very purpose of keeping import duties on edible oils is getting negated," the association said.

### **Drought in the Rainforest**

#### Prepare better for Climate Change

NASA-led study has revealed that more than 7,00,000  $oldsymbol{A}$ sq km of Amazon rainforest has been hit hard by a mega-drought that began in 2005 and caused widespread damage to the canopy that blankets the dense vegetation.

Drought in the rainforest!

Climate Change anyone?

What has happened in the Amazon rainforest could be a localised cyclical climate-related blip or part of a larger climate change impact. Either way, it is important enough to have NASA tracking it and keeping the region and world informed. That's a start. But what about corners as small as

Against the 7 crore hectares affected in the Amazon, Sikkim spreads out a mere 7 lakh hectares. It is unlikely that the impact of climate change or droughts or extreme weather conditions here will flash on the monitors of anyone tracking such events. But the signs are there for all to see. Winters have not been normal in recent years, recording at either too wet or too dry; so dry two years back that the Rabi crops in fields which depend on winter rains and receiving inundation so unhealthy that crops rotted away. The monsoons, after the Met offices vacillated between normal to above average predictions and verdicts, will likely be heavy this year, and most definitely erratic, coming too early or arriving too late.

For those who see these as cyclical events, there are other signs like areas in Sikkim which received only snowfall, now also receiving frequent rainfall; glaciers which used to course kilometres into valleys now having retreated as hanging glaciers leaving behind only scree and debris.

This last reference was experienced firsthand by mountaineers attempting the Zemu Gap in West Sikkim some years back. Relying on surveyor notes from around 80 years ago, they realised that glaciers across which the pioneers had walked across had now receded, leaving a nearly kilometre deep scar of extremely fragile rocks and unstable blocks which were now impossible to navigate. This has to be a result of climate change. Not that this phenomenon requires any reiteration since the discourse has already moved on to preparedness.

To Sikkim's credit, it has a department dedicated to Climate Change [the Department of Science & Technology now includes for Climate Change in its name]. Unfortunately, while recognition of climate change as a major future challenge has been taken at the policy level, at the executive level, nothing has changed. Sikkim's understanding of climate change is no better than any person with access of the internet or relevant literature. Worse still, the impact of climate change on Sikkim has neither been studied nor shared. Unless the impact of climate change is explained with 'local' references to the stakeholders, the policy directives and preparedness plans will not succeed. Sikkim had commissioned a study of its glaciers, and while some references have been made to the findings, the final report has not been shared in the public domain yet. As everyone knows, the study of glaciers can provide important insights into climate change impact. Sikkim has already committed itself to prepare better for climate change; as already shared, no one else is going to help Sikkim study or prepare. It will have to do so itself, hence the sooner the available data is shared with the stakeholders, the faster will the analysts be able to make sense of it and put things in perspective and the quicker Sikkim can expect to start, well, preparing better for climate change...

### The Next Pandemic is Already Happening -Targeted Disease Surveillance Can Help Prevent It

s more and more people around **A**the world are getting vaccinated, one can almost hear the collective sigh of relief. But the next pandemic threat is likely already making its way through the population right now.

My research as an infectious disease epidemiologist has found that there is a simple strategy to mitigate emerging outbreaks: proactive, real-time surveillance in settings where animal-to-human disease spillover is most likely to occur.

In other words, don't wait for sick people to show up at a hospital. Instead, monitor populations where disease spillover actually happens.

THE CURRENT PANDEMIC PRE-**VENTION STRATEGY** 

Global health professionals have long known that pandemics fueled by zoonotic disease spillover, or animal-to-human disease transmission, were a problem. In 1947, the World Health Organization established a global network of hospitals to detect pandemic threats through a process called syndromic surveillance. The process relies on standardized symptom checklists to look for signals of emerging or reemerging diseases of pandemic potential among patient populations with symptoms that can't be easily diagnosed.

This clinical strategy relies both on infected individuals coming to sentinel hospitals and medical authorities who are influential and persistent enough to raise the alarm.

There's only one hitch: By the time someone sick shows up at a hospital, an outbreak has already occurred. In the case of SARS-CoV-2, the virus that causes COVID-19, it was likely widespread long before it was detected. This time, the clinical strategy alone failed us.

ZOONOTIC DISEASE SPILLOVER IS NOT ONE AND DONE

A more proactive approach is currently gaining prominence in the world of pandemic prevention: viral evolutionary theory. This theory suggests that animal viruses become dangerous human viruses incrementally over time through frequent zoonotic spillover.

It's not a one-time deal: An "intermediary" animal such as a civet cat, pangolin or pig may be required to mutate the virus so it can make

initial jumps to people. But the final host that allows a variant to become fully adapted to humans may be humans themselves.

Viral evolutionary theory is playing out in real time with the rapid development of COVID-19 variants. In fact, an international team of scientists have proposed that undetected human-to-human transmission after an animal-to-human jump is the likely origin of SARS-CoV-2.

When novel zoonotic viral disease outbreaks like Ebola first came to the world's attention in the 1970s, research on the extent of disease transmission relied on antibody assays, blood tests to identify people who have already been infected. Antibody surveillance, also called serosurveys, test blood samples from target populations to identify how many people have been infected. Serosurveys help determine whether diseases like Ebola are circulating

Turns out they were: Ebola antibodies were found in more than 5% of people tested in Liberia in 1982, decades before the West African epidemic in 2014. These results support viral evolutionary theory: It takes time - sometimes a lot of time - to make an animal virus dangerous and transmissible between humans.

What this also means is that scientists have a chance to intervene.

MEASURING ZOONOTIC DIS-EASE SPILLOVER

One way to take advantage of the lead time for animal viruses to fully adapt to humans is long-term, repeated surveillance. Setting up a pandemic threats warning system with this strategy in mind could help detect pre-pandemic viruses before they become harmful to humans. And the best place to start is directly at the source.

My team worked with virologist Shi Zhengli of the Wuhan Institute of Virology to develop a human antibody assay to test for a very distant cousin of SARS-CoV-2 found in bats. We established proof of zoonotic spillover in a small 2015 serosurvey in Yunnan, China: 3% of study participants living near bats carrying this SARS-like coronavirus tested antibody positive. But there was one unexpected result: None of the previously infected study participants reported any harmful health effects. Earlier spillovers of SARS coronavi-

ruses – like the first SARS epidemic in 2003 and Middle Eastern Respiratory Syndrome (MERS) in 2012 had caused high levels of illness and death. This one did no such thing.

Researchers conducted a larger study in Southern China between 2015 and 2017. It's a region home to bats known to carry SARS-like coronaviruses, including the one that caused the original 2003 SARS pandemic and the one most closely related to SARS-CoV-2.

Fewer than 1% of participants in this study tested antibody positive, meaning they had been previously infected with the SARS-like coronavirus. Again, none of them reported negative health effects. But syndromic surveillance - the same strategy used by sentinel hospitals - revealed something even more unexpected: An additional 5% of community participants reported symptoms consistent with SARS in

This study did more than just provide the biological evidence needed to establish proof of concept to measure zoonotic spillover. The pandemic threats warning system also picked up a signal for a SARSlike infection that couldn't yet be detected through blood tests. It may even have detected early variants of SARS-CoV-2.

Had surveillance protocols been in place, these results would have triggered a search for community members who may have been part of an undetected outbreak. But without an established plan, the signal was missed.

FROM PREDICTION TO SUR-VEILLANCE TO GENETIC SEQUENC-ING

The lion's share of pandemic prevention funding and effort over the past two decades has focused on discovering wildlife pathogens, and predicting pandemics before animal viruses can infect humans. But this approach has not predicted any major zoonotic disease outbreaks including H1N1 influenza in 2009, MERS in 2012, the West African Ebola epidemic in 2014 or the current COVID-19 pandemic.

Predictive modeling has, however, provided robust heat maps of the global "hot spots" where zoonotic spillover is most likely to occur.

Long-term, regular surveillance at these "hot spots" could detect spillover signals, as well as any changes that occur over time. These could include an uptick in antibody-positive individuals, increased levels of illness and demographic changes among infected people. As with any proactive disease surveillance, if a signal is detected, an outbreak investigation would follow. People identified with symptoms that can't be easily diagnosed can then be screened using genetic sequencing to characterize and identifv new viruses.

This is exactly what Greg Gray and his team from Duke University did in their search for undiscovered coronaviruses in rural Sarawak, Malaysia, a known "hot spot" for zoonotic spillover. Eight of 301 specimens collected from pneumonia patients hospitalized in 2017-2018 were found to have a canine coronavirus never before seen in humans. Complete viral genome sequencing not only suggested that it had recently jumped from an animal host - it also harbored the same mutation that made both SARS and SARS-CoV-2 so deadly.

LET'S NOT MISS THE NEXT PAN-**DEMIC WARNING SIGNAL** 

The good news is that surveillance infrastructure in global "hot spots" already exists. The Connecting Organisations for Regional Disease Surveillance program links six regional disease surveillance networks in 28 countries. They pioneered "participant surveillance," partnering with communities at high risk for both initial zoonotic spillover and the gravest health outcomes to contribute to prevention

For example, Cambodia, a country at risk of pandemic avian influenza spillover, established a free national hotline for community members to report animal illnesses directly to the Ministry of Health in real time. Boots-on-the-ground approaches like these are key to a timely and coordinated public health response to stop outbreaks before they become pandemics.

It is easy to miss warning signals when global and local priorities are tentative. The same mistake need not happen again.

### Why are there so many text scams all of a sudden?

Anew "fraud wave" has been reported in the UK, targeting mobile phone users with texts that, at first glance, appear to be from delivery companies or government institutions.

You may even have been targeted by the text scams yourself, which often ask you to pay missed delivery charges or tax fees and are sent from numbers that claim to belong to Royal Mail, Hermes or HMRC.

While these scams are actually nothing new, there does appear to have been a sudden and dramatic increase in their volume in recent weeks, coming after the recent spike in coronavirus vaccine scams and scams targeting those seeking to buy a pet online during the pandemic.

The resurgence of text scams in the spring of 2021 also appears to be taking advantage of circumstances brought about by the pandemic - but learning more about them can help us to stamp them out.

**INCREASING TEXT SCAMS** 

To understand the apparent increase in text scams, we need to consider two key factors. The first is timing. Missed delivery charge scams are most often rolled out around the busy Christmas postal period, while tax scams are usually timed around April to coincide with the new financial year.

The pandemic has extended the window of opportunity for fraudsters to successfully target people with both types of scam. More of us are expecting a parcel in the post after increasing our online shopping since March 2020, while novel financial measures related to the pandemic, such as the furlough scheme, may have given people the impression that HMRC has temporarily altered its operations.

The second factor is volume. These types of scams are delivered en masse, and fraudsters only need to receive responses to a handful of the thousands of texts they send out to make significant sums of money.

That's not because of the money they're

asking people to send them – which appears tiny in the case of a £1.43 delivery fee - but because criminals can use the card details they're provided to empty victims' bank accounts. Other text scams, which prompt you to click on a link, are designed to infect your phone with malware that can help criminals steal your personal data.

The increasing volume of these scams suggests that they do work. And because their success encourages "copy cat" scams, with new criminal groups experimenting with their own text scams, it's difficult to stamp them out entirely, despite recent arrests. The best way to counter these scams is to reduce their success rate, and we can do this by making the public aware of how and why text scams work.

WHY DO WE FALL FOR TEXT SCAMS?

Despite the apparent crudeness of these fraudulent messages, which often feature misspellings or incorrect grammar, they take advantage of timeworn techniques that exploit our psychological vulnerabilities. The aim is to encourage us to respond on impulse rather than thinking through whether we may be being scammed.

Exploiting emotion is the main method used by scammers to achieve this. The delivery charge scam, for instance, often threatens a loss if you don't immediately pay for redelivery, with fraudsters issuing a tight deadline before they claim your parcel will be returned to its sender. Emotions such as fear, panic and anxiety can cause us to respond impulsively to scam messages.

On the other hand, positive emotions, such as excitement or hope, can also bias our judgement and encourage impulsive behaviour. The HMRC tax refund scam is built on the promise of financial gain if you click on a link - but instead of transferring you cash, the link is built to facilitate phishing that gives criminals access to your personal data or bank

People are far more likely to fall for this scam if they've already received a genuine communication from HMRC that they're due a tax refund. Psychologists refer to this feeling as "illusory

correlation", which happens when we see events as linked when they're not. Illusory correlation tends to confuse or relax our natural caution,

making us more vulnerable to scams. WHO ARE SCAMMERS TARGETING?

Anyone can fall victim to scams. Contrary to popular opinion, older people are not more likely to be victims of text scams, partially because many older people may be less likely to bank and shop online, have dealings with HMRC, or even

use mobile phones. It's the use of mobile devices for these textbased scams that may actually make younger people more susceptible. While we're somewhat used to scam emails, scam texts are relatively new. Texts also feel more intimate we expect them to be from people we know, or from institutions we've trusted with our mobile number. And we often access texts on the go, when we're busy or distracted and less likely to question their veracity.

To avoid falling victim to text scams, we suggest you take a few simple steps before choosing to respond. First, make sure you take some time to properly look at the content of any message you receive. Any written message containing email addresses, phone numbers or language errors could help you spot a scam.

If you can't spot any blatant errors, just wait - even for a few minutes - before responding. This will allow you time to think whether it's normal for a company to commu-

nicate with you via text. For delivery scams in particular, which are currently surging in the UK, it's well worth interrogating everything about the text you receive. Checking websites for the delivery companies they use, or even making a quick call to the delivery company the text claims to be from, can help clear things up. And at the end of the day, it's better to miss your parcel than to lose thousands of pounds to scam artists.

### Mizoram logs 235 new COVID-19 cases, 4 more deaths

AIZAWL, JUN 2 (PTI): Mizoram on Wednesday reported 235 new COVID-19 cases, taking the state's tally to 12,634, official sources said.

The state also reported four more COVID-19 deaths on Tuesday, which took the death toll to 44 on Wednesday, the state information and public relations department said in its official Twitter handle.

At least 3,752 new samples were tested for COVID-19 in the last 24 hours and 6.26 per cent of them came out positive for COVID-19, the department said.

Of the 235 fresh cases, Aizawl district registered the highest at 164, followed by Lawngtlai district, which reported 20 cases, it said.

The remaining cases were from Lunglei district (18), Serchhip district (5), Kolasib district (18), Siaha district (3), Khawzawl district (5), Champhai district (1) and Mamit district (1).

More than 41 children were among the newly infected people, it

Seven patients have travel history while the rest 228 patients were found to have locally contracted the infection, it said, adding that 139 patients have developed symptoms of COVID-19.

Mizoram currently has 3,243, active COVID-19 cases while 9,347 people have recovered from the infection.

At least 133 people were discharged from various Covid-19 care centres on Tuesday.

The state has so far tested 3,97,433 samples for COVID-19 till date.

According to state immunisation officer, Dr Lalzawmi, as many as 2,59,498 people have been administered the first dose of Covid-19 vaccine of which 52,121 people have received both doses till Tuesday.



## **Tathagata Roy to present** report on BJP's Bengal defeat

# South America restarts World Cup qualifying amid COVID rise

BUENOS AIRES, JUN 2 (AP): South American World Cup qualifiers resume on Thursday after a seven-month interruption caused by the COVID-19 pandemic, though that doesn't mean the virus has waned in the region.

Top-of-the-table Brazil and second-place Argentina could take decisive steps in the next two rounds to assure somewhat calm pathways to Qatar, while Peru, which made it to Russia three years ago but now has one point after four matches, is already fighting to survive.

The latest rounds of South American World Cup qualifiers were in November. More games scheduled to be played in March were postponed when clubs of other confederations refused to allow their players to travel due to the pandemic.

The top four teams will automatically qualify. The fifth-place squad will go into an inter-continental playoff. The current standings show Brazil (12 points), Argentina (10), Ecuador (9) Paraguay and Uruguay (6) in those spots.

The two rounds will also be preparatory for this month's Copa Amer-



ica, which will now be hosted by Brazil after Argentina was dropped because of the spread of COVID-19 in that country, even though analysts expect another wave of the virus to hit Brazil by

BRAZIL vs ECUADOR It will be the only match of the fifth round on Friday.

Brazil coach Tite said in a mid-May press conference that the halt in South American qualifiers will affect all South American teams, both in the short and long run.

competitiveness high up, he said before the clash with Ecuador's pragmatic team of Argentinian coach Gustavo Alfaro.

host of Copa America due to the pandemic, Argentina will try to lift some spirits at home against Chile (4 points), now under Uruguayan coach Mart n Lasarte.

Striker Sergio Ag ero, newly signed to Barcelona, will be back to the squad after several absences due to injury. Coach Lionel Scaloni, though, has shown he prefers Lautaro Mart nez up front with captain Lionel Messi.

Chile lost midfielder Arturo Vidal to COVID-19 only two days before the clash against its rival. The same reason forced Lasarte to leave defender Paulo D az out.

Ben Brereton, a 22-year-old striker, will be the new element in Chile's squad. His father is English and his mother is Chilean.

PERU vs COLOMBIA Both teams made it to the World Cup in 2018 and both need to win to

# Absent Ramos still attracting attention ahead of Euro 2020

MADRID, JUN 2 (AP): For the first time in 15 years, Spain finds itself preparing for a major tournament without Sergio Ramos.

The veteran defender, however, is still attracting much of the attention ahead of the European Championship as Spain starts its preparations in Madrid.

Sergio Ramos has always been with the national team, so it's a bit strange that he isn't here now, KokeResurrecci in said Tuesday at the team's training camp.

Ramos had been with La Roja for every major tournament since the 2006 World Cup, having first made the senior team in 2005 at age 18. He was a surprising absence for the Euro 2020 squad despite a season plagued by injuries. Coach Luis Enrique decided to leave the veteran captain off his list because of a lack of play in

recent months.

The 35-year-old Ramos missed most of the second half of the season with Real Madrid after a series of muscle injuries and a knee problem that required surgery. He also tested positive for COVID-19 in April, but was expected to be injury free by the time Euro

Many in Spain criticized Luis Enrique for leaving the star defender out, especially because the coach decided not to use two of the 26 spots available, with Ramos potentially benefiting the squad with his experience and leadership even if he wasn't fully fit.

In the end, these decisions are made by the coach, he is the one who announces the list, said Koke.

It wasn't only Sergio Ramos who was left out, but also other very important players for their clubs, and other very important players for Spain. We have to respect these decisions.

Luis Enrique said he didn't want to pick a full complement of 26 players because some wouldn't end up being used at all.

Players from Manchester City and Chelsea, which contested Saturday's Champions League final, were scheduled to arrive on Wednesday.

### Osaka steps out of French Open and onto sport's third rail

PARIS, JUN 2 (AP): Most athletes are comfortable talking about injuries, so long as they can point to a bruise, a bandage, a cast or a spot on an X-ray. Some will even venture an educated guess at how long they might take to heal. Their mental health is a different story.

Or at least it was before Naomi Osaka ended a damaging standoff with top tennis officials by withdrawing from the French Open earlier this week, citing concerns for her well-being.

It marked the first time a major star walked away from a major tournament without a visible injury. Judging by the reaction, it appeared Osaka landed on the third rail of sports.

Other athletes, notably Olympian Michael Phelps, spoke candidly about mental-health issues before. Some, like Los Angeles Lakers great Jerry West, detailed their struggles in books only after their playing days were long over. Still others wrestled that tortured secret for a lifetime.

None of them sparked a conversation this wide, in no small part because of what was at stake and a very public back-and-forth that played out on social media. How much more oxygen it draws going forward likely depends on Osaka, already a four-time major champion at age 23; whether more athletes follow her lead; and if so, how fans and the sports establishment react.

When someone tears an ACL, it's 6-8 months, we know the time frame. And like with everything



else in life, we want a finite number. But that's not how mental health works, said Dr. Wendy Borlabi, a Chicago-based performance psychologist who works with pro, Olympic and college athletes.

People are different, we experience things differently, but we all want the process to say, This is what you do to get better.' It's not that simple. There's no one-size-fits-all,' she continued.

But the more we talk about mental health in the open, the more we put the stigmatism behind us, especially in sports. This is a big opportunity.

There's a long list of athletes who could have benefitted from the chance. Some may still.

In recent years, NBA players Kevin Love and DeMarDeRozan and the WNBA's A'ja Wilson have spoken very publicly about their bouts with depression, sharing both the successes and setbacks.

certain age remember the late Jimmy Piersall, portrayed in the move Fear Strikes Out, and whose 17-year major league career was littered with well-publicized fistfights, scrapes and stunts all while he was battling bipolar disorder.

Piersall parlayed his relative fame into a second career in broadcasting and scouting, suggesting that some of the stunts he pulled were just that stunts to fulfill the public's perception of him.

Probably the best thing that ever happened to me was going nuts, he wrote in his autobiography.

Who ever heard of Jimmy Piersall until that happened? Mental-health spe-

cialists who work in sports remind the rest of us that the visibility afforded athletes is both a blessing and a curse. There's precious little privacy, and every doctor's note seeking time off scrutinized like a tax return. Imag-

ine having a bad day at work and then sitting down in front of a dozen microphones to explain in detail how and why it happened, over and over.

That's why those same specialists note that by the time an athlete is acting out, the injury has already occurred.

That's the challenge with mental health in sports, said Dr. Ross Flowers, a San Diego based sports psychologist whose client list also includes Olympians and several pro and college teams.

Athletes get attention precisely because they're above average, and sometimes it's easy to forget they're humans first. They're supposed to be dominant and not show vulnerability, yet in most cases we don't learn they're struggling until it shows up in their behavior, he added.

That's why what Naomi did was brave. She was proactive. She recognized something was holding her back and said, I want to be at my best and I can't be that at the moment.'

Whether Osaka's example and a growing public awareness about mental health issues encourage athletes facing similar problems to more forcefully speak out, the people running sports would do well to prepare.

While most of Osaka's contemporaries defended the requirement that players engage with the media to help grow the game, no more than a handful actually enjoy the give-and-take dynamic.

And right on time came further proof that media obligations can be damaging to a player's health. No. 11 seed Petra Kvitova, herself a two-time major champion, announced she, too, had withdrawn from the tournament after falling and twisting her ankle on the way back from what else? my post-match press requirements.

# No better preparation for Ashes than clean sweep against India, NZ: Root



London, Jun 2 (PTI): England skipper Joe Root says a clean sweep against the top two sides in Test cricket -- India and New Zealand -- will be the best preparation for the iconic Ashes series against arch rivals Australia later this year.

Before heading to Australia for the Ashes in the winter, England play seven Tests at home against New Zealand and India this summer.

They will take on the Blackcaps for a twomatch red-ball series, starting Wednesday and then clash with India in a five-Tests series across August and September.

"There are going to be constant conversations about Australia throughout this whole summer, there is no getting away from that," Root told reporters on Tuesday ahead of the series-open-

"We have said for a long time now that we are planning towards that series and as an English fan, an English player, it is such an iconic series.

"It is of utmost importance, absolutely. But the way we are best going to prepare ourselves is by performing well in these seven Tests, by winning seven Test matches against the best two sides in the world," he added.

New Zealand and India are slated to take on each other in the inaugu-

ral World Test Championship final scheduled to be held in Southampton from June 18-22.

Although planning to regain the Ashes will remain in the back of the mind, Root said the full focus will be to have successful summer.

"Planning for Australia is something in the background, it's something we are very aware of and consistently talk about. But that won't be in our thoughts when we are out there this summer.

"You couldn't be asking for two better opponents right now - to take on the best is what sport is all about and every Test means a hell of a lot to our players and to me. These Tests are our full focus.

# Australian power generator takes Greenpeace to court

(AP): Australia's largest electricity generator AGL Energy took Greenpeace to court on Wednesday alleging breaches of copyright and trademark laws in the environmental group's campaign describing AGL as the nation's "biggest climate polluter."

Greenpeace Australia Pacific has accused AGL, which predominantly generates coal-fired electricity, of "greenwashing" by promoting itself as a leading investor in renewable energy.

AGL has targeted in the Federal Court Greenpeace's use of its logo in an online advertising campaign featuring the slogan, "AGL - Australia's Greatest Liability."

Greenpeace lawyer Katrina Bullock said the lawsuit was an example of a "fossil fuel" company using the law to try "intimidate their critics."

AGL unsuccessfully applied for an interim court order in early May that would have forced Greenpeace to stop using

Greenpeace argues that Australian trademark law allows for the logo to be used for satire, parody and criticism.

AGL lawyer Megan Evetts told the court there was a "clear intention to harm the brand" through the Greenpeace campaign. The court must decide whether Greenpeace owed AGL damages, she said.

"AGL is not seeking to stifle public debate. What it is seeking to do is protect itself, protect its intellectual property rights," Evetts said.

Greenpeace lawyer Neil Murray told the court the campaign did not breach the law because it did not use the AGL trademark in a trade context and its motives were "pure."

"The conduct of the campaign to cause people to be critical of AGL for continuing to operate coal until 2048 in the hope that that criticism will create pressure on AGL to change is a legitimate goal: initiating public debate for a beneficial cause," Murray said. "To punish a charity for doing that would be unjust."

AGL accepted in its

latest annual report that it was Australia's largest greenhouse gas emitter with plans to continue generating electricity by burning coal until 2048, Murray said.

"This is not a frolic invented by Greenpeace. This is a serious issue, the dynamics of which are recognized by AGL in its own documents," Murray said.

The campaign was aimed at ending Australian reliance on coal-fired power by 2030 as recommended by the Intergovernmental Panel on Climate Change.

"It's not . . . an exercise in gratuitous denigration of AGL, it's not about trying to inflict maximum harm to them," Murray said. "It's a socially responsible campaign addressed to a very specific issue based on international research."

AGL lawyer John Hennessy said the campaign involved the "wholesale reproduction of the logo" and could not be considered satirical.

Greenpeace campaigner Glenn Walker described the amended AGL logo used in his

campaign as a parody. Under questioning by Hennessy, Walker denied that the aim of the campaign was to persuade AGL to change its policy through a loss of

Walker said Greenpeace advised AGL customers to write messages on social media pages, send emails to the AGL chief executive and telephone AGL's customer service center to raise concerns about the company's climate

clear in our communication with any AGL customers that we'd actually prefer them to engage with the company because we think that has greater impact in this campaign," Walker said.

Walker did not accept Hennessy's proposition that Greenpeace considered AGL a "villain."

"We regard them as a temporary villain," Walker said. "Because many of the companies that we target through our campaigning end up becoming quite good corporate players and we congratulate them for that."

"Ultimately the purpose of the campaign is to get them to shut down their coal-burning power stations and to become a renewable energy leader" he added.

Australia's Clean Energy Regulator confirms that AGL is the nation's largest greenhouse gas polluter, accounting for 8% of the nation's total emissions.

Justice Stephen Burley said at the end of the one-day hearing that he would deliver his verdict at a later date.

### Malaysia to summon Chinese envoy over jets intrusion

KUALA LUMPUR, JUN 2 (AP): Malaysia's government will issue a diplomatic protest against an intrusion" by 16 Chinese military aircraft into its airspace, the foreign minister said.

Minister Foreign Hishammuddin Hussein said late Tuesday that he will summon the Chinese ambassador to explain this breach of the Malaysian airspace and sovereignty."

Malaysia's air force said its radar picked up the Chinese aircraft Monday near Malaysian-administered Luconia Shoals, a rich fishing ground in the disputed South China Sea.

The Chinese planes then moved nearly 60 nautical miles (110 kilometers) off the coast of Sarawak on Borneo is-

After attempts to contact the aircraft failed, the air force sent its fighter planes to identify them. It said they were Ilyushin Il-76 and Xian Y-20 strategic transporters, flying at between 23,000-27,000 feet (7,000-8,000 meters) altitude typically used by commercial flights. Malaysia called the incident a serious threat to national sovereignty and flight safety."

Malaysia's stand is clear having friendly diplomatic relations with any countries does not mean that we will compromise our national security," Hishammuddin said in a statement. He said he will relay Malaysia's serious concern on the matter to his Chinese counterpart.

There was no reaction from Beijing.

China claims almost the entire South China Sea on historic grounds. Brunei, Malaysia, the Philippines, Taiwan and Vietnam also have overlapping claims, and tensions have ramped up since China built several man-made islands and turned them into military outposts.

The strategically important area straddles some of the world's busiest sea lanes and is also rich in fisheries and may hold underground oil

and natural gas reserves. Malaysia says Chinese coast guard and navy ships intruded into its waters in the South China Sea 89 times between 2016 and 2019. Malaysia has filed six diplomatic protests to China, including one in 2017 in response to a Chinese note asserting its claim to the South Luconia Shoals.

### Iran's largest warship catches fire, sinks in Gulf of Oman

TEHRAN, IRAN (AP): The largest warship in the Iranian navy caught fire and later sank Wednesday in the Gulf of Oman under unclear circumstances, semiofficial news agencies reported. The Fars and Tasnim news agencies said efforts failed to save the support warship Kharg, named after the island that serves as the main oil terminal for Iran.

The blaze began around 2:25 a.m. and firefighters tried to contain it. Fars said. The vessel sank near the Iranian port of Jask, some 1,270 kilometers (790 miles) southeast of Tehran on the Gulf of Oman near the Strait of Hormuz the narrow mouth of the Persian Gulf.

Photos circulated on Iranian social media of sailors wearing life jackets evacuating the vessel as a fire burned behind them. State TV and semiofficial news agencies referred to the Kharg as a "training ship." Fars published video of thick, black smoke rising from



the ship early Wednesday morning.

Satellite photos from Planet Labs Inc. analvzed by The Associated Press showed the Kharg off to the west of Jask on Tuesday. Satellites from the U.S. National Oceanic and Atmospheric Administration that track fires from space detected a blaze at the site of the Jask that started just before the time of the fire reported by Fars.

The Kharg serves as one of a few vessels in the Iranian navy capable of providing replenishment at sea for its other ships. It also can lift heavy cargo and serve as a launch point for helicopters. The warship, built in Britain and launched in 1977, entered the Iranian navy in 1984 after lengthy negotiations that followed Iran's 1979 Islamic Revolution.

Iran's navy typically

handles patrols in the Gulf of Oman and the wider seas, while the country's paramilitary Revolutionary Guard operates in the shallower waters of the Strait of Hormuz and the Persian Gulf. In recent months, the navy however. launched a slightly larger commercial tanker called the Makran it converted into serving a similar function as the Kharg. Iranian officials of-

fered no cause for the fire aboard the Kharg. However, it comes after a series of mysterious explosions that began in 2019 targeting ships in the Gulf of Oman. The U.S. Navy later accused Iran of targeting the ships with limpet mines, timed explosives typically attached by divers to a vessel's

Iran denied targeting the vessels, though

Navy footage showed Revolutionary Guard members removing one unexploded limpet mine from a vessel. The incidents came amid heightened tensions between the U.S. and Iran then-President Donald Trump unilaterally withdrew America from Tehran's nuclear deal with world powers.

In April, an Iranian ship called the MV Saviz believed to be a Guard base and anchored for years in the Red Sea off Yemen was targeted in an attack suspected to have been carried out by Israel. It escalated a yearslong shadow war in Mideast waters between the two coun-

The sinking of the Kharg marks the latest naval disaster for Iran. In 2020 during an Iranian military training exercise, a missile mistakenly struck a naval vessel near the port of Jask, killing 19 sailors and wounding 15. Also in 2018, an Iranian navy destroyer sank in the Caspian Sea.

### Russian upper house votes to exit from overflight treaty

MOSCOW (AP): The Russian parliament's upper house voted Wednesday to withdraw from an international treaty allowing surveillance flights over military facilities following the U.S. exit from the treaty.

The vote comes after U.S. officials told Moscow last month that President Joe Biden's administration had decided not to reenter the Open Skies Treaty, which had allowed surveillance flights over military facilities before President Donald Trump withdrew from the pact.

As a presidential candidate, Biden had criticized Trump's withdrawal as "short-sighted." Moscow has signaled its readiness to reverse the withdrawal procedure and stay in the 1992 treaty if the United States returns to the agreement. After the Russian up-

per house voted to leave the treaty, it would now come to Russian President Vladimir Putin for signing. If Putin endorses the exit, it would take effect in six months.

Putin and Biden are to have a summit in Geneva on June 16. The meeting comes as Russia-U.S. ties have sunk to the lowest levels since the Cold War times after Russia's 2014 annexation of Ukraine's



Crimean Peninsula, the accusations of Moscow's interference in U.S. elections, hacking attacks and other irri-

The Open Skies Treaty was intended to build trust between Russia and the West by allowing the accord's more than three dozen signatories to conduct reconnaissance flights over each other's territories to collect information about military forces and activities. More than 1,500 flights have been conducted under the treaty since it took effect in 2002, aimed at fostering transparency and allowing for the monitorother agreements. Trump pulled out of

the pact last year, arguing that Russian violations made it untenable for Washington to remain a party. Washington completed its withdrawal from the treaty in November.

Moscow has deplored the U.S. withdrawal, warning that it will erode global security by making it more difficult for governments to interpret the intentions of other nations, particularly amid heightened Russia-West tensions.

The European Union has urged the U.S. to reconsider its exit and called on Russia to stay

ing of arms control and in the pact and lift flight restrictions, notably over its westernmost Kaliningrad region, which lies between NATO allies Lithuania and Poland.

Russia has insisted the restrictions on observation flights it imposed in the past were permissible under the treaty and noted that the U.S. imposed more sweeping restrictions on observation flights over Alaska. As a condition for

staying in the pact after the U.S. pullout, Moscow has unsuccessfully pushed for guarantees from NATO allies that they wouldn't hand over the data collected during their observation flights over Russia to the U.S.

**NEW YORK (AP)**: Kelly Osbourne is opening up about her battles with drug and alcohol addiction, stopping by "Red Table Talk" to discuss getting hooked as a teen and relapsing after the pandemic.

The TV personality said she ended almost four years of sobriety in in April 2021 as the COVID-19 pandemic was waning, triggered into drinking alcohol again after seeing a couple sipping champagne.

"I was alone, sitting by a pool and waiting for somebody to come have a meeting with me. And I saw this woman and her husband had a glass of champagne. It looked really nice and I was like, 'I can do that, too,'" she said on the Facebook Watch show. "And the next day, I had two glasses. And the day after that, it was bottles."

Osbourne's episode of "Red Table Talk" airs on Facebook Watch on Wednesday at 9 a.m. PDT/noon EDT.

Osbourne also told the hosts — Jada Pinkett Smith, her daughter, Willow Smith; and her mother, Adrienne Banfield-Norris — about the origins of her addictions.

Her first opiate-based drug addiction was with Vicodin which was prescribed to her after an operation to remove her tonsils when she was 13, sending her on a lifelong battle. "That was all I needed," she said sadly.

Osbourne said the drug silenced her insecurities. "It felt like life gave me a hug." Pinkett Smith responded wryly: "Vicodin will do that." Osbourne added that Vicodin led to her misusing Percocet to eventually heroin "because it was cheaper."

Osbourne has discussed her drug and alcohol battles before in several interviews, her 2017 memoir and on podcasts like Dax Shepard's "Armchair Expert."

She has said her drug use became the heaviest during her mother's cancer battle and after her father, "Crazy Train" singer OzzyOsbourne, almost died after an ATV accident in 2003.

"Red Table Talk" has recently made headlines with its interview with Olivia Jade Gianulli and when Pinkett Smith and her husband, Will Smith, discussed their marriage.

### **Producers' body to conduct free** vaccination for 500 members

MUMBAI, JUN 2 (PTI): Indian Motion Picture Producers' Association (IMPPA) will organise a free coronavirus vaccine drive for 500 of its members this month on a "firstcome-first-served" basis, the film body announced Wednesday.

The association, which has 6,000 members, will set up a camp at its Andheri (West) office here on June 15 or June 16.

"All members including those who are facing financial problems... requesting them to fill enclosed form with the Aadhaar card and personal phone number. (It) must be sent immediately on reading this message because entry will be on first come first served basis for the first 500 members," T P Aggarwal, president of IMPPA, said in a statement.

Members who want their spouses to be vaccinated can do so by paying Rs 1,000 per person in advance at the time of filling up the form, Aggarwal added.

The producers, whose membership was valid till 2005, are also eligible for the vaccination drive, he said.

Last month, IMPPA wrote to Maharashtra Chief Minister Uddhav Thackerav to set up a vaccination centre for its members.

On Monday, the Producers Guild of In-

dia (PGI), the association of Indian film, television and digital content producers, announced a vaccination drive for its members and associated production crews beginning Tuesday.

Recently, producer SajidNadiadwala also held a vaccination drive for over 500 of his employees and their families.

The central government launched the nationwide drive in March this year to vaccinate everyone above 60 years of age and those aged between 45 and 59 with co-morbidities.

From May 1, the central and state governments started vaccinating people aged between 18 and 44.

Maharashtra on Tuesday recorded 14,123 new COVID-19 cases, the lowest since March 10, taking the caseload to 57,61,015, while the fatality count increased to 96,198.
