Prof Lama has served an earlier stint, from 2000 to 2007, as the chief economic advisor to the State Government.

The honorary post carries the status of a Cabinet Minister and extends Prof Lama a contingency grant of Rs 60,000 to meet the expenses of secertarial assistance, office, research support and miscellaneous expenses.

he State Government effected 70 trans-**▲** fers in the HRDD on 25 July. Out of the 70, 37 are teachers and other staff of Government schools. Teachers who had been earlier transferred on deputation to other departments have been repatriated back as teachers. On the other hand, teachers have been transferred on deputation to other departments, many of whom have taken up the posts vacated by the repatriated teachers. The post of MVIs and inspectors in other departments like Agriculture appear to be favoured heavily in this round of transfers. It is interesting that while teacher transfers are primarily the domain of HRDD, this set of transfers has been notified by the Department of Personnel, a requirement necessitated perhaps by the fact that these are inter-departmental rearrangements.

The tiger was spotted at an altitude of 3600 metres above sea level through camera traps set up by World Wildlife Fund as part of its special High Altitude Tiger Project under the National Tiger Conservation Authority. ok Sabha election **⊿**2019 recorded the highest number 18,02,646 Service Electors who were sent postal ballots electronically using the flagship IT programme of Election Commission of India, known as Electronically Transmitted Postal Ballot System (ETPBS), as per the Election Commission of India.

The Service Electors were enrolled as Service Electors through online registration with the dedicated portal https:// www.servicevoter.eci. nic.in In the 2014 election, the number of registered Service Electors was13,27,627.

"For the first time a full-fledged online registration portal for service electors has been used to save processing time, resources and human errors," the ECI press release states.

Persons working in Central Forces under Arms Act and Govern-

ment officials deployed in Embassies outside the country are, classified as Service Voters and are provisioned for online

enrolment. In 2019, 10,84,266 e postal ballots were received indicating 60.14% turnout, which is a sigimprovement nificant compared to 2014 when turnout was only 4%, the release mentions.

Out of the total number of Service Electors, 10, 16,245 were from Ministry of Defence, 7,82,595 from Ministry of Home Affairs (Central Armed Police Forces), 3539 of Ministry of External Affairs and State Police 267.

In the seven phases spanning election, total 18, 02,646 postal ballots were dispatched electronically using the flagship IT programme of Election Commission of India, known as Electronically Transmitted Postal Ballot System (ETPBS).

ETPBS is developed by Election Commission

of India, for the use of the Service Voters. It is a fully secured system, having two lavers of security. Secrecy of voting is maintained through the use of OTP and PIN and no duplication of casted ETPB is possible due to the unique QR Code in the portal https://www. etpbs.in. Through this system the service voters cast their vote on an electronically received postal ballot, from anywhere outside their constituency, thus the chances of losing the voting opportunity has reduced. The purpose of the online system was to create con-

that there is presence of at least two different individual tigers in the area. One of these animals, a male, was photographed at an elevation of 3600m which is one of the highest altitudes that tigers have been recorded in India thus far," the release mentions.

These images resulted from surveys that were conducted as part of the Project Status of tiger habitats in high altitude ecosystems of Bhutan. India and Nepal. The survey involved a range of methods inclusive of interviews with local communities about the presence and status of tigers and other mammals, sign surveys to detect wildlife presence and camera trapping. It was undertaken in select areas across North and East Districts of the state.

Mr Shrivastava said that the department has been instrumental in providing the manpower for the project which laid out the camera traps.

"This was a historic day for the Namgyal Institute of Tibetology, till now well known nationally and internationally as an research Institute in the realm of Buddhist and Tibetan studies and for organizing national and international level seminars and workshops in such diverse subjects such as "Quantum Physics and Emptiness in Buddhist Philosophy" or on "Mind and Life" to site a few examples," the release states.

In the year 2017 NIT had ventured into the teaching arena by introducing five and a half years course for Sowa Rigpa (science of healing) graduation and today, NIT inaugurated the Post Graduate course in Buddhist Studies in English medium.

The release further states that this is the first of its kind course introduced in the State of Sikkim offering opportunities to the local students to study Buddhism and its philosophy in languages other than Tibetan.

The Minister in his inaugural address congratulated the Namgyal Institute of Tibetology for the hard work done to diversify the activities of the Institute into the teaching realm. He was of the view that both Sowa Rigpa and the Post Graduate programmes in Buddhist Studies are relevant and appropriate to culture, traditions and religious ethos of the people of the Himalaya regions.

The animal tends to take the circuit which begins in Bengal and takes the route through the dense forest bordering Bhutan and Sikkim reaching beyond the tri-junction area. Apart from Royal Bengal Tiger, the camera traps have captured snow leopards as well, surprisingly in altitudes much lower than their natural habitat.

NIT Director, Tashi Densapa in his welcome speech said that the establishment of Buddhist University was entrusted to the NIT by the State Government in 2015. He said that graduating to a full-fledged University focused on Buddhist Studies alone will be a long process not only in terms of infrastructure requirement but also in terms of the stringent UGC norms applicable for recognition as a separate university.

Therefore, to start with, NIT decided to begin with MA (Post Graduate) course in Buddhist Studies. He also said that in the year 2017, the Sowa Rigpa (Science of Healing) course was introduced by NIT as it is a part and partial of Buddhism. He ended his address by saying that with gradual increase in teaching faculties, it may be possible to get a deemed university status for NIT.

Officer on Special Duty, NIT, K.N. Bhutia, gave a brief background report of the Sowa Rigpa and M.A programmes. While proposing the vote of thanks, the Joint Director made a special mention of the Vice Chancellor and Professors of Central Institute of Higher Tibetan Studies, Sarnath for their active support in preparing the Syllabus of the Post Graduate and Sowa Rigpa pprogrammes.





Crowded Out by Cars

Instead of cursing traffic jams, collaborate to find a solution

There is a footpath lining the highway in Gangtok, I and yet parents are not comfortable sending children out on their own. Upto two decades back, children would rarely stay at home, gathering in groups and heading outdoors. That is a luxury which is denied the generation now in school because outdoors in the capital is a now a jumble of parking lots and dangerous traffic. People have been noticing the increase in traffic on Gangtok roads, many have even ventured explanations and some have stuck their necks out with criticism, and all have come to the same conclusion -Gangtok has been taken over by cars. Cars have captured public spaces and pushed everything else away. The neighbourhood streets, even those which lead to dead-ends, have been consumed, and the town still needs to come up with more and more ingenious ways to park its cars.

Despite the obvious glut on the roads, the rush is showing no signs of abating. Some years ago, a study by the Central Road Research Institute [yes, there is such an institute] revealed that vehicles were occupying almost as much space [10.8%] as the forest cover [11.5%] in the National Capital Region of Delhi. Anyone who has watched the explosion of vehicles in Gangtok will agree that Sikkim's capital too is trying hard to bring vehicular occupation at par with its green cover. Here, the plant life might not be getting hacked away to make space for more parking lots, yet, but it is being choked to death by the swarm of idling engines stuck in impossibly long traffic jams which grip the roads during peak office hours nowadays. There might not be too many people who remember how long a pony ride from Ranipool to Gangtok took in earlier times, but it could not have been much longer than what it takes to make it from Tadong to MG Marg in a vehicle nowadays.

Admittedly, all this description is not required because it is obvious to every Gangtokian that traffic and cars have become a problem and a nuisance. What has still not been accepted is that this problem needs to be addressed. The only initiative taken to address the problem of too many cars has been the commissioning of more parking lots some of which are built and ready but await an inauguration. While more parking is definitely required, this is not enough of a solution primarily because the parking space being created will already be too cramped by the time the structure is completed. For another, more parking space does not address the problem of vehicular movement. In this regard, Gangtok's topography and building practices play spoilsport, making the creation of alternate roads impossible.

The only real option then is to reduce the number of vehicles on the roads. This cannot be achieved by stronger legislations [in case someone is floating that idea], but can be pulled off with an approach which combines structured parking fees, safe and spacious parking in the outskirts [of the congested areas, say beyond Deorali or Tadong at one end or Burtuk at the other end or even along the bypass] and fast, frequent and reliable public transport. Bigger cities around the world have worked this combo quite well and there is no need why Gangtok should not try out the model as well. This is but one option that can be mulled and what would be even better for Gangtok to attempt will be a series of brainstorming meetings aimed specifically at addressing its traffic and parking challenges. Experts from diverse fields can be invited to study the problem and offer solutions. Think about it the next time you stare aimlessly out of the car window at another one Gangtok's traffic jams.

Dissociative disorders are nearly as common as depression. So why haven't we heard about them?

issociative disorders are often said to be rare. But our soon-to-be published analysis of international studies suggest they affect 10-11% of the population at some point in their lives. This makes them nearly as common as mood disorders (such as clinical depression).

So what are dissociative disorders, why is diagnosis controversial and how can people be treated? WHAT IS DISSOCIATION?

Dissociation occurs when a person experiences being disconnected from themselves, including their memories, feelings, actions, thoughts, body and even their identity.

People with dissociative disorders have one or more of the following symptoms:

- amnesia and other memory problems
- a sense of detachment or disconnection from their self, familiar people or sur-
- an inner struggle about their sense of self and identity
- acting like a different person (identity alteration).

For some people, symptoms can last days or weeks, but for others they can persist for months, years, or a lifetime.

Dissociation allows the person to compartmentalise and disconnect from aspects of traumatic and challenging experiences that could otherwise overwhelm their capacity to cope.

A person whose spouse has died may become emotionally numb, allowing them to focus on arranging the funeral; a man who has separated from his wife and lost his job soon afterwards may become so disconnected from his identity that he no longer recognises himself in the mirror and feels his life is happening to someone else; and a young woman who is sexually assaulted may remember her attacker moving too quickly towards her, recalls being safely back in her family home, but cannot remember the assault.

If the traumatic and overwhelming experiences happen repeatedly over a long period of time, the person's personality may become fragmented. The traumatised part of the personality that contains the emotions, thoughts, sensations and experiences relating to the trauma becomes separated from the part of the personality that is trying to get on with daily life.

This allows young children to be with frightening and abusive caregivers they can neither fight nor flee from as they are dependent on them.

The person may have no (or only some) con-

scious awareness of the compartmentalised memories, thoughts, feelings and experiences.

These may, however, intrude into the person's awareness. For example, the person may be aware of thoughts, feelings and internal voices that don't "belong" to them, or may speak or act in ways that are completely out of character.

The most extreme form of structural dissociation is dissociative identity disorder, once known as multiple personality disorder. This is where the person has at least two separate personalities that exist independently of one another and that emerge at different times.

These personality differences are not just psychological. Neuroimaging confirms structural differences in the brains of people with dissociative identity disorder.

A CONTROVERSIAL DIAGNOSIS

There are two competing theories about what causes dissociation: trauma and fantasy.

With the trauma model, dissociative symptoms arise from physical, sexual and emotional abuse; neglect, particularly in childhood; attachment problems if a child fears the caregiver or the caregiver is not adequately attuned to the child's emotional or safety needs; and other severe stress or trauma, such as experiencing or witnessing domestic violence.

This trauma model is reflected in the World Health Organisation and American Psychiatric Association past and present diagnostic criteria.

However, the fantasy model is based on the idea that dissociative disorders are not "real". Instead, they are the delusion of people who are troubled (and often traumatised), suggestible, fantasy-prone and sleep-deprived.

Fantasy model theorist Joel Paris describes dissociative disorders as a North American "fad" that has nearly died out.

Yet my analysis of 98 studies found rates are not declining. In fact, I found dissociation is an international phenomenon far more common in countries that are comparatively unsafe. This is supported by other research which finds dissociation more common in people that have experienced trauma, such as refugees.

All up, the evidence indicates dissociative disorders are real (not imagined) and caused by trauma (not fantasy)

DISSOCIATIVE DISORDERS ARE UNDER-DIAG-NOSED AND MISDIAGNOSED

Even though there are accurate ways of diagnosing dissociative disorders, most people will never be diagnosed. This is due to the lack of health professional education and training about dissociation, the symptoms being less obvious to observ-

ers, and scepticism that the disorder even exists

The person also may not realise they have dissociative symptoms. Even if they do, they may not reveal them due to fear or embarrassment, or may find them difficult to put into words.

At least three-quarters of people with a dissociative disorder will also have one or more other mental disorders. They may be diagnosed with and treated for other mental health difficulties, such as post-traumatic stress disorder, mood disorders, anxiety disorders, sleep disorders, borderline personality disorder, or psychosis. They may also be treated for addictions, selfharm, and/or suicidal thoughts (2% of those diagnosed complete suicide).

They may also be misdiagnosed with schizophrenia because hearing voices is common to both.

But their dissociative disorder usually remains undiagnosed. However, treatment for other mental health issues is not likely to be effective unless the underlying dissociation is addressed.

HOW TO TREAT? WHAT DOES THE EVIDENCE **SAY WORKS?**

The mental health and quality of life of people with a dissociative disorder improves significantly with psychotherapy (a type of talk therapy) that recognises the impact of trauma is physiological (affecting the brain and body) as well as psychological.

In therapy consistent with international treatment guidelines, people can learn skills to cope with unbearable emotions, thoughts and physical sensations. Once people are stable and have constructive coping strategies, therapists can then help people process traumatic and dissociated memories. Dissociative, post-traumatic, and depressive symptoms improve. And hospitalisations, self-harm, drug use, and physical pain declines.

There is no medication that specifically treats dissociation.

WHERE TO GET HELP

Dissociative disorders are one of the most common, yet most unrecognised, mental disorders. Symptoms are often debilitating, but significant improvements are possible if the dissociation is diagnosed and treated correctly.

If you are concerned, you can speak to your GP and ask for a referral to a therapist knowledgeable about trauma and dissociation. A list of therapists with this expertise in Australia is available from the Blue Knot Foundation and worldwide from the International Society for the Study of Trauma and Dissociation.

The uproar over taking 'man' out of 'manhole'

It is not every day that a change to a I municipal code for a medium-sized had its first reading of a proposal to re- idence-based. move gendered language from its municipal code, the media went to town.

The 14-page proposal provides a rationale for the changes, cites legal and grammatical support, specifies the wording that will change and estimates the cost of the initiative at a mere \$600. The proposal was part of Berkeley city council's consent agenda — that is, the portion of any agenda that is deemed so pro forma and uncontroversial that it isn't brought to the floor for discussion. From Berkeley's perspective, this was all pretty dry business.

Almost immediately though. the proposal generated dozens of high-profile media stories, the overwhelming majority of which touted in their headlines one particular proposed change: the replacement of "manhole" with "maintenance hole."

CBS News (among others) claimed that Berkeley is banning gendered words. Late Night host Seth Meyers joked that henceforth in Berkeley, Hooters will be called "Torso." One news radio host characterized the ordinance as "left-wing language lunacy." Former Fox News host Bill O'Reilly called Berkeley a "fascist enclave." What a lot of commotion over a municipal ordinance for a small city with under 150,000 residents.

As a feminist philosopher who does research on gender, I am both impressed by the sensible changes Berkeley is proposing, and struck but not surprised — by the force and the tone of the media response. A PROGRESSIVE CITY

The use of gender-inclusive language is associated with reductions in gender stereotyping and discrimination. Further, for transgender and non-binary people, traditional binary approaches to language can cause stigma. That said, not everyone is

ready for gender-inclusive language, and forcing it can lead to resistance and resentment.

Berkeley is a progressive city in a diverse state. According to Gallup, the larger San Francisco Metro area. of which Berkeley is a part, has the highest proportion of adults who identify as lesbian, gay, bisexual, transgender or queer (LGBTQ) of any major U.S. metropolitan area. Berkeley has a vocal and influential LGBTQ community, and the municipality is more attuned to equity issues many city than councils. Berkeley is the right place to pioneer a gender-inmunicipal clusive

code. Moreover, California's enactment of Bill 179 earlier this year makes now the right time to update the gendered language in the municipal code. Bill 179 responded to growing social awareness about transgender and gender non-conforming identities by introducing a third, nonbinary, gender option for official California documents. At the same time, it removed the requirement for transgender and nonbinary people to undergo surgery or legal hearings to change their gender or name on official documents.

In response to those changes, the League of California Cities recommended municipalities replace all gendered terms within their municipal codes with gender-neutral terms. SIMPLE CHANGES MADE OFFICIAL

After discussing the League's recommendation at a March council meeting, Berkeley assigned staff to work through its municipal code and recommend changes to remove the

gendered language.

Most of the recommended changes simply replace a familiar gendered term with an equally familiar non-gendered term: "policeman" becomes "police officer," for instance. Most of us made these changes to using gender neutral language years ago.

These changes are sensible for two reasons. First, research tells us

"she" with singular "they." But it is an elegant solution to a real challenge. City employees interacting with customers can't tell at a glance what gender they are, and the process of finding out someone's pronouns is complicated and fraught.

Singular "they" allows city employees to circumvent that complexity using a linguistic device that is in fact quite familiar. Most of us already use singular "they" when we don't know the gender of the person we're talking about. "Oh no!" one might

> say, "someone left their book in the lounge. I hope they come

back for it!" These are modest,

practical changes being made in the right place at the right time, and they don't affect the freedoms of people on the street. So, why are dozens of media outlets in North America and abroad making fun of the proposal's single reference to a manhole?

Like most of the terms in Berkeley's ordinance, pushback to gender-inclusive language has been around for years. Gender is deeply bound up with our sense of self, our beliefs and our val-

Change is hard, especially when it cuts to the core of our being. Today, decades-old resistance to gender-inclusive language is inflamed by social media hot takes, renewed culture wars and increasing pressure on media outlets to get as many clicks as

So, what's a mid-sized California city — or indeed any person wishing to promote gender-inclusive language — to do? I say, weather the media storm and work to improve things in tractable ways. Media storms come and go, but with sensible models like the one Berkeley council is considering, we can make the world a little more inclusive for people of all genders.

Six Bangladeshis apprehended by BSF

KOLKATA, JULY 26 (PTI): The Border Security Force (BSF) Friday apprehended six Bangladeshi and one Indian national while they were trying to cross the international boundary illegally in West Bengal.

"We had apprehended six Bangladeshi national and one Indian national during the night when they were trying to crossover to India and vice verse. They were arrested from various sectors of Malda, Baharampore and Nadia," a senior BSF official of south Bengal frontier said.

The border force also seized 82 cattle when they were being smuggled to Bangladesh through different locations of border the districts of Malda, Murshidabad, North 24 Pargnas and Nadia. The total value of cattle seized is Rs 5,48,97, he said.

The matter has been reported to the local police for disposal of the cattle and further investigation, BSF said.

WB govt announces hike in teachers' grade pay

KOLKATA, JUL 26 (PTI): The West Bengal government Friday announced a hike in the grade pay of primary teachers in the state on the fourteenth day of their hunger strike.

The enhancement of grade pay for trained and untrained primary teachers was notified by the school education department of the government.

"The grade pay of trained primary teachers in enhanced from Rs 2,600 in pay band 2 to Rs 3,600 in Pay Band 3 and the grade pay of untrained primary teachers is enhanced from Rs 2,300 to Rs 2,900 in Pay Band 2 with effect from August 1, 2019," the notification said.

Members of Usti Primary Teachers Association (UPTA) have been on indefinite hunger strike in front of Bikas Bhawan in Salt Lake, which houses the state directorate of school education for the past fortnight.

"We have not seen the order yet. But we have heard about it. If this announcement is true we are not at all happy. We are waiting for the government's decision on the revocation of transfer orders of 14 primary teachers," Sandeep Ghosh, one of the agitating teachers, said.

State Education Minister Partha Chatterjee had said on Thursday that the government was ready to effect a hike in the grade pay of the primary teachers.

Chatterjee had reasoned that the teachers were transferred to schools having shortage of teachers.

Earlier in the day, actor-director Aparna Sen paid a visit to the agitating primary teachers and urged the state government to look into the matter immediately with utmost importance.

She said that the state government should stop giving donations to the clubs, organising different festivals and instead pay dues to the primary teachers immediately.

Polls in only 15 pc Panchayat seats in Tripura on Saturday



AGARTALA, JUL 26 (PTI): The three-tier panchayat elections in Tripura will be held in only 15 per cent of the total seats on Saturday as 85 per cent seats have already been won by the ruling BJP unopposed.

While the Congress and the CPI(M) have accused BJP- backed goons of preventing opposition candidates from filing nomina-

tions, the saffron party has said the opposition parties failed to find nominees.

"Elections will be held in 833 gram panchayat seats, 82 panchayat samiti seats and 79 zilla parishad seats," SEC Secretary Prasenjjit Bhattacharya told PTI on Friday.

There are a total of 6,111 gram panchayat seats, 419 panchayat

samiti seats and 116 zilla parishad seats in Tripura.

The SEC official said the BJP has won 5,652 seats of the total 6,646 gram panchayat, panchayat samity and zilla parishad seats unopposed. Ballot papers will be used in the polling which will be held between 7 am and 4 pm. Votes will be counted on July 31.

Man held for duping people on pretext of installing mobile towers

New Delhi, Jul 26 (PTI): A 28-year-old Delhiite was arrested for allegedly duping more than 500 people in Kerala, Assam and Maharashtra on pretext of installing mobile towers, police said on Friday.

The accused has been identified as Ritesh Sharma, a resident of Uttam Nagar, they said, adding efforts are on to nab his associates.

The accused used to target people by posting advertisements in newspapers and lured them by offering good returns for using their property for installation of mobile towers, police said.

During interrogation, it was revealed that Sharma targeted people in Kerala, Assam and Maharashtra by giving advertisements in the newspapers where he would offer people to rent out their land for installation of mobile tower at lucrative returns and would then ask them for money as processing fees, the DCP said.

He has cheated people of an amount ranging from Rs 10,000 to over Rs one lakh. It is roughly estimated that he has managed to con people of around Rs one crore since he started doing this in 2015, they said.

49 projects worth Rs 1,231 cr taken up in northeastern region



NEW DELHI, JUL 26 (PTI): As many as 49 projects worth Rs 1,231 crore have been taken up in the northeastern region by the DoNER Ministry in the first 100 days of action plan in the second term of the BJP-led NDA government.

The projects include setting up of a bamboo industrial park in Dima Hasao district in Assam at a cost of Rs 50 crore and construction of roads and bridges in several northeastern states, an official statement said.

The decisions were taken at a meeting of the Ministry of Development of North Eastern Region (DoNER) held here on Wednesday and chaired by minister Jitendra Singh.

Secretary in the Ministry of DoNER Inder Jit Singh said that 49 projects worth Rs 1,231.94 crore have been taken up so far by the ministry and these include sanction of eight new projects for Rs 586.3 crore under North East Road sector Development Scheme (NERSDS) and

North East Special Infrastructure Development Scheme (NESIDS).

Additionally, 36 on-going projects under various schemes like Non Lapsable Central Pool of Resources (NLCPR), special packages, schemes of North Eastern Council (NEC) etcetera, have been completed with approved cost of Rs 529.18 crore, the statement said.

Works of two projects for Rs 89.63 crore got started and three projects for Rs 26.83 crore have been operationalised during this period.

During the meeting, it was also informed that a bamboo industrial park will be set up in Manderdisa in Dima Hasao district of Assam over an area of 75 hectares at a cost of Rs 50 crore.

The in-principle approval will be granted to this project in August this year. It was informed that the target is to complete the project by March, 2021 and another project for bamboo park in Itanagar, Arunachal Pradesh, would be taken up by the NEC.

2 rhino carcasses found in flood-hit Pobitora sanctuary



Morigaon (Assam), Jul. 26 (PTI): The carcasses of two rhinos have been found from Assam's flood-hit Pobitora Wildlife Sanctuary which had recorded no animal deaths because of inundation even four days ago, an official said.

Forest Protection Force in Pobitora recovered the carcass of a rhino calf from the flood waters near Amaramul Camp inside the sanctuary on Friday, its ranger said.

The forest guards had also found the carcass of another rhino calf on Wednesday from the sanctuary which was flooded by the Brahmaputa, he added.

The cause of the death of both the animals was drowning in the flood inside the sanctuary, said the forest official.

The entire Pobitora

Wildlife Sanctuary, the

densest habitat of one

horned rhinos in the world covering an area of 46 sq km, was completely submerged by the flood waters forcing its wild animals to leave for the nearby highland, the ranger said.

Over 100 rhinos living in the sanctuary have been facing serious problems as there is no green grass or sufficient food for these endangered species, forest department sources added.

On Monday, state Forest Minister Parimal Suklabaidya said the personnel and volunteers at the Pobitora Wildlife Sanctuary have done an impressive job by keeping the number of animal death toll at zero this time.

On the same day, the forest department had said the calamity has claimed the lives of 187 animals, including 16 rhinos, in the Kaziranga National Park.

Assam Oppn stages walkout after Speaker rejects adjournment motion

Guwahati, Jul 26 (PTI):
Opposition MLAs walked
out of the Assam Assembly on Friday after the
speaker rejected an adjournment notice seeking
discussion on the flood
situation in the state.

As soon as the House

assembled for the first day of the summer session here, Congress leader Debabrata Saikia, supported by the AIUDF, moved an adjournment motion, which was rejected by Speaker Hitendra Nath Goswami on the ground that it was not raised "as per the rules of the Assembly". Noting

that Assam was not experiencing floods for the first time in, Goswami said, "The matter can be taken up after the Question Hour. Everyone will get an opportunity to speak on the topic. All members have to obey the rules of the House and should not be play-

ing to the gallery."

Angry exchanges ensued between the opposition and treasury bench BJP MLAs, following which the Congress and AIUDF legislators moved to the well of House, insisting that the speaker fulfill their demand.

As Goswami remained steadfast in his decision, the demonstrating MLAs staged a walkout in protest.

Parliamentary Affairs Minister Chandra Mohan Patowary said discussions can always be held after the Question Hour as per 'rule 60 clause one of the Rules and Procedures of House'.

Maintaining that the House "works for the interests of public and not any party", Patowary said, "The Congress diluted the important issue of floods by staging the walk- out."

Naga political solution has to be achieved within a year: Acharya



KOHIMA, JUL 26 (PTI): A political solution to the Naga issue has to be achieved within a year because Nagaland needs permanent peace for development and progress, outgoing governor P B Acharya has said.

"And for this, we have Prime Minister Narendra Modi, who has the will and guts to resolve the issue," Acharya said while addressing a farewell programme, organised by the state government, on Thursday.

Noting that Nagaland is rich but Nagas are economically weak, he said, "We also need to march along with other states towards development and progress."

Acharya was sworn in as the 19th Governor of Nagaland on July 19, 2014. His successor, R N Ravi, is scheduled to take charge on August 1.

He expressed hope that the new governor will deliver goods to the people and work for the solution of the Naga political issue.

Ravi had been the

Centre's interlocuter for the Naga peace talks. Acharya also offered to extend his support to the state, whenever required.

"I am leaving as the governor of the state but not the Nagas, and I will always be at your disposal," he said.

Mentioning that the Naga people were fortunate to have such an eminent personality as their governor, Chief Minister Neiphiu Rio said, the people have been enriched through his guidance and leadership.

"Your support to the governments efforts towards realising permanent peace and solution to the Naga political issue is well appreciated," Rio said. As constitutional head of the State, Acharya had a meticulous and exemplary tenure, the chief minister said.

"The state experienced a few political crises during the past few years but the governor conducted himself in an impeccable manner and upheld the Constitution of India


in exemplary fashion, for which he deserves to be complimented," the chief minister said.

Leader of Opposition T R Zeliang expressed hope that Acharya will continue to support the Naga people for an amicable solution to the Naga political problem.

He also recalled the framework agreement signed between the NSCN-IM general secretary Thuingaleng Muivah and the governments interlocutor R N Ravi, in the presence of PM Modi, on August 3, 2015.

PARIS, JUL 26 (AFP): Real Madrid's Ferland Mendy has been added to Zinedine Zidane's growing injury list after the Spanish club confirmed on Thursday the France left-back had suffered a calf injury.

Mendy, 24, signed for the La Liga giants in July and heaps further pressure on Zidane's squad after midfielder Marco Asensio ruptured his anterior cruciate ligament and winger Brahim Diaz suffered a thigh problem.

Newspaper AS reported Mendy, who cost the Bernabeu outfit a reportedly 50 million euros (55 million), could miss up to four weeks.

Real have two remaining pre-season friendlies including Saturday's game against capital city rivals Atletico Madrid in New Jersey before the La Liga season begins on August 17 with a trip to Celta Vigo.

Sindhu crashes out of Japan Open; Sai Praneeth advances to semis

TOKYO, JULY 26 (PTI): Olympic silver-medallist P V Sindhu crashed out of the Japan Open badminton tournament after a second successive defeat to local favourite Akane Yamaguchi while B Sai Praneeth continued his good form to advance to the semifinals here on Friday. Sindhu lost to Yamaguchi 18-21 15-21 in a 50-minute women's singles quarterfinal match. This was Sindhu's second defeat at the hands of Yamaguchi, who had beaten the Indian in the final of the Indonesian Open last week.

However, in men's singles, Sai Praneeth recorded an easy win over Indonesia's Tommy Sugiarto to reach the semifinals. His 21-12 21-15 win over Sugiarto fetched him a clash against top seeded Japanese Kento Momota in the semifinals.

Sindhu was leading 12-7 in the first game but she squandered the advantage as her reigning Asian champion opponent clawed her way back to level the scores at 14-14. From there on, Sindhu lost momentum allowing Yamaguchi to surge ahead to 18-15 and then to 20-16. Sindhu won two consecutive points to narrow the gap to 18-20 but could not stop her opponent from bagging the next point and the first game.

In the second game, both were locked 6-6 initially but from there on, it was Yamaguchi all the way as she raced to 13-7 and then to 16-10. Sindhu recovered a bit by winning two consecutive points but in no time, the Japanese had five match points and she wrapped up the tie without much hassle. Sai Praneeth, in contrast, hardly broke a sweat as he just took 36 minutes to clinch up the match.

The unseeded Indian led almost all through the first game leaving the former world championships bronze-medallist Indonesian to play the catch-up game.

Djokovic, Del Potro withdraw from Montreal, Nadal gets top seed

MONTREAL, JUL 26 (AFP): Wimbledon champion and world number one Novak Djokovic has withdrawn from next month's US Open hardcourt tuneup event in Montreal, saying he needs more rest after capturing his 16th Grand Slam singles crown.

The 32-year-old Serbian, who outlasted Roger Federer in an epic All-England Club final earlier this month, was joined by Argentina's 12th-ranked Juan Martin Del Potro in pulling out of the ATP Masters Canada tournament.

"I'm sorry to announce that I decided to pull out of Rogers Cup," Djokovic said in a statement released by Tennis Canada.

"With the support of my team, I have decided to give my body longer rest and recovery time before coming back again to play.

"I love Canada and I have many friends there that always make me feel like I'm at home and I'm looking forward to coming back again to play in front of all of you in Montreal."

Djokovic's withdrawal means Spanish star



Rafael Nadal, an 18-time Grand Slam singles champion, will be the top seed in Montreal when main draw begins August 5. Nadal has captured the Canadian crown four times, most recently last year by defeating Stefanos Tsitsipas in the final.

Djokovic has won the Canadian event that alternates between Toronto and Montreal four times, twice in each city -- Toronto in 2012 and 2016 and Montreal in 2007 and 2011.

He was ousted last

year in Toronto by Greek star Tsitsipas in the third round. "We would have loved for Djokovic to have the chance to be crowned champion for a third we wish him a speedy recovery, he who has experienced his share of injuries in the past few years," Lapierre said. "We look forward to

(PTI): Medal-contender

The Georgian has immense faith in his ward, saying Bajrang is best among the current Indian crop but feels playing badly for just 30 seconds can ruin Olympic dreams.

Bajrang has perched himself on the top of the UWW ranking table in 65kg after winning nine of his last 10 international assignments, including the 2018 CWG and Asian Games. The only final he lost was at the World Championship last year.

"The biggest problem with Bajrang is that he loses focus sometimes and gives away points. It becomes a minus three, minus four start for him. We are working on it. It's difficult. When I came he was 18 now he is 26, so it's difficult to change but I am giving my best," said Shako after Bajrang won the World Championship trials.

"Bajrang and Vinesh are close to Olympic medals. But one incorrect (sic) fight, and you are finished. Lot of legends lost at Olympics, it's a serious competition. You must give everything. One poor bout or 30 bad seconds, and it's good bye Olympics," he said.

So, what is it that causes Bajrang to lose his focus?

"If the training has not gone as per expectations, you might lose focus. And when you are a bit injured or want to avoid injury, it affects you. I try not to get distracted. Actually, when you are on the mat, there is no pressure but before that everyone feels a bit of pressure," Bajrang told PTI after the trials.

Shako did not say it in as many words but hinted that stardom can be distracting. "Wrestling is a difficult sport. Bajrang was a good wrestler before but not the best. Now he is jumping fast, he has got name as well. He is a star now, so it becomes difficult to focus but he is at another level.

Bajrang must learn to retain focus for

Ask Shako what are the three-four things Bajrang must do, to do well at the Worlds and the Olympics and he comes up with a clear answer.

"Leg, leg leg and leg..
if you give 6-7 points,
comeback is possible
but very very difficult in
Olympics."

It's not surprising when Shako said that because the only final

Bajrang lost in the last 18 months was at the Worlds due to poor leg defence. Bajrang though said he made satisfactory progress on that count.

"If you look at my performance after the last World Championship, I have competed in 4-5 tournaments and lost just one bout in Madisson Square. Today, I did not falter on leg defence. I have competed against Harphul before and gave him 1-2 points earlier but today I did not give any points to him, so there is definitely improvement on leg defence."

Shako hinted that perhaps the affable 25-year-old from Haryana does not give his body enough rest in his absence.

"Bajrang does not understand rest. Now he is best wrestler and if I go for one-week vacation, and come back, Bajrang is a different wrestler."

But he is sure that Bajrang definitely is the best as of now in the country.

"There is sea difference in Bajrang and other Indian wrestlers. He is the most disciplined. The problem is mentality. They don't know the history and there is not much Indian history in wrestling," he signed off.

Nikhat, Deepak among five Indian boxers to make Thailand International finals

NEW DELHI, JUL 26 (PTI): Former junior world champion Nikhat Zareen (51kg) was the lone woman boxer to make the finals, while Asian silver-winner Deepak Singh (49kg) led a four-strong Indian men's charge into the summit clashes of the Thailand International Tournament in Bangkok on Friday.

Ashish Kumar (75kg), Commonwealth Games bronze-medallist Mohammed Husammuddin (56kg) and Brijesh Yadav (81kg) were the other three men to make the gold medal bouts.

However, former Asian youth silver-med-allist Ashish (69kg) lost his semifinal bout to sign off with a bronze medal. Ashish lost to Thailand's Wuttichai Masuk in a split decision after an exhausting clash.

Among the women, Manju Rani (48kg) and Bhagyabati Kachari (81kg) ended with third-place finishes. Manju went down to Chuthamat Raksat of Thailand, while Bhagyabati lost to China's Li Qian.

Earlier, Deepak hardly broke a sweat against Bhutan's Tashi Wangdi. The Indian's dominance was such that Wangdi faced two standing eight counts and was left with a gash above his right eye. The judges eventually ruled unanimously in the Indian's favour.

Nikhat was up against Thailand's Jutamas Jitpong. The Hyderabadi impressed with the ferocity of her punches as she edged past the local favourite 4-1 and let out a scream to express her elation when her hand was raised by the referee.

Also advancing was Husammuddin (56kg). In a messy slugfest with Thailand's Ammarit Yaodam, the Indian came out as the more aggressive and clean puncher to emerge triumphant in a 3-2 decision.

In the 75kg category, Ashish defeated Uzbekistan's Fanat Kakhramnov to make the finals. Brijesh was up against local favourite in Saranon Klompian in the last bout of the day and produced a ferocious performance.

A left hook just a minute into the second round sent his opponent crashing and the Thai could not regain his composure after that.

Klompian faced three eight counts before the referee stopped the bout in Brijesh's favour.

PCB seeks explanation from Basit on remarks against India during World Cup



KARACHI, JUL 26 (PTI): The Pakistan Cricket Board has put former batsman Basit Ali's appointment for a coaching assignment on hold and sought an explanation from him for suggesting that India would intentionally lose matches to knock Pakistan out of the recent World Cup.

A source in the PCB told PTI that Ali's appointment as regional coach in Karachi has been held up after the Board had second thoughts about appointing him.

"The board, in fact, conveyed to Basit in clear terms that since he was a Test player and working for them on assignments he should explain and avoid his reckless comments on television," the source said.

Basit had claimed that India would lose intentionally to England and other teams to keep Pakistan out of the semifinals which caused a furore. Pakistan were knocked out of the mega-event's league stage.

"The PCB found itself in an embarrassing situation because of the reckless comments by Basit which were without any evidence or substance as internationally this hurt the image of Pakistan cricket," the

source stated. "The thing is that the PCB now has second thoughts about Basit as Karachi regional coach and wondering that if they appoint him what impression this will ceate internationally since Pakistan is a senior member of the International Cricket Council," he added.

PCB had shortlisted Basit for a coaching assignment in Karachi region but has now put that decision on hold.

"Basit was expecting to be issued a contract soon but this has not happened as yet," the source said.

Basit worked as chairman of the national junior selection committee.

While commentating on a national T20 match some years ago on the state-owned Pakistan Television, he accused the coach of the Sialkot regional team of intentionally losing a match.

When questioned, he slapped a former batsman Mahmood Hamid at the national stadium during a domestic cricket match in which Basit was coach of one team.

Basit first denied slapping Hamid but eventually admitted, saying he was upset with the remarks made by Hamid.

Ex-schoolmate traces Sunanda Pushkar's life story in biography



New Delhi, Jul 26 (PTI): A former schoolmate traces the life story of Sunanda Pushkar from her early days in cantonment towns to her first two marriages, a largely unknown stint in Canada, her rise as a Dubai businesswoman, and finally her years with Shashi Tharoor until her controversial death shook the country.

On 17 January 2014, Pushkar was found dead in her hotel suite in New Delhi. Her death was as shocking as it was suspect, spawning many a controversy and complex legal battles.

In "The Extraordinary Life and Death of Sunanda Pushkar", her journalist friend Sunanda Mehta draws material from personal archives, interviews and investigation across continents to come up with the biography.

The author talks more of Pushkar's life than about her death.

"Sunanda Puskhar was born, surviving all odds," she writes, as she recalls how the former had not cried on birth and appeared to be stillborn.

Her parents Pushkar Nath Dass, who was an army officer, and Jaya Dass was about to give up hope when the doctors were successful in reviving her, Mehta says.

The author describes in detail Pushkar's early life especially her school days, her rise as a businesswoman in Dubai, her stint in real estate, her marriages and her days

with Tharoor.

Mehta and Pushkar were in the same school in Ambala and later their both fathers were posted together in Jhansi.

She says Pushkar was a woman who "lived energetically and loved passionately".

"This was a woman who went beyond her bounds and charted a life for herself that was different, daring and daunting, a woman who encountered unbelievable challenges throughout her life, but always bounced back with amazing tenacity," she writes in the book, published by Pan Macmillan.

"She was like a kaleidoscope - each person who knew her saw in her something no one else did," Mehta writes.

16 Marines arrested in migrant smuggling investigation



SAN DIEGO, JUL 26 (AP): An investigation into Marines accused of helping smuggle migrants into the United States led to the arrest Thursday of 16 of their fellow Marines at California's Camp Pendleton, just north of the U.S.-Mexico border.

In a dramatic move aimed at sending a message, authorities made the arrests as the Marines gathered in formation with their battalion.

None of the 16 Marines were involved in helping enforce border security, the Marine Corps said in a news release. They are accused of crimes ranging from migrant smuggling to drug-related offenses.

Officials could not immediately be reached for additional details.

The arrests came weeks after two Marines were arrested by a Borpicion of transporting three Mexicans on the promise of money after they crossed illegally into the United States.

The military said the investigation helped authorities identify the 16 Marines arrested at the largest Marine Corps' base on the West Coast, about 55 miles (90 kilometers) from San Diego's border with Mexico.

Retired Marine Lt.

Col. Gary Barthel called it a "kind of black eye for the Marine Corps" and said it was important the military show criminal behavior will not be tolerated. "Obviously I think it looks bad whenever you have the military that is helping protect the border and then you've got military people smuggling," said Barthel, an attorney at the Military Law Center in Carlsbad, north of

other U.S. troops were brought in last year to help reinforce the border by installing razor wire on top of existing barriers, among other things. Troops are barred from arresting migrants.

All 16 were junior enlisted Marines. Barthel said smugglers may have targeted young troops who could be vulnerable to being enticed by fast

Border Patrol agents over the years have routinely caught migrants in the country illegally walking onto Camp Pendleton or floating in skiffs off the coast nearby. Authorities said the base, cut by Interstate 5 leading to Los Angeles, sits along a well-traversed route used by migrant smugglers.

Officials from 1st Marine Division worked alongside the Naval

Service in the investigation that started after the July 3 arrests of two Marines, who were charged in federal court with migrant smuggling. Both pleaded not guilty to the charges.

A U.S. Border Patrol agent stopped Lance Cpl. Byron Darnell Law II and Lance Cpl. David Javier Salazar-Quintero about 7 miles (11 kilometers) north of the border after being alerted by other agents that a vehicle similar to theirs was suspected of picking up migrants who came into the country illegally, according to the federal complaint.

Three migrants were found in the backseat of a black BMW driven by Law, investigators say. Both Marines are riflemen assigned to 1st Battalion, 5th Marine Regiment, 1st Marine Division at Camp Pendleton.

that Salazar asked if he was interested in earning USD 1,000 picking up an "illegal alien." Salazar told authorities that Law introduced him to a man who "recruited" him to help smuggle in migrants, according to court documents.

Salazar said he had gone out to pick up migrants on four separate occasions but was never paid.

Law and Salazar, who speaks Spanish, went to the border the night of July 2 and received instructions from a Mexican cellphone, court documents say. Law told the agent they picked up a man and dropped him off at a McDonald's in Del Mar, a beach community north of San Diego, and then returned to the base. They were not paid.

Law said Salazar told him they would be paid if they picked up three migrants on July 3 near the border, according to court documents.

The three migrants told authorities they were from Mexico and agreed to pay USD 8,000 to be smuggled into the United States.

Marine Corps officials gave no details about how or why the investigation expanded to result in the arrest of 16 others. The Naval Criminal Investigative Service also declined to comment.

Google crushes second quarter earnings expectations



SAN FRANCISCO, JUL 26 (AP): Google parent Alphabet beat analyst expectations for the second quarter Thursday, sending its shares up sharply as it bounced back from a rough first quarter.

The company comforted investors with advertising revenue growth that edged out last quarter and assurances that video streaming site YouTube and the company's enterprise cloud business continue to drive growth.

The Mountain View. California-based company brought in revenue of USD 38.9 billion during the second quarter, a 19 per cent bump from the same period last year.

The company reported profit of USD 14.21 per share, or USD 9.9 billion during the quarter, nearly triple what it made last year when it paid a USD 5.1 billion European Commission fine.

Analysts polled by FactSet were expecting Alphabet to report earnings per share of USD 11.10 on revenue of USD 38.2 billion during the second quarter.

Google's stock rose more than 9 per cent in after-hours trading after the earnings report was released.

Investors and analysts had been disappointed by slowing revenue advertising growth Google's main cash cow after the first quarter. But their concerns didn't continue into the next quarter.

Excluding advertising commissions that Google pays to customers, Alphabet's overall revenue was USD 31.7 billion, more than the USD 30.9 billion analysts had estimated.

The company did not disclose anything about federal regulatory

concerns in its quarterly report unlike Facebook, which said Wednesday that the Federal Trade Commission is investigating it for antitrust concerns.

Google is facing mounting pressure from federal elected officials and regulators over a variety of issues such as its market power, misinformation and claims usually offered without evidence that its popular search engine and other services are biased against conservative politicians and viewpoints.

The company has repeatedly denied those claims.

Google is also reportedly under scrutiny from the Justice Department. which announced Tuesday that it would investigate big tech companies for anti-competitive monopoly behavior.

The department didn't name specific companies, but scrutiny has recently focused on Google, Apple, Amazon and Facebook.

Google CEO Sundar Pichai briefly addressed the concerns on a conference call with analysts Thursday. The company is no stranger to regulatory scrutiny, he said. "Even in the US we

have engaged in the process before," he said. "To the extent we have to answer questions we will do so constructively." Google was the subject of an FTC investigation that ended in early 2013 without the agency taking any antitrust action.

Pichai also acknowledged increased conversations about how the company handles user data privacy. He reiterated announcements Google made earlier this year that are designed to give people more control over what information they

are sharing, when.

"It's one of the most important areas we are working on," he said.

The company's streaming site YouTube, a big driver of advertising revenue, has also faced backlash from Congress and regulators over offensive videos on the site and the protection of children who appear in videos or watch You-

Google updated its hate speech policies for YouTube during the quarter, Pichai pointed out, and continues to focus on its "YouTube Kids" app.

A Washington Post report last week suggested the company is expected to pay a multimillion dollar penalty from the FTC over the way it handled kids' information on YouTube.

But none of the bubbling scrutiny put a damper on Google's financials or executive claims that the company's cloud business is making great strides. That includes its business that rents computing power to other companies, as well as its enterprise software tools such as G Suite.

Google's cloud while growing still falls behind market leader Amazon and runner-up Microsoft.

Alphabet's continued to grow for its Other Bets businesses, which include more "moonshot" businesses such as self-driving car company Waymo and internet connectivity balloon company Loon. Other Bets reported a loss of USD 989 million on revenue of USD 162 million.

And Alphabet increased its headcount once again this time to 107,646 employees, adding more than 18,000 workers in the last year.
