SC stays its Feb 13 order directing eviction of 11.8 lakh forest dwellers

NEW DELHI, FEB 28 (PTI): The Supreme Court

Thursday stayed its February 13 order directing 21 states to evict 11.8 lakh illegal forest dwellers whose claims over the land have been rejected by the authorities.

A bench comprising Justices Arun Mishra and Naveen Sinha directed the state governments to file affidavit giving details about process adopted in rejecting the claims.

The apex court posted the matter for further hearing on July 10.

The top court had on Wednesday agreed to hear the Centre's plea seeking withholding of its February 13 order asking 21 states to evict nearly 11.8 lakh forest dwellers whose claims were rejected.

After briefly hearing the matter, the bench said: "We stay and hold our February 13 order."

The bench also directed that the affidavit has to be filed by the chief secretaries of the states giving details of various steps covered for carrying out the eviction of the forest dwellers.

The Centre had rushed to the top court for modification of the order saying the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 was a "beneficial" legislation and should be construed liberally to help "extremely poor and illiterate people" who are not well informed of their rights and procedure under the law.

The Nodal Officers for EVM VVPAT Management of the districts, SDM Mangan, Samdup Bhutia, SDM Yangyang, Tshering Gyatso Bhutia, DFO West, Tenzing Norbu Bhutia and officers and IT staff of the Office of the CEO, Sikkim were also present.

of EVMs and VVPATs are now monitored by EVMS (EVM Management System). The New EVM Man-

agement System has two components, first is the Web based application and second is a Mobile application. The Web Based Ap-

plication has core functionalities related to EVM management process used by users like Manufacture, ECI, CEOs, DEOs and Warehouse in charge, whereas the Mobile Application supports application used by temporary users mainly for scanning at warehouse level during sending and receiving in AC Strong Room after first randomization.

The total number of EVM Units shifted to South District is 112 (BU), 115 (CU) and 161 VVPATs, followed by 41 (BU) 46 (CU) and 54 **VVPATs** to North District and 82 (BU), 87(CU) and 78 VVPATs to West District respectively.

All the EVM VVPAT

Units are collected by Executive Magistrate from the respective district concerned. A tracking device has been installed in the vehicle carrying EVM Units as per the norms of Election Commission of India to monitor and keep track of EVM Units during the transit which is monitored by DEOs and CEO Office.

Strict SOP for security is also being followed. The vehicle is being accompanied by armed guards and executive magistrates throughout the transit.

India-Pakistan tensions ground thousands of air travellers

LONDON, FEB 28 (AFP): Thousands of air travellers worldwide were left stranded on Thursday after Pakistan closed its airspace in response to escalating tensions with India.

Pakistan's Civil Aviation Authority (CAA) said it would keep airspace shut until 11.59 pm local time, disrupting major routes between Europe and South East Asia.

Thai Airways has cancelled nearly 30 flights, affecting 5,000 passengers.

"All THAI flights from Bangkok to Europe departing near midnight of 27 FEB through early 28 FEB and from Europe to Bangkok departing on 27 FEB have been cancelled due to Pakistan airspace closure," the airline wrote on its Twitter page.

The decision affected its services to London, Munich, Paris, Brussels, Milan, Vienna, Stockholm, Zurich, Copenhagen and Oslo, but the airline said at around 0530 GMT that it was resuming normal operations to Europe.

Singapore Airlines' was also forced to direct flights to Europe to re-fuel, while a flight to Frankfurt was cancelled.

The crisis between nuclear-armed neighbours Pakistan and India has raised fears of an all-out war. Pakistan said it would release a captured Indian pilot on Friday, in an overture towards New Delhi. India earlier said its forces had also shot down a Pakistani fighter jet as Pakistan suddenly closed its airspace early Wednesday.

The CAA said Thursday morning that it had temporarily restored its airspace, with three flights departing from Pakistan as of 1000 GMT.

They were an Emirates service from Peshawar to Dubai, an Air Arabia flight from Peshawar to Ras Al Khaimah in the UAE and a Qatar Airways flight from Peshawar to Doha.

Emirates was earlier forced to cancel 10 return flights to Pakistan while Qatar Airways pulled flights to Peshawar, Faisalabad, Islamabad, Karachi, Lahore and Multan.

Saudi Airlines also suspended all flights to Pakistan "until further notice". In Russia, two flights from Moscow to Vietnam and St. Petersburg to Thailand had to turn back to Russia while a Bangkok-bound flight had to land at Uzbekistan. Air Canada suspended flights to Mumbai and New Delhi, diverting an India-bound flight back to Toronto, while seven services from Istanbul to Pakistan were cancelled.

The closure affected Thai Airways flights to Scandinavia and Pakistani International Airlines flights to Copenhagen, with local television station TV2 television reporting that 25 Danish students were stuck at Bangkok airport.

"The atmosphere is not very good right now. We try to keep up the morale, but it's difficult," said student Sara Bjerregaard Larsen, adding that many were in tears.

Thai Airways struggled to find new routes to Europe with Iran "rejecting" a request to travel over its airspace, according to a spokesperson for the carrier.

The Samjhauta Express, named after the Hindi word for "agreement", comprises six sleeper coaches and an AC 3-tier coach. The train service was started on July 22, 1976 under the Shimla Agreement that settled the 1971 war between the two nations.

From Lahore, the train departs on Monday and Thursday.

The train operates from Delhi on every Wednesday and Sunday.

The sources said the footfall on the train, which generally records an occupancy of around 70 per cent, has fallen drastically post the Pulwama terror attack on February 14 carried out by Pakistan-based Jaish-e-Mohammed in which 40 CRPF jawans were killed.

Pakistan ISLAMABAD, FEB 28 (PTI): Pakistan Prime

Minster Imran Khan announced that IAF's captured pilot Wing Commander Abhinandan Varthaman will be released on Friday as Pakistan's Foreign Ofa "gesture of peace".

The surprise announcement during a joint session of Parliament came barely an hour after Foreign Minister Shah Mehmood Qureshi said that Prime Minister Khan is ready to talk to his Indian counterpart Narendra Modi to de-escalate Indo-Pak tensions.

As the opposition leader Shehbaz Sharif took the floor of the House, Prime Minister Khan apologised for interrupting and said he wishes to announce that the Indian pilot captured by Pakistan Air Force on Wednesday will be released Friday as a "peace gesture".

The announcement was greeted by thumping of desks by Pakistani lawmakers.

Earlier, Qureshi said that Pakistan is willing to consider returning the captured IAF pilot if it leads to "de-escalation"

of tensions with India.

US, Taliban pause negotiations in Doha following 'solid' talks

DOHA, FEB 28 (AFP): Zabiullah Mujahid con-The US and the Taliban have paused negotiations in Doha, with the diplomatic push aimed at ending the war in Afghanistan set to restart over the weekend following "solid" talks between the adversaries. The latest meetings follow marathon talks last month that saw the US and the Taliban walk away with a "draft framework" focused on a potential US troop withdrawal and a pact to prevent Afghanistan from harbour-

ing terrorists. "Emerging from three solid days of talks with the Taliban in #Doha. Meetings were productive," tweeted US special envoy Zalmay Khalilzad, who is leading the American side during the negotiations.

"We continue to take slow, steady steps toward understanding and eventually #peace," he said.

"Both sides will take the next two days for internal deliberations, with plans to regroup on Saturday," Khalilzad added.

Taliban spokesman

firmed the pause, adding the insurgents were "committed to the current peace process along with peace". The US has continued to push for a ceasefire in the war-torn country and the opening of negotiations between the Taliban and the Kabul government.

The Taliban however have repeatedly refused to meet with officials of the Afghan government, whom they dismiss as "puppets". Khalilzad hinted that headway was being made on the issue, tweeting "there is also progress on forming a national team in #Kabul ready to engage in intra-Afghan dialogue and talks with the Taliban".

Earlier in the week the special envoy met with the Taliban's top political leader Mullah Abdul Ghani Baradar in Doha, in what has been touted as the highest-level engagement between the two sides in the months-long diplomatic thrust.

For a Better Public **Transport System**

At least 1,14,293 households would welcome a reliable Public Transport option

Waiting in the rain for a share-cab is not the most relaxing way to begin a work-day, especially since the weather is refusing to play along and now a tourist season also setting in to make the wait for taxis even more frustrating. Not only are the jams enormous and tiring, even taxis are becoming scarce as they chase after the more remunerative sightseeing fares. This development, when taken up along with the growing hesitation among banks to jump at every vehicle loan application, leads to a situation where one can safely assume that the number of new private cars on Sikkim roads will not be growing at the same clip as they did in the decade between 2001-2011. A host of factors came together in that decade to inject an explosion of vehicles in Sikkim, and while this might be all fine if one were looking at vehicle ownership as a sign of prosperity, the traffic jams here led to a mistaken notion that there were enough private vehicles in Sikkim to justify the absence of a decent public transport system here.

Let's hold that thought and begin with vehicle ownership statistics in Sikkim as revealed in the data for households released by the Census of India for 2011. Sikkim had around 1.04 lakh households in 2001 which grew to 1,28,131 households in 2011. While the population grew at its slowest rate in recent times at 12.6% between 2001- 2011 [against 33.6% growth in the previous decade, 1991-2001], four wheel vehicle ownership grew nearly four-times. Where 2.3% of the families in Sikkim owned a car/jeep in 2001, the 2011 headcount revealed that this has now grown to 8.3%. It is now 17 years since that census was undertaken, so chances are that the number of families owning a car of their own has grown some more or possibly the same families are now owning more vehicles. Comparing Sikkim's [per capita vehicle spread against the national average for such ownership throws up some interesting statistics as well. While back in 2001, car ownership in Sikkim at 2.3% was slightly lower than the national average of 2.5%, in 2011, it was nearly double the national average of 4.7%. For those who would prefer real numbers, here it is - while 2,618 of the 1.04 lakh households in Sikkim owned a car in 2001, in 2011, this number had grown to 10,635 families out of the around 1.28 lakh households here. The increase, as mentioned, has been mind-boggling and the endless line of vehicles on the highways and town roads here also projects the mistaken notion that there are already too many vehicles on the roads.

And some might even use this density to argue against adding the burden of a wider public transport system here. But that would be a wrong inference, because while many more families in Sikkim now own cars, the number of Sikkim households without any mode of conveyance is also staggering at 89.2% of the households here. Interestingly, at the national level, while much fewer families on average own a car, only 44.1% of the households own no mode of transportation. Again, for those who would prefer actual numbers - the Census of 2011 found that 1,14,293 households in Sikkim do not own any form of conveyance, neither a car, nor a scooter nor even a bicycle. This number was 1,00,548 in 2001. The point being made here is that nearly 90% of the households are in need of a cheap and reliable mode of transportation.

The road network in Sikkim is already expansive and there are jeeps available to and from every corner of the State. People have recourse to only an occasional SNT bus in most places and private jeep services are expectedly more expensive than what a state operated bus would charge for the same journey. What is also sorely missed in Sikkim is a public transport option for shorter distances. Even the City Runner which has a well advised route connecting Gangtok to the suburbs and nearby towns has too few buses on the road compared the number of commuters who would use it if they were more frequent and better scheduled (at least to the level that the jams on Gangtok's only road will allow). The same applies to the districts.

Fact remains that close to 90% of the population remains denied the option of using a state supported public transport, which, even if it were slower, would also be more reliable [against the tourist season vagaries of private operators], safer and cheaper. The policy makers should perhaps factor the interests of this sector in their future projections.

India and Pakistan's Escalating Conflict Will Benefit Modi Ahead of Elections

Tensions in the Kashmir region were already ■ building after more than 40 Indian troops were recently killed by a suicide bomber. India's "pre-emptive strike" over the disputed border on Tuesday – the first of its kind by India since it went

to war with Pakistan in 1971 - has escalated the situation further. India said it had targeted a terrorist training camp and accused Pakistan of violating a 2003 ceasefire, while Pakistan now claims to have shot down two Indian fighter jets.


The origins of the Kashmir conflict lie in British imperial disengagement from the subcontinent. At independence in 1947, the unpopular Hindu Maharaja of Kashmir was faced with invasion by Pakistani tribesmen. He turned to India for help, signing the treaty of accession that took Kashmir into the Indian Union. India sent troops to Kashmir and so began the first war between India and Pakistan.

The Pakistanis were held off by Indian troops after they occupied one-third of Kashmir in 1948. Today, Pakistan continues to occupy that third and India holds the remaining two-thirds including the Kashmir Valley. The border between these two areas in Kashmir is demarcated by the Line of Control (LoC), established after fighting in 1947-48. This demarcation has changed little in all the conflicts of the subsequent years.

Maharaja Hari Singh's move to join India was supported by the popular secular Kashmiri political movement - the National Conference, led by Sheikh Abdullah. Particularly so, as India agreed a special status for Kashmir within the Indian Union - spelled out in Article 370 of the Indian Constitution. A further article in the constitution prohibits people from outside Kashmir from buying land and property in the state, allowing Kashmir to preserve the balance of its ethnic and religiously mixed population (60% Muslim, 35% Hindu and 5% Buddhist).

Pakistan has always maintained that, in accordance with the logic of partition, Kashmir should have been integrated with it. It attempted to take Kashmir by force in 1947-48 and again in 1965, with no success. The Kargil conflict in 1999 was the last substantial direct confrontation between the two militaries.

Since then there have been regular terrorist attacks on mostly military, paramilitary or government targets in Kashmir - see the full list here. Successive Indian governments have held the Pakistan military and their Inter-Services Intelligence (ISI) responsible for training and aiding the terrorists



involved, which Pakistan denies.

After this latest suicide attack, claimed by the Jaish-e-Mohammad (JEM) terror group, the debate now rests on whether the wider apparatus of the Pakistani state was aware of, and can be held responsible for, the actions of a terrorist group based in their country and with supposed links to the ISI. MODI OPERANDI

The suicide attack that killed Indian paramilitary personnel takes on added significance because it occurred in the context of the looming general election in India in which the BJP, led by Narendra Modi, is trying to retain its grip on power. Modi and his BJP came to power with a thumping majority in May 2014, promising competent, clean government and economic development.

However, things have not gone well for the government in recent months. The Indian economy is suffering from the long-term effects of the decision to demonetise in 2016 and the inability to generate new jobs. The BJP was also defeated in five state elections in 2018, including key states of the Hindi belt such as Rajasthan and Madhya Pradesh.

With Modi's supposed record of economic competence and good governance under challenge, he has increasingly relied on his party's version of extreme nationalism to keep people's support. The BJP's Hindutva ideology sees India as a Hindu country and believes all Indian Muslims should have been forced to move to Pakistan in 1947, and now constitute a fifth column in the country. So an attack such as the recent suicide bombing - whether or not it was actually instigated by Pakistan plays into Modi's narrative.

That the attack was carried out by a young man from Indian Kashmir also serves to illustrate the failure of the Modi government in dealing with the Kashmir problem. For more than three years the BJP was itself part of the government of Kashmir in alliance with the People's Democratic Party of Mohammed and Mehbooba Mufti. This alliance fell apart in 2018, mostly over disagreements between the two parties about how to handle the increase in violence in Kashmir and the radicalisation of young Kashmiris, who were once again taking up arms against India.

The Jaish-e-Mohammad terror group, unusually, took immediate responsibility for the attack. Equally, the Indian response to the attack was a first, in that India has never

before responded to terrorism within its borders by attacking Pakistan. India's airstrike is considered the first major use of air power against Pakistan since 1971.

At this stage there are claims and counter claims from both sides about what the Indian bombing raids achieved. Pakistan is threatening an appropriate response, so there is potential for an escalation of this volatile situation between two nuclear armed countries.

Amid an intensifying war of words and action between the two, the only beneficiary will be the BJP. As jingoistic fervour rises in India, they hope they will be swept back to office on the crest of that wave.

What our new study reveals about the genetics and biology of suicidal behaviour

M ore than three quarters of a million people take their own lives every year, to devastating personal, social and economic cost. Recent research has detailed the strong con-

nection between suicide and mental illness, particularly depression.

Past studies have also shown that those who have lost a relative this way are more likely to consider suicide. This paints a complex picture of suicide as something that has been shown to have both environmental and biological causes.

Now our research has identified specific DNA risk markers which are involved. Our analysis has also shown that people who died by suicide had more of these risk markers, and has indicated the extent of overlap with risk markers for mental illness.

In this largest study to date, we assessed the severity of suicidal behaviours of 157,000 people who answered a survey on mental health and well-being. Crucially this study included people with no diagnoses of mental illness as well as those with known mental illness. We analysed each individual's DNA, the genetic variation for about nine million positions across the genome the complete set of DNA. Genetic variations are the differences in the DNA that make each of us unique.

COMPLEX BEHAVIOUR

Suicidal behaviour is complex and poorly understood. It includes a range of thoughts and actions, from thinking about self-harm through to suicide attempts. Thoughts about self-harm are relatively common in the general population, even in those with no history of mental illness.

Genetic variations influence personality types as well as the risk of mental health problems and alcohol or drug use. But it is also clear that

genetic predisposition is only part cluded physical measurements (such of the issue - broader factors such as personality (impulsivity, pessimism), social (loneliness), economic (deprivation), lifestyle (drug or alcohol use) and environmental (loss of a loved one) also play an important role in suicidal behaviour.



Even without mental illness, negative life experiences (such as bereavement, divorce, financial worries) can trigger distress and despair in people. This can be worse in people with low optimism or perfectionist personalities and can lead to suicidal thoughts and behaviours. People with impulsive or aggressive personalities, or those under the influence of drugs or alcohol, might also act in a way that could injure themselves without realising the severity of the consequences. Access to lethal methods (such as guns) is an important factor in the outcome being self-harm or suicide. LOOKING AT THE DATA

In our study, we sought to identify genetic variations that might be associated with a broad range of suicidal thoughts and behaviours by making use of a very large sample of data from the UK Biobank. The UK Biobank is a study that collected a wide range of information from nearly 500,000 people across the UK. Information in-

patterns), family history of disease,

sample for DNA analysis. Approximately six years after the study began, UK Biobank asked 157,000 participants (from the 500,000 people in the initial study), with and without mental health problems, to complete a comprehensive thoughts and feelings questionnaire. This included a range of questions on mental health and self-harm. Participants were asked whether they had ever:

- 1. considered that life was not worth living
- 2. contemplated self-harm
- 3. self-harmed

4. attempted suicide in the past We used this range of suicidal behaviours - from thoughts about self-harm and ending life to suicide attempts - analysed in order of increasing severity, and identified three regions of DNA containing genetic variations that were associated with suicidal thoughts and behaviour.

By linking to death certification

records (a small proportion of the UK Biobank have died by suicide), we were also able to show that having more genetic variants associated with suicidal tendencies were observed in individuals who died by suicide. When considering summary results (rather than individual data) across the genome, we found that, as expected, there was an overlap (a genetic correlation) between the genetic variants for suicidal behaviours and those that increase risk for several mental illnesses, most notably major depressive disorder and anxiety disorders.

IMPORTANT WORK

Understanding the genetics and biology of suicidal behaviour is challenging but important work because it will help to inform our understanding of mental illness more broadly. Further study of the three regions of DNA can help us to understand the biology of suicidal behaviour - do the genetic variants influence personality traits? Do the genetic variants increase the risk of suicidal behaviour only when combined with lifestyle, social or negative life events? Can these genetic variants be useful in predicting an individual's risk of suicidal behaviour?

More accurate models of suicide risk prediction are urgently needed and are vitally important for public health around the world. Our longterm ambition is that researchers in genetics will work more closely with social and psychological scientists to develop useful models of suicidal behaviour that are informed by evidence from biological, social, psychological and medical research.

It is very clear that both nature and nurture are important factors in suicidal behaviour. Now we need to study how these complex areas interact to influence risk at a personal level, as well as how society as a whole can have an effect on risk of suicide, such as raising awareness about the dangers of loneliness and lack of social connection.

Unfazed by trolls CRPF man's widow pitches for peace with Pak

KOLKATA, FEB 28 (PTI): Unfazed by trolls she faced for her advocacy of peace between India and Pakistan, the widow of a CRPF jawan killed in Pulwama attack Thursday asserted she stands by her view that dialogue should be "given a chance". She also urged the Centre to ensure the safe release of Indian fighter pilot Abhinandan Varthaman, who was captured by Pakistan on Wednesday.

Mita Santra's husband Bablu Santra was one of the 40 victims of the suicide attack on a CRPF convoy in Kashmir's Pulwama on February 14. Mita said she was not worried about the criticism she faced on social media over her anti-war stand. "We should give dialogue a chance instead of war that will lead to loss of so many more lives," Mita told PTI and urged the Government of India to make all efforts to ensure Varthaman's return.

"I urge our government to engage with that of Pakistan to get back Wing Commander Abhinandan Varthaman safely," she said. Varthaman was captured following a fierce engagement be-



tween fighter aircraft of the two sides along the Line of Control in which a Pakistani F-16 jet was downed. The IAF also lost a MiG 21 Bison aircrft being flown by Varthaman, who bailed out but was captured and arrested.

Following the death of her husband, Mita had made a strong anti-war pitch despite calls for avenging the suicide attack, insisting that a war should be avoided as it will snuff out many more lives on both sides of the border, leaving women widowed, mothers without sons and children without fathers. Mita said she was not bothered about social media trolls criticising her stand on war, adding that if one person has criticised her, 10 others appreciated her approach.

The trolls even questioned her love for her husband.

"After February 14, nothing touches me. Anybody can say anything, I am not worried," said the mother of a six-year-old girl. However, she wondered if those criticising her had a family member serving in the armed forces. "Sitting in their homes, some people are saying so many things, but do they have any of their family members in the Army, Air Force, Navy or paramilitary forces?" she asked.

It is natural that the armed forces will have to go to war and make the ultimate sacrifice, but the Indian government must ensure their security, she said.

"I want security of the forces to be ensured. All the forces, be it the Army or the paramilitary like CRPF or ITBP, are of the Government of India and it is the duty of the government to take necessary measures to ensure their security," she said.

BENGALURU, FEB 28 (PTI): Glenn Maxwell would prefer batting higher up the order in ODIs, following his series-winning 113 at number four in Australia's seven-wicket victory against India in the second T20 International.

Maxwell bats at number 7 in ODIs and would happily take a promotion in the five-match ODI series starting in Hyderabad on March 2.

30-year-old The slammed his third T20 international hundred on Wednesday night, an unbeaten 113 off 55 balls, to blow away India and win the series 2-0.

"In my case tonight, when I came out, it was 15 overs to go I think. And as long as I get a 80 or a 100 out of that even, if I am doing that at a No 6 or a 7, it doesn't really matter. It's just me making the most of the opportunities when I get them," said Maxwell.

"It's not easy to just come here and go like that because the ball is a lot older, the wicket's gone a lot quicker here. Even tonight at the end of the game, the wicket's sort of drying out and there was scuffs all over it," he added.

Maxwell believes that in ODIs, he will find it difficult to make a difference at No 7 in most occasions and a promotion up the order may just suit his game.

Open in Florida. It was del Potro's first tournament since injuring his knee at the Shanghai Masters in October.

Del Potro had already pulled out of this week's Mexican Open in Acapulco, which he won last year. He also missed the Australian Open in January.

With del Potro's withdrawal, Taro Daniel of Japan moves into the men's draw. The women's draw already lost two-time winner Maria Sharapova, who withdrew with a shoulder injury. The tournament runs March 6-17 in Indian Wells.

Fun in Acapulco as Nadal eases into second round

ACAPULCO (MEXICO), FEB 27 (AFP): Rafael Nadal powered into the second rounds at the Mexican Open, breezing past Germany's Mischa Zverev in straight sets to advance to a meeting with Australia's Nick Kyrgios.

World number two Nadal, playing in his first event since being thrashed by Novak Djokovic in last month's Australian Open final, was always in control during a 6-3, 6-3 victory.

The 17-time Grand Slam champion completed victory in 1hr 20min at Acapulco's Princess Mundo Imperial venue, defeating his 76th ranked opponent with ease.

The tournament top seed seized the advantage in the opening set, scoring a break to go 3-1 ahead with a delicate lob that left Zverev floundering.

With Nadal's superior variety proving too much for Zverev, the Spaniard quickly wrapped up the

opening set for a 1-0 lead. The second set went enth game, when a wild forehand from Zverev sailed wide to give Nadal the break for a 4-3 lead.

Zverev's hung his head following the miscue, seemingly realising there was no way back.

Nadal then held for a 5-3 lead and wrapped up victory in the ninth game, moving to match point when Zverev could only plop a return tamely into the net.

Nadal then produced a sublime backhand winner down the line to seal a deserved win.

Elsewhere Tuesday, Zverev's younger brother Alex had little difficulty in advancing to the second round, defeating Australia's Alexei Popyrin 6-3, 6-3.

Second seed Zverev's service game overwhelmed Popyrin, with the German hammering down 13 aces en route to victory.

Australia's **Kyrgios** meanwhile was made to work hard for victory in his win over Italy's Andreas Seppi, battling into the second round with a 6-3, 7-5 win.

The off-field controversy erupted after Rahul endured a dismal run in the four-Test series in Australia but he is back in the national team after finding his feet with the India A side.

"It was a hard time no doubt. I mean, as a player, as a person, everyone has to go through difficult times and it was my time to go through that and I like I said it gave me time to reflect on my game, on myself. I have always been someone who takes things as it comes," said Rahul after the second T20 International.

India lost the short series 0-2 but Rahul made a successful comeback with scores of 47

and 50. After he was sent back from Australia, Rahul was given the opportunity to regain form in the India A home series against England Lions and he made it count.

Asked if the entire controversy has changed him as a person, the 26-year-old said:"It has humbled me a little bit and you know. I respect the opportunity that I have gotten to play for the country. The dream of every kid is to play for the country and I am no different.

"Just to value where I am, just to keep making opportunities count and put my head down and keep working on my cricket," said the man from Karnataka.

Rahul said the India A stint under coach Rahul Dravid helped him immensely.

"I got some time off from international cricket, so I could come back to India and reflect on what was not going right for me. Fortunately, I got to play some India A games where the pressure is a bit less and where I could focus on my skill and my technique," said Rahul.

"I got to spend a lot of time with Rahul Dravid, working on my game and chatting about cricket. He helped a lot in the five games I played for India A. The time I have spent in the middle has helped. It is nice to be back with the boys and back in blue," the relief was palpable as he spoke.

Rahul hopes that it is a blessing in disguise that he courted controversy early in his international career.

"I hope so. Things happen like I said. Fourfive years with Team India . Learnt about the game, where I stand as a cricketer, as a person so just try to get better from there and be consistent and keep performing."

Rahul admitted that he felt the pressure after making a comeback into the Indian team.

"There was little bit of pressure as I have been away from team. But I came into the series with a little bit of runs, so yeah happy to be back."

India were not able to defend 190 for four on Wednesday and ended up being outplayed in the series. Local hero Rahul said chasing at Chinnaswamy in the night becomes easier with dew factor playing out.

"In the second innings, dew always has an effect. We have seen that in Chinnaswamy. If you see the stadium's history, chasing has been easier. But can't take credit from Glenn Maxwell.

"He (Maxwell) played a very good innings. Our bowlers tried their best but with a wet ball, it was always hard," said Rahul, adding that India will have to find a way to contain Maxwell in the fivematch ODI series starting on March 2.

3rd ODI: England register consolation win, avoid whitewash against India

The World Champions are placed in seventh place and need to be in the top four to qualify directly for the 2021 World Cup.

India had already sealed the series after the winning the first two games.

Defending the target, veteran pacer Jhulan Goswami (3-41) rattled the England top-order, removing Amy Jones

Pakistan Army says troops on high alert along LoC



ISLAMABAD, FEB 28 (PTI): The Pakistan Army said on Thursday that its troops are on high alert along the LoC with all required safeguards to thwart any "Indian aggression" amidst tense ties with New Delhi.

The Pakistan Army's statement came amid tensions between India and Pakistan in the wake of the Pulwama terror attack claimed Pakistan-based Jaish-e-Mohammed (JeM) terror group.

"Due to the prevailing environment, the Pakistan Army troops are on high alert along the Line of Control (LoC) with all required safeguards along the Eastern Border in place to thwart any Indian aggression," army spokesman Major General Asif Ghafoor said in a statement.

He said that the Pakistan Air Force and Pakistan Navy continued to stay fully alert.

"During the last 48

Indian troops hours, resorted to increased ceasefire violations in Kotli, Khuiratta and Tatta Pani sectors along the LoC," Ghafoor said.

Pakistan Armed Forces are in a state of readiness for all eventualities, the spokesperson added. India carried out air

strikes against the biggest training camp of JeM in Balakot on Tuesday. In the operation, a very large number of JeM terrorists, trainers, senior commanders and groups of jihadis who were being trained for suicide attacks were eliminated. The facility at Balakot was headed by Yousuf Azhar, the brother-in-law of the JeM chief.

Trump 'walks' as North Korea talks end abruptly without deal

HANOI, FEB 28, 2019 (AFP): The US-North Korea nuclear summit in Hanoi ended abruptly without a deal Thursday, with President Donald Trump saying he had decided to "walk" in the face of Kim Jong Un's demands to drop sanctions.

The much-anticipated second meeting between the two leaders was supposed to build on their historic first summit in Singapore, but they failed to sign a joint statement as initially scheduled and the talks ended in deadlock.

"Sometimes you have to walk and this was just one of those times," an unusually downbeat Trump told reporters.

"Basically they wanted the sanctions lifted in their entirety and we couldn't do that," said.

But Trump insisted he was "optimistic that the progress we made" before and during the summit left them "in position to have a really good outcome" in the future. "I'd much rather do it right than do it fast," he added.

He noted Kim had vowed not to resume nuclear or ballistic missile testing -- something he previously identified as a yardstick for success -- but said a third summit with the Pyongyang strongman was not on the cards so far, despite reiterating their "close relationship".

"We just like each other... there's a warmth that we have and I hope that stays, I think it will," said Trump.

The outcome in Hanoi fell far short of the pre-meeting expectations and hopes, after critics said their initial historic meeting in Singapore was more style over substance.

"This is a major failure," tweeted Joe Cirincione, president of the Ploughshares Fund peace



foundation. It showed the limit of summitry, he added, with "not enough time or staff" to work out a deal

In the original White House programme, a "Joint Agreement Signing Ceremony" had been scheduled in Hanoi as well as a working lunch for the two leaders.

In the event, both men left the summit venue without signing anything and Trump moved up his news conference by two hours.

Ankit Panda, from the Federation of American Scientists, warned on Twitter that the White House's expectation of further talks "does not have to be a perception shared in North Korea." "Kim may have left irate, for all we know. He may have no intention of continuing this," added Panda.

Trump flew around the world for the meeting and Kim undertook a mammoth two-and-a-half-day trek through China in his olive green train, travelling 4,000 kilometres (2,500 miles).

At first the smiles and bonhomie from Singapore ran on into their

second date in Hanoi as Trump touted the "special relationship" between the two, although concrete statements were vague. The US president frequently dangled the prospect of a brighter economic future for a nuclear-free North Korea, at

one point saying there was

"AWESOME" potential.

From the outset, he had appeared to down-play expectations of an immediate breakthrough in nuclear talks, saying he was in "no rush" to clinch a rapid deal and was content if a pause in missile testing continued.

But Harry Kazianis, Director of Korean Studies at the Centre for the National Interest, said that no agreement was better than a bad one.

There would be "nothing worse than signing a deal just to get something", he told AFP.

"The challenge is North Korea's nuclear weapons are already a reality," he added. "Getting a deal that does little to nothing to remove that threat would be far worse than a flawed deal." - 'Rocket man' -

In Singapore the two

signed a vague document in which Kim pledged to "work toward complete denuclearisation of the Korean peninsula".

Progress subsequently stalled, with the two sides disagreeing on what that means, as the North sought relief from sanctions and Washington pressed for concrete steps towards it giving up its weapons.

As in Singapore, the two men put on a show of bonhomie in Vietnam, appearing to share jokes in front of reporters.

Looking relaxed but appearing to say little, they indulged in a poolside stroll Thursday around the gardens of the luxury Metropole Hotel, a colonial-era building that has played host to stars ranging from Charlie Chaplin to Brad Pitt.

It was a far cry from the height of missile-testing tensions in 2017 when Trump slammed Kim as "rocket man" and the younger man branded the American president a "mentally deranged US dotard".

In apparently unprecedented scenes, Kim answered unscripted questions from foreign reporters, saying he would welcome the establishment of a US liaison office in Pyongyang, which would be a step on the way to diplomatic normalisation.

Before the summit, there was talk that there could be a political declaration ending the 1950-53 Korean War which finished technically with an armistice rather than a peace treaty.

There were also hopes Kim could pledge to destroy North Korea's decades-old Yongbyon nuclear complex, which has long been at the heart of Pyongyang's atomic development but remains shrouded in secrecy. North Korea has promised to mothball it twice before.

A patent distraction from the summit was a scandal back home in Washington with Trump's former personal lawyer and fixer Michael Cohen calling him a "racist" and a "conman" during a congressional hearing.

Ex-Nissan chief Carlos Ghosn makes fresh bail request

TOKYO, FEB 28 (AFP): Lawyers for former Nissan chief Carlos Ghosn on Thursday filed a fresh bail request for the auto titan who has been detained for more than three months, the Tokyo District Court said.

It is the first bail request filed by the 64-year-old since he shook up his legal team as he crafts his defence to three charges of financial misconduct.

The former high-flying executive has been in detention since his shock November 19 arrest, and has tried repeatedly without success to secure bail.

Reached by AFP, an assistant lawyer for Ghosn's lead attorney declined to explain how the bail request would differ from previous filings.

"We can't comment on details, including any differences in approach this time.

We plan to explain about details when we hold a news conference next week," he said.

Ghosn's previous legal team even deployed a rarely-used article of the Japanese constitution to force the court to explain

why the Franco-Lebanese-Brazilian remained in detention.

A judge said Ghosn's continued detention was justified because he posed a flight risk and there was a possibility he would conceal evidence.

Ghosn and his lawyers have argued that neither of those is the case, and he even offered to wear a tracking bracelet and hire guards to monitor his whereabouts, pledging to stay in Japan.

But so far the courts have shown no inclination to end his lengthy pre-trial detention, which has drawn some criticism internationally and from rights groups.

Prosecutors have defended his detention while they investigate three charges of financial misconduct, two involving alleged under-reporting of his salary and a third over a complex scheme in which Ghosn allegedly sought to transfer his

Ghosn has denied all the allegations against him, and in an interview with AFP from his Tokyo detention he slammed

losses to Nissan's books.

his continued detention.

"Why am I being punished before being found guilty?" Ghosn asked, speaking to AFP and the Les Echos daily in January.

The refusal to grant him bail "would not be normal in any other democracy", he said.

Ghosn earlier this month shook up his legal team, replacing his previous lead lawyer -- a former prosecutor -- with hot-shot lawyer Junichiro Hironaka, who has a history of taking on high-profile cases.

Ghosn's November arrest sent shockwaves through the auto industry in Japan and beyond.

A towering figure once revered in Japan for turning around Nissan's fortune, Ghosn also forged a successful alliance between Nissan, Mitsubishi Motors and France's Renault.

But his attempts to deepen the alliance caused resentment in some quarters, and Ghosn has claimed the allegations against him are part of a "plot" by opponents of greater integration between the three firms.

Jin told The Associated Press from her home in Los Angeles that Jiang's sister and father have also been missing since Wednesday afternoon, when they were supposed to have been escorted to the prison by state security agents.

Jiang defended politically sensitive clients like blind legal activist Chen Guangcheng. He was sentenced to two years in prison in 2017 on the vague charge of inciting subversion of state power.

UN chief Guterres following with 'deep concern' escalating tensions between India and Pakistan

UNITED NATIONS, FEB 28 (PTI): UN Secretary-General Antonio Guterres is following with "deep concern" the escalating tensions between India and Pakistan, calling on both sides to urgently take steps for a "meaningful mutual engagement".

In the wake of the Pulwama terror attack by the Pakistan-based terror group Jaish-e-Mohammad (JeM), tensions have escalated between India and Pakistan.

India carried out air strikes against the biggest training camp of JeM in Balakot. In the operation, a very large number of JeM terrorists, trainers, senior commanders and groups of jihadis who were being trained for suicide attacks were eliminated. The facility at Balakot was headed by Yousuf Azhar, the brother-in-law of the JeM chief.

Following the air strikes by India, Guterres again stressed on his urgent appeal to the governments of India and Pakistan to exercise maximum restraint to ensure that the situation does not further deteriorate. The UN chief is "obviously, following the situation as we see it even today with deep concern, and his the United Nations' message, both publicly and privately, to both sides is to urgently take steps to lower tensions through meaningful, mutual engagement and meet their responsibilities to maintain peace and security in the region," his spokesperson St phane Dujarric told reporters Wednesday. Asked if Guterres spoke to the leaders of India and Pakistan following another day of escalating tension and plans to get involved to try and mediate a de-escalation, Dujarric said Guterres had received a call Tuesday from Pakistan's Foreign Minister Shah Mahmood Qureshi, adding that there have been contacts at various levels with all sides.

He said that "as always", the Secretary-General's good offices are always "available should both parties or all parties, depending on the situation, agree to do that".

The spokesperson said the UN chief, through his contacts and others, are in touch with the relevant parties to pass along the message of the need to take steps to lower tensions and exercise maximum restraint. Dujarric said contacts have been made at various levels between the UN and India and Pakistan but did not give further details as to which officials in India the contacts have been made with.

Asked about the UN's role at this point in the situation, he said that the Secretary-General is "kept apprised" of the situation and he is following it. "Discussions are being held at different levels with different parties to make sure that we have we get a full picture of what is going on and the message coming out of those discussions is on the need for both countries to do whatever they can to de-escalate the situation," he said.

In the days following the Pulwama attack, Guterres repeatedly


stressed on the importance for both sides to exercise maximum restraint and take immediate steps to de-escalation.

Guterres reiterated his strong condemnation of the terrorist attack against Indian security forces and said it is "essential that there be accountability under international law and the perpetrators of terrorist acts be brought swiftly to justice". At the same time, the Secretary-General "urgently" appealed to the governments of both India and Pakistan to exercise maximum restraint to ensure the situation does not further deteriorate, the UN chief's spokesperson said.

The UN Security Council in a press statement issued last week also "condemned in the strongest terms the heinous and cowardly" suicide bombing in Pulwama.

The 15-nation Council "underlined the need to hold perpetrators, organisers, financiers and sponsors of these reprehensible acts of terrorism accountable and bring them to justice, and urged all States, in accordance with their obligations under international law and relevant Security Council resolutions, to cooperate actively with the Government of India and all other relevant authorities in this regard". Cuaron does not believe Netflix pushback cost 'Roma' its Best Picture Oscar

Alfonso Cuaron, whose "Roma" missed out on Best Picture Oscar to "Green Book", says people may have been scep-

tical initially about Netflix's involvement but the conversation has changed because it connected with people the way "usually only mainstream films do".
