Covid third wave end of August, may be comparatively mild: Medical **Body**

NEW DELHI, 15 JUL [NDTV]: The third wave of Covid is likely to hit the country at the end of August and chances are that it will not be as intense as the second wave, Dr Samiran Panda, Head of Epidemiology and Infectious Diseases at the Indian Council of Medical Research, has told NDTV.

"There would be a nationwide third wave but that does not mean that it would be as high or as intense as the second wave," Dr Panda told NDTV in an exclusive in-

Four things, he said, could lead to the third wave. The first of these is an instance where the immunity acquired in the first and second wave due drop. "If that goes down, it could lead to a third wave," he said.

Secondly, there could be a variant that can bypass the immunity acquired. Third - the new variant may not be able to bypass immunity but can circulate fast in the population.

Fourth -- if the restrictions are lifted prematurely by states, it could lead to a fresh surge, Dr Panda said.

Asked if the variant involved could be Delta Plus, he said both Delta and Delta Plus have swept the country and "I'm not expecting any more public health havoc from the Delta variant".

Earlier this week, the top doctors'body in the country, the Indian Medical Association, said the third wave is "inevitable and imminent", pointing out that "in many parts of the country both the government and public are complacent and engaged in mass gatherings without following Covid protocols".

CM CHAIRS REVIEW MEETING ON COVID-19

State Govt announces fresh restrictions to curb COVID-19 spread



GANGTOK, 15 JUL (IPR): Chief Minister Prem Singh Tamang chaired a high-level meeting at Samman Bhawan, Gangtok, today, to review the Covid-19 situation in the State and to deliberate on the way ahead.

The meeting had the presence and participation of Ministers, DGP, Additional Chief Secretaries, Heads of Departments, senior Government officials, District Collectors, Chief Medical Officers, Health Department officials, ADCs (Development), and officers of the Covid-19 Management Group.

The Chief Minister issued strict directives to the District Collectors, SPs, ADC Development and BDOs to ensure that strict measures are adopted to contain the spread of Covid-19 any further. He called for the need to review the containment measures. He further called for emphasis on home quarantine even for people who move out of their ward or village. He urged the District Administration to review the paid quarantine facilities for people entering the State through the inter-state borders. He further urged the Health Department officials to enhance mass testing.

The Chief Minister lauded the Health Department for successful implementation of the vaccination programme. He called for additional measures to ensure 100% coverage.

NEW RESTRICTIONS

- Complete ban for one monthon all socio-religious and entertainment related activities like marriage, pujas and birthday parties and other get-togethers, both in urban and rural areas.
- Restrictions on serving food and beverages during funerals and last rites.
- Only in-house puja or rituals will be allowed in religious places. There will be complete ban on visitors to any religious place or institution.
- End practice of issuing special permits, other than for health and police personnel.
- Police will strictly enforce odd-even rule for vehicles without any exception.
- If any person in a ward or village tests positive, the entire ward will be declared a containment zone and strict measures will be enforced to prevent further spread. In case of urban or semi urban areas or towns, the entire building will be contained.
- Any relief work, social or medical service should compulsorily be routed through the District Collectors.
- IEC and mass awareness on Covid Appropriate Behaviour will be upscaled. Strict penalty on people and establishments violating Covid-19 guidelines.

Worryingly for Sikkim, there are 13 Covid patients currently being attended to in ICU facilities at STNM Hospital and Central Referral Hospital.

Binoy Tamang resigns, winds up his faction of GJM

President of Gorkha Jan-mukti Morcha (Binoy faction) Binoy Tamang resigned from his post and party today. He said that this is the end of the Binoy faction of GIM and Bimal Gurung now leads GJM.

Addressing a press conference today, Mr Tamang said, "During the 2017 Gorkhaland agitation, I decided to divide Gorkha Janmukti Morcha into two factions but today I want to end the Binoy faction and return the party flag to Mr Bimal Gurung because he is the founder president of GJM. I request all the party leaders from GJM (Binoy faction) to change the faction's name as per the High Court verdict."

Mentioning that there are many reasons behind his resignation. Mr Tamang said that his party has lost two elections and since 2019 there has been a conspiracy at the national level to throw him out of politics.

"This is not the end of my political career. I will come back stronger and that will be my third phase of politics. I have been with two political parties - Gorkha National Liberation Front (GNLF) and Gorkha Janmukti Morcha. My next journey will be in the interest of Darjeeling Hills and all Gorkha community," said Mr Tamang.

Reacting to the statement given by Binoy Tamang, general secretary of GJM (Binoy faction), Anit Thapa said that he was shocked when he heard of the resignation.

"I will respect Binoy Tamang forever. When Darjeeling Hills was suffering, he did his best to solve the problem. I am totally shocked. It would have been better if he had called a meeting and talked about everything. But he is a senior politician, maybe he thought of what is best for the future. I will always follow his path," said Mr Thapa.

Bimal Gurung, president of GJM (Bimal faction) said he respects Mr Tamang's decision. "I believe we don't

What Oxfam India's study reveals about Assam's Tea Workers

Only 39 percent of workers can be considered as permanent workers, while the remaining 61 percent are temporary workers when social security and other mandated provisions under the Plantation Labour Act (PLA) are taken into consideration," the report titled "In Defense of Living Wages for Tea Plantation Workers: Evidence from Assam" observed.

As per the study, a tea worker's average family income per month is 2 4,774 (without deductions) while the average expenditure on food

non-food expenditure is 3,895. The average deduction by the employer is 778 which varies across tea estates. Therefore, after deductions, the in-"There exists a growing hand income of a tea worker is around 3,996 per month with variations across districts.

The workers are entitled to get 167 per day which is inclusive of both cash and non-cash benefits, but their wages range between 160 to 180 per day, the study noted.

The study estimates that for tea workers to have a dignified life, their compensation should include 285 per day as expenditure on food items (considering 4 members in family) and 599 per day as expenditure on non-food items, both essential and non-essential utilities. Therefore, their living wage should be 884 per day, the study concludes.

that during the Covid-induced nationwide lockdown, only 10 percent of the respondents worked. Women were more severely impacted by the lockdown and were not able to work for 45 days on an average, while for men the duration was 33 days. The study has been con-

ducted jointly by Oxfam India and Dr. Rahul Suresh Sapkal, Assistant Professor, Centre for Policy Studies, IIT Bombay and the research is based on a primary survey which included 5,000 tea plantation workers spread across seven districts -- Biswanath, Dibrugarh, Tinsukia, Lakhimpur, Tezpur, Golaghat and Sivasagar -- in Upper Assam during the period of October to December last year.

The report also observed believe that the findings will make all stakeholders in tea sector to work for their welfare. The study finds a stark gap between the current wages that tea workers receive vis a vis the living wages that has been calculated. We appeal to the government and tea industry to consider an upward revision of the wages to improve the lives of the tea workers," Amitabh Behar, CEO Oxfam India said.

Ahead of Assam's 2021 Assembly elections, the BJP-led government promised a wage hike to the tea labourers. The government then raised the wage by 50 but withdrew the hike following a lawsuit at the Gauhati High Court by the tea estate owners. Assam government, instead, announced the setting up of a new committee for fixing the minimum wage of the tea workers.

India's farmer protest and the issue of stubble burning

The government and farmers clashed last year on the farm bill and the issue further aggravated into prolonged conflict. The NDA government had brought huge changes in the agricultural

sector from economy to environmental factor. The farmers had huge discontent with the government about the bill because it had brought comprehensive changes which ended the monopoly system of Mandi. It also brought the private players in the sphere to negotiate with the farmer. The bill had also produced about the proper disposal of crop residue after the harvest is completed. The burning of this crop residue has aggravated air pollution which affects the atmosphere and the quality of air. According to the Ministry of New and renewable energy (MNRE), India generates on an average 500 million tons of crop residue every year. The highest emission of stubble burning comes out from the states like Uttar Pradesh (23%), Punjab (22%) and Haryana (9%).

Environment problems have an intrinsically transnational character; they do

fore environmentally vulnerable to the economic activities that take place outside their territorial jurisdiction. All human beings have equal rights to use global atmospheric commons, despite the equal importance some advanced countries had benefited it indiscriminately creating further environmental problems. The Stockholm conference led to the establishment of UNEP, which is responsible for coordinating the environmental activities of states and international organizations to promote better regional and global environmental protection. In 1997 Kyoto protocol was enacted in order to mitigate the proportion of greenhouse gases in the atmosphere. The presence of greenhouse gases increases the earth temperature and lead to various trajectories, for example of melting of ice, increase in the earth temperature. The problem with this type of agreement is, states in the long run abandon their commitment and pursue their interest. The developed countries use economic and political leverages to escape from the climate protection has to be holistic rather than individualistic.

India's farmer protest has showed the resistance of farmers, despite of the government bringing huge changes in the agriculture sector. The issue revolves around on the political and economic sphere, very little concern was given to the practice of stubble burning and its impact on the health of the people and global warming. Farmers opt

for burning stubble is because of its easy way to manage the large crop residue, inadequate resource and shortage of labors.

At present approximately 23% wheat straw was taken as fraction burnt in the states of Haryana, Himachal Pradesh, Punjab and Uttar Pradesh and for the rest it was 10%. For sugarcane trash it was considered that 25% of the trash is burnt in the fields.. The main reason for the burning of stubble is because of the short duration available between the harvesting of paddy and sowing of wheat. This rule was laid down by the

2009 Punjab preservation of subsoil act, where the paddy transplantation date is fixed for June 20 which pushes ahead of the harvesting of rice crops. After that, the farmers only get 20-25 days to sow the new crops. Hence, they rely upon the quick and easiest solution i.e. burning of field. The air pollution act of 1981 focuses on the preservation of the quality of air and control of air pollution, the center is responsible for passing the law but

the responsibility for the implication lies at the provincial and local levels.

India is the third-largest emitter of greenhouse gases behind China and the U.S, about a fifth of these emissions, are from the agricultural sector. since 2000, India's agriculture production emission has increased by 14 per cent. Due to the high rate of burning of crops residue in Punjab, Uttar Pradesh and Haryana many airborne diseases are flown capital affecting the lives of many. The poisonous gas like carbon monoxide which is released when the stubble is burned, if inhale reduces the blood efficiency to take oxygen and generate respiratory problems. The problem of Acute Respiration Infection (ARI) is particularly increasing in children due to the high respiration rate among children.

The issue of stubble burning in states like Punjab and Uttar Pradesh had not only created breathing problems and health hazards but contributed to global warming. To deal with Stubble burning government has to come up with a holistic approach focusing on crop diversity, sustainable development and using green technology (for example happy seeder). Indian farmer protest is a local issue, but if it is integrated with climate change it becomes global. The protest did gain huge support from all over the world, mainly supporting the economic cause of the farmers but very few looks in the environmental aspect as the bill also focused on the waste management.

Exploring the fate of Indo-Bangladesh border Haats amidst Covid-19

ccording to Nazneen Ahmed (Ahmed, **A**2021), a border haat is a 'rough and ready market' allowing 'local people to trade in locally-grown agricultural and manufactured' items along the border. The word 'haat' is specific to the South Asian context and it is also interchangeably used for the word 'bazaar' in hindi. The first border haat was initiated on the 13 Jan, 2015, in the south district of Srinagar. Since then three more haats have been established along the Indo-Bangladesh border, which have all been successful in their goal of promoting wellbeing of the people living along the borders. Border haats, unlike the haats that operate within the country, require joint cooperation of both the countries concerned for their smooth functioning. Since these markets exist at the borders, they are also sensitive to global and geopolitical changes that occur on a macro level.

The coronavirus pandemic, first known as Sars-Cov2, and now as Covid 19, was first detected in China in 2019, and it arrived in India in 2020. It has become the greatest existential threat worldwide, shutting down entire sectors of world economies, and devastating small and medium enterprises in an unprecedented manner. Nations had to impose severe lockdowns in order to contain the spread of the virus, resulting in very strict restrictions and even an indefinite shut-down of border trade from the middle opening of Kalaichar haat in January 2021, restrictions have been stricter, affecting the number of visitors who can enter a shop at a given time.

The four operational haats along the Indo-Bangladesh border have had tremendous significance for the inhabitants in the region. Firstly, they are the most essential source of livelihood for the people, and sometimes the main reason behind the decrease in the once thriving illegal trade at the border. Infact, illegal trade has reduced significantly since the haats have begun to operate. The degree of womens' participation in the haats as small and medium entrepreneurs has also increased impressively due to the ease of carrying

out trade in the haats. The socio-cultural significance of the haats cannot be stressed enough, given their role in the reunion of numerous families separated for generations by the Radcliffe Line (Haque, 2020). Poverty and remoteness rendered the border inhabitants unable to get visas for visiting their families across the border for decades. and this situation improved only when the haats were established which allowed them to visit each other legally.

The coronavirus pandemic brought with it the consequence of a nation-wide lockdown. Given the nature of border haats as open markets dependent on people-to-people contact, the question naturally emerges about the scale of damage caused on border of March 2020. key question that arises is about the impact of the pandemic on the positive changes entailed by the haats, most significant being the increased participation of women in public life at the border region. Border haats carry immense potential for encouraging bilateral trade, and increasing the incomes of both nations. Yet they have been underutilised due to a variety of factors. According to Shreeradha Dutta, there is a need to frame border haat development within the greater framework of border aea development as a

Virus spreads in S. Korean regions with lighter restrictions

SEOUL, SOUTH KOREA (AP): South Korea reported a near-high in coronavirus infections Thursday as a weekslong surge extends beyond the capital region and the country's toughest pandemic restrictions.

The surge, increasingly fueled by the more contagious delta variant, is a worrisome development in a country where 70% of the population is waiting for their first vaccine dose. It further erases what had been a success story in the pandemic and underscores the challenges policymakers face in balancing measures to control virus outbreaks without further damaging their economy.

"Over the past week, there has been a clear increase in the speed of transmissions not only in the (Seoul) metropolitan area but also in nonmetropolitan areas," said Bae Kyung-taek, a senior Korea Disease Control and Prevention Agency official, during a brieting. "We ask our people to cancel unnecessary meetings and refrain from going out as much as possible."

Thursday's 1,600 new cases nearly matched South Korea's high from a day earlier and was the ninth straight day exceeding 1,000. The country's caseload is now 173,511, including 2,050 deaths.

Most were in Seoul and nearby Gyeonggi province and Incheon.

raised social distancing restrictions to the highest "Level 4," closing nightclubs and churches, banning visitors at hospitals and nursing homes and clamping down on private social gatherings of three or more people after 6 p.m.

But rising infections outside the capital area are prompting calls for virus restrictions to be elevated nationwide. The 494 cases outside the capital region were the highest since February 2020, when the country dealt with its first major outbreak, which was mostly limited to the southern city of Daegu and nearby areas.

The virus is once again circulating quickly in southern regions, with Daegu, Busan and South Gyeongsang province reporting more than 200 cases combined. Health workers here are scrambling to trace infections linked to various places, including hostess bars, restaurants, schools and offices.

More than 110 cases were reported in the central city of Daejeon and nearby South Chungcheong Province, where hundreds of hostess bars in Cheonan are participating in voluntary closures at least until Sunday over virus concerns.

The regions outside

the greater capital area are currently maintaining Level 1-2 restrictions, which allow for social bubbles of up to eight people and for restaurants, bars and nightclubs to receive custom-

ers until midnight. Busan, South Korea's second largest city, has added extra precautions to its Level 2 rules since last Friday, forcing entertainment venues to close after 10 p.m. and prohibiting social gatherings of five or more people after

Some experts have urged the government to elevate distancing measures simultaneously across the country to prevent a "ballooning effect" where the squeeze in the capital area spikes transmissions elsewhere. But KDCA officials during the briefing said such action isn't currently being discussed.

South Korea was praised for its initial response to the pandemic that included aggressive and contact tracing, but the early success was followed by months of complacency before the country was hit by a devastating winter surge.

Critics say the country has slipped into another huge wave of the virus in a similar way it sleepwalked into the crisis in December and January, with officials sending the wrong message to the public by pushing for a premature easing of social distancing.

"Appalling Apathy": Rights body for CBI probe in Bengal post-poll violence

KOLKATA, 15 Jul tinued. There is palpa-[NDTV]: Accusing the West Bengal government of "appalling apathy" towards victims of political violence after the March-April elections, the National Human Rights Commission (NHRC) has recommended a CBI probe into "grievous offences like murder and rape" and said that these cases should be tried outside the state.

In a sweeping indictment of the state government, an NHRC committee formed on the directions of the Calcutta High Court said the situation in West Bengal was a "manifestation of law of ruler instead of rule of law" and "the local police has been grossly derelict, if not complicit, in this violence."

Backing claims of "retributive violence by supporters of the ruling party against supporters of the main opposition party" the BIP, the report placed before the high court said that it "resulted in disruption of life and livelihood of thousands of people and their economic strangulation."

"To compound the problem, violence and intimidation has con-

ble fear among victims against police and goons of ruling party. Many displaced persons have not yet been able to return to their homes and resume their normal life and livelihood. There have been several sexual offences but victims are scared to speak out. Loss of faith in State administration among victims is very evident," the NHRC said.

"The committee has recommended that grievous offences like murder, rape, etc should be handed over to the CBI for investigation and these cases should be tried outside the state," the report, submitted before the court on Tuesday, said.

The statements, however, have not gone uncontested. West Bengal Chief Minister Mamata Banerjee on Thursday lashed out at the NHRC for "disrespecting the court" and pursuing the "political vendetta" of the BJP by leaking its report.

Ms Banerjee also expressed surprise over the conclusion that the NHRC arrived at in its report without taking into account the views of the state government.

Missed Opportunities

Disaster preparedness should undertaken on mission-mode, 24x7

The 18 September 2011 Earthquake was a water-I shed event for Sikkim in as far as natural disasters are concerned. The scale of the earthquake was unprecedented for the mountain state and the Sikkimese should consider themselves extremely lucky that the nature of damage and number of casualties were not even close to what the temblor had potential to deliver. Yes, the damage to property and the loss of lives were higher than anything recorded in Sikkim in the past, but if one were to step back and take count, the devastation was clearly not of the scale or kind that one has seen in earthquake ravaged regions elsewhere. It was perhaps because of this relatively light penalty exacted by such a major tectonic event that Sikkim, in the decades since, has not undertaken the disciplining so essential for a mountain state to continue living in relative security. Given that Sikkim has a history of living with natural calamities, preparedness should have been a way of life here instead of something people need to be reminded about at workshops. In fact, preparedness was an instinctive practice here until centralized planning started complicating everything and ruining lifestyles. And that brings one to the present situation where even those who have been working on disaster mitigation will admit that Sikkim is still woefully unprepared for calamities. And it is not just lack of preparedness which hamstrings Sikkim; bad planning, irresponsible development/ construction and poor involvement amplify the potential threats.

Even students preparing debate arguments from Wikipedia tips will passionately highlight that while disasters like earthquakes, landslides and floods might be "natural", casualties are largely manmade. To understand what one is getting at here, sample this: In 2010, two earthquakes struck the Americas. The one in Haiti killed more than 3 lakh people, but a much greater earthquake in Chile a few months later killed less than 600. The Chileans were better prepared, had stricter building codes and had trained rescue teams. After 18 Sept 2011, one knows that Sikkim has potential for Chile-like earthquakes. A followup question would then ask why then does it continue to live with Haiti-like ill-preparedness?

There is also an attitudinal handicap at work here. The post-18 Sept months and years have been invested with rebuilding projects, rehabilitation efforts and have been marred with allegations of favouritism and victimization. The government even released a white paper on the matter. Transparency and accountability are always welcome, but what has been inexcusably missing from official and public engagements has been any earnestness to learn from the earthquake lesson. There does not appear to have been any genuine effort towards documenting state and private response to the earthquake or recording what went right and where mistakes were made. This exercise not having been undertaken, no preparedness plan will be complete because lessons learnt on ground remain undocumented and unrecorded. And these lessons would still have only informed rescue operations. Safety will require a different level of engagement because that would demand stronger political will, a more responsible executive and a more involved citizenry.

Even if one were side-step responsibility from dealing with natural calamities and crediting such events to acts of god, the state continues to lack excuses to explain why the rapidly urbanizing towns are developing as death-traps. This is wet season, but dry winters will arrive soon enough and that is also fire season. No fire is easy to fight and Sikkim is lucky that it has brave fire-fighters. It is also lucky that no fire has conflagrated into anything bigger than the force's limited resources and woefully understaffed fire-fighting units. But that does not mean that such an inferno will not test Sikkim ever in the future. Preparedness thus becomes important in this aspect as well. It is not enough to rely on the commitment and professionalism of its firemen alone. Preparedness for worst case scenarios should be a policy-directed initiative and mitigation plans clearly spelled out and widely circulated. We are in the thick of monsoons at present, so there is nothing beyond repairs and clearing we can do at present.

Generation COVID: pregnancy, birth and postnatal life in the pandemic

The pandemic made bringing a baby into the world ■ an even bigger challenge for all new and expectant parents. As a photographer and researcher of visual cultures, I realised this would also be a unique opportunity to capture how COVID restrictions and unprecedented lockdowns impacted this life changing experience for me and my partner.

I began photographing our journey shortly after we got a positive pregnancy test in November 2019. The plan was to document Charley's pregnancy, but the project quickly grew as I explored the effect of COVID-19 on our experience.

Yet it could have been so different. We had planned to have a homebirth because of COVID restrictions on birth partners. But Charley ended up being induced at the hospital and was left to labour alone through the night on the antenatal ward. Our homebirth midwife and I got there just in time to see my baby daughter being born. Charley received support on the phone from her doula (a person who supports a mother through labour and birth) and used the birthing techniques she had learned in online tutorials during her pregnancy. She said:

"I felt confused and distressed throughout my labour and counted down the minutes until I would see James and my midwife again. I knew as soon as I saw them that everything would be OK and I would finally receive the support I so desperately needed."

Moments after our baby was born, the midwife asked me to push the emergency alarm button. A siren sounded immediately and seconds later hospital staff filled the room. Charley was rushed to theatre after experiencing a major obstetric haemorrhage and suddenly we were separated. Fortunately, she had expressed plenty of colostrum (the first form of breastmilk) and I was able to feed our new baby girl using a syringe.

This time in the recovery area is a blur. I received updates from midwives and surgeons dashing to and from theatre as other partners were being reunited with women and their babies. One midwife recognised me behind my mask and reassured me as I cared for our daughter.

Immediately after the birth I took a photograph of Charley with our newborn baby and our midwife. It was later shared widely on Instagram and I began to receive hundreds of messages from other people who wanted to tell their own stories about what it was like having a baby under pandemic restrictions. One woman, Stacey (35, London) told me it felt like she had "given birth to a secret baby, behind closed doors".

And so the Pregnant in a Pandemic project was born: to give a voice to people like Stacey. A visual record of what new and expectant parents living in London were going through and the impact CO-VID-19 has had on their experiences. They have shared portraits and testimonies about love, loss and survival in the face of adversity, as well as personal experiences of key developmental and family

As a mother, and a developmental psychologist, the beginning of the pandemic also triggered in me a cascade of concerns. For many, the birth of a baby is the beginning of a web of positive relationships and connections that reach far beyond those within one household. But as the pandemic enclosed us in a new socially restricted world, I wanted to find out what unanticipated worries were being experienced by those going through pregnancies, birth and early parenthood.

And what of the baby? When their entire world became just their household, did this provide opportunity for closer relationships and improved early development, or were there also risks inherent in this changed landscape?

Our research group at the University of Cambridge and Cambridge University Hospitals set up the COVID in the Context of Pregnancy, Infancy and Parenting (CoCoPIP) online study to further understand and support families. Over 2,500 expectant and new parents have participated so far. Many of their stories bear striking parallels with the experiences of the families who reached out to James.

Our work has aligned through our common desire to provide a platform for "generation COVID" families. Here are just some of those voices.

BISMA – 'A 1% CHANCE OF SURVIVAL'

Bisma is 34. Her waters broke prematurely at 22 weeks on the day the World Health Organization declared the COVID-19 outbreak a global pandemic. No one else could be with her at the hospital, and having already experienced loss in previ-

At Christmas in 2020, Sally (38, London) - who was then 20 weeks pregnant - contracted COV-ID-19 along with the rest of her family, including her mother and 18-month-old son

"I was taken aback, since I didn't have a high temperature or a cough ... I felt numb with fear of the unknown and the harm the virus could cause the baby. There were no answers ... Like dominoes, everyone in my household went down with COVID."

Sally said she was afraid to take pain relief in case it would affect her unborn child. For the next three weeks her entire body was overtaken by surges of excruciating pain, but caring for her toddler was the hardest part. She added:

"He would scream for hours, sleeping only when he was propped up on my already protruding tummy. When he stopped eating and then drinking altogether all the GP could advise was to "try harder" - presumably to keep us out of an already overwhelmed NHS hospital ... We just had to wait it out."



ous pregnancies, decisions about how to manage this pregnancy were left to her alone.

She was told that she could give birth within 48 hours to a baby that had just a 1% chance of survival. Azlan was born at 32 weeks and is now a healthy one-year-old. Bisma said:

"I was assigned a bereavement midwife at 22 weeks and my husband was not allowed to stay with me. I spent three days on my own in a bereavement labour room. I could still feel the baby kicking and my faith was strong. I refused to take the tablet to induce labour and I carried my baby for another ten weeks. Azlan was in NICU [Neonatal Intensive Care Unit] for seven weeks while I made lifelong friends – they held my hand, wiped away my tears and gave me hope."

Bisma's sense of isolation aligns strongly with findings from the first 500 pregnant women in the CoCoPIP study. During 2020, a common theme was the way in which the changes to healthcare provision increased parents' anxiety levels and feelings of not being supported.

Repeatedly, women commented on the acute anxiety from having to attend antenatal appointments alone or by phone or video call, and the chronic anxiety associated with the uncertainty of whether they would have to give birth in the hospital without family or friends present. Antenatal and maternity services for expectant parents have been consistently reported as being disproportionately affected by social distancing requirements put in place worldwide (Human Rights in Childbirth, 2020).

For example, there was a four-fold increase in stillbirths observed in a sample of 1.681 births in London between February and June 2020. This was attributed to a lack of preventative antenatal care.

SALLY - CATCHING COVID

While for many of us the year represents a series of tumultuous restrictions on our lives, Sally's story highlights the additional strain (both physical and mental) that the pandemic has brought into some households whether due to themselves or their wider family contracting the virus.

LEARNING FROM THE PANDEMIC

Birth could be thought of as the most dramatic change in environment that a baby undergoes in its lifetime. A pivotal moment on a journey begun months before, where myriad experiences have already affected a baby's growth and development during pregnancy.

These cascading events are punctuated by birth itself, before a whole new host of experiences and factors continue to shape a baby's early behaviour. And in the wake of each new life come ripples of changes to the lives of the family that supports them.

Many of the difficulties faced by expectant families having a baby during the pandemic have accentuated existing inequalities in antenatal and postnatal experiences across the UK.

And the UK government's own report concerning NHS and social care staff burnout has highlighted that staff shortages have been exacerbated by

Our projects are documenting the real life consequences that stem from these issues, as well as the hardship, courage and resilience that families are showing in the face of adversity. We intend to give "generation COVID" families a voice for months and years to come and we hope these stories, and the research data generated by them, will be a force for change in these most vital areas.

Why fans cover their faces when football players take penalties – a psychologist explains

nenalty shootouts in football are one of the most unpredictable and dramatic events in sport, producing moments of utter ecstasy and deep despair in players and managers. As we saw in the recent UEFA Euro 2020 championship, fans often cover their faces when players take penalties.

Research shows us why. There are psychological reasons behind the powerful emotions that fans' experience, and behind the nervous facial and body expressions in the image

Although the penalty taker may draw on feelings of competence and control to lessen their anxiety and stress, fans have no control over events. Indeed, as fans have very little ability to influence events beyond cheering to encourage their team and jeering to put off the opposition, sometimes fans will cover their faces as a way of coping and to partially block out what is happening.

Another factor at work is the influence of those around us. When we

their emotions through their facial expressions. bodily movements. yells and postures. This is due to the presence of "mirror neurons" in our brains which fire when we observe other peoples' behaviour, and we then mimic and synchronise our emotions with theirs.

From the moment referees blow their whistle to indicate that the outcome of the match will be decided in a penalty shootout, to watching the penalty taker taking the long walk from the halfway line to the penalty spot, fans are feeling the emotions of the players. The image below shows this response to the stressor visibly etched on a fan's face as they seek to manage the unfolding drama.

ENVIRONMENT SCANNING

Penalty shootouts are particularly fear- and stress-inducing events due to the importance of each kick for the outcome of the entire match, and their unpredictability. According to one prominent theory of stress and coping, we continually scan our environment for stressors, and when we encounter them, we evaluate their of threat, harm, challenge or benefit, and then assess the extent to which we have the resources to cope.

Emotions are a pattern of physiological and psychological responses to meaningful situations, such as the outcome of a football match. These responses include changes in bodily sensations such as a raised heart rate, and in mental processes such as thoughts, feelings, expressions, and related behaviours.

As humans we have a fundamental need to belong and feel a sense of connection with others, as was shown in research carried out by Roy Baumeister and Mark Leary. Membership of a group, such as being a fan of a particular sports team, can provide a strong social identity.

In the context of sport, this refers to the extent to which an individual feels psychologically connected with a team and views the team as an extension of themselves. Indeed, the stress the player feels on the pitch is also being felt by the fans.

As social identity is linked with how we view ourselves, highly iden-

The success or failure of groups that we identify with is linked to our emotional state and although there are many benefits of being a sports fan, including enhanced social connections and improved wellbeing, there are also downsides when your team loses.

HEALTH EFFECTS

Fans of unsuccessful teams typically report higher levels of negative emotions and lower levels of positive emotions in comparison to fans of winning teams. There have even been effects on health, with a reduction in heart attack deaths after France won the World Cup in 1998.

So, next time you watch a penalty shootout, don't just think about the players and whether the kicks are scored or saved, spare a thought for all the other fans and the emotions and reactions they are experiencing.

Bangkok's snakes keep catchers busy despite virus surge

BANGKOK (AP): Bangkok parkgoers looking for relief from renewed coronavirus restrictions got a slithering surprise Thursday when a python as long as two of the Thai capital's ubiquitous motorbikes was spotted in one of the city's most popular green spaces.

The reticulated python was only the latest big serpent to turn up in the dense center of Bangkok, where urban sprawl eating into natural habitats has been blamed for a rise in snake sightings in recent years.

This one was found in Benjasiri Park, which is flanked by towering hotels, apartment buildings and several highend shopping malls now largely off limits due to restrictions put in place this week to stem a surge in virus cases.

The curbs have shuttered non-essential businesses and limited restaurants to takeout only, leaving parks among the few public places still open. As parents pushed

strollers and joggers rounded a nearby running path, firefighters called in to corral the snake started by trying to capture it with a ladder from the ground up. The python plotted its

escape by heading out on a limb, bound for a building on the edge of the park that houses the World Fellowship of Buddhists.

firefighters Other were waiting for it on the roof of the building. While one used a stick to grab the python by the neck, another man tried to cut the branch it was on. They soon coaxed it into a sack, tied up the bag, and carried it away.

Firefighter Somchai-Yoosabai said the snake measured 3.5 meters (11.5 feet) long and weighed about 35 kilograms (77 pounds).

Bangkok firefighters typically get thousands of snake-removal calls each year. Yoosabai said his department alone has caught a snake or two a day during the current rainy season, mostly in neighborhoods or houses with pets.

As coronavirus cases rise, so do the risks.

"If any houses ... have COVID-19 cases, we have to go to catch the snakes anyway," he said. "Plus, wherever we go to catch a snake, the crowd is always there. We cannot avoid that."

Thailand reported 9,186 new virus cases, including a record high 98 deaths, on Thursday.



That athletes and medal presenters would be required to wear masks was made clear in the guidelines released in June.

According to the new guidelines, additional podium modules will be placed between gold and silver medallists and gold and bronze medallists to allow for social distanc-

"All the presenters will be vaccinated, and there will be only one IOC member and one Inrepresentative at each event."

"A series of changes have been approved in order to respect the Tokyo 2020 health measures, with the aim of making the experience safe for everyone involved while also preserving the essence of this unique moment, when Olympians savour and celebrate the pinnacle of their sports career," IOC said in a statement.

The IOC said that the athletes, medal presenters and volunteers "will be clearly and thoroughly briefed before the ceremonies on the guidelines they will need to follow."



China's economic growth slows to still-robust 7.9%

BEIJING (AP): China's economic growth slowed to a stillstrong 7.9% over a year earlier in the three months ending in June as a rebound from the coronavirus leveled off.

As expected, the growth reported Thursday fell from the previous quarter's explosive 18.3%, which was magnified by comparison with early 2020, when the world's second-largest economy closed factories, stores and offices to fight the coronavirus. China led a global recovery after the ruling Communist Party declared the disease under control last March and reopened most industries.

The United States and other major economies are bouncing back, but some are hampered by the spread of new virus variants. The rapid U.S. recovery has led the Federal Reserve to suggest it might start unwinding its stimulus earlier than planned, late next year instead of in 2023.

China's growth in the April-June quarter over the previous three months, the way other major economies report results, was 1.3%, reflecting a return to normal for factory activity and consumer spending as government stimulus and easy credit wind down. That was up from the January-March period's 0.6% expansion over the final three months of 2020 but still was among the past decade's weakest quarters.

"Overall, China's economy looks to be on track for recovery," said Chaoping Zhu of JP Morgan Asset Management in a report. The latest data, Zhu said, suggest the economy "has already peaked and is easing back to its long-term average



China's outlook is clouded by a lingering trade war with Washington over Beijing's industrial development tactics. President Joe Biden has said he wants better ties with Beijing but has yet to say whether he will roll back tariff hikes imposed by his predecessor, Donald Trump.

Treasury Secretary Janet Yellen called this week for a "unified front" with Europe against China's "unfair economic practices." Biden has expanded the list of Chinese companies Americans are barred from investing in due to possible military connections.

Still, Chinese manufacturing, auto sales and consumer spending have recovered to above pre-pandemic levels.

Exporters benefited from their relatively early return to work while foreign com-

petitors were hampered by anti-disease controls. Exports surged 32.2% in June over a year earlier, though a government spokesman warned growth might weaken due to uncertain global conditions.

The International Monetary Fund and private sector forecasters expect economic growth this year of about 8% but say that should decline in 2022. The government is in the midst of a marathon effort to steer China to slower, more sustainable growth based on domestic consumption instead of exports and investment.

"With output already above its pre-virus trend, the economy is struggling to gain ground at its usual pace," Julian Evans-**Pritchard of Capital Economics** said in a report. "Headwinds to growth are likely to intensify during the second half of

Activity started to recover in the second quarter. when the economy expanded by 3.2% over a year earlier. That accelerated to 4.9% in the third quarter and 6.5% in the final three months of the year. In an apparent effort to reassure the public and financial markets, the government took the unusual step Thursday of reporting average growth in the second quarter and the same period of 2020 was 5.5%, up from 5.0% for the first quarters of the two years.

World markets took the update in stride. Benchmarks rose in Hong Kong and Shangthe year." China's economy hai, while U.S. futures were marginally lower.

Beijing is in the midst of dual campaigns to step up oversight of a fledgling industry of online finance competitors such as tycoon Jack Ma's Ant Group and to reduce risks to the financial system by forcing the real estate industry to cut its debt levels.

"Both will put downward pressure on growth in the short term," Iris Pang of ING said in a report.

Retail spending has revived more slowly than manufacturing, prompting concern that might weigh on the recovery. That led Beijing to inject extra money last week into the pool available for lending to shore up business and consumer activity. But the central bank and economic planners say they are sticking to plans that call for a return to normal policy.

Retail sales in June rose 12.1%. That was down from 13.9% for the full quarter and well below the 33.9% surge in the January-March period.

"Domestic demand remained muted," Louis Kuijs of Oxford Economics said in a report.

Factory output rose 8.3% in June over a year ago and was up 0.6% from the previous month.

Manufacturers face hurdles including shortages of processing chips.

Auto production fell 13.7% in June from a year earlier and sales fell 11.1% to 1.6 million, according to the China Association of Automobile Manufacturers. It blamed "insufficient supply of chips."

Investment in factories, real estate and other fixed assets rose 12.6% in the first half but was up only 0.4% in June over the previous month.

19 dead, dozens missing in Germany floods; 2 die in Belgium

BERLIN (AP) — At least cidents after their base-19 people have died and dozens of people are missing in Germany after heavy flooding turned streams and streets into raging torrents, sweeping away cars and causing some buildings to collapse.

Authorities in the western county of Euskirchen said Thursday that eight deaths had been reported there in connection with the floods. Rescue operations were hampered by the fact that phone and internet connections were down in part of the region, which is southwest of Cologne.

Police in the western city of Koblenz said four people had died in Ahrweilercounty, and about 50 were trapped on the roofs of their houses awaiting rescue.

Six houses had collapsed overnight in the village of Schuld. "Many people have been reported missing to us," police

Schuld is located in the Eifel, a volcanic region of rolling hills and small valleys southwest of Cologne.

The full extent of the damage in the region was still unclear after many villages were cut off by floodwater and landslides that made roads impassable. Videos posted on social media showed cars floating down streets and houses partly collapsed in some places.

Authorities have declared an emergency in the region after days of heavy rainfall that also affected large parts of western and central Germany, as well as neighboring countries, causing widespread damage.

Police said four people died in separate inments were flooded in Cologne, Kamen and Wuppertal, where authorities warned that a dam threatened to burst.

Authorities in the Rhine-Siegcounty south of Cologne ordered the evacuation of several villages below the Steinbachtal reservoir amid fears the dam there could also break.

A fireman drowned Wednesday during rescue work in the western German town of Altena and another collapsed during rescue operations at a power plant in Werdohl-Elverlingsen. One man was missing in the eastern town of Joehstadt after disappearing while trying to secure his property from rising waters, authorities said.

Rail connections were suspended in large parts of North-Rhine Westphalia, Germany's most populous state. Governor Armin Laschet, who is running to succeed Angela Merkel as chancellor in this fall's German election, was expected to visit the flood-hit city of Hagen later Thursday.

German weather service DWD predicted the rainfall would ease Thursday. Relentless rains through the night worsened the flooding conditions in eastern Belgium, where one person was reported drowned and at least another was missing. Some towns saw water levels rise to unprecedented levels and had their centers turned into gushing rivers.

Major highways were inundated and in the south and east of the nation, the railway service said all traffic was stopped, adding that "alternative transport is highly unlikely."

IOC's Bach brings attention to Hiroshima -- some unwanted

dents of Hiroshima welcome attention from abroad, which IOC President Thomas Bach will bring when he visits on Friday. The western Japanese city has been in the forefront of the world peace movement and a campaigner for the abolition of nuclear weapons.

But Bach will also bring political baggage — as will his vice president John Coates when he visits Nagasaki the same day — that is largely unwelcome in two cities viewed as sacred by many Japanese.

Bach and Coates are using the backdrop of the cities, hit with atomic

bombs by the United States in 1945, to promote the first day of the so-called Olympic Truce, a tradition from ancient Greece that was revived by a United Nations resolution in 1993. They will also be signaling the start of the Tokyo Olympics in one week. The Games are going ahead during the pandemic despite persistent opposition in Japan from the general public and the medical community.

"Many Japanese believe that that IOC strictly forced Japan to have the Olympics this year," Yasushi Asako, a political scientist at Waseda University, wrote in an email to The Associated Press. "Many Japanese believe that it is their (IOC's) fault for having such an international event during the pandemic, and there is a high possibility that the pandemic becomes more severe after the Olympics."

Some of those fears were reinforced on Thursday when Tokyo reported 1,308 new COVID-19 cases, up from



896 a week ago. It was the 26th straight day of cases being higher than a week previous.

Thursday's cases were the highest reported since Jan. 21. Japan has attributed 15,000 deaths to COVID-19, good by world standards but worse than many Asian neighbors.

Bach will be welcomed on Friday by Hiroshima Governor Hidehiko Yuzaki and is expected to place a wreath at the Peace Memorial Park, visit the Peace Memorial Museum and view the Atomic Bomb Dome. He will not be welcome by everyone. Shuichi Adachi, a former Hiroshima bar association head, submitted a strong statement this week to Yuzaki and Hiroshima Mayor Kazumi Matsui opposing Bach's visit. It was written on behalf of 11 anti-Olympic and pacifist groups.

"President Bach using the image of 'a peaceful world without nuclear weapons' only to justify holding of the Olympics by force under the pandemic is a blasphemy to atomic bombing sur"An act like this does nothing but do harm to the global nuclear weapons ban movement."

They also noted the poor timing. The date — Friday, July 16 — marks exactly 76 years since the Trinity nuclear test took place in New Mexico that led to the nuclear attacks on Hiroshima and Nagasaki just weeks later.

A separate group has also launched an online petition opposing Bach's visit. The petition, which has garnered almost 70,000 signatures, is addressed to the government of Japan, the Japanese Olympic Committee, and the mayor and governor of Hiroshima.

In ordinary times, the visits largely photo ops — would draw little attention were it not for the pandemic and the Olympics. Depending on the poll and how the question is phrased, a majority of Japanese oppose holding the Olympics.

Bach defended the visit in a briefing on Wednesday, saying it was focused

only on marking the first day of the Olympic Truce. He termed it an IOC offer of peace "and nothing else."

"This is the message we are going to send in the city of peace — of Hiroshima," Bach said, "This will have nothing to do with politics. We will not politicize this visit in any way."

Reports out of Hiroshima say the security will be similar to what was in place for President Barack Obama's visit in 2016.

The official cost of the Tokyo Olympics is \$15.4 billion, though a government audit suggests it is much more. The IOC has a large financial stake in the Olympics going ahead since almost 75% of its income is from selling broadcast rights.

Dr. Ran Zwigenberg, a specialist in the history of Hiroshima at Penn State University, noted that tying the games to the bombed city was not a problem at the 1964 Olympics. A 19-year man named Yoshinori Sakai — born on Aug. 6, 1945, in Hiroshima, the day the atomic bomb was dropped on the city — ignited the cauldron in the national stadium to open the 1964 Olympics. The image of him doing it is famous.

"The problem is the controversy surrounding the Olympics, and it's being very politicized," Zwigenberg told AP in an interview in Japan where he is doing research. "And that's something that a lot of people in Hiroshima don't like. They don't like to have the image of their city wedded to this kind of controversial visit."

Zwigenberg has written several books on Japanese history, including one focused on Hiroshima -"Hiroshima: The Origins of Global Memory Culture."

"I'm generalizing here, but the people in Nagasaki and Hiroshima don't like to have their name or image used by outside bodies, especially when it's controversial," he added.



Britney Spears' new attorney says father must step aside

Britney Spears to hire an attorney of her choosing at a hearing Wednesday in which she broke down in tears after describing the "cruelty" of her conservatorship.

Los Angeles Superior Court Judge Brenda Penny approved Spears hiring former federal prosecutor Mathew Rosengart, who called on Spears' father to immediately resign as her conservator.

"The question remains, why is he involved," Rosengart said outside the courthouse. Britney Spears, taking part in the hearing by phone, told the judge she approved of Rosengart after several conversations with him. She then asked to address the court, but asked that the courtroom be cleared. As Rosengart began to argue for a private hearing, Spears interrupted him to say "I can talk with it open."

"My dad needs to be removed today," she said, adding that she would like to see him charged with abusing his position.

She spoke so rapidly she was at times difficult for the court reporter and the dozens of media members in the courtroom to understand. She said she wanted the conservatorship to end immediately but not if it required going through any more "stupid" evaluations. She said she did not want another opportunity for "people to question my intelligence for the millionth time."

She described being denied things as basic as coffee, her driver's license and her "hair vitamins" by the conservatorship.

LOS ANGELES (AP): A judge allowed "If this is not abuse, I don't know what is," Spears said. She recalled that "I thought they were trying to kill me" in the early years of the conservatorship as she was being overworked and constantly examined.

> She began to sob as she talked about taking comfort in a therapy dog when she felt abandoned by her family.

> James Spears would not be stepping down as Rosengart challenged, his attorney VivanThoreen said in court, adding that he has only ever had his daughter's best interests in mind.

> Thoreen said Britney Spears had many inaccurate beliefs, among them that "her father is responsible for all the bad things that have happened to her."

> "Whether it's misinformation, lack of correction, or being wrongly advised, I don't know," Thoreen said.

> Thoreen emphasized that for nearly two years James Spears has had control only over his daughter's money, ceding power over her life choices to a courtappointed professional, Jodi Montgomery.

> Thoreen argued that an evidentiary hearing was necessary to look into the allegations that Britney Spears made at the June 23 hearing, including that she was being forced to take medications and use an intra-uterine device for birth control.

> Thoreen said she found it odd Britney Spears would describe those circumstances, which the pop star called "abusive," then approve of Montgomery continuing



in her role as overseer. Montgomery's lawyer, Lauriann Wright, responded that the last thing Britney Spears needed was to be put on the stand and cross-examined over the truth of what she said during her emotional testimony.

"I don't think it's a secret that we're dealing with someone with mental illness," Wright said.

Wright added that it's been "strongly recommended by her medical team that her father Mr. Spears needs to be off the conservatorship." Britney Spears has been under court supervision since February 2008. She was in the midst of a public meltdown at the time and her family sought the conservatorship for her protection. She has had throughout the proceedings a court-appointed attorney to represent her interests, Samuel Ingham III, but he resigned after the dramatic hearing three weeks ago in which the pop star told Penny: "I just want my life back."

Fans from the #FreeBritney movement

outside the courthouse cheered the decision to appoint Rosengart, then cheered Rosengart himself when he walked out.

In court, he called into question whether the conservatorship should ever have been put into place, and said he and a team of attorneys from his firm would be taking a close look at the details of the arrangement.

"This is not working," Rosengart said. "We know that." Florida congressman Matt Gaetz made a brief appearance addressing the Spears supporters outside the downtown Los Angels courthouse, at one point shouting "Free Britney!"

In Washington, D.C., a group of Spears supporters demonstrated on the National Mall in support of the singer.

The case had for several years operated with little drama, though questions about how its length and the singer's feelings about the proceedings, arose in recent years. That has culminated into intense public scrutiny of the court proceedings, which have been conducted largely in secret due to medical and private information about the singer and her condition.

There has also been focus on the complex network of lawyers and others involved in the conservatorship. Penny again gave little indication of what moves she'll make next, scheduling another hearing for late September and expressing hope that the warring factions will find common ground for Britney Spears' sake.
