SUMMIT REPORT GANGTOK, 04 APR:

 $S^{\rm ikkim\ Krantikari\ Mor-}_{\rm cha\ party\ convened\ an}$ election campaign meeting at Rongli Bazaar playground in East Sikkim today. The public meeting was attended by people from Rhenock, Chujachen, Central Pendam and Gnathang-Machong constituencies along with the SKM candidates of these constituencies. Bishnu Kumar Khatiwada, Damber Pradhan, LB Das and Tshering Bhutia and Lok Sabha candidate, Indra Hang Subba.

An SKM press release informs that 611 SDF families from these four constituencies joined SKM at the meeting.

Addressing the people, SKM president, PS Tamang [Golay], announced that all employees, farmers, businessmen, drivers and students of Sikkim are ea-



gerly waiting for 11 April to uproot what he alleged to be the "corrupt, communal and autocratic" SDF government.

He went on to allege that no development has taken place in the State in the 25 years that SDF has been at the helm of af-

fairs and that the people were still lacking even the basic amenities. In this regard, he stressed that the upcoming election

was important to reclaim the State for the people.

SDF accuses SKM of continuing violence

SAGAR CHHETRI GANGTOK, 04 APR:

Cikkim Democratic **>** Front today continued its allegations of poll violence by Sikkim Krantikari Morcha, a recourse SKM was taking after having failed to do politics of programmes and policies.

Addressing a press conference here today, SDF spokesperson, KT Gyaltsen, countered SKM claims and insisted that SDF member, Upen Rai, was stabbed by an SKM youth Joel Rai at Pabong under Poklok-Kamrang constituency on 27 March. SKM, it may be recalled, has claimed that Joel Rai was an SDF youth.

He also recounted other incidents of violence targeting SDF supporters and office-bearers and stated that SKM's penchant for violence can be explained to the fact that it is lead by a person who has served time in jail on a conviction held up by the courts.

Where SDF is consistent, SKM always contradicting itself: Katwal **SUMMIT REPORT** GANGTOK, 04 APR:

Democratic • Front's Lok Sabha candidate, DB Katwal, today claimed that where his party had been consistent in its pursuit of all that is important for Sikkim, the Opposition Sikkim Krantikari Morcha has been dithering and contradictory in its statements and performance.

Addressing a media briefing here today, a confident Mr Katwal insisted that the people have seen through the misinformation that SKM thrives on and are more excited about the prospect of voting SDF into office for a sixth consecutive term.

He pointed out how SKM claimed its president could contest the elections and even rolled out what it claimed was legal evidence to back the claim and then realizing that he couldn't after which they drummed up weak excuses and have now presented him as their chief ministerial candidate.

The people, he said, should be able to see through this tendency of SKM to blatantly lie to them and then try and distract the people with baseless allegations and conspiracies.

As for his stint as Lok Sabha should he win the elections, Mr Katwal said that he would be voice of the Sikkimese youth in the parliament and speak for them and about their issues even as he pursues the State's pending issues with the Centre.

On counting day, SKM's rejection by the people will be formalized: Chamling ARPAN PRADHAN KABI, 04 APR:

Sikkim Democratic party pres-Democratic ident, Chief Minister Pawan Chamling, today announced that whatever was left of the Sikkim Krantikari Morcha by way of relevance will dissipate with the counting of votes on 23 May, 2019, the day when SKM's rejection by the people of Sikkim will be formalized.

Mr Chamling was addressing the sixth day of his party's election campaign today at Kabi in North Sikkim.

Commenting on the mushrooming of leaders and resurfacing of parties at around election time, Mr Chamling rued that these groups were motivated solely by personal ambitions and had no sense of service.

While making a series of announcements for the constituency [see box] should he return to office, Mr Chamling alleged that the Opposition did not have any understanding or even desire

to work for the people and were mischievously copying and repackaging SDF plans and policies in their manifestos.

He also addressed the issue of several ticket hopefuls having been left out and assured that the service and support of party workers and leaders will not be forgotten and that they would always enjoy the gratitude and respect of the party. He called on them to be patient and committed to the party and the people.

He also went on to take personal responsibility for the elected representatives and assured that if the MLAs failed to deliver, he would himself take responsibility of the constituencies and have their demands and aspirations met.

The upcoming election, he stressed, was not important because it would return SDF to government for a record sixth time but because it offered the people a chance to save Sikkim and sustain development and peace here.



The meet was also addressed by former MLA from the constituency, TT Bhutia, who clarified that several rumours had circulated about his having joined the SKM and pointed out that his standing on this dais was proof that those were mischievous rumours.

Mr Bhutia stressed that the party was supreme for him.

SDF questions Indra Hang Subba's understanding of LT issue

Facilities to ensure participation of differently-abled this election

GANGTOK, 04 APR (IPR): As per the instructions of the Election Commission of India this time one of the important themes to be observed during Election is Accessible Elections. Sikkim is going for Polls on 11 Apr, 2019 and to ensure participation of differently-abled Voters in this biggest democratic exercise, the office of the Chief Electoral Officer, Sikkim in co-ordination with Social Justice, Empowerment and Welfare Department, Government of State has taken various steps.

The CEO Office has appointed State Nodal Officer and District Nodal Officers for ensuring that this time the elections are Accessible to all PWD Voters. The Election Commission of India has also appointed two Accessibility Observers to specifically oversee the

preparation in the districts with regard to Accessible Elections.

Commissioner - cum - Secretary, Vishal Chauhan, Health Care, Human Services and Family Welfare Department has been appointed as the Accessibility Observers for East and North District. He may be contacted at 94340-08110 for any complaints/ query with regard to facilities provided to PWD voters for East and North District.

Similarly, Secretary, Ambika Pradhan, Cultural Affairs and Heritage Department have been appointed as the Accessibility Observer for West and South Districts. She may be contacted at 9733157778 for any complaints/ query with regard to facilities provided to PWD voters for West and South Districts.

In the first round of exercise the marking of the differently-abled voters in the Electoral Roll was done with the help of the Booth Level Officers (BLOs). These voters have been marked as per their Polling Station and on the day of the Poll following facilities will be provided to them:

- 1. Basic facilities like drinking water, toilets, shed.
- Transportation for PWD Voters is being made from the office of the District Election Officers on Poll Day. These Voters will be ferried from their residence by a designated vehicle and brought to the polling station. After casting their Vote they will again be dropped to their residence by the same vehicle.
- In a State like Sikkim, the

obstacle in making polling stations physically accessible. Hence, to overcome this challenge, this time Volunteers have been appointed to assist the PWD Voters to reach the Polling Stations, especially for locomotors disabled Voters. These Volunteers are enrolled from the Electoral Literacy Clubs that are established in Schools and also from the NSS, NCC, Scouts and Guides.

- The Polling Stations which are physically accessible are being provided with Wheel chairs for the convenience of such Voters.
- For the benefit of the Visually Challenged Voters

dummy ballot in Braille and voter slip in Braille is being introduced.

- Pictograms are in circulation and also available in the Voters Facilitation Centres for the convenience of Speech and Hearing Impaired Voters..
- 7. PWD Voters and Senior Citizens will be given preference in Voting without having to stand in queue
- PWD Voters can also call the Toll Free number 1950 regarding any query and if they have not marked themselves, they may also mark themselves through the PWD App for any specific assistance.

The Indian Constitution under Article 326 has granted the right

to vote to all its citizens of sound mind above the age of 18, irrespective of caste, religion, social or economic status. Further, the Rights of Persons with Disabilities Act, 2016 lays down certain measures to be taken by the Government and Public Authorities for empowerment of persons with disabilities. The Act envisages creating a "barrier free" environment so that the persons with disabilities can participate in society fully and effectively. Barrier does not only mean physical barrier but it also includes communicational, cultural, economic, environmental, institutional, political, social, attitudinal or structural barriers. Section 11 of the Act emphasizes ac-

After the commissioning, the EVMs and VVPATs were sealed and stored in the respective Strong Rooms in the presence of General Observer for Parliamentary Constituency (South/West), Pankaj Agarwal (IAS) and agents of contesting candidates. The machines are stored under 24×7 CCTV surveillance and are guarded by armed security personnel.

An Open Letter to the youth of Sikkim

Dear Sikkimese Youth,

It is, perhaps, late in the day to be writing this letter. Some might add that a letter from me, a social and political nonentity, may not justifiably command your attention. Nonetheless, ing you with such trashy sentimentality I am writing this as my response to how (do not confuse it with elevated sentipolitics has been given a free rein which is denting the morale of young people in the state.

I want you to know that the overwhelming dominance of politics in our society is not accidental - nor is it attributable to the common election fever that catches all and sundry seasonally. No. Such wholehearted attention to politics is indicative of a deep-rooted malady in our personal and social life. I dare say that the earnestness, apparent sense of purpose, enthusiasm, focus and curiosity people show in politics reflect how badly their priorities have gone awry.

For far too long, we have been assaulted by a political narrative that claims that all of life's problems are related to politics and therefore only politicians can solve them. Such political pretension is not only insulting to our intellect but, far more than some of us would like to acknowledge, it is decimating the tremendous budding potential in hundreds of our youth. A politician recently told a group of students that he would solve the issues of 'depression, drug addiction and suicide' by providing jobs. Such a dismissive attitude underplays the gravity and complexity of life's deepest problems. Instead of encouraging young people to face life's daunting challenges head on and stand tall, instead of encouraging such struggling individuals to seek professional help, instead of acknowledging that some hurting souls need competent and compassionate help - he is shamelessly presenting himself as messiah and offering false hope. My reaction of irritability is justifiably supported by my conviction that this fellow is either fiendishly deceitful or hopelessly ignorant. Are they really claiming that from May 2019 onwards (should they win) there will be no problems in life? That Sikkim will be a paradise where all you need to do is 'wish' and they will fulfil it? Nothing can be more damaging to a culture than chanting such political mumbo-jumbo. I want you to know two things. One - anyone who is wooment) is your biggest enemy no matter how much he claims to be your greatest leader. Two, life is much, much bigger than politics. Explore the possibilities in life without holding the hands of politicians, most of whom, themselves, have achieved nothing in life. Politics in itself is good. We can all like a party/leader and support them. We must all understand political philosophy as best we can. But weaving the fabric of our aspirations around the hopes politicians give is self-defeating. When politics is given the role of our destiny maker, it is simply a cow in the kitchen.

Another concern is our misplaced idea of political consciousness. When I hear 'politically driven young people', what I find is that their language is heavily tinged with negativity, selfishness, criticality - most of which are either borrowed from others or based on subjective feelings. Critical thinking is striking in its absence. Life is not about highlighting needs and problems. It is about taking part in solving them. Fault finding is different from problem analysis. When we only talk about 'defects, faults and problems' in the name of political discourse, it is sign that we are governed by a 'weakening vision' and attuned to an ever 'strengthening fatal tendency'. We must learn to envision solutions and restrain our natural tendency to highlight negativity. Vision comes from rigorous reflection, research, experience and wisdom. Tendency (negative) comes at birth and grows with idleness and negativity.

Also, remember that you cannot set things right by 'joining politics'. Our society needs the holistic approach on the part of other professionals and lay people who are willing to do what they

One thing we must admit sooner rather than later is that most of us have become politically over-driven but sadly uninformed by a literary tradition and objective investigation. That is precisely because we do not read, think and analyse enough. We only listen to our favourite politicians, gossip, should not deprive us of the wealth of angry remarks which further inflame experience and sagacity often found in our ill-advised zeal. Intellectual obtuse- older people. Youthful vitality has its ness on our part is a serious cause for concern. Therefore, when you listen to your political leaders making some preposterous statements, don't feel obliged to hoot or clap and look equally silly. Step back and examine what they say - is your leader knocking on the backdoor of your imagination or on the front door of reason.

We must all admit that there is utter lack of local interpreters that can help us distil the political narratives. We have no dearth of unthinking zealots with torrid lungs and cold hearts all across the political spectrum who sensationalize everything. That calls for you to take it upon yourself to mature and learn to make right judgement. Battle the inner tendency to get carried away by the mood of the crowd.

Finally, much has been said about the need of youth coming into politics. How well has this line of thinking been thought through and debated? Why should youth come into politics? What should they do when they 'come'? You are entitled to your opinions but I think this phrase "youth coming into politics" must be unpacked in clear terms. I have no issues with young people supporting the political ideologies of their choice. I have no problem with some socially-minded, honest and politically sharp young people joining politics full time - provided they want to learn by working hard and staying away from gambling, partying, idleness, swaggering and their ilk. But to say that these young people will bring about change and bring heaven on earth is wishful thinking based on no sensibly sound rationale. Most youth definitely have a higher degree of physical activity, vigour, enthusiasm, aggression and so on. But to over accentuate these qualities is to adopt a limiting measure of worth. In the mosaic of social life, en-

ergy must be tempered with experi-

ence, enthusiasm guided by wisdom, passion channelled by purpose and commitment fostered by vision. Our unchecked desire for youth leadership place, but not without the guidance and experience of the elderly. Many of our worst mistakes and regrettable failures have happened when raw youthful passion went unchecked by elderly wisdom. Yes, we must celebrate the ideas. goals and busy agendas of youth - but not venerate them as the flag bearers of our civilization.

There is the call of the future and the only way to hearken to it is to come out of the bubble of overindulgence in romanticism. The biggest challenge for all the youth of Sikkim is to make up your mind to live like courageous men and women and not let politics paralyse you. We cannot go the distance depending on others. Remember, some of the leaders we have today are underperforming non-achievers themselves. Some of them are grappling with their messed up life. Some of them are bully, always angry, always frustrated, opportunists hopelessly driven by communal bigotry etc. and they are there in all the parties. Reject such moronic leaders without a second thought. These politicians may pretend to look and sound like "adarsh neta" but their overriding deficiencies make them injurious and therefore least preferable. That's the best way to clean up our politics and save Sikkim. If you detect any leader salivating over your muscle power and stirring you to display your 'youth power' physically, stay away from such a fellow.

You college and university grads, use the education that you acquired to become self-made men and women. You will soon realize that the future belongs to those who believe in the beauty of their dreams as Eleanor Roosevelt once said. Your dreams require your effort.



No dodging scholarly research if the grip of jingoism is to be broken

Politics is increasingly becoming about identity, and while deeper enquiries into questions of identity are always welcome, when politics jumps in ahead of research or nuanced understanding, everything – from security to even ideas of identity – get compromised. And that cannot serve any good, ever. We are learning this the hard way every day in our country as is the world with the rise of jingoistic nationalism and easy fear-mongering.

The region itself has been in the grips of identity assertion for some decades now, and while this has worked well to boost political careers and specific agendas, it has not succeeded in infusing confidence which any strong sense of identity should deliver. It hence becomes important for the stakeholders to pause, step back and evaluate. One of the problems with the current wave of claims of identity and belonging is that these are sourced from selective readings of colonial texts. Among the scholars, colonial texts have already been universally denounced for their superficial pigeon-holing of people and communities and for their lack of nuance. These colonial texts are, at present, accepted histories of the region. When a dash of traditionally held prejudices are added to these inaccurate and misleading records, confusion and paranoia result. It is thus required for scholars and researchers to deliver new narratives from fresh perspectives, narratives that are more nuanced and subaltern and also more invested with academic discipline.

The process of rewriting these texts is however not new. Taking Sikkim's example, history has been reinterpreted several times, sometimes by the powers that be and sometimes by individual organizations and even proclaimed by political parties. While some 'inventions' have become accepted notions because they have been around for a long time, others invoke only ridicule, except from those who have a stake in the new theories. Both trends are unhealthy because both are misleading and incomplete. Histories are always contested and thus always open to fresh interpretation, but what separates claim from fact is the erudition, research and evidence that supports the latter. It is obvious that it is this fastidious obsession with supporting evidence that brings credibility to a scholar and only notoriety to the conspiracy theorist. One hopes that the deconstruction of established 'myths' and accepted histories start surfacing soon following the scholarly path and not continue on the current rantings and claims of half-baked notions.

But why are histories required? To borrow a term from an academic who has spared some thought on this; histories are increasingly required to prove the "situatedness" of a people; to establish that they belong. Speaking of the Indian Nepali community, it stands at the crossroads of this journey. A wrong turn could see its endeavour at "situating" its identity and nationality digress into an extended and futile debate over nomenclature. It is obvious that a name cannot be imposed on a people and it is also accepted that no introduction of identity will be taken seriously if it comes from a fractured splinter of the whole. The issue at hand is a clear introduction on what being an Indian Nepali/ Gorkha means. To squabble over a name prioritizes the nomenclature rather than the introduction and a name in itself is no guarantee to recognition, security or identity. But this is only one aspect of the understanding of identities and histories, there is so much more that needs to be researched and recorded, and the sooner a more disciplined approach is initiated, the better it will be for all with a stake in anything.

India: what's at stake in the 2019 elections

Indians are about to start voting in the world's largest democratic exercise. The country's 900m registered voters will vote in national elections between April 11 and May 19 across 1m polling stations in 543 constituencies. India has a Westminster-style parliamentary democracy with voters electing their representatives to India's lower house of parliament, the Lok Sabha. Voting has been staggered over seven phases to ensure that the electoral process is provided the necessary security. The results will be declared on May 23.

India's current prime minister, Narendra Modi, is up for re-election as the head of the Hindu nationalist Bharatiya Janata Party (BJP) and its allies the National Democratic Alliance. A polarising figure, opinions diverge sharply over Modi's record in government and his legacy.

Supporters insist that Modi has ushered in economic development, military strength, national pride and a sense of confidence among the country's Hindu majority. Critics challenge such claims, pointing to soaring unemployment (the worst in 45 years), agrarian distress, reassertion of caste privilege and social polarisation.

Modi faces a range of opposition forces. The principle opposition is provided by the Congress Party and its allies, the United Progressive Alliance. Other opponents include regional parties in different states, such as Uttar Pradesh, West Bengal and Andhra Pradesh, as well as leftist parties in the state of Kerala. The BJP and its allies enjoy a crushing majority in the Lok Sabha, controlling 336 of the 543 seats: the BJP alone has 268 seats.

Fears abound that Modi's re-election will rent asunder India's constitutional values and social fabric. Since the BJP's ascension to power, lynchings of social minorities, especially Dalits and Muslims, have been on the rise. Leaders of India's historically oppressed Dalit communities remain anxious that the BJP seeks to dismantle the affirmative actions for oppressed populations guaranteed by the Indian constitution. The very idea of India is at stake.

A THRIVING DEMOCRACY

When India became independent in 1947, few people expected the country to survive. Nevertheless, Indians introduced universal adult suffrage soon after obtaining independence and adopted a republican constitution in 1950, a full 15 years before economic superpowers such as the US lifted literacy and tax qualifications for voting.

Throughout the 1950s and 1960s international observers remained sceptical of India surviving as a democracy, given its huge levels of poverty and illiteracy. Yet, India not only survived but also emerged – warts and all – as one of the world's most thriving democracies. The country presents a very moving story of the ways in which some of the poorest people on the planet have sought to construct and sustain democracy against enormous odds. Their achievements are under threat today.

India poignantly illustrates the global challenges posed to democracy by the rise of nationalism and populism. Identity politics, or a politics that focuses on people's particular social identities, permeates political narratives in India as elsewhere in the world in 2019. Indians are faced with an idea of nationalism that seeks to exclude significant sections of their own population from its ambit. And they have borne the brunt of right-wing populism, as shown by the growth of cow-protection squads administering vigilante justice over the last few years.

Social identity provides the basis of political mobilisation. India today faces these challenges

alongside countries such as Brazil, Turkey, the US and various European countries. Modi joins a galaxy of strongmen politicians such as Brazil's Jair Bolsonaro, Turkey's Recep Tayyip Erdoğan, the US's Donald Trump and Hungary's Viktor Orbán, accused of rolling back democratic achievements of the last few decades.

How Indians respond to the challenges of exclusionary nationalism, right-wing populism and supremacist identity politics in the 2019 elections holds key lessons for the world as it confronts the global backsliding of democracy. After all, elections provide a window onto the hopes harboured by citizens, the anxieties they confront and the possibilities they imagine. The narratives that emerge prior to, during, and immediately after any elections offer unique insights into ongoing processes of social change.

It is into these imaginations, narratives and social processes, rather than the machinations of the different political parties, that The Conversation will delve over the next few weeks.

Rwanda's gorillas have figured out where to find their sodium fix. But it's dangerous

Mountain Gorilla conservation in Rwanda is a great success story. A number of extreme conservation measures – like daily monitoring and protection, veterinary interventions and controlled ecotourism – have enabled the population to bounce back after a precarious low in the 1960s and 1970s that was brought about by habitat destruction and poaching.

But the population remains fragile. Today only around 1,000 mountain gorillas live in two isolated populations: one in the Virunga Volcanoes – straddling the borders of Rwanda, Uganda and DRC – which has increased from 250 to 600 individuals in about 30 years; and a group in the Bwindi National Park in Uganda with about 400 individuals.

The survival of this particular

species is important for a number of reasons. Firstly, mountain gorillas are some of our closest living relatives. They can therefore help us understand human evolution and behaviour. Secondly, they fulfil an important role in maintaining the health of tropical forest ecosystems – for instance by dispersing seeds. And finally, they are a tourist attraction that generates revenue for Rwanda and supports conservation activities throughout the country. In the last two years, tourism has contributed over US\$400 million to

the national economy.

to raid crops – like eucalyptus and bamboo – on nearby agricultural plots. Leaving protected areas is a huge risk to their safety.

My colleagues at the Dian Fossey Gorilla Fund's Karisoke Research

FOR THE LOVE OF SODIUM

We measured sodium content in samples from 34 of the gorilla's main dietary items and quantified sodium intake by 22 gorillas in three social groups over one year.

Perhaps for minerals we didn't investigate – like iodine – or because of the medicinal benefits that it has. But we also found that gorillas often ventured into the region's colder subalpine or alpine zones where they targeted

plants known as giant groundsels and lobelias. These turned out to be rich in sodium as well.

HUMAN-WILDLIFE CONFLICT

Crop raiding is the main source of conflict between people who live in close proximity to the park and wildlife. Farmers generally perceive crop damage by mountain gorillas as a big deterrent to their agricultural development.

The risk is that encounters between gorillas and local people will add to tensions, and lead to local communities being hostile towards wildlife, hampering wildlife conservation efforts.

Close contact between gorillas and people also increases the risk of disease transmission – such as respiratory diseases and

intestinal parasites – which could have a detrimental impact on this highly vulnerable ape population.

To discourage the gorillas from crossing into farmlands near the forest, there may need to be a change in agricultural practices such as relying less on plants sought by gorillas for their nutrients.

An ideal scenario would be to establish a buffer zone containing nutritionally unattractive and unpalatable plants. If sufficiently wide, it would discourage gorillas from crossing into croplands.

Centre and Max Planck Institute and I wanted to understand why the gorillas were ranging outside protected areas into croplands. We found that when the gorillas left the national park they often headed straight to eucalyptus trees. Our nutritional analyses showed that eucalyptus are more than a hundred times richer in sodium than the gorillas' staple foods inside the park.

This led us to conclude that sodium was the main incentive for the gorillas' escapades. All plants inside the park are low in sodium except a couple of species that grow near the top of the volcanoes. The gorillas obtain up to two thirds of their sodium when consuming eucalyptus.

Sodium is a micro-nutrient that's

critically important for physiologi-

cal processes, like muscle and nerve function and maintaining fluid levels in various parts of the body.

Sodium deficiency can affect bones, growth, and reproduction. A sodium deficit can trigger a specific

hunger for it which causes animals to

go out of their way to obtain it.

This is as true for gorillas as it is for humans.

It's possible that the gorillas were eating eucalyptus for other reasons.

Tight security around Bagdogra airport; Gurung 'unable to land'

(PTI): Police threw a tight security ring around the Bagdogra airport near Siliguri on Thursday after GJM leader Bimal Gurung, who has been in hiding for the past one and a half years, announced he would return to Darjeeling Hills during the day.

Police also whisked away Gurung's two aides Roshan Rai and Yogen Pradhan from the airport but said no arrest has been made. Later, a leader of the GJM (Gurung faction) told PTI he would not return to the Hills on Thursday. "He is unable to land at Bagdogra and the airport has been cordoned off by police".

The airport has no night landing facility.

Gurung had announced he

Tamang then established himself as the de facto leader of the Hills with the help of the ruling TMC and Gurung and his loyalists were expelled from the party. Quizzed about the tight security outside Bagdogra airport, a senior police official said it was precautionary.

Asked whether Gurung would be arrested if he tries to enter Darjeeling, the police official, who did not wish to be named, said, "He is claiming that he can't be arrested as per the (Supreme) court order. So we would like to see the order".

"I can't wait to return to Darjeeling. Once I am there, I will do everything to ensure the victory of Bista. Tamang and his group are agents of TMC. The people of Hills have rejected him and Rai," Gurung has said.

Tamang, when contacted, claimed that the Hills people no longer favour Gurung and his "politics of violence".

The Darjeeling Lok Sabha seat is held by the BJP and the constituency is poised for a neck-and-neck contest between the TMC and the saffron party.

For the first time in over three decades, the two parties are looking beyond the statehood demand in the region and have stressed on the need to ensure development in the Hills.



SC ruling: RBI to come out with fresh circular on resolution of bad loans

MUMBAI, APR 4 (PTI): Reserve Bank Governor Shaktikanta Das Thursday said the central bank will soon come out with revised circular for effective resolution of stressed assets in the backdrop of the Supreme Court order. The Supreme Court Tuesday quashed the RBI circular of last year that pertains to the provisions for referring the defaulter to the National Company Law Tribunal (NCLT) even on a oneday overdue.

"The court has said that power of RBI under Section 35AA has to be exercised in certain manner. The validity of section 35AA of the Banking Regulation Act 1949 stands and henceforth we have to comply with the direction of Supreme Court and act accordingly," Das said.

Section 35AA empowers the central government to authorise the RBI to issue directions to any banking company or companies to initiate insolvency resolution process in respect of a default under the provisions of the IBC. "In the light of the Supreme Court order, the RBI will take necessary steps, including issuance of revised circular as may be necessary for expeditious and effective resolution of stressed assets," he said. Revised framework for resolution of stressed assets issued on February 12, 2018 invited criticism from various quarters, including a parliamentary panel.

The RBI substituted the previous guidelines with a harmonised and simplified generic framework for resolution of stressed assets in view of the enactment of the Insolvency and Bankruptcy Code. "Although the new guidelines have been termed as harmonised and simplified generic framework, yet they are far from being so," Standing Committee on Energy in its report tabled in Parliament last year said.

"The Committee are of the opinion that the coinage of restructuring in resolution plan is hollow without having any serious meaning or business which only reflects the blurred vision of (the) RBI in understanding and appreciating the problems.

RCB to ring in changes against KKR in search of first win

BENGALURU, APR 4 (PTI): On a losing streak in the last four matches, Royal Challengers Bengalore are expected to ring in changes and experiment in search of their first win when they take on Kolkata Knight Riders in an IPL match here Friday. RCB's performance this IPL has been disappointing, both with the bat and ball, and a dejected captain Virat Kohli has conceded that his struggling team is yet to get the right balance but will continue experimenting with its combinations.

They lost their last game by seven wickets against Rajasthan Royals in Jaipur and now they will be up against a balanced KKR side, who have won two matches out of three they have played so far. Last time, the RCB beat KKR was in May 2016 at Eden Gardens and

they have suffered defeats in their last three encounters against the Kolkata-based side at Chinnaswamy Stadium here.

Batting collapse is the biggest worrying factor for RCB and to made matters worse captain Kohli's form has not been up to the mark by his high standards. He has managed a below 20 average in four games. Parthiv Patel and AB de Villiers are the only batsmen who have above 20 average. In their first match against Chennai Super Kings, RCB were bowled out for a paltry 70 in 17.1 overs after their top-order crumbled before the bowling of Harbhajan Singh and Imran Tahir. Against Sunrisers Hyderabad, the RCB bowlers allowed SRH to post a mammoth 232 with centuries from Jonny Bairstow and David Warner. RCB then

collapsed to an embarrassing 35 for 6 in the eighth over, with Kohli and de Villiers contributing just four runs between them. In the end, they were skittled out for 113 to lose the match by a massive 118 runs.

Against Rajasthan Royals too, RCB top order failed, except Parthiv who scored a half century. The RCB think-tank would be hoping that their top order batsmen come out with flying colours on Friday against KKR.

Despite their struggling form, Kohli and de Villiers are nearing personal milestones. Kohli is 17 runs away from becoming the second Indian cricketer after Suresh Raina to complete 8,000 T20 runs and de Villiers 15 runs short of becoming the second highest T20 run-scorer for RCB. He has 3,406 runs under his belt. The bowling

department has also been disappointing. Apart from Yuzvendra Chahal, all the other RCB bowlers have not been among wickets and have conceded far too many runs in death overs. Though KKR lost their last game by 3 runs in Super Over against Delhi Capitals, their confidence level is still high with their batsmen, including Nitish Rana, Andre Russell, Robin Uthappa and Shubhman Gill, being in top form.

Russell has been in sensational form with his incredible power-hitting ability that helped KKR win two matches. Restricting him will be a challenge for Chahal and company. Rana has been impressive as an opener and in the middle order too in the first two games. The performance of Gill will be watched keenly since he is tipped to be a future India star.

Ghosn vows he won't be 'broken' after re-arrest in Tokyo

Tokyo, APR 4 (AFP): Japanese prosecutors Thursday re-arrested Carlos Ghosn on fresh allegations of financial misconduct, as the former auto tycoon slammed an "outrageous and arbitrary" detention and vowed he would "not be broken."

In the early hours, officials raided the central Tokyo apartment the 65-year-old Ghosn has called home since winning bail last month after more than 100 days of detention on different charges. It was the latest twist in a rollercoaster drama that has gripped Japan and the rest of the world since his shock arrest at a Tokyo Airport on November 19.

Prosecutors said Ghosn had been detained over transfers of Nissan funds totalling USD 15 million between late 2015 and the middle of 2018. They suspect Ghosn used USD 5 million of that for personal expenditure.

"The suspect... was responsible for overseeing the whole of Nissan's operations and performing his duty loyally so as not to cause losses to Nissan, but he betrayed that duty in order to benefit himself," they said in a statement.

Ghosn released a statement through his representatives attacking what he called the "outrageous and arbitrary" detention.

"Why arrest me except to try to break me? I will not be broken," said the former high-flying executive.

He has denied any wrongdoing and took to Twitter for the first time Wednesday to announce plans to "tell the truth"

Deputy chief prosecutor Shin Kukimoto justified the arrest by saying they judged there was a "risk of destruction of evidence." But Ghosn's lawver Iunichiro Hironaka, known as the "Razor" for his mental sharpness, told reporters the fresh arrest was "against the spirit of the law" and "should not be tolerated in a civilised nation."

He added his client had expected prosecutors would rearrest him and had therefore prepared a video, without specifying the contents or exactly when it would be released.

Visibly angry, he vowed to fight likely attempts by the prosecutor to extend the detention, claiming the arrest was "not necessary" and designed merely to pile pressure on Ghosn. He added prosecutors had confiscated not only diaries and documents belonging to Ghosn, but also the passport and phone of the tycoon's wife Carole.

Ghosn already faces three separate charges. The first two relate to the alleged deferring of around USD 80 million in income and concealing this in official documents to shareholders.

The third, more complex, charge is that he attempted to transfer personal losses to Nissan and paid a Saudi contact who provided collateral from the company funds.

In an interview with French television to be aired later Thursday, Ghosn reiterated he was "combative and innocent" but acknowledged "it's hard." "A lot of lies have been told and these lies have come one after another," he said.

European Parliament approves no-deal Brexit visa waiver

BRUSSELS, APR 4 (AFP): The European Parliament on Thursday approved a law allowing Britons visa-free EU visits even after a "no deal" Brexit, despite a furious dispute over the status of Gibraltar.

The law means British visitors making trips of fewer than 90 days to the Schengen passport-free zone will not need visas, even if Britain crashes out of the EU without a deal in place.

The parliament approved the measure by 502 votes to 81, with 29 abstentions, paving the way for millions of British holidaymakers to flock to the beaches of the Mediterranean this summer regardless of the outcome of Brexit.

Implementation will depend on Britain granting EU citizens the same rights in return, but London has said it will do so and the principle of the law has broad support.

But the text of legislation itself triggered a bitter row in Brussels, after member states - at Spain's urging - referred in a footnote to the draft to Gibraltar as a "colony of the British crown".

The United Nations does legally list Gibraltar as a "non-self-governing territory", but Britain insists it is part of "the UK family" and that its citizens freely voted to remain British.

Britain's decision to leave the EU has revived controversy over Spain's long-standing claim on the territory, against the backdrop of Spanish elections.

India one of the highest taxing nations in world: Trump

WASHINGTON, APR 4 (PTI): India is one of the highest taxing nations in the world, US President Donald Trump has alleged as he again slammed the country for imposing 100 per cent tariffs on American products, including the iconic Harley-Davidson motorcycles.

Such a high tariff is not fair, Trump said Tuesday during National Republican Congressional Committee Annual Spring Dinner here.

Early this year, at a White House event to announce his support for reciprocal tax, Trump had said he was satisfied with the Indian decision to reduce the import tariff on Harley-Davidson motorcycles from 100 per cent to 50 per cent. "Even this is not enough, this is okay," he said at that time.

Trump has repeatedly claimed that India is a "tariff king" and imposes "tremendously high" tariffs on American products.

"I got a call from Prime Minister (Narendra) Modi of India. They're one of the highest taxing nations in the world. They taxed us 100 per cent," Trump

ten-heard remarks on 110 billion of American Indian tariff structure.

"They charge us 100 per cent tariffs on goods. So they send a motorcycle--and they make a lot of them--Indian cycles. They send them to our country, we charge them nothing. We send a Harley Davidson to India and they charge us 100 per cent. Not fair, okay. Not reciprocal. It's not fair," Trump said.

During his address to the National Republican Congressional Committee Annual Spring Dinner, Trump explained how his trade policies are successfully addressing the balance of trade issue with other countries.

Trade talks with China are going on very well, he said.

The world's two largest economies are locked in a trade war since Trump imposed heavy tariffs on imported steel and aluminium items from China in March last year, a move that sparked fears of a global trade war.

Trump imposed tariff hikes of up to 25 per cent on USD 250 billion of Chinese goods. In response, China, the world's second largest economy after the US, imposed said reiterating his of- tit-for-tat tariffs on USD Trump recounted.

Mosque massacre suspect to face 89 charges in court Friday

WELLINGTON, APR 4 (AP): The man accused of carrying out the Christchurch mosque attacks will face 50 murder charges and 39 attempted murder charges when he makes his second court appearance, New Zealand police said Thursday.

Police had earlier filed a single, representative murder charge against 28-year-old Australian Brenton Harrison Tarrant. He is due to appear via video link during a brief hearing on Friday, and won't be required to enter a plea.

Fifty people died in the March 15 attacks on two mosques and another 50 were injured.

Police said in a brief statement that they were considering filing more charges against Tarrant but couldn't comment further as the case was before the court.

Tarrant's first appearance was on the day after the attacks in the Christchurch District Court. His case has now been moved to the High Court due to the seriousness of the charges. Tarrant has reportedly been moved to a high-security prison in Auckland, which is why he'll appear via video link. During the scheduled court hearing, media photographs



possibility the reporting and images would taint the views of potential jurors before they hear evidence in court. Judge Cameron Mander said in a note that the brief hearing will mainly be about the accused gunman's legal representation.

Tarrant earlier dismissed lawyer Richard Peters, who was assigned to represent him during his district court appearance. Peters said Tarrant told him that he wants to represent himself. Many worry that Tarrant will try to use his trial as a soapbox to push his white supremacist views.

The judge said he had received applications from 25 media organisations to take film, photographs or audio recordings of Friday's hearing but had denied all of them. He said reporters could remain throughout and take notes, although would be restricted in what they could report. He said media could

still use pixelated images of Tarrant which the district court judge had allowed. The pixilation obscured his face. Retired law profes-

sor Bill Hodge said the idea behind obscuring his image was that the prosecution might need a witness to be sure he saw the gunman at the mosque rather than recognizing him from media stories. Hodge said New

Zealand and Australia were trying to preserve the ancient common-law approach to a fair trial, but that it seemed quaint in an era where people could easily find more information or images on the internet.

New Zealand's Department of Corrections said in an email they wouldn't answer questions such as where Tarrant was being held due to operational security reasons. They said that despite some restrictions, he was being managed in accordance with New Zealand and international laws regarding the treatment of prisoners.

"At this time, he has no access to television, radio or newspapers and no approved visitors," the department said.
