"My Ministers don't know Hindi": Mizoram Chief Minister to Amit Shah

GUWAHATI, 09 [NDTV]: The state ministers don't understand Hindi and some of them don't even know English, Mizoram Chief Minister PuZoramthanga said in his letter to Home Minister Amit Shah urging him to modify the centre's order and replace the state chief secretary who does not have a working knowledge of the Mizo language.

The Chief Minister has requested that Additional Chief Secretary JC Ramthanga be named the new chief secretary in place of Renu Sharma.

"After the retirement of my Chief Secretary LalnunmawiaChuaugo of Gujarat Cadre, I requested my present Additional Chief Secretary JC Ramthanga (Manipur Cadre) to be the next Chief Secretary. However, the Home Ministry has posted Mrs Renu Sharma as the new Chief Secretary," the Chief Minister has said in the letter dated October 29, a copy of which is available with NDTV. Renu Sharma, an AGMUT cadre IAS officer of the 1988 batch, was appointed by the Centre on October 28 to take charge from November 1 as Chief secretary of

The same day, the government also ordered JC Ramthanga to take charge as chief secretary from November 1, thus Mizoram now has two Chief secretaries.

"The Mizo people by and large, do not understand Hindi, and none of my Cabinet Ministers understand Hindi, some of them even have problems with the English language. With such a background, a Chief Secretary without the knowledge of a working standard Mizo language will never be an effective and efficient Chief Secretary," the Chief Minister said in his letter. "Due to this fact, the Government of India never posted a Chief Secretary who does not know the working standard of Mizo language since the creation of the state of Mizoram. Whether it is the UPA Government or the NDA Government at the Centre, this has been a practice since the creation of Mizoram State. It is a well-known fact that in other States of India, a Chief Secretary, who does not know even the basic working language of the the respective state is never posted at all," the Chief Minister added.

He then reminds Mr Shah that he has been a "faithful partner of the NDA from the beginning" and hopes that his request would be looked into.

Sikkim close to achieving 90% fullvaccination coverage, Health Secy

 $\mathbf{D}^{ ext{irector}}_{ ext{Secretary}}$ General-cum-Health Department, DrPempa T Bhutia today said that Sikkim has achieved the top place among States that have administered the second dose of COVID-19 vaccination to its eligible citizens due to good team work and constant support from the State and Central governments.

He stated that the State has sufficient stock of vaccines and vaccination teams have been carrying out vaccinations aggressively across the State.

It has to be mentioned here that Sikkim has administered a total of 976,622 doses of vaccine till 08 Nov. This means that 5,23,228 persons have been vaccinated out of which 4,53,383 persons have completed their vaccination schedule.

Speaking to media persons here on Tuesday, Dr Bhutia stated that 87.69% of Sikkim's population has been vaccinated against Covid-19



so far, making it one of the few states in the country to do so.

Sikkim can now be considered fully vaccinated as this figure will soon cross 90%, said Dr Bhutia.

The DG mentioned that the department has received full support in the vaccination drive from the State government and there is strong political commitment from the

Governor and Chief Minister. He added that Sikkim has also received full support and cooperation in this drive with uninterrupted vaccine supply.

He informed that there are 1,74,100 doses of vaccine in UIP Store in the State excluding 25,180 doses of vaccine with East District, 19,680 doses with West District, 4,590 doses with North District and 15,610 doses with South District.

Speaking on other factors, Dr Bhutia mentioned that vaccination teams have been carrying out vaccination without any break in the State. He added that the department has been getting full support from MLAs, Panchayats, Councilors, Aganwadi and ASHA workers and NGOs.

Dr Bhutia said that IEC activities were also carried out to create wider awareness among the people on COVID-19 vaccination. Doorto-door vaccination drives and special camps in required places including prisons, of-

On whether were any concerns he had over the vaccination drive, Dr Bhutia mentioned that the one matter of concern was with a few cases in which people have missed. at least on record, their dates for the second dose. This, he added, could be because some people tested positive after the first does and were observing the 3-month gap advised after recovery or people who are away from the state and took their second dose elsewhere or registered for it with a different phone number. Such technical reasons could lead to records reflecting that the second dose was still pending for such people.

On the same, he informed that the department has carried out "line-listing" of overdue second doses and health workers will be engaged to follow-up on such cases.

He said that the state aims to have the entire adult population fully vaccinated by the end of the year.

Test positivity remains low at 2.5% as Sikkim emerges from Diwali break

GANGTOK, 09 NOV:

Cikkim's daily test positivity rate of returned negative yesterday. **J**COVID-19 remained reasonably low at 2.5% on Tuesday even though li holiday slump. Where Sikkim was averaging barely 160 tests per day through the holidays, yesterday, 478 samples were screened for the virus to return 12 positive cases. Sikkim's tally of confirmed cases of Covidhas now reached 32,058.

As per the Daily Report of CO-VID-19 in Sikkim released by the Integrated Disease Surveillance Programme of Health Department on Tuesday morning, while five new cases were detected in RT-PCR testing of 221 samples, seven cases were picked up in rapid antigen testing of 254 samples.

Of the 12 new cases, seven were registered in East District, three in West District and two in North District. All the 90 samples screened in South Sikkim

Over the same 24 hours, Sikkim recorded 15 more recoveries to imtesting has picked up after the Diwa- prove the number of recoveries to 31,204, giving Sikkim a recovery rate of 98.4%.

> Significantly, no Covid deaths were reported here in the past 24 hours and the toll holds at 400.

> There are currently 122 active Covid cases in the State, most of whom are recovering under home isolation and only 18 of whom have symptoms severe enough to require hospitalization. Further, of the 18 in hospital, only one patient is in ICU.

> On the vaccination front, only 126 Covidshieldjabs were administered on Monday - 10 people reciving their first shots and 116 completing their vaccination schedule with the second dose.

PHE Dept initiates action against consumers still with polypipe connections

 $A^{ ext{fter completion of}}$ the six-week notice, the PHE department of Namchi has started taking action against consumers who have failed to adhere to rules mentioned in the notice issued by the department on 18 Aug. The notice included

strict prohibition on usage of polypipes for water connection from PHE water reservoir to homes and buildings, and failure to adhere to this rule would force the department to disconnect or plug the pipes, as per 1990 Water Supply Acts, without any further notice.

"About 40% of the

consumers have complied with the rules so far," said Assistant Engineer, Sonam Karthak.

He added that PHED Namchi gave time of one and a half month to consumers to replace their poly pipes with GI pipes to reduce leakage in and around Namchi. The department has started taking action those who have failed to convert their lines, said Mr Karthak.

He further stated that the department is trying its best to ensure regular water supply in Namchi.

NHPC diverts Rangit for Stage-IV HEP

Dengue cases piling up, outbreak worst in several years: Delhi Hospital New Delhi, 09 Nov [PTI]:

The dengue outbreak in Delhi is "far more as compared to the last twothree years", a senior doctor at the city's Ganga Ram Hospital told NDTV today, adding that "mortality too is on the rise".

Delhi logged 1,171 dengue cases from November 1-6, after reporting 1,196 through October and 217 in September (the highest for that month in three years), according to news agency PTI.

In January, Delhi reported zero dengue cases. There were two in February, five in March, 10 in April, 12 in May, seven in June, 16 in July and seven in August.

The 2,708 cases reported so far is the most since 2018; cases between January 1 and October 30 was 612 in 2020, 1,069 in 2019, and 1,595 in 2018.

Delhi also reported three dengue deaths on Monday, taking the total number of deaths to nine - the most in a season since 2017, when ten people died.

"Around Diwali (and as winter sets in), when we expected to see cases decrease, there was an increase. This might be because, as Covid restrictions are lifted and we return to normal, people are taking it too easy and not following postmonsoon precautions," Dr PoojaKhosla, a senior consultant told NDTV.

She pointed to stagnant water (breeding grounds for mosquitoes that spread dengue) at re-opened building sites and overcrowded markets as an example of people not being careful.

The increase in dengue in Delhi, Dr Khosla also said, may be because of a rise in cases in neighbouring Uttar Pradesh and other areas of the na tional capital region.

In UP dozens died from dengue and viral fever after a spike from mid-August.

She also said the Ganga Ram Hospital was reporting between 80 and 100 walk-in dengue cases every day, with half that number admitted. About 20 per cent of the walkins are serious and 10 per cent need ICU (intensive care unit), she added. "We are mainly getting regular dengue - i.e., with fever. More complicated cases dengue hemorrhagic fever - patients with bleeding complications... they have low platelet, need ventilators or are hemodynamically unstable..."

"If we don't take timely action the number of cases will keep increasing for the next two or three weeks till winter sets in (when mosquito numbers usually decline)," she warned. Dr Khosla also underlined the fact Delhi's medical professionals had learned from the harsh lessons of Covid and, that while they may be overwhelmed, they were ready to face the dengue threat.

In 2015, Delhi went through a major dengue outbreak, with reported cases crossing 10,600 in October alone, making it the worst in the national capital since 1996.

[NDTV]: As a fresh political controversy erupts over the Rafale deal, NDTV has found more evidence that Indian agencies ignored allegations that French company Dassault, the maker of the Rafale jets, may have paid crores of rupees to middlemen spanning both the BJP-led NDA 1.0 government and the Congress-led UPA.

A day ago, French portal Mediapart reported that Dassault paid almost 13 million euros (nearly 110 crores at current rates) to a middleman, Sushen Gupta, between 2002-12 to help secure the sale of Rafale fighter jets to India, but Indian agencies failed to investigate these allegations despite having access to incriminating documents on at least some of these payments.

Now NDTV has found documents that show that in 2019, three years after India signed the Rafale deal, central agencies, including the CBI, were alerted to possible kickbacks paid by Dassault, yet they failed to act on the allegations. Such allegations could have led to a blacklist of Dassault under Indian

The documents form part of the CBI's chargeruption in the sale of 12 AgustaWestland copters for top leaders in India. They include a statement by DheerajAggarwal, then manager of IT services company IDS, who in 2019 told the CBI that Dassault routed money to Sushen Gupta's Mauritius-based shell firm Interstellar through

The arrangement was that 40 per cent of the payment made to IDS by Dassault was to be commission for Sushen Gupta's Interstellar. IDS had allegedly helped channel 4.15 crore of Dassault's money to Interstellar between 2003 and 2006, according to DheerajAggarwal.

The payment period spans the NDA government under Prime Minister AtalBihari Vajpayee, which was in power till 2004, and the UPA, which came to power right afterwards.

Despite including this testimony in its court filings, the CBI did not initiate a probe against the company. According to Indian laws, a company can be suspended or banned if it "resorts to corrupt practices," "unfair means" or "illegal activities" during any period of the bidding and negotiations.

RBI lifts restrictions on Diners Club International; allows

The Reserve Bank on Tuesday lifted restrictions on Diners Club International and allowed it to onboard new do-

The restrictions have been lifted with immediate effect, the central bank said in a statement.

The RBI had on April 23, 2021, imposed restrictions on Diners Club International Ltd from onboarding new domestic customers onto its card network from May 1, 2021, for non-compliance with the norms on Storage

"In view of the satisfactory compliance demonstrated by Diners Club International Ltd. with the RBI circular...on Storage of Payment System Data, the restrictions imposed, vide order dated April 23, 2021, on on-boarding of fresh domestic customers have been lifted with immediate

Farmers to march to Parliament on Nov 29, "Will sit wherever stopped"

NEW DELHI, 09 NOV [NDTV]: Farmer unions protesting against the Centre's new farm laws, have decided to march to Parliament on November 29 - shortly after their protest at the Delhi border completes one year. The decision was taken today by the nine-member committee of the United KisanMorcha - an umbrella body of farmers' unions.

On November 29, farmers from Ghazipur border and Tikri border will leave for Parliament House on their tractors. They said they will hold

a sit-down protest wherever they are stopped.

The farmers had warned that they would escalate their protest if the government does not revoke the controversial farm laws by November 26.

"The central government has time till November 26, after that from November 27, farmers will reach the border at the protest sites around Delhi by tractors from villages and strengthen the protest site with solid fortifications," farmer leader RakeshTikait had tweeted on November 1.

AkhileshYadavlaunches Samajwadi "Sugandh" perfume ahead of UP election



Lucknow, 09 Nov [NDTV]: Former Uttar Pradesh chief minister Akhilesh Yadav has launched a perfume with the Samajwadi Party's election symbol on it. Called "SamajwadiSugandh" or "Attar", a Samajwadi legislator who also runs a perfume business crafted it in Kannauj district, known for its fragrance industry.

The move was seen as one of the soft outreaches by Mr Yadav's party ahead of the UP assembly election early next year, which is likely to be fought fiercely between the ruling BJP under Chief Minister Yogi Adityanath and the Samajwadi Party. Mayawati'sBahujanSamaj Party is also prepping a strong campaign.

The colours on the perfume bottle resemble the Samajwadi Party flag - olive green and red. The legislator who got it manufactured said the fragrance has ingredients from "Kashmir to Kanyakumari" to represent the country's diversity. He said Mr Yadav himself gave suggestions on

how the perfume should be crafted. The Samajwadi Party launched a similar per-

fume ahead of the 2017 assembly elections. The party lost badly to the BJP.

"It took two scientists about four months to perfect this perfume. Our national president gave us directions about this. This perfume has ingredients from Kashmir to Kanyakumari and when you use it, you will be able to smell the fragrance of samajwad (socialism) and brotherhood," Samajwadi legislator Pushpraj Jain said.

Mr Yadav said, "This is a good perfume. Those who use it will remind others with the fragrance of the Samajwadi Party and its ideology."

96 nations agree to mutually accept vaccine certificates with India: Minister

New Delhi, 09 Nov [PTI]: Ninety-six countries have agreed to mutual recognition of COVID-19 vaccination certificates with India, Union Health Minister MansukhMandaviya said today.

The government continues to be in communication with the rest of the world so that beneficiaries of the world's largest vaccination COVID-19 programme are accepted and recognised, thereby easing travel for education, business and tourism purposes, Mr Mandaviya said in a statement.

"At present, 96 countries have agreed to mutual recognition of vaccination certificates and also those who recognise Indian vaccination certificates of travellers fully vaccinated with Covishield/WHO approved/ nationally approved Covid vaccines," Mr Mandaviva stated.

Consecutively, sons travelling from these countries are provided certain relaxations as enunciated in the Union Health Ministry's guidelines on interna-



tional arrivals issued on October 20, 2021.

For those who wish to travel abroad, the international travel vaccination certificate can also be downloaded from the CoWIN portal, the minis-

Mizoram CM gets clean chit in

Public perception of Courts on vacation like schools not correct: High Court Judge

NEW DELHI, 09 NOV [PTI]: The public perception of courts going on vacation like schools is not correct and an appropriate machinery must be engaged to project their hard work for an "image change", said Delhi High Court Judge Justice JayantNath who demitted office today.

The judge, speaking at his farewell reference organised by the high court, said that overburdening of courts with long pending cases was a known fact but the reasons for delay were not attributable to the courts themselves.

The pendency is there in spite of "huge efforts" by courts and lawyers, he

"It is a known fact that courts are overburdened with long pending cases. Unfortunately, the perception of a common man is to blame the court for delay in disposal of cases. Much is said about the courts going on vacations, comparing it with school vacations. I can say with full conviction that this public image is not correct," said the judge.

"The reasons for de-

lay are many but are not really attributable to the courts. All I can say is, the court needs to take some steps to project this hard and good work that is being put in place by engaging an appropriate machinery. I need not say further on this, but I feel some image change would be useful," he add-

In his farewell speech, Justice Nath advised lawyers to "be sincere" to their briefs and clients, and reminded that there was "no shortcut to success".

The judge said that the Delhi High Court was a "cosmopolitan court" where success came from merit.

"It doesn't matter from which part of the country you come from, which religion you follow, success in this court comes from merit, not from your background," he said.

Chief Justice D N Patel said that Justice Nath is a distinguished judge who will be remembered for his eminence and excel-

Born on November 10, 1959, Justice Nath was appointed as additional judge of the high court in April 2013 and became a permanent judge on March 18, 2015.

Recently, Justice Nath had restrained various generic pharmaceutical companies from manufacturing or selling Valsartan and Sacubitril tablets, a combination to treat cardiovascular diseases, as it may amount to infringement of patent of pharma major Novar-

In May, he had ruled that the Delhi government has no power to indefinitely postpone the collection of annual charges and development fees by private unaided schools as it would unreasonably restrict their functioning.

In January 2018, the judge had upheld an international arbitral award passed in the favour of Daiichi Sankyo, which paved the way for its enforcement against the Singh brothers who had sold their shares in Ranbaxy to Daiichi in 2008 for 9,576.1 crore.

Before his elevation to the bench, Justice Nath was designated as Senior Advocate by the high court in May 2006.

Centre should distribute money collected from oil price hikes: Mamata Banerjee



KOLKATA, 09 NOV [NDTV]: Claiming that the Centre has raised 4 lakh crore in the recent times from increased fuel prices, West Bengal Chief Minister Mamata Banerjee on Tuesday demanded that the money be equally distributed among states.

Ms Banerjee, during an Assembly session, alleged that the Union government has slashed excise duty recently on petrol and diesel, with an eve on the upcoming Assembly elections in five states.

"The central government has collected around 4 lakh crore from the taxes levied from selling cooking gas, petrol and diesel at increased prices. Now, they (BJP) want the states to reduce the VAT. Where will the states get their money

"The Centre should distribute that 4 lakh crore equally among the states," she said while addressing the West Bengal assembly.

The Chief Minister further said that the state has been providing several subsidies despite financial constraints.

"Whenever elections are near, they (Centre) bring down the prices. Once that is over, they increase it again. Those lecturing us on oil prices should first answer

where the state government will get its money from. The Union government does not give us our due funds," she said, targeting the BJP, which has threatened to launch a "movement" if the VAT on oil is not reduced.

Ms Baneriee also accused the central government of meting out a step-motherly treatment to Bengal during distribution of vaccines among states.

"The number of vaccines doled out to us was much less compared to what was given to states such as Uttar Pradesh. We have ensured that not a single vaccine dose gets wasted," she said.

Caught in Quotas

Inspire ambitions for bigger, not nooks and corners

It is never out of season to talk about the near obsessive ambition of communities across the board to get included in some reserved category or the other. We have, in our country, quite a wide range of categories to choose from – there is the ST list, the SC recognition, the OBC, now even MBC, Bihar introduced us to the EBC grouping as well – and one can rest assured that more such segregations will be dreamed up in the coming years. Communities vie to fit in somewhere, speculate to move across to reservation-enjoying groups and seek out more quotas in newer avenues.

Why these categorizations and why this keenness for reservations?

Given the history that India emerged from in 1947, where caste alienation was extreme and janjatis genuinely underprivileged, a policy was required to overcome this legacy of injustice and to provide all in this country with a broad measure of equal opportunities. Since equal opportunities would not have been willingly granted and communities with centuries of oppression behind them could not be expected to benefit from an equal footing standpoint, reservations were eked out. Over the years, reservations were extended to include more communities and even women. The idea was to provide these communities/ genders with the first stepping stone to equality – access. Access to education, to jobs, to positions of power and wider exposure. This target has been met relatively well and as far as access is concerned, a wide swathe has been covered. That said, new elites have emerged within the reserved groups, from those who benefitted first from the 'quota' and thus became the more privileged among the disadvantaged. The obvious next step would have been to pull communities which have benefited "enough" out of the reserved categories and make space for those which still lag behind. If not that, at least consider extending the creamy layer segregation to reserved categories which currently have no such differentiation.

This, obviously, is easier said than done. For one, there is no easily quantifiable way to decide when a community has developed enough to make it on its own steam sans reservation, and for the other, there is the vote-bank politics in which saner decisions in genuine public good would be political hara-kiri. So, the nation is left with an ever overflowing bouquet of reserved sections and shrinking opportunities.

This is where the whole policy has failed. Instead of making people competitive with improved access, it has made them lazier with increased quotas. Little wonder then that more and more communities want to fit into some reserved category or the other. In fact, in the present times, when jobs are rare and competition even for education is tough, it would be foolish of community leaders not to work for a quota for their people. And so the demands keep pouring in. This is not to belittle the aspirations of any community to find a new grouping for itself, but just a suggestion that maybe it is time the country and Sikkim paused to re-read the principles why reservations and special categories were first created, whether its expressed aims are being met, and also whether the people who genuinely require reservations are receiving it or not.

An insider's look at the Glasgow climate summit – talks intensify, amid grandstanding and anger outside

Young people poured into the streets of Glasgow on Nov. 5, 2021, angry and impatient as the first week of the U.N. climate summit ended. Their anger is matched by anxiety in the conference halls as the enormity of what has to be achieved in such a short period of time hovers over a complex process that can become sclerotic.

I've been involved in the climate negotiations for several years as a former senior U.N. official and I am in Glasgow now. At the start of the second week, here's what I'm seeing and hearing, both inside the negotiations and outside.

A SHIFT FROM 2050 TO 2030 GOALS

To slow climate change, every part of our economies will transform, and that is reflected in the conference sessions running in parallel to the formal negotiations and in the constituencies that turned out in real strength the first week – executives from central banks, CEOs of global banks and institutional investors, young people, indigenous peoples leaders, faith communities, advocacy groups and the world's media.

There has been a shift at this year's summit, from making pledges to reach net zero emissions by 2050 to a focus on actions to cut emissions by 2030.

Research shows the world needs to cut global emissions 45% by 2030 to keep global warming under 1.5 degrees Celsius (2.7 F) compared to preindustrial times, an aim of the Paris climate agreement.

The Energy Transitions Commission, a coalition of businesses and nongovernmental organizations, calculated that if the commitments made at COP26 are delivered, it will cut the gap between today and the 1.5 C trajectory in half for carbon dioxide emissions and by almost 40% for methane. In total, the world would be about 9 gigatons closer to the 22 gigatons of emissions reductions needed.

That's a start.

BIG DEALS, BIG CLAIMS

The first week of COP26 was about building momentum – big deals and big claims outside the

negotiations, with different coalitions of countries, companies and others, pushing action forward.

Some of those pledges will likely collapse like a

souffle in the weeks and months that follow, when a company's board balks at some of the details or when they re-run the numbers under greater scrutiny.

But there were notable coalitions announcing

But there were notable coalitions announcing pledges on cutting methane, ending deforestation and diverting international public finance away from fossil fuels and into clean energy. The international financial community formed a broad alliance of firms committed to net zero, attracting accusations of greenwashing.

The U.N. secretary-general announced an expert group to propose clear standards for companies and others making net zero commitments.

THE FORMAL NEGOTIATIONS INTENSIFY

At this point in the negotiations, the U.K. – which holds the COP26 presidency – will drive efforts to wrap up some remaining parts of the rulebook for implementing the Paris climate agreement.

It will also be pushing for agreement on a "cover statement," which will include a whole raft of issues. At this point, it is a long list of issues ranging from human rights, youth engagement and a just transition to more technical and procedural issues, such as how to recalibrate countries' climate commitments and actions each year and how to ensure finance flows to adaptation, not just mitigation.

A "High Ambition Coalition" is emerging, led by the Climate Vulnerability Forum, a group of around 20 countries facing high risks and sometimes existential threats from climate change. They have called for a Climate Emergency Pact that would include: a plan to deliver finance to help them adapt to climate change over the next few years, an agreement to increase those funds beyond that period, progress on finance involving loss and damage from climate change, an agreement on carbon markets, and a process for raising countries' commitments each year until the world is on track.

Now, in the second week, government ministers from the around the world are becoming personally involved in loosening log jams and taking over from their negotiators.

JOINING THE INSIDE AND OUTSIDE

The gulf between what's happening inside the negotiations, and what press releases from events outside the negotiating rooms are saying could widen.

Inside, negotiators cannot agree on billions of dollars in climate finance expected to flow from wealthy countries to help poorer countries. Yet on the outside, press releases discussing trillions of dollars in private investment committed to netzero emissions imply the problem is fixed.

And on the outside, while some analysts tally commitments to see if each gets the world closer to a trajectory that keeps warming under 1.5 C, inside discussions on transparency and reporting on climate progress are stalled.

But the atmosphere is not all bleak. There is optimism that agreement on carbon markets may be found after painfully elongated talks at the summits two years ago in Madrid and three years ago in Katowice.

Ultimately, the Glasgow conference can only be called a success when emissions start to slow and reverse and wealthy nations are able to put finance and real support behind poorer communities' adaptation so they can become more resilient to the climate driven crises still to come.

OPPORTUNITY FOR TALENT

While all of this is resolved, think about this: In every meeting I have been in – with green banks in developing countries and their microentrepreneurs, Silicon Valley CEOs, finance chiefs, management consultancies and mayors – there is an additional concern that goes beyond the need for better policy, new regulation and a braver political class. Their concern is about the talent pipeline, or its absence. As every country, company, fund and bank shifts to a net-zero pathway, the world will need engineers, data analysts, policy experts and planners to plot the course and lead.

The transition is underway, Glasgow needs to deliver, and the world needs to train and prepare for the sprint to 2030 in a race to zero emissions.

Ditching fossil fuels will have immediate health benefits for millions - world leaders must seize the chance

Carbon dioxide (CO₂) emitted by burning fossil fuels for energy today will only be removed from the atmosphere by natural sinks – like forests and the ocean – in the next 300 to 1,000 years. That means the climate benefits of transitioning to clean energy become apparent on far longer timescales than political term limits and election cycles. A US study, for example, found that deep cuts to emissions from the energy sector will not result in climate cooling until after 2100.

The costs of mitigating climate change outweigh the immediate benefits to the climate. Politicians seeking recognition for their actions at climate change conferences like COP26 in Glasgow have little motive to deliver policies which slash emissions quickly. But there is a large, short-term benefit to eradicating fossil fuels for global health.

The same fossil fuels producing the greenhouse gases warming the Earth's atmosphere also form large

quantities of air pollutants. The pollutants most hazardous to health are small particles which can penetrate deep into the lungs. These particles have diameters of no more than 2.5 micrometers, so are called PM₂₋₅. At least 800 of these particles could fit end-to-end on the head of a pin. These fall out of the air when it rains, so they persist in the atmosphere for a much shorter time (just a few days) than CO₂.

In a study we published earlier in 2021 in collaboration with researchers at Harvard University, we estimated that exposure to air pollution from using fossil fuels globally accounts for one in five premature deaths. Our results suggest that at least 8.7 million early adult deaths could have been avoided in a single year if countries had already abandoned fossil fuels. This is equivalent to the population of Greater London.

THE HEALTH BENEFITS OF DE-CARBONISATION

Our estimate of premature deaths far exceeds that of other researchers, as we used a model that simulates the sources and fate of air pollution

to calculate its abundance on a much finer scale. This gives a more accurate picture of the concentrations of air pollution breathed in by people in urban areas. We then used this to estimate excess deaths using the most up-to-date health studies, which have found that air pollution is deadlier than previously assumed.

The most common causes of premature death from air pollution exposure are heart disease and lung cancer, but researchers routinely report additional illnesses. The World Health Organization (WHO) recently published much stricter health guidelines for air quality than it last recommended in 2005 based on substantial evidence that exposure to air pollution is even worse for public health than scientists had imagined.

Our study is probably an underestimate of the possible public health benefits of abandoning fossil fuels. We only accounted for one type of pollution, PM_{2·5}, which arises from burning fossil fuels. A range of air pollutants form as byproducts in all other steps of the fossil fuel supply

chain: from finding, extracting and processing fossil fuels, to storing and

transporting them.

One example is formaldehyde gas, which is emitted during petroleum refining and flaring of natural gas. Formaldehyde reacts to form ozone in the lower atmosphere, where it is toxic and can exacerbate asthma symptoms.

We also only focused on adults. The relationship between air pollution and poor health in children isn't completely understood, but studies so far have shown that exposure to air pollution stunts growth and impedes brain and lung development in children. In a landmark case in 2020, air pollution was directly attributed to the death of Ella Kissi-Debrah, a nine-year-old girl in London.

The health benefits of transitioning to clean energy are substantial and can emerge quickly. They offer a tantalising opportunity for politicians to deliver immediate improvements in the lives of their voters.

In Kashmir, scores of PM CARES ventilators fail trial run

SRINAGAR: More than 100 ventilators supplied under PM CARES fund in Jammu and Kashmir have been found defective and "unfit for critical care" on trial runs. The ventilators supplied to the Government Medical College, Srinagar, were manufactured by three different companies. According to doctors, a trial run is not done on every machine. For every company, tests are conducted on a few machines to check the quality. The government said an inquiry will be ordered to fix the responsibility.

A query filed under the Right To Information Act has revealed that the Medical College received the ventilators under PM CARES Fund to deal with



the second wave of the coronavirus pandemic. But these ventilators could be used for critical care because they had serious technical flaws.

In the RTI reply, the hospital's Department of Anaesthesiology and Critical Care Medicine

The government has said that an inquiry will be ordered. "At this point, I can only say we will investigate it. A probe will be ordered to find out why defective ventilators were supplied," Vivik-Bhardawaj, Additional Chief Secretary Health told NDTV.

Madhya Pradesh orders safety audit of all hospitals after Bhopal fire kills 4



death of four newborns in a fire at a hospital in Bhopal, Madhya Pradesh Chief Minister Shivraj Singh Chouhan today ordered fire safety audit of all government and private hospitals in the state.

The chief minister said the fire at the hospital in the state capital on Monday was a result of "criminal negligence", and the guilty will not be spared.

"It was our (government's) responsibility to save these children as they were under our protection. This is a serious incident," he said addressing state ministers and government officials before the cabinet meet-

"This is criminal negligence. Whoever is guilty will not be spared... we need to prevent such unfortunate incidents in future. All necessary arrangements should be made to avoid such incidents," he said.

The chief minister also said fire safety was now more important as oxygen plants and their supply lines were installed at various hospitals in the wake of the COVID-19 pandemic.

A major fire broke out on Monday in the special newborn care unit (SNCU) located on the third floor of the government-run Kamla Nehru Children's Hospital building, killing four newborns. "I had directed ear-

lier also to conduct the fire safety audit of hospitals. Now, I am telling the chief secretary to submit a report about in which hospitals fire safety audit was conducted and which were left out." MrChouhan said

He also ordered for the fire safety audit of all government and private hospitals of the state again to prevent such incidents in future.

He praised state Medical Education Minister VishvasSarang, who immediately rushed to the hospital here after the blaze on Monday and took care of the relief works.

"The doctors, nurses, ward boys and other people who saved 36 infants by putting their lives in danger will be feliciated," the chief minister said.

MrChouhan also said he was keen to visit the spot on Monday night, but "I was stopped so that the relief work could go on smoothly".

He said he was issuing directives to the officials throughout the

night and taking stock of the situation. The chief minister has also ordered a high-level probe into the incident, to be conducted by Additional Chief Secretary, health and medical education, Mohammad Suleiman.

Meanwhile, state Urban Administration Minister Bhupendra Singh, who is in-charge minister of Bhopal district, also visited the fire-hit hospital today along with MrSarang.

"A big tragedy was averted as the infants were timely shifted to another place. At present, we have information of four deaths. The inquiry will reveal what led to their deaths. This is a sad incident and measures are being taken to avoid such incidents in future," Mr Singh said.

According to MrSarang, a total of 40 children were admitted to the SNCU of the Kamla Nehru Children's Hospital. Out of them, 36 were undergoing treatment in different wards, he said.

Four children died in the fire that broke out probably due to a short circuit, he said.

The chief minister earlier announced compensation of 4 lakh each for the family members of the victims.

Tiger spotted in Jharkhand tiger reserve after stretch of no sightings

MEDININAGAR: A tiger was the total area, 226.32 sq spotted in Jharkhand's Palamau Tiger Reserve (PTR), a top forest official said on Tuesday.

The sighting of the tiger on Monday evening resulted in a wave of happiness among officials and employees of the Palamau Tiger Reserve.

The High Court of Jharkhand has recently wondered why Palamau Tiger Reserve should be called a tiger reserve since there are no tigers and observed that officers are not even aware of how many male and female big cats exist in Iharkhand.

Kumar Ashutosh, the Area Director of the reserve, told PTI that a healthy and young male tiger was spotted by a team of forest guards under Range Officer Tarun Kumar Singh at Baresad forest on Monday eve-

The team saw the tiger crossing the Medininagar-Mahuadandh road and moving from one forest to the other slowly from a distance of about 10 feet, the official said.

On seeing the tiger, the forest workers who were on a regular patrol for the safety of the wildlife kept an eye on it, the official said.

The Director said that, from this morning onwards, skilled forest guards have been deputed to collect the excreta-footprint (stug-pug route) of the tiger.

The Betla National Park located in Jharkhand's Palamau Tiger Reserve was thrown open for tourists on October 1 after it was closed during pandemic since March 2020.

Also, the counting for wild animals has begun in the Palamau Tiger Reserve, known globally for undertaking the world's first census for big cats as early as 1932. For counting of wild animals 509 trap cameras have been installed in the Palamau Tiger Reserve.

Of the 1129.93 sq km area of Palamau Tiger Reserve, 414.08 sq km is marked as core area (critical tiger habitat) and the rest 715.85 sq km as a buffer area. Of km is designated as Betla National Park. In the buffer zone, 53 sq km is marked as a tourist zone.

Palamau was declared a protected forest reserve in 1973-74 when Project Tiger was launched. The reserve, according to information, recorded its highest tiger population in 1995 with 71 big cats but since then their population has been dwindling.

The Palamau Tiger Reserve consists mainly of Sal forests, mixed deciduous forests and bamboo groves. The reserve zone is the watershed area for three important rivers Koel, Burha and Auranga.

The Palamau Tiger Reserve was one of the first nine tiger reserves created in the country at inception of Project Tiger and has the distinction of being the first sanctuary in the world in which a tiger census was carried out based on pugmark count, as early as 1932 under the supervision of JW Nicholson, the then DFO, Palamau.

Apart from leopards, it boasts of elephants, grey wolf, gaur, sloth bear, four-horned antelope, Indian ratel, Indian otter and Indian pangolin among its inhabitants.

A total of 47 species of mammals and 174 species of birds have been identified, according to officials who said that apart from these, a total of 970 species of plants, 17 species of grass and 56 species of medicinal plants have also been identified.

Betla National Park under Latehar district of the state is located about 150 km from Ranchi and 25 km from Palamu headquarter Medininagar (Daltonganj).

The High Court of Jharkhand in September had come down heavily on the forest department for having failed to protect the flora and fauna in reserve forests of the state and a division bench of Chief Justice Dr Ravi Ranjan and Justice Sujit Naravan Prasad, while hearing a public interest litigation, observed that it is shameful to know that there are just five tigers in the wild in the state.

Mizoram Chief Minister gets clean chit in abuse of power, corruption case



AIZAWL: A special court, under the Prevention of Corruption Act, has acquitted Mizoram Chief Minister Zoramthanga in two cases -- one related to misuse of power and the other to possession of disproportionate assets.

organisations -- People Right to Information and Development Implementing Society of Mizoram (PRISM), the erstwhile anti-corruption watchdog, and Mizoram Upa Pawl, a senior citizens" association -- had filed a case in 2009 against Zoramthanga for alleged misuse of power as a public servant to procure angle iron posts and goat-proof wire mesh from the agriculture department for his farm at Aiipuk area in Sihphir in 2007.

Back then, too, Zoramthanga was the chief minister. The state Anti Corruption Bureau (ACB) had filed an additional charge sheet alleging that Zoramthanga held assets disproportionate to his known sources of income.

The charge sheet said that in 2003, Zoramthanga had declared in his affidavit that he owned assets worth 54.18 lakh, which then grew to over 1.38 crore before 2008 elections, without having registered any known source of income.

In the first case, judge Vanlalenmawia said on Monday that materials from the agricultural department were legally issued for the benefit of needy farmers.

There is a provision for giving out those fencing materials under the scheme -- Assistance to Small Marginal Farmers, he said. "In fact, under ing implements could be issued to AiiPuk Farmers' Association at 50% subsidy or even free of cost depending upon the availability of the materials. Mention may be made in this regard that the AiiPuk Farmers' Association applied to the Agriculture & Minor Irrigation department for Angle Iron posts and G.P. wire mesh and the same were given to the association," the judgment order stated.

The court further said that it did not find sufficient evidence to prove the accused had assets disproportionate to his known sources of income, and therefore he is not liable to be convicted under Section 13(2) of the Prevention of Corruption Act, 1988 (punishment for offence by a public servant).

Tamil Nadu Chief Minister visits Chennai amid floods, distributes food

CHENNAI: Tamil Nadu Chief Minister MK Stalin today visited rain-affected and water-logged areas in Chennai and distributed food to needy people in various parts of the city.

The chief minister reviewed the situation of the areas affected in the wake of incessant rains in the city. With the onset of northeastern rains, Chennai received the heaviest rains in the past six years, recalling the 2015 floods. It resulted in flooding in the central and northern parts of the city.

Meanwhile, according to the India Meteorological Department (IMD), low pressure has formed over the southeast Bay of Bengal and neighbourhood which is likely to move from west to northwestwards and reach near the north Tamil Nadu coast by the early morning of November 11. "Under the influence

of the cyclonic circulation over the southeast Bay of Bengal and neighbourhood, a low-pressure area has formed over the same region. Associated cyclonic circulation extends upto midtropospheric levels," IMD said in a tweet.

"It is very likely to concentrate into a Depression over Southwest & adjoining Southeast Bay of Bengal during the next 36 hours. It is likely to move west-northwestwards and reach near the north Tamil Nadu coast by the early morning of November 11, 2021," it Earlier in the day,

IMD predicted that heavy rainfall will occur over Tamil Nadu on November 9-11.

"Isolated very heavy rainfall with Isolated extremely heavy falls is very likely over Tamil Nadu, Puducherry&Karaikal during 09th-11th and south Coastal Andhra Pradesh on 11th November," IMD said.

Manipur congress leaders meet Sonia Gandhi ahead of State polls next year



Grizzlies rally to top **Timberwolves** in **OT**, 125-118

MEMPHIS, TENN. (AP): JaMorant scored 33 points, reserve Brandon Clarke had 20 points and nine rebounds, and the Memphis Grizzlies put together a furious fourth-quarter rally before defeating the Minnesota Timberwolves 125-118 in overtime on Monday night.

Memphis trailed by as many as 16 with 7:30 left in regulation but a 21-4 burst erased Minnesota's advantage. Over the final 5:22 of regulation, Minnesota made only one of 10 shots and had five turnovers.

"I was watching him shoot. Watching it go up, and I was like 'That might go in' because he shot it with a bunch of touch.

"I knew if it hit the backboard, it would have a chance of going in."

But even after the unlikely shot, Memphis pulled away in the extra period, keyed by an offensive rebound and put back by Clarke with 22.7 seconds left.

De'Anthony Melton had 19 points for the Grizzlies, Jaren Jackson Jr. had 14, Desmond Bane had 13 and Kyle Anderson added 12 points and nine rebounds for Memphis, which also had erased a double-digit deficit in the first half.

"We fought to the end," Morant said of the late rally and overtime. "Went down early in the game, late in the game. Went on a run of our own.Big-time run.Got stops.Were able to score."

It was Minnesota's sixth straight loss. D'Angelo Russell, who missed the previous two games with a sprained right ankle, led the Timberwolves with 30 points. Towns had 25 points and 13 rebounds. SAN FRANCISCO (AP): Stephen Curry's personal shooting coach and passing man, Bruce Fraser, offered some pregame thoughts that worked wonders to get the reigning scoring champion right back in

"We kind of talked about certain preparations into my shot, just certain mechanics that he called it even having a little bit more conviction about when it's time to shoot," Curry said. "Just a little seed he planted. I took that into warmups and the rest of the game. He was very timely with those words of wisdom."

Curry scored an NBA seasonhigh 50 points with nine 3-pointers, 10 assists and seven rebounds, almost single-handedly leading the Golden State Warriors past the Atlanta Hawks 127-113 on Mon-

Oh, yes, Curry sure wanted that 50-spot. And if he wasn't counting, his teammates were committed to getting him there.

"It's always nice," he said. "You never come out with like a certain number in mind. It's just when you get it going, you just keep going."

Only Hall of Famers Wilt Chamberlain and Rick Barry had registered a game with 50 points and 10 assists in Warriors franchise

"When he gets going like that, it's a special day," teammate and brother-in-law Damion Lee said.

Curry dominated for long stretches and danced in delight, repeatedly raising his arms in the air to encourage everyone fortunate enough to witness another of his brilliant performances.

He scored Golden State's first 13 points, then 10 straight down the stretch in the third before dishing off for Juan Toscano-Anderson's 3-pointer that made it 102-85 following the Warriors' spectacular, 41-point quarter.

"That was just a stunning performance by Steph," coach Steve Kerr said. "... He was amazing. I want to say I've never seen anything like it but I've been watching it for seven years, so I have seen something like it and still it's just incredible to watch."

Playing to chants of "MVP! MVP!," Curry gave fans a scare



with 8:48 left in the first when he jammed his left shoulder. He was examined by the medical staff during a Hawks timeout and could be seen nodding and moving his arms to shake out the shoulder before drawing cheers when he stayed in the game.

Curry notched his 10th career 50-point game and already had 24 points on 7-for-12 shooting by halftime with five 3-pointers.

"It doesn't get old, for sure," Kerr said.

Curry wound up 14 for 28 from the floor and made all 13 of his free throws as the Warriors won their fifth straight. They are holding opponents to 95.8 points during the unbeaten stretch.

"The fact that Steph got that many open looks was crazy," Hawks star Trae Young said. "He is the best shooter of all time."

Young had 28 points and nine assists in Atlanta's fourth straight loss and sixth in seven.

Jordan Poole added 16 points and Andrew Wiggins 13 for Golden State (9-1) in the second game of a back-to-back, the Warriors' first time playing on consecutive nights so far this season. The Warriors fell behind 55-40 in the second but got within 65-61 at halftime before their decisive third.

On Monday night, Davis showed his mettle and then some despite dealing with some ailments of his own. The All-Star forward had 32 points and 12 rebounds maining in overtime. as the Lakers beat the Charlotte Hornets 126-123 in overtime.

"He's dealing with a lot of stuff and toughing it out," coach Frank Vogel said. "He made some big buckets and was terrific on the defensive end as well."

Davis has been dealing with a right thumb sprain and an illness. He said he threw up at the end of the third quarter, but that wasn't going to sideline him.

"I had 43 minutes of work. Now, I have 48 hours to replenish," Davis said. "With LeBron out.we don't have all our guys. I have to take command. Even when LeBron is playing, guys are telling me to make sure I stay in control of the team and put guys where they need to be."

Davis had six points in overtime, including a pair of free throws that gave Los Angeles a threepoint lead with under a minute remaining. He also partially blocked Terry Rozier's jumper from the corner on the final possession as the Hornets tried to send it to a second overtime. Russell Westbrook

had his first triple-double with the Lakers and Carmelo Anthony scored a season-high 29 points off the bench. It's the Lakers' first victory in the four games that James has missed this season.

Davis, Anthony lead Lakers in

Westbrook notched his 185th career tripledouble. Finishing with 17 points and 14 assists, six of his 12 rebounds came in the fourth quarter and overtime.

Anthony was 7 of 10 from beyond the arc, including a 26-footer in transition to put the Lakers up for good at 122-121 with 2 minutes re-

fenders a chance to close out. I feel good, I'm in a great rhythm and taking advantage of teammates finding me to knock those shots down," said Anthony, who is tied for third in the league with 39 3-pointers.

Migrants camp overnight at Polish border after tense day

WARSAW, POLAND (AP): Polish police posted video early Tuesday showing a group of migrants who had camped overnight just on the far side of Poland's eastern border in Belarus. Polish riot police and coils of razor wire faced the migrants and police said the situation overnight was calm.

That followed a day of heavy tensions on the border, where a large group of migrants — hundreds if not thousands of people mostly from the Middle East and encouraged by Belarus sought to illegally push their way into Poland.

In videos posted on Twitter, tents and campfires can be seen, in near-freezing temperatures, as the Polish police play an announcement warning the migrants that crossing the Polish border is only allowed at official border crossings. Visas are required.

But as of early Tuesday, the nearest crossing point, in Kuznica, in the northeast of the country, was closed.

The situation marks an escalation in months of migration pressure against Lithuania and Poland, and to a lesser extent Latvia, the three EU states on the bloc's eastern border with Belarus. The EU says Belarus is building the pressure, intending to desta-



bilize the bloc in retaliation for Western sanctions.

Polish Prime Minister Mateusz Morawiecki, accompanied by Defense Minister MariuszBlaszczak, went to the border on Tuesday morning to meet with border guards and other security officials. Morawiecki praised them, also on behalf of the EU, for their "effective defense of our border," which is part of the EU's eastern frontier.

"We do not know what else Lukashenko's regime will come up with — this is the reality," Morawiecki said.

The migrants are mostly from Iraq and Syria, though some have come from Africa, seizing on a hope for a new migration route to enter Europe. Most seek to only pass through Poland to reach Germany or other countries in western Eu-

Poland has received strong signals of support and solidarity from the EU and EU member states and the United States as it faces its border crisis.

Germany's outgoing interior minister, Horst Seehofer, said on Tuesday that all EU countries "must stand together, because (Belarusian President Alexander) Lukashenko is using people's fates with the support of Russian President Vladimir Putin to destabilize the West." He called for the European Commission to support Poland in securing the border.

"The Poles have reacted correctly so far," Seehofer told German daily Bild of Poland's reinforcement of the border. "We cannot criticize them for securing the EU's external border with admissible means ... the Poles are fulfilling a very important service for the whole of Europe."

Mayer, told Bild that "Germany could send police very promptly to support Poland if Poland wants that."

So far Poland's ruling nationalists have refused help from Frontex, the EU's border

Many of the migrants fly to Minsk, the capital of Belarus, on tourist visas, and from there travel by taxi to the border with Poland. The EU is seeking to pressure airlines not to facilitate the illegal migration.

Although direct flights from Iraq to Minsk were suspended in August, migrants have been flying into Belarus via commercial and chartered flights from Syria, Turkey, the United Arab Emirates and even Russia, according to recent internal EU migration reports seen by The Associated Press.

On social media, smugglers have advertised transportation from Belarus to Germany by car. Drivers smuggling people across the Polish-German border were mainly from non-EU countries, according to the reports, although there were also EU nationals involved. Many of the migrants have ended up in Germany. But some continued their journey all the way to Finland by ferry via Sweden, one report said.

Denmark wants to reintroduce phased-out coronavirus pass

COPENHAGEN, Denmark (AP): Denmark wants to again consider COVID-19 as "a socially critical disease," paving the way for the reintroduction of a digital pass months after the label was removed and restrictions were phased out.

The move, which still needs approval in parliament, will also allow Denmark to reintroduce other restrictions if deemed necessary. A majority seems to be backing the suggestion of the minority Social Democratic government.

The pass was introduced on July 1 but removed on Sept. 10, when Denmark declared that the outbreak no longer was to be considered "a socially critical disease," citing the high rate of vaccination.

However, Denmark has like many other countries seen an uptick in cases, with health authorities saying the number of infections and hospitalizations has risen faster than expected.

On Monday, Health Minister Magnus Heunicke said the COVID pass must apply to nightclubs, cafes, party buses and indoor restaurants but also outdoor events where

the number of people exceeds 2.000.

The Danish pass app shows a QR code with a green banner if the holder is fully vaccinated or received a first dose at least two weeks ago, has recently recovered from COVID-19 or has had a negative test in the past 72 hours. A paper version is also available.

The call to reintroduce the pass was immediately welcomed by the industry.

KristianNoergaard, a senior member of Horesta, the employers' organization for the hotel, restaurant and tourism business, said that to them the most important thing "is that we avoid more shutdowns. It will be a disaster for a business that will have to pay off the debt from previous closures for a long time to come."

"At the same time, we expect that the initiative can create security around the running of many Christmas events." he said in a statement.

Mikkelsen. Brian head of the Danish Chamber of Commerce, said they too backed the reintroduction of the pass because "new shutdowns must and should be avoided."

Singapore delays appeal hearing on disabled man's

execution

SINGAPORE (AP): Singapore's top court on Tuesday postponed the appeal hearing for a Malaysian man on death row believed to be mentally disabled, after he was diagnosed with COVID-19, in a case that has drawn international attention.

Nagaenthran K Dhar malingam, 33, was scheduled to be executed by hanging on Wednesday for trying to smuggle a small amount of heroin into the country — less than 43 grams (1.5 ounces).

The Malaysian national was sentenced to death in November 2010, under Singapore's strict anti-drug laws. Previous attempts to reduce his sentence to life in prison or receive a presidential pardon have all failed, despite pleas from the international community and rights groups.

The Court of Appeal's Judge Andrew Phang said Nagaenthran had tested positive for COVID-19, after the defendant had been brought into dock but then abruptly taken away again. The court dismissed a prosecutor's suggestion to have Nagaenthran testify via video. "We have to issue a stay of the execution until all proceedings are concluded. That is the proper order of things," Phang said.

The stay on the execution followed a court ruling on Monday that had already granted a similar order, pending the result of the appeal at Singapore's highest court.

Nagaenthran's fense lawyer, M. Ravi, has based his appeal on the argument that executing a mentally disabled person is a violation of Singapore's Constitution.

Russia comes in from cold on climate, launches forest plan

land north of Japan has become a testing ground for Moscow's efforts to reconcile its prized fossil fuel industry with the need to do something about climate change.

More than two-thirds of Sakhalin Island is forested. With the Kremlin's blessing, authorities there have set an ambitious goal of making the island — Russia's largest — carbon neu-

Tree growth will absorb as much planet-warming carbon dioxide as the island's half-million residents and its businesses produce, an idea the Russian government 4,000 miles to the west in Moscow hopes to apply to the whole country, which has more forested area than any other nation.

"The economic structure of Sakhalin and the large share of forestland in the territory and carbon balance distribution reflect the general situation in Russia," said DinaraGershinkova, an adviser to Sakhalin's governor on climate and sustainable development. "So the results of the experiment in Sakhalin will be representative and applicable to the whole Russian Federation."

The plan reflects a marked change of mood in Russia on climate change.

President Vladimir Putin joked about global warming in 2003, saying that Russians would be able to "spend less on fur coats, and the grain harvest would increase" if it continued.

Last year, he acknowledged that climate change "requires real actions and way more attention," and he has sought to position the world's biggest fossil fuel exporter as a leader in the fight against global warming.

The country's vast forests are key to this idea.

"By aiming to build a carbon-neutral economy by no later than 2060, Russia is relying, among other things, on the unique resource of forest ecosystems available to us, and their significant capacity

MOSCOW (AP): A Russian is- to absorb carbon dioxide and produce oxygen," Putin said in a video address Nov. 2 to the U.N. climate summit in Glasgow, Scotland. "After all, our country accounts for around 20% of the world's forestland."

> Scientists say that natural forms of removing carbon dioxide, the main greenhouse gas, from the atmosphere will indeed play a key role in tackling global warming.

Many of the countries at the climate summit rely on some form of absorbing emissions to achieve their targets of being "net zero" by 2050 — that is, emitting only as much greenhouse gas as can be captured again by natural or artificial

But experts say the math behind such calculations is notoriously fuzzy and prone to manipulation by governments, who have a vested interest in making their emissions figures look good.

"Russia makes an enormous contribution in the absorption of global emissions -- both its own and others' -- by means of absorptive capacity of our ecosystems, firstly of forests, which is estimated at 2.5 billion (metric) tons of CO2 equivalent a year," said ViktoriaAbramchenko, deputy prime minister for environmental issues, speaking at a recent conference in St. Petersburg.

The figure came as a surprise to scientists contacted by The Associated Press. It constitutes a fivefold increase on the 535 million metric tons of CO2 absorption that Russia reported to the U.N. climate office for 2019.

Natalia Lukina, the director of the Center of Ecology and Productivity of Forests, a government-funded research institute, said the estimates are actually assumptions because "there is no real accurate data."

"Unfortunately, our official information about forestland is 25 years old, then this data was updated somehow, but there were no direct measurements,"

One problem is that nobody knows how many trees are in Russia's forests.

Last year, its forestry body finished an inventory that took 13 years and cost at least \$142 million, but it hasn't been made public or shared with the scientific community.

Russia's network of emissions monitoring stations is likewise limited. Lukina said.

VadimMamkin, a scientist who maintains one of the country's 11 greenhouse gas measuring masts in the Tver region, said the carbon balance of such old forests is "usually about zero," though figures vary about 10% from year to year.

Wildfires that burn millions of hectares of forest are another, increasingly pressing problem. Forests that have stored carbon for decades suddenly become big emitters when they burn, undoing an absorption effect, said Sergey Bartalev, head of the boreal ecosystems monitoring lab at the Space Research Insti-

Such fires are becoming increasingly frequent in Russia, partly due to climate change.

This year saw a record 13.1 million hectares burned, leading to emissions of 970 million metric tons of CO2 equivalent, according to an estimate by the European Union's Copernicus Programme — almost twice as much as the last reported absorption.

Fire protection is now a priority in Moscow's new strategy of low-carbon development.

Ahead of the climate summit, Putin declared that Russia plans to achieve carbon neutrality by 2060 — a goal similar to those set by China and Saudi Arabia but a decade behind the midcentury deadline that the U.S. and EU are aiming for.

Scientists say that stopping additional emissions of greenhouse gas into the atmosphere by 2050 is the only way to achieve the Paris accord's goal to keep the Earth's warm-

1.5 degrees Celsius (2.7 degrees Fahrenheit) by the end of the century.

Environmental campaigns and other nations that are wary of giving Moscow a free pass while they ramp up their own efforts to cut emissions will be watching closely what Russian diplomats propose.

VasilyYablokov, the head of Energy and Climate Sector at Russian Greenpeace, said Russia's forest calculations will play a key role in its climate plan, and he fears that estimates would be made to "fit into the answer."

One reason why Russia has a vested interest in minimizing its reported emissions in front of the United Nations is the prospect of a carbon tariff being mulled by the EU on imports from countries that are deemed to be not doing enough on cli-

"The role of forest is overestimated, unfortunately," said Alexey Kokorin, the head of climate and energy program at WWF-Russia. "It would be good to trust that Russia will be able to increase the absorption as it is in the draft strategy, and all of us will do the best to achieve it, but it looks like it's too much."


