BJP march over Sabarimala issue turns violent

THIRUVANANTHAPUR-AM, DEC 10 (PTI): The BJP's "secretariat march" over the Sabarimala issue here on Monday turned violent, prompting police to use water cannon and tear gas to disperse the party workers.

Protesting against the police action, BJP has called for a dawn-to-dusk hartal in Thiruvananthapuram district on Tuesday.

The main opposition Congress-led UDF, which continued to disrupt pro-ceedings in the state assembly for the sixth day took out a march to the House later. The BJP and the UDF marched separately, demanding the LDF government's intervention to end the agitation by their respective leaders for with-drawal of the prohibitory orders around Sabarimala.

The BJP workers threw stones and hurled chairs at police person-nel outside the state secretariat when the latter stopped them from proceeding further.

India successfully test-fires nuclear-capable Agni-5 missile

BALASORE (ODISHA) DEC 10 (PTI): India successfully test-fired nucle ar-capable ballistic missile Agni-5, which has a strike range of 5,000 km, from Dr Abdul Kalam Island off the Odisha coast

This is the seventh trial of the indigenously-developed surface-to-surmissile, defence

sources said.
Agni-5 is a three stage missile and is 17 metre tall and 2 metre wide. It is capable of carrying 1.5 tonne of nuclear warheads.

"The missile was launched with the help of a mobile launcher from launch pad-4 of the Inte-grated Test Range (ITR) at Dr Abdul Kalam Island in the Bay of Bengal on Monday afternoon," said a defence source.

"It was an user associated trial. Strategic force command along with DRDO scientists conducted it," the source added.



During this trial, the flight performance of the missile was tracked and monitored by radars. tracking instruments and observation stations, said the source.

India has in its armoury the Agni missile series -- Agni-1 with a range of 700 km, Agni-2 with a range of 2,000 km, Agni-3 and Agni-4 with 2,500 km to more than 3,500 km range.

The Agni-5 is the lat-est and most advanced variant in terms of navigation and guidance, warhead and engine.

"The high-speed on-

board computer and fault-tolerant software, along with robust and reliable bus guided the (Agni-5) missile flaw-lessly (during the test),"

an official said.

The missile is programmed in such a way that after reaching the peak of its trajectory, it turns towards the earth to continue its journey to the target with an increased speed, due to the earth's gravitational pull, and its path precisely directed by the advanced on-board computer and

UK court orders Mallya's extradition to India

LONDON, DEC 10 (PTI): A UK court Monday ordered Vijay Mallya's extradition, in a major boost to India's efforts to bring back the fugitive wanted for alleged fraud and money laundering charges amounting to an estimated Rs 9,000 crores. Delivering

the verdict, Westmi Magistrates' Court Chief Magistrate Judge Emma Ar-buthnot said that there was "no sign of a false case being mounted against him".

"Having considered evidence as a whole. There is a case to answer," Judge Arbuthnot said as she ruled that 62-year-old Mallya could be

extradited to India to stand trial on the charges brought by the CBI and the ED.

She was also extremely critical of how loans were

nificant point in the high-profile extradition trial that has lasted over a year. In relation to the defence's attempts to

EU court rules Britain can revoke Brexit unilaterally

LUXEMBOURG, **10 (AFP):** Europe's top court ruled Monday that Britain could halt Brexit without the approval of fellow EU member states. in a victory for pro-Europeans on the eve of a key House of Commons vote.

"The United Kingdom is free to revoke unilaterally the notification of its intention to withdraw from the EU," the European Court of Justice said, in response to a suit from a group of

Scottish politicians.
"Such a revocation, decided in accordance with its own national constitutional require-ments, would have the effect that the United Kingdom remains in the EU under terms that are unchanged as regards its status as a member State," the court ruled.

Following a 2016 referendum, Britain dea 2016 clared its intention to quit the European Union on March 29 last year, triggering the "Article 50" EU treaty procedure that would see it definitively leave two years later, on the same date next year.

British Prime Minister Theresa May's gov-ernment insists it has no intention of halting the

DEC process and has agreed a draft withdrawal agreement with the 27 remain-

ing member states.
The withdrawal agreement is expected to go before the British parliament for approv-

al on Tuesday.

If, as appears likely, it is rejected it would raise fears that Britain could crash out of the union on March 29 without a deal or that it could revoke or postpone Brexit in order to hold an-

other referendum. The court's ruling will be welcomed by campaigners for a second referendum, but May's government insists it has no intention of re-versing course, whatever the court in Luxembourg

might say.

"We don't want to stay in the EU. We voted very clearly," Environ-ment Secretary Mi-chael Gove, an influencabinet Brexiteer, told BBC radio.

"This case is all very well but it doesn't alter either the result of the referendum or the clear intention of the government to leave.

Nobel laureates urge world to help victims of rape in conflict

OSLO, DEC 10 (AFP): Nobel laureates Denis Mukwege and Nadia Murad called on the world to protect victims of wartime sexual violence in their Peace Prize acceptance speeches on Monday, slamming indifference to the plight of women and children in conflict.

Congolese gynecologist Mukwege, whose work has made him a global expert on rape in conflict, and Yazidi activist Murad, a survivor of IS sexual slavery, both said victims were sometimes valued less than commercial interests.

In an emotional ceremony, which saw the laureates cheered and given standing ovations, Mukwege and Murad called on the world to do more.

"If there is a war to be waged, it is the war against the indifference which is eating away at our societies," Mukwege said at the ceremony in

His Panzi hospital in the Democratic Republic of Congo's war-torn east has treated the wounds of tens of thousands of women and children for sexual assaults that have become a "new reality" in the country. He said the violence

shames our common

humanity". In her speech Murad implored the global community to help free hundreds of women and girls still held by jihadists, saying the world must protect her people and other vulnerable communities.

"It is my view that all victims deserve a safe haven until justice is done for them," she said, paus ing briefly, seemingly overcome with emotion

chairwoman Berit Reiss-Andersen said the pair had received the Peace Prize "for their efforts to end the use of sexual violence as a weapon of war and armed conflict".

She described them as "two of the strongest voices in the world today". In a sombre cere-

mony in Oslo City Hall, both smiled as they received the Peace Prize gold medal, diploma and the nine million Swedish Krona (880.000 euros, a million dollars they will share. dollars), which

Mukwege lay much of the blame for the horrific violence unleashed on civilians on those in power in his troubled country.

"For twenty years now, day after day, at Panzi hospital, I have



sequences of the country's gross mismanagement," said the doctor, a critic of DR Congo President Joseph Kabila, who is set to be replaced in elections this month.

"Babies, girls, young women, mothers, grand-mothers, and also men and boys, cruelly raped, often publicly and collectively, by inserting burning plastic or sharp objects in their genitals." Mukwege said the trade in the country's abundant natural resources helped fuel the violence while profits "end up in the pockets of a predato-

ry oligarchy". "We love nice cars,

jewellery and gadgets. I have a smartphone myself. These items contain minerals found in our country. Often mined in inhuman conditions by young children, victims of intimidation and sexual violence," he said.

"It's not just perpe-trators of violence who are responsible for their crimes, it is also those who choose to look the other way." He called for a global fund to provide reparation for victims and economic and political sanctions for those behind the violence.

Murad survived the horrors of captivity under the Islamic State group in Iraq and Syria where

they targeted her Kurdish-speaking community.

Captured in 2014,

Murad suffered beatings and gang-rape before she was able to escape.

In her Nobel accep-tance address Monday, Murad said more than 6,500 women and girls from her community had been kidnapped, raped and traded "in the 21st century, in the age of globalization

and human rights".

The fate of some 3,000 women and girls is still unknown.

"Young girls at the prime of life are sold, bought, held captive and raped every day. It is inconceivable that the conscience of the leaders of 195 countries around the world is not mobilised to liberate these girls," she said.

"What if they were a commercial deal, an oil field or a shipment of weapons? Most certainly, no efforts would be spared to liberate them." Murad, whose mother and six of her brothers were killed, said on Sunday that "steps towards justice" had given her

some hope.

A UN team authorised to investigate the massacre of the Yazi-di minority is due to finally start fieldwork

in Iraq next year. Murad has been supported in her campaign for justice for Yazidis by Lebanese-British lawyer and rights activist Amal Clooney, who was in the audience in Oslo.

No iihadist has vet faced trial over the atrocities against the Yazidis.

Murad said she was thankful for the Peace prize, but added: "The fact remains that the only prize in the world that can restore our dignity is iustice and the prosecution of criminals

NEW DELHI, DEC 10 (PTI): RLSP president Upendra Kushwaha resigned from the Union council of ministers and walked out of the BJP-led NDA on Monday, a day before Parliament's Winter Session begins.

Kushwaha, in his res-ignation letter to Prime Minister Narendra Modi, said he was "dejected" and "betrayed" by the PM's leadership, accord-

ing to party sources.

"It is unfortunate that the government's priority is not to work for the poor and oppressed, but to fix political opponents by hook or crook," Kush-waha said in the letter.

The Rashtriya Lok Samta Party chief also held a press conference here in which he an-nounced he has quit the National Democratic Alliance, "I have left NDA, other options are open," he said.

Kushwaha also attacked Nitish Kumar, saying the Bihar chief minister was against him.

The first test was conducted on April 19, 2012, the second on September 15, 2013, the third on January 31, 2015 and the fourth one on December 26, 2016. The fifth test was held on January 18 this year and the last one was held on June 3, 2018. All the trials were successful.

Urjit Patel resigns as RBI Governor citing personal reasons

Reserve Bank Governoi Urjit Patel, who faced the possibility of an unprecedented action from the government over differences on a variety of issues. Monday resigned from his job citing personal reasons.

Patel, 55, who took over as the 24th Governor of the central bank on September 5, 2016, had the shortest tenure since 1992.

He was hand-picked by the BJP-led government after his predecessor Raghuram Rajan was denied a second-term.

"On account of personal reasons, I have decided to step down from my current position effective immedi-ately," Patel said in a brief statement.

His resignation was being speculated right from the time the government cited a never-be-fore-used provision of the RBI Act to get him to consider its views on re-



laxing lending norms for segments such as small and medium enterprises, appropriate size of reserves the central bank must maintain and easing norms for

Patel thanked his colleagues at the RBI but made no mention of the government or the Fi-

nance Ministry. "It has been my privi-

lege and honour to serve in the Reserve Bank of India in various capaci-ties over the years. The support and hard work of RBI staff, officers and management has been the proximate driver of the bank's considerable accomplish-

ments in recent years. "I take this opportu-nity to express gratitude to my colleagues and Directors of the RBI Central Board, and wish them all the best for the

future," he said.

Patel had more than eight months of the first three-year tenure left and was eligible for a second term as was given to several of his predeces-

Delhi air quality worsens, to further deteriorate in next two days

NEW DELHI, DEC 10 (PTI): Delhi's air quality worsened further and slipped to 'severe' cate-gory Monday as heavy stagnant air prevented dispersion of pollutants, according to authorities. The Central Pollution Control Board or CPCB recorded an overall air quality index (AQI) of 403, which falls in 'severe' category. Neighbouring Ghazia-bad, Noida and Faridabad also recorded 'severe' air quality. Noida's air quality was worst at a AQI of 452, CPCB data showed.

An AOI between 201 and 300 is considered 'poor', 301 and 400 'very poor' and

401 and 500 'severe'. Nineteen areas in Delhi recorded 'severe' air qual-ity and ten areas recorded very poor' air quality, ac-

cording to the CPCB.

Under the 'severe' category, even healthy people find it harder to breathe and doctors advise physical activity be kept at a minimum. Au-thorities said they are closely monitoring the The overall PM2.5 lev-

el -- fine particulate matter in the air with a diameter of less than 2.5 micrometre -- was recorded at 257 and the PM10

level at 445, it said.
The Centre-run System of Air Quality and Weather Forecasting (SA-FAR) said the overall air quality of Delhi will further deteriorate over the next two days.

"Values are likely to re-main in same range until tomorrow which is likely to decline by Wednesday. Calm surface winds are not allowing pollutants to disperse," it said. "Winds are calm and

dispersion is low. Western disturbances influ-ence may impact Delhi's air quality by introducing the moisture and making air heavy.

Amendments in rules on HSRP for vehicles notified: Govt to SC

NEW DELHI, DEC 10 (PTI): The Centre on Monday informed the Supreme Court that it has notified the amendments to Central Motor Vehicles Rules, 1989 following which all new vehicles will be sold pre-fitted with high security registration plates (HSRP) from April 1.

The government told this to a bench of Justices Madan B Lokur and Deepak Gupta which was hearing a matter related to hologram-based, co-lour-coded stickers for vehicles indicating the fuel being used by them.

The bench said since

the rules have been notified, no further order was required to be passed in

Advocate Aparajita Singh, who is assisting the court as an amicus curiae in the air pollution matter, said on October 1 that the Ministry of Road Transport Highways (MoRTH) had asked the national capital region (NCR) states to im-plement the apex court's order regarding colour coded stickers on vehicles.

She said the rules notified by MoRTH were likely to be challenged and court should make it clear that any chal-lenge to this notification should come to the top court only.

Additional Solicitor

General A N S Nadkarni, appearing for MoRTH, also supported Singh's submissions and said only top court should hear the challenge to notification so as to avoid any multiplicity.

The bench said that challenge to the validity of the notification would be heard by the top court only.

According to MoRTH, the notifica-tion mandates that HSRP, including the third registration mark, shall be supplied by the vehicle manufacturers along with vehicles manufactured on or after April 1, 2019 to their dealers and the dealers shall

place a mark of registration on such plates and affix them on the vehicle.
The vehicle dealers

can also provide the high security regis-tration plates for old vehicles, the ministry has said, adding, that high security registration plate helps in keeping track of ve-hicle and makes it easier to trace a lost or stolen vehicle.
The amicus had

earlier flagged in the apex court an issue that there was only one vendor in a state for issuing HSRP for vehicles and it was a "monopoly" of vendor.

The apex court had on August 13 accepted the proposal of MoRTH

(PTI): Exports of tea to Pakistan during the first 10 months of 2018 rose 22 per compared to 10.65 million kg in the corresponding period of 2017, the Tea Board said on Monday.

Major country-wise exports from January to October stood at 200.38 million kg as against 198.86 mil-lion kg a year ago, as per provisional estimates released by the board.

Iran was the highest im porter of Indian tea at 23.04 million kg during the re-porting period, topping the year-earlier figure of 22.13

However, there was a slight fall in exports to CIS nations at 51.07 million kg from 52.72 million kg in the similar period of 2017.

In value terms, India

exported tea worth Rs 4,061.81 crore during the first 10 months of the year, compared to Rs 3,911.05 crore in the corresponding period of 2017, according to the Tea Board release.

The unit price per kg during January to Oc-tober was lower at USD 2.99 as against USD 3.03 a year ago.

vernment, we cannot resort to anything we want," Singh said, adding, the Human Rights Com mission and the judiciary are there to check the excesses.



Haste Makes Waste About time that budgetary controls were reinforced

One often hears people with bills stuck with government departments complain of how they are routinely turned away with excuses of the department not having enough funds. There was a time when an accounts section in a government department had put up a notice on its door announcing that it did not have funds and that people should not bother them unnecessarily. That was back in 1999! In the two decades that have passed since, not much has changed even if the directness with which the lethargy is admitted has toned down. One says lethargy and not paucity because it is the former that is to be blamed because when a fiscal year draws to a close, funds appear to materialise rather furiously. But we get ahead of the story here. Remember the time when regularized MR and Workcharged employees who had not received their salaries for some months and given the run around with the excuse that the required funds had not been released. Most times, people accept these excuses as being truthful, believing that the concerned personnel in the government know their jobs and that the government is genuinely cash-strapped. But that is almost never the case as reports of the Comptroller and Auditor General of India on the State's finances have routinely pointed out. More often than not, the government ends up not spending up to a quarter of the funds at its disposal on any given financial year. For instance, between 2012 and 2017, in eleven cases at departments ranging from Forests to Social Welfare to HRDD to Power to RM&DD to Tourism, there were persistent savings of more than Rs One crore in each case and also by 10 per cent or more of the total grant.

Now, if this 'saving', and this cannot really be called a saving, was a result of austerity measures and judicious book-keeping, one would be all praises for the army of accountants in government departments. But that was not the case; the 'savings' resulted from incompetence. Few examples illustrate this slipshod financial planning better than the habitual rush of expenditure in the last quarter of the financial year, with a bulk of this coming in the closing month.

When it comes to the budget and the segregation of demands for grants, the government breaks it up into 46 departments and then there are several "heads" under it for specific expenditures. As per the CAG Report, in 28 "Major Heads" under 19 grants/appropriation, an expenditure of Rs 410.71 crore during the month of March 2017 ranged between 50 and 100 per cent of the total expenditure. In eleven cases, 100 per cent of the total provision for the year 2016-17 was incurred in March, which was contrary to the Sikkim Financial Rule which clearly mandates that rush of expenditure in the closing month of the financial year should be avoided. If it is any solace, this situation is slightly better than March 2013 when 22 departments showed an injudicious 'rush of expenditure' between Jan to March that year. This expenditure was under 33 heads and the record reflects on those rushed [it should really be called delayed] expenditure which were in excess of 50% of the provision, i.e. instances when the department spent 50% of its budget [under a particular head] in the last three months of the year. Some of the standouts in this list are Land Revenue Department which did not spend anything on water supply and sanitation for 9 months and then spent the entire budgetary provision between Jan to March, with 62% of it in March 2013 alone, Expenditure on 'public works' by the same department for the said financial year was paid out entirely in March 2013. HRDD spent 67% of its "capital outlay for education, sports, arts and culture" in the last quarter.

But March 2017 was still special.

The State Government incurred an expenditure of Rs 1,062.25 crore (i.e., 22.26 per cent of the total expenditure) in March 2017, out of which, Rs 352.16 crore (7.38 per cent of the total expenditure of the year) was spent on the last day i.e., 31 March 2017.

It goes without saying that the last minute rush $the \, diligence \, of \, the \, accounts \, departments \, to \, spend$ it all, does not offer enough time to really 'spend it all' due to which in 32 cases, savings exceeded Rs one crore in each case and also by more than 20 per cent of total provision. Against the total savings of Rs 1,796.94 crore in the State, savings of Rs 1,040.23 crore $(57.89\,\mathrm{per\,cent})$ occurred in 7 cases relating to 7 grants.

If Rs 1.796.94 crore of the budgetary provision remained unspent in 2016-17. It would have been less worrying if this was just saving, but it is more than that, it is unplanned finances resulting in compromised projects and schemes. Surely, if Rs 1,040.23 cr of the provisions remain unspent in seven cases, everything for which the funds were earmarked in the budget projections gets compromised. Clearly, budgetary control should be strengthened and a good place to begin would be to have a "Budget Manual" which enumerates detailed procedures for better financial manage-

eventy years ago, the then 58 members of the United Nations (UN) adopted its first two fundamental frameworks at the General Assembly in Paris: "the onvention on the Prevention and Punnment of the Crime of Genocide on 9 ecember 1948; and

the Universal Declaration of Human hts on 10 December."

Nowadays, this achievement is recgnised as Human Rights Day. In a few buntries, among them South Africa, Namibia and Cambodia, it's celebrated at some point during the year as a public holiday.

Often, the Universal Declaration is

criticised as an attempt to establish West-ern values to maintain a global dominance. Its eight main drafters came from Australia, Chile, China, France, Lebanon, the Soviet Union, Great Britain and the US. Article 1 starts with the words:

All human beings are born free and ual in dignity and human rights.

Critics have questioned the relevance of these frameworks. But as I argue in a orthcoming book, the Universal Declaration in combination with the Charter f the United Nations served as a relevant ompass in the campaigns for decoloisation during the 1950s. But, as a detailed historical study by Roland Burke documents, once in power an--colonial movements often turned neir backs on the very same rights they used for the mobilisation and recognition of their struggle. So where is the world 70 years on?

The second Secretary-General of the UN

Dag Hammarskjöld popularised the saying: "the UN was not created to bring us to eaven, but in order to save us from hell. Sadly for many people life on earth has remained close to hell. But their numbers ould not be less without the UN framerks. Numerous human rights principles adopted during the last 70 years might not have the effects we would like to see. But they have not been in vain.

The anchoring of genocide and crimes against humanity as part of international law after the Nuremberg trials has been brilliantly documented by historian and author Phillippe Sands. But institutionalised prosecution only followed the adoption of the Rome Statute in 1998 and the establishment of the International Criminal Court in 2002. Even so, most war crimes remained outside of the Court's jurisdiction because big powers such as China, Russia and the US, as well as a host of other states, refused to ratify it.

Established in 2006, its 47 members proportionally represent the world regions. They are elected for a three-year period by the UN General Assembly.

The Court has suffered other setbacks too. A number of African states have withdrawn from it on the grounds that they feel the continent is being selectively targeted. This despite urgent pleas by civil society not influence international law.

Other areas of progress have similarly been marred by setbacks. This has been mainly due to the fact that human rights issues in the global governance sphere are often the victim of strategic or opportunistic motives and reasoning.

SELECTIVE APPLICATION

These contradictions are mirrored in the composition and voting patterns of the UN Human Rights Council (UNHCR). The issue of LGBTI rights is an example of block voting. In mid-2016 Muslim and African countries - with only one exception – voted against, or abstained from supporting, a resolution on the protection against violence and discrimination based on sexual orientation and gender identity.

But this didn't prevent the adoption of a pioneering recognition and obligation for the protection of these communities.

There are other successes. They suggest that the role of the UNHRC – and of human rights campaigns - is anything but obsolete. Take the investigations on behalf of the UNHRC that resulted in a report documenting the violence unleashed in Myanmar by the military against the

Rohingva. It also implicated the Nobel Peace Laureate Aung San Suu Kyi and culminated in the outgoing UNHRC chief demanding her resignation. Her extraordinary fall from grace shows that moral-political postulates do matter, and have consequences when being ignored.

Despite such occasional successes failures to live up to the standards codi-fied (and ratified) continue to characterise the track record in global governance. More often the abuse of human rights remains without such condemnation.

THE STRUGGLE CONTINUES

The dilemma is structurally embedded. Asymmetric power structures in global governance have not been solved. The most influential states control decision making in the UN Security Council. With their veto power they remain gatekeepers and put their own interests over those of humanity.

As a result, the conventions are still selectively applied. Double standards by those who close eves and ears if it suits their economic and geostrategic interests remain firmly in place. The barbaric assassination of the journalist Jamal Khashoggi – and US President Donald Trump's

response – is a sobering reminder. Nevertheless, the frameworks Nevertheless, the frameworks have introduced reference points against which such hypocrisy can be measured, named and shamed. With-out such conventions, campaigns and campaigners - would have been even less successful.

Despite all shortcomings and flaws, the world would not be a better place without the UN and its accepted (though not practised by many) mini-

mum standards of good governance. Human Rights Day might not be a reason for celebrations. But it is a helpful reminder that a great deal is already anchored in frameworks that recognise human dignity

and well-being.

We have to live up to it – and continue to fight for them.

Impersonation clearly work best when ad sponsors are able to hide their identities and motives. Anonymous ads are also more likely to violate ethical stanbeing held responsible for them.

MAKE PLATFORMS MORE DEM-OCRATIC

A more significant change social me-dia companies could make would be to introduce democratic oversight of how they collect and use people's data.

Facebook's Zuckerberg recently took an initial step in this direction, announcing that he will create independent review panels to handle users' appeals against the company's removal of content it judges inappropriate. He explained that he wanted to ensure "these deci-sions are made in the best inter-

nmercial reasons." Whatever you think about this plan – and it has been greeted with plenty of skepticism – Zuckerberg's reasoning acknowledges that be-cause social platforms have become so central to democratic life, their own policies and design decisions require democratic accountability.

Officials earlier said both sides would field 100 personnel to take part in the seventh edition of the exercises.
The inaugural ceremony would be held on Tuesday and the drills would be concluded on



December 23

The drills are being held after a gap of one year as they could not be held last year because both armies were locked in a 73-day standoff at Doklam in the Sikkim sector.
Asked about how Chi-

na viewed the exercises being resumed after Doklam, Chinese Foreign Ministry spokesman Lu Kang said "we hope this can have a good results".

He referred to the informal summit between Prime Minister Narendra Modi and President Xi

Jinping at Wuhan in April this year and the "important consensus" reached between the two leaders to improve relations.

He noted that the two leaders had met four times this year.

The two countries should implement the consensus between the two leaders including the exchanges between the two militaries, Lu said.

"Under the guidance of the consensus be-tween the two leaders and through the con-certed efforts of the two sides, I hope the exchang-

es between the two militaries can achieve positive outcomes, injecting impetus to the bilateral ties," he said.

Govt stops foreign funding to 156 NGOs

NEW DELHI, DEC 10 (PTI): Cracking the whip, the government has barred 156 NGOs from receiving foreign funds for six months for defying an order to open a counts in any of the 32 designated banks.

he Home Ministry said about a year ago, it had directed all non-gov-ernmental organisations (NGOs), business entities and individuals who re ceive funds from abroad to open accounts in any of the 32 designated banks for higher level of transparency. However, the latest order said that it has been observed that the associations have not yet opened their bank accounts in central government's Public Financial Management System (PFMS)-integrated banks and contravened the provisions of the Foreign Con-tribution (Regulation) Act 2010 by not complying with the December 2017 direction.

"Now, therefore, in exercise of the power conferred by section 13 of the FCRA, 2010, pending consideration of cancellation of their certificates, the central government hereby, suspends the registration under FCRA 2010 of the said associations (including their branches and units) for a period of one hundred and eighty days..," the latest directive said. Suspension of

FCRA registration means

the NGOs and entities can not accept funding from abroad, an official said. The directive to the NGOs, companies and in-

dividuals to open foreign contribution accounts in banks, which are integrated with the central PFMS was given for a higher level of transparency and hassle-free reporting The FCRA 2010 pro-

vides for the regulation of acceptance of the foreign funds or foreign hospitality by certain individuals, associations, organisations and companies "to ensure that such contributions or hospitality is not being utilised for the

activities detrimental to the national interest", the ministry had said.

"We welcome everyone who are opposed to the proposed Citizenship (Amendment) Bill. 2016. The bill is likely to be place on the floor of the Parliament tomorrow (Tuesday)," Hrangkhawl said.

The bill seeks to make migrants of six commu-nities eligible for citizenship of India.

the cornerstone of field hockey for so long, dragflicks are fast becoming a "dying art" because of technological advancement of the game and experts feel it is time to infuse a new life to the scoring technique before it diminishes further.

Danger is lurking over the art even though it is still not on life support With the usage of modern technology which includes video analysis, improved coaching methods and upgraded protective gears for first-rushers, scoring with a drag-flick is becoming more and more difficult now-a-days.

A statistical assessment of the matches till the pool stages of the ongoing men's World Cup here will give a fair idea about the diminishing

effect of penalty corner

A total 167 penalty corners were earned by the 16 participating teams in the 24 matches played so far at the end of the pool stages of the World Cup. But the conversion rate provides a threatening picture.
Out of the 167 chance

es, only 40 resulted in goals, which put the con-version rate at a poor 23.95 per cent.

Ask former India captain Sandeep Singh, a lethal drag-flicker in his playing days, about the concern and he sums it up beautifully.

"It is getting tough-er and tougher to score from drag-flicks now-a-days because every team's defence has got smarter. With protective gears in place, the first runners are not afraid today to rush in and take a

hit," Sandeep told PTI.

"But there are still

Is drag-flick a dying art in field hockey? some flickers like Gonzalo Peillat who can beat any defence with power and accuracy. We need variations, variations in not just attempt but in flickers' attempts as well. I mean a flicker needs to use different angles, pace to keep the oposition defence guess-

But it is not a concern that came to fore overnight. The game is witnessing low conversion rate from penalty corners since the 2016 Rio Olympics and it is decreasing with every International Hockey Federation (FIH) event.

Argentina's Peillat, considered as the best drag-flicker of the world currently, feels "sur-prise element" is the need of the hour.

"It's all about how the other team defend. You cannot expect the flick-ers to score from every corner. Every drag-flicker tries to study the defence of other teams. You have to find a way how to beat the defence," he said.

"Every team is working on variations but every time you cannot go variations or direct hit. You have to play with both the styles. It has to be a mix and match to keep the opposition defence guessing. You need to have surprise el-ement," Peillt said in his assessment.

Two-time defending champions Australia has so far earned 15 penalty corners and converted just five. Australia chief coach

Colin Batch said the ever-increasing decline in conversion rate is a cause of concern. Yeah, it is a concern.

It is getting harder and harder to score from short corners. The defence are very good now. We need to get the push out really quick to give

our flickers the best opportunity." Batch said.

India's analytical coach Chris Ciriello, who was a potent drag-flicker for Australia and scored three goals in the final of the last World Cup in 2014, said the usage of varied types of protective gears have made defenders fearless now while defending penal-

ty corners.

"Defending a penalty corner is safe now because of different equip-ments. The guys wear ice hockey gloves, thicker knee pads and shin pads. So the risk of injuries have subsided and the rushers have become fearless," Ciriello said.

But all said and done. the experts are of one opinion while giving their concluding remarks drag-flicks still and will remain a key component of field hockey but exe-cution of the art need to change with time.

India halt 10-year barren run in Australia with 31-run win

ADELAIDE, DEC 10 (PTI): India gave wings to their quest for a maiden series win in Australia with a 31-run victory in the opening Test, their first in the country since 2008, with Rishabh Pant equalling a world record along the way

record arong here Monday.

Chasing 323, the Chasing 323, the hosts were bowled out for 291 in 119.5 overs shortly before tea on day five with Ravichandran Ashwin, Jasprit Bumrah and Mohammed Shami taking three wickets each for a 1-0 lead in the four-

Pant finished with 11 catches, and equalled the record for most dismissals in a Test by a wicketkeeper, sharing it with England's Jack Russell and South Africa's AB

de Villiers.

This was the first time India won the opening Test of a series in Australia in 70 years.

Things went too close for comfort for India as Nathan Lyon (38 not out)

and Josh Hazlewood (13) put on 42 runs for the last wicket and frustrated the Indian bowling. The sparse crowd at Adelaide Oval cheered every single as the duo edged closer and the odd boundary didn't help matters.

Finally, things came to a close as Ashwin had Hazlewood caught at second slip in the 120th over to register India's sixth Test win on Australian soil.

"It's important to stay calm. The odds were stacked up against them as soon as we got Pat Cummins out I wouldn't say I was cool as ice but you try not to show it, Kohli said at the end of

Post lunch, India had a big early breakthrough when Australian skipper Tim Paine (41) played an uncharacteristic pull shot off Bumrah and only managed to loop it up for Pant to take an easy catch.

The visitors then were bothered by two lower-order stands.



First, Mitchell Starc (28) and Pat Cummins (28) put on 41 runs for the eighth wicket and carried Australia past 200 in the 89th over.

The duo had added 31 runs with the onus now on Marsh and Paine as the last recognized batting pair.

Marsh shouldered the responsibility and scored his first half-century in the fourth innings of a Test off 146 balls. It was his 10th Test half-century overall.

He had looked com fortable at the crease all morning, but Bumrah removed him after the drinks break. The big moment came as the ball moved away just a tad and Marsh gave the slightest of edges to be caught behind in the 73rd over.

It was Pant's ninth dismissal in the Test, equalling MS Dhoni (9 versus Australia, Melboure in 2014) as the Indian wicket keeper overseas Tests. He later equalled and went past Wriddhiman Saha's Indian record for highest dismissals in a Test (10) against South Africa at Cape Town

earlier in the year.
Cummins then helped Paine play out 10.5 overs although he had a couple of hairy moments in the 74th over off Ashwin, India wasted a DRS review when they thought he

had edged it.
Four balls later, a loud appeal for caught at short leg was turned down with Cummins reviewing it successfully

India scored 250 in their first innings with Cheteshwar Pujara an-choring with his 16th Test century.

Shakhtar prepare for home match 700 kilometres from home



KIEV, DEC 10 (AFP): It is a big week for Shakhtar Donetsk and their fans as they prepare to host Lvon in the final round of Champions League group games on Wednesday.

But the spectre of war has cast a shadow over the match with the fans now expected to travel over 700 kilometres (435 miles) to watch their own team 'at home'.

Victory over the vis-iting French side will see Shakhtar, the Ukrainian champions, book their place alongside Group F winners Manchester City in the last 16 of Europe's top club tournament.

A draw will be enough for Lyon to progress at Shakhtar's expense, so for the Ukrainians it is all or nothing.

Anticipation among the players and the fans of a packed and pulsating home stadium cheering the team to a place among the very elite of Europe was rising... until the match was moved last week to the capital Kiev.

Shakhtar will now host Lyon in a city over 700 kilometres away from home, the lair of one of their biggest rivals

The reason? War. And the introduction of martial law.

In late November, Russia seized three Ukrainian navy vessels and detained 24 crew members in the most dangerous incident years between the ex-Soviet neighbours.

In response, Kiev im

posed martial law for 30 days in 10 regions that border Russia, including Shakhtar's temporary

home in Kharkiv.

That in turn prompted UEFA to move the Shakhtar-Lyon match to Kiev.

"It's very hard for a club to play in an alien city," Ruslan, a Shakhtar supporter from Donetsk, told AFP. "The team, of course, lacks all those

fans... their support."

Shakhtar fans have become used to having to travel to home games.
For the last two years

the club has been sheltering in Kharkiv, a mere kilometres from Donbass Arena in Donetsk, which they abandoned in 2014 when the region fell under the control of Russia-backed separatists.

Kharkiv was a step up for the fans as Shakhtar has spent two years travelling over 1.200 kilometres to play home games in Lviv on the other side of the country.

Shakhtar's coach Pau-Fonseca has urged fans to support the team in the capital.

We regret that the match venue has been changed, causing inconvenience for our fans who planned to attend match in Kharkiv... We hope for your support in Kiev!" the Portuguese manager said in a statement to the fans on

the club website.

The club even offered to book the best seats at the 70,000-seat Olympic Stadium in Kiev for those supporters who bought tickets to the Kharkiv arena, but now are willing to

come to the capital.

The problem for the fans is twofold. Distance

is certainly a factor but other stumbling block for them is that they will have to play in the capital, home of their longtime rival Dynamo Kiev. They can hardly rely on local support.

"It would be better to play in Kharkiv. There are more of our fans there." Shakhtar fan Sergiy Tsvelyov told AFP.

"I myself planned to go (to Kharkiv). But it will be very difficult for me to go to Kiev," the 20-year-old student, who lives in a small town in eastern Ukraine, said.

Fonseca and his play ers are doing their best not to be distracted by the switch and head into the match in good spirits.

"We do not feel any danger in the cities which

we visit," said Fonseca.

After retaining the Ukrainian title in May, Fonseca's side are seven points clear of Dynamo Kiev in the current championship race. They beat FC Mariupol 3-0 away on Friday in their last match before the domestic league winter break

The players echoed their coach but admitted the Lyon switch is a nuisance for their supporters.

"It didn't create big problems for us (footballers)," midfielder Taras Stepanenko told AFP.

This is a big problem for our fans."

"We hope that the fans will have the opportunity to come... and support the team. It is very important for us." A win on Wednesday will make the journey all the more worthwhile.

LONDON, DEC 10 (AFP):

Tottenham are sitting pretty in the Premier League but face a potenseason-defining against Barcelona in the Champions

League on Tuesday.

Mauricio Pochettino's men have amassed 36 points from 16 Pre-League matches, with 12 wins, leaving them in third place behind Liverpool and Manchester City.

That they have man-aged that despite playing in their temporary home of Wembley and after a World Cup in which so many of their players featured un-til the final weekend, makes their achievement all the more impressive.

However with City and Liverpool in such rampant form, few expect Spurs to win the Premier League, putting increased emphasis on their match against the Spanish league leaders

in Group B.

Pochettino somehow find now find a way Lionel Messi's Barcelona to reach the knockout stages but he remains positive ahead of the daunting trip to the Camp Nou to face the five-time European champions.
"It will be a massive

game. They have qualified for the next stage but in the Champions League no one is going to give a present," said the Argentine, who left Harry Kane out of the starting line-up for the 2-0 win away to Leicester on Saturday. "We need to win

and deserve to win. The mentality is going to be 200 percent to try to win. We are going to arrive in the best con-dition, Barcelona are one of the best teams in Europe." Spurs took just one point from their first three games in Group B, losing to In-ter Milan and Barcelona



and drawing with PSV.

But they beat PSV at home and then scored late through Christian Eriksen to beat Inter 1-0 at Wembley, leaving them in second place on seven points, the same as the Italians.

With Barcelona already guaranteed to top the group, Spurs must match Inter's result to guarantee progress.

Pochettino has in the past talked about how only the Premier League or Champions League title will take the club to the "next level", even though the tro-phy cabinet has been empty since 2008.

Spurs have played in the Champions League for the past three seasons but they cannot boast the pedigree or history of Manchester United or Liverpool in Europe's top club competition.

They have only pro-gressed beyond the Champions League group stage twice, reaching the quarter-finals in 2011.

Barcelona, who beat Spurs 4-2 at Wembley. have already made sure of winning their Champions League group for a record 12th successive season.

Dauntingly for Spurs, Barca are unbeaten in 28 Champions League home matches and the Londoners will not be

encouraged by the fact that the Spaniards have only lost two home matches in 33 against

English opponents.

But Spurs themselves, with a vibrant collection of attacking players including Kane, Eriksen, Dele Alli and Son Heung-min, have won eight out of their past nine fixtures in all competitions and will be hoping that Ernesto Valverde's side take their foot off the gas.

Beating the Catalan

club would be particularly sweet for Pochettino, a former player and coach at Barcelona's city rivals Espanyol.


