A press release from Home Department in-forms that all work and movement including the traffic will stop exact-ly from 11 a.m to 11:02 a.m throughout the State. Wherever available, available commencement of and termination of two minutes' silence period should be indicated by sound of siren. The day will be observed with due solemnity, the release adds.

Hazare to launch hunger strike from Wednesday on Lokpal

Mumbai, Jan 28 (PTI): Social activist Anna Hazare has announced that he would launch a hunger strike from Wednes-day over the "non-fulfill-ment" of assurances by the Centre and the Maha rashtra government on the appointment of Lokpal and passage of Lo-kayukta Act in the state respectively.

In his letter to Chief Minister Devendra Fadnavis, dated January 28, Hazare said he would launch the agitation in his village Ralegan Siddhi in Ahmednagar district of Maharashtra.

Meanwhile, the Fadnavis Cabinet Tuesday decided to bring the office of Maharashtra Chief Minister under the juris-diction of Lokayukta.

Maharashtra Minister Girish Mahajan, who has been acting as an emissary between the gov ernment and the activist, urged Hazare to cancel the agitation, claiming that almost all the de-mands made by the activist have been fulfilled.

Hazare, however, said he would not call off the agitation till the Lokavuk-

ta Act becomes a reality.

Apart from the appointment of Lokpal at the national level and Lokayukta in states, Hazare has been demanding implementation of the Swaminathan Commission recommendations and

some electoral reforms.

"It has been five years since the Lokpal Act was passed. Yet the Narendra Modi government has not appointed Lokpal.. Lokayukta Act has not been passed in Maha-rashtra for four years," Hazare observed in his

letter dated January 28. The activist said the chief minister had mediated when he had launched the agitation at Ramlila Maidan in Delhi in March last year.

Adhoc teachers receive some concessions, want more

Regularisation demand remains unresolved. dharna to continue

NITESH R PRADHAN GANGTOK, 29 JAN: All Sikkim Adhoc Teach

ers Association & Temporary Employees Associa-tion had a meeting with the Human Resources Development Depart-ment Minister, Secretary and officials here at the HRDD head office today after having descended in large numbers at the HRDD office to press for their demands of regularization, continuation of service and reservation in government employment.

Although the pro-testors received some assurances from the Department, they are not completely satisfied yet and their demonstration at the HRDD office is expected to continue.

Meanwhile, accord-

ing to the adhoc teach-



ers, the department has agreed to issue them ap-pointment letters covering the entire year – 01 Jan to 31 Dec. Earlier, the teachers would get appointment letters cov-ering only the academic sessions leaving them without a salary during the winter holidays.

On the demand for

50% reservation for adhoc teachers in all government employment, the Department has assured that 30 to 50 percent will be reserved for the adhoc teachers, it is informed.

The services of temporary teachers appointed under Sarva Shiksha Abhiyan will also continue, the department conceded.

What remains up in

the air, as per the protesting teachers, is the rea-son or fairness of salaries of SSA teachers being reduced from Rs 10,000 to Rs 7,000 per month.

The protesting teachers

are also demanding that all of them who meet the ed-ucational qualifications required for regular teachers be absorbed into service, while those who lack the qualifications be retained in service in the temporary status and the Department formulate a policy by which their services can be regularized on a

There is no clarity yet on how this demand is being addressed and

pre-scheduled timeline.

the protesting adhoc teachers remain uncon-vinced, arguing why, when services of temporary employees in other departments can be regularized should they remain denied

The protesting teachers inform that the CM's assurance that temporary teachers who have served for five years and more will be regularised has been clearly rejected by the Department.

"We fail to understand why they can't implement what the CM has assured," said the protestors.

They have stated that such a protest became necessary when the government did not pay any heed to the ultimatum

served by them.

The adhoc teachers, it may be recalled had taken out a protest rally in Gangtok on 24 Jan and served a 5-day ultimatum to the Department to

address their demands.

Till the time of filing this report, the protestors were still at the head office, insistent that till a concrete assurance was received from the Department, they will continue their demonstration inside the head office.

They are also de-manding that a Temporary and Adhoc Regularisation Act be passed in the legislative assembly in the upcoming session.

North-east parties decide to oppose Citizenship Bill together

GUWAHATI, JAN 29 (PTI): Ten political parties of the north-east, most of which are members of the BJP-led North East Democratic Alliance (NEDA), along with the saffron party's key ally in Bihar, the JD(U), on Tuesday unanimously decided to jointly oppose the Citizenship (Amendment) Bill.

At a meeting of the parties, it was also decided that a delegation com-prising representatives of all the outfits would meet President Ram Nath Kov-ind and Prime Minister Narendra Modi to apprise them of their opposition to the bill that sought to provide Indian citizenship to those Hindus Sikhs Buddhists, Jains, Parsees and Christians, who fled religious persecution in Bangladesh, Pakistan and Afghanistan and entered India before December 31, 2014, after six years of residence in the country.

Meghalaya Chief Min-ister Conrad K Sangma, on whose initiative the meeting was called, and his Mizoram counterpart Zoramthanga also attended the meeting. The Asom Gana Parishad (AGP), which has pulled out of the Sarbananda Sonow-al-led BJP government in Assam over the issue, was also associated with the convening of the meeting.

The 10 political parties that participated in the meeting from across the north-east were -- the Mizo National Front (MNF), the United Democratic Party (UDP), the AGP, the Naga People's Front (NPF), the Na tional People's Party (NPP), the National Democratic Progressive Party (NDPP), the Hill State People's Democratic Party (HSPDP), the People's Democratic Front (PDF), the Indigenous People's Front of Tripura (IPFT) and the Khnam.

SDF Govt failed Sikkim on LT seats, not Opposition: HSP

Нато Sikkim Party has taken strong exception to Chief Min-ister Pawan Chamling's claims that HSP, its working president Bhaichung Bhutia in particular, along with other political parties and organi-sations have delayed the allocation of reserved seats for the Limboos and Tamangs in the State Legislative Assembly.

HSP spokesperson Biraj Adhikari, in a press

statement issued today, points out that the HSP was barely seven months old whereas the LT seats issue has been pending for 17 years.

...the people want to know what the govt was doing during the last 17 yrs to deliver the LT seat," the HSP press communi-qué enquires while adding, "Instead of blaming other people, he [the Chief Minister] should be saying sorry to the LT community and also live up to his words that he will quit.

The release points out that Mr Chamling has said he would quit politics if he doesn't get the LT seat before 2019 elections. "....so we have been waiting to see if his words were sincere or just a lie as usual," Mr Adhikari adds

"He should now stop the lying, and the blame game, and stop pointing fingers on others for the failure of the government and also, his own failures," the release reiterates.

Barcode stray cows, shelter them in unused govt buildings: UP govt to officials

Lucknow, Jan 29 (PTI): Grappling with the men-ace of stray cattle, the Uttar Pradesh government has told officials to barcode abandoned animals and set up temporary cow shelters at unused government buildings.

The suggestions figure in a government or-der (GO) issued Monday, weeks after the Yogi Adityanath government an-nounced a cess to set up shelters for cattle. Temporary cow shelters can be established at various cooperative institutions (such as mandi parishads and sugar mills) and at institutes of the Central government which have been lying closed, it suggested. The order suggested that stray cattle should be bar-coded and RFID-tagged if possible . RFID involves

using radio frequency identification gy to scan identity tags. The order said fodder banks can also be set up at the temporary shelters. Farmers can deposit crop

waste there.
The 23-page order was issued by the state's animal husbandry department to all senior government officials in Lucknow, district magistrates and district police chiefs. The order comes over three weeks after Uttar Pradesh Chief Minister Yogi Adityanath on January 3 gave district magistrates about a week to ensure stray cattle across the state are shifted to fenced shelters Those directions were issued during a video-conference with the DMs, amid reports that stray cattle were destroying crops.

Gyalshing District hospital two days every fortnight. These achievements are nothing in front of our demands. After such an arduous struggle we ended up getting nothing," the release states.

It may be mentioned that SPYF started the protest against IPHS norms not being followed in Gyalshing District Hospital. They had started their march to Gangtok from Gyalshing in West Sikkim on 20 Jan and reached here on 23 Jan. Since then, members of the Forum had been camped in front of DAC East demanding a meeting with the three signatories of a written assurance given by the Health Department in July last year.

This written assurance had stated that 90% IPHS norms will be implemented at Gyalshing District Hospital within one month and remaining requirements will be taken care of within 03 months. Since the Department failed to fulfil these assurances, we want a meeting with the signatories, SPYF had said.

On 26 Jan, in a bid to intensify its protest, SPYF had invited all organizations and political parties to join their movement and had planned to take out a rally on 28 Jan. However, authorities did not allow the rally following which SPYF members blocked the road in front of the DAC East towards Sichey.

SPYF members refused to budge until the Health Minister and other Health officials arrived for talks. The meeting finally took place at the DAC East office around 11:30 p.m. last night.

"Our struggle will continue. We are preparing

for making it a truly state wide movement with the involvements of people from all the districts of Sikkim. Our demand would be implementation of IPHS norms in all the district hospitals of Sikkim. Our movement will continue until no district hospital in the state remains outside the purview of IPHS," the release mentions.

Swine flu death toll rises to 169; Over 4,500 test positive



DELHI. IAN (PTI): The death toll due to swine flu in the country has soared to 169 this year while 4,571 people have tested positive for the virus, with Rajasthan accounting for over 40 per cent of the cases.

According to data issued by the government, Rajasthan recorded 1.911 cases and 75 deaths till Monday fol-lowed by Gujarat with

600 cases and 24 deaths.

Delhi reported the third highest number with 532 people being infected with the H1N1 virus. No death has been reported due to the flu in the national capital so far.

Punjab has reported 27 deaths and 174 cases, followed by Haryana which recorded eight deaths and 372 cases. Maharashtra has corded 82 cases and 12 deaths till Monday.
With the numbers go-

ing up, the health ministry recently held a meeting with the states and

asked them to strength en their surveillance for early detection. It also asked them to keep beds reserved in hospitals to deal with acute cases.

The official said states have not made any demand yet regarding drugs, diagnostic kits and other wherewithal to deal with the issue.

"There is sufficient stock of swine flu drug Oseltamivir and also there is no scarcity of N95 masks and diagnostic kits. Further, states have been asked to is-sue advisories to people mentioning the dos and don'ts," a senior health ministry official said.

Delhi government also has issued an advi-sory in view of the rising cases of swine flu.

The advisory states that seasonal influenza (H1N1) is a self-limiting viral, air borne disease spread from person-to-person, through large droplets generated by the act of coughing

and sneezing, indirect contact by touching a contaminated object or surface (fomite transmission like telephone, cell phones, computers, door handles, door bells, pens, toys etc) and close contact, including hand shaking,

hugging and kissing.
The dos and don'ts mention covering nose and mouth with disposable tissue or handkerchief while coughing or sneezing, washing hands with soap and water frequently, avoiding crowding places, maintaining isolation, drinking plenty of liquid and consulting doctor.

As per the advisory, one should not touch eves, nose or mouth with unwashed hands or hug, kiss and shake hands while greeting, or spit in public places, dispose of used napkin or tissue paper in open areas or smoke in public places.

Last year, the country

These killings were reported from Jammu and Kashmir, Himachal Pradesh, Utarakhand and Delhi, according to the data provided by Wildlife Crime Control Bureau (WCCB), under the Ministry of Environment and Forests. Noida-based

HC quashes Mizoram govt's prolonged liquor ban order

AIZAWL, JAN 29 (PTI): The Aizawl bench of the Gauhati High Court Tues-day quashed the order of the Mizoram government banning sales of liquor from December 21 to March 1, and instructed it to allow vendors to sell alcohol as per the validity of their licences.

The sitting judge, Jus-tice Michael Zothankhuma, found the orders of the Commissioner of Excise and Narcotics department declaring the "dry days" for an extend-ed period as "arbitrary" and set the order aside.

The judge ordered the state government to allow the owners of the three bonded warehouses to import liquor on the basis of permits and the retail vendors to sell liquor as per the validity of their licences issued under the Mizoram Li-quor (Prohibition and Control) Act. 2014.

The government's contention that the prolonged dry days were de-clared due to observance of the Republic Day on January 26 and 'Chanchar Kut', the most prom-inent traditional festival of the Mizos on March was not accepted by the court saying that the state government could declare dry days on such days in accordance with the Mizoram Liquor (Prohibition and Control) Act, but not for such a long period.

The new Mizo Na-tional Front (MNF) government headed by Chief Minister Zoramthanga, in a meeting of the council of ministers on December 18 last year, had de-clared dry days from De-

cember 21 to January 14.
Another meeting of the council of ministers on January 10 decided to extend the dry days from January 15 till

March 1 this year.

The owners of the bonded warehouses and retail liquor vendors submitted petitions on January 17 challenging the orders of the state government.

m here}$ is politics in the air. If one takes the steady stream of press releases at face value, there are so many people joining so many parties every day that families across the State must be regretting the falling fertility rate. They would have had so many more to give to parties if only their families had not been so small. May be that is also why parties are increasingly counting their new converts by the families and not actual number of new members. That being the new trend, now Sikkimese, like they acquire their religion and relatives through birth, will also be inheriting their political leanings through the same connections. Thankfully, the indoctrination is very casual, and takes but the switching of the flag on the roof to also switch sides and then feature, as a family, in a press release, again. Hmmm... If only things were really that simple. And they also are in a way. After all, who, except the "leaders" out to score political points actually goes through the tedium of officially resigning in Sikkim? And also, if supporters in the bastis don't have a formal process of joining up beyond collecting a flag, how could they know of the official processes of signing out? And so the cycle rolls on, with leaders ignoring the obvious and the coteries playing blind too, and the people, well, playing along.

Jokes apart, if speaking into their echo-chambers and gloating over the repeats keeps them occupied and satisfied, so be it, but that is not all that happens when politics picks up. It will also soon be the season when the very real concern of vicious rumour-mongering and tasteless name-calling will begin. The medium might have grown from the poorly produced pamphlets to poorly written Facebook posts complimented with shoddily photoshopped images carried over from more juvenile days, but the messaging remains as crass. What the agents of such media-management seem to overlook is that rumours serve only one purpose - entertainment. They titillate, scandalise, and then evaporate. In most cases, receivers and circulators of such gossip know that no one believes the rumours and that everyone is partaking in it only get over their boredom or to suppress their insecurities depending on which side of the conversation they sit on. It goes without saying that the best response to the rumour mill is to ignore it, but while it is easy to ignore something when it is only whispered in street corners, it becomes difficult to do so when they are palmed out in the public domain. And that is bound to begin happening on a big scale very soon in Sikkim as parties begin guarding turfs, claiming new ground and remaining relevant.

This will also soon become the season of tall claims and wild allegations. Time to bring out the salt, because we will need to be taking pinches of it very often just to remain sane. At the end of the day, the only weapon against rumours is the truth. Circulate it in the public domain and embarrass those who deal in rumours. Don't do so effectively and don't demand it vociferously enough, and soon the confusion will muddy away realities beyond salvaging. Then, Sikkim could find itself where America still dwells - the land of alternative facts where facts have retreated so deep that it is the truth that people become skeptical about even as they lap up every lie and untruth; a situation where attempts to debunk falsehoods often end up strengthening the lies in the eyes of the people.

Amazon deforestation, already rising, may spike under Bolsonaro

Over the past 25 years that I have been conducting environmental research in the Amazon, I have witnessed the the ongoing destruction of the world's biggest rainforest. Twenty percent of it has

been deforested by now – an area larger than Texas.

I therefore grew hopeful when environmental policies began to take effect at the turn of the millennium, and the rate of deforestation dropped from nearly 11,000 square miles per year to less than 2,000 over the decade following 2004.

But a new political climate in Brazil, which set even before President Jair Bolsonaro took office in January 2019, has led to a recent increase in the pace of rainforest felling. And Bolsonaro, a former army officer, made Amazonian development a core campaign pledge.

DAMMING THE TAPAIÓS

At stake is what becomes of the region around the Tapajós River, one of the Amazon's largest tributaries and home to about 14.000 Munduruku tribal people. The Munduruku have until now successfully slowed down and seemingly halted many efforts to

turn the Tapajós into the "Mississippi of Brazil."

The Tapajós River is the Amazon's last undammed clearwater tributary. The basin that surrounds it is roughly equal to 15 percent of the Brazilian Amazon region and about the size of France. This remote area has a great deal of biodiversity.

and its trees store large quantities of carbon.

Because the Amazon rainforest absorbs a lot of the carbon emitted through the burning of fossil fuels, climate scientists consider its preservation key to preventing an uptick in the pace of global warming.

Brazil is planning to build a series of big new hydroelectric dams and webs of waterways, rail lines, ports and roads that can overcome logistical obstacles standing in the way of exporting com-modities and other goods.

The government did suspend plans to build an

8,000-megawatt dam at the heart of this sprawling project in 2016. At the time, it cited the "unviability of the project given the indigenous component and stated it would stop building big dams in 2018, before Bolsanaro took office.

Yet many observers remain very concerned about how Bolsonaro's presidency will affect the Munduruku and the rainforest they protect. Groups like International Rivers - a nonprofit dedicated to the "protection of rivers and the rights of commu-nities that depend on them" – are not about to de-

SOUTH AMERICAN GAMBIT

Brazil's Amazon development plans are part of a broader gambit that includes all the South American nations. First conceived in 2000, the Initiative for the Integration of the Regional Infrastructure of South America is designed to build a continental economy through new infrastructure that provides electricity for industrialization and facilitates trade and transportation

Known widely by its Spanish and Portuguese abbreviations as IIRSA, this initiative is turning the Amazon, 60 percent of which is located on Brazilian territory, into a source of hydropower and a transportation hub connecting the Atlantic

Brazilian soybeans to global markets, and man-ufacturing will expand, stimulating population growth in the Amazon.

The blueprint for this bid to develop the Amazon,

which also includes portions of Peru, Bolivia and six other countries, calls for building more than 600 dams, 12,400 miles of waterways, about 1.2 million miles of roads, a transcontinental railway and a system of ports, much of it in the tropical wil-

NEW WAVE OF DEVELOPMENT

Bolsonaro has not yet confronted the Munduruku or taken concrete actions to keep his promises about developing the Amazon. But he has taken steps that point in this direction with the officials he has selected for key posts. He has also trans-

fear could have disastrous impacts on the indigenous communities living in the region. The new projects need only to repeat what the earlier projects did. This would bring total deforestation to 40 percent.

Climate scientists such as Carlos Nobre worry that this magnitude of forest loss would push the Amazon to a "tipping point" and undermine the process of rainfall recycling, which replenishes the Amazon's supply of water. The outcome would be a drier climate in the Amazon, which has already begun to experience droughts, and the transformation of the forest into savanna. Indigenous people would suffer, and the Amazon's biodiversity would disappear.

A massive increase in the pace of Amazonian deforestation could bring about climatic changes in both South and North America. Scientists predict that precipitation would decline in many areas

The new Brazilian president's plans for the Amazon come on the heels of decades of deforestation following the construction of roads and hydropower facilities during the 1960s and 1970s. This initial vave of construction opened the sparsely populated region to an influx of newcomers, and contributed to the destruction of about a fifth of the forest over four decades.

Then came a wave of stronger environmental policies – such as the stricter enforcement of log-ging laws, the expansion of protected areas and the voluntary decision by soybean farmers to refrain from clearing the forest – which lowered Brazil's Amazon deforestation rate after 2000. It seemed to me and others that a new era of Amazonian conservation had dawned.

But that was before I understood the full impli cations of the Initiative for the Integration of the Regional Infrastructure of South America.

This plan is far more ambitious than earlier in-

frastructure projects which were completed by the end of the 1970s, and I believe that it could wreak even more destruction.

Should all of its components be built, the new transportation and energy infrastructure would be likely to spark a new wave of deforestation that I

of the Americas, including the southeastern part of South America and the Mississippi River Valley. The whole world would suffer from reduced agricultur-al production in these two regions, which are important global suppliers of agricultural commodities like corn and soybeans.

ATTACKING THE AMAZON

To be sure, some of this construction is already underway in Brazil, particularly for hydropower. So far, 140 dams have either been built or are under construction, notably the Belo Monte Dam on the Xingu River and the Santo Antônio and Jirau dams on the Madeira Rivers. And Bolsonaro's predecessors had downsized some of the Amazon's protected areas to facilitate development.

These protected tracts of land cover 43 percent of the Brazilian Amazon and are essential to maintaining biodiversity and sequestering carbon.

When Bolsonaro addressed world leaders at the World Economic Forum in Davos, Switzerland for the first time, he promised to protect the environment in his country - which he called "a paradise."

I remain skeptical, however, given that he

seems to be staffing his government in preparation for construction projects that could devastate the Amazon, reducing its biodiversity and destroying its ecological and cultural treasures

Why Trump's wall rhetoric is about power rather than policy

The nation whose anthem lauds "the land of the free and the home of the brave" and whose constitution was drafted "in order to form a more The nation whose anthem lauds perfect union ... and secure the bless-ings of liberty" continues to flirt with the prospect of authoritarian rule.

In the aftermath of his decision to temporarily reopen the federal government, President Trump is once again threatening to declare a state of emergency to allow him to spend public money on the construction of a wall on the United States-Mexico bor-der without congressional approval.

The weakened position Trump finds himself in now makes such drastic action unlikely. But one of the lessons to be taken from Trump's presidency is to expect the unexpected.

Should be do so it would not of course be the first time an American president has

asserted this prerogative. CURRENT CRISIS NOT ABOUT

Generally, there can be compelling reasons for declaring a state of emergency, but Trump would have been perhaps the first to invoke this prerogative in order to fulfil a (subtly altered) campaign promise.

While there is a legitimate debate about whether or not there actually is an emergency at the border, the crisis that would be created should

Trump declare an emergency in order to secure public funding for his "big, beautiful wall" would not pri-marily be about policy. It would concern more fundamental matters, such as the efficacy of America's much-vaunted constitutional sys-

tem of checks and balances.
The US constitution established three branches of government: legislative, executive, and judicial. It apportions power to each branch so none can dominate the others. But the American constitution pays rel-atively little attention to the presidency. There are only four short sections concerning the office, only one of which contains much detail about presidential powers.

This means the powers of the president remain under-articulated. The constitution is also silent on how states of emergency should be managed. Taken together, this means it's not entirely clear that legislative and judicial institutions can rein in a president who declares a state of emergency on spurious grounds.

In effect, by declaring a state of emer gency a president assumes additional powers by essentially creating excep-tions to rules and laws that normally constrain them. The courts can and likely would review the legality of any such action. But rulings against presi dents are the exception

BATTLE FOR THE GOP

More prosaically, if the "Trump shutdown" strained relations within

the Republican Party imagine what a "Trump state of national emergency might do. The party's establishment has proved willing to accept various affronts to presidential conventions of conduct.

This includes Trump's propensity to play fast and loose with the truth, his lack of appetite for work and limited grasp of policy detail as well as his inability to serve as a president for all Americans.

But it is clear the partial shut-down has significantly ratcheted up tensions within the party and added to speculation Trump will face a primary challenge some time before the 2020 presidential election.

In that context, it is conceivable that a presidential declaration of a state of emergency for wall funding might at last be the moment when Republicans – or at least enough of them to give Trump pause for thought - act in the long-term interests of the country.

More likely, there will be a point

at which political self-interest trumps Trump. Republicans seeking to hold onto seats in 2020 in districts won by Hilary Clinton in 2016, or in which the Democratic Party was resurgent in last year's midterms, may well peel away from Trump if his already soft approval rating continues to slide. There are already signs that some establishment figures are putting daylight between themselves and the president, and as the Republican convention and the 2020 presidential election move into view, more may choose to follow suit.

ROAD TO TYRANNY

Under these scenarios, Republicans may take a closer interest in restraining Trump than they have done so far. Seriously spooked Republicans may prove more amenable to the notion of impeaching the president. And because a president cannot dissolve Congress, Trump would be unable to get in a preemptive strike should the

House move to impeach him.

None of this may come to pass. Trump may well be on the defensive right now but his chances of being re-elected in 2020 will be seriously (and perhaps fatally) compromised if he backs down on the wall issue again when congressional negotiations on immigration and border security wrap up on February 15. During the two years of his administration he has proved perfectly hap-py to plough on regardless of public or political sentiment for far less significant issues. It is conceivable that he will do so again.

He has also demonstrated that he

chafes against constraints on presi-dential agency, wishes to expand the reach of the executive branch and responds badly to criticism. In short, he is a poor fit for a liberal democracy but potentially a rather good one for an autocracy.

Great chance for mentally toughest Saina to win All England: Vimal

NEW DELHI, JAN (PTI): Saina Nehwal is mentally the toughest shuttler in the country and the ability to over-come injuries is the key to her longevity, believes former coach Vimal Kumar.

Saina, who had suffered a shin injury late last year, won the Indonesia Masters last Sunday after the withdrawal of Carolina Marin from the summit clash due to a

leg injury. Her former coach Vimal has also backed the Indian ace to win the cov-eted All England Championship in March.

"She is definitely mentally the toughest, even I will give her edge over the men's players, she is much tougher than all of them," Vimal, who had coached Sain from 2014 to 2017, told

PTI on Tuesday.

"She doesn't think too much once she is on court, no matter if she has some pain, she will go all out and make it difficult for her oppo-nents," said the former India coach, under whom Saina attained the World No. 1 ranking in 2015.

With Marin suffering a torn anterior cruciate ligament (ACL) -- the lig-ament that stabilizes the knee -- and world no 1 Tai Tzu Ying also recuperating from a wrist injury, Vimal feels Indian duo of Saina and P V Sindhu will have a great chance to end India's wait for an All England title.

"It (Indonesia win) will give Saina a lot of confidence and can help her in All England Championship, she can target that," he said.

"Carolina also might need 5-6 months to re-cover if the injury is serious, so the All England will be wide open. Caroli-na and Tai Tzu Ying were favourites. So now Saina and Sindhu will have big chance to win the title."

Saina, who will turn 29 in March, is currently the oldest player in the top ten and Vimal said it is important for the Indian to train smart to stay at the top of her game.

"She has had her share of injuries. I was there with her at the Olympics, she was preparing well and suddenly it came up. But sub-sequently, the way she came back, have to give her credit.

"Now it is a question of training smart. She has a couple of years at the top and with the Olympics coming up, she would want to do well... I don't want to go that far now but she can immediately think of doing well at the All England."

Saina had aggravated her knee injury at the Rio Olympics and needed surgery and rigorous physiotherapy to return

to the sport.

The London Olympics bronze medallist returned to win the Malaysia Masters in 2017, her last BWF title before she ended the two year wait by clinching the Indonesia Masters last week.

"It is a creditable per-formance from. I saw a few matches, I don't know if she had the stamina to play at a good pace like Tai Tzu Ying and Carolina Marin as she was carrying a bit of injury.

"I don't think she was in right shape but be-cause of mental toughness she pulled through quite a few matches," said Vimal.

Last year, Saina had won her second Com-monwealth Games title, besides winning a bronze at the Asian Games and reaching finals at Indonesia Mas-

Perth on October 24 while the tournament will get underway from October 18 with qualifying rounds in South Geelong, according to the fixtures. India, who lost in the semifinals to eventual winners West Indies in the previous edition in 2016, face a qualifving team in their next Super 12 match in Melbourne on October 29. India won the event's inaugural edition in 2007.

The men's competition, from October 18 to November 15, will feature several qualifying matches before hosts Australia take on world's top-ranked Pakistan in the first match of the tour nament-proper on October 24 under

lights at the Sydney Cricket Ground.

ICC Chief Executive David Richardson said: "Whenever we host an event in Australia we know we can guarantee the one billion cricket fans around the world a great show. "The world's best players. Outstanding venues. Noisy, passionate, knowledge-able fans. Exciting cricket. This is the perfect combination for a T20 World Cup and in 2020 we go one step further with two T20 World Cups in one year.

Defending champions West Indies play their first Super 12 group stage match against New Zealand on October 25 in Melbourne.

Australia, Pakistan, the West Indies, New Zealand and two qualifiers make up Group 1 of the Super 12 stage. India, England, South Africa and Afghanistan and two qualifiers make up the other group. The first semi-final will take place at the SCG on November 11. with Adelaide Oval hosting the second semi-final the following night.

The final will be played at the MCG on November 15. The tournament will be held in eight Australian cities and 13 venues. The 22-year-old Mandhana has been in excellent form in recent times and Tuesday's half century was her eighth in the last 10 ODI innings. She hit 105 in the first match of the ongoing series. On Tuesday, she took just 82 deliveries in her unbeaten knock of 90.

Rai, on the other hand. faced 111 deliveries in her sedate knock 63. But, she was a perfect counterfoil to the aggressive Mandha-na. Raj completed the run chase in style with a six as India reached to 166 for 2 in 35.2 overs.

"I am happy with the way the team is shaping up. I have always enjoyed batting in challenging conditions. It wasn't easy, it required patience here. Smriti is in good form and somebody had to give her support," Raj said. India have now taken an unassailable 2-0 lead in the three-match contest, which is part of the ICC Women's Championship series. The visiting side beat New Zealand in the

Raag Darbari is not about a political party, but entire state structure: Dastango Mahmood Farooqui

New Delhi, Jan 29 (PTI): Wheth er it was through the inimitable village patriarch Vaidya ji, or his disillusioned nephew Ranganath, the 1968 novel "Raag Dar-bari" raised serious concerns over the country's socio-political environment at the time

But, the reason why Shrilal Shukla's late 60s work continues to be relevant even after half a century is because it was never a comment on a single political party but one on the entire state structure, feels dastango Mahmood Faroogui.

Farooqui, who has adapt-ed the satire for 'dastangoi' -- a 16th-century Urdu art of storytelling, told PTI that the reality of how the system works, painted by Shukla in his quintessential deadpan humour, has hardly changed over the years. "The

ruling class -- people from politics, corporate, media, and intellectuals, don't change. They are not affected by who is in power. "The book is not about one political party but the entire state structure. The interaction between state and society that was then, hasn't changed much even today," the 40-year old performer-director said.

Farooqui, along with journalist and dastango Darain Sha-hidi, presented a contemporary adaptation of "Raag Darbari" here recently.

The dastango duo added

a contemporary touch to the famed novel by including satir-ical poems by famous writers and poets including Baba Nagarjun and Kedarnath Singh.

Talking about the process be-

hind transforming this novel of over 300 pages into a 120-min-ute dastan, Farooqui said that it

was always a "challenging task" as novels were meant to be enjoved alone and a dastan has to be told in a gathering.

"It is next to impossible to

read a novel and hold the crowd at the same time. To tell it in the form of a dastan, you have to

make changes to it.

"And it needs to be done in a way that those who have read the novel return with something new, and those who haven't, know the essence of the story," he said. In its dastan form, the novel took sha of a 45 page script over a period of five months.

The storytelling art, which "disappeared" after the death of dastango Mir Bagar Ali in 1928, was revived by Farooqui in 2005, thanks to the extensive work done by his uncle and poet

Shamsur Rahman Faruqi.
While in the last 14 years

dastangoi has become an essential part of cultural events like Jashn-e-Rekhta, Farooqui believes now is the time to put 'checks and standards" to maintain the quality of the art.
"I am happy that this art has

revived in India and reached Pakistan, Canada among other places. But the problem that we face now is since there are no masters of this art, every person sitting on the stage considers themselves to be a master.

"It is both a good and bad thing. Good as it encourages and interests more people to learn it, bad as there are no checks and standards," he said.

He added the onus for taking the art forward also lay on the audience who should screen every performance that they watch and "not accept anything in the name of dastangoi."

Stories of those who have witnessed hor-ror in unimaginable ways and have triumphed, help in building across borders and generations, confidence and solidarity for the cherished values of pluralism and peaceful co-existence." he added.

During the panel dis-cussion, Robbins spoke about minorities' contribution to Indian society, and India's history of religious tolerance.

He also outlined the movement of Jews to India during different periods of history.

KABUL, JAN 29 (AP): Negotiators for the United States and the Taliban insurgents have reached "agreements in principle" on key issues for a peace deal that would end 17 years of war in Afghanistan, the top US envoy has said.

The statement by US envoy Zalmay Khalilzad followed six days of talks last week with the Tal-iban in Qatar, where he urged the insurgents to enter into direct negotiations with the government of Afghan President Ashraf Ghani. Ghani on Monday as

sured Afghans that their rights will not be com-promised in the name of peace with the Taliban who have been staging near-daily attacks against Afghan forces, causing scores of casualties every week. Their offensive has not let up despite the se-vere Afghan winter and the insurgents now hold sway over nearly half of

the country.

Khalilzad said in an interview with The New York Times that an agreement in principle was reached with the Taliban on the framework of a peace deal "which still has to be fleshed out" that will see the insurgents commit to guaranteeing that Afghan territory is not used as a "platform for international terror

ist groups or individuals." He said the deal could lead to a full pullout of US troops in return for

a cease-fire and Taliban talks with the Afghan government.

In his statement re-leased by the US Embassy, Khalilzad said, "We made progress on vital issues in our dis-cussions and agreed to agreements in principle on a couple of very important issues."

"There is a lot more work to be done before we can say we have succeeded in our efforts but I believe for the first time I can say that we have significant progress," he said.

Acting Defense Sec-retary Patrick Shanahan said he has been briefed on the talks and described them as encour aging, but he also told reporters that the de-partment has not been directed to prepare for a full withdrawal from Afghanistan.

Speaking before a meeting at the Pentagon with Shanahan, NATO Secretary General Jens Stoltenberg said any dis-cussion about the with-drawal of NATO forces from Afghanistan would be premature. He said Khalilzad had briefed NATO allies on the talks weeks ago.

"We are in Afghani-

tions for a peaceful nego-tiated solution," Stoltenberg said.

'We will not stav longer than necessary, but we will not leave before we have a situation that enables us to leave or reduce the number of troops without jeopardizing the main goal of our presence and that is to prevent Afghanistan from becoming a safe haven for international terrorists once again."

He added that he

believes it's too soon to speculate on withdrawal because "what we have to do now is to support the efforts to try to find a peaceful solution. We strongly support those efforts." Ghani sought to assure Afghans that no deals would be made without Kabul's awareness and full participation "Our commitment is to provide peace and to prevent any possible disaster" Ghani said in an address to the nation. "There are values that are not disputable, such as national unity, national sovereignty and territorial integrity." Ghani's office said he and Khalilzad met late Sunday in Kabul to discuss details from the talks.

Khalilzad's statement emphasised the inclusion of the Afghan govern-


