Industries Secy's comments on Companies Act, his personal opinion: Deptt **SUMMIT REPORT** GANGTOK, 16 FEB:

Comments made by the Principal Secretary, Commerce & Industries Department, Thomas Chandy, which alluded that the Registration of Companies Act [Sikkim], 1961, was redundant and obsolete, were his personal opinions and not that of the State Government.

The comment was reportedly made by the Principal Secretary while addressing a seminar organised by the Confederation of Indian Industry, "Infra Dialogue @Sikkim - Opportunities and Challenges and Way Forward."

His observation, after it was reported in a national daily, had drawn flak from the organisation, Save Sikkimese Soul, which had condemned the officer's dismissing of an Old Law so casually.

In a statement issued today, the Commerce & Industries Department explains that at the seminar "opionions were expressed in view of the strong regulatory framework that exists in the Companies Act 2013 which may be necessary in modern business.

Centre asks states to ensure security of students, residents belonging to JK New Delhi, Feb 16 (PTI):

The Centre Saturday asked all states to ensure safety and security of the students and people from Jammu and Kashmir living in their areas in the wake of threats to them in some parts of the country, officials said.

The advisory came hours after Home Minister Rajnath Singh assured an all party meeting of doing the needful for the protection of the Kashmiri students and people who were allegedly threatened after the terrorist attack in Pulwama in which 40 CRPF jawans were killed.

A Home Ministry official said there have been some reports of students and other residents of Jammu and Kashmir experiencing threats and intimidation. "Therefore, the Home Ministry today issued an advisory to all states/UTs to take necessary measures to ensure their safety and security, the official said.

Some Kashmiri youths studying in the Uttarakhand capital, Dehradun, have alleged that they were harassed and have been asked by their landlords to vacate accommodations fearing attacks on their properties in the aftermath of the attack.

Unemployed agri and horti graduates rally demanding abidance of service rules

SAGAR CHHETRI GANGTOK, 16 FEB:

Cikkim Unemployed **S**Agriculture and Horticulture Graduates Association [SUAHGA] took out a rally today to press for its eight-point charter of demands.

The association's main demand is that the Sikkim State Agriculture Service Rule 1994 and Sikkim State Subordinate Service Rule 2001 be followed strictly.

Before the rally, representatives of the association also submitted a memorandum enumerating their demands to the Secretary of the department here at Krishi Bhawan.

The rally started from Krishi Bhawan with banners and placards on demands of the association and followed the route from Krishi Bhawan to Indira Bye-Pass, Bye-Pass Road and ended at the District Administra-



tion Centre, East. After the rally, members of the association sat on dharna at in front of the DAC gate.

The association has demanded immediate filling up of more than 151 posts of Agriculture and Horticulture Inspectors through direct recruitment and also the filling up of more than 40 posts of Agriculture Development Horticulture Development

velopment Officers through direct recruitment.

The association has demanded that a notification on these two demands be taken out within three days.

lished, and an immediate

The association has also demanded for an amendment of Sikkim State Subordinate Agriculture Service Rule 2001.

While mentioning that according to a notification of ICAR dated 06 October 2016 clarifies that BSc agriculture and horticulture were professional courses which means that agriculture and horticulture graduates were at par with medical and engineering graduates, the association has demanded for the same weightage be given to agriculture and horticulture graduates like medical and engineering graduates.

Group C&D employees thank govt, reiterate grievances over pay revision

The All Sikkim Govern-

■ ment Employees Association [ASGEA] Group C & D has expressed gratitude towards the State Government and Chief Minister Pawan Chamling for "always working in the interest of the government employees". The association has expressed its gratitude to the CM for the prompt action in the approval and sanctioning of the Pay Committee Report and resolution on pay revision and for declaring second Saturdays as holidays again. The Association has also reiterated some of its pending grievances.

Addressing a press conference here today, ASGEA general secretary, Rapden Bhutia, thanked the State Government and the CM for taking prompt action in the in-



terest of the government employees and thanked the CM for the promotion of government employees at all levels, regularizations, for launching humanitarian scheme of One Family One Job and declaring four new government holidays respecting the beliefs and sentiments of the people.

also placed grievances of the government employees and stated that these are not new demands but had already been apprised to the CM verbally and in written.

It is informed that as per the Fifth Pay Commission, the House Rent Allowance has been kept at rationalised rate of 12% within the state and Sikkim Border Compensatory Allowance at 8%.

On the same, the association has requested the government to keep HRA at 15% within the State and SBCA at 10% as earlier.

He urged that HRA and SBCA not be reduced if it cannot be enhanced. Mr Bhutia mentioned that the grade-pay in different departments of C&D employees below UDC have not been redressed and appealed the government to re-

view these differences.

He added that while regularising services of adhoc and MR employees, the government has regularised them as Junior LDCs, Junior Drivers and others on lower pay scale and grade pay. On the same, he requested that the post these junior posts be abolished.

Mr Bhutia mentioned that the CM had given a verbal assurance and announced that a sub-committee would be instituted to resolve these grievances but no follow-up action has been taken so far. He also urged the CM for the personal intervention for the early fulfillment of these demands.

Hina Jaiswal is IAF's first woman flight engineer

BENGALURU, FEB 16 (PTI): squadron, before being Breaking the glass ceiling, Flight Lieutenant Hina Jaiswal has scripted history by becoming the first woman flight engineer to be inducted into the Indian Air Force.

She was commissioned on January 5, 2015, in the engineering branch of the IAF and had served as the chief of firing team and battery commander in a frontline surface to Air Missile

selected for the Flight Engineers Course. During the grueling training, she trained shoulder to shoulder with her male counterparts, and displayed unflinching commitment, Till last year, the Flight dedication and perseverance, the release said.

The only daughter of DK Jaiswal and Anita, Hina described her achievement as a "dream come true." "Finally, her dreams have manifested into reality after successfully graduating from the alma mater of Heli-lift," the release said.

"As a Flight Engineer, she would subsequently be posted to operational helicopter units of the IAF. Hina Jaiswal would be routinely called upon to operate in demanding and stressful conditions, right from the icy heights of the Siachen Glacier to the seas of the Andamans," it said.

Curfew continues in presence stepped up

JAMMU, FEB 16 (PTI): The curfew in Jammu city continued for the second day and the Army's presence was stepped up on Saturday, a day after violent protests rocked the city over a suicide attack that killed 40 CRPF jawans in Kashmir.

Nine more Army columns were deployed in the city, bringing the total to 18 columns, and the force staged flag marches in sensitive localities. Officials said the University of Jammu postponed all examinations scheduled for the day and mobile Internet services remained suspended across Jammu region.

Srinagar-bound vehicles stranded on the Jammu-Srinagar national highway due to a landslide in Ramban were allowed to move

forward amid tight security ar-

rangements, they said. "The curfew is being implement-

ed strictly and there is no report of any untoward incident from any-

where," Deputy Inspector General of Police, Jammu-Samba-Kathua range, Vivek Gupta told PTI.

Deputy Commissioner (Jammu) Ramesh Kumar said authorities

were monitoring the situation and a decision to relax the curfew, which was imposed Friday, would be taken later in the day.

The Army was conducting flag marches in sensitive localities of the city on Saturday, the officials said.

A defence spokesperson said the Army on Saturday deployed nine more security columns with air support to help

the administration to maintain law and order in the entire city. Nine Internal Security Columns (ISCs) of the Army were deployed on Friday. "Helicopters and UAVs of

the Army also put into operation to monitor the situation. The proactive approach jointly taken by J&K Police, Civil administration (Divisional Commissioner and District Collector's office) and Indian Army has ensured the situation in control," the spokesman said.

The city was rocked by anti-Pakistan protests during a general strike called by the Jammu Chamber of Commerce and Industries (JCCI).

People took to the streets to denounce the attack and also held candlelight rallies to pay homage to the jawans. Nine people, including some policemen, were injured in stone-pelting incidents on Friday and several vehicles were torched.

representative of the association, Bikash Subba, stated that agriculture and horticulture graduates were compelled to take out a rally to protest the continuing violation of service rules and the dismissive attitude of departmental officials towards agriculture and horticulture graduates.

He stressed that the association has not been asking for jobs and has only been demanding that service rules be followed strictly and required posts be created for agriculture and horticulture graduates.

He added that these initiatives of the association would secure the future of their juniors as well who are pursuing degrees in agriculture and horticulture.

Mr Subba mentioned that the association will continue with its efforts until the more than 800 agriculture and horticulture graduates received justice. He stated that this has been a 23-year-long struggle for their fundamental rights and added that vacancies in agriculture and horticulture departments are required by rules to be filled on 50-50 ratio - 50% by promotion and 50% by direct recruitment as per the Sikkim State Agriculture Service Rule 1994 and Sikkim State Subordinate Service Rule 2001 but the concerned department has always violated these rules and ignored direct recruitments all these years.

Mr Subba stated that the association has raised these issues repeatedly with the department and received several assurances but not delivery.

He mentioned that in the latest instance, the department again violated the service rule with the promotion of 57 inspectors to ADO, HDO and WDO and promotion of 77 VLWs to agriculture and horticulture inspectors without any matching direct recruitments.

He added that due to these reasons BSc, MSc and PhD holders in agriculture and horticulture have not been receiving the opportunity to even apply for government jobs they were qualified for and entitled to which is letting their technical knowledge go to waste when it should be used in the service of the State.

The JCCI termed the violence "unfortunate" and said, "We shall not allow miscreants to disturb the brother-hood and peace in Jammu where all the religions have coexisted." It said the bandh would not be extended.

Spokesperson of the Jammu university Vinay Thusoo said that all examinations, theory and practical, to be conducted on Saturday were postponed due to unavoidable circumstances.

EU urges Lanka to replace anti-terror law in compliance with global norms

COLOMBO, FEB 16 (PTI):
The EU has urged Sri
Lanka to repeal its controversial anti-terror law
and replace with a new
one in compliance with
the international norms.

Sri Lanka's human rights record, particularly over the impunity enjoyed by law enforcement officers, has been the subject of international condemnation.

The country has been grappling with a new counter-terrorism law in view of the criticism on the Prevention of Terrorist Act (PTA) of 1979. This was enacted at the beginning of the Tamil separatist war in the north and east regions.

Sri Lanka was urged by the European Union (EU) to repeal the current anti-terror law and replace it with a new counter-terrorism law in keeping with the international standards, according to a statement issued at the end of the 22nd session of the EU-Sri Lanka Joint Commission in Brussels on February 14.

The EU welcomed Sri Lanka's steps taken to implement the UN Human Rights Council resolution of October 2015 and setting up of the Office on Missing Persons (OMP) and passing of laws to set up the Office for Reparations.

The country's human

human rights record due to the PTA was under international focus which led to three UN rights body resolutions calling for accountability for alleged human rights abuses blamed both on the Tamil separatist group and and

the security forces.

The rights groups have long demanded for repealing of PTA as it gave troops sweeping powers to arrest and detain suspects indefinitely.

Currently, a parliamentary oversight committee is examining the proposed counter-terrorism act, the committee chief and parliamentarian Mayantha Dissanayake said.

The EU also ex-

pressed concern after Sri Lanka resumed death penalty. It has reminded Sri Lanka that its commitment to 27 conventions on human and labour rights, environment and good governance are conditions to qualify for the EU's GSP+ preferen-

tial trade scheme.

Sri Lanka had benefited by 2.2 billion euros worth of exports to the EU between June 2017 and May 2018 since the facility was restored to Sri Lanka after its suspension in 2010.

Sri Lanka's department of prisons on Monday said that applications have been sought to recruit two hangmen, days after President Maithripala Sirisena vowed to end a 42-year moratorium on death penalty within two months. Sri Lanka has not executed a death row convict since June 1976.

The Liberation Tigers of Tamil Eelam (LTTE) had launched a military campaign for a separate Tamil homeland in the northern and eastern provinces of the island nation for nearly 30 years before its collapse in 2009 after the Sri Lankan Army killed its supreme leader Velupillai Prabhakaran.

The UN Human Rights Council has called for an international probe into the alleged war crimes during the military conflict with the LTTE.

India-Singapore to sign pact for skilling Indians in aviation

SINGAPORE, FEB 16 (PTI): India and Singapore will sign an agreement for skilling Indian youths in the aviation sector at the Aero India Show next week. Academies will be set up in Bengaluru and other places in India that will act as regional hubs for the training of Indian youths for domestic and overseas jobs in these sectors.

National Skill Development Corporation of India's (NSDC) Aerospace and Aviation Sector Skill Council in collaboration with Singapore Polytechnic and a Singapore-based private sector firm will signing a Memorandum of Understanding (MoU) on February 22 to establish skill development centers.

Aero India show 2019 will be held in Bengaluru from February 20-24. It will provide a significant platform in bolstering business opportunities in International aviation sector. These 'Centers of Excellence in Advance Skilling' will provide training and certification drawing from Singapore curriculum and standards in sectors such as aerospace and aviation, emerging technologies, automotive and logistics.

"These are all priority sectors under 'Skill India' and 'Make in India' programmes, which require large workforce with advanced technical skills," India's High Commissioner in Singapore Jawed Ashraf said here on Friday.

He said that these sectors also provide more productive and remunerative employment opportunities.

Singapore is a leader in aviation services including maintenance, repair, overhaul services as well as skill development across various sectors, Ashraf said.

This is one of the many collaborations between India and Singapore in the crucial skill development sector following the signing of two MoUs between NSDC and Singapore Polytechnic to establish state-of-theart Trainer and Assessor Academies across India.

"Skills development is one of the new areas that have gained prominence in the bilateral engagement with many countries, but especially with Singapore, not only at central but also at state level," the envoy said.

There are several institutional engagements including plans for setting up the first Indian Institute of Skills in Mumbai in collaboration with Singapore's Institute of Technical Education Services (ITEES); training programmes for state government officials in public administration and governance; urban planning, logistics and infrastructure development in collaboration with many Singapore-based institutions, including Institute of Technical Education, Singapore Cooperation Enterprise and Civil Service College.

Singapore has also opened three internationally acclaimed Skill Centers in India (New Delhi, Udaipur and Guwahati) and more coming up, Ashraf said.

The World Class Skill Centre (WCSC) in New Delhi has seen hundreds of students clearing the courses in the areas of Hospitality and Retail Sectors with 100 per cent employment rate. There are plans to move WCSC to a new site and further expand it, he said.

Madhya Pradesh Jharkhand, Assam and Odisha are also working with ITEES and Polytechnics in Singapore to develop skill centres. Odisha conducted training of 100 officials from ITI in Singapore last year.

Monsoon Ready?

Who are we kidding?

The thunder-squall which ripped through the region on Saturday should get everyone wondering about what awaits the State once the nor'westers open up in earnest in a few weeks time and what confusion will prevail should monsoons arrive in time three months later and stay a proper season. To begin with, the stability of the hills here has never been very reassuring and they were noticeably weakened by the 18 September 2011 earthquake (yes, that temblor continues to have an effect) and other infrastructure like power and water supply have been severely compromised by absent professionalism and ubiquitous corruption. So yes, Sikkim better start getting worried about the monsoons adequately in advance, because compounding the teetering infrastructure is obvious disinterest and lack of communication in the administration.

The thunderstorm, although it was dramatic over some parts and only threatening elsewhere, was not rare for this time of the year. Most residents could even predict how long the downpour would last and which sections of their water lines might get disrupted by the inundation. And yet, wide parts of Gangtok lost electricity supply due to, one is told, damage at a sub-station. If an evening of thunder and lightning can snap power lines to any part of Gangtok, what more sustained rains could wreck is anybody's guess. And that is the worrying part - no one in any office of consequence is making any intelligent guesses or investing either funds or thoughts on disaster preparedness. While one cannot throw blame for an act of nature as temperamental as lightning, one cannot dodge accountability for a failure to prepare. Mechanical breakdowns, one can understand, but delayed repairs due to unpreparedness is just plain dereliction. If repairs were held up due to lack of spares and equipment, the concerned agencies need to go over their preparedness plans before the weather turns truly hostile. There should be some basic back-up options which anyone with even a passing interest in the needs of professional service delivery can draw up and submit. Get this done.

What was also worrying was the rather disinterested follow-up and lack of effort at streamlining communication that the last power outage revealed. No one is ever available to clearly explain to the people exactly what was wrong, why repairs were taking so long, who was responsible for what and what was being done where. Everyone claimed to be working on a "war footing" but how can that be accepted at face value when information was neither being volunteered or provided clearly even when approached. The officials should understand that the people can handle bad news, they understand that even the best laid out plans can go wrong, but if there is no news, then they speculate and with speculation are born resentment and doubt. Why would they want to sow that? The district authorities should resuscitate the civil defence teams, open proper WhatsApp (since everyone seems to be there) groups to share updates, clarifications and suggestions. Don't do so, and the people will continue sniggering at your lack of professionalism and whispering about how corruption has ruined everything. Don't forget, it was not even a year ago that the CM, giving the power transmission network as an example, had hinted that there was a lot that slipped between what the Cabinet sanctioned for new transformers and what was eventually installed. And that will be the dominant belief until people are brought into the loop and kept informed and updated.

Now for the roads, the National Highway, inexplicably, continues to remain a work-in-progress, scratched and cracked by a combination of widening and repair efforts. The rest of the State has a series of rural roads under various stages of construction and remain risky ventures to drive on. While it was always advisable for the concerned agencies to reinforce the roads during the dry winter months in preparation for the onslaught of the rains, that lesson is conveniently forgotten every winter. When one travels, the highways resemble excavations, when they should have been receiving fortification instead by now. We hear excuses, we hear allegations, but what we don't see is a confidence-inspiring work on the roads.

India: how #MeToo is battling gender-based violence

The #MeToo movement swept India last year **▲** when the Bollywood actress Tanushree Dutta accused actor and filmmaker Nana Patekar of sexually harassing her in 2008 on the set for the film Horn OK Pleassss. In October last year, she also filed a First Information Report (FIR) against him and others with police. It has been reported that Patekar has denied the allegations and issued a legal notice to her to withdraw the allegations. Dutta was also in the news more recently, putting a "curse" on film choreographer Ganesh Acharya, actor Rakhi Sawant and producer Sami Siddiqui for what she suggested was enabling the alleged abuse.

These allegations made by such a well-known figure changed the course of the #MeToo movement in India and opened the floodgates for many other women working in Bollywood, the media, corporations and government to allege sexual harassment by high-profile and powerful men. Social media platforms were flooded with #MeToo stories and outrage, highlighting what has always been a taboo subject in India: the extent of harassment and violence against women, along with the deep-rooted injustice and inequality they face.

The #MeToo campaign has provided a gateway for Indian women to vocalise the "enough is enough" message and seek justice. Some have referred to it as revolutionary. Sadly, the reality is that the majority of women who have encountered harassment will not – or cannot – come forward and voice their stories of victimisation.

The deluge of allegations should not come as a surprise. The wholly patriarchal nature of Indian society has normalised all forms of gender-based violence and inhibited womens' access to justice. It is widely seen as inevitable that being female in India equates to being a recipient of injustice, inequality and all its various manifestations, including harassment. Sexual harassment towards women in India, often referred to as "eve-teasing", is seen as an endemic and persistent condition, a fact of life.

Of course, this is a global issue. Globally, women are expected to "prove" that they have been victimised and that they are speaking the truth. Globally, women have long been the silent victims of violence. Globally, the #MeToo movement has highlighted the scale and prevalence of sexual harassment. Globally, the #MeToo movement signals outrage that women have been persistently silent for fear of the consequences of speaking out and victim shaming.

But will #MeToo be the means for truly tackling gender-based violence in India?

#METOO IN 2019

The impact of #MeToo in India has been immediate. But for many the journey to justice from filing a complaint with the police to prosecution is an

arduous and time-consuming one. Due process in India is laborious and bureaucratic. Far more effective implementation of the laws is needed from all stakeholders. The laws are there, but the effective implementation and practice of them is cumbersome and restrained by cultural and bureaucratic pressures.

also be acknowledged that women are not a homogeneous group. They have a multitude of identities determined by values, faith, economic position, culture, caste, understandings and embodiments of the patriarchy, familial control, justice, equality, sexism and misogyny. Any dialogue must also in-



The #MeToo movement is growing and men are joining the debate. The movement has raised awareness of everyone's responsibility to be duly diligent about their behaviour and actions. That high-profile and powerful men have been accused demonstrates that no one is immune. There is recognition among men that there are repercussions for their inappropriate and violent behaviour towards women. Women will no longer stay quiet or shamed.

But it is important to acknowledge that there is a distinct class narrative to the #MeToo movement in India. It is elite, upper class, empowered and financially independent women who are coming forward. For lower class, rural, uneducated and disempowered women, the #MeToo movement provides little safeguard from the daily abuse and harassment.

All women deserve equal access to justice and safety, but this is less likely for socially and economically marginalised women. The statistics on rape and child abuse in India are horrific, with a one child being sexually abused every 15 minutes and four cases of rape every hour.

A MOVEMENT FOR ALL

For the #MeToo movement to have greater impact and be truly revolutionary, it needs to reach each and every community across India. It must clude men as vital contributors to the movement and advocates for ending gender-based violence.

The mission to combat and end gender-based violence requires men and women to work together, to find a platform for unity and to celebrate gender equality as something that benefits all. Ending gender-based violence cannot be accomplished without men being part of the endeavour - and the demonisation of men via campaigns such as #Me-Too does nothing to progress the mission.

The #MeToo movement is yet another catalyst to tackle the gender-based violence that permeates Indian society – at all levels, in all communities and across all institutions. This is a mammoth endeavour, but one that can be achieved. Dynamic, forward-thinking, gender-inclusive initiatives and projects focused on driving gender equality are needed.

It will require grassroots activism, persistence and holistic partnerships, along with a strong political will and the endorsement at both central and state level. A zero-tolerance approach is needed. There is great work being undertaken to tackle gender-based violence by a diverse range of organisations, including the police, but much more is needed if a true revolution in to become a reality.

The Catholic Church is headed for another sex abuse scandal as #NunsToo speak up

A21-24 February, when senior church clerics across the world meet to discuss how to handle the widening sexual abuse crisis in the Catholic Church. Until recently, this has been focused on the abuse of children. But now Pope Francis has admitted – for the first time – sexual abuse by priests against religious women exists and must be acknowledged.

And Catholic women are speaking

out, under the #NunsToo hashtag. Twenty-five years ago, Irish nun, Maura O'Donohue prepared an extensive report for the Vatican on the abuse of nuns internationally by priests. Her report was based on information supplied by priests, doctors and others, and she had been assured records existed for several of the incidents. But the report was covered up.

In late November, influenced by the success of the #MeToo movement, a group of women theologians convened a meeting - called Voices of Change – in Rome to share their stories of sexual harassment and abuse at the hands of male clerics, and decry the patriarchy of the Catholic hierarchy.

Doris Wagner, a German theologian, recalled her terror as a young woman in a mixed-gender religious order. A superior of the order entered her room one night and raped her. She knew if she were to report this, she would be told it was her fault, so she kept quiet. Years later, she did tell her superior, who did exactly as she feared - she blamed her, and asked if she had used contraceptives.

Wagner said she was later groomed by priest Hermann Geissler. He worked in the Congregation for the Doctrine of Faith, the Vatican organisation that deals with complaints of child sexual abuse. This led to a sesional, which she reported.

He was publicly outed and resigned only after Wagner disclosed the story at the meeting in Rome last year. It is clear the sexual abuse of dal, the maintenance of the reputaadults has been normalised in Catholic clerical culture. Abuse is exercised at every level of ministry, from parish priest to the most senior clerics. Perpetrators are protected and victims silenced. This is aided by a culture of clerical entitlement and opportunity.

There are also cases of high-level clerical sexual abusers, including serial offender US Cardinal Theodore Mc-Carrick, who is now being defrocked, and Argentian bishop Gustavo Zanchetta, who has been accused of sexual misconduct with young seminarians. Pope Francis' response was to remove Zanchetta from Argentina and promote him to a position of power in the Vatican's finance office.

Francis has not adequately handled a number of crises. This includes last year, when he defended a Chilean bishop who had covered up cases of child sexual abuse. As US feminist theologian Mary Hunt says, "you can't make this stuff up".

Little information has been provided about the agenda for the upcoming, so-called "protection of minors in the Church" meeting in late February. But it's clear there will be no survivors, lay women or men in attendance - just the bishops, senior Vatican officials and Pope Francis.

This is the cohort who has protected priest perpetrators, covered up hundreds of cases, failed to report criminal activity to the police, blamed victims and promoted the guilty to positions of power. It is clear the answers to this catastrophic problem will not come from Church leaders. Instead, it is victims, survivors, lay people and experts in institutional change that need to be leading the dialogue, and enacting change. And one such group may be the Voices of Faith.

Dancing Fishermen in Inle Lake

We were still having breakfast when our contact arrived at the hotel. He was the guy who had approached us about the boat tour the previous morning when we arrived in Nyaung Shwe. We had taken the overnight bus from Bagan to this town that gives access to Inle lake and were eager to explore but the continuous journey had taken its toll as we woke up late and

from the very start. The motor power canoe zoomed past wild ducks and white birds enjoying their morning flight. Against the backdrop of Shan mountains and a lovely blue sky, the morning sun made way for glittering diamonds in the clear water of the lake. For a while we remained quiet -each of us trying to soak in the moment and running short of words to describe all that we saw and



had to postpone our boat ride for the next day. There were tons of other tour operators including the one at the hotel but we had given him our word and he was only happy to arrange our boat tour.

So, when we were done with our food, we stepped out and followed him to the dock where a host of canoes were busy taking tourists around Inle lake. He took us to one of the boats that was operated by his nephew and told him to take us around. As we sat, they handed us a blanket because apparently it gets windy and tourists get cranky.

We were soon off in this fresh water lake that proved to be a wonderful treat

felt, till we saw silhouettes of fishermen in the distance.

One of the main attractions of Inle lake are these Intha fishermen who have this peculiar way of rowing their boat. They usually stand on one leg in their boats as they wrap the second leg around the oar and move about the lake. Their hands are free so they can use their basket shaped fishing nets that they use to trap the fishes and use a spear to catch fish. Since the lake is not very deep and their nets are often taller than them, it seems like a technique that they have mastered over the years but it still requires some advanced dexterity.

Interestingly, they know that tourists

come to see their one-of-a-kind fishing style as they strike different poses for our cameras when we approach their boats. Attired in traditional gear, these acrobatic fishermen are fun to watch and photograph, and one shot is not enough. I myself took about fifty shots I realized as I look back at the pictures I took, and each shot is equally interesting. And for these

shots, we tipped them which was fine I thought but some tourists don't seem to like this as they complained how they have commercialized this activity and that the Intha fishermen don't fish this way anymore.

But the tourists are often too presumptuous I feel. On the way back, we actually saw Intha fishermen leg rowing their boats as they went fishing in the lake.

The lake is a world of its own with the many stops at the silver workshop, lotus weaving, floating pagodas, restaurants, floating gardens and one stop where the Kayan women known to wear


neck rings just sat waiting for tourists to come and see them.

While it is very fascinating, this was a little uncomfortable for me than the fishermen in the lake. Of the three three women we met, one was older and looked like she had been wearing the neck rings for a long while but the younger one said she had worn for the last five years. So, we lingered around at the workshop behind where they were making umbrellas and finally got some courage to speak and take a photograph





Though we had hoped only to find the dancing fishermen, Inle lake proved to be a world of possibilities and I am appreciative of all the villagers and children who opened our eyes to their lives on the lake.

Trump confident about his second summit with Kim, says it will be "very successful one" LALIT K JHA

WASHINGTON, FEB 16 (PTI): Exuding confidence ahead of his high-profile meeting with Kim Jong-un later this month, US President Donald Trump has said the second summit will be a "very successful one" as he has established a "very good" relationship with the North Korean leader.

President Trump and Chairman Kim are scheduled to meet in Hanoi, Vietnam on February 27 and 28.

The two leaders had met on June 12 last year in Singapore for the first summit. Trump described his first-ever historic meeting with Kim as "really fantastic" and said they had agreed to sign an unspecified document after their "very positive" summit, aimed at normalising ties and complete denuclearisation of the Korean peninsula.

"I hope we have the same good luck as we had in the first summit. A lot was done in the first summit. No more rockets going up. No more missiles going up. No more testing of nuclear (weapons). Got back our remains, the remains of our great heroes from the Korean War. We got back our hostages," Trump told reporters at the White House on Friday. "We hope we are going to be very much equally as successful. I'm in no rush for speed. We just don't want testing," he said.

Noting that the sanctions against North Koreans remain in place, Trump said both China and Russia were helping the US and he was also working closely with South Korea and Japan.

But China. Russia. on the border, have really been at least partially living up to what they're supposed to be doing," he said.

"So we will have a meeting on the 27th and 28th of February, and I think that will be a very successful one. I look forward to seeing Chairman Kim. We have also established a very good relationship, which has never happened between him or his family and the United States. They have really taken advantage of the United States. Billions of dollars has been paid to them. And we won't let that happen," said the US President.

Trump said North Korea had tremendous potential as an economic force. "Their location between South Korea and then Russia and China right smack in the middle - is phenomenal. We think that they have a great chance for tremendous economic prosperity in the future. So I look forward to seeing Chairman Kim in Vietnam," he said.

"A lot has been accomplished. We're dealing with them, we're talking to them," he said.

The US president had said after the first summit that he believed he and Kim will "solve a big problem, a big dilemma" and that by working together, "we will get it taken care of".

Ronaldo on target as Juventus cruise before Atletico showdown

MILAN, FEB 16 (AFP): Cristiano Ronaldo set up Paulo Dybala to score early and added one himself with defender Leonardo Bonucci also on target as Juventus surged 14 points clear in Serie A with a 3-0 win over lowly Frosinone.

Coach Massimiliano Allegri was taking no chances, even against a side sitting second bottom of the table, ahead of next week's Champions League last 16, first-leg tie at Atletico Madrid.

Dybala returned to the front line alongside Ronaldo and Mario Mandzukic with key defenders Bonnucci and Giorgio Chiellini both back from injury.

"The team is growing in terms of fitness, it's a decisive moment for the season," said Allegri.

Juventus are building towards next week's game in Madrid and a top-of-the table clash against Napoli in the San Paolo Stadium on March 3.

"We struggled a bit after the winter break but now we are ready to face this important moment of the season both in the championship and



the Champions League," added Allegri.

Juventus remain unbeaten this season but the reigning seven-time league champions had been held 3-3 by Parma two weeks ago.

Bharat Express runs into trouble twice New Delhi, Feb 16 ding wheels after the

(PTI): A day after it was flagged off by Prime Minister Narendra Modi, India's first semihigh speed train, Vande Bharat Express, ran into some trouble twice on Saturday while returning to Delhi from Varanasi, officials said.

The first incident occurred around 15 kilometres from Tundla junction in Uttar Pradesh, with officials calling it a case of "skidding wheels".

"This disruption appears to be because of a possible cattle run over. The train was returning at night and cattle run over is a possibility at odd times." Railway spokesperson Smita Vats Sharma said, adding this was not a commercial run, which is scheduled to start from Sunday.

According to sources, including several journalists on board the train, it was stuck near Tundla for over an hour. "It was a case of skidtrain ran over cattle," Northern Railway CPRO Deepak Kumar said. After removing the

obstacles, the train resumed its journey to Delhi at around 8:15 am, officials said.

However, it suffered a breakdown after 40 minutes at Hathras Junction and could resume journey after 10:20 am and is now running at a speed of less than 50 kmph, sources said.

Vande Bharat Express had hit 180 kmph during a trial run on a section of the Delhi-Mumbai Rajdhani route, thus becoming India's fastest train.

The train had left Varanasi Junction at 10.30 pm for Delhi on Friday, nearly 45 minutes after reaching the holy city on its inaugural journey.

Train 18, which was rechristened Vande Bharat Express by Railway Minister Piyush Goyal, has been manufactured by the Integral Coach Factory, Chennai.

NEW DELHI, FEB 16 (PTI): A slight tweak in hand positioning and body posture was all that it took for Rishabh Pant to turn the tables after a tough stint behind the stumps in England and the fast-rising Indian wicketkeeper-batsman credits Kiran More for making it happen.

He faced sharp criticism for his wicket-keeping skills in adverse English conditions but Pant more than made up for it in Australia.

In England, where the red Dukes was seaming all around, a lot of byes were recorded against Pant's name, many of them due to the ball moving in the air even after leaving the stumps.

However, things changed in Australia, where he pulled off 20 catches with a world record-equalling 11 scalps in Adelaide.

"Keeping in England was an altogether different experience. After that, I worked with Kiran sir at the

NCA on a few specific areas. It included hand-positioning and body posture. Every keeper has distinct movement and I tweaked it a little and it worked," Pant told PTI during an exclusive interview.

While Pant didn't elaborate on the specifics, More, who has been a respected coach as well as former chairman of the national selection committee, pointed out a few basic areas.

"Rishabh had a more sideways movement and I suggested a bit more open chested stance. It helps in balance and keeping a still head, something that is key to Mahendra Singh Dhoni's success," More said.

About the positioning of hands, More said, "I advised a very minor change like pointing the finger towards ground rather than the bowler. It helps one avoid injuries and success in taking catches goes up."

For Pant, the endeavour is to im-

prove everyday and working on his

ferent level. From there, I started constantly thinking that how can I improve in certain areas. The process of learning that started in England paid off in Australia," said the heir apparent of Dhoni.

> The 'devil-may-care' approach to batting has been his calling card and he asserts that the high stakes IPL games, where he plays for Delhi Capitals, and for India, have not bogged him down.

But isn't there and insecurity that this approach may let him down when stakes are very high?

"Insecurities will always be there whether you play for India or for your franchise in IPL. But how do you beat those insecurities and perform, defines you as a player."

"Stakes will always be high for India or Delhi Capitals, so if you let insecurities come in your way, it will be very difficult to focus on the job. One needs that balance to treat every game as same," said Pant.

Having scored 684 runs in the last IPL season for Delhi (erstwhile Daredevils), Pant obviously wants a repeat and would prefer batting at the top of the order for the Capitals.

"As a batsman, I would always like to bat as high as possible but the team combination is also very important," said Pant, who expects things to change for Delhi this time round.

"We have had a change in name,

jersey and New players have come in. It's a good blend of youth and experience. Hope both our departments click this time and Delhi Capitals have a good tourney."

With 277,000 followers on Twitter, Pant's fan following is on the rise but for him it's a by-product of his success on the field and nothing more than that.

As a young celebrity, he provided his perspective on how social media can cut both ways.

"You need to be careful about social media. Once you are well known, your personal space shrinks. You will get a lot of praise but one should also be aware that you will have to deal with negativity," he said.

"Irrespective of social media's influence, it's the cricket that you play which will remain paramount. How to keep focus when you have hit a low patch and things are looking down, is something we all must learn," he concluded.

Two States only just solution for **Israel-Palestine conflict: UN chief**

YOSHITA SINGH UNITED NATIONS, FEB 16 (PTI): A "peaceful and just solution" to the longstanding Israel-Palestine conflict can only be achieved through creation of two States living side-by-side in peace and security, UN Secretary-General Antonio Guterres has said, asserting that there is no plan B.

In his address to the Committee on the Exercise of the Inalienable Rights of the Palestinian People, which was established by the UN General Assembly in 1975, Guterres said on Friday that "based on relevant UN resolutions, longheld principles, previous agreements and international law", Jerusalem should be the capital of both States.

"Unfortunately, over this past year, the situation has not moved in that direction", he rued, pointing to protests that began along the border fence with Gaza last year that left hundreds dead and thousands wounded by Israeli security forces.

He also cited "security incidents and provocations by Hamas and other militants in Gaza", including the launching of rockets and incendiary kites that dangerously escalated the situation.

"Thanks to the UN and Egyptian mediation efforts, a major escalation was avoided", he said, appealing to Hamas authorities in Gaza to "prevent provocations".

Guterres said he regretted Israel's decision not to renew the mandate of the Temporary International Presence in Hebron, saying "I hope an agreement can be found by the parties to preserve this long-standing and valuable arrangement".

"Palestinians have endured more than a half-century of occupation and denial of their legitimate right to self-determination" with both sides continuously suffering from "deadly cycles of violence", the Secretary-General said.

He indicated that leaders bore the responsibility to reverse this negative trajectory and pave the way toward peace, stability and reconciliation.

Guterres praised the Committee for keeping the focus on the ultimate objective of a "peaceful solution with two States coexisting in peace and security" as the only way to achieve the inalienable rights of the Palestinian people.

"As I have said repeatedly, there is no Plan B." Guterres said.

He underscored that the UN firmly supports Palestinian reconciliation and "the return of the legitimate Palestinian Government to Gaza" as "an integral part of a future Palestinian State".

Noting that the ongoing humanitarian crisis in Gaza must be immediately addressed, he detailed that some two million Palestinians remained mired in increasing poverty and unemployment, with limited access to adequate health, education, water and electricity, leaving young people with "little prospect of a

better future". "I urge Israel to lift restrictions on the movement of people and

goods, which also hamper the efforts of the United Nations and other humanitarian agencies, without naturally jeopardising legitimate security concerns," Guterres said.

Lauding the UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) for its "critical work" in Gaza, the occupied West Bank and across the region, he called on the international community to "significantly" increase efforts to revitalise Gaza's economy.

Touching upon the risk of further unrest in the West Bank, the UN chief flagged that Israeli construction and settlement plans have expanded, including in East Jerusalem.

"Settlements are illegal under international law", he asserted.

"They deepen the sense of mistrust and undermine the State solution".

Cognizant to pay USD 25 mn to settle India bribery charges

WASHINGTON, FEB 16 (PTI): Major American IT player Cognizant will pay USD 25 million to the US Security and Exchange Commission to settle its India bribery charges, as Department of Justice filed criminal cases against two if its former top executives.

The two former executives have been charged for their roles in facilitating the payment of millions of dollars in bribe to an Indian government official, the Security and Exchange Commission (SEC) said. Cognizant has agreed to pay USD 25 million to settle charges that it violated the Foreign Corrupt Practices Act (FCPA), the SEC said.

The complaint alleges that in 2014, a senior Tamil Nadu official demanded a USD 2 million bribe from the construction firm responsible for building Cognizant's 2.7 million square foot campus in Chennai.

As alleged in the complaint, Cognizant's President Gordon Coburn and Chief Legal Officer Steven E Schwartz authorised the contractor to pay the bribe and directed their subordinates to conceal the bribe by doctoring the contractor's change orders.

The SEC also alleges that Cognizant authorised the construction firm to make two additional bribes totaling more than USD 1.6 million. Cognizant allegedly used sham change order requests to conceal the payments it made to reimburse the firm, SEC said. The SEC charged Coburn and Schwartz with violating anti-bribery, books and records, and internal accounting controls provisions of the federal securities laws. The SEC is seeking permanent injunctions, monetary penalties, and officer-and-director bars against Coburn and Schwartz.

In a separate statement, the Department of Justice said Gordon Coburn, 55, and Steven Schwartz, 51, have been charged in a 12-count indictment with one count of conspiracy to violate the FCPA, three counts of violating the FCPA, seven counts of falsifying books and records, and one count of circumventing and failing to implement internal accounting controls.

The allegations in the indictment filed Thursday describe a sophisticated international bribery scheme authorised and concealed by C-suite executives of a publicly-traded multinational company, said Assistant Attorney General Brian Benczkowski.

According to the indictment, in April 2014, Coburn and Schwartz allegedly authorised an unlawful payment of approximately USD 2 million to one or more foreign government officials in India to secure and obtain a necessary permit to open a new office campus. To conceal Cognizant's involvement in the scheme, Coburn, Schwartz and others allegedly agreed that a

Los Angeles, Feb 16 (PTI): The Academy of Motion Picture Art & Sciences has announced a roll back of its decision to present four categories of Oscars during the commercial breaks.

In its attempt to keep the live telecast under three hours, the Academy had decided to present four categories -- cinematography, film editing, live action shorts and makeup and hairstyling -- during commercial breaks with the winners' speeches set to air later in the broadcast. Academy president John Bailey, a cinematographer himself, in an email to the members had said the change would be on a rotation each year, meaning that at least four different categories would use this format in 2020 and that the four mentioned would be exempt.

The news had to led to a huge controversy with many Hollywood A-listers such as George Clooney, Brad Pitt and · Christopher Nolan, among others, urging the Academy to reverse its decision.

In a brief statement on Friday, the Academy's Board of Governors said, "The Academy has heard the feedback from its membership regarding the Oscar presentation of four awards - Cinematography, Film Editing, Live Action Short, and Makeup and Hairstyling."


