ment of Social Justice & Welfare, Old Age pension, Maternal & Child Services, Orphan Child Welfare, Child Education and Services, Human Resources, Financial Management, enhancement of necessary infrastructure, Child-care homes, Scheduled Caste/Tribe Welfare Schemes, economic balance, protection of people's rights and various scholarship were thoroughly discussed.

The Chief Minister directed the officials to monitor the old-age pensions and ensure the beneficiaries receive them and are not misused.

Likewise, he also urged them to raise awareness about their welfare schemes so a maximum number of people can benefit from them. Matters related to land and relocation of various premises were also discussed during the meeting.

Similarly, in the meeting with the Ecclesiastical department, the officials informed about the number of employees, Monastic schools and Sanskrit pathshala in the state apart from various expenses of the department.

They placed their grievances regarding office space as they have to share a confined space with three other departments with limited space to store valuable texts, assets and others. They brought up the issues of having a Monastic Board and introducing reforms for suitably regulating the department. Issues related to renovation and fencing of their properties, enhancement of the number of nunneries and Sanskrit pathshalas, were also deliberated upon.

The Chief Minister directed the department to find out ways to preserve and sustain traditional art forms. He also provided his suggestions and views and assured support for their en-

No new deaths for second consecutive day and Sikkim also records more recoveries than new cases

Cikkim's COVID death **J**toll held at 308 for the second consecutive day with no new COVID deaths reported in the last 24 hours. On the other hand, 182 more persons were discharged from home isolation after making full recoveries to further improve the figure of recovered cases to

As per Daily Report of COVID-19 in Sikkim released by the Integrated Disease Surveillance Programme [IDPS] of the Health Department at 8AM Saturday, Sikkim recorded 178 new cases of novel coronavirus in the last 24 hours taking the state's tally of confirmed cases of



COVID-19 to 20,955.

These 178 new cases were detected in the testing of 966 samples on Friday, giving Sikkim a test positivity rate of 18.4% today.

Of the new cases, 60

were registered in East at present, of whom District, 64 in West District, 51 in South District and 03 in North District.

Against the 178 new cases, there were only 15 new hospitalisaare currently 94 Covid patients in hospital, the rest are either in facility or home isolation with symptoms mild enough not to require hospitalisation.

SDF condemns GRC's Sikkim-Darj merger proposal

Cikkim Democratic **S**Front spokesperson, MK Subba has condemned the Sikkim-Darjeeling merger issue brought up by the Gorkha Rashtriya Congress recently.

Addressing a press conference here this afternoon, Mr Subba stated that Sikkim

handed over the ownership of Darjeeling to the British government in 1835. He mentioned that those areas which were a part of Sikkim were given back when Sikkim became a part of India in 1975 with the 36th amendment of the Constitution of India.

Likewise, he added that Article 1 of

Indo-Sikkim Treaty of 1950 cancels all official agreements between Sikkim and British India which automatically dilutes all relationship between Sikkim and Darjeeling.

Responding to a media query, he said that the white paper issued by the West Bengal government in 1986 claiming that Darjeeling was a part of West Bengal was unconstitutional and added that only the Parliament of India has the right to make such claims.

Another query on the King of Sikkim accepting lease amount for Darjeeling, he stated that it was not lease amount but British India had actually provided money for the

development of Sik-

He added that the State government and SKM party have also registered their protest but failed to do so in an effective manner.

Mr Subba expressed hope that the dream of separate state of Gorkhaland would be fulfilled soon.

Congress questions centre's silence on **Covaxin pricing** controversy in Brazil

NEW DELHI, 03 JUL: The Congress Party on Friday cornered the central government over the Covaxin pricing controversy in Brazil and asked the Centre why it is "conspicuously silent" on the matter.

Briefing medipersons, Congress spokesperson Supriya Shrinate said, "It is important for us to raise these questions because Bharat Biotech may be a private entity, but, the public fund was diverted for the development of this vaccine. Taxpayers' money was put into this and which is why we have a right to question: what has happened with that money and why is the government conspicuously silent on it?"

The Congress leader said Bharat Biotech had made an agreement with Precisa Medicamentos of Brazil and they had signed a contract to supply 20 million doses to the country. However, according to media reports, Bharat Biotech allegedly had quoted a price of USD 1.34 per dose of Covaxin which was jacked up to USD 15 per dose. The Brazilian opposition and the senate have raised the issue following which criminal investigative agencies are probing the matter. Brazilian agencies are also probing an offshore possible fund diversion by an entity called Madison Biotech related to Bharat Biotech.

She further said that the question is that ICMR was slated to get 5 per cent of the profit from the sale of Covaxin. But, allegations are that Bharat Biotech was selling the vaccine to Madison Biotech at a lower price.

"Madison was garnering the lion's share of the profit. We really want to know, what is the relationship between Madison Biotech and Bharat Biotech. These allegations are of a very serious nature and if Bharat Biotech was selling according to the allegations at a lower price then obviously ICMR's own proceeds get depressed," she stated.

"The allegations are that a USD 45 million offshore payment was asked by Madison Biotech. Why is this 'partner' of Bharat Biotech asking for this sort of money? It is illegal as it is not a part of the contract signed between Bharat Biotech, Precisa Medicamentos and the Brazilian government," she said.


SICUN holds 51st board meeting

Facebook takes down over 30 million posts in compliance with new IT Rules

NEW DELHI, 03 IUL [PTI]: Facebook "actioned" over 30 million content pieces across 10 violation categories during May 15-June 15 in the country, the social media giant said in its maiden monthly compliance report as mandated by the IT rules.

Instagram took action against about two million pieces across nine categories during the same period.

Under the new IT rules,

(with over 5 million users) will have to publish periodic compliance reports every month, mentioning the details of complaints received and action taken thereon. The report is to also include the number of specific communication links or parts of information that the intermediary has removed or disabled access to in pursuance of any proactive monitoring conducted by using automated tools.

A Facebook spokesperson said over the Facebook has consistently invested in technology, people and processes to further its agenda of keeping users and action taken. safe and secure online and enabling them to express themselves freely on its platform.

"We use a combination of artificial intelligence, reports from our community and review by our teams to identify and review content against our policies. We"ll continue to add more information and build on these efforts towards transparency as we evolve this report," large digital platforms the spokesperson said in a statement to PTI.

Facebook said its next report will be published on July 15, containing details of user complaints received and action tak-

"We expect to publish subsequent editions of the report with a lag of 30-45 days after the reporting period to allow sufficient time for data collection and validation. We will continue to bring more transparency to our work and include more information about our efforts in future reports," it added.

Earlier this week, Facebook had said it will publish an interim report on July 2 providing information on the number of content it removed proactively during May 15-Iune 15. The final report will be published on July 15, containing details of user complaints received

The July 15 report will also contain data related to WhatsApp, which is part of Facebook's family of apps.

Other major platforms that have made their reports public include Google and homegrown platform Koo.

In its report, Facebook said it had actioned over 30 million pieces of content across 10 categories during May 15-June 15. This includes content related to spam (25 million), violent and graphic content (2.5 million), adult nudity and sexual activity (1.8 million), and hate speech (311,000).

Other categories under which content was actioned include bullying and harassment (118,000), suicide and (589,000), self-injury dangerous organisations and individuals: terrorist propaganda (106,000) and dangerous organisations and Individuals: organised hate (75,000). "Actioned"

refers to the number of pieces of content (such as posts, photos, videos or comments) where action has been taken for violation of standards. Taking action could include removing a piece of content from Facebook or Instagram or covering photos or videos that may be disturbing to some audiences with a warning.

The proactive rate, which indicates the percentage of all content or accounts acted on which Facebook found and flagged using technology before users reported them, in most of these cases ranged between 96.4-99.9 per cent. The proactive rate

for removal of content related to bullying and harassment was 36.7 per cent as this content is contextual and highly personal by nature. In many instances, people need to report this behaviour to Facebook before it can identify or remove such content.

For Instagram, 2 million pieces of content were actioned across nine categories during May 15-June 15. This includes content related to suicide and self-injury (699,000), violent and graphic content (668,000), adult nudity and sexual activity (490,000), and bullying and harassment (108,000).

Other categories under which content was actioned include hate speech (53,000), dangerous organisations and individuals: terrorist propaganda (5,800), and dangerous organisations and individuals: organised hate (6,200).

Google had stated that 27,762 complaints were received by Google

and YouTube in April this year from individual users in India over alleged violation of local laws or personal rights, which resulted in removal of 59,350 pieces of content.

Koo, in its report, said it has proactively moderated 54,235 content pieces, while 5,502 posts were reported by its users during June. According to the IT

rules, significant social media intermediaries are also required to appoint a chief compliance officer, a nodal officer and a grievance officer and these officials are required to be resident in India. Non-compliance with

the IT rules would result in these platforms losing their intermediary status that provides them immunity from liabilities over any third-party data hosted by them. In other words, they could be liable for criminal action in case of complaints. Facebook recently

named Spoorthi Priya as its grievance officer in India.

India is a major market for global digital platforms. As per data cited by the government recently, India has 53 crore WhatsApp users, 41 crore Facebook subscribers, 21 crore Instagram clients, while 1.75 crore account holders are on microblogging platform Twitter.

No weekend curfew from

[NDTV]: Karnataka today announced the lifting of weekend curfews starting next week as it continues to tread cautiously despite a drop in daily Covid cases. The night curfew will, however, continue to be in place from 9 pm to 5 am, a government order said.

The state has announced more relaxations to lockdown-like restrictions from 6 am tomorrow in places outside the containment zones. However, all educational institutions, tutorial centres, and colleges will continue to remain shut until further orders.

Starting tomorrow, public transport will be allowed to operate up to their seating capacity.

Theaters, cinema halls, malls, restaurants, shops, and offices outside containment zones will be allowed to reopen.

Access to swimming pools has been granted for training purposes only with strict adherence to Covid safety pro-

Sports complexes and stadiums will be allowed

no spectators will be allowed inside.

Congregations and gatherings - social, political, religious, academic and cultural - will be allowed outside containment zones.

The state has now capped the number of guests at a wedding to 100 and those attending funerals to 20 with full compliance with Covid rules.

Places of worship have now been allowed to open to devotees for only darshan. During the hours of

the night curfew, only essential services will be allowed and the movement of individuals will continue to be restricted.

Public transport, private vehicles, and taxis will be allowed to run to and from airports, bus terminals, and railway stations. Those carrying valid travel documents and tickets will be allowed.

On Friday, Karnataka reported 2,984 cases of coronavirus in 24 hours with state capital Bengaluru logging 593 cases.

Swimming Federation of India nominates Tokyo-bound Sajan Prakash for Arjuna Award

NEW DELHI, 03 JUL [PTI]: Swimming Federation of India (SFI) for the second consecutive year nominated the name of Sajan Prakash for the Arjuna Award, and recommended the name of veteran Coach Kamlesh Nanavati for the Dhyan Chand Award for his contribution to Indian swimming over the past four decades.

SFI had earlier in June forwarded its nominations for the National Sports Awards 2021 under the various categories. Soon after the nomination, Sajan Prakash created history in Indian swimming by breaching the Olympic A qualification time which has eluded Indian

swimming for decades, and qualified for Tokyo Olympics.

"By making the A qualification for TOKYO 2020 in the 200-meter butterfly event, Sajan Prakash has broken the glass ceiling and goes down in the history of Indian swimming as the 1st Indian to have achieved this feat. His achievement will inspire many more swimmers in the time to come. We believe this achievement will place Sajan Prakash's nomination for the Arjuna Award at the forefront amongst equals," Monal Chokshi, Secretary-General SFI said in a release.

SFI has also recommended the nomination of

Kamlesh Nanavati for the Dhyan Chand Award, for his lifetime achievements in aquatic sports. He represented India in water polo at many international competitions and subsequently as a swimming coach.

In a career spanning almost 4 decades, Kamlesh has produced numerous National medalists and National record holders.

He has also made a mark for himself in officiating as "Director of Competitions" at national and international meets and has remained on the technical committee of FINA for water polo.

"Kamlesh Nanavati has reason to be satisfied to-

day, as Maana Patel who he has coached for the better part of her career becomes the first swimmer from Gujarat to represent India at the Tokyo Olympics. Blessed is the coach who has the privilege to witness his or her protegee go on to represent the country at the biggest sports platform in the world," SFI President RN Jayaprakash said.

Tapan Panigrahi has been nominated for the Dhronacharya Award (lifetime achievement) for his contribution towards producing many national and international champions in para-swimming as well as able-bodied category.

Border tension between Assam, Mizoram rise over piece of land



GUWAHATI, 03 JUL [NDTV]: After a lull of a few months, border tension between Assam and Mizoram has erupted once again, with police personnel from both the states clashing over a piece of land.

Assam had recently dismantled makeshift huts which it claimed were encroaching forest land inside its territory in Dholaikhal area of Hailakandi district bordering Mizoram's Kolashib. Mizoram officials have now claimed the huts were part of a police camp and were well within its territory.

Visuals show the police personnel jostling and pushing each other in the border area.

Mizoram said it had

sent the police to guard and reserve its territory after the Assam police dismantled the huts. Assam said it had just cleared encroachment from its forest land.

"Neighbouring border areas are forest land which is under the purview of the (Assam) forest department. In this regard, the forest department has requisitioned a police force so that they can do the patrolling, and we have not crossed the border. When we found makeshift structures in the form of encroachment, we followed the Supreme Court order that reserved forest cannot have this kind of encroachment. So, we have removed them. If there are any differences in

perception of the border, officers from both states can meet and ascertain facts," said Niraj Verma, Principal Secretary (Home), Assam.

Countering the claim, Dr H Lalthlangliana, the Deputy Commissioner of Kolashib, said he has brought to the notice of his Hailakandi counterpart the recent tension at Aitlang zau (a piece of land at the Assam-Mizoram border), where the 'Assamese police' had dismantled the camps set up by the Mizoram police. He added that the Mizoram government has sent additional troops to the border to camp at the land.

Officials in Aizawl said that Mizoram Chief Secretary Lalnunmawia

Chuaungo and his Assam counterpart Jishnu Baruah will hold a meeting next week on border is-

On Thursday, Gyanendra Dev, a senior Assam official, visited the disputed areas and talked to the local people and officials.

Mizoram's Aizawl, Kolasib and Mamit districts share borders with Assam's Cachar, Karimganj and Hailakandi districts. There have been several instances of border dispute in these areas.

The Centre last year held high-level talks with the two state governments to work out a temporary solution to defuse the tension brewing at both sides due to violence.

Both doses of vaccine give 98% protection from death due to Covid: Centre

New Delhi, 03 Jul Institute of Medical [NDTV]: Both the doses of Covid vaccine provide around 98 per cent protection from death due to the disease, while one dose gives nearly 92 per cent shield, the government said today citing a study conducted on police personnel in Punjab.

The study was done by the Post Graduate Education and Research, Chandigarh in collaboration with the Punjab government.

Sharing the data of the study, NITI Aayog member (Health) Dr VK Paul said 4,868 police personnel were not vaccinated and out of them, 15 died due to coronavirus infection, which comes down to 3.08 incidence per thousand.

Then out of 35.856 police personnel who were administered one dose, nine died, which translates to 0.25 per thousand. A total of 42,720 received both doses of the vaccine and out of them two died, which translates to 0.05 incidence per thousand, he said at a press confer-

"Police personnel fall in high-risk group. From these numbers, we find that one dose offers 92 per cent protection from death while both doses give 98 per cent protection," Mr Paul said.

"Such studies and their findings show that vaccination eliminates serious disease and deaths. So have faith in the vaccines as they are effective and vaccines should be embraced," he said.

India records 44,111 new COVID-19 cases, 738 deaths

NEW DELHI, JUL 3 (PTI): India saw a single-day rise of 44,111 new coronavirus infections, raising its tally to 3,05,02,362, while the death toll climbed to 4,01,050 with 738 new fatalities, the lowest in 86 days, according to the Union Health Ministry data updated on Saturday.

The active cases --4,95,533 -- were recorded below five lakh after 97 days and comprised 1.62 percent of the total infections. The national COVID-19 recovery rate improved to 97.06 percent, the data updated at 8 am showed.

A net decline of 14,104 cases has been recorded in active coronavirus infections in a span of 24 hours, it said.

Also, 18,76,036 tests

were conducted on Thursday, taking the total cumulative tests conducted so far for detection of COVID-19 in the country to 41,64,16,463.

The daily positivity rate was recorded at 2.35 percent. It has been less than 5 percent for 26 consecutive days, the ministry said.

The weekly positivity rate has declined to 2.50 percent, it added.

Recoveries continue to outnumber daily new cases for 51st consecutive day. The number of people who have recuperated from the disease surged to 2,96,05,779, while the case fatality rate stands at 1.31 percent, the data stated.

Cumulative vaccine doses administered so far has reached 34.46 crore under the Nationwide Vaccination Drive, it said.

India's COVID-19 tally had crossed the 20lakh mark on August 7, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore

mark on December 19. The country crossed the grim milestone of 2 crore cases on May 4 and 3 crore on June 23.

The Health Ministry said the 738 new fatalities include 156 from Maharashtra, 146 from Kerala, 97 from Tamil Nadu and 88 from Karnataka.

A total of 4,01,050 deaths have been reported so far in the country, including 1,22,353 from Maharashtra, 35,222 from Karnataka, 32,818 from Tamil Nadu, 24,983 from Delhi, 22,616 from Uttar Pradesh, 17,758 from West Bengal and 16,086 from Punjab, as per the data.

The ministry stressed that more than 70 percent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," it said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

Heal and Restore Lost Youth

Solve underlying conditions leading to juvenile crime

Tt is not rare for police records to reveal that kids, some of I them not yet 17, are often picked up at holding on to consignments substances of abuse. Often, the "drug busts" result from suspects being picked up for an unrelated incident, like lurking around "suspiciously" or spotted trying to burgle or steal unattended stuff like tyres from parked cars. Invariably, a body search leads to the recovery of prescription drugs of abuse, which we are told are large enough to peddle, but check with anyone who has battled addiction and they will attest that 100 capsules of Spasmo Proxyvon, which might appear to most as a "haul," is barely a week's supply for an advanced addict. Depending on what is recovered, the kids get booked under SADA or NDPS Act. Either way, given that most of these kids come from under-privileged families and have a history of getting into trouble, they receive convictions and rarely much help from even their families.

This situation is shared here because it flags the several issues which confront Sikkim at present, none of which are being addressed in earnest or with any success. Such youth are most of the times not peddlers but mules holding the consignment for someone else and often paid in kind with some free supplies for their addiction. In all probability, their addiction happened after their services were used. There is obviously always someone [not necessarily one person but could be a series of 'seniors'] who initiates the young into the maze of addiction. May be these people even sponsor the habit initially and then use the control they have over the addiction to even use them as mules in a stereotypical process of the young getting sucked in and then left trapped in the vortex of addiction and then criminality.

The near instinctive reflex to seize an opportunity for petty crime, as is being displayed by too many youth, also suggests that they do not have other resources to feed their addiction - whether to drugs or gadgets.

Over interpretation?

Perhaps. But definitely close enough to the ground reality for a sizeable chunk of the youth in the region to warrant a concerted societal engagement. Petty crimes by young delinquents have noticeably increased in Sikkim and addiction has been building up as a major malady for a while now; and yet, at the non-governmental, non-police level there has been no response.

This is not about fixing blame, but an appeal to begin a social engagement to address the problem. It is also important that instead of pointing fingers, a collaborative effort is attempted to save the young. The present response to the situation punishes and excludes people, who, because of their young age, should be seen as victims in need of healing and inclusion. It is time to stop dealing with the symptoms of youth crime and put some community-based participatory effort into solving the underlying conditions.

Kids are using soft drinks to fake Covid-positive tests – Here's the science and how to spot it

hildren are always going to find cunning ways to bunk off school, and the latest trick is to fake a positive COVID-19 lateral flow test (LFT) using soft drinks. So how are fruit juices, cola and devious kids fooling the tests and is there a way to tell a fake positive result from a real one? I've tried to find out.

First, I thought it best to check the claims, so I cracked open bottles of cola and orange juice, then deposited a few drops directly onto LFTs. Sure enough, a few minutes later, two lines appeared on each test, supposedly indicating the presence of the virus that causes COVID-19.

It's worth understanding how the tests work. If you open up an LFT device, you'll find a strip of paper-like material, called nitrocellulose, and a small red pad, hidden under the plastic casing below the T-line. Absorbed to the red pad are antibodies that bind to the COVID-19 virus. They are also attached to gold nanoparticles (tiny particles of gold actually appear red), which allow us to see where the antibodies are on the device. When you do a test, you mix your sample with a liquid buffer solution, ensuring the sample stays at an optimum pH, before dripping it on the strip.

The fluid wicks up the nitrocellulose strip and picks up the gold and antibodies. The latter also bind to the virus, if present. Further up the strip, next to the T (for test), are more antibodies that bind the virus. But these antibodies are not free to move - they are stuck to the nitrocellulose. As the red smear of gold-labelled antibodies pass this second set of antibodies, these also grab hold of the virus. The virus is then bound to both sets of antibodies - leaving everything, including the gold, immobilised on a line next to the T on the device, indicating a positive test.

Gold antibodies that haven't



bound to the virus carry on up the strip where they meet a third set of antibodies, not designed to pick up COVID-19, stuck at the C (for control) line. These trap the remaining gold particles, without having to do so via the virus. This final line is used to indicate the test has worked.

ACID TEST

So how can a soft drink cause the appearance of a red T line? One possibility is that the drinks contain something that the antibodies recognise and bind to, just as they do to the virus. But this is rather unlikely. The reason antibodies are used in tests like these is that they are incredibly fussy about what they bind to. There's all sorts of stuff in the snot and saliva collected by the swabs you take from the nose and mouth, and the antibodies totally ignore this mess of protein, other viruses and remains of your breakfast. So they aren't going to react to the ingredients of a soft drink.

A much more likely explanation is that something in the drinks is affecting the function of the antibodies. A range of fluids, from fruit juice to cola, have been used to fool the tests, but they all have one thing in

common - they are highly acidic. The citric acid in orange juice, phosphoric acid in cola and malic acid in apple juice give these beverages a pH between 2.5 and 4. These are pretty harsh conditions for antibodies, which have evolved to work largely within the bloodstream, with its almost neutral pH of about

Maintaining an ideal pH for the antibodies is key to the correct function of the test, and that's the job of the liquid buffer solution that you mix your sample with, provided with the test. The critical role of the buffer is highlighted by the fact that if you mix cola with the buffer – as shown in this debunking of an Austrian politician's claim that mass testing is worthless – then the LFTs behave exactly as you'd expect: negative for COVID-19.

So without the buffer, the antibodies in the test are fully exposed to the acidic pH of the beverages. And this has a dramatic effect on their structure and function. Antibodies are proteins, which are comprised of amino acid building blocks, attached together to form long, linear chains. These chains fold up into very specific structures. Even a small change

to the chains can dramatically impact a protein's function. These structures are maintained by a network of many thousands of interactions between the various parts of the protein. For example, negatively charged parts of a protein will be attracted to positively charged areas.

But in acidic conditions, the protein becomes increasingly positively charged. As a result, many of the interactions that hold the protein together are disrupted, the delicate structure of the protein is affected and it no longer functions correctly. In this case, the antibodies' sensitivity to the virus is lost.

Given this, you might expect that the acidic drinks would result in completely blank tests. But denatured proteins are sticky beasts. All of those perfectly evolved interactions that would normally hold the protein together are now orphaned and looking for something to bind to. So a likely explanation is that the immobilised antibodies at the T-line stick directly to the gold particles as they pass by, producing the notorious cola-induced false positive result.

Is there then a way to spot a fake positive test? The antibodies (like most proteins) are capable of refolding and regaining their function when they are returned to more favourable conditions. So I tried washing a test that had been dripped with cola with buffer solution, and sure enough the immobilised antibodies at the T-line regained normal function and released the gold particles, revealing the true negative result on the test.

Children, I applaud your ingenuity, but now that I've found a way to uncover your trickery I suggest you use your cunning to devise a set of experiments and test my hypothesis. Then we can publish your results in a peer-reviewed journal.

Most buildings were designed for an earlier climate here's what will happen as global warming accelerates

limate change will affect every aspect of our lives — including the buildings we live and work in. Most people in the US, for example, spend about 90% of their time indoors. Climate change is fundamentally altering the environmental conditions in which these buildings are designed to function.

Architects and engineers design buildings and other structures, like bridges, to operate within the parameters of the local climate. They're built using materials and following design standards that can withstand the range of temperatures, rainfall, snow and wind that are expected, plus any geological issues such as earthquakes, subsidence and ground water levels.

When any of those parameters are exceeded, chances are some aspect of the building will fail. If there are high winds, some roof tiles may be ripped off. If, after days of heavy rain, the water table rises, the basement might flood. This is normal, and these problems cannot be designed out entirely. After the event has passed, the damage can be repaired and additional measures can reduce the risk of it happening

But climate change will breed conditions where these parameters are exceeded more often and to a far greater degree. Some changes, like higher average air temperatures and humidity, will become permanent. What were previously considered once in a century floods may become a regular occurrence.

Some of these impacts are fairly obvious. Houses will be more prone to overheating, putting the lives of residents at risk, which is what has happened during the recent "heat dome" over North America. Flooding will happen more often and inundate greater areas, to the point that some places might have to be abandoned. The village of Fairbourne in Wales has already been identified as a likely candidate. Failure to act on both of these threats in the UK was highlighted in a recent report by the Climate Change Committee.

To some extent, these impacts will be localised and containable, with fairly simple remedies. For example, overheating can be reduced by shading windows with awnings or blinds, good insulation, and ample ventilation. Perhaps more worrying are the insidious effects



of climate change which gradually undermine the core functions of a building in less obvious ways.

TERMITES AND MELTING ASPHALT

More intense wind and rain will cause external cladding to deteriorate more rapidly and leak more often. Higher temperatures will expand the regions where some insects can live. That includes timber-eating termites that can cause major structural damage, or malaria-carrying mosquitoes which living spaces must be redesigned to protect us from.

Materials expand as they get hotter, especially metals, which can cause them to buckle once their designed tolerance is exceeded. For one skyscraper in Shenzhen, China, high temperatures were partially blamed for causing the structure to shake, forcing its evacuation, as the steel frame stretched in the heat. Extreme temperatures can even cause materials to melt, resulting in roads "bleeding" as the surface layer

of bitumen softens.

Subsidence – when the ground below a structure gives way, causing it to crack or collapse - is also expected to happen more often in a warmer world. Buildings with foundations in clay soils are particularly vulnerable, as the soils swell when they absorb water, then harden and shrink as they dry out. Changing rainfall patterns will exacerbate this. Over the next 50 years, for example, more than 10% of properties in Britain will be affected by subsidence.

CONCRETE CANCER

Perhaps the biggest concern is how climate change will affect reinforced concrete, one of the most widely used materials on Earth. Used in everything from skyscrapers and bridges to the lintels above windows in homes, reinforced concrete is made by placing steel rods within a mould and pouring wet concrete in. Once dry, this produces incredibly strong structures.

But a warmer wetter climate will play havoc with the durability of this material. When the steel inside the concrete gets wet it rusts and expands, cracking the concrete and weakening the structure in a process sometimes referred to as "concrete cancer".

Buildings in coastal areas are especially susceptible as the chloride in salt water accelerates rusting. Rising sea levels will raise the water table and make it saltier, affecting building foundations, while saltspray will spread further on stronger winds.

At the same time, the concrete is affected by carbonation, a process where carbon dioxide from the air reacts with the cement to form a different chemical element, calcium carbonate. This lowers the pH of the concrete, making the steel even more prone to corrosion. Since the 1950s, global CO₂ levels have increased from about 300 parts per million in the atmosphere to well over 400. More CO₂ means more carbonation.

The tragic recent collapse of an apartment building in Miami in the US may be an early warning of this process gaining speed. While the exact cause of the collapse is still being investigated, some are suggesting it might be linked to climate change.

The local mayor, Charles Burkett, summed up the bewilderment many felt: "It just doesn't happen. You don't see buildings falling down in America."

Whether or not the link to climate change proves to be true, it is nevertheless a wake up call to the fragility of our buildings. It should also be seen as a clear demonstration of a critical point: wealth does not protect against the effects of climate change. Rich nations have the financial clout to adapt more rapidly and to mitigate these impacts, but they can't stop them at the border. Climate change is indiscriminate. Buildings are vulnerable to these impacts no matter where in the world they are, and if anything, the modern buildings of developed countries have more things in them that can go wrong than simpler traditional structures.

The only option is to begin adapting buildings to meet the changing parameters in which they are operating. The sooner we begin retrofitting existing buildings and constructing new ones that can withstand climate change, the better.



Tripura extends COVID curfew till July 9



AGARTALA, JUL 3 (PTI): The Tripura government has extended the COVID curfew from 2 pm to 5 am in Agartala and eight other urban local bodies (ULBs) till July 9, a notification said.

However, the night curfew from 6 pm to 5 am has been lifted from the villages.

The COVID curfew in the ULBs, first imposed on May 16 and then repeatedly extended, was scheduled to end on July

"The COVID curfew will remain in force in the jurisdiction of Agartala Municipal Corporation (AMC) and eight other ULBs till July 9," the notification issued by Chief Secretary Kumar Alok

Besides Agartala, the restrictions have also been imposed in the municipal councils of Ranirbazar, Udaipur, Kailashahar, Dharanagar, Khowai, Belonia, and nagar panchayats of Jirani and Panisagar.

Shopping malls and market complexes will remain closed at all times and bazaar committees shall deploy volunteers to ensure strict adher-

ence to social distancing. Vehicles can only ply between 5 am and 2 pm

for essential purposes. However, vehicles ferrying medical supplies will be allowed to ply even after 2 pm.

There shall be a total ban on the movement of individuals between 2 pm and 5 am except for prescribed exemptions,

All government and private offices shall remain open till 4 pm with 50 per cent attendance.

Social, political, religious, academic, or other gatherings shall be prohibited. Only essential government meetings with a maximum of 20 participants will be al-

Movie theatres, mulgymnasiums, tiplexes, swimming pools, salons and bars shall remain closed at all times.

Restaurants will remain open only till 2 pm.

Semenya misses Tokyo, may be forced out of Olympics for good

CAPE TOWN, JUL 3 (AP): This could be it for Caster Semenya and the Olympics.

Forced out of her favorite race by World Athletics' testosterone rules, the two-time Olympic champion in the 800 meters took a late shot at qualifying for Tokyo in the 5,000 meters, an event not affected by the hormone regulations. She came up short.

Now 30, Semenya's hopes of making it back to the Olympics are dwindling. The South African once said she wanted to run at top track events until she was 40.

Now, her future ambitions depend on a final, long-shot legal appeal of the testosterone rules or transforming from the world's dominant middle-distance runner into a successful long-distance athlete. That's going to be hard for her.

Semenya is the athlete that has perhaps stoked the most controversy in track and field over the last decade. If there are no more appearances on the biggest stage, it's been a career like no other.

In 12 years at the top, Semenya has won two Olympic golds and three world championship titles, but her success has come amid near-constant interference by track authorities. She has only competed free of restrictions of one type or another for three of those 12 years.

WHY CAN'T SEMENYA DEFEND HER 800 TITLE IN TOKYO?

In 2018, world track and field's governing body introduced rules it said were aimed at female athletes with conditions called differences of sex development, or DSDs. The key for World Athletics is that these athletes have testosterone levels that are higher than the typical female

The track body argues that gives them an unfair advantage. Semenya is the highest-profile athlete affected by the regulations, but not the only one.

The rules demand that Semenya lower her testosterone levels artificially by either taking birth control pills daily, having hormone-blocking injections or undergoing surgery to be allowed to run in races from 400 meters to one mile.

Semenya has simply refused to do that, pointing out the irony that in a sport where doping is such a scourge, authorities want her to take drugs to be eligible to run at the Olympics.

"Why will I take drugs?" Semenya said

"I'm a pure athlete. I don't cheat. They should focus on doping, not us." BUT SHE CAN RUN THE 5,000?

Yes. Strangely, World Athletics decided to only enforce the testosterone rules for track events from 400 meters to one mile, raising criticism from Semenva's camp that the regulations were specifically designed to target her because of her dom-

It means Semenya can compete in the 100 and 200 meters and long-distance ya. Just this week, two 18-year-old female races without lowering her testosterone levels. Field events are also unregulated.

After a brief go at 200 meters, Semenya attempted to qualify for Tokyo in the 5,000 meters, running races in Pretoria and Durban in South Africa and, most recently, at international meets in Germaand Belgium last month. She never came within 20 seconds of the Olympic qualifying mark.

THE COURT BATTLE

Semenya continues to fight against the testosterone regulations in court. She has launched three legal appeals against the rules, calling them unfair and discriminatory, and appears determined to wage her legal fight to the very end.

Having failed in appeals at the Court of Arbitration for Sport and the Swiss supreme court, Semenya has now lodged an appeal with the European Court of Human

Semenya's first appeal at sport's highest court revealed a bitter battle between her and track authorities, centered on World Athletics' claim in the closed-doors hearing that she was "biologically male."

Semenya angrily refuted that, having been identified as female at birth and having identified as female her whole life. She called the assertion "deeply hurtful."

OTHER ATHLETES AFFECTED

The issue won't disappear with Semenathletes from Namibia were barred from competing in the 400 meters at the Tokyo Olympics after they underwent medical tests and it was discovered they had high natural testosterone levels. One of them, Christine Mboma, is the world under-20 record holder.

The two runners that finished second and third behind Semenva at the 2016 Olympics, Francine Niyonsaba of Burundi and Margaret Wambui of Kenya, have said publicly they also are affected by the testosterone regulations and have been banned from the 800, too, unless they undergo medical intervention. Niyonsaba has qualified for the Olympics in the 5,000 meters. WHAT NOW?

WASHINGTON, JUL 3 (AP): Simone Biles is aware of the pressure. She welcomes it. Practically invites it. Look no further than the sequined goat she's nicknamed Goldie that occasionally finds its way onto her competition leotard.

The symbol a play on the acronym for greatest of all-time is both a nod to her hard-earned status as the most talented gymnast (and maybe athlete) on the planet and the outsized expectations she faces, both internally and externally.

It's a delicate dance, one that will take center stage when the 24-yearold American steps in front of the world in Tokyo. No pressure. All she has to do is somehow one-up her staggering performance in Rio de Janeiro, when she won five medals (including four gold) and entered the rarified air of Olympic royalty reserved for the likes of Michael Phelps, Usain Bolt and Nadia Comaneci.

Yes, it's a lot. Then again, whatever bar is set for her by others pales in comparison to the bar Biles sets for herself. It's why she found herself in tears at the U.S. Olympic Trials, when an off night in the finals left her frustrated and angry.

I feel like anything rather than my best will tick me off, Biles said.

It's that drive that led Biles to return to the gym after a year off following her remarkable success in Brazil. New coaches Laurent and CecilleLandi helped her put together a plan that didn't ask her to simply regain the skills that made her the best in the world, but build upon

The first Euro 2020 semifinal matchup was determined Friday after Italy beat top-ranked Belgium 2-1 in Munich and Spain defeated Switzerland in a penalty

burg. Italy is Europe's hottest team, extending its unbeaten run to 32 matches and its winning streak to 13 with Friday's result. By contrast, Spain is on a 12-match unbeaten run and drew its opening two group matches.

HISTORY

Italy prevented Spain from winning a third consecutive European Championship by beating the defending champions 2-0 in the round of 16 at Euro 2016.

The Spanish beat Italy on penalties in the Euro 2008 quarterfinals before ending their 44year trophy drought.

COACHES

Spain coach Luis Enrique was playing for his country at the 1994 World Cup when his nose was broken in the quarterfinals by Italy defender Mauro Tassot-

Italy went on to reach the final that year, losing to Brazil on penalties.

Italy coach Roberto Mancini wasn't part of his country's squad at the 1994 World Cup because he opted out of international duty after not being sure of playing time. His return to the Italian national team only came in 2018, when he was hired as coach.

Afghan pullout has US spies reorienting in terrorism fight

WASHINGTON (AP): The thousands of interprettwo-decade war in Afghanistan has given U.S. spies a perch for keeping tabs on terrorist groups that might once again use the beleaguered nation to plan attacks against the U.S. homeland. But that will end soon.

The withdrawal of U.S. troops from Afghanistan is leaving intelligence scrambling agencies for other ways to monitor and stop terrorists. They'll have to depend more on technology and their allies in the Afghan government — even as it faces an increasingly uncertain future once U.S. and NATO forces depart.

"You may not be blind, but you're going to be legally blind," said Rep. Mike Waltz, a Florida Republican and Green Beret who served in Afghanistan. Waltz said in an interview that while he believed American forces would still be able to detect threats, they would have to respond with lesser intelligence and more complex operations from bases outside the country.

The Afghanistan withdrawal was ordered by President Joe Biden. He has said it's time to end America's longest war after two decades of a conflict that killed 2,200 U.S. troops and 38,000 Afghan civilians, with a cost as much as \$1 trillion.

But that withdrawal comes with many uncertainties as a resurgent Taliban captures ground and fears mount that the country could soon fall into civil war. The U.S. is still working on agreements to base counterterrorism forces in the region and evacuate

CIA Director William Burns testified in April that fighters from al-Oaida and the Islamic State group are still operating in Afghanistan and "remain intent on recovering the ability to attack U.S. targets."

"When the time comes for the U.S. military to withdraw, the U.S. government's ability to collect and act on threats will diminish. That's simply a fact." Burns said. He added that the CIA and other U.S. agencies "retain a suite of capabilities" to monitor and stop

Burns made a secret visit to Afghanistan in April and reassured Afghan officials that the U.S. would remain engaged in counterterrorism efforts, according to two officials familiar with the visit.

The CIA and Office of the Director of National Intelligence declined to comment for this story.

The CIA has had a role in Afghanistan for more than 30 years, dating back to aiding rebels fighting the Soviet Union from 1979 to 1989. During the U.S. war, it is said to have carried out strikes against terror targets and trained Afghan fighters in groups known as Counter Terrorism Pursuit Teams. Those teams are feared by many Afghans and have been implicated in extrajudicial killings of

civilians. The Associated Press reported in April that the CIA was preparing to turn over control of those teams in six provinces to the Afghan intelligence



service, known as the National Directorate of Security. The closure of posts near Afghanistan's borders with Iran and Pakistan will make it harder to monitor hostile groups operating in those areas, and the withdrawal of Americans from Afghan agencies could worsen already troubling problems with corruption, experts said.

Washington has long struggled to gather intelligence even from its allies in Afghanistan. In the early years of the conflict, the U.S. was drawn into rivalries that resulted in targets that were driven by score-settling among factions in the country.

Retired Lt. Gen. Robert Ashley, who led the Intelligence Defense Agency from 2017 to 2020, said U.S. authorities may be able to replace some of their lost footprint with intercepted communications as well as publicly available information posted online, particularly with the growth of cellphone networks compared with the 1990s. And while Afghan forces have faltered against the Taliban, they can also provide valuable information, Ashley said.

"We shouldn't discount their ability to understand their ground truth," said Ashley, now an adjunct senior fellow at the Center for a New American Security. "It's their nature, it's their culture, it's their language."

Former intelligence officials and experts noted that the CIA and other agencies already have to work without a military presence in other countries where militant groups threaten Americans.

Rep. Jason Crow, a Colorado Democrat and former Army Ranger who served in Afghanistan, said human sources in Afghanistan were already limited and the U.S. has monitoring capabilities today that it didn't have two decades ago.

"It's still going to be very robust," Crow said. "When you don't have boots on the ground, it's certainly more challenging, but we have capabilities and things that allow us to meet that challenge. It just becomes a little more difficult."

Crow and

Waltz

are among a bipartisan group of lawmakers who have pushed the White House to quickly process visas for thousands of interpreters and other Afghans who helped American forces. More than 18,000 applications are pending. Senior U.S. officials have said the administration plans to carry out an evacuation later this summer but has not settled on a country or countries for what would likely be a temporary relocation.

Failing to protect Afghans waiting for visas could have "a huge chilling effect on people working with us going forward," Waltz said.

Analysts differ on what to expect from the Taliban if it were to consolidate control over the country. The Office of the Director of National Intelligence reported in May that the Taliban's "desires for foreign aid and legitimacy might marginally moderate its conduct over time," driven in part by international attention and the proliferation of phones.

But Colin Clarke, director of policy and research at the Soufan Group, said he expected the Taliban to continue harboring al-Qaida and worried of a possible insurgency that could embolden extremists and become a regional conflict similar to what happened in Iraq after the American withdrawal there

"I want us to pull out of Afghanistan in theory and be safe," he said. "That's just not from my analysis what's going to happen."

At least 19 missing as mudslide west of Tokyo hits houses

Токуо, Jul 3 (AP): A fighters and police in the powerful mudslide carrying a deluge of black water and debris crashed into rows of houses in a town west of Tokyo following heavy rains on Saturday, leaving at least 19 people missing, officials said.

Dozens of homes may have been buried in Atami, a town known for hot springs. said Shizuoka prefecture spokesman Takamichi Sugiyama.

Public broadcaster NHK gave the number of missing people at 20, but Sugiyama said the prefecture confirmed at least 19, although he said the number may grow.

Torrential rains have slammed parts of Japan starting earlier this week. Experts said dirt had been loosened, increasing landslide risks in a country filled with valleys and mountains.

Sugiyama said it had been raining hard in the area all morning. Self-defense forces will join firerescue operation, he added. Evacuation warnings were issued for a widespread area.

The landslides appeared to have struck multiple times, about as fast as a car.

Footage showed a powerful, black mudslide slide down a mountainside, knocking down and crushing houses and sweeping away cars in its way

Helpless neighbours watched in horror, some recording on their phones.

NHK TV footage showed a part of a bridge had collapsed.

Atami is a quaint seaside resort area in prefecture. Shizuoka about 100 kilometers (60 miles) southwest of Tokyo.

The area that was hit by the mudslide, Izusan, includes hot springs, residential areas, shopping streets and a famous shrine.

Matsuyama tests positive for COVID-19, withdrawn in Detroit

DETROIT, JUL 3 (AP): Masters champion Hideki Matsuyama was withdrawn from the Rocket Mortgage Classic after testing positive for COVID-19.

The PGA Tour made the announcement Friday just before Matsuyama was scheduled to start his second round. Tour officials were unable to say whether Matsuyama has been vaccinated. The PGA Tour, though, does not test fully vaccinated players.

I will take all the necessary precautions to ensure the health and safety of all others, he said in a statement.

I appreciate and look forward to full recovery and returning to competition as soon as possible.

Matsuyama shot an even-par 72 on Thursday, playing with PGA Championship winner Phil Mickelson and Rickie Fowler.

Mickelson and Fowler were informed of Matsuyama's positive test shortly before they began play Friday. According to the PGA Tour's COVID-19 protocols, Mickelson and Fowler were not subject to contact tracing.

Iran's sole nuclear power plant up and running after closure

TEHRAN, IRAN (AP): Iran's sole nuclear power plant is back online following an emergency shutdown two weeks ago, state TV reported Saturday.

The report quoted MostafaRajabiMashahdi, spokesperson for the country's energy ministry, as saying the Bushehr plant "returned to production energy" after the completion of needed maintenance.

Mashahdi did not elaborate but last week, Iran's nuclear department said engineers were working to repair the plant's broken generator.

Authorities earlier this year had warned of Bushehr's possible clo-

sure because of American sanctions barring Iran from procuring equipment for repairs. Bushehr is fueled

by uranium produced in Russia, not Iran, and is monitored by the United Nations' International Atomic Energy Agency. The IAEA acknowledged being aware of reports about the plant, but declined to comment. Construction

on Bushehr, on the coast of the northern reaches of the Persian Gulf, began under Iran's shah in the mid-1970s. After the 1979 Islamic Revolution, the plant was repeatedly targeted in the Iran-Iraq war. Russia later completed construction of the facility.

The 1,000-megwatt plant feeds the grid with enough energy for a tiny part of Iran's nationwide 64,000-megawatt consumption.

In the U.K., cases of the delta variant have increased fourfold in less than a month, with confirmed cases Friday up 46% on the previous week.

Portuguese health authorities this week reported a vertiginous rise in the prevalence of the delta variant, which accounted for only 4% of cases in May but almost 56 per cent in June. The country is reporting its highest number of daily cases since February, and the number of COVID-19 patients in hospitals has surpassed 500 for the first time since ear-

ly April.

Reports of new infections in Russia more than doubled in June, topping 20,000 per day this week, and deaths hit 679 on Friday, the fourth day in a row that the death toll set a daily record.

Still, no one wants any lockdowns, said spokesman Kremlin Dmitry Peskov at a briefing, although he admitted that the virus situation in a number of Russian regions is

In some countries, the virus is spreading much faster among younger people. In Spain, the national 14day case notification rate per 100,000 people rose to 152 on Friday. But for the 20-29 age group, it shot up to

numbers have triggered alarm across the continent.

The Dutch government is extending its vaccination programme to those aged 12-17 to help head off a feared new surge. Greece is offering young adults 150 euros (177) in credit after their first jab. Rome authorities are mulling the use of vans to vaccinate people at the beach. And Poland last week launched a

lottery open only to adults who are fully vaccinated, with new cars among the prizes.

Portuguese authorities have extended the hours of vaccination centers, created new walk-in clinics, called up armed forces personnel to help run operations, and reduced the period between taking the two doses of the AstraZeneca vaccine from 12 weeks to eight weeks.

We're in a race against the clock, Cabinet Minister Mariana Vieira da Silva said.

In the fight against vaccine hesitancy across Europe, the appearance of variants has fed public uncertainty about how effective the shots are.

Madrid this week, Claudia Aguilar, a 58-year-old archaeologist, got her second Pfizer-BioNTech jab at an auditorium that is expanding its working hours overnight.

Some 40,000 fans went to England's European Championship soccer match against Germany at London's Wembley Stadium last week. In Portugal, new restrictions have been half-hearted, such as limiting restaurant opening hours on weekend nights.

In Moscow, however, restaurants, bars and cafes on Monday began admitting only customers who have been vaccinated, have recovered from COVID-19 in the past six months or can provide a negative test in the previous 72 hours.

France lifted the last of its major restrictions Wednesday, allowing unlimited crowds in restaurants, at weddings and most cultural events despite fast-rising cases of the delta variant. Tiago Correia, an

associate professor at Lisbon's Institute of Hygiene and Tropical Medicine, detects a mood of public impatience, especially among young people keen to enjoy warm summer nights.


People want to return to normal more quickly than the vaccination rollout is happening, he said.

The emerging variants have shone a light on the unprecedented scale of the immunisationprogrammes. The ECDC says that in the countries it surveys, 61 per cent of people over 18 have had one shot and 40 per cent are completely vaccinat-

But Dr Hans Kluge,

the head of the WHO's Europe office, cautioned this week that the delta variant is poised to become dominant by August in the 53-country region his office covers. And he notes that some 63 per cent of people in that region haven't had a first jab.

The three conditions for a new wave of excess hospitalizations and deaths before the (fall) are therefore in place: New variants, deficit in vaccine uptake, increased social mixing, Kluge said.

British newspaper that accused him of domestic violence, with a judge ruling the allegations were "substantially correct." In March, a British court refused Depp permission to appeal the ruling that he assaulted Heard, saying his attempt to overturn the decision had "no real prospect of success."

Depp also is suing Heard for \$50 million in Virginia over a Washington Post op-ed essay that she wrote about domestic violence. The trial in that case was recently delayed until April 2022.

Vanessa Williams to honor Juneteenth at July 4 festivities

NEW YORK (AP): When Vanessa Williams hosts this year's televised Capitol Fourth celebration, she will not only honor the nation's traditional independence day, but also the country's newly designated holiday — Juneteenth.

Williams, who was the first Black woman to be crowned Miss America, will sing "Lift Every Voice and Sing," which has

served as the Black National Anthem. "It's in celebration of the wonderful opportunity that we now have to celebrate Juneteenth. So we are reflective of the times," she told the Associated Press on Thursday while promoting this year's show.

Juneteenth commemorates the emancipation of African American slaves and has been celebrated annually on June 19 in various parts of the United States. It was made a federal holiday this year.

"A Capitol Fourth" is marking 41 years on the air. The show is broadcast to millions of viewers on PBS and streaming platforms as well as troops around the globe. Williams serves as host this year but it's not be the first time that she's brought current social changes to the festivities. At last

year's show, Williams said her musical selections expressed the angst that Black women — especially mothers — were feeling. She sang the Stephen Sondheim song, "Not While I'm Around," from his musical "Sweeney Todd," an attempt to commu-
