### Active cases drop to 326 in Sikkim

**SUMMIT REPORT** GANGTOK, 08 OCT:

The number of active Covid cases in Sikkim declined further to 326 on Friday with 74 new recoveries recorded in the past 24 hours. The count of fully recovered cases in Sikkim now stands at 30,606 and the state boasts a recovery rate of 97.7%.

The recovery rate will keep improving from hereon given that most of the Covid-positive people on their way to recovery under home or facility isolation and hospitalization is very low. There were only three new hospitalizations among Covid patients yesterday and there are five in ICU.

What is more, Covid fatalities have also reduced substantially and the State has now gone five days without any Covid deaths and the toll holds steady at 388.

On continuing positive note, Sikkim's daily test positivity rate continues to remain sub-5 and came in at 4.9% today with 33 of the 673 samples screened yesterday testing positive.

As per the Daily Report of COVID-19 in Sikkim issued by the Integrated Disease Surveillance Programme of the Health Department this morning, while 18 cases were detected in RT-PCR testing of 254 samples, 15 others tested positive in rapid antigen testing of 418

samples. Of the 33 new cases in the State, 21 were reported in East District, six in West District and six in South.

The State's tally of confirmed cases of CO-VID-19 detected in the State since testing began on 28 Feb, 2020, stands at 31.636.

Meanwhile, the State

administered 4,258 doses of Covishield on Thursday. While 4,050 completed their vaccination schedule with the second dose yesterday, 208 received their first dose.

4,05,946 people in Sikkim are now fully vaccinated.

There can never be **I** enough awareness about a problem which has fooled not just the internet-ignorant but also a chief accountant and a whole crowd of engineers and teachers. Yes, cyber-cons are back in the news, and South Sikkim Police undertook another attempt at getting people to see the scam behind obviously fraudulent ways to profit and organized an awareness programme on cyber-security at Panchsheel Bhawan in

Jorethang today. The problem is very real in Sikkim, and the victims, unlike suspected, are not just "illiterate, innocent" people from the villages.

The 'Sikkim Against Fraud Action Initiative' is into its second week now. Nayabazar Jorethang Nagar Panchayat chairperson, Pabitra Manav, was present as chief guest for the programme attended by students, teachers, businesspersons, drivers, and others.

PI Neeraj Khatiwada SHO of Jorethang Police Station, Cyber Specialist Dr Palchen Sherpa, and

representatives from RBI were also present as resource persons.

The South District Cyber Cell covered topics like online shopping frauds, social media ethics of responsible netizens, preventive action and redressal to online banking frauds.

The problem has become so acute in the district, which incidentally set up a cyber crimes cell recently, that police here has a 'Cyber Security Awareness Month' underway at present. #### Solar fencing introduced to curb wildlife raids in West and North Sikkim



#### **SUMMIT REPORT** GANGTOK, 08 OCT:

To address the issue of human-wildlife conflict solar fencing was undertaken by WWF-India, Sikkim, under the UNDP-SECURE Himalaya Project of the Forest and Environment Department, a press release informs.

Fencing work has been completed along private farmlands in two villages which had high conflict with wild animals. Chongri village in West Sikkim is located right on the boundary of Khangchendzonga National Park and has seen farms raided by barking

deer, wild boars, and porcupines. Bitchu village in Lachung, North Sikkim, has the Himalayan Black Bear as the main "conflict animal."

At both these villages, the main routes used by wild animals to come into the farmland were identified for fencing. The fencing covers an area of around 0.2 hectares on three sides of the two villages.

These sites were selected after meetings with owners of the farmlands, Forest Department and UNDP- SECURE Himalaya Project Officials and based on Human

Wildlife Conflict Assessment conducted as part of the SECURE Himalaya project by ATREE, the release informs.

The entire solar fencing work was carried out by local youth from Talkharka village in East Sikkim, Sewan Rai and Navin Rai along with WWF-India Team, Pemba Tshering Bhutia and Rikchen Zimba. These youth were trained by WWF-India as part of an earlier intervention in Talkharka for Human Wildlife Conflict management.

Sewan Rai mentioned that the earlier pilot conducted at Talkharka had proved beneficial for the communities with a reduction in crop-loss due to wild animals such as porcupines and barking deer. They were happy to have received the opportunity to expand the solar fencing initiative to other villages that were also suffering from the same challenges.

The surge in international oil prices ended a three-week hiatus in rates on September 28 for petrol and September 24 for diesel.

Since then, diesel rates have gone up by Rs 3.5 paise per litre and petrol price has increased by Rs 2.35.

Prior to the July/August price cuts, the petrol price was increased by Rs 11.44 a litre between May 4 and July 17. Diesel rate had gone up by Rs 9.14 during this period.

### Nobel Peace Prize awarded to journalists Maria Ressa, Dmitry Muratov

OSLO, 08 OCT [AFP]: The Nobel Peace adverse conditions," she said. Prize was on Friday awarded to journalists Maria Ressa of the Philippines and Dmitry Muratov of Russia for their fight for freedom of expression

in their countries. The pair were honoured "for their efforts to safeguard freedom of expression, which is a precondition for democracy and lasting peace," said the chairwoman of the Norwegian Nobel Committee, Berit Reiss-Andersen.

"They are representatives of all journalists who stand up for this ideal in a world in which democracy and freedom of the press face increasingly

Ressa, 58, told Norwegian TV2 she was "shocked" and "emotional" to receive the honour, which she said would give her and her colleagues "tremendous energy to continue the fight.'

In 2012, Ressa co-founded Rappler, a digital media company for investigative journalism, which she still heads, while Muratov is one of the founders of the independent newspaper Novaya Gazeta.

Rappler has "focused critical attention on the Duterte regime's controversial, murderous anti-drug campaign," Reiss-Andersen said.

"The number of deaths is so high that the campaign resembles a war waged against the country's own population," Reiss-Andersen said.

Ressa and Rappler have also documented how social media is being used to spread fake news, harass opponents and manipulate public dis-

Ressa, a former CNN correspondent who also holds US citizenship, is currently on bail pending an appeal against a conviction last year in a cyber libel case, for which she faces up to six years in prison. Muratov, 59, has

defended freedom of speech in Russia for decades, under increasingly challenging conditions.

In 1993, he was a founder of Novaya Gazeta, which has a "fundamentally critical attitude towards power" the committee said. He has been its

editor-in-chief since 1995. Novaya Gazeta's opponents have responded with harassment, threats, violence and murder.

Since the newspaper's start, six of its journalists have been killed, including Anna Politkovskaya who wrote revealing articles on the war in Chechnya.

"Despite the killings and threats, editor-in-chief Muratov has refused to abandon the newspaper's independent policy," Reiss-Andersen said.

"He has consistently defended the right of journalists to write anything they want about whatever they want, as long as they comply with the professional and ethical standards of journalism."

Free, independent and fact-based journalism helps protect against abuse of power, lies and war propaganda, Reiss-Andersen said.

"Without freedom of expression and freedom of the press, it will be difficult to successfully promote fraternity between nations, disarmament and a better world order to succeed in our time," Reiss-Andersen said.

Media watchdogs had been tipped as contenders for the prestigious prize ahead of Friday's announcement.

Last year, the honour went to the UN's humanitarian agency fighting famine, the World Food Programme (WFP).

The award's image has been hit hard over the past years as one of its previous laureates, Ethiopian Prime Minister Abiy Ahmed, became embroiled in a war. Another, Myanmar's Aung San Suu Kyi, was accused of defending the massacre of members of the Rohingva minority.

The prize -- consisting of a diploma, a gold medal and a cheque for 10 million kronor (980,000 euros, \$1.1 million) -- is traditionally awarded on December 10, the anniversary of the 1896 death of prize creator Alfred Nobel.

The Peace Prize is the only Nobel to be awarded in the Norwegian capital.

However, it is not yet known whether Ressa and Muratov will be able to travel to Oslo to pick up the award, due to the pandemic.

The Nobel Institute in Oslo is due to decide in the coming days whether to hold its ceremony online or in person.

Next week, the Nobel season wraps up on Monday with the announcement of the Economics Prize.

After the installa-

tion, training was also imparted to the owners of the farmland on basic maintenance and monitoring of the same. Close monitoring results on the conflict post installation of the fence would be an important data to understand the impact of solar fencing, based on same the fencing work can be scaled up in future. WWF- India has been working with communities and the relevant departments to manage conflict and reduce the income loss suffered by farmers.



There is nothing related to the NBA that would cause a player to have that designation. Unless Irving is vaccinated, he would have to miss the Nets' 41 home games and their two road games against the New York Knicks.

#### Small, Marginal and Ignored

The real farmers of Sikkim need some real engagements

Co, as per the Agriculture Census of 2010-11, there Were 74,928 farmers in Sikkim. It is anybody's guess whether this number has grown or fallen in the eight years since because at least as far as officials in departments which work with farmers, such matters as data, planning or preparation do not command much priority. The number of farmers, it appears, has been worked out from the number of land-holdings in the State and that offers some interesting insights. While the overall number of farmers in the State appears robust, when one break it down to how much land individual farmers have access to for cultivation, the bubble bursts. 40,476 of the farmers, 54% of the total lot, till barely 14% of the landholdings, managing with less than a hectare of farmland. This, in official records, makes them "small farmers". Next, 23% of the farmers have landholdings between one to two hectares making them "marginal farmers" in official records. Small and marginal farmers, accounting for 76% of the landholdings, possess only 33% of the agricultural land. The top-level, those with farming tracts of more than 4 hectares, count barely 780 (1.04% of the total number of farmers) but occupy 11.53% of the total arable land. The biggest portion of land available for agriculture in Sikkim, 55.46% of the landholding area, sits in the hands of big landholders owning between 2 to 4 hectares; there are 16,731 of them, roughly 22% of the farmers in Sikkim.

Of course, not everyone who "owns" farming land is a farmer, and very few, if any, of the two hectares and above owning "farmers" are actually hands-on agriculturists. What is clear is that agriculture and horticulture production in the State relies on the 76% small and marginal farmers of Sikkim who possess an average of 0.61 hectares. As their classification as "small and marginal" suggests, they are also ones most at risk of exploitation and short-changing by middlemen since they are also more at risk of suffering due to the vagaries of weather patterns. Any price support mechanism or addition of value to their produce would hence go a long way towards alleviating their condition. In this regard, the Organic Mission was best suited for them because it offered them an opportunity to earn more their small fields. That would have required more than awareness camps on organic farming, they already know how to do that rather well except perhaps the bureaucratic procedures of getting organic certification. What they required with convincing that that organic route would fetch them higher returns, and for that they needed more focused marketing assistance instead of being talked down upon by service providers how good organic farming was for people's health and Sikkim's environment. That marketing support has been sorely lacking. Is still lacking despite the monopoly extended to them by the ban on non-organic farm produce in Sikkim.

What should also have arrived alongside the Organic push was credit support for them to revitalize their farms and invest in their handkerchief size landholdings (because accept it, 0.61 hectares is not much farmland to work with). It would have been desired that credit support formed an integral part of the Organic Mission and increased alongside the mission engagement to make Sikkim organic. Unfortunately, that did not happen either. The State Focus Paper 2018-19 for Sikkim prepared by NABARD as a bank credit projection for the State reveals that credit flow to the agriculture sector has been low and erratic over the past three years. Banks achieved only 22.36% of the projected target for credit to agriculture in 2014-15, improved it dramatically to 40.87% of the target in 2015-16 and then collapsed to 15.37% in 2016-17. To get a perspective, here are some numbers- against Rs 16,725 lakh projected by NABARD for credit to agriculture in Sikkim, the banks released only Rs 3,739 lakh in 2014-15. Undeterred by this shortfall, NABARD projected a target of Rs 19,901 lakh for agriculture in 2016-17. The banks responded by releasing even less than the credit they had provided in 2014-15 and released only Rs 3,058 lakh by way of loans in 2016-17. Even factoring in the over-ambitious ideal-situation enthusiasm of such projections, concerned officials still expect at least 40% achievement of targets. Instead, banks in Sikkim gave agriculture 22%, 41% and 15% achievement over the past three years. Apart from disinterest among the banks, there were clearly no efforts at coordination by the State's agencies either. In contrast, industries received 241% of the projected credit potential in 2014-15 and even in 2016-17 received a handsome 60% of the projected credit flow for the sector. Housing and transport sector were also favoured by banks and maintained a high 70's percentage till 2016 which dipped to 51% in 2016-17, a drop perhaps forced by the demonetization experiment.

The point being made here is that Sikkim's small and marginal farmers need special attention, not romanticizing but some real engagements which address their issues and not just the requirements of everyone else who claims to be working for them.

#### Facebook whistleblower Frances Haugen testified that the company's algorithms are dangerous – here's how they can manipulate you

 ${f F}$  ormer Facebook product manager Frances Haugen testified before the U.S. Senate on Oct. 5, 2021, that the company's social media platforms "harm children, stoke division and weaken our democracy."

Haugen was the primary source for a Wall Street Journal exposé on the company. She called Facebook's algorithms dangerous, said Facebook executives were aware of the threat but put profits before people, and called on Congress to regulate the company.

Social media platforms rely heavily on people's behavior to decide on the content that you see. In particular, they watch for content that people respond to or "engage" with by liking, commenting and sharing. Troll farms, organizations that spread provocative content, exploit this by copying highengagement content and posting it as their own, which helps them reach a wide audience.

As a computer scientist who studies the ways large numbers of people interact using technology, I understand the logic of using the wisdom of the crowds in these algorithms. I also see substantial pitfalls in how the social media companies do so

FROM LIONS ON THE SAVANNA TO LIKES ON **FACEBOOK** 

The concept of the wisdom of crowds assumes that using signals from others' actions, opinions and preferences as a guide will lead to sound decisions. For example, collective predictions are normally more accurate than individual ones. Collective intelligence is used to predict financial markets, sports, elections and even disease outbreaks.

Throughout millions of years of evolution, these principles have been coded into the human brain in the form of cognitive biases that come with names like familiarity, mere exposure and bandwagon effect. If everyone starts running, you should also start running; maybe someone saw a lion coming and running could save your life. You may not know why, but it's wiser to ask questions

Your brain picks up clues from the environment - including your peers - and uses simple rules to quickly translate those signals into decisions: Go with the winner, follow the majority, copy your neighbor. These rules work remarkably well in typical situations because they are based on sound assumptions. For example, they assume that people often act rationally, it is unlikely that many are wrong, the past predicts the future, and so on.

Technology allows people to access signals from much larger numbers of other people, most of whom they do not know. Artificial intelligence applications make heavy use of these popularity or "engagement" signals, from selecting search engine results to recommending music and videos, and from suggesting friends to ranking posts on news feeds.

NOT EVERYTHING VIRAL DESERVES TO BE

Our research shows that virtually all web technology platforms, such as social media and news recommendation systems, have a strong popularity bias. When applications are driven by cues like engagement rather than explicit search engine queries, popularity bias can lead to harmful unintended consequences.

Social media like Facebook, Instagram, Twitter, YouTube and TikTok rely heavily on AI algorithms to rank and recommend content. These algorithms take as input what you like, comment on and share - in other words, content you engage with. The goal of the algorithms is to maximize engagement by finding out what people like and ranking it at the top of their feeds.

On the surface this seems reasonable. If people like credible news, expert opinions and fun videos, these algorithms should identify such high-quality content. But the wisdom of the crowds makes a key assumption here: that recommending what is popular will help high-quality content "bubble up."

We tested this assumption by studying an algorithm that ranks items using a mix of quality and popularity. We found that in general, popularity bias is more likely to lower the overall quality of content. The reason is that engagement is not a reliable indicator of quality when few people have been exposed to an item. In these cases, engagement generates a noisy signal, and the algorithm is likely to amplify this initial noise. Once the popularity of a low-quality item is large enough, it will keep getting amplified.

Algorithms aren't the only thing affected by engagement bias – it can affect people too. Evidence shows that information is transmitted via "complex contagion," meaning the more times people are exposed to an idea online, the more likely they are to adopt and reshare it. When social media tells people an item is going viral, their cognitive biases kick in and translate into the irresistible urge to pay attention to it and share it.

**NOT-SO-WISE CROWDS** 

We recently ran an experiment using a news literacy app called Fakey. It is a game developed by our lab that simulates a news feed like those of Facebook and Twitter. Players see a mix of current articles from fake news, junk science, hyperpartisan and conspiratorial sources, as well as mainstream sources. They get points for sharing or liking news from reliable sources and for flagging low-credibility articles for fact-checking.

We found that players are more likely to like or share and less likely to flag articles from lowcredibility sources when players can see that many other users have engaged with those articles. Exposure to the engagement metrics thus creates a

The wisdom of the crowds fails because it is built on the false assumption that the crowd is made up of diverse, independent sources. There may be several reasons this is not the case.

First, because of people's tendency to associate with similar people, their online neighborhoods are not very diverse. The ease with which social media users can unfriend those with whom they disagree pushes people into homogeneous communities, often referred to as echo chambers.

Second, because many people's friends are friends of one another, they influence one another. A famous experiment demonstrated that knowing what music your friends like affects your own stated preferences. Your social desire to conform distorts your independent judgment.

Third, popularity signals can be gamed. Over the years, search engines have developed sophisticated techniques to counter so-called "link farms" and other schemes to manipulate search algorithms. Social media platforms, on the other hand, are just beginning to learn about their own vulner-

People aiming to manipulate the information market have created fake accounts, like trolls and social bots, and organized fake networks. They have flooded the network to create the appearance that a conspiracy theory or a political candidate is popular, tricking both platform algorithms and people's cognitive biases at once. They have even altered the structure of social networks to create illusions about majority opinions.

DIALING DOWN ENGAGEMENT

What to do? Technology platforms are currently on the defensive. They are becoming more aggressive during elections in taking down fake accounts and harmful misinformation. But these efforts can be akin to a game of whack-a-mole.

A different, preventive approach would be to add friction. In other words, to slow down the process of spreading information. High-frequency behaviors such as automated liking and sharing could be inhibited by CAPTCHA tests, which require a human to respond, or fees. Not only would this decrease opportunities for manipulation, but with less information people would be able to pay more attention to what they see. It would leave less room for engagement bias to affect people's deci-

It would also help if social media companies adjusted their algorithms to rely less on engagement signals and more on quality signals to determine the content they serve you. Perhaps the whistleblower revelations will provide the necessary impetus.

### Squid Game: the real debt crisis shaking South Korea that inspired the hit TV show

quid Game is anything but your **J**typical, saccharine, soft-glow Korean television drama. In this biting commentary on life in South Korea today, viewers are presented with a twisting, technicolour story of violence, betrayal and desperation. All of this is set around a series of macabre games in which players literally fight to the death. Despite its brutal content, the show has captivated audiences globally, becoming Netflix's top show in at least 90

The drama takes viewers on a high-suspense ride across nine episodes where a group of people mired in debt and personal misfortune enter a series of six survival games, modelled on familiar South Korean children's games. The losers will die by a ruthless process of elimination, and the single winner will take away 46.5 billion South Korean won (around £29 million).

Early episodes show the circumstances that have led central characters to place everything on the line. Audiences see a series of very different lives, but each is mired in debt and misery. A man who was made redundant and then indebted by failed business ventures and gambling is joined by an unsuccessful fund manager. An elderly man dying of cancer plays the game alongside a North Korean defector. A Pakistani migrant worker and a gangster, along with hundreds of other equally hapless individuals who have fallen foul of South Korean capitalism, gamble it all.

Squid Game adds to other recent dren. In August, the South Korean at the time.

South Korean screen productions, most notably the 2020 Oscar-winning film Parasite, in providing a sharp critique of the socio-economic inequality that plagues the lives of many in South Korea. More specifically, it speaks to the deepening household debt crisis affecting the lower and middle classes.

SOUTH KOREA'S STRUGGLE WITH HOUSEHOLD DEBT

Household debt in South Korea has risen sharply in recent years to over 100% of its GDP – the highest in Asia. The top 20% of earners in the country have a net worth 166 times that of the bottom 20%, a disparity which has increased by half since 2017.

There has been rising debt relative to income and a recent hike in interest rates. This has left those who lack the resources to deal with unplanned events, such as a sudden redundancy or a family illness, in an even more precarious position.

The Gini Index measuring national wealth distribution puts South Korea roughly on par with the UK and in a better position than the US. However, growing youth unemployment, soaring house prices and the global pandemic have reversed the modest reduction in inequality experienced in recent years under the progressive Moon Jae-in Government.

It's not just families that are putting themselves in debt to pay for housing and education costs - an essential expense for middle classes hoping to secure entry to a desirable university for their chil-

government announced new lending curbs aimed at bringing down debt among vounger people. Millennials and those in their 30s are in the most debt relative to their

But attempts to curb borrowing have led to some people turning to higher cost and higher risk lenders instead. Such a choice leaves many at the mercy of debt collectors if the slightest change in their circumstances causes them to default on repayments. While few may find themselves in the hands of gangsters threatening to harvest their organs for sale, as shown in Squid Game, the burden of overwhelming debt is a deepening social problem - not to mention the leading cause of suicide in South Korea.

PLAYERS, WINNERS AND LOS-

Squid Game's inclusion of other characters representative of South Korea's disadvantaged minorities highlights the consequences of socio-economic inequality for these groups also. A factory employer's callous exploitation of a migrant worker who is forced to enter the game is representative of the barriers to upward mobility for those from south and south-east Asia. North Korean defectors feature too, as individuals who must fight on many fronts to achieve both financial stability and social inclusion.

The show mocks Christianity repeatedly expressing the growing turn in opinion of South Korea's rapid development during the 1970s and 1980s and its connection with the growth of the church

The supposed Protestant work ethic was a cornerstone of South Korea's authoritarian-era economic "miracle", during which three decades of ambitious economic plans transformed the country into a high income economy. Throughout this time, worldly success was seen as a sign of blessing and mega-churches were booming.

However, corruption rife among politicians and chaebol (conglomerate) families who served as church elders while embezzling funds and building their private empires. Unsurprisingly, disillusionment with some members of the political elite and the church has led many in an increasingly secular country to dispute the truth of Christianity's claim to serve the poor and oppressed in South Korea.

This is not a story unique to South Korea of course. Squid Game's characters, their troubles and their humanity resonate with the experiences of societies globally. Economies similar to South Korea are experiencing many of the same challenges, exacerbated by the ongoing pandemic.

Squid Game brutally reminds the winners of each stage, and the show's global audience, that those who succeed often do so at the expense of those who failed by way of weakness, discrimination, poor judgement, or just bad luck. The final episode hints at the possibility of a second series, but even if it doesn't continue, Squid Game makes it clear that the larger story it represents is far from over.



#### Odisha logs 524 fresh COVID-19 cases, 4 new fatalities



BHUBANESWAR, OCT 8 (PTI): Odisha on Friday registered 524 new CO-VID-19 cases including 75 children which took the state's caseload to 10,30,518 while four fresh fatalities pushed the coronavirus death toll to 8,238, a health department official said.

Though there has been significant improvement in the COVID-19 situation across the state, two coastal districts -Khurda and Cuttack -, continued to remain as points of concern as they together accounted for 62 per cent of the state's daily caseload.

Of the 524 new cases, Khurda and Cuttack reported 325 fresh infections, which is 62 per cent of the total cases reported during the day. While 306 cases were from quarantine centres, the remaining 218 were local contact cases.

Six districts - Bargarh, Boudh, Gajapati, Jharsuguda, Nabarangpur and Subarnapur - did not report any new cases, he said, adding that Boudh district is now COVID-19 Free as it has no active case. Odisha had registered 582 cases on Thursday and 593 on Wednesday.

The state's daily test positivity rate (TPR) was 0.78 per cent as 525 cases gave positive results from among 66,724 samples put for examination on Thursday. The TPR was 0.75% on Thursday, 0.82% on Wednesday, and 0.77% on Tuesday.

ment informed that with four fresh fatalities, one each from Cuttack, Nayagarh, Kandhamal and Sundergarh districts, the state's COVID-19 death toll mounted to 8,238. Odisha currently has

5,111 active COVID-19 cases while 10,17,116 patients including 522 on Thursday, recovered from the highly infectious disease.


The state has thus far conducted over 2.05 crore sample tests while its positivity rate stands at 5.02 per cent. Over 91.95 lakh people have so far been fully inoculated with double dose of COVID-19 vaccine.

Meanwhile, Odisha cautioned the people to remain alert for the next three months in order to prevent the transmission of the virus.

"October, November and December are crucial and people should avoid crowded places and unnecessary travel during this period," Director of Health Services, BijayMohapatra told reporters here.

### 18 ex-NBA players charged in \$4M health care fraud scheme

**NEW YORK (AP):** Eighteen former NBA players were charged Thursday with pocketing about \$2.5 million illegally by defrauding the league's health and welfare benefit plan in a scam that authorities said involved claiming fictitious medical and dental expenses.

"The defendants' playbook involved fraud and deception," U.S. Attorney Audrey Strauss told a news conference after FBI agents across the country arrested 15 explayers and one of their wives in a three-year conspiracy that authorities say started in 2017.

According to an indictment returned in Manhattan federal court, the ex-players teamed up to defraud the supplemental coverage plan by submitting fraudulent claims to get reimbursed for medical and dental procedures that never happened.

Strauss said prosecutors have travel records, email and GPS data that proves the ex-players were sometimes far from the medical and dental offices at the times when they were supposedly getting treated.

In one instance, she said, an explayer was playing basketball in Taiwan when he was supposedly getting \$48,000 worth of root canals and crowns on eight teeth at a Beverly Hills, California, dental office in December 2018.

The indictment said the scheme was carried out from at least 2017 to 2020, when the plan — funded primarily by NBA teams - received false claims totaling about \$3.9 million. Of that, the defendants received about \$2.5 million in fraudulent proceeds.

Strauss said each defendant made false claims for reimbursements that ranged from \$65,000 to

In a statement, the NBA called the allegations "particularly disheartening" because the benefit plans provided by the NBA and the



National Basketball Players Association are critically important to support players' health and wellbeing throughout their careers and post-retirement lives.

"We will cooperate fully with the U.S. Attorney Office in this matter," the statement added.

Michael J. Driscoll, the head of New York's FBI office, said the case demonstrated the FBI's continued focus on uncovering fraud scams that cost the health care industry tens of billions of dollars a year.

Strauss said the conspiracy was led by Terrence Williams, who began his career as a first-round NBA draft pick in 2009. The indictment said he submitted \$19,000 in fraudulent claims to the plan in November 2017 for chiropractic care. The claims led to a \$7,672 payout for Williams.

The indictment said he then recruited other former NBA players to defraud the plan and offered to provide fraudulent invoices from a chiropractor and dentist in Southern California and a wellness office in Washington state.

At least 10 of the ex-players paid kickbacks totaling about \$230,000 to Williams, according to the court papers. A lawyer who has represented Williams in the past declined to comment.

What was then the New Jersey Nets picked Williams as No. 11 in the 2009 draft. He went on to play with four franchises — the Nets, Boston, Houston and Sacramento — over four seasons as a role player, averaging 7.1 points per game. He was waived by Boston two days after his 26th birthday in 2013 and hasn't appeared in the league

Among others charged was Tony Allen, a six-time All-Defensive team selection and a member of the 2008 champion Boston Celtics. His wife was also indicted. Tony Allen was not in custody as of Thursday afternoon. The Memphis Grizzlies announced weeks ago that they plan to retire Allen's number at a Jan. 28 game versus the Utah Jazz.

For the most part, though, the ex-players charged had journeyman careers playing for several different teams and never reached anywhere close to the enormous stardom or salary that top players command.

Still, the 18 players combined to make \$343 million in their oncourt NBA careers, not counting outside income, endorsements or what any may have made playing

Strauss declined to speculate on their motivations or financial situations, saying to do so would go beyond the facts in the indict-

Another former player charged in the scheme was Sebastian Telfair, a one-time high school star in New York who was highly touted when he turned pro, though his NBA career with eight franchises never brought the stardom some had expected. Telfair's finances

qualified him for a court-appointed attorney at an appearance in Manhattan before a magistrate judge, who set bail at \$250,000, although Telfair was freed on his signature alone.

His lawyer, Deborah Colson, declined comment. Telfair, in running clothing and green sneakers, did not respond to requests for comment outside the courtroom, where Colson had entered a not guilty plea on his behalf.

Milt Palacio, one of those charged, was placed on administrative leave from his role as an assistant coach with the Portland Trail Blazers, the team said Thursday. The Blazers declined further comment "pending the outcome of the legal process."

Those charged also included three NBA champions besides Allen. Glen Davis was also part of that 2008 title team in Boston. Shannon Brown won two championships with the Los Angeles Lakers, and Melvin Ely won a title

with San Antonio in 2007. Among others who were charged, Anthony Wroten, Ruben Patterson and Darius Miles were the only players who averaged double figures in their NBA careers.

Arrests occurred in Washington state, California, New York, Alabama, Illinois, Florida, Nevada, Georgia and Tennessee.

All were charged with conspiracy to commit health care fraud and wire fraud, which carries the potential penalty of up to 20 years in prison.

Williams was also charged with aggravated identity theft, which carries a potential penalty of up to two years in prison.

Strauss said the charge was lodged because Williams tried to frighten a co-defendant into paying a kickback by impersonating an employee from the health plan's administrative manager, claiming there was an issue with an invoice that might require the co-defendant to pay back money he'd received.

It wasn't immediately clear who might represent any of the accused players other than Telfair in court or comment on their behalf.

There was no immediate response to efforts to contact Ely, Miles, or Patterson through attorneys or entities that have been associated with them, or to emails sent to possible addresses for the Allens. A person who answered the phone at the home of Ely's relatives said they were unaware of the case.

No working phone number or email address could immediately be found for Davis or Wroten. An email was sent to a possible address for Palacio.

The charges came just weeks after former NFL players Clinton Portis, TamarickVanover and Robert McCune pleaded guilty for their roles in a nationwide health care fraud scheme.

#### Hamilton leads from Verstappen in 1st Turkish GP practice



ISTANBUL (AP): Formula One champion Lewis Hamilton posted the fastest time ahead of title rival Max Verstappen in Friday's first practice session for the Turkish Grand Prix.

This season's narrow championship leader was .43 seconds ahead of the Red Bull driver in warm conditions. Ferrari's Charles Leclerc was .48 behind Hamilton in third spot with Hamilton's Mercedes teammate ValtteriBottas fourth.

There is a second practice later Friday at Istanbul Park.

Hamilton leads Verstappen by two points with seven races to go including this one.

But the Mercedes driver's lead could well be lost on Sunday as Hamilton starts the race with a 10-place grid penalty for going over his allocation of three engines for the season. Mercedes fitted a fourth combustion engine on Friday.

The Istanbul track proved much more reliable than last year, when it had just been re-laid to host an F1 race for the first time since 2011 and was far too slippery.

Drivers complained last year about the surface on the 5.3-kilometer (3.3-mile) course, with Verstappen comparing it to an ice rink. He placed sixth in that race after qualifying in second spot, while Hamilton rose from sixth on the grid to win and clinch a record-equaling seventh world title.

Red Bull is powered by Honda engines, but the Japanese manufacturer is pulling out of F1 at the end of 2021. In honor of Honda, both Red Bull and feeder team AlphaTauri have special liveries on their cars for this race, which replaced the Japanese GP after it was canceled because of coronavirus concerns.

The Red Bulls used a predominantly white livery, inspired by the Honda that American driver Richie Ginther powered to victory at the 1965 Mexican GP. Pierre Gasly and home favorite Yuki Tsunoda's Alpha Tauris had "Arigato" — Japanese for thank you — written on the rear wings.

Verstappen is a major threat to Hamilton's bid for an eighth world title to surpass Michael Schumacher and stand alone among F1 greats. He leads Hamilton 7-5 for wins this season and 7-3 for pole positions.

### FIFA plans to postpone Club World Cup until 2022

**LONDON (AP):** FIFA plans to postpone the Club World Cup until early next year due to hosting challenges linked to the pandemic, people familiar with the planning said.

Coronavirus restrictions led to Japan withdrawing from staging the seven-team tournament this December, and South Africa then abandoned a bid due to the need to get more of the country vaccinated. FIFA is now ex-

ploring staging the event in January or February, the people told The Associated Press. They spoke on condition of anonymgoing talks.

Qatar is an option like in February when Bayern Munich won the delayed 2020 edition in Doha — to help the Gulf nation test venues for the men's national teams' World Cup that starts in November 2022.

FIFA is already due to stage the Arab Cup competition in December in Qatar as part of World base, with Chelsea qualified as Champions League winners. It will disrupt a Premier League weekend for the west London club, as would have been the case if the tournament was contested as planned in December.

She was beaten 6-1, 2-6, 6-2 by KaterinaSiniakova, a three-time major doubles champion from Czech Republic. Siniakova teamed with countrywoman BarboraKrejcikova to win a gold medal in doubles at the Tokyo Olympics.

Clijsters, a 38-year-old Hall of Famer, also lost in the first round at the WTA Tour stop in Chicago last week. The four-time major champion and mother of three originally came back last year, but her attempt was interrupted by knee surgery last October and a bout with COVID-19 in January.

Clijsters committed nine double faults against Siniakova, who converted six of nine break points in the match. Clijsters received a wild-card into the tournament she won in 2005 and 2003. She was runner-up to Serena Williams in

BARCELONA, Spain (AP): Barcelona will play at another stadium for up to a year when the club Laporta said Friday.

Laporta said that he wants to begin the long-delayed overhaul of Camp Nou in the summer of 2022. He added that the work will last three to four years, but that the team will only need to find another home for a maximum of 12 months.

"We are considering different possibilities, but the strongest candidate is the Johan Cruyff Stadium," Laporta told Catalan radio Rac1 on Friday.

Johan Cruyff Stadium is where the women's team plays and forms part of the club's training complex on the outskirts of Barcelona.

With a capacity to seat only 6,000 spectators, Laporta said the club wants to increase that to 50,000 if the men's team plays there.

Another option, Laporta said, would be for the team to play at the city's Montjuic Stadium. The municipal facility hosted the opening ceremonies of the 1992 Summer Olympics and was home to Barcelona rival Espanyol for several years.

# Israel, Palestinian militants use bodies as bargaining chips

ABU DIS, WEST BANK (AP): More than a year after his son was killed by Israeli forces under disputed circumstances in the occupied West Bank, Mustafa Erekat is still seeking his remains.

It is one of dozens of cases in which Israel is holding the remains of Palestinians killed in conflict, citing the need to deter attacks and potentially exchange them for the remains of two Israeli soldiers held by the Palestinian militant group Hamas in the Gaza Strip.

The Palestinians and human rights groups view the practice of holding bodies as a form of collective punishment that inflicts further suffering on bereaved families.

"They have no right to keep my son, and it is my right for my son to have a good funeral," Erekat said.

The Jerusalem Legal Aid and Human Rights Center, a Palestinian rights group, says Israel is holding the bodies of at least 82 Palestinians since the policy was established in 2015. It says many are buried in secret cemeteries where the plots are only marked by plaques of numbers. Hamas holds the remains of the two Israeli soldiers killed during the 2014 Gaza war in an undisclosed location.

Last year, Israel's Security Cabinet expanded the policy to include the holding of the remains of all Palestinians killed during alleged attacks, and not just those connected to Hamas. Israel considers Hamas, which rules Gaza, a terrorist group.

Defense Minister Benny Gantz said at the time that holding the remains deterred attacks and would help ensure the return of Israeli captives



and remains. The Defense Ministry declined to comment on the policy.

One of the bodies is that of Erekat's son, Ahmed, who Israeli officials say was shot and killed after deliberately plowing into a military checkpoint in June 2020. Security camera footage shows the car veering into a group of Israeli soldiers and sending one of them flying back. Ahmed steps out of the car and raises one of his hands before he is shot multiple times and falls to the ground.

His family says it was an accident. Mustafa said his son was passing through the checkpoint on his way to the nearby city of Bethlehem to buy clothes for his sister's wedding later that night. The shooting attracted widespread attention, in part because Ahmed was the nephew of Saeb Erekat, a veteran Palestinian spokesman and negotiator who died last year.

Ahmed was to get married soon, his father said: "He had a house that was ready for him."

To this day, he has no idea where his son's remains are.

Omar Shakir, the Israel and Palestine director at the New York-based Human Rights Watch, said Israel has turned "corpses into bargaining chips." The policy is "deliberately and unlawfully punishing the families of the deceased, who are not accused of any wrongdoing," he said.

Israel has a long history of exchanging prisoners and remains with its enemies. In 2011, it traded more than 1,000 Palestinian prisoners for an Israeli soldier who had been captured by Palestinian militants five years earlier and was being held in Gaza.

In 2008, it traded five Lebanese prisoners, including a notorious militant, and the remains of nearly 200 Lebanese and Palestinians killed in fighting, for the remains of two Israeli soldiers captured by the Lebanese militant Hezbollah group two years earlier.

Egypt has been mediating negotiations over a similar agreement that would return the remains of the two soldiers, as well as two Israeli civilians believed to be alive, held by Hamas in Gaza.

In the meantime, the Erekats and other Palestinian families must turn to Israel's Supreme Court in a process involving multiple hearings that can drag on for years.

The court denied a recent appeal by the Erekats, citing confidential information submitted by the military. Mustafa Erekat says the system is rigged. He accused the court of dragging its feet until the policy on holding the remains was expanded and then relying on secret evidence.

Mohammed Aliyan, spokesman for six Palestinian families who filed a Supreme Court petition for the return of their relatives' bodies in 2016, said the judges initially sided with the families before an appeal from the military

They always go along with the military's demands," Aliyan told The Associated Press, "They are afraid to take any decision against them."

Liron Libman, an expert on military law at the Israel Democracy Institute, said there are situations where certain pieces of information can't be made public for fear of exposing protected sources or special operations.

"Each side has the right to request a postponement of the hearing, and the court will accept the request if it believes it is for a justifiable reason," Libman told the AP.

Even if a family's petition is successful, locating relatives' bodies for exhumation can pose further challenges, especially in cases when bodies were buried decades ago.

Rami Saleh, the director of Jerusalem Legal Aid and Human Rights Center, said his organization has dealt with cases where Israeli authorities were unable to locate bodies and also those where Palestinian family members needed to take DNA tests to confirm the remains of a relative.

Mustafa said he has not given up hope and intends to challenge the Supreme Court's decision. In the meantime, he and Aliyan, the spokesman for the other families, attend weekly sit-ins calling for the release of all bodies held by Israeli authorities.

"The feeling of not being able to bury your relative's body is more painful than their death," Aliyan said.

#### At flooded restaurant near Bangkok, the special is a splash



NONTHABURI, land (AP): A flood-hit riverside restaurant in Thailand has become an unlikely dining hotspot after fun-loving foodies began flocking to its waterlogged deck to eat amid the lapping tide.

Now, instead of empty chairs and vacant tables, the Chaopraya Antique Café is as full as ever, offering an experience the canny owner calls "hotpot surfing."

If you like your food washed down with plenty of water, this is the place for you.

Shortly after the water tops the parapet, the first diners arrive. Before long, the deck is crammed with carefree customers happily tucking in as if dining in a deluge is the norm.

The wait staff — some clad in rubber boots step gingerly through the swirl that quickly rises to more than 50 centimeters (20 inches).

The restaurant, in Nonthaburi near Bangkok, opened in February in a riverside location that perfectly complements its antique architecture and décor.

But a recent severe tropical storm and heavy monsoon rains combined to raise the river's water level. Add in the tides and the result has been daily inundation.

Coming straight after a monthslong coronavirus shutdown, it could have spelled disaster. Instead — boosted by

publicity in the Thai media — it's now so popular that customers need to make reservations.

"This is a great atmosphere. During this flood crisis this has became the restaurant's signature attraction. So I wanted to challenge myself and try out this new experience," 24-year-old SiripojWaiinta said as he munched his food with the water creeping up his shins.

The owner dubbed the experience "hot-pot surfing." When a passenger boat motors past you find out why. The delighted scramble to avoid a soaking from the wave is the moment everyone waits for, and with one passing every 15 minutes, no one goes home disappointed.

It's TV presenter TitipornJutimanon's first restaurant venture. He says he was worried what would happen when the floods came.

"It turns out the customers have a great reaction. They are happy. We can see the atmosphere of customers enjoying the experience of eating in the water. So a crisis has turned into an opportunity. It encourages us to keep the restaurant open and keep customers happy."

Best of all, he says, it means he can keep his staff happy by keeping them employed. So, even amid harsh economic times, the only thing that needs a bailout is the restaurant itself.

#### Finland joins other Nordic nations in curbing Moderna shots



COPENHAGEN, DENMARK (AP): Finland has joined other Nordic countries in suspending or discouraging the use of Moderna's COVID-19 vaccine in certain age groups because of an increased risk of heart inflammation, a rare side effect associated with the shot.

The Finnish Institute for Health and Welfare said Thursday that authorities won't give the shot to males under age 30. They will be offered the Pfizer/BioNTech vaccine instead. The government agency said it found that young men and boys were at a slightly higher risk of developing myocarditis.

The move by Finland followed similar decisions by three neighboring countries on Wednesday. Sweden suspended the use of Moderna for people under 30, Denmark said those under 18 won't be offered the Swiss-made vaccine, and Norway urged those under 30 to get the Pfizer vaccine instead. All four countries

based their decision on an unpublished study with Sweden's Public Health Agency saying that it signals "an increased risk of side effects such as inflammation of the heart muscle or the pericardium" the double-walled sac containing the heart and the roots of the main vessels. It added: "The risk of being affected is very small."

The preliminary information from the Nordic study has been sent to the European Medicines Agency's adverse reaction committee to be assessed.

### **Ireland buckles to pressure, joins global corporate tax deal**

**LONDON (AP):**Ireland has agreed to join an international agreement establishing a minimum corporate tax of 15% around the world, ditching the low-tax policy that has led companies like Google and Facebook to base their European operations in the country.

The Irish government, which initially rejected the agreement, said Thursday it had decided to join the Organization for Economic Cooperation and Development's global minimum tax accord after compromises that would protect the country's economic interests. Ireland's 12.5% corporate tax rate has been a cornerstone of the country's economic policy since 2003. The announcement came before a meeting Friday where representatives of 140 countries are expected to approve the agreement designed to ensure that multi-national corporations can't reduce their tax bills by shifting operations to low-tax jurisdictions. U.S. President Joe Biden has been one of the driving forces behind the agreement as governments around the world seek to boost revenue following the COVID-19 pandemic.

"I believe that the upsides of being in such a historic international agreement far outweigh the downsides of staying out," Finance Minister Paschal Donohoe said Thursday. "This is a difficult and complex decision but I believe it is the right one."

The agreement has two prongs, first reallocating corporate profits proportionally based on where products and services are consumed, then imposing a minimum

15% effective tax rate on companies with global revenue of at least 750 million euros (\$866 million).

Ireland decided to join the regime after other countries agreed to set the rate at 15%, removing language that could have allowed a higher minimum rate, Donohoe said. Ireland also will be allowed to retain the 12.5% rate for companies with revenue of less than 750 million euros.

This means that 160,000 companies that employ 1.8 million people will see no change in their tax rate, Donohoe said.

The new 15% tax rate will apply to 1,500 foreign-owned companies and 56 Irish multinationals employing a total of 500,000 people, the government said.
