SKM condemns **SDF** allegations of weakened panchayats SUMMIT REPORT GANGTOK, 07 OCT:

Cikkim Krantikari Mor-**J**cha has condemned allegation leveled by Sikkim Democratic Front vice-president [incharge] of panchayat cell, KN Rai, that SKM has stripped away the powers of panchayats.

An SKM press release issued by its secretary [press & publicity], Ranjana Pradhan, insists that the SKM government has provided full powers to panchayats.

The release claims that SKM has freed panchayats of party-politics by making elections non-partisan. It was SDF which stifled panchayats by making rural body elections party-based and thereby limiting the effective power of panchayats.

Responding to allegation that the powers of panchayats were given to BDOs, the release states that the SDF should look at its own track-record when party cadre controlled panchayats. The SKM release adds that BDOs were government employees and not the party cadre and that the main objective of the SKM Government was to ensure impartial work by panchayats.

The release also recalls the threats and warnings issued by the SDF president in the 201 panchayat elections when he was CM.

Central team assesses Covid surge in Mizoram amid alarming positivity rate AIZAWL, 07 OCT [NDTV]:

A four-member central team accessed the COVID-19 situation in Mizoram amid a worrying surge in infections in the northeastern state. Mizoram crossed one lakh Covid cases yesterday with 1,471 people testing positive for the virus. The positivity rate in Mizoram stands at 15.36 per cent and is a major cause of concern in the state with a total population of just over 11 lakh.

Headed by National Centre for Disease Control (NCDC) consultantepidemiologist Dr Vinita Gupta, the central team arrived in the state capital Aizawl on Tuesday. Aizawl has reported 65 per cent of the total cases of the state so far. The central team virtually held a review meeting with chief medical officers of all 11 districts on Wednesday.

of Covishield on Wednesday, of which 1,582 were to people who completed their vaccination schedules with the second dose and 75 others received their first dose.

In the meantime, the state's daily test positivity rate came in reassuringly low at 4.2% this morning with 18 new cases detected from the testing of 419 samples vesterday.

As per the Daily Report of CO-VID-19 in Sikkim issued by the Integrated Disease Surveillance Programme of the Health Department,

12 of the new cases were registered in East District and 06 in West Disfrom South and North districts in the past 24 hours.

Sikkim's tally of confirmed cases of COVID-19 now stands at 31,603.

On the other hand, active cases also dipped slightly to 367 with 34 new recoveries in the State. The figure of recovered cases has further improved to 30,532 and the state currently enjoys a recovery rate of 97.6%.

The Covid death toll also continues to hold at 388 with no new CO-VID deaths reported in the State in the past 24 hours.

The E-Daakhil portal is a Consumer Grievance Redressal portal developed under the Consumer Protection Act of 2019 [which came into force in July 2020]. It has a provision for e-filing of consumer complaints at the Consumer Commissions and online payment of fees for filing these complaints.

This digital platform



for filing consumer complaints includes features like e-Notice, case document download link and virtual conference hearing link, filing of written responses by opposite party, filing rejoinders by

complainants and alerts via SMS/ email.

The E-Daakhil portal empowers the consumer and their advocates to file complaints along with payment of requisite fees online from anywhere

for the redressal of their complaints. It also facilitates the consumer commissions to scrutinize the complaints online and accept, reject or forward complaints to the concerned

Resetting reforms for a resilient and inclusive New India

Indian economy is seeing rapid changes, lacksquare particularly in the last seven years, that are transformational. Time does not give us the luxury for gentle incremental changes which are less disruptive. Moving India away from debilitating socialism to a free market economy suffused with Indian ethos is an enormous task. Socialism, aggravated by a licence quota Raj, chained down Indias entrepreneurs, withered away her assets and resources and brought in hopelessness.

Although opening up of our economy commenced in 1991, several necessary follow-up actions were not taken up then. This led to a dilution of the impact the opening-up was to have had on the economy. A decade later some efforts began but soon, government changed hands. Unfortunately, what followed that brief period was a lost decade, which set us back so badly that we were classified one among the five fragile economies.

When government changed in 2014, PM Modi, with his three unbroken terms as CM, committed himself to build a New India. The demographic dividend provided a market even as the youth were revving to serve as entrepreneurs. Their innovations remained unrecognised even as they were contributing to economies far away from home. Technology and digitisation could bring in efficiencies. In the New India, every ones basic necessities such as water, sanitation, accommodation and health will be provided for. New Indias policies shall work on empowering people. Even after decades of trying, policies based on principles of entitlement have failed to break the vicious cycle of poverty, unemployment and deprivation.

Old India kept our traditional skills and craftsmen in a glorified cage that they couldnt access growing markets. In the name of protecting them they were kept in the reserved list thereby restricting access and competition. A disservice for those who conquered world markets before imperialism stifled them! Our farmers who were producing bountiful crops even as they weathered unpredictable climatic conditions, were bound by restrictions that curtailed their fair earnings. In a diverse country as ours, there were local products, almost one a district. They were left as the underlings. The skills, the artisans, the local products, the dairy and textile cooperatives, all needed revival and rejuvenation. Old India needed to come alive to infuse colour and flavour and to rivet New India to its roots.

Old India was left behind being protected or neglected. An exaggerated belief of socialist India was that government could do nearly everything and deliver too. Steel, cement, watches, telephones, tyres, clothing, pharmaceuticals, condoms, scooters, cars, ships, even bread were manufactured by government units. Government was also in Banking, Insurance, Refineries, mining, hotels, hospitality, tour operations, air service and telephone communication. Moving away from this to bring in efficiencies of the private sector was important. Recognising legitimate profit making, respecting Industry as job and wealth creators required policy support.

India is seeing a phase of make-over.

A clear moving towards an Indian-ethosinfused-market-economy. Not an unbridled mercantilism or a heartless capitalism. The guiding philosophy is a classic: Sab ka Saath, Sab ka Vikas, Sab ka Vishwas and Sab ka

In Modi 1.0 the flood gates of reforms, rejuvenation and revival started in full view. The Jan Dhan Yojana, the strengthening of Aadhar and the using of mobile (the JAM trinity) gave the first mover advantage to the poor. This was soon followed up with Direct Benefit Transfer (DBT) in reaching pensions, ration, fuel, samman nidhi to those eligible. A big collateral benefit resulting from this exercise was the savings for the taxpayer. All ghost accounts

were eliminated and vast sums of money were stopped from pilfer. Ujjwala helped achieve so many goals even as it nudged demerit users out of subsidy. The poor couldnt be denied safe and healthy fuel.

The Goods and Services Tax brought the multiplicity of indirect taxes across the country into one. The Insolvency and Bankruptcy Code was taken up as a major step towards a time-bound resolution of insolvencies. Reforming the financial sector commenced with the four R principle: Recognition, Resolution, Recapitalisation and Reform. The problem of legacy Non Performing Assets (NPA) was addressed steadily that today nearly all banks are out of Prompt Corrective Action. They were recapitalised periodically. Now, they are also raising funds in the

Momentum of economic make-over continues in Modi 2.0 despite the pandemic. In November 2020, PM Modi while addressing the Bloomberg New Economic Forum observed: the Covid-19 pandemic has posed enormous challengesThe biggest question before the entire world is how to restart? The restart will not be possible without a reset. A reset of mindset. A reset of processes. And a reset of practices.

Ensuring no one remains hungry was a priority during the pandemic resulting in free food grain distribution to nearly 80 crore people for eight full months, plus up to 3 cylinders of cooking gas and some little cash for exigencies that may arise. The Divyang, construction workers and the poor senior citizens were provided some relief. Through the four Aatma Nirbhar Bharat announcements timely hand-holding support for small and medium enterprises, traders and small employees were also provided.

Equally noteworthy is the flurry of systemic reforms that were undertaken. The lowering of Corporate tax rate was a decision post the first budget of Modi 2.0. For new companies the rate was brought to 15% and for the existing it was brought to 22%. Minimum Alternate Tax (MAT) was also exempted for companies. For empowering farmers three Farm Reforms Acts were passed. Now the farmers can choose the buyer and the price at which they wish to sell their produce.

Even during the pandemic amalgamation of banks happened. Today we have only 12 public sector banks from 27 in 2017. A National Asset Reconstruction Company and an India Debt Reconstruction Company

are established. They shall carve out the NPAs from commercial banks and realise maximum values for the banks. To ensure the value realisation, government provides a back stop arrangement. Long term infrastructure funding with proper risk assessment and long term capital shall now be available through the National Bank for Funding Infrastructure Development. An enabling provision in the law also envisages

private sector development funding institutions. A Pipeline of projects with total capital expenditure of over Rs112 lakh crores are announced and a portal gives the status of progress.

To attract further investments and make India a manufacturing hub a Production Linked Incentive Scheme (PLI) is introduced to benefit 13 champion sectors. In the light of a global supply chain reset, this scheme has attracted investments in mobile, medical devices, API/KSM manufacture in pharma, food processing, textiles etc.

Long awaited reforms to the Telecom and Power sectors critical to the economy are undertaken.

The Budget 2021 saw a policy on public sector enterprises which identified those strategic sectors where only a bare minimum presence of public enterprises will be allowed. Equally, all areas are now open for the private players. An enabling amendment to the General Insurance Act was done. In Insurance sector 74% FDI is allowed through automatic route. Life Insurance Corporation goes out for an Initial Public Offer (IPO).

A consent-based framework for Account Aggregation is introduced. Bank customers can avail different financial services from a portal where several service providers will be available. Customers can share their data with their chosen service provider. This is a major step in financial inclusion and for access to credit.

Amendments to Deposit Insurance Credit Guarantee Act will provide Rs 5 lakh insurance cover for small depositors. 98.3% all deposits gets covered through this on step in case of any restrictions on the banks.

Writing recently on the De Soto Effect, Niranjan Rajadhyaksha states: poor working in tiny informal enterprises are in effect shut out of the formal credit system, and hence condemned to live in poverty, because a lack of clear property rights makes it difficult for them to offer their land assets as collateral to banks. The SVAMITVA scheme envisages mapping of land parcels using drone technology and providing record of rights to village land/house owners. The vicious cycle of poverty due to lack of credit availability is broken through this scheme. Three other schemes the SVANidhi, Mudra and the Stand Up aim at collateral free lending for small enterprises which are changing the lives of the poor with their dignity intact.

This and more is possible because the leadership remains connected to its people and its philosophy Sab Ka Saath.

Joint Secretary-cum-**Nodal Officer for Persons** with Disabilities, Abinash Rai, Social Welfare Division, Dr MB Chettri, Joint **Commissioner for Persons** with Disabilities (Technical), Office of the Commissioner for Persons with Disabilities and Unique Disability Identity (UDID) State Coordinator, Sameer Pradhan were the representatives for the programme from the Social Justice & Welfare Depart-

The participants for the programme included the Chief Medical Officer (CMO), District Medical Superintendent (DMS), ENT Specialist, Sr ENT Specialist, Medical Specialist (Ortho), Physiotherapist, Pediatrician. Gynecologist, Medical Officers from PHCs, Dental Surgeons, Dental Consultant and Assistant Nursing Superintendents.

Joint Secretary in his address briefed about "The Rights of Persons with Disabilities (RPwD) ACT", 2016. He spoke about the inclusion of 21 types of disabilities in the ACT and also highlighted the penalties one has to face if a person with disability is denied basic rights as mentioned in the RPwD ACT 2016. He stated that a person with Benchmark Disabilities is the one who has forty per cent of the specified disability as certified by the certifying authority

and also highlighted that

no person having a disabil-

ity less than forty per cent

should be denied a disability certificate by the Medical Authority. He emphasized on the importance of being empathetic towards people with disabilities by the general population and priority should be given by the hospitals regarding treatment of Persons with Disabilities and senior citizens.

Joint Commissioner (Technical) for Persons with Disabilities, briefed about the 21 Disabilities in detail. He also spoke in detail about the Guidelines for assessment of all 21 types of disabilities and how the Medical Authority / Medical Board should give the percentage as per the guidelines specified in the RPwD ACT 2016.

The RPwD ACT 2016, Guidelines for Assessment of disabilities and Pamphlets on 21 types of disabilities were handed out to all the participants followed by a feedback ses-





Media Should Invite More Criticism

There can, after all, be no improvement without analysis

The news media is introduced as the fourth estate, the fourth pillar holding up the shelter of democracy.

Interestingly, while the other "estates" of democracy - the judiciary, the executive and the legislative have a screening process to get where they do and are also occasionally held accountable for their actions in a formal way in the public domain, the news media is an equal opportunity sector where anyone can get in and appears to work unfettered and is technically answerable to no one. In a perfect world, this is how things should be with "open access" graduating to meritocracy and excellence in this estate. The watchdog in a true democratic system should not be subservient to anyone or anything if it is to deliver on its responsibilities properly. It is, however, not a perfect world that we live in, so checks and balances are required at every level. One could argue that the readers are the best agency to rein in the media when the power of the pen goes to their head. And, in a way they are. No matter how sensational its content, a newspaper, news channel or any other vehicle of information loses credibility in the reader's mind if it keeps reporting rumours for facts and highlighting trivialities as issues. Readers might turn to them for entertainment, but will take the information with a pinch of salt. And, with so many other modes of entertainment available nowadays, even that USP becomes a liability very fast. So, yes, readership/ viewership (or followers if you are more SocialMedia inclined) is the one factor that fixes accountability on

Obviously, sometimes, just this much is not enough. Readership is not respected to the extent it should be neither in Sikkim nor in India as a whole. While simple numbers are enough to decide readership in Sikkim, at a national level it becomes slightly more complicated. The numbers game that media houses indulge in to inflate circulation is no secret and it is perhaps for this reason that an editorial post common in West is now being toyed by some newspapers in India too. The Hindu had started the ball rolling with the offer to appoint a Reader's Editor, an Ombudsman of sorts. This was a brave decision as the Reader's Editor, the in-house critic, is expected to be scathing in her/his analysis of the newspaper. That experiment has played out to mixed results, but is worth exploring on wider scale. A Reader's/ Public Editor does not only question and challenge the veracity of news-reports, but also pulls up the intents and vested interests behind the highlighting, prominence and display of certain stories. That is not all, s/he is also allowed to question journalistic ethics of the newspaper and also air opinion when some stories are downplayed or dropped. S/he does all this not in internal memos, but in a space allotted in the newspaper. In the public domain. Reader's Editors in the West have been known to be extremely sharp in their criticism. Their performance in India leaves a lot to be desired but is a necessary undertaking. It is also unlikely to happen with any significance because media criticism/ analysis is still a rare animal in media circles. Some online platforms are trying to correct this, but their reach is still limited.

The reason this is being shared here is to highlight the fact that there can be no improvement without criticism. And, there is no such thing as "positive criticism." Criticism is criticism, its positivity or negativity depends on the target of the criticism and how it is used. Newspaper reports are not the final word. Everyone knows that, and since there is still a lot of room for improvement as far as our conduct is concerned, we, in the media, should invite more responses. To begin with, there will be crude and poorly informed outbursts, but if we give it time, discussions on newspapers in the public domain will soon become more coherent and, yes, "constructive".

Is Social Distancing Unraveling the Bonds that Keep Society Together?

With birthday celebrations being downsized, religious services moving back online and indoor playdates getting canceled, millions of Americans are having fewer social interactions because of persistently high case numbers and high rates of transmission.

It's not just interactions with friends and families that are getting cut. Routine yet beneficial interactions with people at fitness and child care centers and volunteer organizations are also being eliminated.

Social distancing is vital to combating CO-VID-19. But is it unraveling the social bonds that keep society together?

SOCIAL CAPITAL ADDS UP

As a sociologist of religion and education, I study how Americans develop social ties, and how these social ties influence people's lives. Scholars refer to relationships that exist between and among people as "social capital." When people interact, even briefly, they start to trust one another and feel comfortable asking each other for help. But for that trust to develop, people need to physically interact with one another.

Social capital is highly valuable during times of crisis. During Hurricane Ida, for example, people waded through rising water to save neighbors. A similar thing happened during Chicago's 1995 heat wave when hundreds of people who lived alone without air conditioning were rescued by neighbors and acquaintances.

Having trusting relationships with people ahead of crises is key – and building those relationships requires people to spend time together.

While isolating at home in spring 2020, I started to wonder: Does the need to social distance affect how social capital gets activated during a pandemic?

From August to October 2020, I interviewed 36 middle- and low-income Jewish parents in the greater Philadelphia area who had school-aged children. There was a range among parents in how

involved they were in Jewish communities and organizations. Some were regular synagogue-goers. Others rarely went to services but actively volunteered for Jewish organizations. And some rarely participated in any religious or social dimensions of lewish life.

How does a study of Jews help us understand the flow of social capital during a pandemic?

Both Jews and non-Jews can develop social capital by participating in religious organizations. It's not religious rituals that cultivate social capital – it's all those social interactions that occur outside of religious rituals.

RELATIONSHIPS PAY OFF

When COVID-19 hit, millions of Americans needed to avoid social contact and couldn't participate in religious services.

That also meant they couldn't participate in the social dimensions of religious life – they couldn't help people mourn their dead, volunteer in soup kitchens or gather with people for meals during holidays and the Sabbath.

For Jews, limiting social interaction was especially difficult because many rituals require a minyan – a quorum – of 10 people.

My interviews revealed two key phenomena. First, social capital gets activated differently during a pandemic than it does during weather-related digasters

During hurricanes and heat waves, social capital manifests itself in people physically helping their acquaintances get out of dangerous situations

But during a pandemic, the physical help itself is what's dangerous. Working parents couldn't turn to their neighbors or friends for child care help without putting their acquaintances, as well as their own children, at risk of contracting COVID-19.

Since physical interaction was off limits, the role of social capital transformed. Jewish parents were able to use their social connections in Jewish organizations to get supermarket gift cards, groceries and even lump sums of cash to offset lost income. For these economically fragile families, the immediate resources helped them feel secure and

cared for in a time of profound uncertainty.

Parents were more likely to get these resources if they had been actively engaged in the social life of the Jewish community before COVID-19. Parents who weren't embedded in Jewish communities didn't even know that they could ask for help.

At the same time, rabbis who had received funds through larger Jewish organizations to help their congregants and community members knew whom to distribute funds to only if they had relationships with them ahead of the pandemic – relationships that were developed through social interactions outside of formal religious rituals like prayer.

RECIPROCITY REQUIRED

The second major finding is that extended periods of social distancing threaten the flow of social capital.

Parents who received material resources from Jewish organizations or rabbis were often those who contributed in some capacity to the system prior to COVID-19. Some served as greeters or as security guards during synagogue events; others organized meal trains; and some volunteered for their local chevra kadisha, or Jewish burial society.

The key point is that social capital requires reciprocity – people need to give in order to receive. Physical and reciprocal acts of generosity are crucial for maintaining the social bonds of society.

But what happens to our social bonds when social distancing limits our ability to physically help each other? While individuals can still contribute money, there is little opportunity for people to give their time and join in physical communal efforts.

If human interactions are hindered for long periods of time, social capital could break down. This could profoundly unravel the social ties that bind Americans together and motivate them to transcend their self-interests to help others. Americans may survive the pandemic, but will they have anyone left to turn to the next time they need support?

Standing on one leg is a sign of good health – and practising is good for you too

Research shows that people's ability to stand on one leg is an indicator of health and that getting better at standing on one leg can add to fitness and potentially lifespan.

Being able to stand on one leg is linked to increased levels of physical activity and decreased risk of falls and is associated with both quality and length of life. Around 37.3 million falls per year worldwide are severe enough to require medical attention.

The inability to balance on one leg for 20 seconds or longer is linked in otherwise healthy people to an increased risk of small blood vessel damage in the brain and reduced ability to understand ideas. You are less likely to be able to stand on one leg without a wobble if you have a multitude of medical conditions such as Parkinson's disease, stroke or Alzheimer's disease).

Pregnancy, menopause, the diagnosis of disease and retirement can also alter our strength and balance and ability to stay upright, mostly because of the way these affect our ability and motivation to engage in regular physical activity.

Sitting or reclining while awake

is associated with lower muscle strength, risk of falls and physical function, sometimes irrespective of the amount of moderate or vigorous intensity physical activity you do. People who sit for prolonged periods are more likely to develop type 2 diabetes, higher waist circumference and obesity.

WHY STANDING ON ONE LEG MATTERS

Data shows that the time people can stand on one leg changes for men and women at different ages – and an inability to hit those target times for your age group can highlight health problems.

The human body, when standing upright, is inherently unstable. We have a very small base of support relative to our height and width. When in good health we rely on our central and peripheral nervous system to integrate all the information coming in from our balance senses (eyes, inner ears and feedback from muscles and joints). We then engage the right muscles (feet, ankle, leg and core muscles, sometimes even the arm muscles) at the right time to make the necessary adjustments to our posture to stay upright.

The more physically active we are, the more likely we are to have good balance and of course the wider

physical, psychological and social benefits of being regularly active are well known.

Other health problems can also affect our physical activity and are characterised by stooped posture and worsened balance, such as depression and osteoporosis, leading to an increased risk of falls and fracture. A stooped posture makes standing on one leg more difficult.

SHOULD I START STANDING ON ONE LEG?

You can improve your ability to stand on one leg at any age, and improve your balance. It's more challenging if you have a neurological condition, but studies have shown improvements in balance following exercise in many conditions and it is known to reduce falls in many others. In the UK around one in three adults over 65 and half of people over 80 will have at least one fall a year. A recent Public Health England report suggests that lack of activity in older adults because of the social restrictions during the pandemic could lead to 110,000 more older people falling this year.

You can test your own balance here and have a try at some simple balance exercises. You are more likely to have improved confidence in performing physical activity, and getting

more active can help lengthen and

improve quality of life.

Standing on one leg can be made much more challenging if you close your eyes while doing it. This is worth practising as it helps with our long-term balance and reduces the risk of falling over. With our eyes open the body becomes lazy and relies on our vision to help keep us balanced. If you take out vision, it gets the other senses working better. Most people can only do this for a short time compared to when they keep their eyes open. Have something close by to hold on to. You will improve over

For the over 70s, there's also evidence to show standing on each leg for one minute three times a day can help improve hip bone mineral density. Stronger hip bone mineral density means if you do fall you are less likely to fracture.

And on that note, do I stand on one leg? Yes, when I am cleaning my teeth morning and evening, alternating from one leg to another at least twice. If I am feeling bold I try one round of the teeth with my eyes closed. That, I might add, I am starting to find more difficult – I must practice more.

UEFA sets date for Euro 2024 qualifying draw in Frankfurt

SWITZERLAND (AP): The 2024 Euro-Championship qualifying groups will be drawn in Frankfurt in one year, UEFA said Thursday.

The qualifying format was not announced, though the 54 teams involved will likely be drawn into 10 qualifying groups, each with five or six teams playing from March to November in 2023.

That would let the top two in each group advance directly to the 24team finals tournament joining host Germany.

The Euro 2024 lineup will likely be completed in March 2024 by three playoff brackets involving teams based on their standings in the Nations League groups played next year.

The Nations League groups are played next June and September, ahead of the Oct. 9 draw for the Euro 2024 qualifying groups.

UEFA is scheduled to draw those Nations League groups on Dec. 16 in Montreux, Switzerland.

The top three Nations League tiers each have 16 teams leaving just seven countries in the lowestranked League D, which is unlikely to get a protected playoff path to the Euro 2024 finals tournament. For Euro 2020, the fourth-tier playoffs let North Macedonia qualify.

Top-tier teams which advance to the Nations League Final Four in June 2023 will need to be drawn into the lighterschedule five-team qualifying groups for Euro 2024.

Nigerian sprinter **Okagbare facing 3** charges in doping case



MONACO (AP): Nigerian sprinter Blessing Okagbare is facing three charges in a doping case which surfaced in dramatic circumstances when she was barred from running in the Olympic 100-meter semifinals hours before the race.

The Athletics Integrity Unit revealed on Thursday that Okagbare tested positive for blood booster EPO in Nigeria in June, in addition to another failed test for human growth hormone in Slovakia in July, which was announced during the Olympics.

Okagbare was also charged with failing to cooperate with the investigation after she disobeyed an order to produce "documents, records and electronic storage devices" in relation to the other charges, the AIU said.

She has not commented on the charges, but the AIU said she denies all charges and has requested a disciplinary

Okagbare had won her 100 heat at the Tokyo Olympics when the AIU told her she was provisionally suspended over the test for human growth hormone. During the Olympics, she criticized Nigerian sports officials after other athletes from the country were blocked from the Games because they hadn't undergone enough drug testing in the months before. Officials were "forgetting their major responsibility 'THE ATHLETES'," she wrote on Twitter.

Three days before her EPO positive in June, Okagbare ran the 100 in a personal-best 10.63 seconds at the Nigerian championships, just 0.02 seconds slower than the eventual winning time for Olympic gold medalist Elaine Thompson-Herah. World Athletics records don't consider Okagbare's time official because of a substantial

tailwind. Okagbare won the bronze medal in the long jump at the 2008 Olympics. That was later upgraded to a silver medal when a Russian athlete was banned for doping. At the 2013 world championships, she doubled up with long jump silver and 200-meter bronze. Okagbare also won the 100 and the 200 at the Commonwealth Games in 2014.

Greek lawmakers to vote on major defense pact with France

GREECE (AP): ATHENS. Greece's lawmakers were debating and voting Thursday on a broad five-year defense pact signed last week with France which includes a clause of mutual assistance in case of attack by a third party.

Prime Minister Kyriakos-Mitsotakis signed the deal with French President Emmanuel Macron during a Sept. 28 visit to Paris, during which Greece also announced it would be buying three French frigates for the Greek navy.

The purchase and defense deal come at a time of generally increased tension between Greece and its fellow NATO member and neighbor Turkey over energy exploration rights in the eastern Mediterranean.

Thursday's parliamentary debate and vote are for the defense pact only, not the purchase of the warships. The deal is expected to be ratified as the governing conservatives have a comfortable majority in par-

Describing the pact as "historic," Mitsotakis said the deal meant the bolstering of Greece "in the troubled Mediterranean, and at the same time the first bold step in the strategic autonomy of Europe."

The benefits of the deal, he said, were clear.

"For the first time, an explicit and unequivocal military assistance clause is provided in the case of a third party attack on one of the two states," Mitsotakis said. "We all know ... who is threatening whom with a casus belli in the eastern Mediterranean."

Turkey has said it would be a casus belli — a cause for war - if Greece extends its territorial waters from the current

Turkey argues such a move would turn the Aegean into essentially a Greek sea. Athens maintains it has the right to extend to 12 nautical miles in accordance with the U.N. Convention on the Law of the Sea, and recently extended its western territorial waters, in the Ionian Sea facing Italy, to 12 nautical miles.

Regional rivals Greece and Turkey have been at loggerheads for decades over a series of disputes, including the delineation of the continental shelf, territorial rights in the Aegean Sea, aviation and maritime boundaries and the demarcation of Exclusive Economic Zones — areas where each country has exclusive rights to the exploitation of resources — in the Mediter-

Greece's government announced last year it would be overhauling its military, including the hiring of personnel and a major military procurement program that has already seen the country buying 18 French Rafale fighter jets.

The defense deal with France includes a mutual assistance clause. which states that the two sides will come to each other's aid "with all appropriate means at their disposal, and if necessary with the use of armed force, if they jointly ascertain that an armed attack is taking place against the territory of one of the two."

The deal also includes a provision for Greek participation in French-led military operations such as those it has conducted in the Sahel region

Mitsotakis said last week that the mutual assistance clause "essentially says that if any of the countries is attacked, if its territory is challenged, its sovereignty is challenged, then there is an obligation by the other party to assist it."

The idea of collective defense is a principal tenet of NATO, of which both Greece and France are members, as is Turkey. Article 5 of the alliance's treaty stipulates that an attack on one member nation is considered an attack on all.

"Does Article 5 apply in the case of an attack by a NATO member? I'm not sure NATO has ever been very clear on that issue," Mitsotakis had said when asked during the conference why Greece needed an extra alliance agreement. "My obligation is to defend my country and to form the necessary alliances over and above the security arrangements that we already have."

On Tuesday, NATO Secretary-General Jens Stoltenberg appeared to be critical of European defense initiatives that aren't within NATO.

"What I don't believe in is efforts to try to do something outside the NATO framework or compete with or duplicate NATO, because NATO remains the cornerstone, the bedrock for European security, and also actually for North American security," Stoltenberg said in a speech without directly mentioning the defense deal between Greece and France.

Russia's infections reach the highest level so far this year

MOSCOW (AP): Russia's daily coronavirus infections soared Thursday to their highest level so far this year as authorities have struggled to control a surge in new cases amid a slow pace in vaccinations and few restrictions in place.

The daily coronavirus death toll topped 900 for a second straight day, with 924 new deaths reported Thursday — a day after reaching a record 929.

Russia already has Europe's highest death toll in the pandemic topping 213,000 — and a conservative way of calculating the number suggests the actual number could be even higher.

On Thursday, the government's coronavirus task force reported 27,550 new confirmed cases, a nearly 10% rise from the previous day. New infections in Moscow soared by nearly 50% to 5,404 cases.

A quick rise in infections and deaths began in late September, with authorities blaming it on the low vaccination rate. As of Tuesday, almost 33% of Russia's 146 million people had received at least one shot of a coronavirus vaccine, and 29% were fully vaccinated.

Despite surging infections, the Kremlin has shrugged off the idea of imposing a new nationwide lockdown, delegating the power to tighten restrictions to regional authorities.

Some regions have limited attendance at large public events and restricted access to theaters, restaurants and other places to people who have been vaccinated, recently recovered from COVID-19 or tested negative in the previous 72 hours.

In some areas, Russia's vast yet severely underfunded care system has started to show signs of being overwhelmed by the outbreak.

Russian media have reported long lines of ambulances once again forming in front of hospitals in St. Petersburg. And on Tuesday, the presidential envoy in the Ural Mountains district — a part of central Russia that encompasses six regions — said 95% of the hospital beds for COVID-19 patients there have been filled.

Overall, Russia's coronavirus task force has registered nearly 7.7 million confirmed cases and 213,549 deaths. However, reports by Russia's state statistical service Rosstat that tally coronavirus-linked deaths retroactively reveal significantly higher mortality numbers.

smuggling bust worth \$26.9M

HONG KONG (AP): Hong Kong authorities on Thursday said they have made their largest smuggling bust, seizing goods including endangered species worth an estimated \$26.9 million.

The government said the smuggling ring operated using speedboats and that four trucks were also impounded in the

It said a 34-year-old man was arrested in the operation that began in Iune and more details were set to be released. A statement said the customs department and the marine police small boat division descended on the smugglers who were operating in the city's New Territories close to mainland China on Sept. 23.

"This is the largest smuggling case among all forms of smuggling by air, sea and land detected by Customs on record in terms of the seizure value," the government said.

Seized items displayed at a news conference included endangered plants, luxury handbags, cigars and shark's fin, which is prized as a delicacy in southern Chinese cuisine. The semi-autonomous southern Chinese city has a high demand for luxury items along with abundant air and sea links to world markets.

Austrian leader vows to stay on amid bribery allegations

BERLIN (AP): Austrian Chancellor Sebastian Kurz is denying wrongdoing and vowing to remain the country's leader after anti-corruption prosecutors said he is under investigation in a probe of suspected bribery. However, his coalition partner said Thursday that the allegations left a "disastrous" impression and raised questions over the chancellor's "ability to act."

Prosecutors said Wednesday they are conducting an investigation into Kurz and nine other people, as well as three organizations they didn't identify, on suspicion of breach of trust and bribery. They conducted searches at the chancellery, the finance ministry and the offices of Kurz's conservative Austrian People's Party.

The case centers on allegations that finance ministry money was used between 2016 and at least 2018 to pay for manipulated polls that were published in a newspaper without being declared as advertising. Kurz became his party's leader and then chancellor in 2017 after previously serving as Austria's foreign minister.

In a separate case, the 35-year-old chancellor was put under investigation in May by anti-corruption authorities on suspicion of making false statements to a parliamentary commission, an allegation he has also rejected.

Kurz rejected responsibility in the latest case in an interview Wednesday night with ORF public television.

100-year-old former Nazi camp guard goes on trial in Germany

100-year-old man went on trial in Germany Thursday, accused of being an accessory to murder for serving as a Nazi SS guard at the Sachsenhausen concentration camp near Berlin during World War II.

The trial of the defendant, who charged with 3,518 counts of accessory to murder, was held at the Neuruppin state court, which moved the proceedings to a prison sport hall in Brandenburg for organizational reasons.

The suspect, who identified only as Josef S. in keeping with German privacy rules, is alleged to have worked at Sachsenhausen between 1942 and 1945 as an enlisted member of the Nazi Party's paramilitary wing. The suspect's law-

yer, Stefan Waterkamp, told the court that his client did not want to comment on the allegations, German news agency dpa reported. There are no formal pleas in the German legal system.

150 years since first tour

Fisk Jubilee Singers celebrate



NASHVILLE, TENN. (AP): The Fisk Jubilee Singers' first tour wasn't an immediate success, but their perseverance through financial hardship to find an audience took them around the world and kept their school afloat.

Fisk University in Nashville, Tennessee, celebrated the singing group's 150th anniversary on Wednesday and reflected on a legacy that was built with their performances of slave spirituals, which kept alive not only the university but also a musical tradition. Poet, author and educator Nikki Giovanni, who is a Fisk alumna, talked about that first tour during her keynote speech during Jubilee Day, their annual event.

"We're here today celebrating," Giovanni said. "But when we look at how we carried those songs, and we carry those songs now, and we still lean on the everlasting arms."

Opened as a liberal arts school for freed Black slaves in 1866, Fisk University was financially struggling just a few years later. Giovanni explained that one of the students, Ella Sheppard, who was born a slave, offered to help. She was a piano player.

Nine students, some of those former slaves or descendants of slaves, set off on a tour on Oct. 6, 1871, singing mostly European songs, such as those by Gilbert and Sullivan, to white audiences, Giovanni said. They got little response and barely made enough money to feed themselves, but still managed to donate money to victims of the deadly Chicago fire of 1871. The turning point was when they started singing the songs their ancestors had brought with them to America: spirituals.

"Everybody was shocked," Giovanni said. "They'd never heard anything like

The songs they performed, such as "Steal Away," were a musical bond to their ancestors who were brought over from African nations.

"We were put on a block and we were bought and we were sold and we were bought and we were sold," Giovanni said. "And the only language we still had was the music that had been passed down from Jesus to Mary Magdalene."

Soon the word spread of their performances and they were invited to sing at the White House by President Ulysses S. Grant. Then they toured internationally, singing for Queen Victoria and others. Their work helped Fisk build Jubilee Hall, the oldest building on campus and one of the oldest academic buildings continuously dedicated to educating Black students.

In addition to their anniversary, they earned their first Grammy Award for best roots gospel album this year and started a new endowment.

Tanzanian **AbdulrazakGurnah** awarded Nobel literature prize

STOCKHOLM (AP): Tanzanian writer AbdulrazakGurnah was awarded the Nobel Prize for Literature on Thursday for works that explore the legacies of imperialism on uprooted individuals.

The Swedish Academy said the award was in recognition of his "uncompromising and compassionate penetration of the effects of colonialism and the fate of the refugee in the gulf between cultures and continents"

Born in Zanzibar in 1948 and based in England, Gurnah is a professor at the University of Kent. He is the author of 10 novels, including "Paradise," which was shortlisted for the Booker Prize in 1994.

Anders Olsson, chairman of the Nobel Committee for literature, called him "one of the world's most prominent post-colonial writers."

The prestigious award comes with a gold medal and 10 million Swedish kronor (over \$1.14 million). The prize money comes from a bequest left by the prize's creator, Swedish inventor Alfred Nobel, who died in 1895.

Last year's prize went to American poet Louise Glück for what the judges described as her "unmistakable poetic voice that with austere beauty makes individual existence universal."

Glück was a popular choice after several years of controversy. In 2018 the award was postponed after sex abuse allegations rocked the Swedish Academy, the secretive body that chooses the winners. The awarding of the 2019 prize to Austrian writer Peter Handke caused protests because of his strong support for the Serbs during the 1990s Balkan wars.

On Monday, the Nobel Committee awarded the prize in physiology or medicine to Americans David Julius and ArdemPatapoutian for their discoveries into how the human body perceives temperature and touch.

The Nobel Prize in physics was awarded Tuesday to three scientists whose work found order in seeming disorder, helping to explain and predict complex forces of nature, including expanding our understanding of climate change.
