There are 30,480 votl ers who came of voting age only this year while there are 07 voters who are more than 100 vears old in the State. This was informed by Chief Electoral Officer of Sikkim, R Telang, in a press conference held today.

Mr Telang informed that there were a total of 4,32,306 voters as on date with 2,20,305 male voters and 2,12,001 female voters in Sikkim. There are 415 voters of above 90 years.

There are 2042 PWD voters in Sikkim and school students have been appointed to assist them on polling day. Units will be put to use during the polling day.





Institutionalize Monitoring For once, let's try engaging affected people in genuine collaborations

 $\mathbf{P}^{\text{rojects,}}$ whether hydel, road or industrial, go through a lot of teething problems. Given their labour-intensive and landscape-ruining nature, they arrive neither with aspirational job openings nor pleasing environmental interventions. This is why mantras like "nation-building" and "development" are played out on a spool to win public endorsement. Speaking about Sikkim, experience also shows that the initial resistance to such projects is tranquilized with handsome compensations and tall promises. But these projects have a long gestation period and even longer construction phases which leads to a situation where the compensations along with the solatium component are long spent before the project has been completed. Resentment returns, and every slight gets amplified, leading to a complete breakdown of trust between the local community and the project-investors and their personnel on site. Sikkim has seen this cycle play out with just about every project, and occasionally the distrust manifests in gheraos and confrontations which then find mention in newspapers. Most of the times, however, the ill-will festers under a façade of apparent normalcy. This is not a healthy situation because the bitterness does not always find release against the management of such units and sometimes erupts against the establishment and other agencies which the people feel did not look out enough for their interests. Surely, these are not developments that the planners or the executors originally had in mind. And yet these are situations which develop often.

In the latest instance, Sikkim saw "affected people" of the 96 MW Dikchu hydel project lay out a litany of complaints against the project managers. Similar complaints and all allegations have been heard against pharma companies and the promoters of other hydel projects. Like in those cases, this bushfire will also be addressed piecemeal, focused only on the immediate demands, but ignoring the larger issue of the lack of adequate consultations, information-sharing or over-watch. The problem, hence, will remain. What is required is for every project to begin with a more transparent public hearing preceded by gram sabhas where every aspect and the fine print are discussed in detail. The state machinery should only provide information and not exert influence. Every project should have a project monitoring committee with affected people in majority representation and ex-officio posts for government officers and public representatives only in secretarial responsibilities of taking the minutes and drafting resolutions. Proper schedules should be dictated to keep these committees updated on project components and these committees should then be required to brief the gram sabhas or other panchayat meetings on a regular basis. This way, not only transparency, but even accountability can be ensured, and once this is achieved, possible problems can be addressed in advance and issues resolved before things boil over. Such engagement will also reassure the local community and, in the long run, help the projects as well because once the people are involved in the decision-making process, even if it is only by way of regular and clear updates, they will develop a sense of ownership and extend sage advice where the current system of things leaves them only with the option of registering condemnations.

Don't blame Sharia for Islamic extremism - blame colonialism

Warning that Islamic extremists want to impose fundamentalist religious rule in American communities, right-wing lawmakers in dozens of U.S. states have tried banning Sharia, an Arabic term often understood to mean Islamic law.

These political debates – which cite terrorism and political violence in the Middle East to argue that Islam is incompatible with modern society - reinforce stereotypes that the Muslim world is

They also reflect ignorance of Sharia, which is not a strict legal code. Sharia means "path" or "way": It is a broad set of values and ethical principles drawn from the Quran - Islam's holy book - and the life of the Prophet Muhammad. As such, different people and governments may interpret Sharia differently.

Still, this is not the first time that the world has tried to figure out where Sharia fits into the global

In the 1950s and 1960s, when Great Britain, France and other European powers relinquished their colonies in the Middle East, Africa and Asia, leaders of newly sovereign Muslim-majority countries faced a decision of enormous consequence: Should they build their governments on Islamic religious values or embrace the European laws inherited from colonial rule?

THE BIG DEBATE

Invariably, my historical research shows, political leaders of these young countries chose to keep their colonial justice systems rather than impose religious law.

Newly independent Sudan, Nigeria, Pakistan and Somalia, among other places, all confined the application of Sharia to marital and inheritance disputes within Muslim families, just as their colonial administrators had done. The remainder of their legal systems would continue to be based on European law.

To understand why they chose this course, I researched the decision-making process in Sudan, the first sub-Saharan African country to gain independence from the British, in 1956.

In the national archives and libraries of the Sudanese capital Khartoum, and in interviews with Sudanese lawyers and officials, I discovered that leading judges, politicians and intellectuals actually pushed for Sudan to become a democratic Islamic state.

They envisioned a progressive legal system consistent with Islamic faith principles, one where all citizens - irrespective of religion, race or ethnicity - could practice their religious beliefs freely

"The People are equal like the teeth of a comb," wrote Sudan's soon-to-be Supreme Court Justice Hassan Muddathir in 1956, quoting the Prophet Muhammad, in an official memorandum I found archived in Khartoum's Sudan Library. "An Arab is no better than a Persian, and the White is no better than the Black."

Sudan's post-colonial leadership, however, jected those calls. They chose to keep the English common law tradition as the law of the land.

WHY KEEP THE LAWS OF THE OPPRESSOR?

My research identifies three reasons why early Sudan sidelined Sharia: politics, pragmatism and demography.

Rivalries between political parties in post-colonial Sudan led to parliamentary stalemate, which made it difficult to pass meaningful legislation. So

Sudan simply maintained the colonial laws already on the books.

There were practical reasons for maintaining English common law, too.

Sudanese judges had been trained by British colonial officials. So they continued to apply English common law principles to the disputes they heard in their courtrooms.

Sudan's founding fathers faced urgent challenges, such as creating the economy, establishing foreign trade and ending civil war. They felt it was simply not sensible to overhaul the rather smooth-running governance system in Khartoum.

The continued use of colonial law after independence also reflected Sudan's ethnic, linguistic and religious diversity.

Then, as now, Sudanese citizens spoke many languages and belonged to dozens of ethnic groups. At the time of Sudan's independence, people practicing Sunni and Sufi traditions of Islam lived largely in northern Sudan. Christianity was an important faith in southern Sudan.

Sudan's diversity of faith communities meant that maintaining a foreign legal system - English common law - was less controversial than choosing whose version of Sharia to adopt.

WHY EXTREMISTS TRIUMPHED

My research uncovers how today's instability across the Middle East and North Africa is, in part, a consequence of these post-colonial decisions to

In maintaining colonial legal systems, Sudan and other Muslim-majority countries that followed a similar path appeased Western world powers, which were pushing their former colonies toward secularism.

But they avoided resolving tough questions about religious identity and the law. That created a disconnect between the people and their govern-

ments. In the long run, that disconnect helped fuel unrest among some citizens of deep faith, leading to sectarian calls to unite religion and the state once and for all. In Iran, Saudi Arabia and parts of Somalia and Nigeria, these interpretations triumphed, imposing extremist versions of Sharia over millions of people.

In other words, Muslim-majority countries

stunted the democratic potential of Sharia by rejecting it as a mainstream legal concept in the 1950s and 1960s, leaving Sharia in the hands of

But there is no inherent tension between Sharia, human rights and the rule of law. Like any use of religion in politics, Sharia's application depends on who is using it - and why.

Leaders of places like Saudi Arabia and Brunei have chosen to restrict women's freedom and minority rights. But many scholars of Islam and grassroots organizations interpret Sharia as a flexible, rights-oriented and equality-minded ethical

RELIGION AND THE LAW WORLDWIDE

Religion is woven into the legal fabric of many post-colonial nations, with varying consequences for democracy and stability.

After its 1948 founding, Israel debated the role of Jewish law in Israeli society. Ultimately, Prime Minister David Ben-Gurion and his allies opted for a mixed legal system that combined Jewish law with English common law.

In Latin America, the Catholicism imposed by Spanish conquistadors underpins laws restricting abortion, divorce and gay rights.

And throughout the 19th century, judges in the U.S. regularly invoked the legal maxim that "Christianity is part of the common law." Legislators still routinely invoke their Christian faith when supporting or opposing a given law.

Political extremism and human rights abuses that occur in those places are rarely understood as inherent flaws of these religions.

When it comes to Muslim-majority countries, however, Sharia takes the blame for regressive laws - not the people who pass those policies in the name of religion.

Fundamentalism and violence, in other words, are a post-colonial problem - not a religious inev-

For the Muslim world, finding a system of government that reflects Islamic values while promoting democracy will not be easy after more than 50 years of failed secular rule. But building peace may demand it.

Aquarter of a century ago Rwanda was a graveyard. Hundreds of thousands of lives had been lost and government institutions were in a shambles. This was the aftermath of a genocide that started in April 1994 and went on until July

An estimated three quarters of Rwanda's Tutsi minority perished in the genocide that was presided over by the Hutu-dominated government. At the same time, tens of thousands of Hutu were massacred by the Tutsi-dominated Rwandan Patriotic Front (RPF).

When the fighting ended in July 1994, the government and all its institutions laid in ruins. The rebel Rwandan Patriotic Front led by Major General Paul Kagame took over the government, promising to establish democratic government rule.

Since then debates on Rwanda's post-genocide recovery have been polarising. On one hand, Rwanda is seen as a success story: a showcase for post-conflict reconstruction thanks to its achievements in terms of stability, economic growth, pro-business environment, women in leadership, and effective public services

On the other hand, the country is seen as experiencing an authoritarianism which is grounded in growing inequality and a cli-

mate of fear, intimidation and impunity. This paradox raises serious questions

nomic growth in a society dominated by one of the most autocratic, repressive governments in the world.

ECONOMIC RECOVERY AND GROWTH

After the genocide Rwanda's economy was severely depressed. But 25 years down the line the country has achieved strong economic growth and impressive improvements in standards of living.

According to a World Bank study, Rwanda's real GDP grew by more than 120% over two decades.

This remarkable growth trajectory has boosted the Rwandan Patriotic Front's ambitions to transform the country from a poor, agrarian rural society into an IT-driven, market-centered, middle-income African economy by 2020.

We would argue that this vision for success is not only too ambitious but harmful as well. This is because it is has benefited the ruling elite, foreign corporations and investors, with few benefits to the poor. A notable example is how millions of rural Rwandans were negatively affected by a government decision to replace smallscale and subsistence agriculture with commercial agribusiness and large scale ranching ventures.

Moreover, there are signs of strain within the economy. Key world players like the International Monetary Fund, who have often praised Rwanda's economic progress, are now warning that despite its achievements "The Rwandan economy

remains vulnerable to external shocks and fiscal risks."

Rwanda is very well aware that it is impossible to meet its Vision 2020 goal. As a result, authorities have now extended their development deadline to 2035. But even with more time to achieve the vision, financial institutions like the World Bank are estimating that at the current rate of growth Rwanda will barely cross the threshold for lower middle-income status by 2035.

AUTOCRATIC LEADER

The autocratic governance in Rwanda's pre-genocide era was one of the key factors that led to the 1990-1994 civil war and the genocide that followed.

It would therefore have been prudent for the post-genocide government, led by the Rwandan Patriotic Front, to embrace democratic governance. Instead, the new regime established a government of national unity by incorporating other political parties and, within no time, Rwanda became a de facto one-party state with all the power concentrated in the hands of one man - Paul Kagame.

Today, Rwanda is identified as an authoritarian regime. The 2018 Democracy Index - a global governance report assembled by The Economist - noted that Rwanda is a democracy in name only.

The authors of the index observed that the Rwandan Patriotic Front, "Professes a commitment to political pluralism but has proved to be unprepared to loosen its grip on power and allow space for genuine, non-violent opposition."

This is a fair assessment. Kagame has shown a reluctance to relinquish his grip on the presidency. In 2015, he successfully engineered a constitutional amendment that allowed him to run for a third term in office. And in the August 2018 presidential elections, he was reelected for a third seven-year term with a reported 99% of the vote.

It is well known in Rwanda that challenging Kagame is risky. As a result he faces minimal opposition. Those who have challenged him have paid the price. Most of the candidates who opposed him in the last three elections spent time in jail.

NO FREEDOM

Autocratic governance is also reflected in the lack of freedom in Rwanda. In its 2018 report, Freedom House, ranked Rwanda as "Not Free" stating that while the regime has maintained peace and economic growth, it has also suppressed political dissent through pervasive surveillance, intimidation, and suspected assassinations.

In March 2019, Anselme Mutuyimana of the United Democratic Forces of Rwanda became the latest in a long line of opposition politicians to be found dead.

His body showed signs of strangulation and Human Rights Watch reported Mutuyimana's death as the "latest in a long line of murders, disappearances, politically motivated arrests, and unlawful detentions in Rwanda, especially of suspected government opponents."

The Rwanda Investigation Bureau promised to investigate his death but justice is unlikely to be served. All the previous investigations into suspected assassinations have been flawed.

On his part, Kagame has spoken publicly about the assassination of his enemies. In March 2019, he bragged about the assassination of former Interior Minister Seth Sendashonga saying, "Seth Sendashonga died because he had crossed the line. I have little to say about that, but I am also not apologetic about it."

President Kagame uttered these words in the presence of the entire Rwandan leadership, and he knew well that neither the legislature nor the judiciary would dare initiate any proceedings to hold him accountable.

This kind of brazen authoritarian leadership has forced many Rwandans into exile and prompted refugees to remain in their host countries. Some of those refugees are active members of a growing number of armed groups who want to unseat President Kagame.

If Kagame doesn't allow political reforms, there is a possibility that violence on a large-scale could repeat itself, putting in peril Rwanda's economic achievements, and making Vision 2035 unattainable.


Campaign ends for first phase Lok Sabha poll in Bengal

KOLKATA, APR 9 (PTI): The high voltage campaign for the first of the seven-phase Lok Sabha elections in West Bengal concluded on Tuesday.

Prime Minister Narendra Modi of the BJP, West Bengal Chief Minister and TMC supremo Mamata Banerjee, and top leaders of the Congress and Left parties have campaigned for this phase in which two seats of north Bengal will go to polls on April 11.

Issues ranging from corruption to communalism, NRC to chitfund scams, and, development to security featured in the speeches of the warring party leaders.

The high-pitched campaign was mainly polarised between Banerjee and Modi.



The first phase electoral battle is going to be held in Cooch Behar (SC) and Alipurduar (ST) seats, both having The Trinamool Con- a four-cornered contest among the TMC, the BJP, the Congress and Left Front constituents Forward Bloc and Revolutionary Socialist Party (RSP)

The TMC has fielded Paresh Adhikari against the BJP's Nisith Pramanik in Cooch Behar where Piya Roy Chowdhury of the Congress and Gobinda Roy of the FB are also in the fray.

In Alipurduar, the TMC nominated Dasarath Tirkey against John Berla of the BJP, while Mohanlal Basumata of the Congress and Mili Oraon of the RSP will also contest from the constituency.

A total of 18,09,598 electorates will decide the fate of 11 contestants in Cooch Behar, while 16,42,285 voters will choose from seven contestants in Alipurduar.

The Election Commission has made elaborate security arrangements with the deployment of central and state forces to ensure a free fair and peaceful poll.

Polling personnel have already left for 2010 polling stations in Cooch Behar seat and 1834 polling stations in Alipurduar seat.

Besides general election observers and expenditure observers, the poll panel for the first time deployed a special police observer Vivek Dube.

In another first, VVPAT will be used in all polling booths along with the EVMs.

CPI(M) knocks EC's door as PM asks first time voters to vote for Balakot strike men



NEW DELHI, APR 9 (PTI): The CPI(M) wrote to the Election Commission on Tuesday alleging violation of the poll panel's directive after Prime Minister Narendra Modi at a rally in Maharashtra asked first-time voters to dedicate their votes to the brave men who carried out the air strike in Pakistan's Balakot.

The Election Commission had last month asked all political parties to desist from using photographs of defence personnel as part of their election propaganda or campaigning.

World's top 10 all seeking first Masters green jacket

Augusta (United States), beau (sixth), Rickie Fowl-Ap 9 (AFP): There's a major hole on the career accomplishments list for the world's 10 al -- none of them owns a Masters champion's green jacket.

It's the first time since the global rankings began in 1986 that the entire top 10 arrived at the year's first major tournament and none of them had ever won the Masters, including new world number one Justin Rose of England.

"If you look at the skill sets of the guys at the top of the world rankings, Augusta really should suit most of us," Rose said. "So I would say that this year there's probably a very good probability that one of those guys will get it done."

Third-ranked Rory McIlroy of Northern Ireland, a four-time major winner, needs a Masters win to become only the sixth golfer to complete a career Grand Slam.

There's a trio of top-10 Americans with major wins lacking one at Augusta National, including second-ranked Dustin Johnson, three-time major winner Brooks Koepka (fourth) and 2017 PGA Championship winner Justin Thomas (fifth).

"I think it's just a coincidence that nobody in the top 10 has won the Masters," Thomas said. "It definitely speaks to the new wave of players."

Three more US players seek their first major title: Bryson DeCham-

er (ninth) and Xander Schauffele (10th).

Mix in reigning seventh-ranked reigning top-ranked golfers this British Open champion week at Augusta Nation- Francesco Molinari of Italy and sixth-ranked Spaniard Jon Rahm, who shared fourth last year in only his second Masters start, and there's an element of extra hunger under the Georgia pines this week.

"The most important thing I learned last year is that Augusta National, expect for the par-5s, plays over par," Rahm said. "So if you make par, don't get frustrated. That's just the way it is around this course."

Rahm, 24, could not claw back from an opening 75 last year despite firing the lowest Masters thirdround score of 65, but won the Spanish Open the following week.

"I hope my putting is a lot better than it was last year," Rahm said. "I feel strong in every part of my game. I just want to make a few more putts than I did last vear.

The only golfer among the world's top 16 who has won the Masters is 14-time major winner Tiger Woods. And the 12thranked American, now 43, won his most recent of four Masters crowns in 2005.

Thunderstorms closed the course Monday afternoon with more severe weather forecast Tuesday, but most players in the field of 87 -- matching the smallest since Woods won in 1997 -- practiced before the rain struck.

NE people to be consulted before bringing up citizenship bill: Rijiju

A day after the BJP promised in its election manifesto to enact the Citizenship (Amendment) Bill if voted back to power, Union minister Kiren Rijiju said Tuesday people of the northeastern states will be consulted before bringing up the bill.

Even if the bill is implemented in the rest of the country, there will be special provisions for the region, Rijiju said.

The contentious bill seeks to grant Indian citizenship to people belonging to minority communities Hindus, Sikhs, Buddhists, Jains, Parsis and Christians in Afghanistan, Bangladesh and Pakistan after six years of residence in India even if they do not possess proper documents.

A largescale protest had broken out in the northeastern states earlier this year as the indigenous people of the region apprehended the enactment of the bill would endanger their livelihood and identity.

"If other states of the country want the bill to be enacted, the BJP is committed to bring it. However, for the northeast, the party will consult the people before taking any decision which is clearly mentioned in the manifesto," the minister of state

"There should be no doubt among the people of the region, the BJP is committed to protect their rights," Rijiju said.

The bill, being vehemently opposed in the region even by some allies of BIP, was passed in Lok Sabha on January 8. However, it is set to lapse on June 3, when the term of the present Lok Sabha ends, as it could not be passed in Rajya Sabha.

The Union minister, who is seeking re-election from Arunachal West parliamentary constituency, said no other dispensation had attached so much importance to the northeast as the NDA government. Even Indians of oth-

er states cannot settle in Arunachal Pradesh, Nagaland and Mizoram that are 'protected' under special provisions of the Constitution, he said.

However, for other 'unprotected' states of the region such as Assam, Manipur, Meghalaya and Tripura, the government has decided to introduce the National Register of Citizens (NRC) in which only genuine Indian citizens would be included, he said.

With introduction of the NRC, refugees who have already settled in the region due to reli-

On the contentious Permanent Resident Certificate (PRC) issue in Arunachal Pradesh, which left three people dead and private and public properties damaged in February, Rijiju claimed that people have already realised who were responsible for the violence.

"The people have also realised the mission of the BJP. It is committed to peace, progress and development," Rijiju said adding that the party would work for a "clean election" drive in the state after coming to power.

"Clean election is the hallmark of clean governance. We will try to make election clean without involvement of cash for a better Arunachal,"

Suarez returns to England with much to gain and nothing to prove

BARCELONA, APR 9 (AFP): His goal against Atletico Madrid on Saturday should prove Barcelona's knock-out blow in La Liga and now Manchester United are tasked with containing the might of Luis Suarez in Europe.

The image of Lionel Messi's partner-in-chief has been defined by his darker side, a relentless, ferocious and, occasionally, misguided opponent, running defenders ragged for the best part of a decade.

Two months before his clash with Chiellini, Suarez had been named the Premier League's PFA Players' Player of the Year and won the division's Golden Boot award after scoring 31 goals for Liverpool.

In four seasons at Anfield, he hit 82 goals in 133 games, a ratio better than both Thierry Henry and Robin van Persie at Arsenal, Alan Shearer at Newcastle and Didier Drogba at Chelsea.

For Barcelona, who paid Liverpool just over 80 million euros to sign Suarez in 2014, his contribution has been clouded less by indiscipline and more by Messi, the player around whom the whole team revolves.

Suarez is Messi's provider, runner and foil but has managed to perform the role without losing sight of what he can bring too.

Algeria lawmakers elect first new president in 20 years

ALGIERS, APR 9 (AFP): Lawmakers named the speaker of the upper house as Algeria's first new president in two decades Tuesday, after the resignation of Abdelaziz Bouteflika mass protests.

The election of Abdelkader Bensalah as interim president follows constitutional rules but goes against the demands of demonstrators, who have pushed for him and other top politicians to stand down.

"I want to work towards fulfilling the interests of the people," Bensalah told parliament on taking up the 90-day interim presidency.

He is not only "not tolerated by the citizen movement, which demands his immediate departure, but also by the opposition" and various political groups in both houses of parliament, the newspaper said.

On Friday -- in the first weekly mass protest since Bouteflika announced his departure after losing the military's support -- Algerians demanded regime stalwarts be excluded from the political transition.

Three men in particular have drawn ire: Bensalah, head of the constitutional council Tayeb Belaiz and prime minister Noureddine Bedoui.

The protest movement is calling for a new transitional framework that is committed to deep reforms and organising free elections.

Ahead of Bensalah's appointment, calls continued for the speaker to step down.

"He has to resign, it's the voice of the people and the people must be right," said 50-year-old Mourad, an entrepreneur who will protest Friday with his two young daughters.

"They don't know that there's democracy... I want to teach them what freedom is," he added.

Algerians of all ages have rallied since late February against Bouteflika, who resigned a week ago after efforts to appease demonstrators proved fruitless.

But although the 82-year-old's resignation was celebrated by protesters, they have remained firm in pushing for a wider overhaul of the political system.

Human Rights Watch said Bouteflika's departure is "at most a first step in ending autocratic rule." "During any transitional phase, authorities should fully respect the rights of Algerians to speak, assemble and associate with one another," the watchdog said in

a statement.


Q12. Is it possible to vote more than once by pressing the button again and again?

Even if one presses that button further or any other button, no further vote will be recorded. This way the EVMs ensure the principle of "one man, one vote". The next vote is enabled only when the Presiding Officer/Polling Officer in-charge of the Control Unit releases the Ballot by pressing the Ballot Button. This is a distinct advantage over the ballot paper system.
