Three-day Green Film Festival & Forum to begin in Gangtok today

SAGARCHETTRI GANGTOK, 14 SEPT:

three-day **⚠**Unique Green Film Festival & Forum on Environment and Wildlife is set to begin here on Wednesday. The festival is scheduled to be inaugurated by Minister to Forest, Environment & Wildlife Department, KarmaLoday Bhutia here at SidkeongTulku conference hall of Forest Department at Deorali.

The event is being organized by SECURE Himalaya Project of UNDP with the support of Forest, Environment & Wildlife Department, Government of Sikkim and Ministry of Environment, Forest & Climate Change, Government of India and CMS Vatavaran. The festival and forum is part of the 9th CMS Vatavaran Travelling Film Festival and Forum in four Himalayan cities of Uttarkashi, Gangtok, Keylong and Leh.

Addressing a press conference here on Tuesday, CMS Vatavaran



Deputy Director, SabyesachiBharti mentioned that the main idea behind the event is to encourage conservation through films, festivals and forums. He added that the festival also aims to reach and engage a cross-section of stakeholders in environment conservation and also provide a platform to showcase initiatives and

activities of SECURE Himalayas.

Due to the COVID-19 pandemic, only 35 participants, including college students and NGO members, have registered for this three-day long event.

Mr Bharti informed that the event will include a two-day long capacity building workshop on 15 and 16 September on Environmental Filmmaking and Mobile Journalism, which will have a faculty member of SKIFT at Film & Television Institute of India, Mojo Educator, Film & Photography Educator, RiteshTaksande.

The event will also screen national and international nominated and awarded films on environment & wildlife issues at the venue along with spot quiz and drawing competition on environment for students during film screening. The closing and award ceremony of the festival will be held on 17 September.

He said that the idea behind the event was to support the unique green movements for environment conservation through films, festivals and forums. Such a festival would give ideas to youths in filmmaking and mobile journalism and ultimately encourage them to know the importance of biodiversity and its conservation, he added.

Covid claims one more, Sikkim's toll reaches 378

GANGTOK, 14 SEPT:

With the virus claiming a life in the past 24 hours, Sikkim's Covid death toll climbed to 378 today after having held at 377 for three consecutive days. This was the first COVID-death recorded in the State this week. The new fatality was reported from Namchi District Hospital in South District, the Daily Report of COVID-19 in Sikkim released by the Integrated Disease Surveillance Programme of the Health Department this morning informs.

Meanwhile, Sikkim count of active Covid cases has come down to 777 with the discharge of 77 more people from home and facility isolation on Monday after making full recoveries. With this, the state's figure of recovered cases has further improved to 29,242.

Infections meanwhile remained low over the same period with 46 people testing positive for COVID-19 from the screening of 695 samples yesterday giving the state a daily test positivity rate to 6.6%.

While 28 of these new cases picked up in rapid antigen testing of 400 samples and 18 were detected in RT-PCR testing of 293 samples.

Of the 46 new cases, 22 were registered in East District, 11 in West District, 12 in South District and 01 in North District. Sikkim's tally of the confirmed cases of COVID-19 has reached 30,696.

In the past 24 hours, only ten more COVID patients were hospitalized in the State, taking the number of Covid patients in hospital to 60 [out of the 777 active cases]. Of the patients in hospital, eight are admitted in ICU facilities at STNM Hospital and CRH.

Of the 60 Covid patients in hospital, only four are under 18 years of age none of whom are in ICU.

On the vaccination front, 2,567 more received their Covishield shots on Monday, of whom 152 received the first dose and 2,415 completed their vaccine schedules with the second dose.

Stalled 15 times by BJP from visiting constituency: Ex-Tripura Chief Minister Manik Sarkar

NEW DELHI. 14 SEPT [PTI]: Former Tripura Chief Minister and CPI(M) leader Manik Sarkar on Tuesday alleged that he was prevented from visiting several areas of the state and his constituency by the ruling BJP multiple times. Manik Sarkar served as chief minister of Tripura from 1998 to 2018.

This comes days after CPI(M) general secretary Sitaram Yechury wrote to Prime Minister Narendra Modi alleging violence against the Left party's cadre by the BJP in the state.

Sitaram Yechury and Manik Sarkar lashed out at the BJP over violence in Tripura at a press conference today.

"In Tripura, the Constitution of India doesn't work. CPI(M) MLAs, including me, aren't being allowed to visit their constituency. In the 42 months that the BJP has



parts of the state and my Constituency," Manik Sarkar alleged. The two Left lead-

ers claimed that there is a "huge discontent" against the BJP government in Tripura.

"The CPI(M) is spearheading efforts to galvanise people's protest. They (BJP) do not want to allow this process and are unleashing violence," Mr Yechury alleged.

A few days ago, in his letter to the prime minister, Mr Yechury had alleged that the party's offices in Tripura were attacked by "mobs of BJP men" in a "pre-planned fashion" on September 8.

In the letter, the leader has alleged that the "impunity" with which the attackers operated shows the "connivance of the state government".

Dzongri-Goechala trekking route opens for tourists

YUKSAM, 14 SEPT:

The popular Dzongri-Goechala trek-**■** king route inside the UNESCO World Heritage site, Khangchendzonga National Park (KNP), in West Sikkim has opened for trekking and tourism after the Central and State Government removed restrictions on national parks and zoos recently. Khangchendzonga National Park,

covering an area of 1,784 sq kms in northern and western part of Sikkim, is famous for the Dzongri-Goechala trekking route. The Dzongri-Goechala trekking

route starts from Yuksam, the first capital of Sikkim.

Now tourists, international and domestic, are again allowed to take the trek inside KNP.

The Chief Wildlife Warden signaled the lifting of restrictions by issuing an order on 10 September.

Following the Ministry of Environment's order shutting down all nation-



al parks and sanctuaries in the country due to Covid, the State Government had closed down Khangchendzonga National Park along with other sanctuar-

ies in the first week of May this year.

Along with trekking inside KNP, trekking and hiking to Barsey Rhododendron sanctuary, along the Indo-

Nepal border at Chewa Bhanjyang, through the Singalila range from Uttarey in West Sikkim is also open for hiking, trekking and tourism activities.

Meanwhile, nearly 90 percent of tourism stakeholders such as tour operators, trekking guide, trekking cook, porters, yak and horse man (pack animal operators), tourist vehicle drivers have completed their vaccination schedule and are eligible to operate following CO-VID-19 protocols and safety measures.

After the announcement of reopening of tourism activities inside Khangchendzonga National Park, KNP division under the state Forest Department convened a meeting with local tourism stakeholders and pack animal operators to oversee the conditions of trekking route and trekkers huts inside

KNP-Range Officer, Tenzing W Bhutia informed that trekking trail inside the KNP is blocked at several stretches due to landslides during this monsoon.

UNION HEALTH MINISTER ON INDIA'S HANDLING OF COVID

World's largest adult vaccination program prepares India for grand leap forward in Atma-Nirbharta

Ceventy-five years after attaining **J**freedom from foreign rule, our search for freedom of a different kind continues—this time the country is seeking freedom from an invisible invader—the SARS-CoV-2, which has been ravaging the country for the past 20 months. From what we know about this deadly virus, it can be tamed by following Test-Track-Treat and vaccination strategy at administrative level and encouraging adherence to Covid-Appropriate Behavior through community participation.

But to eliminate it, we needed a lasting immunity against it. Indian scientists and agencies have pushed the physical and technical boundaries to develop COVID-19 vaccines within a record period and on 16 Jan, 2021, our Prime Minister launched the world's largest adult vaccination program by introducing two "made in India" CO-VID-19 vaccines. The introduction of India-made vaccines within weeks of the global introduction of COVID-19 vaccines was also the beginning of an exciting period in the public health history of India.

Perhaps, this is one of the very few upsides of the COVID crisis—we have had the rare opportunity to build a healthcare infrastructure on mission mode that will do much more than just leave us stronger for future onslaughts

of the kind we are currently facing.

Under the leadership of our Prime Minister, Narendra Modi, the country has been investing a great deal of its resources in strengthening the healthcare system since March 2020 when the first few COVID cases were detected. Alongside, an entrepreneurial ecosystem for vaccine research and development, developing new diagnostics techniques as well as treatment modalities were put in place. Mission COVID Suraksha made special and proactive efforts to provide financial and technical assistance to the established vaccine manufacturers for ramping up the manufacturing capacity and start-up biotech units for exploring the new vaccine platforms and product devel-

As a result, in less than a year, vaccines were developed, tested, approved and a nationwide immunization program was rolled out. Within couple of months, the country became self-reliant in the production of masks. PPE kits, testing devices, etc. that were critical to our fight against COV-ID-19. These COVID sensitive interventions created an enabling environment in fight against COVID-19 virus.

To further accelerate vaccination coverage, the Prime Minister's decision to make vaccine free for all eligible beneficiaries at public health facilities across India demonstrated a strong political commitment at the highest level towards public health.

It is remarkable that in a matter of few months, India has administered over 750 million doses of COVID-19 vaccines, among the highest globally. Currently, over 1.1 million beneficiaries are receiving the COVID vaccines in a single day. I strongly believe that it is the people's whole-

hearted participation in the vaccination program that has made it such a success.

The Covid-19 vaccination drive, which aims to vaccinate the entire population of the country by the end of this year, is also yielding valuable lessons for further refining our universal immunization program and other health initiatives. Our ever-expanding Covid-19 vaccination program can become an effective entry point for delivering primary healthcare, nutrition, water, and sanitation related services to our citizens. The rapid augmentation of our healthcare facilities across the country will help us ensure that everyone has equitable access to quality healthcare.

Our healthcare and frontline workers have worked with great commitment and dedication to achieve this momentous feat of having administered 75 crore doses of COVID-19 vaccines a fitting tribute to our 75 years of "Azadi ka Amrit Mahotsav".

The world's largest adult vaccination program is also strengthening India's resolve toward Atmanirbharta. The Atmanirbharta has to be inclusive and embrace complementary collaborations for essential technology and leverage the essential interdependence across the sectors and countries. Vaccine research

and development and manufacturing are similar to rocket science and nuclear program. A lot of scientific, manufacturing, technology and quality assurance pro-

cesses are involved in this. There is therefore a need to create an ecosystem that encourages enterprise and domestic production of vaccines, including required raw material, using advanced technologies. For this to happen, sustained strategic investments have been made in research and development, enabling collaborations and policy support to achieve the goal and sustain them.

The revolutionary vaccine program (both development and implementation aspects) and disease surveillance measures for COVID-19 will have a long-term impact on India's immunization program.

The pandemic has forced us to experience the fragility of life and to pay urgent attention to healthcare. It has also taught us that we no longer have the luxury of time to wait, experiment, and take small steps to build our healthcare ecosystem. The moment has come for the great leap forward—and the country is prepared to do that.

FTA review with ASEAN NEW DELHI, SEP 14 (PTI): India and the 10-member ASEAN bloc should strive to announce the review of the free trade agreement (FTA) between them before the yearend, Minister of State for Commerce and Industry Anupriya Patel suggested on Tuesday.

The issue came up for discussion during the 18th ASEAN-India Economic Ministers Consultations.

ASEAN-India Trade in Goods Agreement was signed on August 13, 2009. It came into force on January 1.

The Association of Southeast Asian Nations (ASEAN) members are -- Indonesia, Thailand, Singapore, Malaysia, the Philippines, Vietnam, Cambodia, Myanmar, Brunei and Laos.

Patel resolved to complete the scoping process expeditiously to make the agreement trade facilitative, user-friendly with contemporary and streamlined customs and regulatory procedures, the commerce ministry said in a statement.

She stated that the trade arrangement has to be reciprocal, mutually beneficial and should balance the aspirations of all the partners.

Patel emphasised on the need for securing the FTA provisions to prevent misuse of preferential treatment and also highlighted the non-tariff measures faced by Indian exporters in accessing ASEAN market, especially in agriculture and auto sectors.

"Patel suggested that both sides should make earnest efforts to finalize the scoping paper before the ASEAN-India Leaders' Summit scheduled in October, 2021 and to announce the review before the end of this year," it said.

KNP division has started restoration work on the Dzongri-Goechala trekking trail with the help of local pack animal operators, it is informed and may take a week to completely restore it.



Embrace Plurality of Opinions

...even if mass media would have you shun them

rime-Time on Indian TV news channels makes for stressful viewing with the shallow-jingoism and mock-conscientiousness of frowning celebrity anchors who have become caricatures of themselves or poor imitations of the bigger stars and the fingerpointing self-righteousness of party spokespersons who fulminate only to earn brownie points with their respective masters. While very little is achieved by way of informing the audience, the hypnotic spell of real-time quarrels entering homes gets the TRPs soaring, urgently dramatic music completing the experience and convincing people that something important was playing on TV. Since the suggestion of sensationalism can fool only for so long, occasionally, newsrooms manufacture sensational situations as well and almost always, they pander to the lowest common denominator of the ideology in power because they command the most brainwashed of lumpen elements to unleash and sustain another news cycle. The superficial nationalism of TV news crews was earlier focused on Syed Ali Shah Geelani and Arundhati Roy, and then moved to the likes of Kanhaiya and other left-leaning youth and now just rails against anyone who calls out the dangerous pontification that has come to define national discourse.

Most times, the media instigation plays circles around its own hyperbole, and occasionally they muddy the waters enough for pressing concerns to swim out of the public domain. Unfortunately, we have also become a nation where agenda is set by the belligerence of 24x7 TV news channels and the slew of soundbytes and studio fulmination often lead to ill-advised action and almost always succeed in distracting people from the core issues facing the nation. Every time that happens is a sad day for democracy, because the only attitudes being increasingly reinforced are intolerance, insensitivity and the impassivity of the mainstream which instigates so many mutinies in our country.

The idea of India was always to embrace plurality, not only of people and communities, but also views and opinions, increasingly however, the focus has been more on homogenising everything, starting from defining what is Indian to heckling multiplicity out of public discourse. For a long while it was the government which engaged in this exercise of compartmentalisation, but of late, mass media has joined the bandwagon as well, allowing vocabulary like "splittist, extremist, hardline, controversial, inflammatory" to infiltrate their reportage without adequate attention paid to how such identifiers can bias audiences towards a particular opinion. Has anyone noticed how the brainwashing efficacy of noise on TV has made even "liberal" a character flaw?

Responsible professionalism has fallen victim to the demands for sensationalism which is why the basic tenets of freedom and democracy need to be reiterated often. No one should have an issue with the fact that free citizens have a right to hold independent opinions and broadcast them. Even if one were to ignore the principles of democracy, it follows for civil people to realise that while everyone has the right to hold opinions and share them, none has the right to foist or force these opinions on anyone or instigate violence.



Perilous Situation for Afghan Allies Left Behind Shows a Refugee System That's Not Up to the Job

resident Joe Biden has hailed the end of the U.S. engagement in Afghanistan as a historic achievement, with 120,000 people evacuated by air. Behind the widely viewed scenes of chaos at the Hamid Karzai International Airport, a massive effort of volunteers and nongovernmental organizations used social media to help identify, locate and advocate for Afghans desperate to leave the country, using social media. It has been characterized as a "digital Dunkirk" – in reference to the mass evacuation of Allied soldiers by sea during World

Nonetheless, the president and his administration have weathered considerable criticism about the execution of the long-planned withdrawal, much of it focused on the complex and frustrating process for Afghan allies who needed visas in order to leave the country and head to the U.S.

In mid-July, U.S. Embassy staff in Kabul raised the alarm about the Taliban's advances, recommending that the administration take action to speed up the protection of Afghan allies by granting them what's called a "special immigrant visa," also known as the SIV.

Had the visa process worked better, more Afghan allies might have been able to flee possible deadly retaliation by the Taliban.

"The SIV program is obviously not designed to accommodate what we just did, in evacuating over 100,000 people," U.S. Secretary of Defense Lloyd Austin explicitly acknowledged in a press conference at the end of the airlift.

And the perilous situation of Afghans who want to flee now, but can't, is a reminder that populations face terrible danger in conflict zones across the globe - but aren't able to make their way to safety in other countries.

REFUGEE PROTECTION

SIVs allow Afghan and Iraqi interpreters and translators for the U.S. military whose work "placed a target on their backs" to come live in America.

In 2009, a distinct Afghan SIV program was established by the U.S. and was originally designed to provide 7,500 visas over five years. The quota does not include family members who are entitled to come to the U.S.

For years, advocates have raised concerns about serious delays with processing visas - up to 3 ½ years at one point. Some advocacy groups even sued the federal government to break the logjam.

With the onset of the COVID-19 pandemic, the what's called "lily pad sites," for further security Trump administration slowed the review process even more. That move was part of a larger policy to allow fewer refugees into the country.

A QUESTION OF PLANNING

A backlog of 17,000 cases in the Afghan SIV program faced the Biden administration in January 2021. Throughout the spring, advocates urged the administration to take more urgent steps to expand the program's focus and get Afghan allies to the U.S. faster and in greater numbers.

It was not until mid-July 2021 that Operation Allies Refuge was launched by President Biden to evacuate SIV applicants who were in later stages of

By the end of July, Congress authorized the approval of 8,000 additional visas for the applicants, waived the onerous pre-approval medical examination requirements and removed other restrictions. In early August, the administration expanded protection to a larger category of people - known as "P2" - such as those who worked for nongovernmental organizations and media outlets in Afghanistan supported by the U.S.

But by Aug. 13, evacuation of SIV applicants was deemphasized to make way for U.S. citizen evacuation from Afghanistan. Government insiders and advocates criticized the U.S. State Department at that time for delays in processing SIV applications and failure to coordinate with the Pentagon to get applicants into the Kabul airport.

OTHER OPTIONS

Defense Secretary Austin also acknowledged that the SIV program was "designed to be a slow

Immigration experts have pointed out that the Biden administration had a number of other options, based on prior experiences with Haitians and Cubans as well as Vietnamese, Iraqi Kurd and Kosovar Albanian refugees, to expand and speed up refugee protection.

Afghans are eligible, for example, for quicker forms of refugee protection, such as humanitarian parole, which allows individuals who face dangerous conditions in their home country to gain emergency entry into the U.S., though the status is temporary and without benefits. Using the regular U.S. Refugee Admissions Program would have required raising the quotas and dealing with its own back-

In the end, many of the 100,000 or so Afghans who were trying to get SIVs or other forms of protection were evacuated to other countries, to screenings before entry into the U.S.

LEFT BEHIND

The estimates of individuals remaining in Afghanistan who are at risk for Taliban persecution are staggering and difficult to confirm.

Before the evacuation ended, advocates claimed that 65,000 SIV-eligible applicants and their families remained, while eligible P2 applicants and their families were estimated in a range from almost 200,000 to, potentially, millions.

These numbers do not account for Afghans who worked at the forefront of nation building, including for the government, women's and human rights organizations, the media and the United Nations mission. Even before the fall of Kabul, Afghans were the second-largest refugee population globally, after Syrians.

And what these people - especially women and girls – face is currently extremely precarious. A new government is taking shape that represents the hard-line Taliban leadership of the past.

While the Taliban have sought to reassure the international community that they will allow Afghans to leave the country and respect human rights, recent violence against women's rights protesters and reports of human rights abuses belie the posturing. The ISIS-K attack on the Kabul airport indicates how fragile Taliban security could be. Law and security scholars have warned against global recognition of a terrorist-controlled govern-

Amid a growing humanitarian disaster involving hunger and extreme poverty, the United Nations estimates that half a million more Afghans might seek refugee status by the end of 2021.

While declaring an end to U.S. military deployments to support nation building, President Biden has asserted his commitment to make human rights central to his foreign policy.

Minimizing the military's role should be welcome to experts who contend that it is the U.S.-led war on terror that failed in Afghanistan, not nation building.

How exactly this helps Afghans who want to flee but haven't been able to yet isn't clear. And how to ensure the wide-scale protection of populations facing mass atrocity and human rights violations without the threat of U.S.-led coalition military power also remains uncertain - in Afghanistan and anywhere else across the globe.

What happens when your foot falls as leep?

 $\mathbf{W}^{ ext{hat}}$ hat happens when your foot falls asleep? – Helen E., age 8, Somerville, Massachusetts

Imagine you've just sat down to watch your favorite TV show. You decide to snuggle in with your legs crisscrossed because you find it more comfortable that way.

When the episode ends, you try to stand up and suddenly your right foot isn't working. At first you just can't move it, then it feels like it has pins and needles all over it. For a minute or two it feels uncomfortable and weird, but soon enough you are able to stand up and walk around normally.

WHAT JUST HAPPENED?

I'm an exercise physiologist - a scientist who studies what happens to our bodies when we move and exercise. The goal of much of my research has been to understand how the brain talks to and controls the

different parts of our bodies. When your foot falls asleep, there is something wrong with the communication between your brain and the muscles in that area.

Every time you decide to move your body, whether it's standing up, walking around or playing sports, your brain sends signals to your muscles to make sure they move correctly. When the brain is unable to talk with a muscle or groups of muscles, some weird things can happen - including that part of your body getting that weird falling-asleep sensation.

It usually starts with a sense of numbness or tingling in that area. This sensation, which people often also call "pins and needles," is technically known as paresthesia.

Some people mistakenly think a lack of blood flow causes this feeling. They imagine the "asleep" feeling happens when your blood, which carries nutrients all over your body, is unable to get to your foot. But that's

When your foot falls asleep, it's actually because the nerves that connect the brain to the foot are getting squished thanks to the position you're sitting in. Remember, it's these nerves that carry messages back and forth to let your brain and your foot communicate with each other. If the nerves have been compressed for a little while, vou won't have much feeling in your foot because it can't get its normal messages through to your brain about how it feels or if it's moving.

Once you start to move around again, the pressure on the nerves is released. They "wake up" and you'll start to notice a "pins and needles" feeling. Don't worry, that feeling will only last for a few minutes and then everything will feel normal again.

Now comes the important question: Is this dangerous? Most of the time, when your foot, or any other body part, falls asleep, it is temporary and nothing to worry about. In fact,

since it lasts for only a minute or two, you may not even remember it happened by the end of the day.

Even though it's not causing any permanent damage, you might still want to avoid the uncomfortable feeling that comes when your foot falls asleep. Here are a couple of tips that may help:

Switch your position often. Don't cross your legs for very long.

When you are sitting for a long time, try standing up every so

You probably can't 100% prevent your foot from ever falling asleep. So don't worry when it happens every once in a while. It'll go away pretty quickly - and maybe it can remind you of all the important brain messages your nerves are usually transmitting without your even noticing.

Making money in boxing means never having to say you're sorry. Not for allowing Evander Holyfield to risk his life at the age of 58 just to make a few bucks. Certainly not for stealing money from gullible fans for a farce of a pay per view show that would have done terrible damage to the sport if only the sport wasn't so badly damaged already.

No one was apologizing — at least loud enough to hear — among the crew at Triller Fight Club, a fledging promotional outfit on the fringe of boxing. They managed to get Holyfield licensed in Florida and moved the entire card there on short notice from California after planned headliner Oscar De La Hoya pulled out with what he said was COVID-19.

Holyfield wasn't apologizing, either, after being credited with landing just one punch before being stopped in the first round by a former MMA fighter. The Real Deal apparently now lives on the edge of reality as he suggested after the fight he wanted another bout — this one against Mike

Somewhere else in boxing, though, there was an apology. An apology both rare and heartfelt from a judge who said he messed up.

The best thing about it? It came out of nowhere, like a perfect left

Stephen Blea was one of three judges ringside Friday night in Tucson as hometown hero Oscar



Valdez took on Robson Conceicao in a junior lightweight title bout. It was a familiar position for Blea, who estimated he had officiated more than 60 title fights as a judge for referee in rings around the world.

On this night, the sellout crowd was cheering — and cheering loudly — for Valdez. In his ringside seat, Blea also had to deal with photographers on one side of him and a camera crew in constant motion on the other.

Still, "I honestly thought I would be able to do my Job 100%, no excuses," he said.

But the crowd noise influenced Blea early. He scored some rounds for Valdez that could have been scored even, or for Conceicao

In the end, Blea got the winner right. But his 117-110 margin stood out in a fight that was extremely close (the other two judges had it 115-112 Valdez). Auction for New IPL teams to take place on October 17: report

 $\mathbf{B}^{ ext{idding}}$ for the two League (IPL) franchises will take place on October 17, sources told ANI.

The bidding for the two new Indian Premier League (IPL) teams is set to take place on October 17. Interestingly, while the last day for queries in regards to bidding for the teams is September 21, the bids can be picked till October 5. Speaking to ANI, sources in the know of developments confirmed the same. "The bidding is set to take place on October 17 while queries regarding the same can be made till September 21," the source said. The Governing Council of the Indian Premier League (IPL) had on August 31 invited bids to acquire the right to own and operate one of the two new teams proposed to be introduced to take part in the tournament from the 2022 season, through a tender process.

"The detailed terms and conditions governing the submission and evaluation of bids including eligibility requirements. process for submissions of bids, proposed new teams' rights, and obligations, etc. are contained in the 'Invitation to Tender (ITT)' which will be made available on receipt of payment of non-refundable fee of INR 10,00,000 (Rupees Ten Lakhs Only) plus any applicable Goods and Services Tax," the BCCI had said in an official re-

The ITT is available for purchase till October 5. Interested parties have been requested to send an email to BCCI to get further details for purchasing the ITT. The email requesting the ITT should have the subject line "ITT for the Right to Own and Operate One of Two Proposed New IPL Teams".

Any interested party wishing to submit a bid is required to purchase the ITT. However, only those satisfying the eligibility criteria set out in the ITT and subject to the other terms and conditions set out therein, shall be eligible to bid.

It is clarified that merely purchasing this ITT does not entitle any person to bid. BCCI reserves the right to cancel or amend the bidding process at any stage in any manner without providing any reason.

New-Look inter Milan begin Champions League campaign against Real Madrid

Inter Milan will host ter than his more il-Real Madrid in their Champions League opener on Wednesday.

Simone Inzaghi is trying to put Inter Milan's rocky recent European past behind him as his side prepare for the visit of Real Madrid and an attempt to finally make it to the Champions league knockouts. A long, hot summer at the Italian champions seems to be cooling down now that the new season has got underway, as memories of the departed stars RomeluLukaku, Achraf-Hakimi and Antonio Conte -- as well as the financial problems that led to their exits -- are shunted aside in face of a new-look Nerazzurri side which has started the campaign well.

Seven points from the first three matches of the season is not a bad haul for new coach Inzaghi, although after missing a host of chances in Sunday's 2-2 draw at Sampdoria the former Lazio boss will be wondering why it isn't a perfect nine.

And after a promising opening few weeks domestically he now he has the chance to go one betlustrious predecessor Conte did in his two years in charge at the San Siro and make it past the group stage.

"I'm not thinking about last season because it's since 2010 (2011, Ed) that Inter haven't get into the last 16. That's not last season, it's the last 10 years," Inzaghi told reporters on Tuesday.

"That's a statistic that we want to change at all costs."

Inter also have the chance to get revenge on two of the sides who denied them a place in the knockout rounds last vear, with Madrid and Shakhtar Donetsk again paired with Inter, this time in Group D with minnows Sheriff

'I think that what happened with the two matches with Madrid last season is the past. Now we have a great chance to write an exciting new page," said Inzaghi.

"It won't be a very easy group but our hope is that we can get through it."

While Inter obviously miss the firepower of one of the world's best strikers, Inzaghi still has a strong base from which to attack the competition, with Copa America winner Lautaro Martinez in form up front and one of Italy's Euro 2020 heroes NicoloBarella shining in midfield.

New signings Edin-Dzeko. HakanCalhanoglu and Joaquin Correa have all settled in well but up to now have only faced modest opposi-

Wednesday's match is a much sterner test against a Madrid side which lead La Liga and have scored 13 times in four matches, with nine of those strikes coming from red-hot Karim-Benzema and Vinicius

The Delhi Capitals players who were part of the Indian squad for the Test series against England landed in Dubai safely on Sunday for the second half of the IPL 2021.

The players, including Rishabh Pant, RavichandranAshwin, AjinkyaRahane, Ishant Sharma, Axar Patel, Prithvi Shaw and UmeshYadav, underwent Covid tests upon arrival in Dubai.

"The players will be serving a 6-day hard quarantine, as per IPL protocols, during which they will be tested thrice. Thereafter, the players will join the rest of the Delhi Capitals squad, who are already part of the bio-bubble," said Delhi Capitals in its official statement.

The Board of Control for Cricket in India (BCCI) had informed all franchises that every player coming in from the UK would have to undergo six days of hard quarantine before they join the existing team bubbles in UAE for the resumption of the 2021 edition of the IPL.

The 14th season, which was postponed in May this year in the wake of the COVID-19 pandemic, will resume on September 19 in Dubai with a blockbuster clash between Chennai Super Kings and defending champions Mumbai Indians.

Meanwhile rubbishing claims that IPL played a part in the cancellation of the 5th Test, BCCI president SouravGanguly on Monday had said that players were afraid to take the field after second physioYogeshParmar tested positive.

"No, no, the BCCI will never be an irresponsible board. We value other boards too," Ganguly said when asked whether IPL played a role in the calling off of the fifth

"The players refused to play but you can't blame them. PhysioYogeshParmar was such a close contact of the players. Being the only one available after Nitin Patel isolated himself, he mixed freely with the players and even performed their COVID-19 tests," Ganguly added.

Following the cancellation, the BCCI had offered the England board to reschedule the cancelled Test at a later date.

Egypt team identifies fossil of

land-roaming whale species

Founder of South Korea's biggest church, Cho Yong-gi, dies

SEOUL, SOUTH KOREA (AP): The Rev. Cho Yong-gi, whose founding of South Korea's biggest church was a symbol of the postwar growth of Christianity in the country before that achievement was tainted by corruption and other scandals, died Tuesday. He was 85.

Cho, an emeritus pastor at Seoul's Yoido Full Gospel Church, died at a Seoul hospital where he had been treated since he collapsed due to a cerebral hemorrhage in July 2020, the church said.

"He conveyed the gospel of hope to the Korean people who fell into despair after the Korean War," the church said in a statement. "He was instrumental in growing the Korean church, particularly developing Yoido Full Gospel Church as the world's largest church."

Better known as David Yonggi Cho or Paul Yonggi Cho abroad, the late pastor started his church in Seoul with five worshippers in 1958, when South Korea was still struggling to rebuild itself from the ashes of the 1950-53 Korean War. Under his leadership, the church achieved explosive growth and become a symbol of the rapid growth of Christianity in what was then a deep-



ly Confucian country.

In 1993, the church had more than 700,000 members, making it the world's biggest church congregation according to Guinness World Records, the church said. Church officials said its membership has since declined to about 600,000 and that they cannot confirm whether their church remains the world's largest.

It's still the largest Protestant church in South Korea. Church officials said it has 400 pastors and evangelists in South Korea and 500 missionaries abroad.

Despite his achievement, Cho and his family have been embroiled in scandals in recent years.

In 2017, he was convicted of breach of trust and causing down as the church's top pas-

financial losses to the church but avoided jail as he received a suspended prison term. In 2013, a female politician filed a paternity suit against one of his sons. His family has also faced long-running criticism that they dominated key posts at the church and other church-related organizations.

In 2008, Cho stepped

tor and a non-family member succeeded him in what the church called "an unprecedented, democratic" power transition. In South Korea, many church founders hand over their leadership positions to their children.

Lee Hunjoo, secretarygeneral of the Christian Alliance For Church Reform, a Seoul-based NGO, said the fast rise of Cho's church led other churches in South Korea to push excessively to expand their own congregations.

"It's true that the Rev. Cho did meaningful work for Korean churches," Lee said. "But in some sense, megachurches in South Korea began with Cho's Yoido Full Gospel

According to a 2015 government census, Protestantism was the biggest religion in South Korea, followed by Buddhism and Catholicism. There were about 9.7 million Protestants at the time, accounting for nearly 20% of the country's then 49 million people.

Cho is survived by three sons. His funeral is set for Saturday, and the church will receive mourners from Wednesday, according to the

of a four-legged prehistoric whale, unearthed over a decade ago in the country's Western Desert, is that of a previously unknown species. The creature, an ancestor of the modern-day whale, is believed to have lived 43 million years ago.

CAIRO (AP): Egyptian

scientists say the fossil

The prehistoric whale, known as semiaquatic because it lived both on land and sea. sported features of an accomplished hunter, the team's leading paleontologist, HeshamSallam, told The Associated Press — features that make it stand out among other whale fossils.

The fossil was first found by a team of Egyptian environmentalists in 2008 in an area that was covered by seas in prehistoric times, but researchers only published their findings confirming a new species last month.

Sallam said that his team did not start examining the fossil until 2017 because he wanted to assemble the best and the most talented Egyptian paleontologists for the study.

"This is the first time in the history of Egyptian vertebrate paleontology to have an Egyptian team leading a documentation of a new genus and species of four-legged whale," said Sallam.

The fossil sheds light on the evolution of whales from herbivore land mammals into carnivorous species that today live exclusively in water. The transition took place over roughly 10 million years, according to an article published on the discovery in the journal Proceedings of the Royal Society B.

Egypt's Western Desert region is already known for the so-called Whale Valley, or Wadi Al-Hitan, a tourist attraction and the country's only natural World Heritage site that contains fossil remains of another type of prehistoric whales.

The newly discovered creature belongs to the family of Protecetids. extinct semi-aquatic whales that lived from 59 to 34 million years ago, Sallam said. It would have walked on land but also hunted in the water.

"This is yet another

new species of early whales from the time when they retained four functional limbs," said Jonathan Geisler, an expert on the evolutionary history of mammals with New York Institute of Technology. He said that the location of the discovery in Egypt is also a clue as to when and how they spread around the globe. Geisler was not involved in the find.

The oldest fossil whales are about 50 million years old and are believed to have originated in modern-day Pakistan and India. However, scientists have not been able to reach a conclusive answer as to when whales moved out of their point of origin to all the world's oceans.

"This new species by itself cannot answer that question, but when viewed in the context of other fossil discoveries. suggests that this dispersal occurred 43 million years ago," said Geisler, adding the new find could possibly serve as a link between Indo-Pakistan and North American regions. The fossil whale has been been named Phiomicetus Anubis, after the god of death in ancient Egypt.

"We chose the name Anubis because it had a strong and deadly bite," said Sallam, professor of paleontology at Mansoura University in Egypt. "It could kill any creature it crossed paths with."

The new species stands out for its elongated skull and snout that suggest it was an efficient carnivore capable of grasping and chewing its prey, he said. It was about 3 meters (9 feet long) and weighed around 600 kilograms, according to researchers. It is also believed to have had sharp hearing and sense of smell.

Violating the official secrets law carries a maximum penalty of 14 vears in prison. The colonial-era statute criminalizes the possession, collection, recording, publishing, or sharing of state information that is "directly or indirectly, useful to an enemy."

The exact details of Turnell's alleged offense and those of the others have not been made public, though state television, citing government statements, has said the Australian academic had access to "secret state financial information" and had tried to flee the country.

Turnell has been confined in Yangon's Insein Prison, known for decades for holding political prisoners.

Meanwhile, the trial

of SuuKyi, 76, and two colleagues continued Tuesday at a special court in Naypyitaw, a day after she had to cancel her participation because of illness. The court on Monday allowed her to return to her place of detention -- which is kept secret by the authorities -- after she explained that she was suffering from cold symptoms and felt dizzy on the ride to the court. KhinMaungZaw, said her condition had visibly improved Tuesday when she returned to court, though she inthat she still felt some dizziness. Her co-defendants on several charges, former President Win Myint and Naypyitaw ex-Mayor MyoAung, were also in attendance.

SuuKyi is being tried in Naypyitaw on charges of sedition, defined as spreading information that could cause public alarm or unrest, and sometimes termed incitement; two counts of flouting COVID-19 pandemic restrictions during the 2020 election campaign; illegally importing walkie-talkies for her bodyguards to use; and unlicensed use of the ra-

SuuKyi's lawyers have argued in court that the sedition case should not be prosecuted, and both her team and the prosecution on Tuesday presented arguments to the court on that matter, KhinMaungZaw said.

Two prosecution witnesses failed to show up to testify about the CO-VID-19 restrictions case and the testimony of a third was postponed, he said.

KhinMaungZaw also told reporters that the defense lawyers had SuuKyi sign documents appointing them to represent her in corruption cases filed in the central city of Mandalay.

Military junta to open talks over Guinea's future post-coup



CONAKRY, Guinea (AP): bauxite and gold exports threatened sanctions underscores the fragility Guinea's junta is expected to face more pressure Tuesday to set a timeframe for new elections as the military rulers open a four-day series of meetings about the West African nation's future following the coup just over a week ago.

Concerns are growing about how quickly the junta led by Col. MamadyDoumbouya will give up power to a civilian-led transitional government as called for by regional mediators and the international community.

The coup has been cautiously welcomed by other longtime opponents of deposed President Alpha Conde including Guinea's most prominent opposition figure, CellouDaleinDiallo, who had lost to the ousted leader in the last three presidential elections.

Anger over Conde's quest for a third term last year led to violent street demonstrations, and many in the capital, Conakry, have shown support for the military takeover. How long that lasts could depend on what deals are struck at this week's meetings.

Among those taking part are leaders from Guinea's mining industry, whom the junta leader has sought to reassure in a bid to prevent the destabilization of critical that hold up the country's economy.

On Tuesday, the junta kicks off talks by meeting with officials from Diallo's party, the Union of Democratic Forces of Guinea, and other critics of Conde. Later it will welcome religious leaders to the People's Palace, where earlier it summoned officials from the ousted government and demanded they hand over their passports and keys to government vehicles.

After wrapping up a visit to Conakry on Monday, the head of the U.N. Office for West Africa and the Sahel said he was placing "a lot of hope" on this week's meetings.

"Because whatever the international community will say or do, the fate of Guinea is what the Guineans themselves will decide," AnnadifKhatirMahamatSaleh said.

Diallo, the three-time presidential candidate, has made clear he'd like to run if new elections are organized. In an interview with The Associated Press on Sunday he called the ousted president a dictator who brought about his own demise because of his defiance of constitutional term limits.

The West African regional bloc known as ECOWAS already has

less the junta releases the deposed president, as it did last year when a military coup took place in neighboring Mali.

"I call on them not to sanction Guinea, but to accompany the new authorities in the rapid return to constitutional order within a reasonable timeframe through the organization of inclusive, free and transparent elections," the longtime Guinean opposition leader told the AP.

After Mali's August 2020 coup, ECOWAS imposed sanctions and proposed a one-year deadline for the political transition. Regional mediators later acquiesced to the junta leaders and accepted an 18-month timeframe that now appears in doubt as February 2022 approaches. After agreeing to a civilian transitional government following the coup, Col. AssimiGoita effectively staged another coup nine months later by firing the president and prime minister and later declaring himself president of the transition.

Both Guinea and Mali had gone years without military coups, leading some to think they might have become a thing of the past. Even if a deal is struck this week in Guinea, observers say the Mali situation unof such agreements with military juntas.

Some fear that if left unchecked, the coups in West Africa could encourage militaries elsewhere to stage takeovers of their own. Earlier this year, the military in Chad also seized power after longtime President IdrissDebyItno was slain, putting his son MahamatIdrissDeby in charge even though Chad's constitution had called for power to be transferred to the National Assembly president.

NiagaleBagayoko, chair of the African Security Sector Network who focuses her research on West and Central Africa, said the threat extends beyond military coups to include presidents who try to change their country's constitutions to remain in power.

"What it is at stake today is: Do we continue to support democratically elected authorities, and what does it mean to be democratically elected?" she said. "The problems that we do have in the sub-region, not only in countries where a coup happened, is that you have both unconstitutional civilian kinds of coups and military coups. And it's difficult to fight against the latter when there's not been really any condem-

nation for the former."





'Jeopardy!' begins season with already-ousted Richards



NEW YORK (AP): The very brief Mike Richards era on "Jeopardy!" began on Monday as the beleaguered game show dealt with the embarrassment of opening its 38th season with a host that its fans already know is toast.

Richards stepped down as Alex Trebek's replacement on Aug. 20, and was ousted as the show's executive producer a week and a half later, after it was discovered podcasts he had made in 2013 and 2014 contained demeaning remarks about women and

His selection as host by Sony Pictures Television after a lengthy run of tryouts by other personalities was already unpopular with fans before the old podcasts surfaced.

His ouster came after he had completed a week's worth of taping shows for the new season, and Sony couldn't redo them without affecting the game's integrity.

Richards was introduced as host Monday by a downcast-sounding announcer, Johnny Gilbert. Not a word was mentioned of his status as Trebek's replacement; if it had been originally, it

Before he was introduced, it was

noted that Trebek's widow and children had been on hand for the stage's dedication to its old host, who died of cancer last October.

"For the first time on the Alex Trebek stage, let's play 'Jeopardy!," Richards said.

In keeping with Trebek's tradition — he considered the game and its playa backseat to the action.

The show is in the midst of an historic run by Matt Amodio, a Ph.D student from New Haven, Connecticut. He won his 19th straight game on Monday, increasing his total winnings to \$642,601, behind only Ken Jennings and James Holzhauer.

Amodio made quick work of competitors AmdeMengistu of Brooklyn, N.Y., and Gabbie Kim, of Pittsburgh, Pennsylvania, winning \$67,800 on Monday.

"Jeopardy!" next week will bring actress MayimBialik back as guest host before beginning another series of tryouts for Trebek's permanent replacement.

The Richards era will end after five shows. Trebek, who began in 1984, totaled more than 8,200.

Amazon brings palmswiping tech to Red Rocks concert venue

NEW YORK (AP): Your palm could soon be your ticket into a concert. Amazon says it is bringing its palm-recognition technology to the Red Rocks Amphitheatre in Denver and it will be available at other venues in the coming months. It's the first time the technology, called Amazon One, will be used outside some of Amazon's stores, where shoppers can pay for groceries and snacks by swiping their palms.

Starting Tuesday, concertgoers at Red Rocks can sign up to connect their palm to a ticketing account by hovering their hand over a device. They only need to sign up once and then can use their palm to get into other shows and events at the venue. An Amazon account is not needed to use it.

Amazon signed a deal with entertainment company AEG to bring the technology to Red Rocks, which sells tickets on AEG's ticketing site, AXS.
