EC gives go-ahead to GST Council meeting on March 19



New Delhi, Mar 13 **(PTI):** The Election Commission has given approval for holding the upcoming GST Council meeting on March 19 to consider various issues including the implementation of lower GST rates for the real estate sector.

The next meeting will be held through videoconferencing, sources said. Following the approval from the Election Commission. sources said, notices have been sent from the GST Council Secretariat to states for the 34th meeting of the Council on March 19, they said.

The nod from the Election Commission was required as the Model Code of Conduct has been in force since Sunday.

The meeting will be held to discuss only transition provision and related issues for the implementation of lower GST rates for the real estate sector, the sources said. In the previous meeting, the high-powered GST Council slashed tax rates for under-construction flats to 5 per cent and affordable homes to 1 per cent, effective April 1. Currently, the goods and services tax (GST) is levied at 12 per cent with input tax credit (ITC) on payments made for under-construction property or ready-to-move-in flats where completion certificate is not issued at the time of sale. For affordable housing units, the existing tax rate is 8 per cent.

GST collections in February dropped to Rs 97,247 crore from Rs 1.02 lakh crore in the previous month.

Of this, Central GST was Rs 17,626 crore, State GST (SGST) stood at Rs 24,192 crore, Integrated GST Rs 46,953 crore and cess was Rs 8,476 crore. GST collections in the current fiscal till February totalled Rs 10.70 lakh crore.

The government has lowered the GST collection target for the current fiscal to Rs 11.47 lakh crore in the Revised Estimates, from Rs 13.71 lakh crore budgeted initially.

GST collection stood at Rs 1.03 lakh crore in April, Rs 94,016 crore in May, Rs 95,610 crore in June, Rs 96,483 crore in July, Rs 93,960 crore in August, Rs 94,442 crore in September, Rs 1,00,710 crore in October, Rs 97,637 crore in November, Rs 94,725 crore in December 2018

Many schools in Meghalaya have only two or four students: Minister

SHILLONG, MAR 13 (PTI): Meghalaya Education Minister Lahkmen Rymbui told the Assembly on Wednesday that there are many schools in the state where there are only two or four students.

While the teacher-pupil ratio is 1:30, Rymbui said there are many Sarva Siksha Abhiyan (SSA) schools which are functioning with two teachers teaching only two or four students.

"We are in the process to rationalise teachers placement in SSA schools so that resources of the government is not wasted," he said.

In Meghalaya, there are 395 lower primary schools with 808 teachers and 508 upper primary schools with 1874 teachers, he informed.

On the delay of payment of salaries to school teachers, the Minister said the disbursement of salaries take place as and when the funds are



released from the Centre.

The Minister replying to a call attention moved by opposition Congress MLA Mayralborn Syiem on the delay in construction of an SSA lower primary school building at Khlieh Umwang village in Ri Bhoi District said the lower primary school building in the village along the inter-state boundary with Assam was demolished by Assam Police.

He said the incident had taken place in August last year wherein a departmental inquiry was made.

According to the report, some part of the building, which was under construction and sanctioned by the office of the Ri-Bhoi District Mission Coordinator for the year 2017-18 was destroyed by the Assam police.

The minister said the state government is taking the issue seriously and solutions to the problem are being explored so that social and educational developmental works could be implemented for the benefit of the children living in those areas.

Model Code of Conduct guidelines



SUMMIT REPORT GANGTOK, 12 MAR [IPR]:

With the announcement of Schedule for General Election to the 17th Lok Sabha and the Legislative Assemblies including Sikkim, the Model Code of Conduct for guidance for Political parties and Candidates have come into force w.e.f 10 Mar, 2019.

The Chief Secretary of Sikkim held a meeting with all HODs and briefed them on enforcement of Model Code of Conduct and guidelines to be adhered by all Government Department and authorities.

The following instructions have been reiterated through Home Department Circular dated 11 Mar, 2019:

1. Conduct of Government

Servant:-No Government servant shall take part in party politics such as public meetings, campaigns, rallies, etc. and they will act in neutral manner in respect of political party.

Use Govt. Vehicles: There is a total ban on use of official vehicles for touring in districts by any political party, candidate or any person connected with election except officials performing election related duty. The ban is applicable to Government vehicles, Public Sector Under-

takings, Cooperative

Societies etc.

- Funds: Discretionary All spending from the discretionary fund is stopped immediately
- Leave and transfer of government servants: leave of Government servants related to Elections to be avoided. Ban on transfer, appointment or promotion of all employees of government and Public undertakings.
- The MCC prohibits any party or candidate from making use of any Government accommodation including office premises for the purpose of election propaganda

Schemes undertaken for tackling emergencies related to natural disasters should be done after prior approval of Commission.

Prohibition of announcement of new projects, programmes, new sanctions and concession of financial grants in any form. No work shall start in respect of which even if the work orders have heen issued before the Model Code of Conduct came into effect, if the work has actually not started in the field.

Also instruction has been received for removal of all unauthorized political advertisement, all wall writings, posters, defacement in any other forms on Government property, public property and in public spaces. Further, no advertisement shall be issued in electronic and print media highlighting the achievements of the Government at the cost of public exchequer. All photographs of political functionary from official website have to be removed. Direction has been issued to all concerned departments to furnish a list of work which has already started on the ground and list of fresh work which has not started on the ground for development construction related activities to the office of the CEO/ DEO within 72 hours of date of announcement of the Elections.

Curtailing Corruption

Read, notice, realize and demand accountability

In the year 2017, the Legislative Assembly was informed that a total of 515 corruption cases had been registered by the Vigilance Police in Sikkim in the past 23 years. This works out to an average of around 22 Vigilance "cases" every year. That works out to two per month with a December off. But averages can be misleading and it would be more interesting to also find out how these cases are spread out over the years, when they record a slump or when they surge. Meanwhile, something like 259 government servants and 256 private citizens have been implicated in these cases and chargesheets have been drawn up in 183 instances.

This is quite a number. But has it had any effect on corruption?

Corruption cannot be tackled by government agencies instituted directly to combat this problem, the noise about CBI in Sikkim is thus just that, noise. After all, these agencies, whether the CBI or the Vigilance, with their charter to investigate corruption, become convenient weapons of mass political destruction. In the hands of politicians, as we see often with CBI and many would claim even with Vigilance, this arsenal gets aimed at reputations and does not target the faulty system itself. The system, after all, outlives reputations and political dynasties and everyone in the political rat-race will want the system sustained in its murky existence so that it can be oiled to serve their needs when they command it. This explains why such agencies make raids, file FIRs and draw up chargesheets into major media events, but downplay the actual trial and verdicts or even the processing of such cases.

Even when earnestly implemented and enforced without bias, this approach addresses only one end of the corruption chain. A more effective option would be for those who feed this monster to decide otherwise. Corruption would get automatically contained. But that is easier said than done and would require a ground swell of civil activism, even the tremors of which not yet in the making; at least not in Sikkim yet.

Does that mean that corruption cannot be contained? What would life be without some optimism? Of course corruption can be contained; by deploying guerrilla tactics that seem to serve every de-prioritised issue so well. Instead of knocking on doors of anti-corruption agencies, the people should start studying documents produced by the non-aggressive arms of the executive like the CAG reports and the even the annual reports of respective departments with more interest. These documents encapsulate findings and claims and each links up with accountability. It is because people continue to ignore the importance of fixing accountability and demanding it that the system continues to corrode. The voters have to demand of their elected representatives to hold departments and its officials accountable. The leaders need votes and if the voters lay the condition of accountability in exchange for support, then their representatives will deliver them accountability. Once the message gets through that transgressions in handling of public accounts will no longer be excused with merely "don't do it again" advise, things will start falling into line. Corruption would have been curtailed to a significant extent.

The internet is now an arena for conflict, and we're all caught up in it

Most people think the internet operates as a kind of global public square. In reality, it's become a divided arena where conflict between nation states plays out.

Nation states run covert operations on the same platforms we use to post cat videos and exchange gossip. And if we're not aware of it, we could be unwittingly used as pawns for the wrong side.

How did we get here? It's complicated, but let's walk through some of the main elements.

THE AGE OF ENTANGLEMENT

On the one hand, we have an information landscape dominated by Western culture and huge multi-national internet platforms run by private companies, such as Google and Facebook. On the other, there are authoritarian regimes such as China, Iran, Turkey and Russia exercising tight control over the internet traffic flowing in and out of their countries.

We are seeing more cyber intrusions into nation state networks, such as the recent hack of the Australian parliamentary network. At the same time, information and influence operations conducted by countries such as Russia and China are flowing through social media into our increasingly shared digital societies.

The result is a global ecosystem perpetually close to the threshold of war.

Because nations use the internet both to assert power and to conduct trade, there are incentives for authoritarian powers to keep their internet traffic open. You can't maintain rigid digital borders and assert cyberpower influence at the same time, so nations have to "cooperate to compete".

DATA FLOWS IN ONE DIRECTION

Authoritarian societies such as China, Russia and Iran aim to create their own separate digital ecosystems where the government can control internet traffic that flows in and out of the country.

The Chinese Communist Party is well known for maintaining a supposedly secure Chinese internet via what is known in the West as the "Great Firewall". This is a system that can block international internet traffic from entering China according to the whim of the government.

For the majority of the 802 million people online in China, many of the apps we use to produce and share information are not accessible. Google, YouTube, Facebook, Twitter are blocked. Instead, people in China use apps created by Chinese technology companies, such as Tencent, Alibaba and Baidu.

Traffic within this ecosystem is monitored and censored in the most sophisticated and comprehensive surveillance state in the world. In 2018, for example, Peppa Pig was banned and the People's Daily referred to her as a "gangster" after she became iconic of rebelliousness in Chinese youth culture.

COMPLETE BLOCKING OF DATA IS IMPOSSIBLE

A key objective of this firewall is to to shield Chinese society and politics from external influence, while enabling internal surveillance of the Chinese population.

But the firewall is not technologically independent of the West – its development has been reliant upon US corporations to supply the software, hardware innovation and training to ensure the system functions. And since the internet is an arena where nations compete for economic advantage, it's not in the interest of either side to destroy cyberspace entirely.

As cyber security expert Greg Austin has observed, the foundations of China's cyber defences remain weak. There are technical ways to get around the firewall, and Chinese internet users exploit Mandarin homophones and emoji to evade internal censors.

Chinese economic and financial entanglement with the West means complete blocking of data is impossible. Consistent incentives to openness remain. China and the United States are therefore engaged in what Canadian scholar of digital media and global affairs Jon R Lindsay describes as:

"chronic and ambiguous intelligence-counter intelligence contests across their networks, even as the internet facilitates productive exchange between them."

That is, a tension exists because they are covertly working against each other on exactly the same digital platforms necessary to promote their individual and mutual interests in areas such as trade, manufacturing, communications and regulation.

Since Russia is less dependent upon the information technology services of the United States and is therefore less entangled than China, it is more able to engage in bilateral negotiation and aggression.

DIFFERENT STYLES OF INFLUENCE

If the internet has become a contest between nation states, one way of winning is to appear to comply with the letter of the law, while abusing its spirit.

In the West, a network of private corporations, including Twitter, Google and Facebook, facilitate an internet system where information and commerce flow freely. Since the West remains open, while powers such as Russia and China exercise control over internet traffic, this creates an imbalance that can be exploited.

Influence operations conducted by China and Russia in countries such as Australia exist within this larger context. And they are being carried out in the digital arena on a scale never before experienced. In the words of the latest US Intelligence Community Worldwide Threat Assessment:

"Our adversaries and strategic competitors [...] are now becoming more adept at using social media to alter how we think, behave and decide."

The internet is a vast infrastructure of tools that can be used to strategically manipulate behaviour for specific tactical gain, and each nation has its own style of influence.

I have previously written about attempts by China and Russia to influence Australian politics via social media, showing how each nation state utilises different tactics.

China takes a subtle approach, reflecting a long term strategy. It seeks to connect with the Chinese diaspora in a target country, and shape opinion in a manner favourable to the Chinese Communist Party. This is often as much as about ensuring some things aren't said as it is about shaping what is.

Russia, on the other hand, has used more obvious tactics to infiltrate and disrupt Australian political discourse on social media, exploiting Islamophobia – and the divide between left and right – to undermine social cohesion. This reflects Russia's primary aim to destabilise the civic culture of the target population.

But there are some similarities between the two approaches, reflecting a growing cooperation between them. As the US Intelligence Community points out:

"China and Russia are more aligned than at any point since the mid-1950s."

A STRATEGIC ALLIANCE BETWEEN RUSSIA AND CHINA

The strategic origins of these shared approaches go back to the early internet itself. The Russian idea of hybrid warfare – also known as the Gerasimov Doctrine – uses information campaigns to undermine a society as part of a wider strategy.

But this concept first originated in the Chinese People's Liberation Army (PLA). In 1999, Chinese PLA colonels

penned a strategy titled Unrestricted Warfare, which outlined how to use media, government, pretty much everything, in the target country not as a tool, but as a weapon.

It recommended not just cyber attacks, but also fake news campaigns – and was the basis for information campaigns that became famous during the 2016 US presidential election.

In June 2016, Russia and China signed a joint declaration on the internet, affirming their shared objectives. In December 2016, Russian President Vladimir Putin signed off on a new Doctrine of Information Security, which establishes how Russia will defend its own population against influence operations.

Observers noted the striking similarity between the Russian document and Chinese internet law.

Russia and China also share a view of the global management of the internet, pursued via the United Nations:

"[...] more regulations to clarify how international law applies to cyberspace, with the aim of exercising more sovereignty – and state control – over the internet."

The recent "sovereign internet" bill introduced to the Russian Parliament proposes a Domain Name System

(DNS) independent of the wider internet infrastructure. If the internet is now a site of proxy war, such so-called "balkanization" challenges the dominance of the United States.

Nations are competing for influence, leverage and advantage to secure their own interests. Russia and China don't want to risk an all out war, and so compe-

tition is pursued at a level just below armed conflict.

Technology, especially the internet, has brought this competition to us all.

WE'RE ENTERING TURBULENT WATERS

Despite its best efforts, China's leaders remain concerned that the digital border between it and the rest of the world is too porous.

In June 2009, Google was blocked in China. In 2011, Fang Binxing, one of the main designers of the Great Firewall expressed concern Google was still potentially accessible in China, saying:

"It's like the relationship between riverbed and water. Water has no nationality, but riverbeds are sovereign territories, we cannot allow polluted water from other nation states to enter our country."

The water metaphor was deliberate. Water flows and maritime domains define sovereign borders. And water flows are a good analogy for data flows. The internet has pitched democratic politics into the fluid dynamics of turbulence, where algorithms shape attention, tiny clicks measure participation, and personal data is valuable and apt to be manipulated.

While other nations grapple with the best mix of containment, control and openness, ensuring Australia's democracy remains robust is the best defence. We need to keep an eye on the nature of the political discussion online, which requires a coordinated approach between the government and private sector, defence and security agencies, and an educated public.

The strategies of information warfare we hear so much about these days were conceived in the 1990s – an era when "surfing the web" seemed as refreshing as a dip at your favourite beach. Our immersion in the subsequent waves of the web seem more threatening, but perhaps we can draw upon our cultural traditions to influence Australian security.

As the rip currents of global internet influence operations grow more prevalent, making web surfing more dangerous, Australia would be wise to mark out a safe place to swim between the flags. Successful protection from influence will need many eyes watching from the beach.

Developing countries are bad at collecting taxes. What can help

The ability to raise revenues from taxes – called "fiscal capacity" – is a crucial aspect for the functioning of any state. Being able to tax citizens, and collect it efficiently, is a cornerstone of state formation and survival. Secondly, greater fiscal capacity implies greater access of the state to resources needed to provide public goods.

Developing countries are only able to raise a small share of taxes. Typically they collect only between 10% to 20% of GDP. The average in high-income countries is double this at 40%.

These low rates are the consequence of many problems. First, the large size of the informal economy. Second, a lack of investment in tax collection – most developing countries rely on sales taxes, which are easier to administrate than personal taxes, but entail lower revenues.

Low tax collection rates have devastating consequences on development. They mean that governments aren't able to invest in public goods such as health, infrastructure and education. Even the sustainable development goals, which aim, among other things, to build effective, accountable and inclusive institutions at all levels have set mobilising revenues as a goal on its own.

In our paper on taxation in developing economies we focus on the question: why do they tax so little? We focus particularly on the role of the state in creating an environment conducive to collecting taxes. And we also try to offer some solutions.

We posit that political systems that place strong constraints on executive power would be more likely to lead to taxation systems that have a higher degree of accountability and transparency than heavy handed measures to enforce compliance.

BASIC RELATIONSHIPSWe lay out some basic relationships

about how tax revenue as a share of GDP varies with per capita income and with the breadth of a country's tax base. We then sketch a baseline model of what determines

a country's tax revenue as a share of GDP.

We begin with factors related to the economic structure of economies. But we argue that there's also an important role for political factors, such as weak institutions, fragmented politics, and a

ters for a number of reasons.

Firstly, it means that citizens can control and limit the executive's access to resources. Citizens can also demand greater accountability from the state about what

happens to the taxes they pay.

Greater constraints on the executive can also make a country's tax system more transparent. Our findings, based on 47 countries, suggests that greater trans-

ghost ventures. In particular, there was an unexplained mismatch between the collected revenue of TSh 25.3 trillion (US\$10.88 billion) and the TSh 23.8 trillion (US\$10.24

billion) government expenditure.

The Public Accounts Committee submitted a report in early February 2019 claiming:

"Our verification was limited by lack of supporting documents and adequate explanations from management (of the Ministry of Finance), which were necessary for ascertaining the accuracy and validity of amounts to be verified. For example, the Ministry was unable to provide documents such as the proper cash book for the consolidated funds and bank reconciliation statements that provide crucial underlying information for the figures under verification. The provided information was scattered in numerous sections and were subjected to frequent

adjustments in the course of verification."

This quote highlights two issues. First, Tanzania has a significant mismatch between planned and actual revenue and expenses, and it is unable to keep a record of its transactions. Second, public bodies are unwilling to share information with the public. Nor are they willing to be held accountable.

WHAT NEEDS TO BE DONE

Building a fiscally capable state won't bring benefits in the short term. Changing institutions takes time, and changes in the law don't immediately translate into changes in behaviour. But it's nevertheless key to consolidating working political institutions, providing strong checks and balances on the discretionary power of the executive and

building confidence among taxpayers.

In each case, we suggest the need for a dynamic approach that encompasses the two-way interactions between political, social and cultural factors and the economy.

There's no single answer to fixing a state's ability to collect taxes. The reasons for not being able to do so efficiently depends on a number of factors. These include historical ones, such as internal or external conflicts, and political factors, such as weak institutions or a weak sense of national identity. And finally, economic factors like a country's dependence on natural resources. WHY CONTROLLING THE EXECUTIVE

Holding executives to account mat-

more important in raising tax revenues than measures that only focus on coercing people into paying their taxes.

This effect is sizeable. We found

This effect is sizeable. We found that there were significant improvements when constraints were put on the executive. For example, over nine years there was a 2.4% increase in total revenues and income tax revenues as shares of GDP.

One country we looked at was Tanzania. An inability to hold the executive to account, plus lack of transparency, seem to be the main drivers behind the country's budgetary problems. Its tax collection rate is a mere 12.8%.

In March 2018 the Controller and Auditor General, Mussa Assad, presented his annual audit report for the 2016/2017 financial year. This showed that state institutions had diverted trillions of shillings into

The NER investigation wing on Tuesday issued orders for deployment of the 157 officials who will spread over seven states - Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland and Tripura, the sources said.



NEW DELHI, MAR 13 (PTI): The BJP Wednesday urged the Election Commission to declare West Bengal "super sensitive state" to enure fair Lok Sabha polls and demanded that central forces be deployed at all polling stations in the state.

A BJP delegation, including Union ministers Ravi Shankar Prasad, Nirmala Sitharaman, J P Nadda and party's general secretaries Bhupender Yadav and Kailash Vijayvargiya, met top officials of the poll body and apprised them of their demands.

Briefing the media after the meeting, Prasad said, "We have requested the Election Commission that the state of West Bengal should be declared as super-sensitive. And have also demanded that central forces should be deployed at all polling booths in the state."

He said the party has also requested the poll panel to transfer those police officers whose electoral impartiality is questionable as well as the withdrawal of former Kolkata Police Commissioner Rajeev Kumar from election duty.

Yadav Bhupender the delegation brought to the EC's notice incidents wherein the state bureaucracy has become "completely subservient" to the TMC, negating the "very doctrine of impartiality and fairness".

"The commission was

apprised of the fact that General Elections 2014 & Assembly Elections 2016 reveal a pattern of intimidation, fear and violence, negating the very essentials of free and fair elections. (BJP) Urged EC for a fair environment for peaceful conduct of Lok Sabha polls," he tweeted.

The BJP is trying to make inroads into TMC's bastion state (West Bengal) which has 42 Lok Sabha seats. In 2014, the Trinamool Congress (TMC) won 34 seats, the Congress four, while the BJP and CPI(M) bagged two seats each in the state. The state assumes importance for the saffron party as it aims to win a sizeable number of seats there.

The BJP delegation also alleged that Congress chief Rahul Gandhi broke the Model Code of Conduct (MCC) and complained to the poll panel regarding the same.

Rose Valley investors can approach asset disposal committee for refund: Official

KOLKATA, MAR 13 (PTI): The Enforcement Directorate (ED), probing into the multi-crore Rose Valley ponzi scam case, has urged the duped investors to approach the asset disposal committee appointed by the Calcutta High Court to recover their dues.

According to an ED official, the investors, who were promised high returns on their investments by the ponzi firm, are free to approach the committee which was set up following a high court sug-


gestion in 2015. "In the Rose Valley ponzi scam case, so far the ED has attached properties worth Rs 4,600 crore," an ED official, who did not wish to be named, told PTI.

The enforcement agency attached Rese Valley properties worth Rs 2,300 crore in one go, including two dozen hotels and resorts, which till date is the single largest attachment in the case.

The assets are to be sold off via public auction and the proceeds would be used to repay the investors. The ED had registered an FIR against the firm, its Chairman Gautam Kundu and others in 2014 under the Prevention of Money Laundering Act (PMLA).

Kundu was arrested by the agency in Kolkata in 2015.

Multiple charge sheets have been filed in the courts in Kolkata and Bhubaneswar by the ED in the case. The group had allegedly floated a total of 27 companies to run the chit fund operations, of which only 6 were active.



Dipa eyes Olympic berth with strong performances

New Delhi, Mar 13 (PTI): India's Dipa Karmakar will look to secure an Olympic berth with "some good performances" at back-to-back Artistic Gymnastics World Cups in Baku and Doha, beginning Thursday.

Dipa had claimed a bronze at the vault event of the Artistic Gymnastics World Cup in Cottbus, Germany in November 2018, to make a strong bid for her Olympic qualification.

It was Dipa's first appearance after recovering from a knee strain, which had spoilt her chances at the Jakarta Asian Games, where she missed the vault final and also had to pull out of the team event.

However, she recovered in time to secure a third-spot finish at Cottbus, keeping alive her chances of Olympic qualification. Although Dipa skipped the World Cup in Melbourne (February 21-24), she is now eyeing good outings at the two World Cups - Baku (March 14-17) and Doha (March 20-23).



Environment damage behind 1 in 4 global deaths, disease: UN

NAIROBI, MAR 13 (AFP): A quarter of all premature deaths and diseases worldwide are due to manmade pollution and environmental damage, the United Nations said Wednesday in a landmark report on the planet's parlous state.

Deadly smog-inducing emissions, chemicals polluting drinking water, and the accelerating destruction of ecosystems crucial to the livelihoods of billions of people are driving a worldwide epidemic that hampers the global economy, it warned.

The Global Environment Outlook (GEO) -- a report six years in the making compiled by 250 scientists from 70 nations -- depicts a growing chasm between rich and poor countries as rampant overconsumption, pollution and food waste in the developed world leads to hunger, poverty and disease elsewhere.

As greenhouse gas emissions continue to rise amid a preponderance of droughts, floods and superstorms made worse by climbing sea levels, there is a growing political consensus that climate change poses a future risk to billions.

World leaders in 2015 came up with the Paris climate deal, which saw each nation promise action to cut emissions in a bid to limit global temperature rises to 1.5C (2.7 Fahrenheit). But the health



impacts of pollution, deforestation and the mechanised food-chain are less well understood.

Nor is there any international agreement for the environment close to covering what the Paris accord does for climate.

The GEO compiles a litany of pollution-related health emergencies. It said that poor environmental conditions "cause approximately 25 per cent of global disease and mortality" -- around 9 million

deaths in 2015 alone.

Lacking access to clean drinking supplies, 1.4 million people die each year from preventable diseases such as diarrhoea and parasites linked to pathogen-riddled water and poor sanitation.

Chemicals pumped into the seas cause "potentially multi-generational" adverse health effects, and land degradation through mega-farming and deforestation occurs in areas of Earth home to 3.2

billion people.

The report says air pollution causes 6-7 million early deaths annually. And the way Earth is set, unchecked use of antibiotics in food production will see drug-resistant superbugs become one of the largest causes of premature death by mid-century. "Urgent action at an unprecedented scale is necessary to arrest and reverse this situation," said a note to policymakers accompanying the report.

"If you have a healthy planet it supports not only global GDP but it also supports the lives of the very poorest because they depend on clean air and clean water," Joyeeta Gupta, GEO co-chair, told AFP.

"If you turn that around, an unhealthy system has massive damage on human lives."

The report called for a rootand-branch detoxifying of human behaviour while insisting that the situation is not unassailable.

Food waste for instance, which accounts for 9 per cent of global greenhouse gas emissions, could be slashed. The world currently throws away a third of all food produced. That figure is fuelled by 56 percent in richer nations going to waste.

"Everyone is saying that by 2050 we have to feed 10 billion people, but that doesn't mean we have to double production," Gupta said. "If we reduce our waste and perhaps have less meat you could immediately reduce that problem." At the same time, she acknowledged, "that would require changes in the way we live."

The report also called for a rapid drawdown in greenhouse gas emissions and pesticide use to improve air and water quality. "Human behaviour is due to environment. It's the way we get around, it's the energy we use

and it's how we build our homes," GEO co-chair Paul Ekins said.

The report estimates that global infrastructure will increase by

two thirds by 2050.

"The way it is built will determine what kind of world we have," Ekins said. The GEO draws on hundreds of data sources to calculate the environ-

mental impact on over 100 diseases.

Its unveiling at the UN Environment Assembly in Nairobi is likely to add to the debate over who bears the greatest responsibility for the damage already borne by Earth. Sources close to the negotiations told AFP some developed nations, led by the United States, had threatened not to "welcome" the GEO report -- a procedural but nonetheless significant hurdle if nations are to agree on the necessary cuts in waste, overconsumption and pollution.

Gupta said that nations, however big or small, would all have to adapt to the environmental reality facing every human on the planet.

"If you look at land, it's fixed," she said. "If the population is going to go up we have to redistribute, one way or the other. "If you look at freshwater, it's more or less fixed. You have to end up sharing. This is a discourse that many developed countries don't like."

Cardinal George Pell sentenced to six years in prison in Australia for child sex abuse

(PTI): Cardinal George
Pell, the most senior Vatican official to be convicted of sex abuse to date, has been sentenced to six years in prison by an Australian court for the "callous" assault of two choir-

boys in the late 1990s.

A former senior adviser to Pope Francis, Pell, 77, was found guilty by a jury in December last year.

The County Court Chief Judge Peter Kidd, while delivering the sentence, described Pell's abuse of two choirboys in the sacristy at St Patrick's Cathedral in Melbourne as "a brazen and forcible sexual attack on the victims".

"There was a clear relationship of trust with the victims and you breached that trust and abused your position to facilitate this offending," the chief judge said.

"The brazenness of your conduct is indicative of your sense of authority and power in relation to the victims," he said.

The chief judge said Pell's abuse had had a "significant and long-lasting impact" on the wellbeing of one of his victims, whom he referred to as J.

The chief judge said he did not have the benefit of a victim impact statement from his other victim, referred to as R, who died of a heroin overdose in 2014 and never reported the abuse.

"However on the basis of J's account at trial I am able to say your offending must have had an immediate and significant impact on R," Kidd said.

"Whilst it is not possible for me to quantify the harm caused, or articulate precisely how it impacted on R in the long run, I have no doubt that it did in some way."

Pell will serve a minimum of three and eight months in jail before he will be eligible for parole. "I will impose a shorter non-parole period than I otherwise would have been inclined to impose in recognition in particular of your age, so as to increase the prospect of you living out the last part of your life in the community," the

felt it was too light, while others were happy to see justice being done. "I would have been happy with one month, one week," one said.

"I'm doing my best to hold myself and my family together."

Until last month Pell held the role of Vatican treasurer, considered by many to be the third most senior position within the Roman Catholic church.

Pell's legal team has previously announced it will appeal his conviction on three grounds, including that the jury's verdict on all five charges was unreasonable, based on the evidence submitted. The Court of Appeal is due to hear submissions in early June.

Reporting of the trial and verdict was suppressed by the court to avoid prejudicing a second trial, which crown prosecutors abandoned in February after the judge ruled some prosecution evidence couldn't be submitted.

UK set for another major Brexit vote to rule out no-deal exit

LONDON, MAR 13 (PTI): A day after British Prime Minister Theresa May's Brexit divorce bill was rejected in a bruising 149-vote defeat, MPs will return to the House of Commons on Wednesday to vote on whether to prevent the UK's exit from the EU by March 29 without any deal in place.

The latest motion to try and avert a chaotic no-deal Brexit, which would see Britain crash out of the 28-member economic bloc without any transition phase, follows a rejection of May's withdrawal agreement 391 to 242 despite a final push by her to try and convince hard-Brexiteers that the concessions she had won to the controversial Irish backstop clause would not see the UK tied to the EU rules indefinitely.

Speaking moments after yet another Parliament defeat over Brexit on Tuesday night, May said that MPs would have to decide whether they want to delay Brexit, hold another referendum, or whether they "want to leave with a deal but not this deal".

She made her own opposition to a no-deal Brexit very clear, warning of potential damage to the Union that leaving without a deal could do.

The motion to be voted on Wednesday reads: "This House declines to approve leaving the European Union without a withdrawal agreement and a framework on the future relationship on 29 March."

In an unusual move aimed at curbing further dissent between the various warring cliques within her own Conservative Party, May announced that her party MPs will be given a free vote on the motion and not be whipped to vote in any specific way by the government. It reflects the deep divisions that linger within her party over the issue. While some hard-Brexiteers such as former Cabinet minister Boris Johnson are in favour of a no-deal exit, there is unlikely to be a majority for it in Parliament. The Opposition Labour Party has been demanding no-deal be taken off the table for months now.

If no-deal is rejected, MPs will then vote on Thursday on delaying Brexit by extending Article 50 the legal mechanism that takes the UK out of the EU. This would have to be ratified by the EU and the length of extension will become the next focus on both sides.

However, how the EU will react to an extension request remains unclear at this stage, given that it is preparing for its own EU elections towards the end of May. The EU side has expressed dismay at the agreement being rejected by Britain for a second time since the last vote in January and said it would need "a credible justification" before agreeing to any extension.

Unless agreed otherwise, Britain leaving the EU by March 29 remains the default Brexit option by law. With that in mind, the UK government on Wednesday also unveiled plans for trade across borders under such a scenario. As a temporary measure, most imports into the UK would not attract a tariff in the event of a no-deal Brexit, the UK's Department for International Trade (DIT) announced.

Under a temporary scheme, 87 per cent of imports by value would be eligible for zero-tariff access up from 80 per cent at present. Tariffs would be maintained to protect some industries, including agriculture.

The government also announced it will not introduce any new checks or controls, or require customs declarations for any goods, moving from across the border from Ireland to Northern Ireland if the UK leaves the EU without a deal.

Sri Lankan government divided on UN rights body representation

COLOMBO, MAR 13 (PTI): The Sri Lankan Government appeared to be at loggerheads over the country's representation at the 40th session of the UN Human Rights Commission where a resolution to address the human rights concerns in the island nation will be taken up next week.

Colombo is once again under international pressure to implement fully the measures identified by the UNHRC in 2015 to address human rights concerns after the United Kingdom and Germany on Tuesday tabled a resolution at the UN body in Geneva. The UN rights office calls for international investigations into alleged war crimes and encourages member states to prosecute Sri Lankans suspected of war crimes in accordance with universal jurisdiction principles.

The resolution which Sri Lanka is expected to co-sponsor was also endorsed by Canada, Germany, Montenegro, North Macedonia, the United Kingdom and Northern Ireland. There is a clear division within the government over its representation and the approach as was evident in Parliament on Wednesday.

The leader of the House of Parliament and senior minister Lakshman Kiriella probed if President Maithripala Sirisena was sending his own delegation to attend the UNHRC sessions. An announcement from Sirisena said that he was sending his own men as part of the government delegation.

Sirisena and Prime Minister Ranil Wickremesinghe, who are from different political parties, are at loggerheads over governance. In October last year, Sirisena sacked Wickremesinghe in a move declared unconstitutional by the Supreme Court. The prime minister was later restored after the apex court intervened.

The government has come under fire from the main opposition for agreeing to co- sponsor the resolution. The government's defence has been that this strategy will prevent international war crimes allegations being continuously levelled against Sri Lankans through strengthened ownership of the implementation process.

Kiriella asked Masser

Kiriella asked Mahinda Samarasinghe, a Sirisena loyalist who had been named as a member of the team to Geneva, if Sirisena was sending his own men.

Samarasinghe replied that even though

he had pulled out from it, three others representing Sirisena will be attending.

The aim is to show the consensus within the government, Samarasinghe said.

However Sirisena's public statement made last month on the Geneva resolution said that the president wanted the UNHRC to grant Sri Lanka a reprieve to mind Sri Lanka's own business without any interference.

The government's defence has Notwithstanding Sirisena's public statement on rights accountability sought by the UNHRC, the foreign ministry which is under Wickremesinghe's control reiterated the government's commitment to implement the UNHRC resolution.

The main Tamil party legislator Tamil National Alliance (TNA) MA Sumanthiran questioned Sirisena's intentions in sending his own men who are in effect opposition representatives.

The resolution presented in the UNHRC session calls for accountability to alleged human rights violations committed by both government troops and the LTTE during the last phase of the conflict in 2009.
