All 33 primary contacts at Deorali Girl School test negative; Only 3 of Sikkim's 41 active cases in hospital

GANGTOK, 15 MAR:

It was a Monday of good news **I** for Sikkim today when, apart from no new cases of Covid being reported in the past 24 hours, samples of all the 33 primary contacts of the Deorali Girls School staff member who had recently tested positive for Novel Coronavirus have returned negative for the virus.

Health Department State IEC Officer, Sonam Gyaltsen Bhutia, informs that while test

results of 32 of the primary contacts had arrived yesterday itself, since official confirmation on the exposure of one more contact was still awaited, the announcement was withheld till today.

The school, its staff members, students and their parents must be heaving a sigh of relief as must schools across the State who would have been watching developments at Deorali Girls School closely. Since schools have reopened for in-person classes, there

must have been apprehensions in the management and parents about possible exposure to nCoV.

While just this one episode of the virus not transmitting in schools even among primary contacts cannot be taken as evidence that this will not happen, it does go a long way to establish that if adequate precautions are taken, transmission can be reasonably well checked.

In the State meanwhile, Sikkim's tally of confirmed

cases of COVID-19 held at 6,184 for the second straight day with no new cases of novel coronavirus reported in the last 24 hours.

The Kurseong and Darjeeling branch commit-**▲** tees of Gorkha National Liberation Front convened a joint organizational meeting of the party at Kurseong for its Sonada-Toong and Rangbul-Dhotaria-Rangbook units in the run-up to the approaching Assembly elections.

Ajoy Edwards, the GNLG Darjeeling Branch president, in his address, called on the supporters to remain wary of rumours seeking to sow divisions and confusion among GNLF supporters and stressed that the party was not looking at the upcoming elections as a play for power or posts, but as one which was crucial for the community.

In this regard, he also reassured that every leader will support the party's choice for candidate and that there was no competition among prospective candidates despite what the rumor-mill might be claiming.

I want to make one thing clear to all our party members that we will always accept the decision made by our President Maan Ghisingh. ₹ 2,000 notes haven't been printed in last 2 years, Minister tells Parliament

New Delhi, 13 Mar [**NDTV**]: ₹ 2,000 notes have not been printed in the last two years, the Finance Ministry said today in parliament to a question on why the currency notes introduced after demonetization in 2016 were hardly in circulation

2000-rupee notes were not sent to the printing press in 2019-20 and 2020-21, Minister of State for Finance Anurag Thakur said in the Lok Sabha.

a question, MDMK MP A Ganeshamurthi had asked whether the government was aware of the

fact the circulation of ₹ 2,000 currency notes among the people was "very low" and it was not available in banks and ATMs even. "The printing of

banknotes of particular denomination is decided by the government in consultation with the Reserve Bank of India (RBI) to maintain desired denomination mix for facilitating transactional demand of public," Anurag Thakur replied, explaining that the printing of currency was de-

mand based. The decision was also taken based on whether it was convenient to use. There was a drop in the circulation of the 2,000-rupee note, the minister said.

Last year, a top official had said 2,000 rupee notes constituted 35 per cent of the total circulation.

The pink banknotes were introduced along with new ₹ 500 currency after Prime Minister Narendra Modi announced in November 2016 that old ₹ 500 and ₹ 1,000 notes would be scrapped.

Subsequently, new ₹ 500, 200, 100 and 50 notes flooded the market, and the highest currency - ₹ 2,000 - was used less and less.

Mamata's injured leg kicks off political spat in Bengal

KOLKATA, MAR 15 PTI): Mamata Banerjee's injured leg Monday kicked off a spat between her and Amit Shah. with the wheelchair-bound TMC boss asserting she will fight as long as her "heart beats and vocal cord functions" and the home minister reminding her of the "pain" of the mothers of BJP workers "slain by your goons".

The two leaders crossed swords as they went stumping in West Ben-

Shah told an election rally that while the TMC cried conspiracy over the Nandigram incident, the Election Commission had concluded it was not "hamla" (attack) but "haadsa" (accident).

"Wait for a few days, my leg will get better. I will see whether your legs get to move freely on Bengal's soil," Banerjee told an election rally in Jhalda, ostensibly trying to get a leg up on the BJP.

"I will continue to fight against the BJP as long as my heart beats and vocal cord functions," the West Bengal leader, true to her persona of a street fighter politician, asserted.

She said "no conspiracy or injury" can deter her from taking forward her fight against the BJP, which is making a determined bid to dislodge her from power after two successive terms in

Bill to define role, powers of Delhi Lt Governor introduced in Lok Sabha



New Delhi, 15 Mar [PTI]: With the objective of giving a proper "interpretation" of a Supreme Court ruling, the government on Monday introduced a bill in Lok Sabha that seeks to define certain role and powers of the Lieutenant Governor of Delhi.

Union Minister of State for Home G Kishan Reddy introduced the Government of National Capital Territory of Delhi (Amendment) Bill, 2021.

According to proposed amendments, Section 21 of the Act -dealing with restrictions on laws passed by legislative assembly with respect to certain matters -- is sought to be revised to clarify that the expression "government" referred to in any law to be made by the legislative assembly shall mean the "Lieutenant Governor". A sub-section shall be inserted to this effect in Section 21.

In section 24 of the principal Act -- which requires a Bill passed by the Delhi legislative assembly to be presented to the LG who may assent, withhold or reserve it for consideration of the President -- an additional clause will be inserted to cover any of the matters that fall outside the purview of the powers conferred on the legislative assembly.

In Section 33 of the principal Act, in sub-section (1) after the words "conduct of its business", the words "which shall not be inconsistent with the Rules of Procedure and Conduct of Business in House of People" shall be inserted.

Also, in the proviso, for the words "Provided that", the following shall be substituted, "Provided that the Legislative Assembly shall not make any rule to enable itself

or its Committees to consider the matters of dayto-day administration of the Capital or conduct inquiries in relation to the administrative decisions, and any of the rule made in contravention of this proviso, before the commencement of the Government of National Capital Territory of Delhi (Amendment) Act, 2021, shall be void".

In section 44 of the

principal Act dealing

with powers to makes

rules for conduct of business, in sub-section (2) -- which states that as otherwise provided in this Act, all executive action of the Lieutenant Governor whether taken on the advice of his Ministers or otherwise shall be expressed to be taken in the name of the Lieutenant Governor -- the following proviso shall be inserted, namely "Provided that before taking any executive action in pursuance of the decision of the Council of Ministers or a Minister, to exercise powers of Government, State Government, Appropriate Government, Lieutenant

Governor, Administrator or Chief Commissioner, as the case may be, under any law in force in the Capital, the opinion of Lieutenant Governor in term of proviso to clause (4) of article 239AA of the Constitution shall be obtained on all such matters as may be specified, by a general or special order, by Lieutenant Governor".

According to the statement of objects and reasons of the bill, the original bill was enacted to supplement the provisions of the Constitution relating to the legislative assembly and a Council of Ministers for Delhi and for matters connected therewith.

"The section 44 of the

act deals with conduct of business and there is no structural mechanism provided in the act for effective time bound implementation of said section. Further, there is no clarity as to what proposal or matters are required to be submitted to the LG before issuing order thereon," it said.

It said that to give effect to the interpretation made by the Supreme Court which had ruled that the city government need not obtain the Lieutenant Governor's "concurrence" of every issue of day-to-day governance, the bill has been brought.

government said it wanted to clarify the expression "Government", which in the context of legislations to be passed by the Delhi assembly, shall mean the LG of Delhi, consistent with the status of Delhi as a Union Territory to address the ambiguities in the interpretation of the legislative provisions.

It further seeks to ensure that the LG is necessarily granted an opportunity to exercise the power entrusted to him under proviso to clause (4) of article 239AA of the Constitution, in select category of cases and also to make rules in matters which incidentally encroach upon matters falling outside the preview of the assembly.

"The said bill will harmonious promote relations between the legislature and the executive, and further define the responsibilities of the elected government and the LG, in line with the constitutional scheme of governance of National Capital Territory of Delhi, as interpreted by the Hon'ble Supreme Court," the statement of objects said.

CBI interrogates Trinamool MP Abhishek Banerjee's relatives in coal scam

KOLKATA, 15 MAR [PTI]: The Central Bureau of Investigation (CBI) on Monday questioned relatives of Trinamool Congress MP Abhishek Banerjee in connection with its investigation into the multi-crore coal pilferage

The central agency had on Friday issued a notice to Ankush Arora, husband of Menaka Gambhir who is the sister-in law of Mr Banerjee, for questioning in the illegal coal mining case.

The agency also asked Ms Gambhir's father-inlaw Pawan Arora to join the investigation.

"Both have appeared before the anti-corruption branch officers at CBI's Nizam Palace office here for interrogation," a source in the agency said.

A CBI team had on February 23 visited the residence of Mr Baneriee and examined his wife Rujira in connection with the case. The agency also examined Rujira's sister on the previous day on the same matter.

Abhishek Banerjee is West Bengal Chief Minister Mamata Banerjee's nephew.

"When Gambhir was interrogated by the CBI, she had told the sleuths that her husband and father-in-law were in the knowledge of some bank transactions. She claimed that she was not aware of anything," the agency source said.

Earlier, searches were conducted at the residences and offices of people who are "considered close to Anup Majee alias Lala" -- the main accused in the coal scam.

Mr Majee is believed to be involved in the illegal coal mining in the Asansol-Raniganj belt of Eastern Coalfields Ltd and has been evading arrest. The CBI has also issued a look out notice against him.

The investigating agency on November 28 last year carried out a massive search operation in a number of locations in four states -- West Bengal, Bihar, Jharkhand and Uttar Pradesh - after registering a case against Majee.

The CBI is keeping a close watch on businessmen who have a close connection with Mr Maiee, the agency source said.

The Enforcement Directorate, another central agency, is also probing the money laundering aspect of the case.

India-Bangladesh meet on river water sharing on Mar 16

NEW DELHI, MAR 15 **(PTI):** Top officials of the water resources ministries of India and Bangladesh will meet here on Tuesday to discuss issues related to river water-sharing and flood forecast, sources said on Monday.

The Indian delegation will be headed by Pankaj Kumar, secretary in the Jal Shakti Ministry. The Bangladesh side will be headed by senior secretary Kabir Bin Anwar, the

sources added. The meeting takes place ahead of Prime Minister Narendra Modi's visit to Bangladesh later this month.

Sources said the two sides will discuss water sharing of Manu, Muhuri, Khowai, Gumti, Dudhkumar and Dharla rivers.

They added that discussions are also expected to take place on withdrawing water from Feni river for the Sabroom town in Tripura.

Further, talks are also expected on a possible Memorandum of Understanding (MoU) for drawing water from the Surma river.

Oli and Nepal groups meeting ends with both sides refusing to budge from their stance

KATHMANDU, 15 MAR future. [KATHMANDUPOST]: A meeting of senior CPN-UML leaders including party chair and prime minister KP Sharma Oli and senior leader Madhav Kumar Nepal on Monday ended with both sides proposing their ideas but refusing to budge from their stances.

Monday's meeting was the first between Oli and Nepal in about four months ever since they met on November

The UML is currently divided along two factions led by Oli and Nepal. The Oli faction on

Monday asked the Nepal faction to cancel the national gathering of its leaders and cadres scheduled for March 17-18. The Nepal group demanded that Oli withdraw the decisions taken on Friday, including induction of 23 Maoist members into the Central Committee.

Leaders said both sides disagreed to each other's demands and the meeting ended with the promise to continue talks in the

"Oli was not ready to withdraw the unilateral decisions made on March 12," said Bhim Rawal, a Standing Committee member. "We are ready to reconcile if Oli withdraws the March 12 decisions. Or else, we will go ahead with our decisions." On March

through a Central Committee meeting, Oli had decided to amend the party statute to incorporate 23 leaders of CPN (Maoist Centre) and changed the responsibilities of party leaders, stripping leaders close to Nepal of their responsibilities.

The Oli faction has called another meeting of the Central Committee on March 20, which the Nepal faction has said it would not attend until the decisions taken on March 12 are not withdrawn.

"It's not about (the decisions of) March 12, there are several issues including the national gathering and another Central Committee meeting scheduled for March 20," said General Secretary Ishwar

Pokhrel following the meeting. "We will gradually evaluate other activities as well including the 19-page document against Oli."

On November 13 last year, Pushpa Kamal Dahal, when he was the chair of then Nepal Communist Party (NCP) had prestend a 19-page document, levelling serious allegations against Oli, his fellow chair, which had led to souring of relations between them.

Monday's meeting was attended by Subash Nembang, Pradeep Gyawali, Bishnu Poudel and Ishwar Pokhrel from Oli's side while besides Ghanashvam Bhusal, Surendra Pande, Gokarna Bista, Bhim Rawal and Raghuji Pant had accompanied Nepal.

Though they have agreed to continue dialogue, the date for the next meeting has not been fixed yet.

Monday's meeting comes a day after 11 leaders of the Nepal group issued a press statement saying they should continue their struggle against Oli as he was leading the communist movement towards an end.

Pucca Research, Real Identity

No dodging scholarly research if shallow jingoism is to be discarded

Dolitics is increasingly becoming about identity, and while deeper enquiries into questions of identity and belonging are always welcome, when politics jumps the line on research or nuanced understanding, everything - from security to even ideas of identity - get compromised. Where politics and those who obsesses over it see everything in binary, there are some ideas like identity which are more layered and complex than the simplistic us and them or us and no one else version that suits politics. And that cannot serve any good, ever. We are learning this the hard way every day in our country as is the world with the rise of jingoistic nationalism and easy fear-mongering which are being peddled to sell everything from genocide to wars to rapes.

The region itself has been in the grips of identity assertion for some decades now, and while this has worked well to boost political careers and specific agendas, it has not succeeded in infusing confidence which any strong sense of identity should guarantee. It hence becomes important for the stakeholders to pause, step back and

One of the problems with the current wave of claims of identity, belonging and rights is that these are sourced from selective reading and myopic interpretations. Anyone unfettered by political blinkers will immediately denounce superficial pigeon-holing of people and communities. But this is essentially what colonial and/ or monarchical texts did with easy alacrity. When a dash of traditionally held prejudices are added to these inaccurate and misleading records, confusion and paranoia result. It is thus required for scholars and researchers to deliver new narratives from fresh perspectives, narratives that are more nuanced and subaltern and also more invested with academic discipline and do a better job of explaining interconnectedness rather than reinforcing prejudices or isolating.

The process of rewriting these texts is however not new. Taking Sikkim's example, history has been reinterpreted several times, sometimes by the powers that be and sometimes by individual organizations and even proclaimed by political parties. While some 'inventions' have become accepted notions because they have been around for a long time, others invite only ridicule except from those who have a stake in the new theories. Both trends are unhealthy because both are misleading and incomplete. Histories are always contested and thus always open to fresh interpretations, but what separates claim from fact is the erudition, research and evidence that supports the latter. It is obvious that it is this fastidious obsession with supporting evidence that brings credibility to a scholar and only notoriety to the conspiracy theorist. One hopes that the deconstruction of established 'myths' and accepted histories start surfacing soon following the scholarly path and not continue on the current rantings and claims of half-baked notions.

But why are histories required? To borrow a term from an academic who has spared some thought on this - histories are increasingly required to prove the "situatedness" of a people; to establish that they belong. Take for instance the Indian Nepali community which has been standing at the crossroads of this journey for a while now, stuck more in an extended debate over nomenclature rather than "situating" its identity and belonging. It is obvious that a name cannot be imposed on a people and it is also accepted that no introduction of identity will be taken seriously if it comes from a fractured splinter of the constellation. To squabble over a name prioritizes the nomenclature rather than the introduction, and a name in itself is no guarantee to recognition, security or identity. But this is only one aspect of the understanding of identities and histories, there is so much more that needs to be researched and recorded, and the sooner a more disciplined approach is initiated, the better it will be for all with a stake in anything anywhere. But this exercise is safest in the hands of trained researchers instead of inspired political groups.

How the Nazis Used Music to Celebrate and Facilitate Murder

Tn December 1943, a 20-year-old Inamed Ruth Elias arrived in a cattle car at the Auschwitz-Birkenau concentration camp. She was assigned to Block 6 in the family camp, a barracks that housed young women and the camp's male orchestra, an ensemble of incarcerated violinists, clarinet players, accordion players and percussionists who played their instruments not just when the prisoners marched out for daily labor details, but also during prisoner flog-

Performances could be impromptu, ordered at the whims of the SS. the paramilitary guard of the Nazi Party. In a postwar interview, Elias discussed how drunken SS troops would often burst into the barracks late at night.

First, they'd tell the orchestra to play as they drank and sang. Then they would pull young girls from their bunks to rape them. Pressed against the back of her top-level bunk to avoid detection, Elias heard the terrified screams of her fellow

Before her tormentors engaged in these acts, she recalled, "The music had to play."

Music is often thought of as inherently good, a view exemplified in the playwright Wilhelm Congreve's oft-cited aphorism "music hath charms to soothe a savage breast." It is also often seen as a form of art that ennobles those who play and listen to it. Its aesthetic qualities seem to transcend the mundane and horrific.

Yet it's also been used to facilitate torture and punishment, a topic I think is worth exploring.

When I was researching my book "Drunk on Genocide: Alcohol and Mass Murder in Nazi Germany," I was struck by the ways in which music accompanied deaths in the camps, the ghettos and the killing fields.

Beautiful music accompanying murder and rape is a bizarre and disturbing juxtaposition. But its use by the perpetrators to torture their victims and to celebrate their acts reveals not only the darker side of its use but also offers insights into the festive mindset of the killers as they participated in genocide.

THE 'JOY' OF KILLING

Stories of the integration of music and song into acts of torture and killing can be found throughout the interviews and memoirs of survivors. As in Auschwitz, the SS detail at the Belzec killing center organized a prisoner orchestra for its entertainment. Every Sunday evening, members of the SS forced the ensemble to play for their enjoyment as they held a drunken party.

One of the SS troops amused himself by having the orchestra repeatedly play a melody while the other prisoners were forced to sing and dance, without respite.

Another Jewish survivor remembered listening to that same orchestra as it accompanied the cries of those being murdered in the camp's gas chamber.

In the absence of an orchestra, troops could nonetheless spontaneously break into song.

Genia Demianova, a Russian schoolteacher, was interrogated, tortured and gang raped in August 1941. After the initial assault, she wrote of hearing the clinking of glasses as her rapist toasted, "The wildcat is tamed!" Other German soldiers then took their turns with Genia, who lost count of the number of assailants. As she lay battered and

bleeding on the floor, she heard the voices of her attackers crooning to "the sound of a sentimental [Robert] Schumann song."

And SS Col. Walter Blume, a commander in the Einsatzgruppen, the notorious SS death squad, was known to gather his men after a day of murder for evening singalongs around a campfire.

CARNIVALS OF CARNAGE

The single largest massacre of prisoners in a concentration camp occurred on Nov. 3, 1943, at Maj-

Planned under the celebratory code name "Operation Harvest Festival," German soldiers shot some 18.000 lewish men, women and children. During the executions, Viennese waltzes, tangos and military marches blared from the camp's loudspeakers.

During a postwar interrogation, one policeman recalled hearing a colleague at the time exclaim, "It's really nice to shoot to military march music."

Afterward, the troops returned to their quarters for a "wild party," during which they swilled vodka and celebrated in uniforms covered in the victims' blood.

In September 1941, a group of German policemen prepared to execute 400 Jewish men, women and children near the Ukrainian town of Cutnow. In postwar testimony, one of the policemen described the presence of a band as the Jews were marched to the grave site.

"It was loud," he testified, "just like a carnival."

I came across this often during my research - mass killings described as carnivals or evoking a "wedding atmosphere." The recollections of these heinous acts as part of some sort of macabre celebration have appeared during other genocides, too.

After the Rwanda genocide, one Hutu perpetrator remarked that "the genocide was like a festival," and he remembered celebrating a day of murder with beer and a barbecue with his fellow killers. A female Tutsi survivor described intoxicated perpetrators singing as they hunted for their victims and engaged in mass rapes.

WINE, MURDER AND SONG

The fusion of alcohol, music and song with mass murder shows how violence was normalized - even celebrated - by the

Under the Nazi regime, music and song forged community, camaraderie and shared purpose. In unit bars, around campfires and at the killing sites, the addition of music was more than just a form of entertainment. It was also an instrument for promoting a common purpose and bringing people together. Through rituals of song, drink and dance, the Nazis' actions could be collectivized and normalized - and their larger project of violence that much easier to pull off.

Ultimately, genocide is a societal endeavor; music and song - like political philosophies - are part of a society's cultural artifacts.

So when mass murder becomes a central tenet of a society, perhaps it shouldn't be a surprise that these atrocities are carried out against a backdrop of stirring song, a rousing military march or a sentimental Schumann melody.

Six Tips for Coping When the News is Getting to You

It can often feel difficult to escape a bad news **I**story. For many, the murder of Sarah Everard has been one of these stories. People are sharing their own experiences of harassment on social media, organising vigils and discussing how close to home the case feels.

The news plays a prominent role in our lives, something that has been emphasised even further during the past year. The pandemic has brought with it daily news briefings and a seemingly never-ending influx of COVID related headlines.

Staying informed and educated is important. However, constant exposure to negative reporting may be bad for your wellbeing. The World Health Organization has found news coverage can increase distress and anxiety, and a recent study suggests news reports shared through social media lead to increased panic.

Some people may be particularly vulnerable to negative impacts of specific stories. For example, people with eating disorders have reported being triggered by an emphasis in the media on exercise and weight loss during the pandemic.

Whatever it is that triggers you, the goal is to find the balance between using the news to stay informed and not becoming overwhelmed.

BEING TRIGGERED

A trigger is something that causes negative feelings or behaviours for someone. They can be driven by many internal processes, for example a reminder of past trauma, or intense emotions such as stress, anxiety, entrapment or a lack of control.

When someone is "triggered" they experience negative consequences such as a panic attack, flashbacks or an increase in mental health symptoms - for example, disordered eating, self-harm, anxiety or depression.

You may be able to spot that you're at risk of being triggered by listening to your psychological and physiological responses. For example, you may notice an increase in negative or brooding thoughts, increased heart rate, rapid breathing or feeling like you're in a state of high alert.

You may also have started to notice other phys-

ical symptoms related to stress, such as fatigue or changes to your sleeping pattern. Tuning into your mind and body responses can provide the earliest signs that the news may be having a negative impact on your wellbeing.

If you find yourself beginning to feel negative impacts from the news, now is the time to start putting protective steps into place.

1. REGULATE CONSUMPTION

Regulating consumption of news includes making the conscious decision to take "time out" from the media for a period of time. Alternatively, you may have noticed a pattern around the negative impacts you are experiencing – for example, do you tend to feel more negative impacts if you read the news when you're tired or just before bed, or during periods of increased general stress? If so, you may wish to limit exposure at certain times of day, in particular contexts or both.

You may notice that certain news sources use communication styles or content that you find particularly distressing or triggering. Perhaps they are particularly confrontational, biased or controversial. If so, try to find more positive sources that work for you.

For example, during the pandemic, the World Health Organization suggests limiting access to health authority websites which aim to provide just the facts on the current situation.

2. TAKE OWNERSHIP OVER YOUR EMO-TIONS

Never blame yourself for experiencing negative emotions. It is important to acknowledge that it is your right to feel how you do. In doing so, acknowledge that you also have control over your reactions. This can help you to feel more in control and more empowered to work towards more positive coping mechanisms.

3. TAKE CARE OF YOUR HEALTH

Investing time in your physical care can help provide you with the best chance to react positively to stressful situations. Healthy body, healthy mind.

Try to eat healthy meals, get regular - but

not excessive - exercise and maintain a good sleeping pattern. Remember the emphasis is on health, not weight loss or other potentially negative drivers. Similarly, take care of your mental health by striving for positive work life balance, practising mindfulness or staying in contact with

supportive friends and family. 4. FOCUS ON THE POSITIVE

If you're being triggered by negative news coverage, try to find some positive resources to focus on. For instance, during the current pandemic, the World Health Organization suggests focusing on recovery stories.

5. REPLACE UNHEALTHY COPING SKILLS WITH POSITIVE ALTERNATIVES

There are resources available to help individuals identify positive behaviours which they can use to replace unhealthy coping mechanisms such as eating disorders and self-harm. Similar resources are available for a wide range of behaviours.

6. SEEK SUPPORT

Contact support groups or healthcare professionals. It's important to recognise the value of positive social support and to recognise that seeking help is a positive and strong step. These contacts can also help you find other helpful resources. You are not alone, reach out for support.

It can be difficult to find the right balance between being informed by the news media and not becoming overwhelmed - especially during a global crisis. This has been a very difficult year for many.

It's natural to feel concerned, apprehensive and stressed at times. However, it's also important to invest time in self-care and to seek help if you are experiencing negative impacts on your health.

It is important to recognise that everyone is an individual, and what works for one person may not be the best approach for another. Be prepared to take some time to find the techniques that work for you, and do not be apprehensive about seeking professional help to guide you through this pro-

Fears of Nepal's rhinos migrating to India add to challenges in their conservation

MANDUPOST]: Nepal's one-horned rhino conservation faces yet another challenge.

The latest is that many of the vulnerable species from Chitwan National Park, which shelters the country's largest rhino population, could possibly migrate across the border to India and authorities fear that they may be stranded

"With the rhino population highly congregated in the western part of the park, we have realised that those rhinos could go to the Indian side," Ananath Baral, the chief conservation officer in Chitwan, told the Post. "Once they go to the Indian side, that will lead to other problems in bringing them

Officials estimate that roughly 70 percent of the park's rhinos, which is more than over 400 of the 600 rhinos in Nepal's oldest national park, live in the western part of the protected area, which is adjacent to Valmiki Tiger Reserve

"Why such a large number of KATHMANDU, 15 MAR [KATH- rhinos have been staying in that particular area needs to be studied," said Baral.

> The western part of the park is determined by taking Kasara, the park's headquarters, as the centre.

> Park officials fear that rhinos going to the Indian side will result in complications in rescuing and repatriating them. The park had faced such obstacles in the past while bringing rhinos back to Nepal from Valmiki Tiger Reserve.

> The devastating flood of 2017 in the Tarai region, which not only affected settlements in the southern plains but also wildlife living in those parks, killed and displaced rhinos from Chitwan. At least four rhinos had died due to the flood and as many as 11 rhinos were swept down to India.

> Nepali officials worked hard to bring the rhinos back from the Indian side as the authorities there kept on refusing to return them.

> Last monsoon too at least two rhinos were swept down to India, according to Baral. But they have not returned to Chitwan as of now.

"Some rhinos also died in the floods and at least two are already in Valmiki Tiger Reserve. But the Indian side does not share the details about rhinos stranded on their side," said Baral. "It seems more rhinos could end up on the other side. Losing even one rhino is a big loss for us."

In May last year, a lone female rhino was killed in Valmiki Tiger Reserve in West Champaran district of Bihar. The rhino had been inhabiting in the reserve after being swept downstream from the adjoining Chitwan National Park in Nepal during the 2017 floods.

In another incident nearly ten years ago, an adult female rhino was found dead in the Indian reserve in 2011. The rhino had also reached the Indian territory from Chitwan Park.

Valmiki Tiger Reserve is not home to one-horned rhinos. But rhinos from Chitwan Park stray into the Indian protected area. The trend worries Nepali officials.

"Two rhinos are already in India. There could be more. We don't know the exact number. Valmiki

does not have a rhino population of its own and our rhinos are kept there. They do not allow them to return," said Baral.

"We had planned to bring rhinos whenever they are seen in the Susta area. But it needs a lot of preparation to get them back on our side. Even though it is confirmed that those are our rhinos, as they have no rhinos, it has been challenging to bring them home."

Besides the chances of rhinos shifting to the Indian side, the congregation of rhinos in the western part of the park is another challenge.

An unprecedented rise in rhino deaths was also attributed to the concentration of rhinos in the western part of the park. Higher concentration in one place means these rhinos share the habitat and water resources and fight for them, which often leads to territorial

Overcrowding of rhinos in the western part of the 952 sq km sanctuary could be one of

the reasons for their migra-

"We found a majority of rhinos had crowded in that western sector," said Baburam Lamichhane, chief of the Biodiversity Conservation Centre, Sauraha, under the National Trust for Nature Conservation. "A study conducted in 2012 had estimated that a male rhino requires nearly 14 sq km as its home range, and a female rhino needs 9 sq km. However, there can be overlapping as well. If the habitat is good and abounds with resources, then a small area would be adequate. Otherwise a relatively larger area will be required."

A team of wildlife experts part of the team formed to investigate the increasing deaths of one-horned rhinos in Chitwan National Park in December—suggested an internal relocation of the protected animal, among other conservation measures.

Lamichhane, who was also part of the team, examining the cause of deaths, feels that recommendations of the study, although meant for bringing down the number of rhino deaths, can also be useful for averting their migration to India.

"Internal relocation was a short-term measure, among those we recommended," said Lamichhane. "Habitat improvement was also suggested. Once the habitat is managed, these rhinos will automatically disperse. Otherwise, in the western part, they are likely to keep fighting among themselves and be swept down to India during flooding."

Wildlife experts are looking up to a rhino census which is scheduled to begin on March 22. As the census will give information not only on the rhino population but also their distribution within the park, it is expected to help authorities give valuable insights for future conservation efforts.

According to the rhino census of 2015, there are 645 one-horned rhinos in Nepal. "The upcoming rhino census will help in determining more ways to deal with the problem [of the rhinos migrating to India]," said Baral.

Mamata Banerjee's nephew Abhishek Banerjee said Jhargram was "easily" reachable by road. "Those who attend rallies in the afternoon in this heat, they don't come to hear speeches. The home minister had a rally in Jhargram, he could not reach his meeting due to a technical snag. West Indies beat Sri Lanka by 5 wickets, win ODI series 3-0



NORTH POINT (ANTI-GUA), MAR 15 (AP): Darren Bravo's fourth international one-day century steered the West Indies to a five-wicket win over Sri Lanka and a sweep of the three-match ODI series.

Bravo was out for 102 in the 47th over when the West Indies needed only 26 runs to overhaul Sri Lanka's total of 274-6. He shared an 80-run partnership with captain Kieron Pollard, who finished 53 not out as the home side won with nine balls to spare.

Bravo earlier joined with Shai Hope in a 109run partnership for the third wicket which put the West Indies on target to victory after the hosts had been 39-2 in the 10th over.

Captain Jason Holder ended the run chase with a six from the third ball of the 49th over as West Indies ended on 276-5.

Bravo's century was his first in an ODI since June, 2016 when he scored 102 against South Africa at Bridgetown, Barbados.

I think today was an important day for me, Bravo said.

Yesterday my sister celebrated her 30th birthday. I wasn't there for her celebration so I knew I had to do something special for her. I just want dedicate this

one-day hundred to her. Bravo had been hinting at the onset of his best form with scores of 58, 19 and 47 in the three-match Twenty20 series, which the West Indies won 2-1. He also scored 37 not out and 10 in the first two matches of the ODI series.

He emulated the performances of Hope, who made 110 to help West Indies win the first match of the series by eight wickets, and Evin Lewis, who scored 103 to help the home team win the second match by five wickets.

Bravo said he took inspiration from the innings by Hope and Lewis which have led a strong West Indies batting performance in the series, saying it gave us the motivation to go out and do

Once again, Sri Lanka lost the toss and was asked to bat first. Danushka Gunathilaka (36) and captain Dimush Karunaratne (31) got the tourists off to a solid start with a 68-run opening stand.

But the middle order couldn't capitalize on the start, and Sri Lanka slipped to 151-6 in the 32 over. Ashen Bandara and Winandu Hasaranga revived the innings with an unbroken 123-run partnership for the seventh wicket.

Bandara finished 55 not out, a watchful innings from 74 balls, while Hasaranga smashed an unbeaten 80 from 60 balls with seven fours and three sixes.

Hasaranga's maiden ODI 50 came from 48 balls and he struck the next 30 runs from only 12 deliveries.

The teams meet in a two-match test series starting at the same venue next weekend.

Flights cancelled during China''s worst sandstorm in decades

BEIJING, MAR 15 (AP): China's capital and a wide swath of the country's north were enveloped Monday in the worst sandstorm in a decade, leading to the cancelation of hundreds of flights.

Skyscrapers in the center of Beijing appeared to drop from sight amid the dust and sand. Traffic was snarled and more than 400 flights out of the capital's two main airports were canceled be-

Thomas lives on edge and rallies to win Players Championship

PONTE VEDRA BEACH, FLA. (AP): The resilience it takes to get through a nerve-jangling Sunday at Sawgrass was nothing compared with what Justin Thomas had been through already this year.

An otherwise impeccable start to his career on and off the course came under scrutiny in January with a slip of the tongue when he muttered an anti-gay slur under his breath that cost him one sponsor and led another to publicly reprimand him. Tougher still was the death last month of his grandfather, Paul, part of the legacy of golf pros in the Thomas

He found the right time to deliver a gem. Thomas took on every shot in The Players Championship, right down to the 5-wood that rode the edge of the lake down the left side of the 18th fairway, and closed with a 4-under 68 for a one-shot victory over Lee Westwood.

He won for the seventh straight year, his 14th career title, and became only the fourth player to win a major, The Players

Championship, the FedEx Cup and a World Golf Championship.

"It's been a crappy couple months. I've had stuff happen in my life I never thought I'd have happen," Thomas said. "Losing grandpa was terrible, and having to play a round of golf dealing with that, and then on top of that not playing well, it just was a lot, and it took a lot on me mentally.

"This week was huge to win a big championship like this in front of fans again, which is incredible. It tested me mentally, physically, emotionally, and I'm very proud of myself for getting it done."

Like most Sundays at this championship, it was wild as ever.

Thomas was four shots behind when he walked off the green on the par-3 eighth with a three-putt bogey. Four holes later, he walked off the 12th green with a two-shot

He hit a 5-iron to 20 feet to set up a two-putt birdie on the par-5 ninth. He took on a tough pin at No. 10 for a 6-foot birdie. He drilled a 4-iron to 20 feet for an eagle at No. 11 for his first lead of the week, and he capped off the run with a nifty pitch from behind the green on the reachable par-4 12th for birdie.

Westwood was a hard-luck runner-up for the second straight week — to Bryson DeChambeau at Bay Hill, to Thomas at The Players, two major champions who were born in 1993, the year the 47-year-old Westwood turned pro.

He was tied for the lead until he couldn't match Thomas, playing in the group ahead, on the par-5 16th.

Thomas teed it low and slung a hard, low draw that ran out some 40 yards and set up a 5-wood into 50 feet, which he lagged down for a two-putt birdie. Westwood's 3-iron clipped a tree and dropped into the sand, and that quirky 65-yard shot went into another bunker and forced him to scramble for

"When you're in contention, you'd like to win every tournament you're playing in,"

Westwood said after a 72. "But I didn't quite yards until it plunked into the water. have my game today."

He made birdie on the 18th to finish alone in second. DeChambeau (71) and Brian Harman (69) were another shot behind.

Thomas finished at 14-under 274. He was outside the cut line after nine holes Friday, made it with two shots to spare and then tied The Players Championship record with a 12-under 132 weekend.

Thomas still had one more shot before he was in the clear. He took on the water framing the left side of the 18th fairway, the ball moving right-to-left and bouncing straight off the crown of the first cut, safely in the fairway. Only when he saw it on land did Thomas twirl his club, pulling his cap over his face and wiping his brow.

"I've seen some crazy stuff happen on TV in the past, and I'm glad to be on this side of it," he said.

Australians rally at Parliament to demand justice for women

CANBERRA, MAR 15 (AP): Australians rallied in the capital and other cities Monday demanding justice for women and calling out misogyny and dangerous workplace cultures as the government reels from two rape allegations.

Outside Parliament House in Canberra, the crowd of hundreds was mostly female and most wore black. They carried placards including Justice for Women and Men, Own Your Guilt.

Prime Minster Scott Morrison refused organizers' demand that he address the crowd. He agreed to meet a delegation of protesters in his office, but a meeting didn't take place.

We have already come to the front door, now it's up to the government to cross the threshold and come to us, organizer Janine Hendry said.

We will not be meeting behind closed doors, she added.

Morrison is standing by his Attorney-General Christian Porter over an allegation that he raped a 16-year-old girl when



he was aged 17 in 1988. Porter denied the allegation. His accuser took her own life last year after withdrawing a complaint to police.

Separately, Defense Minister Linda Reynolds has been criticized for failing to adequately support a young staffer who alleged she was raped by a more senior colleague in the minister's office in Parliament House in 2019.

Brittany Higgins said she felt she had to make a choice between between reporting her allegations to police or

continuing her career. She quit her government job in January and reported her allegation to police.

I was raped inside Parliament House by a colleague, and for so long it felt like the people around me only cared because of where it happened or what it might mean for them, a tearful Higgins told the Canberra crowd.

It was so confusing because these people were my idols. I had dedicated my life to them. They were my social network, my colleagues, and my family. And suddenly they treated me differently. I wasn't a person who had gone through a life-changing, traumatic event. I was a political problem, she added.

The Associated Press does not usually identify alleged victims of sexual assault, but Higgins has chosen to identify herself in the media.

The protests, which also took place in Sydney, Melbourne, Brisbane and Hobart, coincide with the first sitting of Parliament since the allegation against Porter became public in early March.

Reynolds has since apologized for describing Higgins to her staff as a lying cow and said she was referring to Higgins' allegation of inadequate support, not the rape allegation. The minister also agreed to pay Higgins an undisclosed sum as compensation.

Porter's lawyers announced on Monday that he is suing Australian Broadcasting Corp. for defamation over a news article that he said made false allegations against him.

Although he was not named, the article made allegations against a senior Cabinet minister and the attorney-general was easily identifiable to many of Australians as the subject of the allegations, the lawyers said in a statement.

Porters has been on mental health leave since March 3 when he held a news conference denying that he had raped the girl, who has not been named.

Reynolds has also been on sick leave with a heart condition since Higgins made her allegations.

Pandemic sets back Italian women's long fight for jobs

ROME (AP): One of hundreds of thousands of women in Italy who lost jobs in the pandemic, Laura Taddeo has a masters degree in tourism, speaks fluent English and Spanish and some Arabic,

Her contract as a tour operator with a high-end Italian hotel company expired in May, just as COVID-19 travel restrictions were crippling tourism, and it wasn't renewed. But whenever tourism does rebound, Taddeo, who cuts a confident figure, will brace for the job interview questions.

"It's not, 'What have you studied? What languages do you speak?' but 'Do you have a family? Do you intend to have children?"' Taddeo, who is 33, said every man who has interviewed her asked her that right off the bat.

Worldwide, working women have paid a painfully high price during the pandemic as many quit jobs to care for children when schools closed or saw employment evaporate in hardhit retail and hospitality businesses. But Italian women went into the COVID-19 crisis already struggling for decades to expand their presence in the workforce.

Among the 27 European Union nations, Italy ranks next to last, just above Greece, in terms of women's participation in the workforce. In 2020, while Europe's economy was reeling from pandemic restrictions, 49.4% of women aged 15 through 64 worked in Italy, compared with an EU average of 67.3%. By comparison, 67.3% of men had jobs, against an EU rate of 79%.Deeply rooted Italian societal attitudes that hold a woman's main vocation is in the home help to explain

"It's not so much that women shouldn't work, but they shouldn't neglect the household. That's the responsibility of women," said sociologist Chiara Saraceno of the widespread attitudes. Affordable day-care is chronically scarce, both

Of 456,000 jobs lost

in 2020 in Italy, where the pandemic first erupted in the West, 249,000 were held by women, many of whom had been working as waitresses, store clerks, nannies and caretakers for the elderly. According to the national statistics bureau, ISTAT, between November and December, when Italy was grappling with a devastating resurgence of infections, a staggering 99,000 of the 101,000 jobs that disappeared were women's, mostly among the self-employed.

Even before the pandemic, Italy's economy had never fully recovered from the economic crisis of more than a decade ago. The Bank of Italy has estimated that GDP would improve by some 7 percentage points if the proportion of women in the workforce climbs to 60%.

"We're talking about women who are more educated than men, but that our country doesn't succeed in employing," ISTAT's central director Linda Laura Sabbadini said in an interview last month with the weekly Io Donna, (I, Woman). "The point is that, as long as women are underutilized in respect to their potential, Italy won't grow."

If anyone is acutely aware of that issue that would be Mario Draghi, who headed both the Bank of Italy and the European Central Bank and last month became the nation's premier.

A hefty chunk of the 209 billion euros (\$250 billion) in EU pandemic aid for Italy is to be earmarked for digital innovation and shifting the economy to environmentally friendly technologies. In laying out his priorities to Parliament last month, Draghi said Italy must invest "economically, but above all, culturally," so that young women can train for careers in sectors that will get the new investment.

Some 37% of Italian men have degrees in science, technology, engineering and mathematics

(STEM), compared with 16% for women.

That has some worried that EU funding could widen the gender

"There is a big risk it will end up increasing jobs for men," said sociologist Saraceno, who is based in Turin. "I have been saying for some time that you have to prepare both sexes for this kind of work."

Daniela Magnanti, 42, says the push for tech and engineering jobs for women comes too late for her. She wrote computer code for years until her employer went bust. In a phone interview from her home in a Rome suburb, Magnanti recounted how, when she tried to get back to work after the birth of her second daughter, parenthood hurt her prospects.

For recruiters, asking if she had a child "was a routine question. (And) it was always a male (recruiter) who called."

Magnanti now works part-time at the check-in desk of a hotel in a nearby beach town and does administrative work for her brother's plumbing business.

"At first, in the 1960s and 1970s, (lack of women working) was justified by saying they weren't prepared, they didn't have the competence," said Liliana Ocmin, who coordinates the CISL labor union group's efforts for women. But even after Italian women armed themselves with college degrees and skills they remained behind in the workforce.

ISTAT's Sabbadini noted last year that day-care availability nation-wide was a scarce 25%. In southern Calabria, it was a mere 9%.

Draghi seems to be getting the message. In remarks to the nation on Monday, International Women's Day, he said Italy needed "profound reforms" to narrow the gender gap, including more equitable access to day-care.

Meanwhile, Italian cultural attitudes toward working women seem stuck in a time warp for Carmen Basso, 63.

Iran warns election delays could slow nuclear deal moves

BRUSSELS (AP): Iranian Foreign Minister Mohammad Javad Zarif on Monday urged the United States to quickly rejoin the international agreement limiting Iran's nuclear ambitions, warning that the Islamic Republic's upcoming elections could stymie progress in any talks.

The Trump administration in 2018 unilaterally withdrew the U.S. from the Iranian nuclear accord, in which Tehran had agreed to limit its uranium enrichment in exchange for the lifting of economic sanctions.

When the U.S. then reimposed some sanctions and added others, Iran gradually and publicly abandoned the deal's limits on its nuclear development.

development.
White House officials

have said the new U.S. administration is prepared to return to the deal as soon as Tehran shows "strict compliance" with its terms.

Zarif said that as Iran's June elections approach, the United States will find itself dealing with a government unable to make progress in the nuclear talks.

"A lame duck government will not be able to do anything serious. And then we will have a waiting period of almost six months. We will not have a government before September," Zarif said at an online conference with the European Policy Centre think-tank in Brussels.

"A lot of things can happen between now and September. So, it is advisable for the United States to move fast," Zarif said.

Going into the presidential election, the Iranian public is disenchanted with President Hassan Rouhani and his allies who struck the nuclear accord. Rouhani, a cleric who is a relative moderate in Iran's theocratic government, is term limited from running again.

In December, Iran's parliament passed a bill requiring the government to limit its cooperation with U.N. inspectors and push the nuclear program beyond the agreement's limits. Tehran then began enriching uranium up to 20% purity and other work barred by the deal.

But Iran believes that the U.S., as the country which first reneged on the 2015 agreement, must make the first move, and should not set any preconditions. "We are ready to go

back immediately, after the United States goes back to implementation of the deal. That's as simple as that," Zarif said. He rejected renegotiating any parts of the deal, or adjusting the "timeframe" under which Tehran should take certain steps.

"We don't see any reason for talks; we can go immediately to implementation and then have talks," Zarif said, adding that he has seen no new proposals from the U.S. yet. "Up until now, this administration has done nothing different from the Trump administration."

The sanctions im-

posed on Tehran lock it out of international financial markets and bar the country from selling its crude oil abroad. Iran's economy has cratered in the meantime as inflation remains unchecked and its currency, the rial, suffers. The coronavirus pandemic has only worsened those woes.

Zarif said that a significant amount of Iranian money is now being held in Iraq.

"We are selling Iraq gas and electricity ... but the U.S. doesn't permit Iraq to give us the money, as if they give us permission to donate to Iraq gas and electricity. And we need that money very badly for corona, for the vaccine, for food and medicine for our people."

Myanmar junta orders martial law in 6 Yangon townships

YANGON, MYANMAR (AP): Myanmar's ruling junta has declared martial law in six townships in the country's largest city, as security forces killed dozens of protesters over the weekend in an increasingly lethal crackdown on resistance to last month's military coup.

State broadcaster MRTV said Monday that the Yangon townships of North Dagon, South Dagon, Dagon Seikkan and North Okkalapa have been put under martial law. An initial announcement was made late Sunday saying two other townships — Hlaing Thar Yar and neighboring Shwepyitha — were being placed under martial law.

At least 38 people were killed Sunday and dozens were injured in one of the deadliest days of the crackdown on anti-coup protesters,

according to the Assistance Association for Political Prisoners, or AAPP, an independent group tracking the toll of the violence. Several estimates from other sources gave higher figures.

Complicating efforts

Complicating efforts to organize new protests as well as media coverage of the crisis, mobile internet service has been cut, though access is still available through fixed broadband connections.

Mobile data service has been used to stream live video coverage of protests, often showing security forces attacking demonstrators. It had been turned off only from 1 a.m. to 9 a.m. for several weeks, with no official explanation.

The blockage of internet service forced postponement of a court hearing in the capital, Natpyitaw, for Myanmar's detained leader, Aung San Suu Kyi, who

was supposed to take part via a video conference, said her lawyer Khin Maung Zaw. Suu Kyi and President Win Myint were detained during the Feb. 1 military takeover, and have been charged with several criminal offenses that their supporters believe are politically motivated to keep them locked up.

Since the takeover six weeks ago, Myanmar has been under a nationwide state of emergency, with its civilian leaders ousted and detained, and military leaders in charge of all government. But Sunday's announcement was the first use of martial law since the coup and suggested more direct military control of security, instead of local police.

The announcement said that the State Administrative Council acted to enhance security and restore law and order, and that the Yangon

regional commander has been entrusted with administrative, judicial and military powers in the area under his command. The orders cover six of Yangon's 33 townships, all of which suffered major violence in recent days.


Thirty-four of the deaths were in Yangon. Video from Hlaing Thar Yar township showed people running away after gunfire was heard at nighttime. Those fleeing carried one injured person and tried to revive two others, one who seemed to be dead or dying, the footage from independent Democratic Voice of Burma showed.


Hlaing Thar Yar was the location of 22 civilian deaths Sunday, according to the AAPP, which said more than a dozen civilians were wounded and described a large number of junta forces engaged in the township.

Four other deaths were reported in the cities of Bago, Mandalay, and Hpakant, according to the AAPP and local media.

In a new tactic, anti-coup demonstrators used the cover of darkness to hold mass candlelight vigils in various parts of Yangon over the weekend, including some that took place after 8 p.m., when a curfew imposed by authorities starts.

The protest movement has been grounded in nonviolent civil disobedience from the start, with marches and general strikes among its main features. But some protesters have advocated stronger, more agile methods of self-defense - such as holding small rallies that are quick to disband and reunite, and devising cover from fire extinguishers, billowing laundry and burning tires.

Billie Eilish makes history after winning Grammy for theme song of unreleased

'No Time To Die'

Los Angeles, Mar 15 (PTI): Singer Billie "No Time to Die" movie.

It was for the first time in the Grammys history that a track from an unreleased film won the award.

In the past, the song, titled "No Time to Die", would have been disqualified, but the Grammy soundtrack committee tweaked its rules amid the coronavirus pandemic, which had a huge impact on movie release calender.

"No Time to Die", the 25th film in the James Bond franchise, was initially suppose to arrive in theatres in April 2020, but was pushed several times amid the pandemic.

The film is now slated to hit the theatres on October 8, 2021.

Eilish, the youngest musician to write a James Bond theme song, released "No Time to Die" track last year on February 13.

The singer-songwriter, who also performed during the 63rd annual show, accepted the award during the pre-show.

Other winners in the visual media catego-Eilish and her brother Finneas won the best ry were filmmaker Taika Waititi for best comsong written for visual media Grammy award pilation soundtrack for 2019's black comedy for their James Bond theme from unreleased "JoJo Rabbit" and Icelandic composer Hildur Gu nadottir for the "Joker" score.

> Eilish was also nominated for song of the year, record of the year, and best pop solo performance for her track Everything I Wanted.

Taylor Swift wins album of the year Grammy, becomes first woman to receive top honour thrice

Los Angeles, Mar 15 (PTI): Singer Taylor Swift's album of the year win for 'Folklore' at the 63rd Annual Grammy Awards has made her the first female artiste to win the top honour three times in her career. She also won it in 2010 for her album 'Fearless

and again in 2015 for '1989'. Prior to the pop singer, celebrated musicians Stevie Wonder, Frank Sinatra and Paul Simon have won the top prize thrice.

Swift's 'Folklore' defeated nominated albums by Jhene Aiko, Black Pumas, Coldplay, Jacob Collier, HAIM, Dua Lipa and Post Malone to win the highest prize of the ceremony.

In her acceptance speech, the 31-year-old singer thanked her collaborators, Laura Sisk, Jack Antonoff and Aaron Dessner, and her boyfriend, actor Joe Alwyn, for helping her write the songs during the coronavirus pandemic.

"I had the best time writing songs with you during quarantine," Swift said.

Alwyn is credited on 'Folkore' under the pseudonym William Bowery. The album, Swift's eighth, released in July last

In addition to album of the year, Swift was nominated at the ceremony for pop solo performance (Cardigan), pop duo/group performance (Exile

), song written for visual media (Beautiful Ghosts), pop vocal album (Folklore) and song of the year (Cardigan)

The singer also performed at the Grammys for the first time in five years, singing a medley of songs from her albums 'Evermore' and 'Folklore'.

The audience-free performance scene was set up on a stage inside the Los Angeles Convention Center, where most of the performances were pre-recorded because of pandemic

Grammys' in memoriam especially long, grim in pandemic year

LOS ANGELES (AP): Brandi Carlile paid tribute to John Prine, Bruno Mars celebrated Little Richard and Lionel Richie honored Kenny Rogers during an in memoriam segment on Sunday night's Grammy Awards that featured an especially long list of names after a year of the coronavirus pandemic.

In one of four performances interspersed between the names and faces in the montage of the past year's dead, Carlile sang "I Remember Everything" for Prine, one of the musical artists lost to the coronavirus, along with country singers Charley Pride and K.T. Oslin, musician and composer Adam Schlesinger, folk singer Trini Lopez and many others.

Earlier Sunday, Prine won two posthumous Grammys for best American roots song and best American roots performance, a year after receiving a lifetime achievement award at the Grammys.

Carlile told The Associated Press that it didn't bother her to be performing without an audience at the pandemic-restricted Grammys because "this time I'm just performing for John Prine.

It's just for John, and I know he's there." Mars, joined by Anderson . Paak blazed

through Little Richard's "Good Golly Miss Molly" and Richie sang "Lady," the ballad he wrote and Rogers made a hit, adding, "I miss you Kenny" as he ended.

Former Alabama Shakes singer Brittany Howard, backed up by Coldplay's Chris Martin on piano, ended the tribute with a stirring version of the Broadway standard "You'll Never Walk Alone."

Among those named in the montage

was jazz pianist Chick Corea, who won two Grammys on Sunday only about a month after his death.

Corea, who died of a rare form of cancer at age 79, won the trophy for best improvised jazz solo and best jazz instrumental album.

Host Trevor Noah introduced the segment by telling viewers that they can see the names of nearly 1,000 people in the music industry who died in the past year at Grammys.com.
