#### AstraZeneca says its vaccine effective against variants identified in India

LONDON, 23 JUN [REUTERS]: AstraZeneca Plc's COVID-19 vaccine is effective against Delta and Kappa variants, which were first identified in India, the company said on Tuesday, citing a study.

The study by the Oxford University investigated the ability of monoclonal antibodies in blood from recovered people and from those vaccinated to neutralize the Delta and Kappa variants, the

Last week, an analysis by the Public Health England (PHE) showed that vaccines made by Pfizer Inc and AstraZeneca offer high protection of more than 90% against hospitalization from the Delta variant.

The latest Oxford study results are built on the recent analysis by PHE, the company said.

The Delta variant is becoming the globally dominant version of the disease, the World Health Organization's chief scientist said on Friday.

#### Chennai's Virtual Warriors save hundreds of lives during pandemic

CHENNAI, 23 JUN [NDTV]: From their Chennai home, sisters Grace Priyadarshini Emmanuel, an IAS aspirant, and Preethi Esther Emmanuel, an architect, both Covid survivors, are virtually helping other patients and their families every day.

They share verified information on availability of beds, oxygen, ambulance, medicine, oxygen concentrators and even food on their Instagram pages. The siblings work 18 hours a day, glued to their devices, talking on their phones or texting those in need of help or hospitals and service providers. Their timely leads, they say, have helped several thousands of patients as the messages were shared and went viral when cases in Tamil Nadu peaked amid the second wave, with acute shortage of oxygen and beds.

The sisters lost their maternal grandparents to Covid after five members in their family, including their mother Pamila Emmanuel, contracted the virus. It was then the family, just like thousands of others, faced the ground reality of shortage of beds and oxygen facilities and struggled without leads that led to wastage of time.

Once the sisters recovered, they decided to reach out and help others like them with credible leads. On what motivates them, Preethi Esther, who's also a gospel singer, said, "People found beds when they were on the verge of dying. What more in life can one ask for? In the ambulance, when you hear the beep sound, you know the person could die any moment and I find a bed and they stabilise. What more can one want?"

In just weeks, they evolved a unique model. More than a hundred individuals from around the world who benefitted from their help volunteered to join hands with them. They verify every lead before sharing. Their reach has now expanded across south India. "People don't have to call us as we share only verified leads and we receive so many thank you messages and calls about how the information helped them," said Priyadarshini Emmanuel.

## Low testing spikes positivity rate, but reassuringly no new Covid deaths in last 24 hours

The number tests be- $\mathbf{I}$  ing conducted in the State have mdropped substantially, and while this could be because fewer primary contacts of Covid-positive people have still not been screened, it is also something that the concerned authorities should address and expand mass testing system. And as can expected with fewer tests, when people who suspect exposure show up for tests, Sikkim's test positivity rate has also gone up and was recorded at 19.80% after having dropped close to 5% only a few days back. Sikkim recorded 131 new cases of Covid-19 in the last 24 hours from the testing of 659 samples.

On the other hand, continuing its record of posting more recoveries than new cases, the same 24 hours also saw 171 Covid patients make full recoveries and get discharged from home iso-

These two figures combined to reduce the number of active Covid cases in the State to 2,390.

At the same time, the State witnessed no new COVID deaths in the last 24 hours in the State, and this reassuring since only a day earlier, it had lost three lives to Covid. Sikkim's COVID death toll stands at 296. The

second wave has claimed 160 lives since 22 April.

> INSACOG had recently identified a viral variant (delta, B.1.617.2). This viral variant has also been seen in nine other countries of the world.

INSACOG is an Indian consortium of 28 labs, established by the Government of India to carry out genome sequencing of the virus causing the COVID-19 pandemic.

The World Health Organisation has introduced a classification as VOC (variant of concern) and VOI (variant of interest), with the evolution of several variants around the globe.

Delta variant as well as all Delta sub-lineages including Delta Plus are classified as VOC, the statement said.

The Indian SARS-CoV-2 Genomic Consortia (INSACOG)reported the evolution of Delta plus variant (B.1.617.2) + K417N lineage of SARS-CoV2 called as B.1.617.2.1/ AY.1.

The Delta plus variant B.1.617.2.1/ (AY.1) is characterized by the K417N mutation in spike protein, the statement said.

As of June 18, 205 se-The spike protein aids the virus to gain receptor-mediated entry into human cells. K417N corresponds to the change

to asparagine (N) at the 417th position of spike protein. There are other Delta plus variants with other mutations.

The AY.1 is the most well-known, but these are not identical. A second clade found in sequences uploaded to GISAID from the USA, is now designated AY.2, but is not seen in India yet, the statement said.

"All Delta sub-lineages are treated as a variant of concern VOC, although properties of AY.1 are still being investigated. Currently, the variant frequency of AY.1 is low in India. Cases with AY.1 have been mostly reported from nine countries of Europe, Asia and America," the ministry statement stated.

The SARS-CoV-2 virus causing COVID-19 disease is mutating continuously with increase in the number of infections both across the world and in India.

Mutations help the virus to become either more transmissible or more virulent or both. With time these mutations known as Variants of Interest (VOI) increase in frequency in the selected population and are considered then as

Thief Election Commissioner,

Sushil Chandra along with Election Commissioner, Rajiv Kumar and Election Commissioner, Anup Chandra Pandey released 'General Elections 2019 - An Atlas' on 15 Jun, a press release informs.

Mr Chandra commended the officers of the Commission for compiling this innovative document and expressed hope that this would inspire academicians and researchers to further explore the vast landscape of the Indian elec-

The Atlas encompasses all the data and statistical figures of this monumental event. It has 42 thematic maps and 90 tables depicting various facets of the elections. The Atlas also shares interesting facts, anecdotes and legal provisions related to the Indian elections, the release adds.

Since the first General Elections in 1951–52, the Commission has been publishing compilation of electoral data in the form of narrative and statistical books. 17th General Elections conducted in 2019 were the largest democratic exercise in human history which witnessed the participation of 61.468 crores Voters at 10.378 Lakhs polling stations spread over 32 Lakhs square kilometer territory of India.

In Indian elections, electoral data is primarily collected during

the preparation of Electoral Roll by the Electoral Registration Officers and also in the process of conduct of elections by the Returning Officers. This data is then collated by these statutory authorities. Thereafter, after the culmination of the electoral process, the Election Commission of India collects this electoral data and prepares various reports for compilation, record and dissemination purposes.

In October 2019, the Commission released statistical reports based on the electoral data made available by the Returning Officers of 543 Parliamentary Constituencies. The maps and tables as placed in this AC as depict that information and provide for better understanding and appreciation of electoral diversity of the country. In addition to contextualizing the data, these detailed maps reveal electoral patterns at various levels as well as indicate its spatial and temporal settings. With an aim to better visualize and represent the electoral data, this AC as serves as an informative and illustrative document that brings to light the nuances of the Indian electoral process and empowers readers to analyze trends and changes.

The Atlas brings out salient features such as data of the 23 States and UTs where women voting percentage was more than the male voting percentage; information about the largest & smallest parliamentary constituency in terms of electors, candidates and performance of political parties amongst other parameters.

The Atlas depicts the elector's data in different categories and through various comparison charts like Elector Gender Ratio and electors in different age categories. The 2019 General Elections witnessed the lowest gender gap in the history of Indian elections. The Elector Gender Ratio which has shown a positive trend since 1971 was 926 in 2019 General Elections.

The Atlas also compares the average number of electors per polling station in different states during 2014 & 2019 General Elections. The Election Commission of India set up over 10 Lakhs polling stations in General Elections 2019 with the lowest number of electors per polling station (365) in

Amongst the various other categories, the atlas compares the number of contesting candidates in the General elections since 1951 In the 2019 General Elections, there were 8054 qualified contesting candidates after rejection of nominations & withdrawals from a total of 11692 nominations filed across the country.

#### in a week. He spoke to Moody's cuts India growth forecast for 2021 to 9.6 pc

New Delhi, Jun 23 (PTI): Moody's Investors Service on Wednesday slashed India's growth projection to 9.6 per cent for 2021 calendar year, from its earlier estimate of 13.9 per cent, and said faster vaccination progress will be paramount in restricting economic losses to June quarter

In its report titled 'Macroeconomics India: Economic shocks from second COVID wave will not be as severe as last year's', Moody's said high-frequency economic indicators show that the second wave of COVID-19 infections hit India's economy in April and May. With states now easing restrictions, economic activity in May is likely to signify the trough. 'The virus resurgence adds uncertainty to India's growth forecast for 2021; however, it is likely that the economic damage will remain restricted to the April-June quarter. We currently expect India's real GDP to grow at 9.6 per cent in 2021 and 7 per cent in 2022," Moody's said. Earlier this month, Moody's had projected India to clock a 9.3 per cent growth in the current fiscal ending March 2022, but a severe second COVID wave has increased risks to India's credit profile and rated entities.

Indian economy contracted by 7.3 per cent in fiscal 2020-21 as the country battled the first wave of COVID, as against a 4 per cent growth in 2019-20.

Stating that stringent lockdowns in economically significant states will mar April-June quarter economic activity, Moody's said the 10 states that have been hardest hit by the second wave collectively account for more than 60 per cent of the pre-pandemic level of India's GDP.

## Banks get part of Vijay Mallya, Nirav Modi, Mehul Choksi's seized assets

NEW DELHI, 23 JUN [PTI]: Assets worth ₹ 9,371 crore belonging to fugitive businessmen Vijay Mallya, Nirav Modi, Mehul Choksi have been transferred by the Enforcement Directorate to state-run banks that will help them recover losses on account of the fraud.

So far, the agency has seized assets worth ₹ 18,170.02 crore, which include assets worth of ₹ 969 crore located in foreign countries. The value of those assets represents 80.45% of the total bank loss.

"As on date, out of the total seized assets of ₹ 18,170.02 crore, under the provisions of the Prevention of Money Laundering Act, 2002 (PMLA), assets worth of ₹ 329.67 crore were confiscated and assets worth ₹ 9041.5 crore, representing 40 per cent of the total loss to the bank have been handed over to the Public Sector banks," the Enforcement Directorate said today.

Citing the move, Finance Minister Nirmala Sitharaman, in a tweet, said, "Fugitives & economic offenders will be actively pursued; their properties attached & dues recovered."

The extradition of Vijay Mallya has been ordered by the Westminster Magistrates Court and confirmed by the UK High Court. Since, Vijay Mallya has been denied permission to file appeal in the UK Supreme Court, his extradition to India has become final.

Recently, the ED has transferred shares attached by it (worth of ₹ 6,600 crore approx) to SBI-led consortium as per order of PMLA Special Court, Mumbai. Debt Recovery Tribunal, on behalf of the consortium of banks, has sold the shares for over ₹ 5,800 crore. The transferred attached assets also include real estate properties and other movable assets of the fugitives.

## **Deciding Employment**

#### The job market requires better sales persons

fter nearly two decades of trying to inspire the Ayouth towards gainful self-employment, entrepreneurship and private sector employment, and even throwing up the carrot of "unemployment allowance," the State is soon going to have an entire university dedicated to skill development. Only the Act has been passed, so it is still early days to see what it will achieve and deliver. As for the unemployment allowance, it was a policy commitment announced by the previous government which one should perhaps explain away to an election year temptation, and some form of it was also promised by the dispensation now in office, and even that can be excused to the pressures of an election year. What that led to is a situation where the "policy announcement" remained only an expression of interest and no specific details of how this 'allowance' was to be dispensed were shared. Coming as it did in an election year and in a political charged time, and given the less than mediocre level of professionalism among its bureaucrats and the complete absence of an earnest civil society, it was always unlikely that this initiative will be allowed to be anything more than a sop. One had hoped though that the allowance did not end up encouraging indolence because the real role of an unemployment allowance is to support an unemployment youth in her/ his search for employment, not to ensure that they can continue living comfortably unemployed. It is important that if such an allowance is ever extended, it sustains efforts to find employment and does not become a sop which rewards the status of remaining unemployed. And this should be an initiative which the unemployed youth should lobby for to be made meaningful because if extended as a sop, the allowance will be a pittance because it will have to be spread wide and indiscriminately, but if drafted intelligently and with the interests of those genuinely interested to find employment, it can supplement the continuing efforts to equip Sikkim's unemployed young with more employable skills. It will also ensure that desperate youth do not end up settling for jobs much below their skills.

And while on the topic of unemployment, employability and aspirations, it will be worthwhile for Sikkim and its people to also deliberate over the continuing obsession for government jobs. Government employment, with its job security, absence of accountability and lavish salaries, is understandably aspired for by the unemployed; but it is beyond comprehension how employment anywhere else is not even considered an employed status in Sikkim. People employed in the private sector can continue to secure 'employment identity cards' attesting to their unemployed status! While one may argue that remunerations in the still nascent pri vate sector are rather low, it still does not explain why it is not considered employment. In fact, if they are so recognised, then such employers can also be pulled up when employees are paid unfair wages. Don't even recognise it, and then the sector cannot even be regulated.

Attempts were made to make this system of "employment identity cards' more representative of actual employment status during such schemes as the CMSES, but these met with only limited success. Issues like these will also be need to be resolved when the unemployment allowance regime is brought into play. And then there is the still largely unaddressed situation under which attempts to inspire the youth towards self employment and private job markets continue to meet with only limited success. Sikkim needs to collectively address this issue and take the opportunity opened by the pandemic during which the list of benefits of having "local" employees has grown longer to address employment and its aspirations...

## Campus Free Speech: Does it extend to what students say online?

Professors fiercely champion free speech. Many believe that unfiltered, even offensive, expression is fundamental to post-secondary academic life. But what about their students? Should student social media posts be punishable, even if they are made off-campus?

This emerging issue in the perpetual battle over free expression speaks to the perils of ever-present devices, ubiquitous wifi and instantaneous communication. Given Bill C-10's potential impact on Canadian online speech, such as the Canadian Radio-television and Telecommunications Commission (CRTC) potentially regulating content we view on social media, defining the contours of online expression is important.

This issue also relates to rapidly shifting demographics at Canadian post-secondary institutions. Namely, the difficulty in adjudicating diverse speech by even more diverse students.

Racialized students account for 40 per cent of undergraduates and graduates at Canadian universities. Weighing unrestricted expression via dynamic technologies against fostering a tolerant public sphere will test the fundamental freedoms we cherish in our democratic society.

THE CASE OF A PHARMACY STUDENT

Kimberly Diei is a graduate student at the University of Tennessee studying at the pharmacy school. Earlier this year, the university received anonymous complaints about her social media activity - more than 17 Instagram posts and tweets (all made under a pseudonym) - including rap lyrics she wrote based on Cardi B and Megan Thee Stallion hit song WAP.

University of Tennessee administrators later expelled her for "crude" and "vulgar" posts. Diei appealed and her expulsion was reversed. She then filed a lawsuit alleging that the University of Tennessee violated her freedom of expression without valid educational purposes.

Evolving online communication practices raise important issues:

- What are the limits of student speech?
- How should institutions judge incendiary social media posts?
- Can we prevent problems similar to Diei's

from recurring? TINKER TAILORS SPEECH: THE DISRUPTION

Tinker v. Des Moines remains the iconic student

expression case. The case involved young activists who wore black armbands to school to protest the Vietnam War. Administrators expelled the students until they removed this "offensive" clothing. The students fought back.

In response, U.S. Supreme Court Justice Abraham Fortas wrote that students do not "shed their constitutional rights to freedom of speech or freedom of expression at the schoolhouse gate," guaranteeing student speech constitutional protection in America.

The Tinker standard became determinative. Expression was protected as long as it did not disrupt education.

Subsequent cases refined Tinker's broad speech protection. Bethel prohibited sexually vulgar speech made during a school assembly. Hazelwood School District vs. Kuhlmeier granted a school editorial control over sponsored activities like student newspapers. Morse v. Frederick permitted a school to restrict speech promoting drug use. Mahanoy Area School District v. B.L. involves a cheerleader who was suspended for posting expletives on Snapchat (she had expressed frustration over not making her high school cheerleading squad). This case is currently being decided by the U.S. Supreme Court. Substantial disruption remains the standard.

Canada has no formal case law equivalent to Tinker, so student online expression rules tend to vary depending on campus policies. For example, the University of Toronto Mississauga suggests that faculty, staff and students who post to institutional accounts follow the Golden Rule in guiding their posts, among other prudent recommendations.

Although Diei's dilemma was not decided at trial, University of Tennessee administrators applied the Tinker standard. Anonymous student complaints show that she unsettled members of her learning community. However, Diei's posts did not appear to meet existing disruption thresholds to justifiably limit her speech. This seems appropriate given the coarse nature of daily online discourse.

"Freedom of thought, belief, opinion and expression" are enshrined in the Canadian Charter of Rights and Freedoms, subject to "reasonable limits." As such, Canadian post-secondary institutions could follow Tinker's disruption standard to judge whether student speech should be reasonably limited.

Despite her vindication, Diei's struggles speak to another issue. The role post-secondary institutions should play in policing student communications.

SHIFTING COMMUNICATION TOOLS - ONLINE

IDENTITY EXPLORATION

Many people support opening up academic spaces to new people. However, public-facing digital communication tools surface a new source of

Academic spaces are used to accommodating a relatively finite amount of private expression, like traditional face-to-face interactions in classrooms. Now they are trying to keep up with a much higher volume of online speech occurring in an ever expanding number of virtual spaces via social media platforms.

In short, slow-paced post-secondary institutions with long histories in the physical world have difficulty responding to incredibly fast-paced student social media posts in the virtual world. And the university's faculty may not realize that these online spaces are fundamental for youth identity exploration that may inadvertently violate inflexible communication norms of the institution.

Diei's difficulties speak to the need for these formal places to become responsive to shifting technological mores. They should also welcome novel forms of informal expression that push against traditional forms of communication.

LETTING KIDS BE KIDS? - UNDERSTANDING PROFESSIONAL SPEECH

Many professors likely believe that discussing social media is beyond the scope of the classroom. Why should the average lecturer spend valuable time speaking about student posts when they are busy teaching?

Diei expressed confusion about what she could express online. Younger students may be even more perplexed about how their expression potentially breaches institutional communication standards.

Given the internet's infinite memory, we should proactively discuss online speech across all levels of education. Otherwise, students could be increasingly penalized as communication becomes further disjointed. Languages intermingle and social media organically creates unique new idioms that are different from traditional academic and professional speech.

Youth must understand how their informal expression conflicts with the professional environments they are entering. Unless we discuss how traditional communities communicate, and even challenge their unforgiving standards, our students could face career difficulties that may only worsen while they are under our educational care and beyond.

## How to teach writing to Grade 1 kids: New strategies for teachers and parents

ing. However, many children struggle to learn to write. For most, their difficulties persist throughout elementary school unless they get help. As recently as 2018, there was very little research on how to teach Grade 1s ef-

However, recent research shows how teachers can help Grade 1s make a strong start on writing. Parents have a vital role to play in laying a foundation for early writing success.

Many parents have likely heard children say, "I don't know what to write." Teaching children strategies for writing tackles this problem head-on.

BREAKING WRITING DOWN INTO **STEPS** 

In 2019, a team of Spanish and British researchers published one of the first experiments on teaching writing strategies in Grade 1. They explored how a child can learn to write a story by asking themselves a series of questions: When did it happen? Where did it happen? Who is the story about? What did they do? What happened? How did it end? These questions help the child to generate and organize their ideas.

To help children remember this writing strategy, teachers in the study used a picture of a mountain with a path that led past six houses — one for each question. The teachers discussed the strategy, modelled how to use it and wrote together with the class. After instruction, the children wrote stories that were higher in quality, longer and more coherent.

strategies in Grade 1 has been con-Writing is a craft that is vital for both communicating and learn- firmed by additional studies that examine teaching specific kinds of writing is more effective than teaching each ing: Procedural writing (instructions for someone on how to do something), and opinion writing (short essays meant to persuade someone of something). In this writing research, teachers combined strategy instruction with discussions, picture books and dramatization.

> And in our own recent research, we found that strategy instruction is effective for Grade 1 students across the range of writing achievement levels: low, medium and high. These Grade 1 studies join over 100 previous studies with students in higher grades in showing that teaching writing strategies works.

HANDWRITING, PRINTING, **SPELLING** 

Recent research also provides renewed support for the seemingly old-fashioned skill of printing. Grade 1s who can print accurately and quickly are able to create better and longer stories and reports. Teaching printing helps students to create better stories. Despite over 70 previous studies on the benefits of teaching printing and cursive writing, systematic teaching and assessment of these skills has declined in some curricula.

Spelling is another traditional skill, the importance of which has been confirmed by recent research. Better spellers create better and longer stories, while poor spellers struggle with composing, and Grade 1 spelling affects the development of composition in later years.

Spelling education works best if

it is formal, including, for example, The value of teaching writing lessons and practice activities. Additionally, teaching writing strategies of these skills alone.

> Parents can help children practice spelling at home. Teachers and parents can also show children the "invented spelling" strategy of saying a word slowly, stretching out the sounds, and printing a letter (or letter combinations, such as "th") for each sound. This will lead to some errors, but in kindergarten and Grade 1, invented spelling is an important driver of spelling development.

UNDERSTANDING NEW GRADE 1

This new understanding of the importance of Grade 1 is beginning to change writing education. In the past, many schools in Canada and the United States waited for struggling readers and writers to reach the middle elementary grades. Then, they were assessed by a school psychologist. If they were diagnosed with a learning disability, they were placed in a special education class.

However, in a new approach, response to intervention, teachers use evidence-based methods (like strategy instruction) to teach the whole class. They assess students regularly based on their daily writing, and if a child is below grade level, they receive help in a small group.

This approach is not yet common. However, it is almost certainly coming to some provinces in reading education. Reading education and writing education are intertwined, so we can expect the same approach to follow in writing.

The foundation for writing success is ideally being supported at home before children start kinder-

Parents can ask children to tell them stories, print the stories for them, then read them aloud for the child. They can teach children simple skills like forming letters and printing

Parents can also practice printing with children at home; this is especially valuable for struggling writers. They can help children to write things that are important to them, like birthday cards for family members.

Parents can also encourage children to read and write independently. Once children begin to write, parents can be their best audience, praising their efforts and the good qualities of their writing, and making suggestions to help with ideas, printing, and spelling.

When children begin school, and into Grade 1, parents can watch for red flags in their child's writing development. During Grade 1, the average student learns to print the letters of the alphabet legibly and fluently, spell one syllable words the way that they sound (cat, game) and spell common short words that are not spelled the way that they sound (you, they). They also learn to write a story a few sentences in length about a personal ex-

If your child is missing these basic skills, don't wait and see — talk with your child's teacher and make a plan to help them succeed.

Mr Dhankhar, who shares a strained relationship with the TMC government, is yet to react to the development.

"We have been saying Bengal's parliamenta- this for a long time that

the present governor is acting as the mouthpiece of a specific political party. He is not only interfering in the functioning of the state of affairs but is also maligning the West Bengal government," senior TMC leader and MLA Tapas Roy said.

However, the West Bengal unit of the BJP came out in support of the governor and claimed that he has exposed the truth.

"The TMC is angry with the governor as he has exposed the lawless situation in the state. There have been complaints against him earlier, but all of them were baseless," BJP state chief Dilip Ghosh said.

The TMC government and Mr Dhankhar have been sharing an acrimonious relation since he assumed office in July

## 10 new cases push COVID-19 tally of Andamans to 7,425

PORT BLAIR, JUN 23 (PTI): The COVID-19 tally of Andaman and Nicobar Islands rose to 7,425 on Wednesday as 10 more people tested positive for the infection, a health bulletin said. Two new patients have travel history, while eight fresh infections were detected during contact tracing, it

The COVID-19 death toll in the Union territory remained unchanged at 127 as no fresh fatality was reported, the bulletin said. Four more people have been cured of the disease, taking the total number of recoveries to 7,195, it said. The archipelago now has 103 active cases, the bulletin said.

The administration has so far tested more than 4.03 lakh samples for COVID-19, with a positivity rate of 1.84 per cent. Over 1.40 lakh islanders have been vaccinated to date.

#### **UP police to use drones to spot illegal** liquor dens near Nepal border

BAHRAICH, 23 JUN [PTI]: Drone cameras will be used to find illicit liquor dens in forest areas near the Indo-Nepal border, an official said on Wednesday.

Instructions have been issued to identify illegal liquor manufacturing and selling bases with the help of drone cameras, especially in the forests of the Mihinpurwa area of the district, he said. Police, excise, and administrative machinery have been asked to develop an effective informer network in this direction, the District Magistrate said, adding the Gangsters Act will be invoked against those involved in the trade.

After reports partment will carry out deaths following consumption of spurious liquor in Aligarh, Pratapgarh, and other districts, the state government issued instructions of taking strict action against those involved in the trade, especially in the rural areas.

In Bahraich, police have arrested many in connection with it by raiding forest and rural areas near the Indo-Nepal border.

#### 103 jail inmates among 430 new Covid cases in Mizoram

AIZAWL, 23 JUN [PTI]: remaining 415 fresh in-Mizoram's COVID-19 tally soared to 18,398 on Wednesday as 419 more people, including 103 jail inmates, tested positive for the infection, a health official said.

All the infected prisoners are inmates of Central Jail, Aizawl, he said.

More than 70 children, six security personnel and two healthcare workers are also among the new patients, the official said.

Also, 16 fresh cases were detected in an orphanage and rehabilitation centre in Aizawl where 528 infections were reported on June 21. Aizawl district registered the highest number of new cases at 299, followed by Lawngtlai (52) and Kolasib (30), he said.

Four patients have travel history, while the fections were detected during contract tracing, the official said.

The new cases were detected among 3,974 samples that were tested, with the highest single-day positivity rate of 10.82 per cent. Mizoram now has 4,413 active cases, while 13,900 people have recovered from the disease and 85 patients have succumbed to the infection so far.

The state has thus far tested over 4.62 lakh samples for COVID-19. The recovery rate among the coronavirus patients in the state stands at 75.55 per cent, while the mortality rate is at 0.46 per cent.

Over 4.14 lakh people have been inoculated thus far, State Immunisation Officer Dr Lalzawmi said.

## **IndiGo offers discount for** vaccinated passengers



New Delhi, Jun 23 (PTI): IndiGo will give 10 per cent discount from Wednesday onwards to all passengers who have taken at least one dose of COVID-19 vaccine, a statement said.

The discount would be given on base fare and only "limited inventory" is available under this offer, the airline's statement noted.

"The offer is only available to vaccinated passengers aged 18 years and above, who are located in India at the time of booking and have already received a (at least one dose of) COVID-19 vaccine in the country," it said.

Passengers who have

availed the offer at the time of booking will be required to furnish a valid COVID-19 vaccination certificate -- issued by the Ministry of Health and Family Welfare -- at the airport check-in counter as well as the boarding gate, it mentioned.

"Alternately, they can display their vaccination status on the Aarogya Setu mobile application at the airport check-in counter/boarding gate," it added.

Sanjay Kumar, Chief Strategy and Revenue Officer, IndiGo said, Being the largest airline in the country, we feel it is our responsibility to contribute to the national vaccination drive, by

encouraging more people towards this common goal."

During April and May, India had been badly hit by the coronavirus infection's second wave, which is receding currently. Several states have been complaining about the COVID-19 vaccine shortage for the last couple of months.

Ministry Health and Family Welfare said on Tuesday that more than 2.14 crore COVID-19 vaccine doses are still available with the states and union territories and over 33,80,590 vaccine doses are in the pipeline and will be received by them within the next three days.

## Mosque demolition: HC issues notice to ex-Barabanki SDM

Lucknow, Jun 22 (PTI): The Allahabad High Court Tuesday directed the respondents to file their responses within three weeks in connection with the demolition of a mosque at Barabanki on May 17.

The Lucknow bench of the HC also issued a notice to the then Sub-Divisional Magistrate (SDM) of Ram Sanehi Ghat in Barabanki for his reply as malice was alleged against him.

It also granted a week to the petitioner for filing a rejoinder affidavit, fixing July 27 as the next date of hearing.

A division bench of Justice Rajan Roy and Justice Saurabh Lavania passed the order on two writ petitions filed by UP Sunni Central Waqf Board and Hashmat Ali and others.

The bench had heard the matter on June 15 and reserved its order on the question of interim

relief.

The bench recorded in its order that the senior advocate appearing for UP Sunni Central Waqf Board was unable, as of now, to show any documentary proof about the ownership right of the committee of management on the land where the mosque was constructed.

In the writ petitions, it has been alleged that the mosque was standing for hundred years on the land recorded as abadi land in revenue records.

It has been alleged further that the then SDM Ram Sanehi Ghat, due to personal grudges and mala-fide reasons, got it demolished on May 17, 2021 in the garb of powers exercised under section 133 of CrPC.

"The matter was beyond the scope of exercise of power under Section 133 CrPC, yet, the SDM, only to satisfy his personal ego and out of malice, not only proceeded under the said provision unjustifiably and illegally, but ensured that the mosque is demolished," charged the petitioners.

It was also pleaded that here is no place for personal ego, whims and fancies in a country governed by rule of law.

The state lawyer opposed the petitions and pleaded that the writs were not maintainable.

After hearing the matters, the bench issued notices to the respondents and asked them to file their detailed reply.

## In Ramdev vs Doctors, Patanjali co-founder goes to Supreme Court



New Delhi, 23 Jun [NDTV]: Yoga teacher Ramdev -- who infuriated doctors across the country with his disparaging remarks on allopathic medicine - has approached the Supreme Court seeking a freeze on the police cases against him over the issue. He has also asked that the First Information Reports filed across the country be clubbed together and transferred to Delhi.

Last month, as the second wave of Covid ripped through the country killing thousands, Ramdev stirred a controversy with his remarks on the efficacy of allopathic drugs against the

In a widely shared video, he was heard saying, "Lakhs of people have died because of allopathic medicines, far more than those who died because they did not get treatment or oxygen."

He even purportedly called allopathy a "stupid and bankrupt" science. offending the whole medical fraternity.

challenging Later, calls for his arrest, said, "even their baap (father) cannot arrest Swami Ramdev". His firm, Patanjali, said it would give a "befitting reply" to any defamation notice.

Various units of the Indian Medical Association filed complaints against him with the police, based on which multiple cases were lodged. The association, which had sought an apology within 15 days, later sued him for defamation and demanded a compensation of ₹ 1,000 crore.

The Delhi Medical Association also went to court, seeking a to-

ken compensation of Re 1 and an unconditional apology.

Ramdev had withdrawn his comments within days, following a communication from the Union health minister Dr Harsh Vardhan. But the Indian Medical Association has said they would drop the cases against him only if he withdrew his comments against al-

> lopathy in entirety. "We have nothing against yoga guru Baba Ramdev. His statements are against vaccines for COVID-19. We think his statements could confuse people, may divert them. This is our big concern as he has many followers," said IMA chief Dr JA Jayalal.

Earlier this month, Ramdev said he would soon get the jab and described doctors as "God's envoys on earth".

## Ayton soars for last second alley-oop, Suns beat Clippers

**PHOENIX (AP):** Devin Booker sat in a chair with a crooked and swollen nose, complete with tape over three fresh stitches.

He also had a big smile on his face, remembering Jae Crowder's pass, Deandre Ayton's tip-in dunk and a play that will live in Phoenix Suns lore for a long, long time.

Ayton jammed an alley-oop pass from Crowder with 0.7 seconds left, lifting the Suns to a 104-103 win over the Los Angeles Clippers on Tuesday night in Game 2 of the Western Conference finals.

It was a game that looked as if it was all but over, but Booker's Suns were not going to be denied.

"I believed it could happen,"

Booker said. "100 percent."

The Suns were down one with 0.9 seconds left when Crowder lofted a high pass on an out-of-bounds play on the baseline. A soaring Ayton came down the lane and stuffed it through the net over L.A.'s Ivica Zubac as the crowd roared in disbelief. Booker — playing with a stitched up nose following a collision with Clippers guard Patrick Beverley — had a key

"The celebration and reaction were a little shaky," Ayton said. "Because I wasn't sure what I did. I wasn't sure if it counted."

screen on Zubac on the final play,

which helped free Ayton.

The referees spent about a minute reviewing the play before ruling the basket was good and Booker spent some time jawing with Clippers players Rajon Rondo and Demarcus Cousins in the aftermath. The Clippers couldn't get a shot off in the final 0.7 seconds.

"Those are my Kentucky guys," Booker said with a grin. "I told them 'Go Big Blue."

The Suns now have a 2-0 lead in the series heading to Los Angeles for Game 3 on Thursday night.



The Clippers will be fighting from a 2-0 deficit for the third time in these playoffs after rallying to beat the Mavericks and Jazz.

The Crowder-to-Ayton connection negated a Clippers rally that was led by Paul George, who had 26 points.

George made a layup with 31 seconds left to give the Clippers a 101-100 lead for their first advantage since early in the third quarter. He added a 22-footer on their next offensive possession for a 103-102 lead.

But there was a lot more action left.

George — and 85% career free throw shooter — missed two free throws with 8.2 seconds remaining and the Suns had a chance to win, but it looked as if it wouldn't happen when Mikal Bridges missed a

corner 3-pointer and the ball was deflected out of bounds.

Instead, it set up Crowder's heave to Ayton, who was dominant in the paint all game long.

Even with his big late shot-making, George's missed free throws loomed large.

"Obviously, it was an opportunity that was missed," George said. "Pat made an unbelievable play that put me in the position to extend the lead. I am always confident at the free throw line. I have always been very successful in clutch moments at the free throw line. Tonight, I was just unsuccessful."

The Suns have won a franchise-record nine straight in the playoffs.

The Suns were led by Cameron Payne, who was brilliant while

subbing for All-Star Chris Paul. He finished with a career-high 29 points. Ayton had 24 points and 14 rebounds, while Booker added 20 points.

"We just had no answer for Cameron Payne," Lue said. "He got downhill all night. His speed and his quickness really hurt us all night."

Payne repeatedly carved through the Clippers defense, making tough buckets at the rim with pretty left-handed finishes. He made what looked like a crucial layup with about 90 seconds left, finishing high off the glass to give the Suns a 100-95 lead.

But the gritty Clippers responded and nearly pulled this one out.

"It is a hard game to swallow because look at this game, we've got this game won," Beverley said. "But we have been in the trenches before. We respond well in the trenches and we will respond well. We always do."

It was a tough night for the stars from Game 1 until the final minutes. Booker shot just 5 of 16 from the field and missed part of the third quarter with a bloody nose. George was 10 of 23 from the field and missed his first seven 3-point attempts before his late buckets.

Ayton continued his eye-opening performance in these playoffs. The No. 1 overall pick in 2018 out of Arizona often has been overshadowed by later picks in the same draft like Atlanta's Trae Young and Dallas' Luka Doncic. But he has carved out quite a niche in Phoenix and now has a signature play that will live on in franchise histo-

ry. The Suns were playing without Paul for the second straight game. The 11-time All-Star has been in the league's COVID-19 health and safety protocol for the past week and the team isn't sure when he'll return.

Clippers star Kawhi Leonard missed his fourth straight game with a right knee sprain, and he stayed in Los Angeles to get treatment on the injury.

The action was physical from the opening minutes. Referee Scott Foster gave technicals to Crowder and Clippers forward Marcus Morris Sr. after some jawing following a scrum for a loose ball.

## Hungary's PM uses soccer to push vision of right-wing Europe

BUDAPEST, HUNGARY (AP): Populist Hungarian Prime Minister Viktor Orban has long used soccer to advance his right-wing politics, and now widespread international criticism of a new law seen as targeting the LGBT community has turned this month's European Championship into a major stage for his challenge to Europe's liberal values.

Last week, as more than 60,000 soccer fans poured into Budapest's Puskas Arena, an emblem of Orban's famous devotion to soccer, the Hungarian Parliament approved a controversial bill that bans sharing with minors any content portraying homosexuality or sex reassignment.

Human rights groups and liberal politicians in Hungary and from around Europe denounced the law as conflating homosexuality with pedophilia and as a draconian effort to push any representation of LGBT people into the shadows. Nearly half of the European Union's 27 member countries issued a statement calling it a "clear breach of (LGBT people's) fundamental right to dignity," and officials are examining whether the legislation contravenes EU law.

In a direct rebuke to the law, Munich's mayor and city council called for its stadium to be lit up with rainbow colors in a show of support for tolerance and gay rights when Germany plays Hungary on Wednesday at Euro 2020.

But UEFA, European soccer's governing body, denied the request because it considered it a political move, though other stadiums in Germany unaffiliated with the tournament will be allowed such displays and the team captain will wear a rainbow armband.

The controversy has turned the game into a symbolic showdown between competing visions for the future of Europe, pitting Orban's promotion of what he calls "illiberal democracy" against Western



Europe's "liberal consensus."

Orban has been challenging that consensus ever since he returned to power in 2010: frequently criticizing multiculturalism, curtailing media freedoms, and relentlessly campaigning against the EU itself, portraying Brussels as a modern heir to Soviet Moscow, which dominated Hungary for decades.

His message resonates with many Hungarians who resent interference and perceived condescension from the EU — and he has frequently shown himself adept at maneuvering around its policies, such as when he went out on his own to make Hungary the first EU country to procure Russian and Chinese COVID-19 vaccines not approved by European regulators.

The move — which has led Hungary to have the second-highest rate of vaccination in the EU — offered validation for his strategy of bucking the bloc's dictates, both increasing his power at home and challenging the EU's credibility and liberal values.

Fiercely opposed to immigration, he has blasted European leaders, including German Chancellor Angela Merkel, for plans in 2015 to distribute the burden of that year's wave of refugees from the Middle East and Africa and refused to accept asylum seekers. His crackdowns on the media have led to "a degree of (state) media control unprecedented in an EU member state," according to Reporters Without Borders.

More recently, after his ruling Fidesz party broke with its center-right political group in the European Parliament, Orban has embarked on a mission to unite Europe's rightwing forces into a new political formation.

By all accounts a soccer fanatic and a former player himself, Orban has often used the sport as his preferred venue for pushing his political vision and amplifying his image as a man of the people.

Since the days of Hungary great Ferenc Puskas — widely regarded as one of the best players of all time who led "the Mighty Magyars" to the 1954 World Cup final and an Olympic gold medal at the 1952 Helsinki Games — the country has never again achieved world-class status in soccer. But Orban has attempted to rekindle some of the old magic.

In 2007, he founded the

Puskas Soccer Academy in his home village of Felcsut, where he had played semi-professionally in the 1990s. His government also introduced a scheme where companies may donate money to sports clubs in lieu of paying corporate tax, an arrangement that since 2010 has netted clubs as much as \$2.7 billion — money that critics say would have been better spent on Hungary's ailing health care sector.

The government also directly funds the sport, paying for several of the 32 stadiums that have been built or renovated in Hungary since Orban assumed power, making the structures something of a symbol of state largesse.

This major injection of capital into soccer has made games a popular meeting place for politicians and the politically connected. Orban is often photographed at games with some of Hungary's most successful businessmen, including billionaire Sandor Csanyi, Hungary's second wealthiest person who is also the president of the Hungarian soccer federation and a UEFA vice president.

The games themselves have

In 2017, FIFA, soccer's international governing body, fined the Hungarian soccer federation \$22,000 after Hungarian fans directed the same chant at Ronaldo at a World Cup qualifier in Budapest.

Earlier in the tournament, during a friendly match in Budapest between Ireland and Hungary, Hungarian fans booed Irish players as they knelt on the field as a sign of solidarity against racism.

Orban seized the opportunity to denounce the gesture that has swept Europe and the United States amid calls for action against racial injustice. He defended the fans, asserting that "politics has no place in sports," and chided the Irish national team, telling them not to "provoke the host if you come as a guest."

Hungarians only kneel before God, their country, and their lovers, he said.

Levente Toth, 45, a Hungarian fan who traveled to Munich to view Wednesday's game, said that he thought the push to illuminate Germany's stadium in rainbow colors "has no place in sports," adding that he thought opposition to the new law was "overblown" and echoing the typical message that the legislation protects children.

"No one wants to harm gays or people who think differently or people of different sexual orientations," he said.

But Toth said those displaying homophobic banners or engaging in hateful chants at games "should be lifted out of the crowd."

# Japanese soccer player Yokoyama comes out as transgender TOKYO (AP): Japanese crimination, causing

TOKYO (AP): Japanese soccer player Kumi Yokoyama said they are transgender — a revelation praised in the U.S. where they play in the National Women's Soccer League but an identity not legally recognized in Japan.

The 27-year-old forward for the Washington Spirit said they felt more comfortable with their own gender identity while living in the United States, where teammates and friends are more open to gender and sexual diversity.

"I'm coming out now," Yokoyama said in a video talk on former teammate Yuki Nagasato's YouTube channel. "In the future, I want to quit soccer and live as a man."

Yokoyama's revelation was praised by President Joe Biden.

"To Carl Nassib and Kumi Yokoyama – two prominent, inspiring athletes who came out this week: I'm so proud of your courage. Because of you, countless kids around the world are seeing themselves in a new light today," Biden tweeted. Nassib is the first active NFL player to come out as gay.

The Spirit also expressed the team's support and pride in Yokoyama. "Thank you for showing the world it's ok to embrace who you are!" the team tweeted, adding that the player uses they/them pronouns.

Support and awareness of gender and sexual diversity has slowly grown in Japan, but LGBTQ people lack many legal protections and often suffer dis-

crimination, causing many to hide their sexual identities. An equality law pushed by rights groups was scrapped recently due to opposition from the conservative ruling party.

Transgender people in Japan also must have their reproductive organs removed to have their gender recognized on official documents — a requirement that human rights and medical groups criticize as inhuman and unnecessary and say should end.

Yokoyama said they weren't enthusiastic about coming out but it was a choice made while thinking about the future and that it would be harder to live closeted. "I would not have come out in Japan," they said.

They thanked their teammates, friends and girlfriend for their support and courage.

Yokoyama played for Japan at the 2019 Women's World Cup in France and moved from Japanese club AC Nagano Parceiro to the Washington Spirit.

Yokoyama said they felt a strong pressure to conform and remain closeted in Japan but hoped to live as a man after retiring as a professional soccer player and to help raise awareness for sexual minorities in Japan.

"More people in Japan are becoming familiar with the word LGBTQ and it's seen more (in the media), but I think awareness won't grow unless people like myself come out and raise our voices," Yokoyama said.

### Iran likely had failed rocket launch, preparing for another

Dubai, Jun 23 (AP): Iran likely conducted a failed launch of a satellite-carrying rocket in recent days and now appears to be preparing to try again, the country's latest effort to advance its space program amid tensions with the West over its tattered nuclear deal.

Satellite images, a US official and a rocket expert all confirmed the failed launch, earlier this month, at the Imam Khomeini Spaceport in Iran's Semnan province. The attempt comes as Iran's space program has suffered a series of high-profile losses, while its paramilitary Revolutionary Guard runs its own parallel program that launched a satellite into orbit last year.

As with other failed launches, Iranian state media did not acknowledged it took place. Iran's mission to the United Nations did not immediately respond to a request for comment early Wednesday.

Satellite photos from Planet Labs Inc. and Technologies Maxar show preparations at the spaceport on June 6. Those images include what appears to be fuel tanks alongside a massive white gantry that houses a rocket, while scientists fuel it and prepare for launch. Before the launch, workers tow the gantry away to expose the rocket.

The number of fuel tanks, based on their size, appear to have been enough to fill the first and second stages of an Iranian Simorgh rocket, said Jeffrey Lewis, an expert at the James Martin Center for Nonproliferation Studies at the Middlebury Institute of International Studies. The Simorgh is a satellite-carrying rocket that has been launched from that same area of the spaceport, he said.

Later satellite images on June 17 showed a decrease in activity at the site. Lewis said analysts believe Iran launched the rocket at some point in that window.

Nothing had blown up. There wasn't a giant stain like they had dumped the fuel and the vehicles had kind of just moved around," he said. "The overall level of activity at the site was much lower. So to our mind, that looked like a launch. CNN, which first reported on the failed launch, quoted Pentagon spokesman Lt. Col. Uriah Orland saying that U.S. Space Command is aware of the Iranian rocket launch failure which occurred early June 12. Orland did not elaborate. The Pentagon and U.S. Space Command did not immediately respond to a request for comment early Wednesday from The Associated Press.

It wasn't immediately clear why Iran would have picked June 12 for a launch as Tehran typically schedules such launches for national commemorations. However, it did come in the run-up to Iran's presidential election last week, in which the Islamic Republic had hoped to boost turnout.

## Germany hosts conference to push for progress in Libya

BERLIN (AP): Germany and the United Nations are bringing together representatives of Libya with powers that have interests in the country at a conference Wednesday which aims for progress toward securing elections in the North African nation and the removal of foreign fighters.

The meeting at the foreign ministry in Berlin, with U.S. Secretary of State Antony Blinken among participants, follows up on a January 2020 conference where leaders agreed to respect an arms embargo and to push the country's warring parties to reach a full cease-fire. Germany has tried to act as an intermedi-

Countries that have been involved in the process include the five permanent members of the U.N. Security Council, along with Italy, Turkey and the United Arab Emir-

Ahead of the conference, German Foreign Minister Heiko Maas noted that much has been achieved in the past two years. An October ceasefire agreement that included a demand that all foreign fighters and mercenaries leave Libya within 90 days led to a



deal on elections, due to be held on Dec. 24, and a transitional government that took office in February.

But "many challenges still lie ahead of us," said Maas. "For the further stabilization of the country, it is crucial that elections take place as planned and that foreign fighters and mercenaries really do leave Libya."

He added that Wednesday's conference launches a new phase "in which we no longer only talk about Libya, but in which we are now speaking with Libyan men and women about the future of their country."

Blinken said that "we share the goal of a sovereign, stable, unified, secure Libya free from foreign interference — it's what the people of Libya deserve, it's critical to regional security as well."

"For that to happen, national elections need to go forward in December and that means urgent agreement is needed on constitutional and legal issues that would undergird those elections," he said at a news conference with Maas. "And the Oct. 23 ceasefire agreement has to be fully implemented, including by withdrawing all foreign forces from Libya."

The U.S. special envoy for Libya, Richard Norland, said it was important to start bringing all armed groups in the country under a joint military command. "When foreign forces leave, they're going to need to be replaced by a viable united Libyan national military and police structure," he said.

Meanwhile, aid group **Doctors Without Borders said** this week it was suspending its activities in two detention centers in Tripoli after "repeated incidents of violence toward refugees and migrants held there." It said staff had witnessed guards beating detainees at one center and received reports of people being

Libya has been a key transit country for migrants from Africa trying to reach Europe, especially after the collapse of order when a NA-TO-backed uprising toppled and later killed longtime dictator Moammar Gadhafi in 2011. The oil-rich country

U.N.-supported government in the capital, Tripoli, and rival authorities based in the country's east, each backed by armed groups and foreign governments.

"That's what it comes down to, and of course it's not politically correct to say," he said. He cautioned that elections could deepen polarization if conducted too hastily.

## Hong Kong's embattled Apple Daily says it will close



**HONG KONG (AP):** Hong tors and executives, who per will stop publishing Thursday, following last week's arrest of five editors and executives and the freezing of \$2.3 million in assets under the city's year-old national security law.

The board of directors of parent company Next Media said in a statement Wednesday that the print edition and online edition will cease due to "the current circumstances prevailing in Hong Kong." The paper later said Thursday's edition will be its last.

The silencing of a prominent pro-democracy voice is the latest sign of China's determination to exert greater control over the semi-autonomous territory after huge protests in 2019 shook the government. Since then, Beijing has imposed a strict national security law to curb dissent and revamped Hong Kong's election laws to keep opposition voices out of the legislature.

The Apple Daily announcement coincided with the start of the city's first trial under the national security law, which is being closely watched as a barometer of how strictly the courts will interpret it.

The widely expected move to close Apple Daily followed last week's arrests of the five edi-

foreigners to endanger national security. Police cited more than 30 articles published by the paper as evidence of an alleged conspiracy to encourage foreign nations to impose sanctions on Hong Kong and China.

The police action against Apple Daily was the first time the national security law had been used against journalists for something they had published, in an intensifying crackdown by authorities in a city long known for its freedoms.

Apple Daily reported that its management made the decision out of concern for employee safety and staffing issues.

Police also Wednesday arrested a 55-yearold man on suspicion of foreign collusion to endanger national security. According to Apple Daily, which cited unidentified sources, the man writes editorials for the newspaper under the pseudonym Li Ping.

Apple Daily has been outspoken in defending Hong Kong's freedoms, and in recent years has often criticized the Chinese and Hong Kong governments for limiting the city's democratic freedoms as well as constricting the rights of free speech and assembly not found on mainland Chi-

> The police operation against Apple Daily drew criticism from the U.S., the E.U. and Britain, which say Hong Kong and Chinese authorities are targeting the freedoms promised to the city when the former British colony was returned to China in 1997.

Chinese and Hong Kong officials have said the media must abide by the law, and that press freedom cannot be used as a "shield" for illegal activities.

The national security law imposed last year criminalizes subversion, secession, terrorism and foreign collusion. The first person to

Tong Ying-kit, pleaded not guilty Wednesday to charges of terrorism and inciting secession by driving a motorcycle into police officers during a 2019 rally while carrying a flag with the slogan "Liberate Hong Kong, the revolution of our times." Several officers were knocked over and three sustained injuries.

His trial will set the tone for how Hong Kong handles national security offenses. So far, more than 100 people have been arrested under the security law, including prominent pro-democracy activists such as Lai, Apple Daily's founder.

The slogan "Liberate Hong Kong, the revolution of our times" was often chanted during anti-government demonstrations demanding broader democratic freedoms. Protests accuse Beijing of walking back on its promise at the 1997 handover of Hong Kong from Britain that the city could retain its freedoms not seen elsewhere in China for 50 years.

China responded with tough measures silencing opposition voices, including the national security law.

The legislation makes calls for Hong Kong independence illegal, and a government notice last July said the protest slogan connotes a call for independence and subversion of state power.

A court ruled last month that Tong will stand trial without a jury, a departure from Hong Kong's common law traditions. Under the national security law, a panel of three judges can replace jurors, and the city's leader has the power to designate judges to hear such cases.

The law carries a maximum penalty of life in prison for serious offenses. Tong is on trial at the High Court, where sentences are not

A special flight of Pakistan International Airlines (PIA) PK-6852 airlifted two million doses of Sinovac COVID-19 vaccine from the Beijing Capital International Airport to Islamabad on Tuesday.

It is in addition to 1.55 million doses of Sinovac vaccines from China to Pakistan on Sunday.

According to the National Command and Operation Centre (NCOC), the main body to combat the virus, "The National

Disaster Management (NDMA) is Authority spearheading the process of purchasing vaccines from the international market under the auspices of the NCOC.

The fresh doses will be sent to various vaccine centres across the country for which arrangements are already in place. "With the arrival of

this consignment, the daily average administering of doses across the country will be enhanced considerably," the NCOC




Wednesday. With 39 more deaths, the country coronavirus toll rose to 22,073, reported the Ministry of National Health Services.
