Astrologer Bejan Daruwalla passes away

AHMEDABAD, MAY 29 (PTI): Renowned astrologer Bejan Daruwalla died at a private hospital here on Friday evening, his family said.

Daruwalla, known for his newspaper columns on astrology, was 90.

Apollo Hospital here confirmed that Daruwalla died during treatment.

Speaking to PTI, his son Nastur Daruwalla denied the speculation on social media that his father had contracted coronavirus.

Daruwalla was suffering from only pneumonia, he said.

No govt approval needed for COVID-19 tests:

Gujarat HC AHMEDABAD, MAY 29 (PTI): In a relief to private doctors and people, the Gujarat High Court on Friday said that there was no need to take approval of the government for carrying out coronavirus tests if doctors recommend it.

The Ahmedabad Medical Association (AMA) had approached the high court against a Gujarat government order, which prohibits private doctors and hospitals from conducting COVID-19 tests without getting approval from designated health officials.

In its plea, the AMA argued against this directive saying that doctors' opinion should be treated as final because any delay would adversely affect the health of both the patient and the doctor.

The division bench comprising Chief Justice Vikram Nath and Justice J B Pardiwala clubbed the plea with a suo motu PIL it has been hearing since March about various aspects related to coronavirus pandemic. The judges have been hearing the PIL and related matters from their residences through videoconferencing.

The AMA claims that it usually takes two to three days for the approval to come.

While hearing the plea, the bench asked the government why people were barred from getting tested when the ICMR had already recognised 12 laboratories to conduct COVID-19 tests in the state.

Replying on this, the state government informed the bench that doctors only need to send an email to the designated officer and permission is usually granted in two days.

India's coronavirus death toll overtakes that of China

worst-hit nation by the pandemic with 1,65,799 COVID-19 cases.

The country has registered 175 deaths and a record 7,466 fresh coronavirus infection cases in the last 24 hrs till Friday 8 am, according to the Union Health Ministry.

According to the John Hopkins University (JHU) data, India has now overtaken Turkey and is the ninth most affected nation in terms of COVID-19 cases after the US, Brazil, Russia, UK, Spain, Italy, France and Germany.

China has confirmed 84,106 cases and 4,638 deaths from COVID-19 so far, according to the JHU.

This is the first time that the single-day spike crossed the 7,000 mark, with the country reporting over 6,000 coronavirus infection cases per day since May 22.

The number of active COVID-19 cases in India stood at 89,987, while 71,105 people have recovered so far and one patient has migrated.

"Thus, around 42.89 per cent patients have recovered so far," a senior Health Ministry official said.

According to the Indian Council of Medical Research (ICMR) a total of 34,83,838 samples have been tested as on May 29 till 9 am and 1,21,702

According to the health ministry data updated in the morning, the highest number of confirmed cases in the country are from Maharashtra at 59,546 followed by Tamil Nadu at 19,372, Delhi at 16,281, Gujarat at 15,562, Rajasthan at 8,067, Madhya Pradesh at 7,453 and Uttar Pradesh at 7,170.

South Korea postpones school reopening due to new outbreak



SEOUL, 29 MAY [THE-**GUARDIAN**]: South Korea has postponed the planned reopening of more than 800 schools as it battles a renewed outbreak of the coronavirus, with cases now at their highest level for almost two months.

of lockdown measures has gone into reverse, with museums, parks and art galleries closed again on Friday for two weeks. Kindergarten pupils, and some primary and secondary school students were due back from Wednesday, in the last phase of school re-

700 samples await testing at NBMC, efforts on to clear backlog **SUMMIT REPORT**

GANGTOK, 29 MAY:

Secretary, Health Department, Dr Pemba T Bhutia, today said that results are awaited for around 700 samples sent from Sikkim to North Bengal Medical College, Siliguri. He added that efforts are meanwhile underway to build pressure on NBMC to clear the backlog.

The Sikkim samples awaiting clearance from NBMC were last sent on 23 May.

It may be recalled that NBMC had returned the around 90 samples sent by Sikkim on 27 May. These have been kept at STNM Hospital here and will be tested at the State's own viral lab once it gets operational.

Sikkim's own viral lab could become operational as early as Saturday, he informs.

Meanwhile, the primary focus moving forward, in light of the thousands of returning Sikkimese, will be on Trunat testing which is quicker and for which the State had recently increased its capacity.

'Make noise and don't panic': India tries to ward off locust invasion

NEW DELHI, 29 MAY [THE-**GUARDIAN]:** Residents of Delhi are bracing themselves for a possible invasion of locusts, which have been ravaging areas in the north of the country.

A change in wind direction could save the city, but Dr K L Gurjar, deputy director of the Locust Warning Organisation, has warned residents to be prepared to "make a lot of loud noise so that instead of settling, they keep flying and fly past the city. And don't panic".

Parts of India are experiencing the worst locust invasion the country has seen for 25 years. Skies above large parts of north India have darkened during the

day due to millions of locusts. Rajasthan is the worst affected state, but Madhya Pradesh, Gujarat and Punjab have also experienced damaging swarms.

The UN Food and Agriculture Organization's locust watch website said the movement of the locusts has been affected by the strong westerly winds from Cyclone Amphan, which hit the coast of India earlier this month.

About 50,000 hectares have been affected by the insects so far. While produce in some parts of the country had already been harvested, in other areas farmers have seen the insects devour their crops. Unless the locusts are controlled,

they fear summer crops could also be destroyed.

Tractors have been spraying

pesticides and fire engines have been used to target locusts in trees. Honking horns and sounding police car sirens other methods deployed to try to ward the locusts off. In the fields, farmers have been playing loud music and banging anything they can find to stop the insects ravaging their crops.

"We are hoping to contain it in the next 10 days," said an official in Barmer, in Rajasthan. "Our officials are out spraying pesticide early in the morning. When the sun comes out and [the locusts] get warm is when they start flying. This year, they are younger, immature adults who fly faster and cover distances of up to 150km per day."

On Monday, swarms were spotted in the city of Jaipur in Rajasthan.

Gurjar hopes the change in wind direction will spare Delhi.

Neighbouring Pakistan declared a nationwide emergency in February after swarms devastated parts of the country.

India's agriculture ministry is hoping to control the invasion before monsoon season hits north India at the end of June, when locusts mature and breed. If the infestation is not controlled, it may threaten summer crops such as rice, maize and sorghum.

India's first 'green' village adapts to life without tourists

ANNE PINTO-RODRIGUES NEW DELHI, 29 MAY [THE-**GUARDIAN**]: As he looks to the future, Kezhaseria Meyase, a 37-year-old resident of Khonoma, expresses confidence in the youth of the village. "They are well aware of the importance of conserving our forests and wildlife," he says.

For the first time since the creation of the Khonoma Nature Conservation and Tragopan Sanctuary (KNCTS) in 1998, tourism in Khonoma has come to a halt. In 2019, the remote 700-year-old village in the Indian state of Nagaland, near the Indo-Myanmar border, received more than 4,000 visitors. Nearly a fifth of the tourists were from overseas, drawn to Khonoma's rich biodiversity and conservation success (in 2005, it was named India's first "green village").

The 20 sq km (7.7 sq mile) sanctuary, consisting of dense subtropical and temperate broadleaf forests, is the first formally conserved community sanctuary in India. It is home to several vulnerable mammal species, including the clouded leopard, Asiatic black bear and hoolock gibbon; and villagers have recorded more than 300 avian species. Bird-Life International recognises the sanctuary as one of the 555 Important Bird Areas (IBAs) in India, and the Blyth's tragopan, a large pheasant which is the state bird of Nagaland, thrives in the higher reaches of KNCTS.

Khonoma, like the rest of the world, is coping with the economic fallout of the Covid-19 pandemic and the lockdown in India, which began on

25 March. Visitors stayed away during the peak birding season of March and April.

chairman of Meyase, KNCTS, says: "Yes, people from the village providing tourismrelated services have lost cash income due to the lockdown. But they are still able to sustain themselves by farming and rearing livestock."

He remains optimistic. "Soon after the lockdown is lifted, people from neighbouring villages and from within the state will start visiting."

Dismissing concerns about hunting in the sanctuary during the lockdown, Meyase adds: "As long as there is no free movement of people, the sanctuary is safe.

"Once the lockdown is lifted, the Khonoma Youth Organisation, which is responsible for monitoring the sanctuary, will continue their surveillance."

A steep fine of 20,000 rupees (£210) for any person caught hunting in KNCTS, as well as Khonoma's long history as a village of fierce warriors, serve as deterrents to any potential poachers, he adds.

Pulling together

Khonoma's residents belong to the Angami people, who have lived off the forest for centuries, with hunting being a sacred cultural practice. In the early 1990s, following the mass slaughter of Blyth's tragopans by villagers over the Christmas period, a few of Khonoma's conservationminded elders began campaigning for a protected area. They also recognised that conserving the forest, which is a rainwater catchment area,

would secure water for the village and for the rice terraces in the valley below.

Their sustained efforts bore fruit when the Khonoma village council passed a resolution for the creation of KNCTS in 1998. The hunting and logging ban was soon extended beyond the sanctuary, to include the entire village.

To ensure that the men wouldn't return to hunting, they were recruited as forest wardens for three years and paid a salary via a grant from the Gerald Durrell Memorial Fund. Women, who had traditionally foraged in the sanctuary for fruit and vegetables to sell, were banned from doing so.

Vitsokhono Pier, 35, who owns a plant nursery in Khonoma, says: "Women turned their attention to other income-generating activities like running a homestay or maintaining a nursery. Poinsettias are in big demand before Christmas."

The initial trickle of tourists to Khonoma led to the opening of the first homestay homes offering accommodation to paying guests - in 2006. There are 12 homestays in the village today and before the lockdown 20 people were employed as guides. Several more made handicrafts while others provided taxi services. The cash earned from tourism enables these families to buy groceries, pay for their children to go to school and meet other household expenses.

According to Tsilie Sakhrie, 77, one of the village elders instrumental in the formation of KNCTS, about 100 (out of 600) families in the village have benefited from the tourist trade.

But despite the lockdown and the loss of income from tourism, the village continues to have a high level of food security. Khonoma is known for its sustainable agriculture, and takes great pride in the fact that it has been self-sufficient since ancient times. Paddy terraces are positioned at the base of surrounding hills and the fields are irrigated by nutrientrich rainwater that flows down the slopes. More than 20 rice varieties are grown in the vil-

"In addition to rice, we also grow a variety of grains like millet, corn and Job's tears," says Kevikelie Pier, 52, a teacher at the local government school. "And our livestock can last us for at least a year."

Produce such as squash, pumpkin, carrot, cabbage, potato, mustard, ginger, garlic and king chilli are also grown in the village, in home gardens and rotating, shifting cultivation plots. Vegetables are also bartered with neighbours.

Following the creation of KNCTS, several villages in the state began to emulate Khonoma's conservation efforts. Village elder Khriekhoto Mor, 64, says: "Today, there are over 700 community-conserved areas (CCAs) in Nagaland, though only a handful are as actively conserved as Khonoma."

In November 2014, the Nagaland Community Conserved Areas Forum (NCCAF) was formed with 22 members to facilitate the exchange of ideas and strengthen the conservation movement in the state. Mor currently serves as chairperson of NCCAF.

Khonoma's conservation success did, however, create an unforeseen problem for its residents. With the increase in wildlife populations, animals began to venture out of the forest and destroy crops. Wild boar and porcupines would dig up vegetable patches while large flocks of birds such as munias and parakeets attacked grain crops.

Most of Khonoma's residents, who are subsistence farmers, were badly affected by this loss. To manage the situation, the KYO was empowered to issue a three-day hunting permit to a farmer requesting to get rid of a nuisance animal. The permit is strictly limited to the area of the farmer's land. Thirty such permits were issued in 2019, ensuring villagers remain on board with the conservation measures.

More than 20 years since the formation of KNCTS, it remains a safe haven for a multitude of rare species. Vitsokhono Pier, who has been visiting the village's forests since her childhood, says: "When I went into KNCTS the last monsoon, I was happy to hear the call of the Blyth's tragopan at several different places. I also saw the footprints of many animals in the mud."

Despite the pandemic, village leaders remain hopeful that future generations will continue to focus on conservation and sustainable development. "I'm sure our young people will do an even better job of protecting the sanctuary," says Meyase.

Most of these cases have been linked to a distribution centre in Bucheon. The warehouse is run by the country's biggest e-commerce firm Coupang. Health officials traced at least 82 infections to the facility, with the virus found on workers' shoes and clothes. They are now testing all employees and visitors.

In the Philippines, meanwhile, plans were unveiled on Friday to ease strict lockdown measures despite a record spike in new cases. The country reported 539 infections on Thursday, bringing its total to 15,588, with 921 deaths.

From Monday the capital, Manila, will allow gatherings of up to 10 people and free movement in and out of the city as long as travellers wear masks and keep their distance. Workplaces, shops and some public transport will reopen. Manila is home to 12 million people and is the centre of the nation's outbreak and efforts to battle the contagion.

"For me, this does not look bad," President Rodrigo Duterte said in a televised address. He described the country's mortality rate as low and called for a move to the "new normal". Health minister, Francisco Duque, said 90% of the country's Covid-19 cases were

Manila's lockdown will this weekend surpass the 76-day quarantine of Wuhan, the city in China where the first outbreak of the coronavirus was detected. Manila's restrictions have hit the livelihoods of millions of workers and there is pressure to ease damage to an economy that is facing its deepest contraction

Globally, deaths stand at nearly 360,000, with 5.8 million cases. Asia is struggling to cement early success in controlling outbreaks of coronavirus.

In India, Mumbai's hospitals are on the verge of collapse, with footage emerging of patients sharing beds and oxygen tanks. "The volume and density of our population in Mumbai makes it very difficult to see how we will get out of the other side of this peak," said Manish Shetty, a doctor on the Covid-19 ward in Guru Nanak hospital in Mumbai. "The magnitude of the cases is overwhelming us all."

Weeks earlier, footage emerged of patients being treated next to dead bodies, lying unclaimed by families fearful of infection.

Meanwhile in Sri Lanka, some lockdown rules will be rolled out again from Sunday after more than 250 returnees from Kuwait were found to be infected with coronavirus.

In Japan, a cluster response team has been sent to the south-western city of Kitakyushu, which has seen a sudden rise in cases after three weeks with no new infections. The city has clocked up 43 cases this week, bringing its total to 119. How more than a dozen of the latest infections came about remains unclear.

The mayor, Kenji Kitahashi, warned of a second virus wave and asked residents to refrain from nonessential outings. "If we leave this as it is, we will definitely be hit by a large second wave," he said.

Several Middle Eastern countries eased restrictions on Friday. In Saudi Arabia a three-day transition to relative normality got under way, with malls and waterfronts open and the Kingdom readying to allow up to 90,000 mosques to receive worshippers on Sunday for the first time in nearly two months.

In the United Arab Emirates, Dubai's beaches and parks reopened. The city's museums are expected to reopen their doors on Monday, as officials try to position the country as 'open for business' after the most crippling economic slowdown in the country's history.

Both the Emirates and Saudi Arabia have been among the regional states most affected by Covid-19, with the virus taking an unprecedented toll on state revenues and forcing seismic shake-ups in labour markets and other key sectors.

Balancing dwindling revenues and consumer confidence against a public health emergency has been particularly challenging for the UAE, one of the globe's main aviation hubs and an emerging tourist destination, the viability of which depends heavily on a pre-Covid interconnected world resuming on a similar scale.

Both countries have enforced social distancing and have imposed curfews throughout the crisis. Numbers have increased steadily throughout the pandemic, with more than 32,500 cases registered in the UAE and more than 80,000 in Saudi Arabia. Migrant workforces account for large numbers of cases in each state. The ratio of deaths to contractions in each state is lower than the global average, at less than one per cent.

It has risen to 2,533 in Karnataka, 2,256 in Telangana, 2,158 in Punjab, 2,036 in Jammu and Kashmir and 1,660 in Odisha.

Haryana has reported 1,504 coronavirus infection cases so far, while Kerala has 1,088 cases. A total of 856 people have been infected with the virus in Assam and 469 in Jharkhand.

Uttarakhand has registered 500 cases, Chhattisgarh has 399, Chandigarh has reported 288 cases, Himachal Pradesh has 276, Tripura has 242, Ladakh has 73 and Goa has 69 cases so far.

Manipur has reported 55 COVID-19 cases, Puducherry has 51 instances of infection while Andaman and Nicobar Islands has registered 33 infections.

Amit Shah briefs PM on CMs views on lockdown

New Delhi, May 29 (PTI): Union Home Minister Amit Shah on Friday met Prime Minister Narendra Modi and informed him about the views of all chief ministers on the extension of the ongoing nationwide lockdown beyond May 31, officials

During the meeting, Shah briefed Modi about the suggestions and the feedback he received from the chief ministers during his telephonic conversations on Thursday, a government official said.

The nationwide curbs were first announced by Prime Minister Narendra Modi on March 24 for 21 days in a bid to contain the spread of novel coronavirus. It was first extended till May 3 and then again till May 17. The lockdown was further extended till May 31. The home minister's telephonic conversations with the chief ministers came just three days before the end of the fourth

phase of the lockdown.

During his talks with the chief ministers, Shah sought to know the areas of concern of the states and the sectors they want to open up further from June 1, the official said.

Interestingly, till now, it was Modi who had interacted with all chief ministers through video conference before extension of each phase of the coronavirus-induced lockdown and sought their views.

This was for the first time that the home minister spoke to the chief ministers individually before the end of another phase of the lockdown.

Shah was present in all the conferences of chief ministers along with the prime minister.

It is understood that majority of the chief ministers wanted the lockdown to continue in some form but also favoured opening up of the economic activities and gradual return of the normal life, another official said.

The central government is expected to announce its decision on the lockdown within the next two days.

The number of CO-VID-19 cases in India has climbed to 1,65,799 on Friday, making it the world's ninth worst-hit country by the coronavirus pandemic.

The Health Ministry said the death toll due to COVID-19 rose to 4,706 in the country.

While extending the fourth phase of the lockdown till May 31, the central government had announced continuation of prohibition on opening of schools, colleges and malls but allowed opening of shops and

markets. It said hotels, restaurants, cinema halls, malls, swimming pools, gyms will remain shut even as all social, political, religious functions, and places of worship will remain closed till May 31.

The government, however, allowed limited operations of train and domestic flights. The Indian Railways is also running special trains since May 1 for transportation of migrant workers from different parts of the country to their native states.

HC asks Delhi govt to file detailed reply on pleas challenging levy of 70% 'special corona fees'

NEW DELHI, MAY 29 (PTI): The via a viz sale/ dealing in liquor Delhi High Court Friday asked the Delhi government to file a detailed affidavit on a batch of pleas challenging the decision to levy 70 per cent 'special corona fees' on the MRP of liquor of all brands in the national capital.

The Delhi government had earlier filed its response to the petitions, saving that trade or consumption of liquor is not a fundamental right of a citizen and the State has the authority to regulate its sale and levying 70 per cent 'special corona fees' on MRP of all alcohol brands is a price for grant of such privilege to public.

A bench of Chief Justice D N Patel and Justice Sangita Dhingra Seghal, conducting the hearing through video conferencing, heard part arguments and asked the government to file another detailed affidavit and listed the matter for further hearing on June 19.

The Delhi government, in its earlier affidavit, has opposed the petitions which have challenged a May 4 notification levying a 'special corona fees' on liquor in the national capital and said there is an element of privilege and the State is free to regulate it under the excise law.

A citizen, therefore, has no fundamental right to do trade or business in liquor or for that matter also to consume liquor. On the other hand, the State has the authority and jurisdiction to regulate (including prohibit totally or partially) such trade and commerce as well as to regulate the sale, purchase and consumption of liquor, it said.

Besides Delhi, 10 other states, Assam, Meghalaya, Karnataka, Andhra Pradesh, Telangana, Uttar Pradesh, Haryana, Rajasthan, Tamil Nadu and West Bengal have imposed similar fees, the government argued.

The affidavit said owing to the clamp down on all economic activities due to the coronavirus (COVID-19)lockdown, the revenue of Delhi government (which primarily comes from VAT/GST collection, state excise and stamp duty) has shrunk by almost 90 per cent in April 2020 and the total collections dwindled to a mere Rs 300 crore as opposed to approximately Rs 4,000 crore in the corresponding month in 2019. Repairs Alone Will Not Do

For the long run, roads here need customized solutions

The pre-monsoons, even though the drizzles have been sustained, has been relatively weak thus far. Its lashings have been varying in intensity over various parts of Sikkim and the region. And yet, even this subdued season of downpours, has been strong enough to convert culverts into raging rapids and jhoras into torrents bringing down boulders, washing away alignments, sweeping aside retaining walls, pouring down at least one landslip of enormous volume and catching the concerned agencies wrong-footed yet again.

The monsoon remains moody, but its impact on daily life in Sikkim remains consistent in its ability to impose disruptions. The fragility of Sikkim's mountains contribute to the instability of the roads and the precariousness of the houses here, but the most substantial role in the annual ritual of blocked drains and roads is played by the continuing prioritizing of repairs over solutions and the triumph of ignorance over science. Deploying work gangs to clear drains, bull-dozers to clear away debris and investing tonnes of stones and crores of rupees in erecting retaining walls are at best, short-term measures providing immediate relief. Unfortunately, these have been the only engineering skills applied to the annual assault of slush and debris that roads here come under. Much more refined science should have been applied to fortify Sikkim's roads by now. The level of preparedness should have evolved into a multidisciplinary exercise by now. The problem is obviously not only in the intensity of the monsoons or the vehicular stress on the roads. Worsening the situation is the degradation of the catchment areas, the weakening of the jhoras [through quarrying and encroachments, for example], the obvious seismic activity [which, it appears, no one bothers to keep track of or share information about anymore], and, of course, the still only sketchily understood reasons behind load limits for different roads.

Those responsible for the care of roads have to realize that roads can be tended properly only if all these aspects are factored in and the reasons behind at least the traditional trouble-spots understood better. Solutions will have to then be devised through interventions from all fields and disciplines and not just by throwing more stones and more crores into repairs. Even the technology deployed for repairs appears to be as archaic, if not even older, than the vintage of the roads themselves.

The alternate highway supposedly sanctioned for Sikkim will be helpful, but remains still an assurance, and one must still bear in mind that even this alternative will snake through the same hills, and will be managed by the same agencies, ergo, will be beset by the same problems and limitations. Repairs are necessary, but for the long run, customized solutions are required.

Donald Trump's attacks on social media threaten the free speech rights of all Americans

iven that US president Donald Trump appears Uto use Twitter almost instinctively, his recent attacks on the platform may seem counterintuitive.

But his feud with Twitter is another example of the ways in which the president has routinely distorted the principles of the First Amendment in order to undermine the very freedoms he claims to be championing – as well as American democracy more broadly.

On May 26, Trump tweeted that – contrary to all available evidence - mail-in voting is plagued by rampant voter fraud. Twitter placed a factcheck label on the tweet linking to information demonstrating the falsity of Trump's claims.

In response, Trump attacked Twitter, accusing it of stifling "free speech" and threatened to take measures to strongly regulate social medial platforms or to potentially close them down entirely.

On May 28, Trump signed an executive order purportedly directed at preventing online censorship, which proposes sweeping changes to protections afforded to social media platforms under US law.

These abuses must be recognised and challenged. Trump is making a concerted effort to disseminate false information regarding the integrity of America's electoral process with the goal of eroding the public's confidence in election results and making it more difficult for Americans to vote in the 2020 election. It is a direct attack on American democracy.

The First Amendment's protections, commonly referred to as "free speech" rights, do not apply to restrictions on speech imposed by non-government actors. As a result, the president cannot legitimately claim that social media platforms are violating his – or anyone else's – free speech rights. Put simply, there is no First Amendment right to use social media.

Moreover, the Supreme Court expressly recognises that corporations and other private entities have their own free speech rights, and that the First Amendment prohibits the government from interfering in the editorial judgements of private

speakers – including business entities – on issues of public concern. In other words, the government may not tell a private speaker what to include or not include in speech about such issues.

So when the president endeavours to interfere with the content of social media platforms via government regulation, he is endangering free speech, not protecting it.

CHANGING THE RULES

The main target of the order is the Communications Decency Act (CDA), which established a comprehensive immunity for digital intermediaries for civil liability resulting from the content of thirdparty users. This means, for example, that Twitter may not be held liable for defamatory comments made on its platform by third parties.

If the CDA was repealed by Congress, this would mean that intermediaries such as social media sites would be treated as traditional publishers like newspapers, magazines and television stations. All of these entities can be held liable for publishing or distributing obscene or defamatory material written or prepared by others and all are free to publish criticism of the president and factcheck his claims.

There is no obligation under the First Amendment for publishers to be neutral on matters of public concern. Indeed, this would be antithetical to US free speech principles. Additionally, the Supreme Court has made it clear that the government has no right to interfere with the "open marketplace" of ideas and no interest in "equalizing" the relative ability of individuals and groups to influence the outcome of elections.

The American Civil Liberties Union warns that the order represents a direct threat to platforms that they will be punished if they engage in speech that displeases the president, and correctly points out that the president "has it backwards: the First Amendment protects us from the government, not the government from us".

The director of the Program on Platform Regulation at Stanford's Cyber Policy Center, Daphne Keller, describes the order as "95% political theatre - rhetoric without legal foundation, and with-

out legal impact". The order should be called out for what it is – a blatant attempt by the president to bully and intimidate platforms in an effort to improperly manipulate public discourse.

It appears that, for the moment, Twitter is refusing to be bullied by the president. On May 29, Twitter hid one of Trump's tweets regarding unrest in Minneapolis following the killing of George Floyd.In line with the company's rules, administrators attached a warning that the tweet "glorifies violence".

Anyone wishing to view the tweet can do so, but only after clicking through the warning.

FREE SPEECH? OR AUTHORITARIAN RULE

Trump's attacks on social media platforms and the press reveal his true intention - which is not to protect the free speech rights of Americans. Instead his strategy appears to be aimed at stifling any and all expression that endeavours to hold him and his administration to account. His use of social media to attack the press as "evil" and the "enemy of the people" - and to malign anyone who criticises him - are blatant attempts to insulate himself from any form of accountability.

Such behaviour is anti-democratic and undermines fundamental First Amendment principles, including that the press serves as an important restraint on government and that public discourse must remain free and open to prevent the government from controlling the search for "political truth".

Trump wants free rein to lie to the American people regarding vital matters of public concern without any restraints whatsoever, including factchecking. In so doing, he is effectively behaving like an authoritarian, attempting to control and manipulate public discourse without criticism or accountability.

The president's efforts to undermine free speech and to misinform the American public represent a serious threat to American democracy that should not be lost in the cacophony of contemporary political discourse in the US. While alarm bells are ringing, we should all be concerned that with so much noise, not enough people will hear them.

Is it safe for children to return to school?

In England, the phased reopening of **■** schools is due to begin on June 1. But a recent poll of parents has revealed that around half are unconvinced that their children are safe to return.

Fortunately, there is an increasing body of evidence that we can consider. In light of the widespread concern, we've reviewed the risks posed to children by COVID-19 and answered the most pressing questions.

ARE CHILDREN LESS LIKELY TO **CATCH CORONAVIRUS?**

To answer this, we can look at two important sources. The first is data from widespread community testing. In Iceland, 6% of the population was screened early on in the pandemic (22,279 people). In the targeted testing group (which tested people either with symptoms, from high-risk areas or who had come into contact with someone with COVID-19), 6.7% of children under 10 tested positive, compared with 13.7% of people aged 10 or over. In the random population screening group, all under-10s tested negative, while 0.8% of persons 10 years or older tested positive.

And, in the municipality of Vo' in northern Italy, 86% of the population (2,812 people) were tested after a resident died early on in the epidemic. All 217 children aged 10 or under tested negative. Out of the 250 young people aged 11-20 who were screened, 1.2% were positive, compared with 3% for those 21 years and

The second useful source is detailed track-and-trace data linked to demographic information. A Chinese study analysed whether 105 COV-ID-19 patients transmitted the virus to their 392 household contacts. It revealed the risk of a child acquiring the virus from a positive household

STÉPHANE PAULUS & ELSE BIJKER member was only 4%, compared potheses have been raised. with 17.1% for adults. Similarly, contact tracing data from Hunan province in February showed that 6.2% of children aged 0-14 who had been in contact with a COVID-19 patient caught the virus, compared with 10.4% of older people.

> Thus, accumulating evidence from various places indicates that children are significantly less susceptible to infection than adults.

> DO CHILDREN FALL ILL IF IN-FECTED?

> Young infants are generally more susceptible to picking up infections and falling ill. But for COVID-19 the evidence suggests it's the other way around. Public Health England data up to May 22 showed that only 1.6% of all COVID-19 cases had been in children (aged 0-19), despite them making up 23.4% of the population.

> Of course, this data is influenced by many factors, including testing strategy. For example, very young children may not be tested in the community, while testing in hospitals is likely to include more seriously ill patients, who tend to be adults. But reports from other countries consistently show low numbers of cases among children, with milder disease compared to adults.

> Data from China and the USA and a review of studies published up to May 1 show that the illness in children is either asymptomatic, mild or moderate in 88-97% of cases. Only about 0.6-2% of children are admitted to intensive care and 0-0.18% of cases are associated with a fatal out-

> This compares with a case fatality rate of 3.5-3.6% for those in their 60s, 8.0-12.8% for those in their 70s and 14.8-20.2% for those 80 or over, as reported in Chinese and Italian cohorts. Why children are less affected remains unclear, although several hy-

(called the paediatric inflammatory multisystem syndrome temporally associated with SARS-CoV-2 infection, or PIMS-TS) has gained increasing attention recently. This condition remains rare, with about 230 suspected cases across Europe and two fatalities reported. A British Paediatric Surveillance Unit study is underway to gain further insight into the condition.

DO CHILDREN TRANSMIT CORO-NAVIRUS TO OTHERS?

It is difficult to formally quantify the extent to which children contribute to transmission of the coronavirus. There is, however, increasing circumstantial evidence suggesting that their contribution is limited and that children are far from being the "super-spreaders" that they can be with seasonal flu.

An analysis of 31 household transmission clusters found that in only three was the index case a child. And a systematic review on children and coronavirus transmission found that, although able to transmit it like any other individual, children seem much less likely to do so.

In the Netherlands, the tracing of more than 700 contacts of patients with COVID-19 has shown different infection rates depending on the patient's age. For patients aged 18 and under, none of their contacts tested positive. In patients 19 years or older, however, 9% of their contacts were positive.

IS IT SAFE FOR SCHOOLS TO RE-

OPEN? Denmark was the first country to reopen schools in Europe, and others such as Norway, Germany, France and the Netherlands have followed. In Denmark, the virus's reproduction number rose from 0.6 to 1.0 after opening schools, but came down

again within a week. As of May 12 A novel syndrome in children there were no reports of outbreaks in Swedish schools, which have remained open during the pandemic.

> In New South Wales in Australia, schools have remained open. Analysis of 18 cases that occurred in 15 schools showed that, out of 735 children who had close contact, only two (0.3%) were infected. None of the 128 staff who had close contact were infected.

> The available evidence would suggest that the risks posed by children returning to school is small. The potential for transmission of coronavirus within schools can be reduced by adequate infection control measures, such as pupils physically distancing from staff whenever possible, frequent handwashing, and prompt testing and isolation of individuals with possible COVID-19 symptoms. Additional measures such as children remaining within a small peer group ("social bubble") and increasing the time spent outdoors should also be considered.

> School plays a critical role in the wellbeing of children. It is not only a place to learn, but to socialise and exercise, and for some children to simply be safe. While some schools provide effective online learning, this is far from universal, and children from more disadvantaged backgrounds are increasingly deprived of crucial education by school closures.

> We therefore conclude, like other colleagues have also recently done, that a progressive return of children back to school, supported by adequate preventive measures and an effective test, track and isolate strategy, is now advisable.



Mathews' absence in 2011 WC final hurt us: Sangakkara



KOLKATA, MAY 29 (PTI): Former skipper Kumar Sangakkara believes missing Angelo Mathews due to an injury hurt Sri Lanka badly in the summit clash of the 2011 World Cup, which hosts India won after a gap of 28 years.

Having played a key role in their thrilling semifinal win against New Zealand, Mathews was forced out of the final against India at Mumbai's Wankhede Stadium by a quadriceps muscle

Reflecting on the sixwicket loss to India, the former Sri Lankan captain said Mathews' injury forced him to opt for a 6-5 combination and was also the reason behind his decision to bat first after winning the toss.

Police want any match where Liverpool can win title played at neutral venue



LONDON, 29 MAY [AP]: Police have set out the Premier League matches they would like to be played at neutral venues, which would include any Liverpool game where the title could be won.

The matches which have been requested to take place at neutral grounds are Manchester City v Liverpool, Manchester City v Newcastle, Manchester United v Sheffield United, Newcastle v Liverpool and Everton v Liverpool. The police statement adds that "the game in which Liverpool could secure the league title" should also be moved but this may end up needing to be more than one match if the Jürgen Klopp's side do not clinch it at the first attempt.

Deputy chief constable Mark Roberts of South Yorkshire Police, the UK's football policing lead, said in a statement: "Our discussions with the Premier League throughout this process have been positive, with a shared focus on the priority of public health. As such we have reached a consensus that balances the needs of football, while also minimising the demand on policing.

"The majority of remaining matches will be played at home and away as scheduled, with a small number of fixtures taking place at neutral venues, which, contrary to some reports, have yet to be agreed. The views and agreement of forces which host Premier League clubs have been sought and where there were concerns, the Premier League has been supportive in providing flexibility in arranging alternative venues where requested. "This plan will be kept continually under review to ensure public health and safety and a key part of this is for supporters to continue to respect the social-distancing guidelines and not to attend or gather outside

Test is best for England fast bowler Wood

LONDON, MAY 29 (AFP): World Cup-winning fast bowler Mark Wood would opt for a place in England's Test side if a congested schedule means they have to field entirely separate squads this season following the coronavirus outbreak.

An expanded training group of up to 45 players is due to be named on Friday, with the 18 bowlers already invited back for individual sessions soon to be joined by batsmen and wicketkeepers.

Despite the pandemic delaying the start of their home season, the England and Wales Cricket Board (ECB) still plans to stage a full international programme that includes three-Test series against West Indies and Pakistan as well as limitedovers internationals against Australia and Ireland.

The ECB previously said its "worst-case" scenario, with no cricket played, could mean a 380 million pound (469 million) hole in its finances. But with several months of the season wiped out, England may still need to field separate red and white-ball squads in order for players to have sufficient time for training and recovery.

Wood was a member of the England side that won last year's World Cup but the Durham quick would still rather play Test cricket. The 30-year-old's career has been blighted by ankle injuries, meaning he has played just 15 Tests since a 2015 debut against New Zealand at Lord's. But the last of those, against South Africa at Johannesburg in January saw him return Test-best match figures of nine for 100 and Wood is keen to carry on from where he left off at the Wanderers ground.

Germany rallied to save women's football - the FA should be embarrassed

LONDON, 29 MAY [THEGUARDIAN]: On Monday the Women's Super League and Championship seasons were ended by the Football Association after weeks of waiting for what had become an inevitable announcement.

While women's football in England has become the latest sporting casualty of Covid-19, elsewhere the situation is being used to help fuel the growth of the game. On Wednesday details of a one-month 25-game Challenge Cup tournament in the US were unveiled, scheduling women's football as the first sport to return in the country. And on Friday the Frauen Bundesliga resumes with the league leaders, Wolfsburg, playing struggling

Some will deem the restart of Germany's top women's league too great a risk. Not just from a public health point of view, but a personal one, too. A rapid turnaround means teams will have had only one week of full training before playing competitive games. That, it is felt, is not enough time. According to the AI data analytics company Zone7, eight players picking up injuries in the opening six men's Bundesliga games was no accident. Men's teams had only nine days to switch from individual training to high-intensity group work.

Even when international tournaments cut into pre-season, clubs will more often than not find 30 days to prepare their squads. When Zone7 looked at the effect changes in preseason length may have on injury risks within teams, 75% of those that had two years of data available demonstrated higher injury rates in the first half of the season when the preparation period was shorter.

Regardless of whether they should be playing competitively now, or with more time to ease players back in, the Frauen Bundesliga's return alongside the men should be welcomed. It is also extremely embarrassing for the Football Association.

Many point to the cultural difference and the 51% ownership

model in Germany that keeps sporting hearts and interests above economic forces. But the return of women's football and its growth is in the economic interests of clubs and leagues long term.

Additionally, just because the English game has decayed to a point where profit rules and all football outside the Premier League – men's and women's – is pushed aside, sacrificed supposedly for its own benefit but ultimately to protect short-term profits, does not mean we should accept it. The Bundesliga is not a social-

ist paradise - clubs there have been hit financially amid this crisis, too. The Deutsche Fussbal Liga, which runs Germany's leagues,y was said to be facing a €770m (£691m) loss should this season not be seen out. Clubs will lose €91m (£81m) in match-day revenue with games played behind closed doors – in the 2018-19 that accounted for 12.9% of their total income. Werder Bremen have been forced into taking out a loan from a state-owned bank, and last month, Kicker magazine reported 13 of the 36 top clubs faced insolvency. Yet when discussing recovery, clubs dug deep.

Bayern Munich, Borussia Dortmund, RB Leipzig and Bayer Leverkusen all contributed €7.5m (£6.93m) while also giving up €12.5m (£11.2m) in TV rights payments to help build a €20m solidarity fund for the whole of German professional football, benefitting men's Bundesliga 3 clubs and those in Frauen Bundesliga (clubs with parent teams in the men's Bundesliga and mBundesliga 2 waived their shares). The DFB, German football's governing body, unanimously agreed that the pot should be used to cover testing and its additional costs and lost income.

"We can only overcome this crisis together, when we act as one, because there is only one football," the DFB president, Fritz Keller, said in a statement. "The Bundesliga clubs exemplify this cohesion in a brilliant manner with their financial support. It shows that we are fighting together for the good

of our football and that we won't give up on any club."

In England, the question put to professional football outside the Premier League is: can you afford to resume? The answer in the case of the Women's Super League and Women's Championship was no. There is no solidarity fund to assist with losses, let alone to cover the costs of restarting. The notion that you should help clubs equitably rather than equally, by financially assisting struggling clubs and not those with wealthy parent operations, on the assumption that it is good for the long-term health of the game, is seen as idealistic.

English football is crippledby conservatism, in sharp contrast to Germany, which has shown it values football beyond the elite, and

the women's game in particular. In the US, with the new commissioner, Lisa Baird, at the helm, the NWSL could cover the costs of running the Challenge Cup in Utah through sponsorship and TV deals. P&G and Secret are sponsoring the event; CBS All Access will show the games, and they will all be made available worldwide via Twitch. The semi-finals and final are also sponsored by Budweiser, and the league has a new multi-year partnership with Verizon.

By working with the Utah Royals owner, Dell Loy Hansen, who furloughed staff when the crisis hit, the NWSL is hosting the tournament in a state with a low Covid-19 count and Hansen is assisting with providing teams with accommodation, training facilities and competition needs. Even, according to Equalizer Soccer, allowing clubs to borrow planes to travel to the tournament.

The NWSL players' association has worked hard to have players' concerns made central to planning, with contracts to be honoured even if players choose not to take part. Mothers will also be able to bring their children to games.

In Germany and the US, governing bodies are showing that if you are bold women's football does not have to be a casualty of this crisis. Instead, it can be a pioneer.

Fans allowed to attend Russian football matches next month

Moscow, May 29 (AFP): Russian authorities said that a small number of spectators would be allowed at stadiums when the country's Premier League restarts its suspended season next

In mid-May, Russia's football association said that the country's Premier League would restart its suspended season from June 21 behind closed doors.

But on Thursday, the association said it had agreed on a compromise with the state consumer health watchdog, adding spectators will be initially allowed to occupy 10 percent of stadiums' seats.

"This is a safe number

of fans if all safety mea-

sures are observed," the association said, quoted by the country's official anti-coronavirus portal. Deputy Prime Minister Dmitry Chernyshenko said fan support

was important for players, calling it "a special emotional component of football."

Due to the coronavirus outbreak football matches have been suspended in Russia since March 17.

The Russian Premier League, the country's top football division, has eight rounds of matches remaining in the season.

Russia has the world's third largest number of confirmed cases at 379,051, behind the United States and Brazil.

On Tuesday, President Vladimir Putin said, citing experts, that the country had passed its peak of coronavirus infections.

Ricciardo 'in Ferrari talks' before McLaren switch



PARIS, MAY 29 (AFP): Daniel Ricciardo said he had been talking to Ferrari about a dream drive with Formula One's most famous team before penning a deal to switch to McLaren in 2021.

The 30-year-old Australian will instead leave Renault for McLaren from where Carlos Sainz has been signed to replace four-time world champion Sebastian Vettel who will leave Ferrari at the end of this season.

"There have been discussions already from a few years back. And that continued all the way through to now," Ricciardo told CNN of his talks with the Italian team.

"So yeah, I won't deny that. But obviously it's never really come to fruition."

He added: "I see how Carlos is a fit for the team. So I don't really look at it like 'why not me?' I just look at it: Yeah, Carlos had a very strong 2019. Yeah, he's a bit of hot property right now, and I guess it's a good fit for where they are at."

Ricciardo only joined Renault for the start of last season after five seasons with Red Bull.

However, it was a miserable campaign for the Australian who failed to secure a single podium.

He ended the championship down in ninth place, his worst finish since his Toro Rosso days in 2013.

Renault finished fifth in the constructors' championship, 54 points behind McLaren.

UN urges \$2.4 billion to help Yemen cope with war and virus

UNITED NATIONS, MAY 29 (AP): The U.N. humanitarian chief urgently appealed for 2.4 billion to help millions of people in Yemen cope with the conflict and COVID-19, saying programs are already being cut and the situation is alarming.

Mark Lowcock told a UN briefing on Thursday that the United Nations received 3.2 billion last year for Yemen because countries in the region including Saudi Arabia and the United Arab Emirates who are involved in the conflict stepped up.

This year, the U.N. has appealed for about 3.4 billion but as of Wednesday it had only received 516.6 million, just over 15%. The Saudis pledged 525 million in early April and Lowcock said he hopes it will quickly be turned into cash.

The United Nations and Saudi Arabia are cohosting a video pledging conference for Yemen on Tuesday and Lowcock said he has been on the phone with Persian Gulf leaders in recent days but doesn't know what they're going to do. The collapse in oil prices because of the pandemic may be spurring internal discussions, he said.

Lowcock said he expects high-level representation at the conference, and asked: Is the world ready simply to watch Yemen fall off the cliff? Yemen's conflict started with Houthi Shiite rebels backed by Iran capturing the capital, Sanaa, in 2014.

The following year, a Saudi-led coalition backing the government intervened to battle the rebels and curb Iran's influence in what has turned into a stalemated regional proxy war. Since then, more than 100,000 people fighters and civilians have been killed.

Lowcock and the heads of 10 other U.N. agencies and several U.N. officials and humanitarian organizations issued a joint statement Thursday saying COVID-19 is spreading rapidly across the country already experiencing the world's largest humanitarian cri-

Tragically, we do not have enough money to continue this work, they said. Of 41 major U.N. programs in Yemen, more than 30 will close in the next few weeks if we cannot secure additional funds. This means many more people will die, they warned.

The 17 signatories said they have the skills, staff and capacity to meet the difficult challenges of delivering aid in Yemen but no money and time is running out.

Muhannad Hadi, the World Food Program's regional director for the Middle East and North Africa, told the video briefing that the U.N. agency needs about 200 million a month to provide assistance to 12 million Yemenis. But unfortunately, they've had to start cutting back to try to stretch their money and the food they have in the country, he said.

Flames engulf US police station as black rights unrest spreads

Flames ripped through a Minnesota police station and seven protesters were shot in Kentucky as unrest spread across the United States over the deaths of black people during police encounters.

Officers abandoned the building in the city of Minneapolis late on Thursday before demonstrators barged through barriers, breaking windows and chanting slogans. A fire broke out, which soon became an inferno that engulfed the struc-

The protests entered their fourth day on Friday and have spread beyond Minnesota, with protests breaking out in several states across the country, including Denver, Colorado and Phoenix.

In Kentucky, seven people were hit by gunfire at a protest on Thursday over the death of Breonna Taylor -- a black woman who was shot after police entered her home in March, local media reported.

One of those wounded was in a critical condition, according to the Louisville Metro Police Department. It is not yet clear who fired the shots.

Police responded with a Twitter post asking the city to "please choose peace," alongside a video message from a family member of the woman killed. She asked those in the streets to "go home and be safe and be ready to keep fighting."

Thousands joined the protests in Minnesota, which were triggered by the Monday death of 46-year-old George Floyd after being arrested on suspicion of using a counterfeit banknote. A video taken by a by-



stander shows an officer kneeling on his neck as he is pinned to the ground. At one point Floyd is heard saying he cannot breathe.

As unrest spread, President Trump tweeted: "These THUGS are dishonouring the memory of George Flovd and I won't let that happen," in apparent reference to protesters in Minnesota, adding the state's governor has the backing of the military.

"Any difficulty and we will assume control but, when the looting starts, the shooting starts."

Twitter flagged the tweet for vio-

lating its rules on glorifying violence a few hours after it appeared.

Minnesota's governor Tim Walz earlier called up 500 of the state's National Guard, but after Trump tweeted he defended his decision not to put them on the streets as fire gripped the police station. "Bricks and mortar are not as important as life," Minneapolis mayor Jacob Frey said at a press conference, adding that officers had been deployed in the city to prevent looting.

He added that the "anger and frustration" on the streets must be

understood, but that the looting was unacceptable.

"Our communities cannot and will not tolerate it. These are businesses, these are community institutions that we need," Frey said.

The City of Minneapolis called for people in the third precinct -where the police building is located -- to leave for their own safety, saying "explosive materials" could be inside and gas lines to the area had been cut.

Outbreaks of violence have gripped the city as tensions rose

On Wednesday, demonstrators clashed with law enforcement, looted stores and set fire to shops and a construction site. They were met with police tear gas and rubber bullets.

One person died of a gunshot wound, and police were reportedly investigating whether he was shot by a store owner.

- 'I have not slept' -

The Justice Department on Thursday promised to carry out a "robust" investigation into Floyd's death, saying they will make the case a top priority.

Democrats have also called for a probe into the deaths of two other black people -- Ahmaud Arbery, who was shot by two white men in the city of Brunswick in Georgia, and Breonna Taylor.

Floyd's family has demanded the officers present when he died face murder charges. All of them have been fired.


"You know, I want an arrest for all four of those officers tonight. A murder conviction for all four of those officers. I want the death penalty," Floyd's brother, Philonise Floyd, told

Two African American leaders of national stature, Jesse Jackson and Al Sharpton, arrived in Minneapolis Thursday and urged more protests.

"We told the governor you must call murder a murder," Jackson told an audience at the Greater Friendship Missionary Baptist Church.

Australian court rules queen's letters can be made public



Canberra. May (AP): Australia's highest court ruled on Friday to make public letters between Queen Elizabeth II and her representative that would reveal what knowledge she had, if any, of the dismissal of an Australian government in 1975.

The High Court's majority decision in historian Jenny Hocking's appeal overturned lower court rulings that more than 200 letters between the monarch of Britain and Australia and Governor-General Sir John Kerr before he dismissed Prime Minister Gough Whitlam's government were personal and might never be made public.

The only-ever dismissal of an elected Australian government on the authority of a British monarch created a crisis that spurred many to call for Australia to sever its constitutional ties with Britain and create a republic with an Australian president.

Kerr dismissed Whitlam's government and replaced him with opposition leader Malcolm Fraser as prime minister to resolve a month-old deadlock in Parliament. Fraser's coalition won an election weeks later.

The National Archives of Australia had held the correspondence. known as the Palace Letters, since 1978. As state records they should have been made public 31 years after they were created.

Under an agreement struck between Buckingham Palace and Government House, the governor-general's residence, months before Kerr resigned in 1978, the letters covering three tumultuous years of Australian politics were to remain secret until 2027. The private secretaries of both the sovereign and governor-general in 2027 still could veto their release indefinitely under that agreement.

A Federal Court judge accepted the archives' argument that the letters were personal and confidential.

An appeals court upheld that ruling in a 2-1

The archives' lawyers argued the records were created with the strong conception that their character was private, and they were received by the archives under those conditions.

convention The British across Commonwealth nations is that communications between the queen and her representatives are personal, private and not accessible by the executive government, they argued.

The archives did not immediately respond to a request for comment on Friday.

Hocking, a Monash University academic and Whitlam biographer, was to hold a news conference later on Friday in Melbourne.

Buckingham Palace and Government House have previously declined The Associated Press' requests for comment on the case.

Hocking has been fighting to access the letters since 2016.

Police across US speak out against Minneapolis custody

Los Angeles, May 29 (AP): Murder. Brutality. Reprehensible. Indefensible.

Police nationwide, in unequivocal and unprecedented language, have condemned the actions of Minneapolis police in the custody death of a handcuffed black man who cried for help as an officer knelt on his neck, pinning him to the pavement for at least eight minutes.

But some civil rights advocates say their denunciations are empty words without meaningful reform behind them.

Authorities George Floyd was detained Monday because he matched the description of someone who tried to pay with a counterfeit bill at a convenience store, and the 46-year-old resisted arrest. A bystander's dis-

Typically, police call for patience and calm in the wake of a use of force. They are reluctant to weigh in on episodes involving another agency, often citing ongoing investigations or due process.

China reports five asymptomatic COVID-19 cases

BEIJING, MAY 29 (PTI): China has reported five new asymptomatic CO-VID-19 cases, taking the total number of such infections to 409, while no new confirmed case was recorded in the country, health officials said on Friday. No new suspected cases or deaths related to the disease were reported on Thursday, the National Health Commis-

Five new asymptomatic cases were reported in the country on Thursday, it said. The 409 asymptomatic cases, including 337 in the coronavirus first epicentre Wuhan, were still under medical observation.

Asymptomatic cases pose a problem as the patients test positive for the COVID-19 but develop no symptoms such as fever, cough or sore throat. However, they pose a risk of spreading the disease to others.

As of Thursday, China has a total of 82,995 confirmed COVID-19 cases and the death toll remained at 4,634, the NHC said.

CNN's Omar Jimenez Arrested on Live TV While Covering Minneapolis Protests

"A black reporter from CNN was arrested while legally covering the protests in Minneapolis. A white reporter also on the ground was not," the news network

CNN reporter Omar Jimenez and his crew were on Friday arrested on live TV

while covering protests in Minneapolis. The arrests came amid contin-

ued protests in Minnesota - and other parts of the country - following the death of George Floyd, a black man, in police custody.

Jimenez "has been taken into police custody during a live broadcast at the site of the protests in Minneapolis, after clearly identifying himself to officers," CNN said on its website. "Jimenez's crew, including a producer and a camera operator, were also placed in handcuffs."

In a tweet, the news network, owned by AT&T's WarnerMedia, highlighted: "A black reporter from CNN

was arrested while legally covering the protests in Minneapolis. A white reporter also on the ground was not."

In an online post, the network added: "CNN's Josh Campell, who also was in the area but not standing with the onair crew, said he, too, was approached by police, but was allowed to remain." The post quotes Campbell as saying: "I identified myself ... they said, 'OK, you're permitted to be in the area.' I was treated much differently than [Jimenez] was."

In a CNN video of the arrest, the reporter is seen reporting about another arrest on the scene, saying: "We have got one person being arrested here," before telling his colleagues in the studio:

"We are speaking with state patrol now. Give us a second, guys." Jimenez then addresses police, saying: "We can move back to where you like here. We are live on the air at the moment. This is the four of us, we are one team. Just put us back where you want us. We are getting out of your way. Just let us know."

The reporter then continues his re-

action, using pepper spray and batons to disperse crowds near the police station. Police were seen shoving at least one person, while protesters responded by throwing projectiles at the officers as others fled the site."

Later Friday morning, CNN tweeted that Jimenez and his crew have been released. The network also reported



port, with one police officer putting his hand on Jimenez's arm. Another member of the police team then says to him: "You are under arrest," leading the reporter to ask "do you mind telling me why I am under arrest?" The police then handcuff Jimenez and lead him away.

Jimenez was arrested around 5 a.m. local time.

Jimenez said on CNN.com earlier in the night: "Dramatic scenes have unfolded in Minneapolis after the police arrived on the scene and clashed with protesters. It was the first time authorities had been seen on the scene in more than an hour. The police officers, some in riot gear, immediately launched into that Minnesota Gov. Tim Walz told CNN Worldwide President Jeff Zucker that he deeply apologizes for what happened.

After his release, around 6 a.m. local time, Jimenez returned to the air and said he had been treated well after he was led away. "We're doing OK, now. There were a few uneasy moments there," Jimenez said.

The death of the unarmed Floyd led to the firing of four Minneapolis police officers. Floyd's family says they want murder charges against them.

Protesters in Minneapolis set a police precinct building on fire. Media reports said authorities arrived on the scene just after 3:30 a.m. local time.
