NEFT transactions to be available 24x7 from Dec 16

MUMBAI, DEC 6 (PTI): In a bid to promote digital transactions, the RBI on Friday said round-the-clock transactions will be allowed under the National Electronic Funds Transfer (NEFT) system from December 16.

The 24X7 NEFT system will be available on all days of the year, including holidays, it added. NEFT transactions are settled in hourly

batches. For weekdays, the batches are from 8 am to 7 pm. On first and third Saturdays, the settlement happens from 8 am to 1 pm.

In a notification, the central bank said it has been decided that the facility on NEFT system shall be made available from December 16, 2019 on 24X7 basis. The first settlement will take place after 00:30 hours on December 16, 2019 (night of December 15, 2019).

The RBI has asked the member banks to keep adequate liquidity in their current account with the regulator at all times to facilitate successful posting of NEFT batch settlements.

Santhali language makes debut in Rajya Sabha

New Delhi, Dec 6 (PTI): Santhali language on Friday made its debut in Rajya Sabha when a lawmaker from Odisha used it to raise a matter of urgent public importance during the Zero Hour.

Saroini Hembram of the Biju Janata Dal spoke in Santhali, an Austroasiatic-Munda language spoken mostly by tribals in Odisha.

She also demanded Bharat Ratna for Raghunath Murmu, who in 1925 created the Ol Chiki script for the Santhali language. Pt. Murmu is revered by tribals and is recognised as a big cultural icon in the state, she said, adding the state government has already recognised his contribution and now it was the turn of the nation to do so. Chairman M Venkaiah Naidu, who has encouraged MPs to use their local language for raising Zero Hour mentions while ensuring that English and Hindi translations are available to other members on headphones, said this was the first time that Santhali language was used in the Upper House.

Members thumped desks to welcome the move. Naidu said the interpretation in Hindi was done under a new scheme by a non-regular employee engaged for the purpose.

NEW DELHI, 06 DEC [IPR]: Chief Minister PS Tamang [Golay] met the Union Minister for Power, RK Singh, in New Delhi on Thursday.

We are not criminals, says Farooq Abdullah

NEW DELHI, DEC 6 (PTI): "We are not criminals,"

says Lok Sabha member and National Conference president Faroog Abdullah in a letter to Congress leader Shashi Tharoor on his personal letterhead which mentions his residence as "sub-jail".

Abdullah, under detention since August and subsequently booked under the stringent Public Safety Act (PSA) on September 17, is at present at his residence in Gupkar which has been declared as a sub-jail.

Abdullah is among a host of political leaders who have been detained on August 5 after the Centre withdrew special status of Jammu and Kashmir under Article 370 and bifurcated the state into union territories.

Tharoor, a Lok Sabha member from Kerala, had written a letter to Abdullah on October 21 which was delivered to him on December 2. The contents of the letter were not available.

In his one paragraph reply, Abdullah, a three-time former chief minister of the erstwhile state of Jammu and Kashmir, thanked Tharoor for his letter.

He said the October 21 letter was delivered to him on December 21 by the magistrate who looks after him in the sub-jail.

"It is most unfortunate that they are not able to deliver me my post in time. I am sure this is not the way to treat a senior Member of the Parliament and leader of a political party. We are not criminals," Abdullah wrote in his reply, which has been shared by Tharoor on his Twitter handle.

In his tweet, Tharoor said parliamentarians should be allowed to allowed to attend "the session as a matter of parliamentary privi-

"Otherwise the tool of arrest can be used to muzzle opposition voices. Participation in Parliament is essential 4 (for) democracy and popular sovereignty," he added.

Another depositor of fraud-hit PMC Bank dies

71-year-old depositor of fraud- hit PMC Bank died of a heart attack at his residence here, his relative said on Friday.

Pratap Jiandani suffered a heart attack on Thursday afternoon at his residence in suburban Mulund, he said.

Earlier, at least eight depositors, who had high quantum of money stuck with the bank, had died in the last couple of months, including one who committed suicide.

The relative said Jiandani had an account in Punjab & Maharashtra Cooperative Bank (PMC Bank), which was put under restrictions by the

Mumbal, Dec 6 (PTI): A RBI in September after an alleged Rs 4,355 crore scam came to light.

> However, his death was nothing to do with the bank scam, said Jiandani's relative Mukesh Chhandiramani.

> Jiandani's son is returning from Spain after which his last rites will be performed, he said.

> Some of the PMC depositors who died in the aftermath of the scam were under stress due to the RBI-mandated curbs.

On October 14, PMC Bank depositor Gurudas Kaisare, a resident of Airoli in Navi Mumbai, died due to stress as he was not able to withdraw his money.

He was admitted for Rs 1,000 and raised in treatment, but was not able to access money to pay medical bills, said his relatives.

Another depositor, Kuldeep Kaur Vig, died of a heart attack in neighbouring Navi Mumbai in the first week of November, her family said.

Vig (64), a resident of Kharghar, was worried about her money getting stuck with the bank and feeling stressed after watching news about depositors protest on TV, her husband Varinder Singh Vig (74) said.

As part of RBI's restrictions, withdrawal from PMC Bank accounts was initially capped at

a staggered manner to Rs 50,000 per customer over six months.

The PMC Bank, which has around 16 lakh depositors, was placed under an RBI administrator on September 23 for six months due to massive under-reporting of dud loans.

The bank, over a long period of time, had given more than Rs 6,700 crore in loans to Housing Development and Infrastructure (HDIL), which is 73 per cent of its total advances, and which turned sour with a shift in the fortunes of the now bankrupt company.

Encounter killings draw mixed political reactions New Delhi, Dec 6 (PTI): in place on the safety of The Hyderabad po-inal justice system."

The 'encounter' killing of the four men accused in the rape and murder of a woman veterinarian in Hyderabad evoked mixed political reactions on Friday, ranging from fulsome praise to outright condemnation, with some preferring to exercise circumspection in their response.

With many political parties being of the view that the encounter killing may have drawn some public support, even the strong rivals of the ruling Telangana Rashtra Samithi such as the BJP and the Congress refrained from criticising the police action, which has drawn condemnation from civil right groups, and left it to individual voices within their organisations to offer a mixture of views.

The Left parties, however, took a strong stand with CPI(M)'s Sitaram Yechury asserting that extra-judicial killings cannot be the answer to the serious concerns over the safety of women. The CPI's D Raja said no one can justify encounters in the name of speedy justice.

"How we must secure the lives and dignity of each of our citizens, must be what civilised societies are about. Justice can never be retribution. Why is the tough law put women after the 2012 Delhi crime not being implemented properly?' CPI(M) general secretary Yechury said.

BIP leaders such as Meenakshi Lekhi and Rajyavardhan Rathore hailed the police action while another party leader Maneka Gandhi slammed the encounter, saving it has set a "horrifving" precedent.

Senior Congress leaders like P Chidambaram and Shashi Tharoor reacted cautiously with the former finance minister saying that the incident should be thoroughly enquired into to find out if it was a genuine encounter.

Another Congress leader Adhir Ranjan Chowdhury noted that a magisterial inquiry is already on and his party will wait for its outcome.

Chidambaram told reporters, "I don't know the facts of what happened in Hyderabad. As a responsible person all I can say is, it must be thoroughly inquired into to find out if it was a genuine encounter, whether they were trying to flee or it was anything else."

Tharoor said people should not rush to condemn the encounter until details emerge. He, however, added that extra-judicial killings are otherwise unacceptable in a society of laws.

Congress leader and lawyer Abhishek Singhvi virtually endorsed the police action, saying the mood of the country sometimes takes "precedence over human rights

"Sometimes in spite of all the debates and human rights logic, we shall understand the mood and sentiments of the people of the nation and stand with them. After all, democracy is all about the people," he tweeted.

Delhi Chief Minister Arvind Kejriwal said it is the anger in people against such incidents that is making them happy about the encounter killings. "The rape cases that have come to light of late, the entire country is in anger whether it is Unnao or Hyderabad, so people are expressing happiness over the encounter, he said. The AAP leader, however, struck a note of caution, saying, "It is also something to be worried about, the way people have lost

Hailing the encounter, BJP's Rathore also praised the "leadership" that allowed it.

"I congratulate the Hyderabad police and the leadership that allows the police to act like police. Let all know this is the country where good will always prevail over evil. (Disclaimer for holier than thou-police acted swiftly in self defence)." he said.

Lekhi also appeared to approve the encounter as she said in the Lok Sabha that arms are not meant to be a showpiece for police. However BJP MP Maneka Gandhi was unambiguous in her condemnation of the encounter killing.

"What happened was horrifying for the country. You cannot kill people because you want to. You cannot take law in your hands. They would have been hanged by court anyway. If you're going to shoot them before due process of law has been followed, then what's the point of having courts, law and police?" the former Union Women and Child Development minister told reporters.

Samajwadi Party MP Iava Bachchan, who had recently called for lynching of those accused of such ghastly crimes, said "better late than never" in her reaction to the encounter.

15.86 lakh cancer patients in 2018: govt tells LS

New Delhi, Dec 6 (PTI): There were 15.86 lakh cancer cases in the country in 2018, Union Health Minister Harsh Vardhan said in Lok Sabha on Friday.

The minister said cancer is diagnosed and treated at various levels in the health care system and the treatment of cancer is by surgery, radiotherchemotherapy and palliative care.

"As per the National Cancer Registry Programme of Indian Council of Medical Research, the estimated incidence of cancer cases in 2018 was 15,86,571," he said

during Question Hour. Vardhan said while doctors with D.M.

(Medical Oncology), M.Ch. (Surgical Oncology) and M.D. (Ra-Oncology) diation treat cancer patients in higher level tertiary care hospitals, other doctors such as general surgeons, gynaecologists, ENT surgeons etc. also provide treatment for cancer in government and private hospitals, depending on the type and site of cancer.

The minister said the information regarding cancer patients in government hospitals is not main-

tained centrally.

"Health being a state subject, the central government supplements the efforts of state governments in providing health care services including cancer care.

"The government of India is implementing the National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NP-CDCS) under the National Health Mission (NHM)," she said.

Vardhan said the objectives of NPCDCS include awareness generation for cancer early detection and referral to an appropriate level institution for treatment.

He said 599 Non Communicable eases (NCD) clinics at District level and 3,274 NCD clinics at community health centre level have been set up under the programme.

To enhance the facilities for tertiary care of cancer, the central government is assisting 18 state cancer institutes and 20 tertiary care cancer centres under the strengthening of tertiary care for cancer scheme, he said.

NEFT transactions to be...

NEFT transactions after usual banking hours are expected to be automated transactions initiated using 'Straight Through Processing (STP)' modes by the banks.

The existing discipline for crediting beneficiary's account or returning the transaction (within 2 hours of settlement of the respective batch) to originating bank will continue, it added.

Besides, member banks will ensure sending of positive confirmation message for all NEFT credits and all provisions of NEFT procedural guidelines will be applicable for 24x7 transactions as well, it added.

"Member banks are also advised to initiate necessary action and ensure availability of all necessary infrastructural requirements at their end for providing seamless NEFT 24x7 facility to their customers." the regulator said.

Banks may disseminate information on the extended timings for NEFT to all their customers, RBI

From July 1 this year, RBI had decided not to levy charges on transactions through NEFT and Real Time Gross Settlement (RTGS) system in order to promote digital transactions in the country, and asked banks to pass on the benefits to the customers.

Earlier, the RBI used to levy minimum charges on banks for transactions routed through RTGS and NEFT. Banks, in turn, levy charges on their customers.

RTGS is meant for large-value instantaneous fund transfers, while NEFT is used for fund transfers of up to Rs 2 lakh.

Encounter: some ex-cops welcome it, some term it 'short-cut'

MUMBAI, DEC 6 (PTI): Reactions of some former senior police officials from Maharashtra on Hyderabad encounter were mixed on Friday, with some justifying the action citing the circumstances, while others condemning it as undesirable "short-cut".

The four men arrested for the rape and murder of a 25- yearold woman veterinarian in Hyderabad last month were killed in an 'exchange of fire' with a police team on Friday morning.

Former Maharashtra Director General of Police D Sivanandhan said this kind of "short-cut" will not help with prevention of crime in the long run.

The 1976-batch IPS officer, whose tenure in Mumbai in the 1990s saw several encounters of gangsters, said, "After the encounter, the police may get praised for a short period, but it is not good in the long run."

Sivanandhan also said it was better to take measures to prevent crime against women with the help of technology.



"There should be proper patrolling and adequate police presence all over the city," he said.

Another former top official of Mumbai Police said, requesting anonymity, "Whatever happened should not have happened, especially when the accused were in police custody."

Julio Ribeiro, former Mumbai police commissioner and Punjab DGP, condemned the encoun-

"The judicial process system is not working. That is why these shortcuts are adopted under pressure from the public and politicians," he said.

SS Virk, who served as DGP of Maharashtra and Punjab, said going by the circumstances narrated by Hyderabad Police, the action was justified. "TV clips show that

people are very happy with the police action. I do not disagree with them. (But) While praising the encounter on the whole, we also have to see whether there was any legal lacuna," he said.

"The rape and murder was barbaric. If such things start happening then no girl or woman will feel safe," Virk said, adding that it was a crime against entire society.

"In Nirbhaya case, strong legal action was taken against the accused. They were all sentenced to death, but have not been hanged so far," he pointed out.

"The legal system loses its impact in such cases. When our criminal justice system becomes weak and ineffective, the public expects strong action. Then even if the action is not strictly legal, people welcome it," he

"We have to fast-track our system, make it more effective," Virk said.

Former Mumbai police commissioner Satyapal Singh, who is now the BJP MP from Baghpat, hailed the encounter.

"I would like to congratulate Hyderabad Police for tackling the situation with great valour. It would've been a big stain on the uniform if the culprits would've managed to escape from custody. Jai Hind," he said in a

Retired Assistant Commissioner of Police Prafulla Bhosale, one of the Mumbai police officers who gained fame as `encounter specialists', justified the killings, saying it was the "need of the situation".

"It is justified as the accused tried to snatch the weapons of policemen during the crime scene reconstruction," he said.

"Had the accused managed to flee, it would have been disgusting for the police and they would have been blamed for negligence," he added.

Collaborating Towards a Better Town

Gangtok might be clean by national standards, but it could be so much better

When they experimented with MG Marg, the policy-makers had hoped that the litter & spit free zone would eventually encompass all of Gangtok, and if that happened, dream even bigger and extend it to all of Sikkim. The mission has succeeded to the extent that Sikkim went on to become the first Nirmal Rajya (open defecation free state) and has also bagged a Safaigiri award for its obviously better garbage management credentials than the other states of the country. But that is hardly a comparison to boast about or be satisfied with since Sikkim has the benefit of its small size and abundant finances to devote to waste management, a luxury, which say a Bihar does not enjoy. So, while the State, its government and its people deserve credit for being better, they should now aim to become really good as well.

What better place to begin than the capital itself. Gangtok remains a town of contradictions where the residents continue to live comfortably in the company of stinking jhoras which they themselves have clogged with all types of household refuse and even the occasional sewage release. Instinctive cleanliness around public spaces is thus perhaps too much to expect. Gangtokians might live in pine-wood paneled houses that they themselves rub with mansion polish every day, but are oblivious to their civic duties as they prove with clockwork regularity as the corners and roadsides continue to mimic public dustbins and the jhoras have become a study of consumption patterns. This, despite a functional garbage collection service being in place. This is unfortunate because with even a few collaborative efforts, this town could be much better. A keener sense of responsibility towards public spaces would help and the right awareness at the school level could easily address the problem of irresponsible littering. It is after all not enough to reach a garbage bag to the UDHD trucks in the morning and then spend the rest of the day littering the town with wrappers and other refuse or surreptitiously empty septic tanks into neighbourhood jhoras.

What is required is an attitudinal shift which displays more collective consideration. Gangtok is not really a city yet, but it is already overflowing with brash disregards; house-owners are lavish with their own accommodations but cramp the floors below with pigeonholes and common toilets and bathrooms; Gangtok drivers are among the most impatient and insensitive, as are their VIP vehicles. Such mindsets, which disregard common intent or pursuits, continue to rear up in all engagements and personal aggrandizement thus becomes a driving force. An immediate fall out of this has been the noticeable rollback in aesthetic nuances. Aesthetic appeal is after all for public consumption and extravagance for personal indulgence. No prizes here for guessing which option Gangtok takes on a daily basis. Bigger cars, higher buildings and increased consumption have left Gangtok an ugly town. Take any back-lane and one will be confronted with innumerable case-studies of how private greed has encroached upon public space and convenience. The capital is exploding with private decisions thumbing their collective noses at public courtesies.

With too much ugliness already permanent in the form of concrete, the least that can be done is to leave the open spaces [which are mostly the roads and shortcuts now in Gangtok] free of litter. Maybe starting with this conscious effort, Gangtok could begin the process of becoming and town more becoming of its hill station status and more true to its cleanliness credentials.

Our plan to identify 'illegal immigrants' could get some Muslims declared 'foreign'

The Indian government will soon ask its 870 million voting-age citizens for documentation that they are legal citizens with ancestral ties to India. On Nov. 20, Indian Home Minister Amit Shah announced a plan to expand the National Registry of Citizens, a four-year documentation effort that recently concluded in India's northeastern state of Assam, to the entire country. Shah claims that the effort will help identify illegal immigrants in a "nondiscriminatory" fashion.

The news was met with some dismay. After Assam finished tallying its 30.5 million people in August, about 1.9 million were declared "foreign." Some were Bangladeshi immigrants living in Assam illegally. Others were refugees who migrated to India after Bangladesh's independence war in 1971. Most were women, members of oppressed castes, religious minorities or poor.

Even some people with paper ID were rejected from the register because of misspelled names or incorrect formats.

As a historian who studies identity and exclusion in India, I know that when governments try to determine who belongs and who does not, the most marginal are inevitably left out.

INDIA'S MANY IDs

India, which was under British rule from the 18th century until 1947, has seen many different governments try to define citizenship.

The British Indian Passport, implemented in the early 20th century, was the first large-scale attempt. The British used their passport to give "respectable" Indians the right to travel across British colonies and prevent travel by groups deemed "undesirable" by the colonial government – indentured and migrant workers, anti-colonial and communist dissidents, among others.

After the arbitrarily drawn partition of the British-ruled subcontinent into the sovereign nations of India and Pakistan in 1947, new systems of documentary control were invented to control the ensuing refugee flows between two new countries.

Some of these would later come to serve as evidence of nationality in India. The India-Pakistan Passport, which enabled people to cross freely between the two countries, did double duty as a certificate of citizenship. India's ration cards, which entitled Indians to welfare distribution in the post-colonial era, also served to verify residency and allowing inclusion into electoral rolls.

In 2009, India launched the ambitious Aadhar project. The goal of this project was to provide a biometric identity and unique identification number to all of India's 1.3 billion people.

Though critics have raised concerns regarding privacy and surveillance, most Indians now have an Aadhar card.

Yet, in Assam, this card was not considered valid for the state's citizenship registry. Anyone who has been in India for six months can apply, so the state considered the Aadhar card in-

sufficient proof of residency.

'WEAPONIZATION OF PAPER'

Prime Minister Narendra Modi and his Bharatiya Janata Party have released few details about the planned national extension of the citizen registration process. It is unclear when it would begin, how long it would take and which government agency would lead the process.

But the Indian Ministry of External Affairs stated that it will follow the Assam method of determining citizenship. A spokesman says the state used a "fair," "nondiscriminatory" and "scientific" way to identify illegal immigrants.

To register officially as an Indian citizen, people across the country will have to submit a combination of documents that confirm residence and establish links to India. These include birth certificates, land deeds, prior inclusion within electoral rolls or evidence of government service.

But documentary proof of identity requires access to state services and financial privilege. In India, as in other emerging economies, many people lack government-issued birth certificates and land deeds.

Traditionally, long-time residence, kinship, language and religion have been sufficient proof of belonging in India.

Critics call Assam's citizen registry initiative a "weaponization of paper" that targets religious minorities and marginalized communities.

RELIGIOUS DISCRIMINATION

Modi's commitment to Hindu nationalism – a political stance that promotes India as a Hindu nation – has raised concern that any national citizen ID effort will target Muslims, India's largest majority.

Since entering office in 2014, Modi has revoked the special status of Kashmir, the only Muslim-majority state in India. He has overseen legislation that economically and socially excludes Muslims and watched silently as hate crimes against Musııms surge

A particular reason for concern about religious discrimination in the citizen identification process is a separate citizenship bill likely to be approved by the Indian Parliament.

It promises to grant Indian citizenship to all Hindus, Buddhists, Jains, Sikhs and Christians who have fled religious persecution in Pakistan, Bangladesh or Afghanistan. Their citizenship would be automatic after a short residency in India and would require no documentary proof.

If that bill passes, the results of any future national citizen documentation process would in effect apply solely to Muslims who cannot prove residency.

TRAUMA OF EXCLUSION

Many countries have stumbled during efforts to identify all their citizens.

Periodic U.S. efforts to identify and expel undocumented migrants in the 20th century at times led the government to mistakenly detain and even deport American citizens who lacked the proper

The 1.9 million Assam residents unable to prove their Indian citizenship may now appeal to the Foreigners' Tribunals, quasi-judicial bodies created by the Assam government for this purpose.

Those confirmed as "foreign" face potentially lengthy confinement in detention centers now under construction to hold newly stateless people.

Deportation is not an option for the majority of people excluded from Assam's citizenship rolls. They do not have residency elsewhere. Neighboring Bangladesh says it will not accept Assam residents declared to be Bangladeshi immigrants without proof of Bangladeshi citizenship.

For many, the pain of not qualifying as Indian has started taking its toll. At least 30 people excluded from the Assam registry have killed themselves this year.

Good literature can come in digital forms – just look to the world of video games

Some years ago, tired of scrolling through Netflix in search of something we hadn't seen yet, I suggested to my partner that we play a video game instead. Not the gaming type, she wasn't too keen on the idea, but I promised something where she didn't have to "aimlessly collect things". The game we played was Dear Esther, which is part of the burgeoning trend in "literary video games".

The suggestion proved successful. She enjoyed the experience and, compelled by immersion and the story, progressed right through the two-hour play-time in one sitting. I knew that Dear Esther would be the perfect game for someone who doesn't like games. All the hallmarks of gamification are absent: you don't have clear objectives, you don't have to overcome obstacles, collect anything, battle anyone, and you can't really die. In Dear Esther, all you really do is walk.

Developed by British game studio The Chinese Room, Dear Esther belongs to a contemporary genre of games known as "walking simulators". These titles involve little more than travelling from one point to another, sometimes interacting with the occasional object while leisurely taking in the surrounds.

Many walking simulators have gone on to receive critical acclaim, works like Everybody's Gone to the Rapture, also by The Chinese Room, The Vanishing of Ethan Carter, All the Delicate Duplicates, and Journey. The degree to which one has stuff "to do" varies between such works, but typically, players have very little to interact with in these worlds. And yet, they are immensely popular.

FINDING THE STORY

The reason is that these games are all about story and about the vital role of place in the act of storytelling. Creators of digital fiction are using rich virtual worlds to make their stories engaging. We all know when we have come upon a good story, because we want to stay in it, we want to know how it ends. We want to go over it again to be sure that we haven't missed something the first time around because there is pleasure in knowing and unknowing. A feeling that there might be more story to be revealed, hidden somewhere in the game world. But this is a false sense of liberation – what I refer to in my book Towards a Digital Poetics: Electronic Literature & Literary Games as the "illusion of choice".

Scholars of digital fiction have long been fascinated by this idea, the reality that interaction makes the player feel like an active participant in the narrative's progression; when they are in truth still a voyeur, bound by predetermined authorial structures as they might be in print. The difference, of course, is that sense of active participation, of narrative exploration which, however false, is extremely compelling.

What is interesting about the use of video games to tell stories is that we are constantly being told that literature is suffering in this current age of screens. Such arguments tend to construct a tension between print and screen-based storytelling. But language is just one form of expression, and while it is a hugely powerful instrument when yielded on its own, there is also much that can be achieved by combining it with other modes, as we have long seen with film and other multimedia storytelling.

Video games, inherently mixed media, are ideal for such expressive mash-ups. A storyteller can describe a world with words, but they could also show you that world with computer graphics; allow you to build it in your mind's eye, or traverse it with a mouse and keyboard.

It is easy to argue that compared to mixed media storytelling, the use of language alone can be more liberating to readers: the worlds we imagine are limited only by ourselves. Whereas video games, despite illusions otherwise, are mathematically confined. The worlds we inhabit in games are, while seemingly vast, surrounded by hard-coded event horizons – points which the player just cannot pass. But good stories are not defined by their capacity to be infinite, but the extent to which they make us feel something, whatever their aesthetic confines.

DIGITAL LITERATURE'S DAY

Of course, not all video games are concerned with story. In fact, Ian Bogost, one of the stars of game studies, thinks they're better without. Some are still all about play, about doing, about space without narrative. Astrid Ensslin, who wrote the book on this topic, Literary Gaming, talks about a "literary-ludic spectrum", with games that privilege play being on one end and games that privilege story on the other. Considering that video games are the cultural form of the day, there is plenty of room for both.

Video games have become a new form of literature without much fanfare. People still refer to the 1970s and 80s as the glory days of interactive fiction, a time when computers were giving choose-your-own-adventure stories a new lease of life. But technology has come a long way since then, and so too has our ability to capture the hallmarks of good literature in digital forms.

Literary games are not just those indie works like Dear Esther and Everybody's Gone to the Rapture that privilege spatial narratives. Even blockbuster, big-budget (what are called "Triple A") titles like Red Dead Redemption and Horizon: Zero Dawn recognise the importance of characters, dialogue, setting and theme. These are all the elements of literature, and somewhat quietly, they have become central to a large element of the contemporary video game canon.

ACB exonerates Ajit Pawar in Vidarbha irrigation scam

NAGPUR, DEC 6 (PTI): Maharashtra's Anti-Corruption Bureau (ACB) has given a clean chit to NCP leader and former deputy chief minister Ajit Pawar in the multicrore Vidarbha irrigation

The ACB, in its affidavit submitted in the Nagpur Bench of the Bombay High Court, has ruled out Pawar's involvement in cases of alleged irregularities in approval and commissioning of irrigation projects in the state.

The affidavit was submitted on November 27, a day before the Maha Vikas Aghadi (MVA) government of the Shiv Sena -NCP-Congress was sworn-in the state on No-

The court had asked the ACB to clarify its stand on the role of Pawar, a former Water Resources Development Minister, in these cases.

Pawar, the NCP MLA from Baramati in Pune district, was Water Re-Development sources Minister during 1999-2009 when the Congress-NCP combine was in power in Maharashtra.

Pawar had also served as chairman of Vidarbha

Irrigation Development Corporation which had cleared irrigation projects in which irregularities were alleged.

The affidavit said there were lapses on the part of executing agencies of the tender work - that is engineers, divisional accountants and respective contractors of these projects.

"However, the VIDC chairman/Minister Water Resource Department (WRD) cannot be made responsible for the acts of the executing agencies as there is no legal duty on his part," it stated.

The ACB is inquiring into a total of 2,654 tenders related to 45 projects of VIDC as per two PILs filed in 2012 before the Nagpur bench of the Bombay High Court.

On November 25, the anti-graft agency had said it has closed probe in nine cases of alleged corruption in irrigation projects, but clarified none of them was linked to Pawar.

"These enquiries were closed as no criminal offence was made out after enquiry against anyone. None of these

nine enquiries was in respect to Ajit Pawar, the then chairman of VIDC," the ACB had said.

About the November 27 affidavit, a senior ACB official said the court had asked the agency to submit a 'status report' on the VIDC scam before November

"We have not closed inquiry into the VIDC cases. In some cases we have filed chargesheets and investigation is also going on. Similarly, investigation into FIRs related to these cases are also going on.

"We have submitted the status report on investigation going on into tenders that were issued (by VIDC)," he

He said the HC had asked the ACB to submit a report on the PIL filed by one Atul Jagtap concerning award of tenders for an irrigation project in Amravati. Pawar was named a respondent in this PIL.

"Concerning this we had, in our previous affidavit, written that we have referred this matter to the government for opinion.

"Now, we have got opinion from the government that Ajit Pawar was not involved in it (the scam) and this we have communicated to the court a few days back.

"Besides, Ajit Pawar was never an accused in any of our cases and investigation into Vidarbha irrigation tender cases are still on," the ACB official said

Voda Idea to shut if no relief provided by govt: Kumar Mangalam Birla

NEW DELHI, DEC 6 (PTI): Vodafone Idea Ltd, the India's third largest mobile service provider, will shutdown if the government does not provide relief on the liability it faces in past statutory dues following a Supreme Court order, its billionaire chairman Kumar Mangalam Birla said on Friday.

"If we we are not getting anything then I think it is end of story for Vodafone Idea," Birla said at the HT Leadership Summit when asked about the future of Vodafone Idea in absence of a government relief on payment of Rs 53,038 crore

Birla's Idea Cellular and British telecom giant Vodafone plc's India unit had merged last year to compete with the onslaught of free voice calling and dirt cheap data unleashed by richest Indian Mukesh Ambani's

Reliance Jio. In the process, it accumulated Rs 1.17 lakh crore debt and had just weeks back posted corporate India's biggest



upholding the government's position on what base should statutory liabilities be calculated.

"It does not make sense to put good money after bad. That would be end of story for us. We will shut shop," he said in a response when asked if Vodafone Idea will put in more money.

Market leader Bharti Airtel, Vodafone Idea and other telecom players have to pay as much as Rs 1.47 lakh crore in payment of telecom license fee and

loss after it provisioned spectrum usage charge for the liability arising together with interest from the Supreme Court and penalty for past 14 years.

Both Airtel and Vodafone Idea have petitioned the government for relief in waiver of interest and penalty, which will halve the dues, and also filed a review petition in the Supreme Court.

Birla was however hopeful of a relief from the government not just for the telecom sector but the industry as a whole to pull out the economy from a six-year low GDP growth of 4.5 per cent.

"They (the government) have realised the fact that this (telecom)

is a very critical sector. The whole digital india programme rests on this. This is a strategic sector,"

he said.

The government, he said, has publicly stated that it wants three players from the private sector and one player from the public sector.

"I think that we can expect much more stimulus from the government because it is required for the sector to survive. If we weren't getting anything then I think it is end of story for Vodafone Idea," he said.

The government had late last month deferred by two years the payment due to telecom companies for spectrum they bought in past auctions. This relief totalled Rs 44,000 crore for the industry but companies are expected to pay this due together with interest after the two year moratorium.

Asked about the specific relief sought, Birla said, "The big elephant in the room is AGR. Which is actually I think something which lies in the court of judiciary. I believe government can have a dialogue. This was a suit filed by the government against telecom service providers."

AGR refers to adjusted gross revenues, a percentage of which the telecom companies pay as statutory dues. The Supreme Court had upheld the government position that non-telecom revenues have to be included in the AGR for calculating dues.

"Since the government has won, it gives them headroom to talk to judiciary and try to find some of solution. I don't know which form or shape it takes," he added.



Everton sack Marco Silva and put Duncan Ferguson in temporary charge

Duncan Ferguson has been placed in temporary charge of Everton after Farhad Moshiri, the club's majority shareholder, made Marco Silva his fourth managerial sacking in under four

Silva was dismissed midway through a threeyear contract with Everton languishing in the relegation zone after eight defeats in their past 11 Premier League matches.

Moshiri had been reluctant to part company with the Portuguese, an appointment he instigated and ultimately had to pay Watford around £4m in compensation for, but the manner of Wednesday's shambolic 5-2 defeat at Liverpool proved the breaking point.

David Moyes is the leading candidate to succeed Silva with Tim Cahill under consideration to become the former Everton manager's assistant. Other possible contenders include Vítor Pereira who was overlooked for the Everton job in 2013. The Portuguese is currently in charge of Shanghai SIPG.

has been Moyes championed for some time by the chairman, Bill Kenwright, despite his poor track record since leaving for Manchester United after his Everton contract expired in 2013. The 56-year-old is available having been out of work since leaving West Ham in May 2018, although he will not be installed before Saturday's home game against Chelsea. His first game could be away at United on Sunday week.

Ferguson, a first-team coach under several Everton managers, was asked to take temporary charge following a chaotic day that had Moshiri visit Silva in person at the club's training complex. Neither Moshiri nor Kenwright attended the derby defeat at Anfield but Moshiri travelled from London to visit Finch Farm with fellow board members and the director of football, Marcel Brands.



Silva took training as usual on Thursday before Brands instructed the first-team squad to remain behind for a meeting with Moshiri. The players were not criticised for their part in Silva's sacking – it is understood the 42-yearold was not mentioned during the meeting – but were asked what the board could do to help improve their performances. The directors reconvened and, six days after Brands gave an inhouse interview calling for stability and unity at Goodison Park, Silva was informed his time as the Everton manager was

over after 18 months. He follows Roberto Martínez, Ronald Koeman and Sam Allardyce as managers sacked in Moshiri's reign – the under-23s' manager David Unsworth has also taken temporary charge in that time - and leaves with the lowest pointsper-game average (1.28) of any Everton manager since Walter Smith, Moyes's predecessor. Silva won 19 of his 53 league matches at Everton.

In a statement the club said: "Majority shareholder Farhad Moshiri, chairman Bill Kenwright and the board of directors would like to thank Marco for his service over the last 18 months and wish him well for the future. Duncan Ferguson has taken temporary charge of the first team and will manage the side for the game against Chelsea on Saturday. The club aims to confirm a new permanent manager as swiftly as possible."

Silva paid an inevitable price for bad results and was left a lame-duck manager after Everton fans turned on him following the 2-0 home defeat by Norwich, who were bottom of the table at kickoff, on 23 November. However, there was also recognition within the Everton hierarchy of his misfortune with injuries and VAR decisions, plus a flawed transfer strategy last summer.

Everton spent approximately £117m on players in that time but also recouped £84m from clearing out dead wood inherited from previous managers, plus the reluctant sale of Idrissa Gueye to Paris Saint-Germain. Gueye's replace-Iean-Philippe ment. Gbamin, made only two appearances before rupturing a thigh muscle and has yet to resume full training. Another central midfielder, André Gomes, suffered a fracture dislocation to an ankle last month, while Fabian Delph, the summer signing from Manchester City, has been hindered by several injuries.

The failure to replace the on-loan Kurt Zouma in central defence also hindered Silva, who had wanted the Chelsea player's signing to be a priority, while Brands led the £29m signing of 19-yearold striker Moise Kean from Juventus when the manager wanted a more experienced forward. Kean has started only twice in the league and has not scored in 13 appearances in total for the

Everton's board, of which Brands is a part, has been divided on sacking Silva, and his potential replacements, for several weeks. The club has spent around £450m on players since Moshiri's arrival in February 2016, recouping just under half of that, but a string of poor purchases and bad appointments have resulted in another fight for survival.

New book claims Albert Camus was murdered by the KGB

Cixty years after the French Nobel laureate Albert Camus died in a car crash at the age of 46, a new book is arguing that he was assassinated by KGB spies in retaliation for his anti-Soviet rhetoric.

Italian author Giovanni Catelli first aired his theory in 2011, writing in the newspaper Corriere della Sera that he had discovered remarks in the diary of the celebrated Czech poet and translator Jan Zábrana that suggested Camus's death had not been an accident. Now Catelli has expanded on his research in a book titled The Death of Camus.

Camus died on 4 January 1960 when his publisher Michel Gallimard lost control of his car and it crashed into a tree. The author was killed instantly, with Gallimard dying a few days later. Three years earlier, the author of L'Étranger (The Outsider) and La Peste (The Plague) had won the Nobel prize for "illuminat[ing] the problems of the human conscience in our times". "The accident seemed

to have been caused by a blowout or a broken axle; experts were puzzled by its happening on a long stretch of straight road,

a road 30 feet wide, and with little traffic at the time," Herbert Lottman wrote in his 1978 biography of the author.

Catelli believes a passage in Zábrana's diaries explains why: the poet wrote in the late summer of 1980 that "a knowledgeable and well-connected man" had told him the KGB was to blame. "They rigged the tyre with a tool that eventually pierced it when the car was travelling at high speed."

The order, he said, had been issued by Dmitri Shepilov, the Soviet Union's minister of internal affairs, in retaliation for an article by Camus in the French newspaper Franc-Tireur published in March 1957.

"It seems it took the intelligence three years to carry out the order," Zábrana's diary reports. "They managed eventually and in such a way that, until today, everyone thought Camus had died because of an ordinary car crash. The man refused to tell me his source but he claimed it was completely reliable." Camus had sided

publicly with the Hungarian uprising since autumn 1956, and was highly critical of Soviet actions. He also publicly praised and supported the Russian author Boris Pasternak, who was seen as an-

ti-Soviet. Catelli has spent years researching the validity of Zábrana's account. In his book, he interviews Zábrana's widow Marie, investigates the KGB's infiltration of France, and includes secondhand testimony from the controversial French lawyer Jacques Vergès. Catelli was contacted by Giuliano Spazzali, an Italian barrister, after the book's publication in Italy. Spazzali recounted a conversation he'd had with the late Vergès about Camus' death.

dent had been staged. It is my opinion that Vergès had more evidence than he cared to share with me. I refrained from asking," Spazzali told Catelli. "Discretion is the best attitude when a hot topic rises unexpectedly. I didn't investigate any further, and yet I remember how Vergès was certain that the staged accident was schemed by a KGB section with the endorsement of the French intelligence."

Catelli argues that Camus' outspokenness was interfering with French-Soviet relations, and "Camus' prominent character ... stood out in the eyes of the French

people as a reminder of the USSR's cruel imperialism. Both the French and the Soviet governments would have benefited greatly from silencing this unpleasant reminder ... No proper investigation was carried

out." Catelli's said his theory had not been endorsed by Camus' daughter Catherine, who prohibited publisher Gallimard from quoting her father's work. The book has nonetheless been published in France, Argentina and Italy, and received the backing of Paul Auster, who called Catelli's argument compelling.

"A horrible conclusion, but after digesting the evidence Catelli has given us, it becomes difficult not to agree with him. Thus 'car accident' should now be filed in another drawer as 'political assassination' - and thus Albert Camus was silenced when he was 46 years old," writes Auster in a foreword.

"I hope that the academics will not follow the old opinion that it was a simple accident," said Catelli, who is talking to British publishers about an English translation. "I think we owe it to the memory of Albert Camus."

"Our nations face a range of shared security threats, including terrorism, drug trafficking, illegal migration, cyberattack, and the spread of nuclear, chemical, and biological weapons," Trump said in his luncheon meeting with the Permanent Representatives of the UN Security Council.

The US holds the monthly rotating presidency of the UN Security Council for December.

"We are working very hard on those problems, especially the last three. There can be nothing more important. The Council must take action to confront these and other dangers facing the world," Trump said at the top of the luncheon at the White House.

"That also includes the behaviour of the Iranian regime, which has killed hundreds and hundreds of people in a very short period of time. They're killing protestors. They turned down their Internet system. People aren't hearing what's going on," he said.

Trump also called on Security Council members to join the United States in "our vital efforts to promote religious liberty" around the globe.

"The world is more secure when people have the right to follow their convictions and to worship in peace. We have been very strong

Trump said it is a horrible situation in Iran and urged the media to get involved by going there and seeing what's happening.

"It's something that is going to be a big scandal throughout the world very soon. They're killing a lot of people. And they're arresting thousands of their own citizens in a brutal crackdown in recent weeks because they're protesting. I think the media should get involved in that. I don't know that they will because they have their own reasons, but the media should absolutely get involved in that," he said.

America will always stand with the Iranian people in their righteous struggle for freedom, Trump said, and added that the Iranian situation could be fixed "very quickly and very easily".

Trump urged the UNSC Permanent Representatives to work together to address global challenges from denuclearisation of the Korean Peninsula and peace talks in Afghanistan, the White House said in a readout from the meeting.

Trump also encouraged the Permanent Representatives to take action to confront malign actors threatening global security and prosperity.

France hit by second day of massive strike over pension reform

ravellers ■ France endured a second day of chaos on Friday as unions vowed to keep up their strike until President Emmanuel Macron backs down on controversial pension overhauls.

Rail operator SNCF said 90 percent of highspeed TGV trains were again cancelled, and several airlines dropped flights including Air France, EasyJet and Ry-

Nine of the capital's 16 metro lines were shut and most others severely disrupted, sparking some 350 kilometres (220 miles) of traffic jams in the Paris region, well above the usual 200 km, the traffic website Sytadin reported.

Many employees were unable to get to work and several schools again provided only daycare, though fewer teachers were on strike compared with Thursday when some 800,000 people demonstrated across the country according to the interior ministry.

Bike paths were crowded with bikes and electric scooters, with metro operator RATP sponsoring special deals for commuters with a



range of ride-hailing companies and other transportation alternatives.

The walkout is the latest test for Macron after months of protests from teachers, hospital workers, police and firefighters as well as the "yellow vest" movement demanding improved living standards.

Unions say his "universal" pension system, which would eliminate dozens of separate plans for public workers, forces millions of people in both public and private sectors to work well beyond the legal retirement age of 62.

Health Minister Agnes Buzyn said Friday that the government had "heard" the protesters' anger and would meet with union leaders to discuss the reform on Monday.

The government has yet to lay out the details of its plan, and Buzyn told Europe 1 radio that "there is indeed a discussion going on about who will be affected, what age it kicks in, which generations will be concerned -- all that is still on the table".

Macron 'determined' -

Yves Veyrier, head of the hardline FO union. warned Thursday the strike could last at least until Monday if the government did not take the right action.

But it remains to be seen if the protests will match the magnitude of

the 1995 strikes against pension overhauls, when France was paralysed for three weeks from November to December in an action that forced the government to back down.

Macron, a former investment banker, has largely succeeded in pushing through a series of controversial reforms, including loosening labour laws and tightening access to unemployment benefits.

But this is the first time the various disgruntled groups have come together in protest.

So far Macron has not spoken publicly on the stoppages though a presidential official. who asked not to be named, said

Thursday that the president was "calm" and "determined to carry out this reform" in a mood of "listening and consultation".

While most of Thursday's rallies were peaceful, police fired tear gas to disperse dozens of black-clad protesters smashing windows and throwing stones during the Paris march, with one construction trailer set on fire. Sporadic clashes were also reported in some other cities.

Many people were bracing for further disruptions over the weekend, including the prospect of fuel shortages as unions blocked most of the country's eight oil refineries.

The minimum pension age in France is 62, one of the lowest among developed countries, but there are 42 "special regimes" for railway workers, lawyers, opera employees and others offering earlier retirements and other benefits.

The government says a single system will be fairer for everyone while ensuring its financial viability while acknowledging that people will gradually have to work longer.

Governor: All 3 crew killed in Black Hawk helicopter crash St. Cloud, Minn, Dec 6

(AP): All three Minnesota National Guard soldiers were killed when the Black Hawk helicopter they were in crashed Thursday, Gov. Tim Walz said.

The identities of the soldiers were not released, pending notification of family.

The crash was being investigated and preliminary information on the crash was not released.

The Black Hawk helicopter with the three crew members aboard crashed Thursday in central Minnesota, the Minnesota National Guard said.

Earlier, the Guard tweeted that the UH-60 crashed south of St. Cloud and that authorities were on the scene. The Guard lost contact with the helicopter shortly after taking off on a maintenance test flight from St. Cloud on Thursday afternoon, Guard Master Sgt. Blair Heusdens said.

The helicopter called mayday about nine minutes after takeoff. Our first priority is the safety and well-being of our Guardsmen and our thoughts are with our soldiers and their families at this time," Heusdens said in a statement before the crash was confirmed.

The Black Hawk sent helped in the search.

a mayday signal at 2:15 p.m., Stearns County Chief Sheriff's Deputy Dan Miller told reporters. Crews from multiple departments spent several hours searching before finding the crash, Miller said.

Television aerial footage showed the wreck of the helicopter along a tree line near open fields near St. Cloud, a city about 59 miles (95 kilometers) northwest of Minneapolis.

Apparent marks encircled the flattened wreckage in the snow. The Guard's base near St. Cloud Regional Airport has been in operation since 2009, with Black Hawk and Chinook helicopters maintained there.

Gov. Tim Walz canceled a tree-lighting ceremony, and a spokesman said he was headed to the St. Cloud area near the crash site.

Walz served for 24 years in the Army National Guard, while he was a schoolteacher and coach, but retired in 2005 to run for Congress.

The Minnesota State Patrol was called to bring in a helicopter to help with the search. A State Patrol Cirrus aircraft, equipped with thermal imaging cameras, also

'Mega fire' forms north of Sydney

SYDNEY, DEC 6 (AFP): Several Australian bushfires have combined to form a "mega fire" that is burning out of control across a swathe of land north of Sydney, authorities said Friday, warning they cannot contain the blaze.

New South Wales Rural Fire Service deputy commissioner, Rob Rogers said "there are probably more than eight fires in all" that have merged to form what has been dubbed a "mega fire" in an area of national park forest.

The blaze was burning across 300,000 hectares -- an area roughly 60 kilometres (37 miles) across -- within an hour's drive of Australia's largest city, which was again subsumed in a soup of toxic smoke.

"There is just fire that whole way" said Rogers, who added that firefighters could do little more than get any residents out, protect property and hope for an end to fire-friendly dry and windy conditions.

We "cannot stop these fires, they will just keep burning until conditions ease, and then we'll try to do what we can to contain them," he told public broadcaster ABC.

"The best thing we can do is try to protect property and people as much as we can." Prolonged drought has left much of eastern Austra-



fires have raged every day for the past three

Bushfires are common in Australia but scientists say this year's season has come earlier and with more intensity due to a prolonged drought and climatic conditions fuelled by global warming.

Dramatic footage of firefighters running from a wall of fire ripping through the tree canopy above them was captured overnight in Orangeville, less than 100 kilometres west of Sydney.

The local fire and rescue team that shot the images said no one was injured and the vehicles surrounded by the swirling embers also survived the blaze.

"The video was put up to demonstrate why you need to listen to the fire advisory system," the team from Ingleburn fire station said on Facebook. help out.

"If your property is not prepared for the bushfire season and your (sic) not sure you are able or capable of defending your property if a fire approaches you need to leave straight away," they warned.

At a wildlife park in the area, 300 animals were evacuated.

Walkabout Wildlife Park said it had shipped out lizards, dingoes, peacocks and marsupials, as firefighters battled more than 100 fires up and down the eastern seaboard.

"This fire has been doing some crazy things, so we have to be prepared," general manager Tassin Barnard told AFP.

New South Wales rural fire chief Shane Fitzsimmons said some US and Canadian firefighters had arrived to

The specialists are expected to supervise waterbombing planes and heavy equipment used in creating fire containment lines.

"We are not only appreciative of their presence here today, but of their sacrifice," said Fitzsimmons -- who has become a fixture on Australian television screens for weeks, updating the public on blazes in towns, national parks and backwaters.

"They are volunteering to sacrifice time from loved ones, from families, to give up that special time of the year around Christmas and New Year to come down here and lend us a hand," he said.

More than 600 homes have been destroyed and six people have died since the crisis began in September.

That is many fewer than Australia's deadliest recent fire season in 2009 when almost 200 people died, but 2019's toll so far belies the scale of devastation.

An estimated two million hectares have burned -- the size of some small countries -across a region spanning hundreds of kilometres (miles).

The fires have taken a toll in Sydney and other major cities, which have been blanketed in toxic smoke for weeks and occasionally sprinkled with snow-like embers.

Fitzsimmons said he could not "overstate the effect that this profound drought is having" as he warned of a long, painful summer ahead.

"There is an absolute lack of moisture in the soil, a lack of moisture in the vegetation... you are seeing fires started very easily and they are spreading extremely quickly, and they are burning ridiculously intensely.

Uber reveals thousands of reported sexual assaults in US

Ridesharing lead-er Uber, under fire around the world for its safety record, said it had tallied nearly 6,000 sexual assaults in the United States over the past couple of years.

That included more than 450 cases of rape, according to Uber's first public report into the issue Thursday, which counts attacks by both passengers and drivers over 2017-18.

It also revealed 19 to the company over the two-year period, when it averaged more than 3.1 million trips each day in the United States.

Sexual assaults were reported on 0.00002 percent of trips, Uber calculated.

"While these reports are rare, every report represents an individual who came forward to share an intensely painful experience," it said.

"Even one report is

one too many."

Uber stressed that the figures also showed its drivers were attacked at about the same rate as passengers reporting sexual assault.

"Drivers are victims, too," it said.

While the report is confined to Uber's biggest market, the company faces complaints worldwide that it is doing too little to protect passengers.

In London, Uber fatal assaults related has lost its license after transport authorities said the company had failed to fix a litany of safety issues -- including at least 14,000 cases of drivers handing their permits to unlicensed friends or relatives.

Uber continues to operate in the British capital pending an appeal.

In France, the firm is under pressure from a viral campaign detailing sexual assault involving its drivers, under the hashtag #UberCestOver (Uber it's over).



R. Kelly faces new bribery charge in Brooklyn criminal case

NEW YORK (Reuters) - Federal prosecutors in Brooklyn on Thursday unveiled a new criminal charge against singer R. Kelly, accusing him of arranging to bribe an official as part of a scheme to recruit underage girls for sex.

The 52-year-old R&B singer, known for such hits as "I Believe I Can Fly" and "Bump N' Grind," was arrested in Chicago in July on separate sets of charges brought by federal prosecutors in Brooklyn and Chicago. He has pleaded not guilty.

The new charge came in an indictment unsealed in the Brooklyn case. Prosecutors said that in 1994, Kelly caused another person to offer a bribe to an official to create a fake identification document for a person identified by the pseudonym "Jane Doe #1."

The indictment did not say whether the bribe was actually paid or the document created. It also did not accuse Kelly of sexually abusing Jane Doe #1.

A lawyer for Kelly could not immediately be reached for

The singer, whose full name is Robert Kelly, is scheduled to go to trial in Brooklyn in May 2020. He has been jailed in Illinois since his arrest.

Kelly had denied abuse allegations for decades before the latest charges. In 2008, he was tried on child pornography charges and found not guilty.

The Brooklyn prosecutors have charged Kelly with racketeering, accusing him and his entourage of inviting women

and girls backstage after concerts, keeping them from friends and family and making them dependent on him financially.

The Chicago prosecutors said Kelly had sexual contact with five minors and recorded sexually explicit videos of some of them. They also accused Kelly of obstructing justice by using threats and bribes, including payments of hundreds of thousands of dollars, to keep his victims quiet.

A trial in Chicago has been scheduled for April 27.

In addition to the two federal cases, Kelly is facing charges from state prosecutors in Illinois and Minnesota. He has pleaded not guilty to those charges as well.
