The Sikkim unit of I the Bharatiya Janata Party has expressed gratitude towards Prime Minister Narendra Modi for giving more than Rs One lakh crores to Sikkim by way of development funds in different sectors over the last four years. enters eighth day

JAIPUR, FEB 15 (PTI): Gujjar community members continued to block railway tracks in Rajasthan for the eighth consecutive day on Friday despite the state government releasing a notification to give 5 per cent reservation to them and four other communi-

ties agitating for it.

State tourism minister Vishvendra Singh and representatives of the Gujjar community are holding discussions to end the deadlock, Station House Officer of the Malarna Dungar police station Brijendra Singh said. The ongoing dharna led by Gujjar agitation leader Kirori Singh Bainsla on railway tracks and a blockade laid on highways has caused much inconvenience to people. As per the North Western Railways spokesperson, 64 trains have been cancelled, 71 diverted and 32 partially cancelled in the last eight days.

Bainsla and his supporters began their sitin on railway tracks in Malarna Dungar area of Swai Madhopur district on February 8, demanding 5 per cent quota for Gujjar, Raika-Rebari, Gadia Luhar, Banjara and Gadaria communities in

jobs and education. The Rajasthan Assembly on Wednesday passed a bill giving 5 per cent quota in government jobs and educational institutes to the Gujjars and four other communities agitating for it. The Gujjar agitators are sitting on Mumbai-Delhi railway track near Malarna Dungar and Sawai Madhopur-Jaipur rail track at Chauth Ka Barwara in Sawai Madhopur district.

ASDTF mediates with NHPC on behalf of contractual drivers

↑ ll Sikkim Democrat-**A**ic Transport/Drivers Front [ASDTF] has mediated on behalf of contractual drivers engaged with the NHPC on grievances raised by the drivers during a meeting with AS-DTF executive members a few days back.

The NHPC management, a press release informs, has agreed to increase allowances for meals during outstation tours, allowing one-third of the drivers to simultaneously stay on leave during public holidays, salary for an additional driver for ambulances, increase in period of agreement from 4 years to 5 for the owners and drivers of deputed vehicle, full salary for drivers during times of acci-



dents, and induction of all vehicles into NHPC through driver associations of Singtam, reducing working hours for drivers after the renewal of the vehicles.

These were decided at a meeting between an ASDTF delegation headed by state in-charge GM Gurung and General Manager of National Hydropower Corporation, Sahadev Khatua, at the latter's office.

At the meeting, Mr Gurung also appealed to the management to handle local employees, drivers with more respect, immediately extend medical facilities to 700 workers.

The meeting was also attended by Senior Manager Sanjeev Kumar, HR Head Pravesh Kumar from NHPC along with Sandeep Chettri, Tinku Adhikari, Tenzing Sherpa among others from ASDTF.

Students unions to begin campaign against Modi govt

CHENNAI, FEB 15 (PTI): A pan-India students and youths organisations' collective-Young India National Coordination Committee (YINCC) has said it will begin campaigns next month across the country to vote BJP out of power for "ditching" the student community.

The body, consisting of 42 students and youth organisations, includes students' unions of Jawaharlal Nehru University, New Delhi, Aligarh Muslim University, Allahabad University and Rajasthan University.

JNU Students Union President (JNUSU) Sai Balaji said the collective would begin campaigns across the country from next month (March), in the run-up to the Lok Sabha elections.

"The present government has clearly ditched us in several ways and we have been bearing the brunt of it. This campaign is also to vote the BJP out of power," Balaji told PTI during an interaction.

Last week, thousands of students and youths of the collective took out a march in the national capital from Red Fort to Parliament Street demanding jobs and better educational opportunities.

"To any new government, our demands would be to fill all vacant posts in the government, offer an education loan waiver," Balaji said, referring to a charter released by YINCC.

The charter demands allocation of at least 10 per cent on education in the budget, ending the practice of alleged seat-cuts in universities, fee hike, reservation-cut in higher educational institutions.

"End gender discriminatory rules, ensure academic freedom and freedom of expression on campuses, fulfil constitutionally-mandated reservations," it said.

ence here today, SSS coordinator Passang Sherpa stated that his organisation strongly condemns such a controversial statement by the Principal Secretary to refer to an Old Law of Sikkim as redundant.

He questioned how a bureaucrat could make a comment like that about Old Laws of Sikkim.

"Bureaucrats should not comment on such matters,"

He mentioned that the matter if extending Companies Act 2013 to Sikkim was still pending with the Ministry of Corporate Affairs and that the Ministry has sent around ten reminders to the State Government in 2018 alone seeking its view on the matter but received no response.

Mr Sherpa inferred that political leaders were now sending bureaucrats to pass remarks that an old law was not relevant.

"We want political parties of Sikkim to take up this important issue and live up to their claims of safeguarding old laws of Sikkim but their silence on this issue shows they are only after vote banks not real issues. So we are compelled to take up this issue in the interest of the people of Sikkim," Mr Sherpa said.

GUWAHATI, FEB 15 (PTI): Assam Chief Minister Sarbananda Sonowal Friday urged the people of the state to cooperate in the hearing process of National Register of Citizens (NRC).

Hearings for the claims and objections regarding the NRC updation began in 1436 centres across the state during the day, officials said.

The chief minister asked all officials engaged in the work to ensure smooth completion of the hearing process of claims and objections as an error-free NRC would make the implementation of Clause 5 of Assam Accord possible, he said.

Chairing a meeting here to discuss various issues connected to the claim and objection process during the NRC updation, Sonowal said the process for preparing an which has lapsed.

error-free citizens register has been going on under the direct supervision of Supreme Court in which both the central and state governments have extended support.

Names of 40.37 lakh people were not included in the final draft of NRC which was published on July 30, 2018. Out of them 36.28 lakh people have claimed for inclusion and another two lakh have registered their objections.

In a statement Sonowal appreciated the peaceful environment maintained by the people during the publication of the first and the finals drafts of the NRC and appealed for maintaining it during the hearing process of claims and objections.

The state had been witness to large-scale protests against the Citizenship Amendment Bill.

Centre garners Rs 12,000 crore GST from Bengal till Dec

KOLKATA, FEB 15 (PTI): divarai G V said on the The Centre has raked in some Rs 12,000 crore from West Bengal during the current fiscal till December as its share from the Goods and Services Tax from the state and expects to exceed the target of Rs 18,000 crore by March 2019, a revenue official said Friday.

"The CGST share target for the FY19 was Rs 18,000 crore and till December we have already collected Rs 12,000 crore. We hope the target may get exceeded by March," assistant commissioner of CGST, Pan-

Tax expert T B Chatterjee said GST is a great step but was introduced without training of officials.

RBI lifts cap on FPI investments in corporate bonds

MUMBAI, FEB 15 (PTI): The Reserve Bank of India (RBI) Friday withdrew the 20 per cent limit on investments by FPIs in corporate bonds of an entity with a view to encourage more foreign investments.

As part of the review of the FPI investment in corporate debt undertaken in April 2018, it was stipulated that no FPI should have an exposure of more than 20 per cent of its corporate bond portfolio to a single corporate (including exposure to entities related to the corporate).

While the provision

was aimed at incentivising FPIs to maintain a portfolio of assets, market feedback indicates that foreign portfolio investors (FPIs) have been constrained by this stipulation, the RBI said.

"...in order to encourage a wider spectrum of investors to access the Indian corporate debt market, it has been decided to withdraw this provision with immediate effect," the central bank said.

The RBI said the directions in this regard have been issued the Foreign Exchange Management Act.

Total prohibition in Mizoram from April

The Zoramthanga government in Mizoram will impose total prohibition in the state from April this year, state Excise and Narcotics Minister K Beichhua said Friday.

The Mizo National Front (MNF) government, which came to power in December 2018 after deseating the Congress, had promised total prohibition in its election manifesto like the other opposition parties in the face of stringent demands for it by the church, which has a big presence in the Christian majority state.

The government has been drafting a prohibition law which is likely to introduced in the state assembly in March during the budget ses-



sion, officials said. Prohibition had been force in the north eastern state since February 20, 1997 when the former chief minister Lal Thanhawla

came to power heading a Congress government.

The earlier MNF governments of Zoramthanga which was in power from December 1998 to December 2008 had abided by it. Thanhawla had, however, eased the stringent prohibition law by legislating the

Mizoram Liquor (Prohiallowed to purchase lim-

bition and Control) Act, 2014. The Act had come into effect from January 15, 2015 under which liquor card holders were

ited amount of liquor from wine shops, which were opened for the purpose.

An official statement Friday said that Beichhua has appealed to all concerned officials to be prepared to successfully enforce the prohibition as they would otherwise become the target of NGOs, churches and opposition parties.

The state government would work together with the civil societies and the churches to combat the menace of drugs and alcohol and all the vacant posts in the excise department would be filled up expeditiously to enforce the total prohibition, he said at the general conference of the Mizoram Excise and Narcotics Service Association (MENSA).

Regional parties wasted Central funds in Sikkim: Cong

ll India Congress Committee [AICC] general secretary incharge North Eastern States [excluding Assam], Luizinho Faleiro, today contended that the Centre has provided substantial funds to Sikkim over the last 43 years, but governments of regional parties have not been able to convert it into tangible development. His clear indication was to the fact that Sikkim has elected only regional parties to office, political choices he blames for what he sees as the lack of adequate development and progress in the State.

Addressing a press conference here today, Mr Faleiro stated that responding to the aspirations of the people of Sikkim, Congress has been working towards uniting all opposition parties of

He added that the party was open to all and was in touch with SKM and HSP to explore alliances.

However, he added that in case no coalition came about, the party was ready to go it alone in elections and contest from all 32 seats.

He informed that the party has asked its dis-



trict level committees to identify potential candidates and submit a report to the state committee. He stated that the party would reach out to every household of Sikkim.

Mr Faleiro claimed that the UPA government had provided much development and progress to Sikkim but those did not transform to reality. He alleged that the SDF government has taken Sikkim backward.

He further alleged that loans of crores of rupees taken by the State government have not produced any results and the State still depends on imports for food grains. He further alleged that Sikkim has the highest loans debt, suicide rate

which need to change for the better.

Mr Faleiro stated that the Congress has always respected the unique identity, culture and traditions of Sikkim and provided special provisions for the safeguard of Sikkim and the interests of its people.

He also argued that the biggest threats to Sikkim were the Prime Minister and RSS which have been trying to destroy the unique identity, culture and traditions of Sikkim and the north-eastern region.

Mr Faleiro criticised and condemned SDF party and its MP, PD Rai, for having supported the Citizen Amendment Bill.

It was also informed that Sikkim Pradesh Conhad convened a meeting at its party office on Friday which was attended by Mr Faleiro and Pradyot Deb Barman, AICC observers for Sikkim, and state president Bharat Basent and other leaders of SPCC.

The meeting discussed different issues of Sikkim and passed resolutions and also observed a one-minute silence in the memory of Pulawa blast victims.

The meeting passed a resolution to thank the AICC president Rahul Gandhi for his strong decision on not allowing the Citizenship Amendment Bill to pass in the Parliament and for announcing a unique Minimum Income Guarantee

SHILLONG/RANGIA, FEB 15 (PTI): A day after a clash broke out between villagers and Assam Police personnel in disputed Langpih area, Meghalaya Chief Minister Conrad K Sangma on Friday said the situation was normalised there.

Talks between the two states on the matter have started, though prohibitory orders under Section 144 CrPC was imposed in Langpih as a precautionary measure by the authorities in Meghalaya. A report from Assam quoting police in Kamrup district said seven persons, including five police personnel, were injured in the clash on Thursday and two people were detained.

Langpih - or Lumpi, as it called in Assam - has been a bone of contention between the two north-eastern neighbours for decades. Meghalaya claims it to be part of West Khasi Hills district, while Assam asserts that it falls under

its Kamrup district. "The situation was normalised but four people were injured and two people were arrested," Meghalaya Chief Minister told reporters in Shillong.

He said, "We have immediately spoken to the Assam. West Khasi Hills district SP has informed the matter to the SP of the other side. They have discussed it and I think the two people will be released."

During the sub-divisional officer of Mawshynrut area has promulgated section 144 CrPC in Langpih as a precautionary measure following the clash, officials said. The clash took place at Umawali village near Langpih on Thursday when the Assam Police tried to stop work for electrification there and arrested two persons, a senior officer of Meghalaya Police said.

"They said the area falls in Assam. When the villagers protested and started pelting stones, the Assam policemen resorted to lathi charge and, in the process, four persons were injured," he said. Jogendra Barman, Officer-in-Charge of Boko police station in Kamrup district of Assam, said labourers working under a contractor were illegally engaged in electrification work at Lumpi claiming that the area belonged to Meghalaya.

People of Lumpi tried to stop the workers who then attacked the locals, Barman said. A police team reached the spot on being informed but unidentified people from Meghalaya pelted stones at them injuring one assistant-sub-inspector of police and four constables, the OC said.

DSP Kalyan Pathak and Barman himself then went there with more personnel and controlled the situation after resorting to a lathi charge, Barman said adding that two labourers were detained for interrogation from the spot where policemen and CRPF personnel were deployed.

The Meghalaya chief minister said the government is trying to ensure that development reaches to the people and status quo is maintained.

He said a "very strong" communication has been sent to the Assam government on the matter. Sangma, however, said such incidents keep on happening from both sides.

The Indomitable History of Gastroenterology at STNM Hospital

Thirty-four years ago, a dire need was felt to start Endoscopic procedures to intervene during gastrointestinal bleed and the complications induced by alcohol or otherwise in a society where alcohol use is socially and culturally accepted.

Hence, on 02 October 1985, the Department of Gastroenterology was established at the STNM Hospital under the able stewardship of Dr. MR Kotwal, MD, who was then a Medical Specialist. After a brief training and with a small dedicated team, he ventured into the intra-luminal diagnostic procedures and to think the Endoscopic machines were primitive in yonder years.

Dr. Kotwal's foray into the diagnostic Endoscopic invasive procedures 34 years back brought in an avalanche of changes in the management of gastrointestinal diseases leading to a definite curtailment in referrals outside the state. In this period, he managed to publish many international studies on Gall stones and Gall bladder diseases, Gastro esophageal reflux diseases and many more.

In the latter half of 2005, after my specialized training in Gastroenterology, I joined the Gastroenterology team. By then the department was equipped with Olympus Evis Exera 160 series machine, the latest for that era and we are still using it.

Unfortunately, in 2008 Dr Kotwal decided to hang his gloves and move on. We had to carry on and we did prevail. It was felt that the Unit should take further initiation in starting Therapeutic Endoscopic procedures. So with the permission of the competent

with sclerotherapy for esophageal varices and hemorrhoids. With the passage of time, we introduced Esophageal Variceal band ligation at a very low cost compared to the mainland India. It was a watershed era where bleeding upper and lower gastro intestinal patients were not referred outside the state to Siliguri or elsewhere. There was a drastic reduction of referrals lessening the burden to the Government exchequer. Other basic procedures for Gastric and Duodenal ulcers, Carcinoma diagnosis, foreign body removals continued. Balloon Dilatation of Gastric Outlet Obstruction, Esophageal dilatation with Savary Gilliard dilators for Achalasia Cardia was initiated, though

palliative. In 2009, we felt that Viral Hepatitis infection was not being addressed to properly. So a protocol-based treatment and management was initiated for Viral Hepatitis B and C infections. This intervention too curtailed the referrals outside the state which was a prevailing practice. We started with Nucleotides and Nucleosides therapy for Hepatitis B infection and for Hepatitis C infection although very expensive we had to use Pegelated Interferon, the cost which ran over lakhs of rupees but the Government was philanthropic to reimburse the cost to the patients. As the years have passed on, newer, novel and cheaper drugs are available and patients are being managed. It would be appropriate to declare here that a National Programme, National Viral Hepatitis Control Programme is being launched in coming months and the STNM Hospital Gastroenterology department is designated as the Model

authorities we initially started Treatment Center for the State with sclerotherapy for esopha- of Sikkim.

It was about this time with the help of Corporate Social responsibility we were able to lease a Fibro scan machine to the State. Fibro scan evaluates the liver stiffness to assess the liver damage. We screened over 4000 individuals under the SILVER programme (Sikkim's initiative on Liver Diseases) all over the state over a period of 2 years.

Since the formative years intestinal worm infestation was a big menace. But over the years it has gradually decreased to once in a while finding in endoscopies which reflects the holistic inter and intra departmental work done in the State.

In the latter half of 2010 the department was provided with the state of art Endoscopy machine Olympus Evis Exera 180 series with a Narrow Band Imaging. NBI is a special feature where in early cancerous mucosal changes can be detected in esophagus. stomach and the intestines. So the families with the history Gastric and Colonic cancers were motivated for screening and are still being screened . However as a team we have to emphasise and convince the society to screen themselves for early cancerous lesions. Information, Education and Communication has yet to be strengthened in this field.

Team Gastro continued introducing more therapeutic procedures and continued with small polypectomies, fundal glue applications, foreign body removals, luminal dilatations. We were the first in North Bengal and Sikkim to start palliative esophageal metallic Stenting without the luxury of a fluoroscopy x ray machine. It is a humble feeling to be able to

bring respite to those suffering from end stage diseases.

We as a Department have been evolving despite financial crunch, machines breaking down for months together. However these set back did not deter us from evolving more. We started addressing to large and small bowel disorders like Malabsorbtion syndromes, Celiac disease, Tropical Sprue, Crohns disease, Ulcerative Colitis, abdominal Koch's and the rest.

Now the additional good news is that more members from the Gastroenterology fraternity will be joining us in the New Multispecialty STNM hospital. The Gastroenterology Department is now equipped with a large well designed Endoscopy suite with latest state of the art machines that can be availed. In addition to the procedures already being done we intend to start other procedures like ERCP (endoscopic retrograde pancreaticogram), cholangio Colonic Stenting, PEG etc

The vision for the years to come with the support and guidance from the Government we hope to move on to newer frontiers in Gastroenterology like

- Fibroscan : study elasticity of the liver
- 2. Capsule Endoscopy: study the entire bowel particularly the small intestine
- 3. Endoscopic Ultrasound : a diagnostic as well as therapeutic procedures
- 4. Esophageal manometry5. Eventually third space endoscopy : example

Death Due to Disengagement

When a society refuses to engage, the shocking becomes the new normal

Suicides have become so frequent, and the general response to them so uninvolved that this newspaper has stopped reporting on suicides on a day to day basis, fearful that the commonplace nature of such deaths will convince those contemplating such ends that this is a "normal" means to opt out. But there is nothing normal about a suicide. It is a traumatic experience for everyone touched by it - the victim, the families, the friends and even the police personnel who have to recover the bodies and draft reports about the incident. Why, even journalists who have to report on these incidents are left disturbed. Why then is it that suicides do not figure in public and political discussions? Is it not worrying that something which can be addressed and is yet allowed to take away so many lives from Sikkim's midst is not attracting the attention of leaders beyond the occasional lip-service?

Speak to any cop, especially the ones posted at the more remote out-posts where they respond more to recover bodies of suicide victims than law & order situations, bringing down limp bodies of lives that could have been saved and one does not sense disinterest from the routineness of the matter but a frustration over why lives end in this manner so often in Sikkim. They return to this thankless task every day, reporting to their beats knowing that their policing of yesterday has made no dent in the nexus of disinterest and insensitiveness that spawns suicides in Sikkim. What is worse, the society at large is not only disinterested, but also complacently dismissive, reading of social challenges like suicides and drug busts with shallow comments of this being caused by corruption and materialism.

This is a dangerously uninvolved attitude. These are social challenges, situations that need to be met with social engagement and supported by a political will which creates the enabling laws and environment to redress the situation. Those who pass superficial judgements, blaming these societal trends on law & order failures and not the society, are causing perhaps even more damage than the indifference with which the community at large is responding to the challenges. Among all the factors that sustain substance abuse, societal indifference contributes the most. Suicides in Sikkim manifest in the failure of adequate awareness, or even interest, about mental health. Economic destitution has not claimed lives here yet. Lives are being lost and put in harm's way because a civil society refuses to come together in Sikkim.

Community engagement, when genuinely crafted, automatically leads to spontaneous involvement. And one is referring here not only to substance abuse and suicides. Look at how consistently mute the people and their organisations have remained in Sikkim in the face of every situation that has confronted the State. There is neither any spontaneity in jubilant celebrations nor any instinctive revulsion when misfortune comes visiting. The only voices that find comment indulge in rounds of condemnations and counters and are exclusively politically inspired. The lay citizens remain aloof because they have not cobbled together organisations which are not only not politically compromised, but also neither forceful nor forthright. In this vacuum, issues are manufactured and forced on the people and genuine problems remain unaddressed. Also manifesting because of this involvement deficit are social challenges which grow ever more staggering and confounding. Superficiality and token gestures do not solve any problem, and the situation with suicides is much too pervasive to even be called a "problem" any more - they have become the new normal for Sikkim. Unless the society invests some real involvement, this "normalcy" will keep getting worse and the State the poorer.

And no, don't look at the government to solve this problem. It cannot do so on its own because those who are harm's way are around families and their immediate circle of friends and only they can catch the warning signs in time. The government could help by arranging proper awareness and access to experts, but it will have to be the lay people who walk the way to help and encourage others to do the same. Given how things have been, even the first step has not been taken. As a result, by the time you finish reading this, chances are, that a panic call has gone through to another police outpost reporting an unidentified body found hanging in a neighbourhood somewhere in Sikkim...

Too much screen time linked to an epidemic of myopia among young people

Ask anyone about the benefits of technology and it probably won't take them long to rhyme off a list of examples: it helps broaden your knowledge, connect with friends, both new and old, and allows you to see things you've never seen before.

But what about the drawbacks? Here's a major one: increased screen time is hard on your eyes.

In fact, more and more young people are wearing glasses to correct their nearsightedness. This trend has prompted optical health experts to determine if the use of electronic devices such as computers, tablets and smart phones is leading to a deterioration in sight that is reaching epidemic proportions.

Let's take the example of Pauline although she could just as easily be a David or a Jason. She is 10 years old and a studious child, doing well in school. Like any young person her age, she loves to use her tablet computer to study or have fun. She's on it two hours a day, plus weekends.

Pauline may be in for a change, however. She has recently been diagnosed with nearsightedness and her optometrist has strongly recommended that she — and her parents — limit her use of electronic devices and spend more time playing outside.

Pauline isn't happy. She thinks it's

But her case raises the question: what is the link between the use of electronic devices and the appearance of myopia?

A PUBLIC HEALTH ISSUE

Forty per cent of North Americans are affected by myopia. The number of cases doubled between 1972 and 2004 and continues to grow at a rate that qualifies the phenomenon as an epidemic.

In Europe, myopia is prevalent among 42.2 per cent of adults aged 25 to 29 years, almost twice that of adults aged 55 to 59 years.

This suggests there is a real public years, is being closely examined. health issue facing us — and not just the common problem of an error in the refraction of the eye which shows up as blurred vision when looking into the distance.

In fact, high amounts of myopia significantly increases the risk of major ocular health disorders such as retinal tearing (21 times greater), glaucoma (40 times) or cataracts (six times).

An eye that becomes short-sighted becomes longer. The stretching is proportional to the increase in myopia. The more the eye stretches, the more the retina, which lines the inside of the eye, becomes thinner. Symptoms such as cracks, abnormal development of subretinal blood vessels and bleeding may appear.

Ultimately, the very nearsighted patient has a more than 50 per cent risk of spending the rest of his or her life legally blind — in other words living with vision reduced by 60 per cent. This means that the length of their eye exceeds 28 mm (the normal length is 23 mm) or that the myopia levels exceeds six diopters. (Diopters is a unit of measurement used to calculate eyesight — the further away from zero indicates a worsening in vision.) It is important to intervene before this happens to avoid these levels.

(In Canada, legal blindness is defined by a visual acuity of less than 20/200 in the best eye with the help of glasses or contact lenses. A legally blind person therefore sees, at best, 20 times worse than a person with normal acuity.)

WHAT'S BEHIND THE EPIDEMIC?

There are many causes of onset myopia. Genetics plays an important role but epigenetics — the environment in which the child evolves — is a more important factor.

And what has changed in our environment to explain the recent myopia epidemic? The impact of technology, which has seen a boom in recent

For example, a rapid increase in visual problems has been noted since the introduction of the smartphone in 2007. While the device itself does not emit harmful radiation, it requires the user to read its screen at a distance of 20 cm rather than the normal distance of 45 cm to 50 cm. It has been suggested that this close distance boosts the risk of developing myopia by eight times, especially if both parents are myopic.

Ambient lighting also plays a role because the use of fluorescents, such as in classrooms, also promotes myopia. When a tablet is used in such an environment, the effect is multiplied tenfold.

Unlike books printed on paper, tablet and computer screens are optically associated with so-called chromatic aberrations. The shortest wavelengths (blue light) are perceived in front of the others by the eye, which generates a myopia stimulus. There is a dose and response effect here, suggesting that prolonged use leads to more negative effects.

Today's young people don't play outside as much as their predecessors and are heavy users of electronics. However, exposure to daylight has a protective effect against myopia. These beneficial effects are decreased, but not negligible, during less sunny months or when myopia is already present.

POSSIBLE SOLUTIONS

The purpose of myopia treatment is to reduce the rate of progression of the dioptric, but above all to slow down the elongation of the eye. If, obviously, we cannot play with genetics, it is imperative to influence epigenetics and therefore the environment in which the child evolves.

Therefore, using any electronic media before the age of two should be avoided, even if it's only for a few minutes. A limit of one hour per day should be the rule for those between two and five years of age and

the emphasis should be put on educational sites or applications that promote interactions between the parent and child.

While school requests should be taken into consideration, the use of electronic media should continue to be limited as the child gets older. A maximum of one hour, besides school work, must be observed for good eye health. A two-minute break after every 30 minutes of device use will also lessen harmful effects and exposure to a device should be avoided at least one hour before sleep.

Children should also get a minimum of 45 minutes of daylight per day. They can get this by walking to school or participating in such activities as regular outdoor sports.

The next step is to ensure the co-ordination of both eyes, from far away but especially close up. An optometrist will need to perform an orthopic check-up and correct, by exercise or optical means, any anomaly that may have been detected.

Finally, optical correction must be chosen with the goal of slowing down the progression. In rare cases, glasses with anti-myopia lenses may be prescribed. They provide a deceleration rate of about 30 per cent. Specialized contact lenses are often preferred and offer control ranging from 50 per cent to 80 per cent. The contact lens treatment is available from the age of seven, and will be periodically reassessed according to the child's changing needs.

In short, myopia is not just a commonplace vision defect. It is a significant risk factor for serious eye disease. We must therefore do everything possible to slow its progress and protect our children's vision and that means also reviewing their relationship with electronic devices.

Polar bear 'invasion': how climate change is making human-wildlife conflicts worse

The ten hottest years on record were all during I the past two decades and the hottest global ocean temperatures ever were recorded in 2018 - a heat increase from 2017 equivalent to 100 million times that of the Hiroshima bomb. Climate change is here and it's already wreaking havoc.

The polar bear – something of a poster child for climate change - is just one of countless victims in this warming world. It's thought that if global temperatures continue to rise by an average of 4.5°C since pre-industrial times, which is likely to happen if we do nothing to reduce our carbon emissions, half of the world's wildlife could be lost from Earth's most biodiverse places.

As ocean temperatures melt ice sheets – the hunting grounds of polar bears - these large carnivores have to search new areas for food, which is why 52 polar bears "invaded" a Russian town in February 2019, looking for their next meal. Locals were frightened to go outside – with good reason: polar bears can, and do, hunt people.

Unfortunately, climate change is only going to make these negative interactions between humans and wildlife more common. Already, while Australia heats up, wildlife is seeking refuge in towns. Kangaroos have swarmed human settlements in search of food and flying foxes have had to be hosed down by locals to stop them from overheating.

In southern Africa, more frequent droughts have meant thirsty elephants have raided villages to eat crops and pilfer water from storage tanks. Most wild animals are naturally averse to being so close to humans, so their incursions into our lives shows how desperate they are getting.

As climate change begins to take its toll on humans, by reducing crop productivity for example, we are likely to become less tolerant of these sorts of human-wildlife conflicts. Poor African villagers who have had their entire yearly crop destroyed by a herd of hungry elephants can hardly be blamed for wanting to get rid of the problem by killing the animals.

Sadly, elephants – like most other species – are already experiencing precipitous declines in their populations and this is almost exclusively due to human activities.

Climate change will exacerbate conflicts over natural resources between and within species ourselves included. For example, some observers have suggested climate change was partly responsible for the Arab Spring uprisings, as droughts forced people from rural areas into overcrowded cities and inflamed tensions. If conflicts within our own species can't be overcome, there is little hope for mitigating conflicts with other species - especially as resources become scarcer.

But there is a small glimmer of hope – there are effective methods to reduce damage caused by wildlife. Polar bears can be scared away from human settlements by flares and water tanks can be made elephant-proof. These technical fixes can help limit immediate conflict between wildlife and humans in the short term, providing much-needed relief in poor communities from the damaging effects of intruding wildlife.

Realistically however, technical fixes to human-wildlife conflict are only a temporary stopgap. To truly address the issue, we must focus on the root cause. Carbon emissions must be reduced - not only for the sake of wildlife but for the survival of humans too.

Wildlife habitat must be protected to ensure that species have space and food without needing to enter human settlements. Equally, societies must address their insatiable demand for natural resources, reduce overconsumption and excessive waste.

Much of this is easier said than done, of course. Without political will and sufficient funding all of this falls short. Global leaders must step up to the task - and it is partly up to ordinary people to pressure them to act. Movements such as the Extinction Rebellion and the school students organising global strikes against climate change are an encouraging start and must be built upon.

We need to cause an uproar like our lives depend on it - because they do. We have no planet B, as the refrain goes - and neither do the planet's 8.7m other species.

Two lynched in Meghalaya's village, another critically injured SHILLONG, FEB 15 (PTI):

Two persons lynched by an angry mob in Meghalayas West Garo Hills district and another was critically injured, police said Friday.

The incident took place at Chanangpara village after the locals were alerted about the suspicious movement of the trio in their car, they said.

A mob of over a 1000 people stopped the car and when they found weapons- a dagger and rods- inside the car trunk, the occupants of the car were fatally attacked leaving two of them dead and one seriously wounded, according to eyewitnesses.

While the victims ran to take shelter in the house of the Nokma (village chief), the crowd barged into the house and dragged them out before thrashing them.

One Mokibul Akond died on the spot while Mikseng Marak was declared brought dead at the Hospital, district Superintendent of Police M G R Kumar.

He said Akond had been charged in a kidnapping case earlier and police are now verifying if the other two also had any criminal antecedents.

The police team that arrived at the village could do nothing but retrieve the bodies of the three and rushed them to the nearest hospitals, according to the SP.

Borgohain, gold-medallist from the Indian Open last year, got the better of Australian Jessica Messina.

Basumatari endured a stiffer challenge in Bulgarian Melis Yonuzova before prevailing 3-2. She has Croatia's Marija Malencia coming up in the quarterfinals.

However, there was disappointment for the country's men with former Commonwealth Games silver-medallist Mandeep Jangra (69kg) and rookie Harsh Lakra (81kg) bowing out following opening round losses.

Jangra lost 0-5 to Ukraine's Viktor Petrov, while Lakra was beaten by Azerbaijan's Rauf Rahimov.

TMC leadership seeks report on security threat to MLAs, party leaders

KOLKATA, FEB 15 (PTI): In the backdrop of the killing of ruling TMC MLA Satyajit Biswas, the party leadership has sought reports from all district presidents about the threat perception of its MLAs and important leaders, Trinamool Congress functionaries said.

Apart from enhancing the security of MLAs, TMC district leaders also want official security for key people in the party organization ahead of the elections.

"We are preparing a report on the security status of MLAs in the district. We are preparing a separate report on our key organizational leaders who may not be MLAs or elected representatives but need to be provided security cover," a senior minister and district president of TMC told PTI, wishing not to be named.

The party leadership will finally submit a report to the state administration and police, and they will take a call on it.

TMC chief whip in the state assembly Nirmal Ghosh said most party MLAs have voiced con-



cern about their security and either appealed for enhanced cover or made their own arrangements.

"I am more cautious now and have taken steps to strengthen my security. I have also asked MLAs to be more careful," Ghosh said.

Biswas, the TMC MLA of Krishnaganj, was shot dead by unidentified assailants inside a

Saraswati puja marquee in Nadia district on Saturday evening. Biswas was gunned down in the presence of a host of party workers when he was climbing down the dais at a puja pan-

borders Bangladesh. There were allegations of complete lack of security at the scene of the crime despite the presence of the MLA and a minister.

A TMC MLA of South 24 Paraganas district was attacked by unidentified gunmen last year. The MLA escaped unhurt but two of his associates were killed.

Nadia district TMC president and MLA Gouri Shankar Dutta said he

was in discussion with local leaders for preparing the report.

Senior TMC leader and state food and civil supplies minister Jyotipriyo Mullick said enhancing security of elected representatives and party leaders is a must as they apprehend more such attacks in the run up to the Lok Sabha polls.

"The way the BJP

attacks, the TMC should take steps to check infighting in West Bengal's ruling party. "The BJP doesn't believe in politics of violence. In Bengal, it is the BJP which is at the receiving end of the TMC's reign of terror. Instead of blaming us they should take steps to control infighting," Ghosh said.

The TMC currently has 213 MLAs. The government also has the support of 18 other MLAs from the Congress and the Left Front who switched over to the TMC but are yet to resign as lawmakers.

Apart from the chief minister and ministers who are allotted Y+, Z and Z+ security cover depending on the threat perception, MLAs of the ruling and opposition parties are allotted 1-2 personal security officers (PSO) by the state government.

The TMC follows the practice of dividing each assembly constituency into 6-7 organizational areas, with a local leader being appointed incharge. "I need security cover for some of these leaders as they are valuable assets of the party," Mullick said.

Chelsea edge out Malmo as Arsenal suffer Europa League setback

PARIS, FEB 15 (AFP): Chelsea claimed a 2-1 victory at Malmo in the Europa League last-32 first leg to ease some of the pressure on beleaguered coach Maurizio Sarri, while Arsenal suffered a shock loss to BATE Borisov.

Visitors Chelsea desperately needed a response after back-to-back humiliating away losses, with last Sunday's 6-0 thrashing by Manchester City following a 4-0 reverse at Bournemouth.

Ross Barkley took advantage of a defensive lapse by the home team on Thursday to put Chelsea ahead on the half-hour mark, with Olivier Giroud adding a 58th-minute second before Malmo's late goal gave them a glimmer of hope ahead of next week's return match at Stamford Bridge.

Chelsea face Manchester United in the FA Cup on Monday, before facing City again in the League Cup final on February 24.

"I am happy because we played with confidence and it wasn't really very easy after the last match (the defeat by City)," Sarri told BT Sport.

"I think I am always confident but sometimes we had the wrong approach with matches so we need to be careful in every match.'

Sarri named a strong team, although he did leave Gonzalo Higuain and Eden Hazard on the bench.

Chelsea found themselves up against a spirited Malmo outfit in the first half, roared on by a vociferous home crowd, but kept the Swedes at arm's length before Barkley grabbed their first away goal of 2019. Pedro swung over a cross which



Lasse Nielsen should have headed away, but the defender failed with his attemped volleyed clearance and Barkley was on hand to control and stab into the net.

Uwe Rosler's Malmo piled on the pressure at the end of the half, but Barkley twice produced crucial headers at the other end to keep Chelsea in front.

But the Premier League giants took total control of the tie in the 58th minute

with a wonderful counter-attack.

Barkley led the charge before picking out Willian, and the Brazilian powered to the byline before cutting the ball back for Giroud to flick in a cool back-heeled finish.

The French striker has now scored five goals in six Europa League games this season, despite only netting once in 23 matches in domestic competitions.

But Malmo did grab the goal their ef-

forts deserved in the 80th minute, as Anders Christiansen slotted past Chelsea goalkeeper Kepa Arrizabalaga.

Coach Raman keen on improving Mandhana's 'patience'



MUMBAI, FEB 15 (PTI): India women's team opener Smriti Mandhana, who is in blazing form, said here on Friday that the team's coach W V Raman has set her targets to bat for a specific number of overs to develop her patience at the crease.

"He (Raman) has been telling me to play 30 overs in ODIs as he knows that if I bat till 30 overs, I will continue to bat. And in 20 over games he has been telling me to bat for 13 overs," the 22-year-old Mandhana, a Red Bull athlete, told PTI.

"He's giving me targets to bat a certain number of balls, because strike rate and those kinds of things never concern me, the only problem is the patience aspect. He is helping with that and giving me targets to bat through these many balls and that many overs and that is being great," said the left-handed batswoman.

Mandhana, asked specifically whether the team was too dependent on her, replied that the perception was not correct.

"No, I don't think so. We have got a lot of match-winners in our team. It is just that sometimes someone goes through a lean patch and you need to cover up for your teammate. And sometimes that would be the case, if I am not going, the middle order will look after me (help me).

"So you can't say that they (other batswomen) are too dependent, but I think the main responsibility as a batter is to win matches and dependence never comes (in the way)," she stressed.

During last year's women's T20 tri-series. Mandhana had said that she was throwing her wicket away after setting herself in.

Eleven months later, she feels that she is being able to improve 10 per cent on this aspect, but the next aim was to carry on batting till the end of the innings.

"Somewhat, yes, may be 10 per cent I have improved on that. From 50 to 60s, I have gone to 70s. But I'm still leaving 20-30 runs when we are chasing. I think it will be good if I come back not out. Hopefully I can do that against England in the (upcoming) ODI and the T20 series," she said.

"Im really excited (for the England series) and we are playing the ICC Championships and we need six points to be up there. Hopefully we will all stick together and win the ODI series (against England). I hope that I can win more matches for India," Mandhana remarked.

War kills over 100,000 babies a year: Save the Children



MUNICH, FEB 15 (AFP); At least 100,000 babies die every year because of armed conflict and its impact, from hunger to denial of aid, Save the Children International said on Friday.

In the 10 worst-hit countries, a conservative estimate of 550,000 infants died as a result of fighting between 2013 and 2017.

They succumbed to war and its effects, among them hunger, damage to hospitals and infrastructure, a lack of access to health care and sanitation and the denial of aid.

It said children face the threat recruited by armed groups, abducted or falling victim to sexual violence.

in the past two decades," said the charity's CEO Helle Thorning-Schmidt in a statement.

"The number of children being killed or maimed has more than tripled, and we are seeing an alarming increase in the use of aid as a weapon of war," she said on releasing the report at the Munich Security Conference.

Save the Children said a study it had commissioned from the Peace Research Institute Oslo had found that 420 million children were living in conflict-affected areas in 2017.

This represents 18 percent of of being killed or maimed, all children worldwide and was up by 30 million from the previ-

The worst-hit countries were "Almost one in five children Afghanistan, Central African Republic, Democratic Republic of never be targeted."

Congo, Iraq, Mali, Nigeria, Somalia, South Sudan, Syria and Yemen. The total number of deaths from indirect effects over the five-year period jumped to 870,000 when all children under the age of five were included, the charity said.

It also issued a list of recommendations to help protect children, from steps such as committing to a minimum age of 18 for military recruitment to the avoidance of using explosive weapons in populated areas.

Thorning-Schmidt said the rising number of child casualties was very worrying.

Bangladesh PM Hasina wants to retire to make way for young leaders DHAKA, FEB 15 (PTI): Bangladesh Prime Minister Sheikh Hasina, who won a historic fourth term, becoming the counlongest-serving leader, has indicated that she will retire after the current term to promote voung leaders, according

to a media report. In an interview with the German broadcaster Deutsche Welle (DW) 71-year-old Hasina, who assumed office just a month ago, for the fourth time as the prime minister, said she wanted to retire after the five-year term, the Bangladesh daily Dhaka Tribune reported. "It's the third consecutive term and before that I was prime minister (1996-2001), so it's my fourth term. I don't want to continue for more (time). I think that everybody should take a break so we can accommodate the younger generation," she said.

On Tuesday, at a cultural event in Gazipur, the prime minister said she would like to go back to her ancestral village of Tungipara in Gopalganj to spend her retirement, the daily said.

Hasina, the daughter of Bangladesh's founder Bangabandhu Sheikh Mujibur Rahman, won the 11th parliamentary elections in December last year with a landslide victory even as Opposition Bangladesh Nationalist Party rejected the polls marred with violence that claimed 18 lives, making it one of the deadliest polls in the country.

The Awami League chief was pitted against a united opposition Jatiya Oikya Front (United National Front) led by octogenarian Kamal Hossain, an Oxford-educated jurist and former foreign minister. Her arch-rival ex-premier and BNP hief Khalida Zia, who has been serving a 17-year sentence for corruption, was barred from contesting the polls.

Asked about her plans about the rest of her tenure, Hasina said the fight against poverty will continue to be her first priority.

"Food security, housing, education, healthcare, job opportunities; these are basic needs," she said, "Definitely, every human being wants a better life We have to ensure that."

China again says no to back India's bid to list JeM chief Azhar as global terrorist



BEIJING, FEB 15 (PTI): China on Friday expressed deep "shock" over the Pulwama terror attack carried out by a Jaish suicide bomber but did not give an assurance to India that it will back New Delhi's appeal to list the UN-proscribed Pakistan-based terror group's chief Masood Azhar as a global terrorist.

At least 40 CRPF personnel were killed and many injured on Thursday in one of the deadliest terror attacks in Jammu and Kashmir when a Jaish-e-Mohammad (JeM) suicide bomber rammed a vehicle carrying over 100 kg of explosives into their bus in Pulwama district.

"China has noted the reports of suicide terrorist attack. We are deeply shocked by this attack. We express deep condolences and sympathy to the injured and bereaved families," spokesman of the Chinese Foreign Ministry Geng Shuang told a media briefing here when asked about the incident.

In a carefully worded response to a number of questions on the Pulwama incident, Geng said China condemned the incident as part of its overall stand on terrorism.

"We firmly oppose and strongly condemn all forms of terrorism. We hope relevant regional countries will cooperate to cope with the threat of terrorism and jointly uphold regional peace and stability," Geng said.

Without directly referring to India's persistent demand to declare Azhar as a global terrorist, Geng said JeM has already been included in the sanctions list of the UN committee but he was not forthcoming on why China is opposed to extend the ban on the leader of the group.

When asked about China's stand on the listing of Azhar as a global terrorist by the UN Security Council, he said: "As for the issue of listing, I could tell you that the 1267 Committee of Security Council has a clear stipulation on the listing and procedure of the terrorist organisations".

"JeM has been included in the Security Council terrorism sanctions list. China will continue to handle the relevant sanctions issue in a constructive and responsible manner," Geng said in an apparent reference to External Affairs Ministry's appeal to all members of the UN Security Council to list Azhar as a global terrorist.

If Azhar is listed as terrorist by the UN Security Council, he would face a global travel ban and assets freeze.

China, a veto-wielding member of the UNSC and a close ally of Pakistan, has consistently blocked moves first by India and later by the US, the UK and France to designate Azhar as a global terrorist by the 1267 Committee by putting technical holds.

Asked whether China would be re-looking at the issue in view of the positive momentum in bilateral relations generated by last year's Wuhan summit between Prime Minister Narendra Modi and Chinese President Xi Jinping, Geng reiterated that: "IeM as an organisation has been included in the sanctions list of the Security Council.

"As to the listing of an individual, we have always upheld an earnest, responsible and professional manner. We always acted in accordance with the requirement of the situation. We will continue to maintain communication close with India and relevant parties on this issue". Replying to a ques-

tion on India not permitting UN Military Observer Group in India and Pakistan (UNMOGIP), Geng said: "Both India and Pakistan are important countries in this region. We hope the two countries can properly resolve (differences) through consultations. We also hope the regional countries can cooperate to uphold stability and peace in this region to curb terrorism".

Pak rejects India's charge on Pulwama terrorist attack



SAJJAD HUSSAIN ISLAMABAD, FEB 15 (PTI): Pakistan has condemned the terrorist attack in Jammu and Kashmir's Pulwama district and said it is a matter of grave concern even as it rejected India pointing out Islamabad's link to the incident without investigations.

At least 37 CRPF personnel were killed and five injured on Thursday in one of the deadliest terror attacks in Jammu and Kashmir when a Jaish suicide bomber rammed a vehicle carrying over 100 kg of explosives into their bus in Pulwama district.

Pakistan's Foreign Office, after keeping quiet for hours, issued a statement after midnight.

The attack in Pulwama in Jammu and Kashmir "is a matter of grave concern," it said.

"We have always condemned heightened acts of violence in the Valley," the FO said.

Pakistan also rejected that it was in any way involved in the attack.

"We strongly reject any insinuation by elements in the Indian government and media circles that seek to link the attack to the State of Pakistan without investigations," the FO added.

US asks Pakistan to immediately end 'support' and 'safe haven' to all terror groups

WASHINGTON, FEB 15 (PTI): In a stern message to Pakistan, the White House has asked Islamabad to "immediately end" its "support" to all terror groups and not to provide "safe haven" to them, as the US condemned the brutal Pulwama terror attack claimed the lives of at least 40 CRPF soldiers.

Pakistan-based Jaish-e-Mohammad (JeM) has claimed responsibility for the terror attack in Jammu and Kashmir's Pulwama district on Thursday that left at least 40 CRPF soldiers dead and five others critically wounded.

"The United States calls on Pakistan to end immediately the support and safe haven provided to all terrorist groups operating on its soil, whose only goal is to sow chaos, violence, and terror in the region," White House Press Secretary Sarah Sanders said in a late night statement on Thursday.

"This attack only strengthens our resolve to bolster counterterrorism cooperation and coordination between the United States and India," she said in a strongly-worded statement issued by the White House.

Sanders said the United States condemns in the strongest terms the heinous terrorist attack in Pulwama by a Pakistan-based terrorist group.

"We express our deep condolences to the victims' families, the Indian government, and the Indian people for the loss of life in this brutal attack," said the Press Secretary of President Donald Trump. Earlier. the US State Department said in a statement that it was "resolutely committed" to working with the Indian government to combat terrorism in all

"The US condemns in the strongest terms the terrorist attack today on an Indian Central Reserve Police Force convov in the Indian state of Jammu and Kashmir," State Department Deputy Spokesperson Robert Palladino said.

"The UN designated, Pakistan-based terrorist group Jaish-e-Muhammad has claimed responsibility for this heinous act. We call on all countries to uphold their responsibilities pursuant to UN Security Council resolutions to deny safe haven and support for terrorists," Palladino said.

Several US lawmakers also expressed solidarity with India in the wake of a dastardly terror attack and said the two countries stand united in condemning and defeating terror.

Cutting across party lines, over 50 Congressmen and Senators took to social media to express their solidarity with the people of India and called for strict action against the JeM terror outfit and its state sponsors.

"I strongly condemn the terror attack in Kashmir. The United States stands with our friends in India, and I send heartfelt condolences to the families that lost loved ones," top Democratic Senator Chuck Schum-

er tweeted. Democratic Senator Robert Menendez said he was outraged by the terror attack, "one of the deadliest in the region since 1989".

Republican Senator Johnny Isakson strongstrike and pleaged the US' support to India in defeating terrorism.

"Today, more than 40 Indian military police were killed by a radical Islamist terrorist group in the deadliest attack in 30 years on Indian forces in Kashmir. I send my deepest condolences to the soldiers injured and killed in this senseless attack, to their families, and to India, a critical ally in the global war on terror, said Republican Senator John Cornyn, Co-Chair of Senate India caucus.

"My heart is with the victims of the Kashmir Terror Attack. The United States stands with our Indian allies against those behind this heinous act of terrorism," Democratic Senator Mark Warner, who is co-chair of the Senate India Caucus and Vice Chairman of the Senate Select Committee on Intelligence, posted on Twitter.

Congresswoman and Democratic presidential candidate Tulsi Gabbard said, "We stand with the people of India in condemning the terrorist attack in Jammu & Kashmir, and send our condolences and prayers to the victims families. We must all stand up against these jihadists and their ideology. Heartbreaking. My thoughts are with the families of the victims of

heinous terrorist attacks

in Jammu and Kashmir today. We must confront terror and defeat it, wherever it occurs, Indian-American Congresswoman Pramila Jayapal said.





"But the WWE never held the women back. It was actually more of the fans not taking them very seriously. They wanted to see more male characters, many years ago. That's what they wanted. It was a male dominated sport," Paige told PTI.

The 26-year-old says things were dramatically different when she was in FCW (Florida Championship Wrestling).

"There were only five women there and 70 men. There was a lot of struggle but WWE believed in us so much."

Paige is considered a key figure in bringing 'women's revolution' in the ring, aided by her NXT Women's Championship in 2013 which gave a

platform to several other female wrestlers to show their talent. "When I got into the ring with the them, I wanted to prove myself and prove to the WWE, the fans and the male wrestlers that

the girls can have really good matches and sometimes even better," she says. "It was my kind of my mission from the get go to start doing that... A lot of the girls started to come out of their comfort zone and more female wrestlers were getting signed too. Now of course there's a revolu-

tion which is incredible," she adds.

Paige now has her life chronicled on the big screen in "Fighting With My Family", a rousing comedy about dreams and identity directed by Stephan Merchat, co-writer and co-helmer of the popular British sitcom "The

Office". The film shows how Paige, who was born into a tightknit wrestling family, is ecstatic when she and her brother Zak get an opportunity to try out for WWE but only Paige earns a spot in the competitive training programme and she must now leave her family and face the new, cut-throat world alone.

Paige says growing up in a family of wrestlers was "normal" for her but often people around her were left amused. "Zak and I have been surrounded by wrestlers our en-

> tire life. Everyone else thought it was a peculiar thing, it was kind of weird. But we didn't care. We loved wrestling and didn't care what people thought. That's also what the movie talks about: we didn't care about people's opinions," she says.

> The film features actor Florence Pugh as Paige and has been produced by Dwayne Johnson, aka The Rock, who also features in a special appearance.

> Johnson is by far the most popular WWE superstar, who branched out of professional wrestling and became a global name thanks to his blockbuster movies.
