#### BJP accuses Finance Dept of allowing Rs 44,260.13 cr to remain unclaimed

sued today, the party has said that the main reason behind the meeting was to submit a memorandum accusing the Department of "mismanagement and huge loss of public funds" amounting to Rs 44,260.13 crore by Sikkim Lottery.

According to the CAG

According to the CAG (Comptroller Auditor General) report, different marketing agents have not deposited a sum of Rs 44,260.13 crore to government treasury and no steps have been initiated by the State government


and the concerned department so far.

The party has alleged that the marketing agents are selected by manipulating the process and there is no transparency in the tender process. For tender process, they call the highest bidder for optimum revenue benefit and this negotiation and practice of the Department has deprived the revenue benefit to the state, it is alleged.

Marketing Agents who have outstanding liabilities or dues are being allowed to participate in bid, BJP alleges. The company Tashi Delek Gaming Solution was embroiled in a legal battle with the State Government due to default in payment but the company was still allowed

to participate in the bid.

#### The Inequality Index

Realities behind the smokescreen of surgical strikes and destruction on black money

Thile the nation was being distracted with pride over surgical strikes [the movie now] and spite vide tasteless references to power-cuts during Diwali, an economic miracle was underway. Yes, in a year during which the aftershocks of demonetization and the below-the-belt sucker punch of GST ensured that most of the country was so broken that wholesale price of onions could not even cover the storage costs billed for farmers, there were a privileged very few who laughed their way to the bank. In a vulgar reiteration of how far we have veered from the pretext of being a socialist state, arrived information that India's richest 1% mopped up 73% of the total wealth generated in the country in 2017. According to this new survey by international rights group Oxfam, the rich, who have always had it good in the easily co-opted governments of the past and through the years of liberalization, are clearly having even giddier days of profiteering in the current times of uber-nationalism and inyour-face majoritarianism.

Titled 'Indian income inequality, 1922-2014: from British Raj to Billionaire Raj?', a research paper by the two economists showed that income inequality in India was at its highest in 2014 since 1922, the year the country passed the Income Tax Act. The paper's findings are now in a full-fledged report, the World Inequality Report, published by the World Inequality Lab. According to it, 10% of Indians garnered 56% of the national income in 2014. To get some perspective, sample this - the top 1% of earners captured less than 21% of total income in the late 1930s, before dropping to 6% in the early 1980s and rising to 22% in 2014, the report reveals. In 2017, the richest 1% rolled up 73% of all earning in 2017! And here is some more context- the Oxfam report underlines that 67 crore Indians, comprising the population's poorest half, saw their wealth rise by just 1% in 2017. Our nationalist economists will see no problems in this figure and will point out that in comparison, globally, 3.7 billion people that account for the poorest half of population saw no increase in their wealth and that 82% of the wealth generated last year worldwide went to the top 1%

But that can be no consolation, right?

And in case you are veering towards that conclusion, last year's survey had showed that India's richest 1% held a huge 58% of the country's total wealth - higher than the global figure of about 50%. In 2017, the wealth of India's richest 1% increased by over Rs 20.9 lakh crore during 2017 - an amount equivalent to total budget of the central government in 2017-18! Here is some more context - In India, it will take 941 years for a minimum wage worker in rural India to earn what the top paid executive at a leading Indian garment firm earns in a year!!

Clearly, for inclusive growth, the nation needs labour-intensive sectors to be supported so that more jobs are created; agriculture needs to be incentivized so that existing strength and wider sections of the population benefit and social protection schemes need to be reinforced so that more people feel more confident to take risks. Take a look at the major policy interventions imposed on the country in the last three years and the maliciousness with which they undercut all the sectors mentioned in the previous sentence becomes apparent. Could this bloodletting in the unorganized sector and agriculture and suspension of subsidies have contributed to the windfall pouring into the income accounts of the nation's richest? Why did no one notice this earlier? Was the dazzle of nationalist posturing so dazzling that it blinded all realities away? It clearly did, but we are still not taking note.

## Rationality: research shows we're not as stupid as we have been led to believe

uppose you toss a coin and get four heads in a row - what do you think will come up on the fifth toss? Many of us have a gut feeling that a tails is due. This feeling, called the Gambler's Fallacy, can be seen in action at the roulette wheel. A long run of blacks leads to a flurry of bets on red. In fact, no matter what has gone before, red and black are always equally likely.

The example is one of many thought to demon strate the fallibility of the human mind. Decades of psychological research have emphasised the biases and errors in human decision making. But a new approach is challenging this view – showing that people are much smarter than they've been led to believe. According to this research, the Gambler's Fallacy might not be as irrational as it seems.

Rationality has long been an important concept

in the study of judgement and decision making. The highly influential work of psychologists Daniel Kahneman and Amos Tversky comprehensively showed that we often fail to make rational decisuch as worrying about a terrorist attack but not about crossing the road.

But this failure is based on a strict interpretation of what it is to be rational – obeying the laws of logic and probability. It is not interested in the machine that must weigh up the evidence and reach a decision. In our case, that machine is the human brain – and like any physical system, it has its limits.

COMPUTATIONAL RATIONALITY
Although our decision making falls short of the standards required by logic and mathematics, there is still a role for rationality in understanding human cognition. The psychologist Gerd Gigerenzer has shown that while many of the heuristics we use may not be perfect, they are both useful and efficient.

But a recent approach called computational

rationality goes a step further, borrowing an idea from artificial intelligence. It suggests that a system with limited abilities can still take an optimal course of action. The question becomes "What is the best outcome I can achieve with the tools I have?", as opposed to "What is the best outcome that could be achieved without any constraints at all?" For humans, this means taking things like memory, capacity, attention and noisy sensory systems into account

Computational rationality is leading to some elegant and surprising explanations of our biases and errors. One early success consistent with this approach was to examine the mathematics of random sequences like coin tosses, but under the assumption that the observer has a limited memory capacity and could only ever see sequences of finite length. A highly counterintuitive mathematical result reveals that, under these conditions, the observer will have to wait longer for some sequences to arise than others – even with a perfectly fair coin.

The upshot is that for a finite set of coin tosses, the sequences we intuitively feel to be less random are precisely the ones that are least likely to occur.



Imagine a sliding window that can only "see" four coin tosses at a time (roughly the size of our memory capacity) while going through a series of results – say from 20 coin tosses. The mathematics show that the contents of that window will hold "HHHT" more often than "HHHH" ("H" and "T" stands for for heads and tails). That's why we think tails will come after three heads in a row when tossing a coin demonstrating that humans do make sensible use of the information we observe. If we had unlimited memory, however, we would think differently.

There are many other examples of this kind, where the optimal solution, once cognitive limitations are taken into account, is surprising. Our recent work shows that inconsistent preferences – a cornerstone of supposed human irrationality – are actually useful when you are unsure about the value of options available to you. Traditional economic rationality suggests that a bad option that you would never choose (from a menu, say) should not have any effect on which of the good options you do choose. But our analysis shows that bad, and supposedly irrelevant options, allow you to get a more accurate estimate of how good the remaining alternatives are.

Others have shown that the availability bias,

where we overestimate the probability of rare events such as plane crashes, results from a highly efficient way of processing the possible outcomes of a decision. In short, given that we only have a finite amount of time to make a decision, it is optimal to make sure that the most critical outcomes

A DEEPER UNDERSTANDING

The perception that we are irrational is one unfortunate side effect of the ever growing catalogue of human decision-making biases. But when we apply computational rationality, these biases aren't

seen as evidence of failures but as windows on to how the brain is solving complex problems, often very efficiently.

This way of thinking

about decision making is more akin to how vision scientists think about vi-sual illusions. Take a look at the picture on the right. The fact that the A and B squares appear to be different shades (they aren't – see the video below) doesn't mean that your visual system is faulty, rather that it is making a sensible infer-

ence given the context. Computational rationality leads to a deeper understanding because it goes beyond descriptions of how we fail. Instead, it shows us how the brain marshals its resources to solve problems. One benefit of this approach is the ability to test theories of

what our abilities and constraints are.
For example, we have recently shown that people with autism are less prone to some decision-making biases. So we are now exploring whether altered levels of neural noise (electrical fluctuations in networks of brain cells), a feature autism, could cause this

With more insight into the strategies the brain uses, we might be able to tailor information in a way that helps people. We have tested what people learn from observing a long random sequence that viewed a sequence divided into s chunks (as we typically would in everyday life) did not benefit at all, but those that viewed the same sequence divided into much longer chunks rapidly improved in their ability to recognise randomness

So the next time you hear people characterised as irrational, you may want to point out that this is only in comparison to a system that has unlimited resources and abilities. With that in mind, we are really not so dumb after all.

### Brexit: Theresa May survives confidence vote, but Brussels is in charge now

Just 24 hours after suffering a historic defeat in parliament over her Brexit deal, the prime minister has survived a vote of no confidence in her government – thanks to the support of her backbench MPs. Up until this point, these same backbench MPs have been all too willing to vote against her and her Brexit deal.

The result was expected, given that a Conservative rebellion would have likely resulted in a general election that might have gone very badly for the party. Ousting the prime minister is less appealing when, instead of offering the potential for career advancement, there is a strong chance that it would instead lead to a demotion to

the shadow cabinet.

With the very public plotting and scheming that has been displayed over Brexit, it is little wonder that British people have become profoundly mistrustful of their elected representatives and their motivations. What happens next is therefore crucial not only for the prime minister and the country, but also the public's faith in the nation's democracy.

The way forward is not clear and many in the EU would like to

know just what it is the UK actually wants. In an attempt to find out, May has promised to consult with leading parliamentarians over the way forward. She has been criticised for not doing this sooner and, while it could perhaps throw up a fresh idea to move things forward, it is hard to see what assurances the prime minister or the European Union can give that would placate anyon RE-OPEN THE NEGOTIATIONS?

Realistically speaking the only way to get the major changes on the controversial issues would be to re-open Brexit negotiations with the European Union and extend the article 50 period. While there is some support for the latter, the former has not been an acceptable option on the continent for some time now. That doesn't appear likely to change.

suggested that parliament's dismissal of the deal will put the EU under pressure. They think Brussels will come back to the negotiating table once the screws are turned. But, as things stand, this looks like misplaced bravado and even wishful thinking.

To suggest that the defeat of the deal in parliament will somehow force the EU to waver is a perfect display of the flawed logic that created this the government may keep making parliament vote on the deal, or some version of it, until it passes, although the legality of this is now in question. If the deal cannot get through the Commons, there may be no other option but to leave without a deal.
Conservative MPs therefore need to either get behind the deal or resign themselves to endorsing a

no-deal scenario.

It is also decision time for Jeremy Corbyn and

the Labour Party. Having failed to win the vote of no confidence and force their preferred option of a general election, they too have to either get behind the deal or consign the country to a no-deal scenario. That said, there is of course the ever-controversial option of a second referendum Corbyn has resisted calls for this so far - but, with mounting pressure from MPs and the membership, as well as a desperate need for some distinctiveness on Brexit between the two major parties, it may prove hard to keep voting down the prime minister's deal without offering a viable



Having successfully showed their desire and ability to assert them-Having selves in the Brexit process in parliament, the MPs themselves may be the key to ending the deadlock. There is the looming threat that they will seize complete control of the issue, legislating to prevent a no-deal scenario from even being possible.

Given the historic defeat over the Brexit deal, it is not implausible that such a move could get the support it needs. However, if the EU refuses to budge on the deal or the timing of Brexit, it is again hard to see where this would ultimately lead. Despite claims that Brexit would allow the UK to "take back control", it still seems that it is the European Union that is very much in charge of the situation.

#### World Archery refuses to recognise recent AAI elections

PHILEM DIPAK SINGH New Delhi, Jan 17 (PTI): Archery's world governing body has refused to recognise the recent elections of the national federation, a development that might rein AAI's suspension and renew the administrative wrangling in the sport here.

The World Archery

(WA) informed B V P Rao who was elected president of the Archery As sociation of India (AAI) on December 22, that it does not accept the polls as they were conducted without approval from the General Body.

"...I regret to inform you that the World Archery Executive Board at stage cannot accept the outcome of the General Assembly held on 22nd December and your election as president as well as the rest of the Board...," the world body said in a letter.

The WA said that the decision was taken be-cause the constitution that was used to conduct the elections was "never formally approved" and only accepted by the returning officer.

'We ask you to provide us the full minutes General Assembly (of December 22) for verification of the above matter before 25th January 2019. Following the receipt of the minutes the World Archery Executive Board will take a decision on the pos-sible suspension of the Archery Association of India," the letter written by WA Secretary General Tom Dielen, added, The development meant that the AAI office-bearers elected on December 22 under the supervision of former Chief Election Commissioner of India S Y Quraishi, who was ap pointed administrator by the Delhi High Court, will not be able to select Indian archers for international events.

Rao, a former IAS officer, was elected as president of AAI in the contro-versial elections, ending Vijay Kumar Malhotra's four-decade long reign since 1973. The AAI was de-recognised by the

government in 2012.

The world body also asked Rao to inform it about any decision by the Delhi High Court on the matter. "We have also been informed that this matter has been raised to the High Court which will decide on this in February. We ask you to inform us as soon as possible on

the outcome," it said.

The IOA had sent a letter to Dielen this informing the world body that it does not recognise the elections held on December "The amended constitution that formed the basis of the basis of the election of AAI held on 22 December 2018 does not have the approval of the AAI General Body. Further the amended constitu-tion is not on lines with National Sports Develop-ment Code of India 2011," said the letter written by the IOA to World Archery

IOA informed that it did not send any observer to the AAI elections as it was not happy with the developments.

# Olympic hero Phelps says he was scared of water as a kid

**Мимваі, Jan 17 (РТІ)**: Не may have been the greatest swimmer ever whose exploits in the pool in-clude smashing almost all world records, but as a kid, Michael Phelps dreaded the water.

"I was somebody who was afraid to face the water as a kid, I guess I overcame that fear pretty fast," Phelps, the greatest Olympic athlete, said at an event organised by private equity fund Truenorth here late Wednesday.
Phelps, who has had

23 Olympic golds, including the record-making haul of eight at Beijing in 2008, said many children are like him, who are afraid of water, and that non-profit initiative started by him a decade ago has so far taught 30,000 children about swimming.
Speaking about the

2008 games, Phelps said he was programmed to be just perfect during the eight days of pool competitions, which included a strong focus on exactly how much he drinks swims, eats and sleeps.

Phelps recounted he had only 70 minutes between two competitions the 200-metre freestyle and anchoring the US team to a victory in the 800-metre relay - and had to manage a coolhad to manage down and a 400-metre



warm up for the next event after squeezing-in time for medal presentation for the first event.

"I just ran around the venue and made it in time for the start of the next race," he said.

He rewarded himself

with a break a life first when he had taken time off after the 2008 games but contractual commitwith sponsors made him return to competitive swimming

Phelps admitted that he was "faking it", not giving his best and under-lined that the results are there to see for everyone he won four golds at the London 2012 games.

Fall from sporting glory and some family issues led him into depression after the 2012 which included flirting with suicidal

thoughts as the purpose of living became difficult to find. A month of mental detox at a training centre later, he was back to water.

"I was able to just look at myself as a human be-ing. I think that was the first time I had been really able to do that. For so long, I thought of myself as a swimmer. I didn't look at myself as a per-son," he revealed, adding that for the first time, he was "vulnerable"

Having fought the mons, Phelps fodemons. cused on the next big task, the 2016 games in Rio de Janeiro, where he ultimately hauled five gold medals.

"It (the comeback) was for me. And that was the only reason I was coming back. I wanted to come back because I

wanted to finish on my terms, I wanted to retire from the sport and be able to hang up my suit the way I wanted to," Phelps said.

The only way to achieve this was the per-fection in training sought by his long-time coach Bob Bowman, he added.

Phelps said all through his career, he laid a strong focus on training, which included being in the pool for every single day for six years in the early 2000s, which gave him an edge of training 104 days more per year than his competitors

"I was willing to make that much more sacrifice as a kid because I had the chance to do something that nobody in history ever thought of or believed it was possible.

nobody else had the op-portunity on the planet and there was only one Michael Phelps," he said.

The swimmer said his coach put him through ing regimens, including working for any mishaps in water to ensure success and recounted one such tale of water seeping into his goggles in a race.

He said 25 metres into the 200-metre butterfly finals at Beijing, water seeped into the goggle and he became "blind". However, courtesy the preparations, he could swim the remaining 175 metres, including at least three turnarounds in the pool, by simply adjust-ing to the circumstances that involved counting the number of strokes, he said.

All through his career, Phelps said, he tried to be competitive, aim high

and never rest on laurels.

"As a kid growing up,
I wanted that feeling of winning an Olympic gold medal, breaking a world record and becoming a professional athlete By 18, I had accomplished all three," he said, adding that he continued despite all this till hanging up the suit after the Rio games in 2016.

"I despised losing in anything I did. I hate losing more than I like winning," he said.

# We want to change names in our country, not system: Emraa

Emraan Hashmi fails to see any "logic" in the now revised title of his film, "Why Cheat India" and the actor believes the move reflects a mindset in the country where people are more invested in changing names and not the system.

They have passed the title for the promos and I thought after watching the film they'd realise it's even more relevant. I don't think they attribute too much of sense to the audience. "That the audience won't get it. You won't end up cheating

"Artistes don't have creative freedom. A lot of the stuff we



do, we self censor or cut it off. You're not really sprea wings and wanting to make the kind of film you want to make

"You are always scared and on tenterhooks, 'Oh, will they e a problem with this? You never know what they won't like'. It's very surprising." Hashmi said the censor board needs a "major rethink" in the way it functions.

Rahman was speaking at the launch of Nexa Music, which aims to provide aspiring Indian musicians a platform to compose



original music and lyrics.

He is one of the mentors for the participants, four of whom will get a chance to do 12 live events with the NEXA Music mentors

across the country.

The composer said there are a growing number of aspiring singers who put their


work on the Internet but that does not promise quality. "Because of the Internet, today there's no wall preventing someone
