ISRO eyeing to launch Chandrayaan-II rover in Moon's south pole

KANYAKUMARI (TN) MAY 3 (PTI): Seeking to create history with India's second moon mission Chandrayaan-2, space agency ISRO Friday said it will attempt to launch a rover in the lunar South Pole, a uncharted territory so far.

"Till date nobody has made an attempt to land a rover in the region. It has been only near the equator (of the Moon). We will be attempting to launch the rover (of Chandrayaan 2) in lunar South Pole for the first time", Indian Space Research Organisation (ISRO) Chairman K Sivan said here.

Earlier this week, ISRO has said all three modules of the moon mission -- Orbiter, Lander (Vikram) and Rover (Pragyan) -- were getting ready for the launch scheduled in July and the lander was expected to touch down on the lunar surface in early September. ISRO has kept the launch window for the mission onboard GSLV MK-III rocket from July 9 to July 16 with an expected Moon landing on September 6, Sivan told reporters here.

The Orbiter and Lander modules will be interfaced mechanically and stacked together as an integrated module and accommodated inside the launch vehicle. The Rover is housed inside the Lander.


On ISRO's proposed Aditya-L1 mission, Sivan said currently scientists were exploring possibilities to study more about Sun. "To learn about Sun orbit, we will be sending Aditya-L1 during the first half of next year", he said.

The mission is aimed at observing the solar corona, the outer layers of the Sun. The satellite would be inserted in a halo orbit around the L1 (Lagrangian point 1) of the Sun-Earth system so that it has the advantage of continuously viewing the Sun without any occultation or eclipses. The L1 is 1.5 million kms from the Earth.

On a question about tracking cyclone Fani, he said, with the details provided by ISRO, officials were able to forecast the landfall area and this helped in taking precautionary measures in advance. "Due to tracking conditions, we have been able to minimise the impact caused in terms of casualties...," he said.

Cyclone 'Fani' hit Odisha Friday, packing rain and windstorm that gusted up to 175 kmph, leaving at least three people dead, blowing away thatched houses, and swamping towns and villages.

Nepal Army, wildlife officer dismiss Indian Army's Yeti claim

KATHMANDU, MAY 3 (PTI): The Nepal Army and a wildlife expert have dismissed the Indian Army's claim that its soldiers have spotted footprints of Yeti, the mythical beast found in the Himalayas, near the Makalu Base Camp, saying they were likely that of a bear. On Monday, the Army claimed its mountaineering expedition team in Nepal found mysterious large footprints in the snow that they believe belong to Yeti, or the abominable snowman. In Nepali folklore, Yeti is a mythical ape-like creature taller than an average human that is said to inhabit the Himalayas, Siberia, Central and East Asia.

"For the first time, an Indian Army Mountaineering Expedition Team has sited (sic) Mysterious Footprints of mythical beast 'Yeti' measuring 32x15 inches close to Makalu Base Camp on 09 April 2019. This elusive snowman has only been sighted at Makalu-Barun National Park in the past," the Indian Army tweeted on Monday night.

The Army also released photos showing large footprints in the snow which they claim belong to the creature. However, Director General of the Department of Wildlife and National Parks Man Bahadur Khadka has dismissed the Indian Army's claim, "According to our experts, it may be the footprint of a bear found in the Himalayas," he was quoted as saying by the Kantipur Daily.

According to Nepal Army spokesperson Bigyan Dev Pandey, a liaison officer of the Nepal Army, who accompanied the Indian Army expedition team, had not directly seen the footprint.

Pandey said some 3 to 4 years ago, a French expedition team had reported a similar sighting of giant footprints. At that time it was reported that the unusual footprints were seen in the mountain. When the wildlife experts were contacted for verification, they said that the Makalu Barun region is home to large snow bears and the footprints might belonged to them, the officer said.

An Indian Army team of 18 personnel led by Major Manoj Joshi embarked on an expedition to Mount Makalu in Nepal on April 2. On April 9, the team spotted "mysterious footprints" measuring 32 X 15 inches to close to the Makalu base camp.

Makalu is the fifth highest mountain in the world at 8,485 metres. It is located in the Mahalangur Himalayas, some 19 kilometres southeast of Mount Everest, on the border between Nepal and Tibet, China. Stories of the Yeti first emerged as a facet of Western popular culture in the 19th century. Given the lack of evidence of its existence, the scientific community has generally regarded the Yeti as a legend.

One election commissioner gave dissent on two decisions on complaints against PM: Sources NEW DELHI, MAY 3 (PTI): the Pulwama martyrs in

One of the two election commissioners had dissented in the decision of the 'full Election Election Commission' to give clean chit to Prime Minister Narendra Modi in the two speeches made in Maharashtra last month, highly-placed sources aware of the development said Friday. In the last three days. the Commission gave its decision on as many complaints by the Congress ngainst the prime minister, alleging violation of the model code.

One of the election commissioners, according to the sources, gave his dissent in EC's decision to give clean chit to the prime minister on his speech at Wardha on April 1 where he attacked Congress chief Rahul Gandhi for contesting from minority-dominated Wayanad seat and his appeal to first-time voters by invoking the Balakot air strikes and Latur on April 9. The 'full Commission' which takes such decisions comprises Chief Election Commissioner Sunil Arora and fellow election commissioners Ashok Lavasa and Sushil Chandra.

The two decisions were then taken based on 2:1 majority as per prescribed law which governs the functioning the of the poll panel, the sources said.

The Election Commission (Conditions of Service of Election Commissioners and Transaction of Business) Act, 1991 states that if the Chief Election Commissioner and other Election Commissioners differ in opinion on any matter, such matter shall be decided according to the opinion of the majority.


The Commission transacts its business by holding regular meetings and also by circulation of papers. All Election Commissioners have equal say in the decision making of the Commission.

Mala, Helen, Nargis: How are cyclones named?

New Delhi, May 3 (PTI): Mala, Helen, Nargis and Nilofer may sound like the names of yesteryear Bollywood actors, but they are, in fact, lethal cyclones that have brought violent winds, heavy rains and wreaked destruction. As Cyclone Fani pounded the Odisha coast on Friday, the name, which was suggested by Bangladesh, also evoked curiosity. Mritunjay Mohapatra, the additional director general of the India Meteorological Department (IMD), said Fani, pronounced as 'Foni', means a snake's hood.

But how are cyclones named?

The World Meteorological Organisation/Economic Social Commission for Asia and the Pacific Panel on Tropical Cyclones, at its twenty-seventh session held in 2000 in Muscat, Oman, agreed to assign names to the tropical cyclones in the Bay of Bengal and Arabian Sea.



menced from September 2004.

The eight countries along the Bay of Bengal and Arabian Sea suggest names that are sequentially listed. The nations suggest names

alphabetically -- Bangladesh, India, Maldives, Myanmar, Oman, Pakistan, Sri Lanka and Thailand.

The Regional Specialised Meteorological Centre (RSMC) based here gives a tropical cyclone an identification from the names list. The identification system covers both the Arabian

Sea and the Bay of Bengal.

So, for instance, Bangladesh suggested 'Onil' the first in the list. Onil originated in Arabian Sea, off the Gujarat coast between September to October 2004. It made landfall in the state, but impacted both India and Pakistan.

BCCI is hosting the VIVO IPL Fan Park for the first time in Sikkim in collaboration with DNA Networks and SCA.

He informed that the BCCI has shortlisted 21 States and 36 cities to host the VIVO IPL Fan Park for this season of IPL. Although the IPL has huge fan following globally the BCCI has taken this initiative to further increase viewership and to provide stadium type atmosphere even in those cities which do not have cricket stadiums, he added.

The new State included in VIVO IPL Fan Park 2019 is Sikkim and new cities are Gangtok, Tezpur, Bhilai, Una, Shivmogga, Tirunelveli, Mudurai and Trichy. It is informed that the Fan Parks have covered 65 cities in last four years and in the last season 35 venues accommodated around 5 lakhs of cricket fans. The cities retained for this year are the ones which have seen a good footfall in previous years and continue to draw fans in larger numbers.

Mr Bhutia stated that the main objective of VIVO IPL Fan Park is to provide entertainment and fun for cricket lovers and to bring social changes through community viewing and globalisation of the game of

Speaking about various attractions of VIVO IPL Fan Park at Gangtok, he informed that the event will have a lucky draw to provide two VIVO phones per day to winners and another lucky draw to provide iersev and bats autographed by big cricket stars and there will be face painters for viewers and banners to cheer their favourite team.

The venue will also have facilities like free distribution of drinking water, toilets and kids zone. He informed that the venue will have live commentary and music and a team will shoot the entire event for live uplink to be broadcasted from the IPL venue.

Mr Bhutia urged sports lovers of Sikkim to be a part of this major event in the state. He informed that the venue can accommodate around 3000 people at a time and the entry to the venue is totally free of cost. He also expressed his hope that the event will further encourage and motivate young cricketers of the State to work harder to play in major tournaments and IPL in the near future.

Mala, Helen, Nargis...

Cyclone Phetai, suggested by Thailand, originated in the Bay of Bengal and made landfall in Andhra Pradesh. ravaging the coastal districts in December last year.

The next cyclone, whenever it originates, will be named 'Vayu', suggested by India.

Of the 64 names suggested by these eight countries, 57 have been utilised.

Some of the names suggested by India are Agni, Jali, Bijli, Akash, while Mala, Helen and Nilofar were suggested by Sri Lanka, Bangladesh and Pakistan respectively.

These lists are used sequentially and they are not rotated every few years, unlike the Atlantic and East-

ern Pacific lists. "A storm causes so much death and destruction that its name is considered for retirement and hence is not used repeatedly.

"If the public wants to suggest the name of a cyclone to be included in the list, the proposed name must meet some fundamental criteria," a circular on naming the cyclones over the North Indian Ocean said.

"The name should be short and readily understood when broadcast. Further, the names must not be culturally sensitive and must not convey some unintended and potentially inflammatory meaning," it added.

The name can be communicated to the director general of the IMD.

According to the IMD, in the beginning, storms were named arbitrarily.

Laxman Singh Rathore, a former director general of the IMD, said the practice of naming the storm first started in the United States. This helped identify it and also aided the researchers.

Earlier, the storm was named after the coast it hit,

"Then the mid-1900s saw the start of practice of using feminine names for storms. In the pursuit of a more organised and efficient naming system, meteorologists later decided to identify storms using names from a list arranged alphabetically," the IMD said explaining the genesis of the naming process.

"Before the end of 1900s, forecasters started using male names for those forming in the Southern Hemisphere. Since 1953, Atlantic tropical storms have been named from lists originated by the National Hurricane Centre. They are now maintained and updated by an international committee of the World Meteorological Organisation," the IMD added.

Storms over South Pacific and Indian Ocean are known as cyclones. In the North Atlantic, central North Pacific, and eastern North Pacific, the term hurricane is used.

The same type of disturbance in the Northwest Pacific is called a typhoon, according to the National Ocean Service of the US' National Oceanic Atmospheric Administration.

All SDMs and BDOs were directed to undertake cleanliness drives in their respective stations.

Justice Rai begins threeday tour of North Sikkim



MANGAN, 03 MAY (IPR): The three days tour to North Sikkim of Justice, Meenakshi Madan Rai, Judge High Court of Sikkim and Executive Chairperson, Sikkim State Legal Services Authority began today. She was accompanied by Sonam Palden Bhutia, District and Session Judge, North, Suraj Chettri, Member Secretary, SSLSA, Matilda Isaacs, Special Secretary, SSLSA, North, Kunzang Dorjee Shangderpa, Sr. Superintendent of Police, North, Roger R Rai, Managing Director, SIDICO and Somnath Adhikari, Additional District Magistrate.

On the first day of her three days tour, Justice Rai chaired an awareness-cum-sensitization programme on Protection of Children from Sexual Offences (POCSO) Act, 2012, Protection of Women from Domestic Violence Act, 2005, Maintenance and Welfare of Parents and Senior Citizens Act, 2007, Juvenile Justice (Care and Protection of Children) Act, 2015 and Adoption in terms of the Juvenile Justice (Care and Protection of Children) Act, 2015 at Chungthang, Panchayat Bhawan.

The programme which was organized by the Sikkim State Legal Services Authority in coordination with District Legal Services Authority, North Sikkim aims to make the school students and general public aware on the importance of above stated Act as the safeguarding tools for the protection of the rights of Senior Citizens, Women and children.

During the programme, resource person Sonam Palden Bhutia sensitized to the participants on various provisions of Sikkim Anti Drugs Act (SADA), Protection of Child from Sexual Offences (POCSO) Act and Narcotic Drugs and **Psychotropic Substances** Act (NDPS).

He informed that POCSO Act being implemented with the objective to provide care and protection of children from sexual assault, sexual harassment, pornography and to serve as guidance to children who are in conflict with law.

Similarly, resource person, Suraj Chettri sensitized the house on Protection of Women from Domestic Violence Act, 2005, Maintenance and Welfare of Parents and Senior Citizens Act, 2007, Juvenile Justice (Care and Protection of Children) Act, 2015 and Adoption in terms of the Juvenile Justice (Care and Protection of Children) Act, 2015.

Elucidating the JJ Act, Mr. Chettri enlightened the students on various crimes against children and Acts designed to safeguard the welfare of the children. He also highlighted the responsibilities of Child Development Protection Officer (CDPO) towards Care and Protection of Children those who are in need. Simultaneously, he informed about the Juvenile in Conflict with

Talking on various provisions of child adoption he suggested the house to follow duly legal procedures before adopting any baby child. Further, he enlightened that the senior citizens can approach to the Sub Divisional Magistrate for seeking their maintenance under the Maintenance and Welfare of Parents and Senior Citizens Act.

Talking on Domestic Violence he informed that there are three types of Domestic Violence viz. Physical Violence, Mental Violence and Economic Violence. Any women facing such violence can seek legal assistance from their respective Magistrate Court.

Summing up the sensitization programme Justice Rai informed that the programme was aimed to enlighten the unreached rural community about child rights and child protection through this sensitization programme. Moreover, she called upon the people of north district to approach Judicial Court in case of any POCSO offences rather to settle it amicably.

On the other side, she urged the Police Personnel to remain more sensitive towards POC-SO offence. She opined that the general information of POCSO should be taught in more serious manner in the school as to bring more sensitization among the students.

Justice Rai stated that POCSO is a non-compoundable and non-bailable offence and encouraged everyone to join hands to combat child sexual abuse in our society.

Col D N Bhutia Secretary The Meghalaya government has sought deployment of a platoon of the National Disaster Response Force (NDRF) in the state in view of Cyclone Fani, officials said Friday.

The extremely severe cyclonic storm made landfall in Odisha on Friday morning. It is gradually heading towards West Bengal and from there it is likely to move towards the north-east, the officials said.

One NDRF platoon, comprising 25 to 30 personnel, has been sought from Guwahati, Meghalaya Revenue and Disaster Minister Kyrmen Shylla said.

The IMD has warned of thundersquall accompanied with gusty winds and heavy rains for the next 48 hours across the northeastern states, including Meghalaya.

"We have requested the NDRF to deploy at least one platoon at the state capital. The NDRF personnel would assist the state in case of any emergency," Shylla told PTI.

The officials of all the 11 districts have been asked to be on alert, the minister said, adding, all officers, including those posted in various blocks, have been asked not to leave their places of posting, the minister said.

The State Disaster Relief Force and the

SHILLONG, MAY 3 (PTI): Fire Services have been kept on standby, the minister added.

The district disaster management authorities have asked all residents to take precautions, he said.

"People are required to take extra care to avoid any incidences and ensure safe keeping of all objects such as lumber piles, loose tin sheets, bricks, garbage bins and signboards which could be blown away by strong winds," an advisory issued by the Disaster Management Authority of East Khasi Hills district said here.

Meanwhile, the Eastern Air Command of the Indian Air Force (IAF) has been kept on standby in view of the storm.

"Six light helicopters for rescue operations and five medium-lift helicopters for transporting relief materials are ready in case of any emergency," a spokesperson at the EAC headquarters said here.

"In addition, four AN 32 aircraft have been kept ready, with medical teams, for ferrying relief material, medical help, NDRF teams and equipment," the spokesperson said.

The IAF spokesperson said that the helicopters have been kept ready at Bagdogra and Purnea for quick deployment in Odisha and West Bengal.

Modi "touched base" with almost every Indian in 125 days

NEW DELHI, MAY 3 (PTI): In the last few months of his tenure, Prime Minister Narendra Modi attended 200 programmes, political as well as official, held across 27 states and union territories, "touching base with almost every Indian" in 125 days, according to his website.

It said there is no part of the country that he did not visit during the 125 days between December 25 and May 1 as he crisscrossed from Kashmir to Kanyakumari and Jamnagar to Silchar, while speaking to students to scientists, farmers, entrepreneurs, foreign heads of state and political workers.

"These numbers speak for themselves. They also offer a unique glimpse into the working style and multi-tasking abilities of Modi. Through these programmes, he would have touched base with almost every Indian in 125 days," it said.

In this period, Modi made promises and worked at their swift delivery, the website said, referring to flagship welfare programmes, 'Pradhan Mantri Kisan Samman Nidhi' and 'Pradhan In the last few months, Mantri Shram Yogi Man Dhan Yojana'. The former provides monetary support of Rs 6000 per annum to farmers and the latter assures a monthly pension to the unorganised sector.

The prime minister also dealt with the Pulwama terror attack with "courage and statesmanship" as the Indian Air Force launched air strikes on terrorist camps in Pakistan which put the neighbouring country "on the defensive". "Modi's proactive foreign policy has diminished the stature and voice of Pakistan at the world stage. On May 1, Masood Azhar was declared a terrorist by the UN, thanks to the support from a large number of nations," it noted.

The website also said he became the first prime minister in years to visit the Kumbh Mela and take a dip in Sangam, besides attending a puja ceremony.

"This visit indicated the prime minister's pride towards India's rich culture and the desire to draw more voungsters towards our rich ethos. Modi visited several such centres closely associated with India's history and culture," it added.

The prime minister also visited Port Blair to pay tributes to Hindutva icon Veer Savarkar and several others at the iconic Cellular Jail.

Noting that Netaji Subhash Chandra Bose has always been an influence on Modir, it said that he unfurled the Tricolour to mark the 75th anniversary of the unfurling of the national flag by Bose. During the 125 days, Modi visited his Lok Sabha constituency Varanasi five times and attended wide-ranging programmes.

The holy city has seen "unparalleled development work", especially in local infrastructure, electricity and cleanliness, and one project that stands out is the Kashi Vishwanath Dham project, which aims at improving infrastructure at the Vishwanath temple and will "transform" Varanasi. In February, Modi addressed a rally of ex-servicemen and dedicated the National War Memorial to the nation.

Looking Out for 10% Should Not be Difficult

s of 2011, exactly 64,111 members of Sik-As of 2011, exactly 04,111 memoris 21 memoris 22 kim's population were in the 0-6 age-group, making up a neat 10.50% of its population of 6,10,577 people. The national share of population in this age-group is slightly higher at 13.1%, down from 15.9% in 2001. These figures, as per the Census of India 2011. The previous census had posted the number of children in this agegroup at 78,195, making up 14.50% of Sikkim's population of 5,40,851 at the time.

There has been talk of the fall in fertility rates, with some even suggesting that Sikkimese women should bear more children:-o While such demands are clearly wrong on so many levels, this section had only recently commented on such attitudes, so today, let's discuss "young age dependency", as census enumerators refer to the 0-6 age-group. Dependency ratio can be defined as the age-population ratio of those typically not in the labor force. This would mean the minors and the senior citizens, whose care rests on the shoulders of the productive/ working population. Clearly then, the lower this number, the lesser the stress on the working population and better the access to available resources for the 'dependents'. At a wider, society and State level, this means that the existing infrastructure and funds can now go much further since the number of beneficiaries is fewer. Even in absolute terms, for instance, the number of minors has dropped from 78,195 in 2001 to 64,111 in 2011. Given the trend, this number must be even lower now, five years down the line. Budget outlays have however consistently risen, and even after factoring in inflation, there should be much more available by way of funds for these children per head than was the case a decade and a half ago.

It goes without saying that fewer number of the very young translates into an enhanced ability to invest in child development. It's simplistic, but one needs to be bear in mind that a fewer newborns now, while it might free resources to ensure better care and education for them in the immediate future, also translates as greater responsibilities on their shoulders in the longer run. As a generation ages, they will stop being active contributors to the economy and the work-place. Improved healthcare facilities will mean that they will also remain dependent for more years. The share of elderly will increase, and with fewer young coming of age down the line, the pressure on them to look after the aged will increase. China is feeling the stress of its one-child policy now. That said, today's minors will deliver on their adult responsibilities only as well as they have been groomed at present. All the more reason why they should be exposed to the best education and groomed with a stronger sense of responsibility and belonging if the present generation wants to be looked after better when they retire and grow into the dependency of old age.

If education is genuinely touched by quality, a more confident and definitely more resourceful generation can be prepared. But Sikkim has been failing its young embarrassingly. Take the Annual Status of Education Report (ASER) for 2018, for instance. Where one had hoped that more children would have received access to improved classroom teaching, the opposite seems to be happening. Reading levels among standard III students rose only marginally from 26.9% in 2012 to 29.3% in 2018. Even as the improvement is too miniscule, what is also distressing is that reading levels were measured as class III students being able to read standard I texts. It should be a worry that barely 30% of the current standard III students can read even basic standard II texts. Mathematics has actually recorded a fall in learning quality. In 2012, 55% of the standard III students could do subtraction [2-digit by 2-digit with borrowing], a basic standard II task for this age, but in 2018, this number had fallen to 40%! Where the young should have been learning better because there are fewer of them and still the same number, if not more, of teachers attending to them, the quality of learning appears to have fallen!

But quality education is something everyone owes to the very young. And now it is also affordable. Think about it, if 90% of the population wakes up to its responsibilities towards the remaining 10% who depend on them for everything, they can ensure that the minors receive the best of everything. If this 90% consciously resolves to genuinely care, a much more responsive, warm and compassionate generation will take charge of Sikkim in the very near future.

How the world's largest democracy casts its ballots

bout 600 million Indian citizens are expected $oldsymbol{A}$ to cast their votes over a period of 39 days ending May 19, in the ongoing election for their country's parliament. There are roughly 900 million eligible voters, and the country has typically seen about two-thirds of them turn out to polling places.

I have been working on the security of electronic voting systems for more than 15 years, and, along with other colleagues, have been interested in understanding how a nation can tally that many votes cast over such a long period. India uses a domestically designed and manufactured electronic voting machine – as many as 4 million of them at 1 million polling places, at least some in extremely remote locations.

The first version of the Indian electronic voting machine debuted in the state election in Kerala in 1982. Now they're used in elections throughout the country, which happen on different days in dif-

HOW DOES IT WORK?

When a voter arrives at the polling place, she presents a photo ID and the poll officer checks that she is on the electoral roll. When it's her turn to vote. a polling official uses an electronic voting machine's control unit to unlock its balloting unit, ready to accept her vote.

The balloting unit has a very simple user interface: a series of buttons with candidate names and symbols. To vote, the voter simply presses the button next to the candidate of her choice.

After each button press, a printer prints out the voter's choice on paper and displays it to the voter for a few seconds, so the person may verify that the vote was recorded correctly. Then the paper is dropped into a locked storage box.

The whole system runs on a battery, so it does not need to be plugged in.

When it's time for the polling place to close at the end of the voting day, each electronic voting machine device and paper-record storage box is sealed with wax and tape bearing the signatures of representatives of the various candidates in that election, and stored under armed guard.

After the election period is over and it's time to tally the votes, the electronic voting machines are brought out, the seals opened and the vote counts for each control unit are read out from its display board. Election workers hand-tally these individual machine totals to obtain the election results for each constituency.

SECURITY PROTECTIONS - AND CONCERNS

The Indian electronic voting machine primarily runs on specialized hardware and firmware, unlike the voting machines used in the U.S., which are software-intensive. It is intended for the single purpose of voting and specially designed for that, rather than relying on a standard operating system

like Windows, which needs to be regularly updated could let hackers alter the results. to patch detected security vulnerabilities.

Each machine requires only a connection between a balloting unit and a control unit; there are no provisions to connect an electronic voting machine to a computer network, much less the internet - including wirelessly.

This design does offer some protections against possible tampering with how votes are recorded and tallied. The Election Commission of India has repeatedly claimed that the electronic

The Election Commission of India argues that any manipulation or error would be detected because the electronic voting machine is tested frequently and candidate representatives have opportunities to participate in mock elections immediately before a machine is used in a real election. However, it is possible to make changes that will not be detected. Testing can reveal only some problems, and the absence of problems during testing does not mean that problems do not exist.



voting machines are tamper-proof. However, a scholarly study has demonstrated there are ways to rig the machines. In particular, the simplicity of the design allows for simple attacks, such as intercepting and modifying the signal carried over the machine's cable.

The Election Commission has not made public any independent security evaluations, so it's unclear exactly what is – or isn't – possible. Parties that lose elections often suspect malfeasance and question the equipment.

MANUFACTURING THE MACHINES

As I and others have observed, when the machines are being made, there are a number of opportunities for someone to physically tamper with an electronic voting machine in ways that preelection device testing might not detect. The machines' software is designed, written and tested at two electronics companies owned by the government of India: Bharat Electronics Limited and Electronics Corporation of India Limited. The chips for the machines are manufactured outside India. In earlier versions of the machine, the chip manufacturer also wrote the machine code into the chip; today the electronics companies do it themselves.

At any time during manufacture, testing and maintenance, it may be possible to introduce counterfeit chips or swap out other components that

AUDITING THE MACHINES' RESULTS

There is, however, a mechanism for detecting attacks - that printed-out paper bearing the vote and stored securely with the electronic equipment. A 2013 Supreme Court directive asked the Election Commission to create that process to protect the integrity of the balloting process.

In each constituency, five electronic voting machines will have their results audited by comparing a manual count of the printouts with the electronic tallies. (This means about 1% or 2% of each constituency's machines will be tested.) Opposition parties have asked the Supreme Court to order audits of half of all electronic voting machines, but that may not happen with this year's election.

While the electronic voting machine system is useful and functional, officials and observers shouldn't assume there's no way to tamper with the results. The Election Commission should certainly continue to improve testing and provide public reports of independent testing. However, because no technology can be tamper-proof, each election outcome should be verified by a manual audit, to ensure that the results are correct, whatever they may be

Julian Assange has refused to surrender himself for extradition to the US. What now?

In the case of Julian Assange, focus has turned to the United States' efforts to extradite him from Britain to the US to face a charge of conspiracy "to commit computer intrusion".

The initial extradition hearing, which took place on Thursday, was a preliminary step in what will be a long, drawn-out process. Assange appeared before the court by video link and made it clear he opposes extradition. The next procedural hearing is set for May 30.

Assange had been arrested by London Metropolitan police on April 11, and removed from the Ecuadorian embassy. He had been granted asylum by the embassy seven years earlier, after fleeing arrest out of fear he would be extradited to the United States.

Earlier this week, Assange was convicted of breaking the conditions of his bail in 2012, and sentenced to 50 weeks imprisonment.

WHAT HAPPENS NEXT?

The actual extradition hearing will be some time off, following these preliminary hearings. After an initial decision by a judge, either side may have access to an appeal procedure through the courts.

Regardless of that outcome, the final step rests with Home Secretary Sajid Javid. Despite pressure from UK lawmakers, Javid cannot make a political decision on whether to extradite Assange – rather, his role is to approve a court order for extradition unless there are statutory provisions that prohibit it.

His decision to extradite Assange might also be subject to High Court appeal. WHAT IS EXTRADITION?

Extradition is a legal process that states use to facilitate the transfer of a person from one jurisdiction to andition arrangements between states rely on bi- and multilateral extradition and mutual assistance treaties.

The US and UK signed an extradition treaty in 2003. Under this treaty. both countries agreed to extradite people sought for trial or punishment for extraditable offences. An offence is extraditable where the conduct is punishable under the laws of both countries "by deprivation of liberty for a period of one year or more."

The offence for which Assange is wanted in the US is punishable by up to five years' imprisonment. It is grounded in an allegation that Assange engaged in a conspiracy with Chelsea Manning to hack US Department of Defence files, and publish classified information on Wikileaks.

Assange maintains his innocence, and his defenders argue that his extradition would set a dangerous precedent for journalism and the publication of truthful information - particularly as it may affect the US.

It is important to note the parallel, but now lapsed extradition claim from Sweden, which had earlier sought Assange for a preliminary investigation and possible prosecution for rape charges. Assange had claimed an extradition to Sweden to face those charges would result in another extradition from there to the US. Having lost his protection under Ecuador, Assange now faces exactly that prospect.

CONSTRAINTS ON EXTRADITION

Extradition is a heavily regulated and multi-stage process. Rules and procedures within and beyond the 2003 Extradition Treaty potentially protect Assange from extradition to the US, or at least constrain its conditions.

POLITICAL OFFENCES

"Extradition shall not be granted if the offence for which extradition is requested is a political offense."

It is common for countries to retain a power to refuse extradition where it is sought in relation to political offences. Such an exemption can protect whistleblowers and others who legitimately challenge the exercise of governmental power.

Pure political offences are those that directly target the government, such as treason, sedition or espionage. Relative political offences are ordinary offences that are "committed for political motives or in a political context".

The UK does not have a statutory or generally accepted judicial definition of a relative political offence. However, the Anglo-American system uses the "incidence-test" according to which "the act must be incidental to and forming a part of political disturbances."

The "requested state" may also refuse extradition if it determines that the request was politically motivated.

Assange's lawyers are expected to make this a chief argument against extradition. Such an argument could not succeed on the basis that conspiracy to commit computer intrusion is a pure political offence under UK legislation, because it is not.

However, the UK courts or authorities may regard the charge Assange faces as a relative political offence. Alternatively, they may be convinced by Assange's argument that his work with WikiLeaks is purely journalistic and the US charge politically motivated.

THE 'RULE OF SPECIALITY'

The "Rule of Speciality" under the extradition treaty offers Assange pro-The 2003 extradition treaty be-tection against new charges. Accord-

other in order for that person to be tween the UK and the US explicing to this rule, an extradited person for which the extradition is granted, or for crimes committed thereafter. However, the requested state may waive the rule of speciality in which case Assange may end up facing more charges than originally specified.

> This rule is important for both Assange and the UK authorities. The UK is entirely opposed to the imposition of the death penalty in any circumstances. The UK would be bound to refuse to extradite Assange to the US were he to face charges that carried a possible death penalty.

> There will be pressure on the UK authorities to respect the rule of speciality, in which case Assange would face a maximum of five years imprisonment should he be extradited to the US.

TIME AND APPEAL PROCEDURES

Final decisions on extradition requests take considerable time. For example, the extradition of Abu Hamza from the UK to the US took eight years. Progress of the extradition request is likely to be slow through the UK courts and bureaucracy. It will be further delayed by any appeal procedures Assange seeks to utilise, whether through the UK courts or the European human rights system.

It is impossible to say, for now, what awaits Assange. At the very least, following the completion of his current prison sentence, there will be renewed uncertainty about his liberty. Controversy, of course, will persist over whether Assange deserves protection against political prosecution, if he may actually have nefarious links to Russia, or indeed whether the most just course would be for the Swedish charges to be revived first.

Cyclone Fani to change Nepal's weather condition





Doctors dispel myths on asthma treatment

New Delhi, May 3 (PTI): In view of rising asthma cases in the country, especially in the city, experts Friday called for more awareness and also stressed upon dispelling myths and fears associated with inhalation therapy. In India, the soaring numbers have reached 15-20 million and the number will continue to grow until adequate emphasis is laid on the importance of identifying the right medication, which can help manage asthma effectively, Dr Anant Mohan, the Head of Department of Pulmonary Medicine at AIIMS, said.

The chronic disease affects a large population worldwide and its number is rising every year. According to the WHO Fact sheet, between 100 and 150 million people around the globe suffer from asthma. The reasons for the increasing prevalence of asthma are multifactorial. They include rising air pollution with increase in air particulate matter, smoking, incorrect treatment in children, and viral infections in early childhood.

Emphasising on right treatment and awareness, Dr Mohan said it is very important to change the perception towards asthma and inhalation therapy.

"While inhalation treatment can play a crucial role in reducing the impact of asthma on people's lives, adherence is crucial. Inhaled medicines help to deliver the drugs directly to the lungs where they are required, so they work faster, better and with negligible side effects," Dr Mohan said.

He said the challenge is to convince the patients to accept inhalers and adhere to the treatment



prescribed in order to get the full benefit. Inhalation therapy works to control asthma by preventing and relieving symptoms and reducing flare-ups, but they will work if patients work in partnership with their physicians and take them as advised.

Another challenge to manage asthma is discontinuation of the medication once the symptoms have subsided. Unfortunately, this may also result in the aggravation of the disease and flare-up of symptoms, leading to worsening of disease.

Experts suggested consulting a doctor before taking such steps as asthma usually requires longterm treatment.

Air pollution is becoming an important cause and trigger for asthma in India and it is proven now that inhalation therapy remains the best form of drug delivery in asthma as it delivers drugs directly in the lungs, and the action

is quick and lesser dose is required to improve the symptoms.

"We need to make people aware about this safe and effective therapy. Inhalers are handy, easy to carry and patient friendly as they are very simple to use," said Dr Ankit Parakh, senior consultant Pulmonologist, Centre For Child Health at BLK Super Speciality Hospital, New Delhi.

According to a Lancet Report, traffic-related pollution caused asthma among 350,000 children in India in 2015, second only to China.

The Lancet study analysed 194 countries and 125 major cities worldwide. Although less than half the size of China's burden, India had the next largest number of cases (350,000) due to its large population of children. Among cities, Paris ranked 21st (33 per cent), New Yorkv29th (32 per cent), London 35th (29 per cent), and New Delhi 38th (28 per cent).

Nepal witnesses first bird flu death

KATHMANDU, MAY 3 (PTI): A 21-year old man has died here after being infected by bird flu, becoming the first-ever patient in the Himalayan nation to succumb to the viral disease, according to a media report.

The patient, whose identity has not been revealed, was admitted to a hospital in Kathmandu on March 24 with symptoms of fever and cough. His saliva sample was sent to the National Public Health Laboratory and also to Japan following which it was confirmed that he was suffering from bird flu or avian influenza, My Republica reported on Thursday.

Though he was treated, the patient died on March 29, officials from the Ministry of Health and Population (MoHP) said. It was the first-ever death case caused by bird flu in Nepal, they said.

The incident was unexpected, Pushpa Chaudhari, secretary at MoHP, said. Bird flu is caused by the highly pathogenic avian influenza A (H5N1) virus or other non-human influenza sub-types (eg H7, H9), according to the World Health Organisation (WHO).

Activists want PepsiCo to compensate farmers for 'harassment'

AHMEDABAD, MAY 3 (PTI): A day after PepsiCo announced that it would withdraw cases filed against the potato farmers in Gujarat, activists and farmer leaders Friday said the company must do it unconditionally and also pay a compensation to the cultivators for causing "harassment".

Agitated by PepsiCo's earlier decision to sue potato growing farmers for allegedly growing a variety of potato registered by it, around 25 major farmers' bodies of Gujarat and the country, including Bharatiya Kisan Sangh (BKS), along with activists and NGOs have decided to form a central body - Seed Sovereignty Forum - to protect farmers' rights on seeds. A meeting to chalk out an action plan under this umbrella body was held on Friday at the Gujarat Vidyapith here, said farm rights activist, Kapil Shah of NGO 'Jatan'.

"We are apprehensive because PepsiCo's statement yesterday does not offer anything new. The company had earlier told the court that it will withdraw cases on two conditions - either farmers give up using company's seeds or farmers become part of contract farming with the company," Shah told report-

ers here. "We demand that the withdrawal of cases must be unconditional. We also want the company to pay compensation to these farmers for causing harassment. The law is crystal clear and it says that farmers' or cultivators' rights will always supersede the rights of seed breeders. Farmers' right over seed is non-negotiable," he said.

Nine farmers from Sabarkantha and Aravalli districts were sued by PepsiCo in two separate courts for allegedly growing a variety of potatoes for which the company has claimed plant variety protection (PVP) rights, and sought damages ranging from Rs 20 lakh to Rs 1 crore from each of them. They have been sued by the company under the Protection of Plant Varieties and Farmers' Rights Act, 2001. Shah said the issue

touches farmers of the entire country and not just of Gujarat.


"After this issue cropped up, around 25 national and regional organisations working for farmers decided to come under one roof to form 'Seed Sovereignty Forum'. We will hold a meeting today to devise an action plan to fight against such cases in the future and formulate a long-term strategy to en-

sure that farmers' rights are not snatched away," said Shah. Shah was accompanied by four farmers of Sabarkantha district, who were sued by the MNC. Office-bearers of the BKS and several other farm rights activists were also present.

Registrar of Gujarat Vidyapith, Rajendra Khimani, called for spreading of awareness among farmers about various laws that protect them. "All the Acts are in En-

glish, not in the language understood by the majority of farmers. As a result, they are not aware of their rights. There is a need to make such laws available in local languages. We also need to keep a check on any attempt aimed at diluting such pro-farmer laws," Khimani, who is the president of Gujarat Association of Agricultural Sciences, said.

Chhabil Patel, one of the farmers sued by PepsiCo, said they used rejected potatoes as seeds, which is a natural practice in villages. "We have been wrongly framed. After grading, PepsiCo takes only large-size potatoes (to make chips), while small potatoes were discarded. Such rejected stock is available everywhere. We sowed those potatoes only.



Delhi Capitals eye big win in pursuit of 2nd place finish

Other players include Swedish duo of GM Nils Grandelius and GM Tiger Hillarp Persson, GM Liviu-Dieter Nisipeanu of Germany besides Nihal Sarin.

More Aussie candidates withdraw over social media posts



SYDNEY, MAY 3 (AFP): Another candidate for Australia's governing Liberals was forced to stand down over anti-Muslim comments Friday as the party struggles to fend off charges it harbours right-wing extremists.

But the main opposition Labor party, which is comfortably leading in opinion polls ahead of the May 18 general election, also saw one of its own stand down Friday over lewd social media posts.

Jessica Whelan became the third Liberal candidate to quit the race in the past three days over racist or homophobic social media posts.

Whelan, running for the lower house of parliament from the island state of Tasmania, initially said the posts, which included references to "filthy Muslims" and called for a referendum to ban Muslim immigration, had been doctored by hackers.

Party leaders supported her as late as Thursday and said police had been called in to investigate the alleged shots of additional anti-Islam posts emerged in the Australian press overnight, Whelan withdrew from the race early Friday. The move came after the Liberals, led by Prime Minister Scott Morrison, were forced to drop two other candidates in the key state of Victoria on Wednesday after they were found to have posted anti-Islam or homophobic messag-

es on social media.

The incidents provided new ammunition to opposition parties' charges that the Liberals have become dominated by extremists since party hardliners ousted moderate prime minister Malcolm Turnbull last August, putting the more conservative Morrison in power. "The Liberals have been forced to dump another one of its extreme right-wing candidates," trumpeted La-

bor leader Bill Shorten. Morrison denied that Whelan's views reflected a broader far-right agenda for his party. "Her views were her views and they do not represent the views of the party I lead," he said.

Labor has also been hit by controversy as both major party campaigns are roiled by social media posts made by their candidates, sometimes years earlier.

One Labor candidate dropped out of the race earlier this week over posts deemed anti-Semitic and Friday another Labor hopeful stepped aside for posting rape jokes and other lewd comments.

Luke Creasey, an openly gay 29-year-old school teacher running for office in Melbourne, posted the comments in 2012 and Shorten defended him Friday morning, saying the candidate regretted the posts made when he was 22.

But with Labor under withering criticism from Liberal officials, Creasey withdrew from the race hours later.

In an increasingly fiery campaign, both parties are learning the value of vetting candidates even in long-shot races where they stand little chance of taking office.

WASHINGTON, MAY 3 (AFP): A man convicted of murdering two people was executed on Thursday in the US state of Georgia.

Scotty Morrow, 52, was put to death by lethal injection at 9:38 pm (0138 GMT) at a prison in Jackson, the Georgia Department of Corrections said in a statement.

Shortly after Christmas 1994, Morrow broke into his ex-girlfriend's house, where she was with two friends and her children.

Morrow shot the three women, killing two of them, including his former girlfriend, in front of her five-year-old son.

He was convicted of the double murder and sentenced to death in 1999, but the decision was overturned in 2011 on the grounds that his trial defense was poor because his lawyers had failed to note he had been abused and raped as a child.

The Georgia Supreme Court then reversed that decision, confirming the original verdict from

On Wednesday, the Georgia State Board of Pardons and Paroles dismissed a clemency request from supporters, who claimed he had become a model prisoner who was sorry for his crimes.

On Thursday, lawyers made a final appeal to the US Supreme Court, after the state Supreme Court rejected a clemency bid.

He is the fifth person executed in the United States in 2019.

Massive Afghanistan peace summit ends in Kabul



KABUL, MAY 3 (AFP): A huge peace meeting aimed at finding an exit from Afghanistan's war is due to finish Friday in Kabul, with leading politicians expected to announce visions for a much-needed breakthrough.

This week's "loya jirga", or grand assembly, saw about 3,200 religious and tribal leaders, politicians and representatives gather under tight security to try to find common ground and discuss possible conditions for a peace deal with the Taliban.

On Thursday, several officials said a vital first step is an immediate reduction in violence, which has continued apace across Afghanistan even with various peace summits taking place.

"Every day, Afghans are being killed without any reason. An unconditional ceasefire must be announced," said Mohammad

Qureshi, head of one of the jirga's many committees.

The jirga comes as the Taliban, who were not at the talks, are this week separately meeting in Doha with US peace envoy Zalmay Khalilzad.

Those talks focus on a potential deal that would see the withdrawal of foreign forces from Afghanistan in return for the Taliban guaranteeing terrorist groups could no longer operate in the country.

Huge swathes of Afghan society worry that if the US does make a deal with the Taliban, the militant Islamists would try to seize power and undo advances in women's rights, media freedoms, and legal protections.

Such concerns were laid bare at the jirga, where hundreds of women were in attendance outlining their "red lines" for any negotiations with the Taliban. "We don't want such a peace that women's rights are not respected, freedom of expression are not ensured, elections are not held," committee member Faizullah Jalal told the summit.

The jirga proved controversial, with opposition figures slamming it as an election campaign event for President Ashraf Ghani, who is due to deliver closing remarks

Among those boycotting were Chief Executive Abdullah Abdullah and Gulbuddin Hekmatvar, a notorious former warlord. Both men are running for president in elec-

tions slated for September. Meanwhile, Afghanistan's war rages on, with thousands of civilians and fighters being killed each year. US forces continue to train Afghan partners on the ground and strike the Taliban from the air, in a bid to push the war -- now in its 18th year -- to a political settlement.

NZ PM Ardern to marry long-time partner

WELLINGTON, MAY 3 (AFP): New Zealand Prime Minister Jacinda Ardern and her long-term partner Clarke Gayford have become engaged to be married, her office said Friday. A spokesman for Ardern and Gayford said the couple, who have a baby daughter Neve, agreed to tie the knot over the Easter break.

He could not reveal whether a date for the prime ministerial nuptials had been set or who had proposed to whom.

"I can't say anything about it other than they are engaged and it happened over Easter," the spokesman told AFP. Ardern, 38, had Neve last June, becoming only the second prime minister in the world to give birth while in office and later taking the infant onto the floor of the UN Assembly in New York.

Since the birth, Gayford, a television fishing show host, has taken on the role of stay-at-home dad. The engagement comes after a trying time for Ardern, who has been widely praised for her response to the March 15 Christchurch mosque shootings that claimed the lives of 51 Muslim worshippers. Ardern said in an interview last year that she would not propose to Gayford, even though she regards herself as a feminist. "I want to put him through the pain and torture of having to agonise about that question himself," she told the BBC.

News of the engagement broke after journalists noticed Ardern was wearing a diamond ring while carrying out her duties on Friday. However, there have been at least two false alarms in the past when Ardern has been spotted sporting bling on her ring finger.

On both occasions she quashed the speculation, saying she had to constantly swap her rings between fingers on her left hand due to eczema.

MUMBAI, MAY 3 (PTI): The Maharashtra Navnirman Sena (MNS) has been asked to submit details within 90 days of expenses incurred on the election rallies of its president Raj Thackeray.



Biopic on PM Modi to release on May 24 now



Hollywood celebs remember Chewbacca actor Peter Mayhew

LOS ANGELES, MAY 3 (PTI): Chewbacca actor Peter Mayhew passed away on April 30 leaving his on-screen companion Harrison Ford and "Star Wars" teammates Mark Hamill, George Lucas among other Hollywood celebrities heartbroken.

Mayhew, who the affable Wookie giant Chewbacca, a friend to Ford's Han Solo, in Lucas' original "Star Wars" trilogy, was 74. At the time of his death, he was surrounded by his family and friends at his North Texas home.

In a statement, obtained by The Hollywood Reporter, Ford said Mayhew dedicated his life to portraying Chewbacca and he will never forget his contribution to the franchise.

"Peter Mayhew was a kind and gentle man, possessed of great dignity and noble character. These aspects of his own personality, plus his wit and grace, he brought to Chewbacca. We were partners in film and friends in life for over 30 years and I loved him. He invested his soul in the character and brought great pleasure to the Star Wars audience," the actor said.

"Chewbacca was an important part of the success of the films we made together. He knew how important the fans of the franchise were to it's continued success and he was devoted to them. I and millions of others will never forget Peter and what he gave us all. My thoughts are with his dear wife Angie and his children. Rest easy, my dear friend," he added.

Hamill, who played Luke Skywalker in the franchise, paid tribute to Mayhew in a heartwarming post on Twitter, calling him the "gentlest of giants".

"A big man with an even bigger heart who never failed to make me smile and a loyal friend who I loved dearly. I'm grateful for the memories we shared and I'm a better man for just having known him. Thanks #RIPPeterMayhew #Heartbroken," he wrote.

Creator of the Star Wars universe, Lucas, remembered Mayhew as a "wonderful man".

"He was the closest any human being could be to a Wookiee: big heart, gentle nature; and I learned to always let him win. He was a good friend, and I'm saddened by his passing," Lucas said in a statement.

Billy Dee Williams, another "Star Wars" veteran, also paid his tributes to Mayhew and posted photos with the actor on Twitter.

"Much more than Chewie to me...My heart hurts... I will miss you my dear friend... Thanks for the great mem-



#RIPPeterMayhew #StarWars," he wrote in the caption. Directors JJ Abrams and Rian Johnson, who helmed "The Force Awakens" and "The Last Jedi" respectively, also paid homage to the Chewbacca actor.

"Peter was the loveliest man... Kind and patient, supportive and encouraging. A sweetheart to work and already deeply missed" Abrams, who is currently working on the franchise's new instalment "The Rise of Skywalker", said in a brief statement posted on Twitter.

Johnson said, "RIP Peter Mayhew. To create a beloved character with warmth and humoor is a testament to any actor's spirit. To do it under a half ton of yak hair takes a true legend."

Disney CEO and Chairman Bob Iger and Lucasfilm president Kathleen Kennedy also posted their tributes on the microblogging site.
