# Stakeholders finalize concept of Lepcha shrine at Statue of Unity complex



#### **SUMMIT REPORT** GANGTOK, 07 MAY:

The concept and de-I sign of the first Lepcha shrine to be constructed at the Statue of Unity on MG Marg was finalized in a meeting conducted by the Pang Lhabsol Celebration Committee [PLCC] on 05 May.

A press release from the committee informs that Bongthings perform rituals every year at the Statue of Unity and since there is no proper shrine, it was felt that a permanent one should be constructed both for prayers as well as for academic purposes.

There was some delay as the Lepchas worship nature and some felt that there should not be a definite shrine, at the same it was also

felt that in days to come when there won't be many shamans and practitioners of the tradition, the whole system can be lost and as such there was the need to have a symbolic manifestation of the Lepcha shrine, the

release mentions. The first brainstorming was done in 2017, followed by another one in Kalimpong in 2018 with at least four concept drawings being prepared and used as reference.

The concept with all the requisite components/elements was adopted unanimously by all present in the meeting.

The responsibility of overall process of research, consultations, logistics for the shrine was undertaken by vice president PLCC, Tseten Lepcha, general secretary PLCC, Namgyal Lepcha and general secretary PLCC, Ongden Tshering Lepcha with active support from all other members.

PLCC president, T Lachungpa presided over the meeting which was attended by Bongthings, scholars, representatives of Lepcha associations, teachers and students.

preme Court Tuesday refused to modify its April 8 order which directed the Election Commission to increase random matching of VVPAT slips with EVMs to five polling booths per assembly segment in the Lok Sabha elections, and dismissed the review plea of 21 opposition leaders seeking that it be raised to 50 per cent.

"We are not inclined to modify our order," a bench headed by Chief Justice Ranjan Gogoi told senior advocates A M Singhvi and Kapil Sibal, who were appearing for the petitioners led by Andhra Pradesh Chief Minister N Chandrababu Naidu.

The apex court on April 8 had directed the poll panel to increase random matching of VVPAT slips with EVMs from one to five polling booths per assembly segment in the Lok Sabha polls, saying it would provide greater satisfaction not just to political parties but the entire electorate.

On Tuesday, Singhvi told the bench, which also comprised Justices Deepak Gupta and Sanjiv Khanna, that random matching of Voter Verifiable Paper Audit Trail (VVPAT) slips with Electronic Voting Machines (EVMs) should be increased to at least 25 per cent as against the present 2 per cent.

"The Supreme Court had increased it from one to five (polling booths per assembly segment). We have asked for 50 per cent but we will be happy with 33 or even 25 per cent. We want at least 25 per cent. It is for increasing satisfaction and confidence building measure," he told the bench. He said that the number of random matching of VVPAT slips with EVMs should be "viable" and the order for increasing it to five polling booths per assembly segment would amount to only 2 per cent.

These leaders had sought a review of the court's order, saying the "increase from one to five is not a reasonable number and does not lead to satisfaction desired by this court".

"The petitioners submit that the aforesaid increase to a mere 2 per cent is not sufficient and will not make any substantial difference to the situation that existed prior to the passing of the impugned order," they said. "Therefore, even though the petitioners have succeeded on merits of their contention, their success does not resolve their grievance or cause any meaningful change to the situation that they were originally aggrieved," the plea said.

Referring to earlier observations of the apex court, it said the 2 per cent increase in random matching of VVPAT slips with EVMs would not achieve the purpose of raising "public confidence in the integrity of the electoral process".

The plea opposed the poll panel's argument, which was earlier accepted by the court, that as the elections were nearby and hence it would not be viable to increase the number of random matching of VVPAT slips with EVMs. "It is submitted that, once this court agrees that the number of EVMs that should be subjected to VVPAT verification should be increased to a 'reasonable number', not increasing the same to a number which is 'reasonable' because it may not be 'viable' to do so renders the entire exercise otiose and futile," the plea had said.

Consequently, the 'viable number' must also necessarily be reasonable, it had said, alleging that at many

# Myanmar frees two Reuters journalists after global outrage

YANGON, MAY 7 (AFP): Two Reuters journalists jailed for their reporting on the Rohingya crisis in Myanmar walked out of prison on Tuesday, freed in a presidential amnesty after a vigorous global campaign - and backroom diplomacy - for their release.

Wa Lone and Kyaw Soe Oo were mobbed by media as they stepped out of Yangon's notorious Insein prison after more than 16 months in detention.

Their December 2017 arrests made them an international cause celebre and a sign of Myanmar's deteriorating press freedoms under Nobel laureate and civilian leader Aung San Suu Kyi.

Wa Lone, 33, thanked people from "around the world" for advocating for their release and vowed he would return to work. "I can't wait to go to my newsroom," he said. "I am a journalist and I am going to continue." Reuters editor-in-chief Stephen Adler said: "We are enormously pleased that Myanmar has released our courageous reporters".



"Since their arrests 511 days ago, they have become symbols of the importance of press freedom around the world. We welcome their return." They were freed in an amnesty that included more than 6,000 prisoners. A government spokesman told reporters that family members had sent letters to Suu Kyi and the president Win Myint. "Leaders took into consideration the

long-term interest of (the) country," Zaw Htay said. Lord Ara Darzi, a British advisor and confidant of Suu Kyi, said it was "fitting" the pair were released a few days after World Press Freedom Day. "The lesson is simple: dialogue works even in the most difficult of circumstances," he told media in Yangon.

US Vice President Mike Pence, who had previously condemned the Reuters journalists' jailing, said the release was "great news". "Freedom of religion & freedom of the press are essential to a strong democracy," he tweeted. The journalists waved and smiled broadly as they walked out of the jail.

The two men were convicted on charges of violating the official secrets act and sentenced to seven years each.

At the time of their arrest, they had been reporting on a September 2017 massacre of 10 Rohingya Muslims in conflict-hit Rakhine state, where the Myanmar army forced some 740,000

milestones, including the birth of Wa Lone's daughter. Their families were overjoyed with the news.

"We are very happy," Chit Su Win, who is married to Kyaw Soe Oo, told AFP. A reunion photo of both couples celebrating, smiling and holding each of their daughters was widely shared on Twitter.

During their imprisonment, the journalists were showered with numerous awards and honours in response to their work.

Last month, they won the prestigious Pulitzer

Wa Lone and Kyaw Soe Oo were also on the cover of TIME magazine as part of its person of the year coverage featuring journalists targeted for their reporting.

The case against them became a byword for the war against press freedom and prompted an international campaign that attracted the support of prominent rights lawyer Amal Clooney, who said Tuesday it had been an "honour to represent" her clients.

Rights groups and legal experts say the prosecution's case was riddled with irregularities.

A whistleblowing police officer testified during their trial that his superior had ordered his team to trap the reporters in a sting -- testimony the judge chose to ignore.

The now-former officer Moe Yan Naing told AFP he was "delighted" the families were back together, and expressed interest in meeting the journalists if they wanted to.

Media advocates, the UN, and rights organisations praised the release but slammed the original arrest

"We congratulate Wa Lone and Kyaw Soe Oo on walking free from unjust imprisonment and applaud they have now been reunited with their families," said Phil Robertson, Human Rights Watch deputy Asia director, adding they should have never been arrested in the first place.

Suu Kyi led her National League for Democracy party to victory in historic 2015 polls, ending decades of military-backed rule.

But the dreams of a new day for Myanmar were short-lived -- the army launched a campaign against the Rohingya in Rakhine state, which UN investigators have said amounted to genocide.

Myanmar has denied the charges and said it was defending itself against Rohingya militants, who attacked and killed police officers in August 2017.

# Training for Counting officials held in West

# South holds meeting on Pre-**Monsoon Preparedness**



NAMCHI. 07 MAY (IPR): A daylong co-ordination meeting on Pre-Monsoon Disaster Preparedness was organized by District Disaster Management Authority South (DDMA) at the Conference Hall of DAC Namchi today.

The meeting chaired by DC (South), Ragul K was held with an objective to meet the chal- munication during times lenges of the impending of disaster and urged the monsoon. The meeting was also attended by SP(S), Manish Verma, ADM (South), Satyam K Pradhan alongside SDMs and HoD's of line Departments from the district.

During the meeting, issues related to monsoon induced calamities, action plans, coordination between all line departments, and readily available assistance to reinforce normally of lives post disasters were discussed.

Speaking on the occasion, DC (S), Ragul K, highlighted that all the concerned officials and disaster management team to be vigilant and

monsoon disasters. He also spoke in detail about the availability and access of disaster management equipments and directed the stakeholders to remain vigil and ready to tackle any magnitude of disaster.

He also addresses the issues of effective compublic to report any incidents or casualties to the SDMs or the concerned officers of the area. Matters related to disbursement of ex-gratia were also taken up during the meeting.

In addition, the DC urged the representatives of different departments to ensure full preparedness to face natural calamities of any kind during monsoon season. He called for an active and correct monitoring and implementation for disaster relief plans for the district under Incident Response System (IRS).

The DC took up matters of damaged and vulnerable water pipe-

alert during times of line supply in Namchi with the PHE Dept and directed them to get the problem resolved in a timely manner. Similarly, he issued directives to Roads & Bridges Department and the Private stakeholders to ensure restoration of slide prone areas along the highway prior to monsoons and emphasized the clearance of roads in order to avoid unnecessary traffic. He asked the officials of PMGSY and Roads Department to clear the drains urgently and take preventive actions. He also asked the SDMs to inspect the roads to avoid natural calamities.

Likewise, the DC advised the Forest Department to look into the problem of reckless dumping, felling of tilted trees and plantation wherever necessary. All officials were directed to be on high alert during the monsoons and stock adequate supplies of essentials in the respective stations during the course of the meeting.

# BJP getting access to official documents in Tripura: Congress

AGARTALA, MAY 7 (PTI): A senior Congress leader in Tripura on Tuesday said the party has has lodged a complaint with the Election Commission alleging that the BJP is getting access to government documents and has demanded an inquiry into it. A BJP delegation had met the Chief Election Commissioner on May 2 and submitted a memorandum demanding the removal of Tripura Chief Electoral Officer.

Tripura Congress vice president Tapas Dey said that " ... documents attached in the BJP memorandum to the CEC include a letter of the Returning Officer addressed to the chief secretary of Tripura, a representation by Tripura Civil Service Association and the chief secretary's letter to the ECI".

Dey said the BJP was 'not supposed' to have access to such government documents and alleged they were given to the saffron party in an "unauthorized manner" and demanded an inquiry into it. Dey said he has lodged a complaint with the Chief

Election Commissioner on Monday about the BJP getting access to official letters and documents.

Earlier, the opposition Congress and CPI-M had both lodged complaints of alleged large scale rigging and irregularities in the elections in West Tripura constituency, which went to poll on April 11. Both the parties have demanded fresh elections in the constituency. BJP spokesperson Nabendu Bhattacharya denied the allegations of Dey about leakage of official documents to the BJP.

### two more cases: Sources NEW DELHI, MAY 6 vote in Ahmedabad, Modi

**(PTI):** The Commission has given clean chit to Prime Minister Narendra Modi in two more cases, sources aware of the development said Monday.

The Congress had alleged that he held a "roadshow" in Ahmedabad on April 23 and the sources said the commission has concluded that Modi did not violate the model code and the election law.

They said that the commission has also cleared Modi for his April 9 speech at Chitradurga in Karnataka where he had reportedly asked new voters to dedicate their vote for the heroes of the Balakot air strike.

On the same day, he had made a similar appeal in Ausa in Latur district of Maharashtra. The EC had given a clean chit to him in that case as well, but one of the election commissioners had given a dissenting view in the matter. Though the com-

mission has so far not made the two decisions public, with these decisions, Modi has been given a clean chit in eight matters.

The poll authorities in Gujarat are learnt to have maintained that prima facie no violation was found.

The Congress had moved the EC alleging that Modi took out a "roadshow" after casting his vote and made political remarks in violation of the Model Code of Conduct. After casting his

# Noida boy who died during class 10 exams with Stephen Hawking dreams scores nearly 100 in 3 subjects

New Delhi, May 7 (PTI): Vinayak Sreedhar, who idolised Stephen Hawking, scored nearly 100 in three subjects he appeared for during the CBSE 10 examination, and passed away in March before he could write the remaining two.

He scored 100 in English, 96 in Science and 97 in Sanskrit and could not appear for Computer Science and Social Studies.

Topping the class 10 board exams, becoming an astronaut and a trip to Rameswaram are among some of the unfulfilled wishes of Sreedhar, who was diagnosed with muscular dystrophy when he was two-years-old.

Duchenne muscular dystrophy (DMD) is a genetic disorder characterised by progressive muscle degeneration and weakness. It is caused due to the absence of dystrophin, a protein that helps keep muscle cells intact.

The results for the class 10 Central Board of Secondary Education (CBSE) examination were announced on Monday.

The Amity International School, Noida, student appeared for the exams under the general category and not the Children With Special Need (CWSN) category.

"His muscular movement was very limited. He could write slowly but since there is a time encourage him further," duration for exams he used a scribe to write English and Science exam. For Sanskrit, he insisted to write himself. His body movement was restricted and he was wheelchair-bound, but his mind was very sharp and aspirations very high," Mamta Sreedhar,

"He would always say I want to become an astronaut despite all the challenges and would say if Stephen Hawkings could go to Oxford and make a name in Cosmology I can go to space too. He was confident that he will be among top rankers. We were always amazed with his confidence and would

"We are today in Rameshwaram and are going for darshan in the evening. It was his unfulfilled wish so we decided to not postpone the plans and do it for him," his mother said.

However, Vinayak Sreedhar is not the only one in his family to make his parents proud. His sister is an Indian Institute of Science (IISc) alumnus and is currently pursuing her Phd at the University of British Co-

lumbia on a fellowship. While Vinayak's father is vice president in GMR, his mother is a

home maker by choice. "I made this choice. My entire day revolved around him. From brushing his teeth to feeding him, I did it all myself but it was his willpower which always gave us the strength," his mother said.

The Chhattisgarh police for the first time has inducted women commandos in the District Reserve Guard, its frontline

anti-Naxal force. A senior official said these women commandos were part of the security forces' "short action teams" that eliminated three Naxal "commanders" in the past one month.

The specially-raised squad, christened 'Danteshwari Ladake'. or fighters of Goddess Danteshwari, was inducted in the state's Naxal-hit Dantewada district, around 400 kilometres from here.

Comprising 30 women led by Deputy Superintendent of Police (DSP) Dineshwari Nand, officials said they have received extensive training in jungle combat.

"A first-of-its-kind platoon of women DRG commandos has been raised. Of the 30 recruits, 10 are surrendered women Naxals, while 10 others are assistant constables who were part of the erstwhile Salwa Judum (anti-Naxal militia) movement," Dantewada Superintendent of Police Abhishek Pallava told PTI. With the

commando contingent, the number of platoons of the DRG in Dantewada now stands at six, he said. Personnel of the DRG are recruited from local youth and it also has surrendered Naxals in its ranks and has of late gained a fearsome reputation for taking the fight into the enemy camp and conducting successful strikes in Maoist strong-

holds, officials said. "Although the state police and paramilitary forces in Bastar have deployed women personnel but they have limited work. It is for the first time that an exclusive team of women commandos has been set up to carry out counter insurgency operations shoulder to shoulder with male DRG members in the area," said Pallava, who is credited with in-

troducing this platoon. "These women commandos have been given three-months advanced in-house training in jungle warfare tactics. They are trained for motorcycle patrolling in the dense forests, map reading, understanding Naxal profiles and counter ambush strategy," he said.

"The important factor is all of them are lo-

Naxal women's commando unit RAIPUR, MAY 7 (PTI): induction of the women cal residents, including surrendered Naxals, and therefore are well acquainted with the forested terrain and the local language. All these are key elements in the fight

against Naxals," he said. The SP added that being able to melt into the local crowd wearing civil attire like sarees and still move around with concealed weapons gave the women commandos the "surprise element" to get the better of the Maoist

"In the past one month, this women platoon was part of the security forces' short action teams that gunned down three Naxal commanders," he said.

He said the women commandos could motivate others to join the forces and also curb chances of fake allegations of human rights violations.

A member of the platoon, Gange, a surrendered "deputy commander" with the outlawed CPI (Maoist), said, "We are feeling relieved after quitting the Naxal movement. We wanted to marry which was not allowed in the Naxal outfit. We are now living a life with dignity and purpose as police personnel.

# **Quality Education** on the Agenda

Study and evaluate, then replicate best practices

 $\mathbf{F}^{\mathrm{or}}$  quite a while now, politicians, bureaucrats, teacher associations and even student groups have been speaking of the need for government schools in Sikkim to impart quality education. The Board exam results have just come in, and in the absence of any other, easier, yardstick to measure "quality," this data should be studied some more. May be not how high the marks were, but more on how some students still manage to fail, because, let's accept it, even if one has issues with exams as the deciding factor for quality, one needs to accept that a decent education will at least equip students with enough to at least pass the exams. That said, with the big exams over and the results out, chances are that Quality Education deliberations will get mothballed again, so here goes another attempt to reiterate how quality could be achieved in education here.

To qualify the following comments, it is also recognized that experiments and efforts are currently underway in an organized manner to inject improved learning at schools and what follows should be seen as something complementing that effort.

While 'quality' is welcome in any field and because there is always room to improve quality in everything, Quality Education will be welcome. To have such a thing, however, will require more than rhetoric; it will not deliver by itself just because it is a felt-need or because it is demanded. 'Quality' will have to be defined first and then ways and means devised to meet that definition. Not enough has been done in any earnest thus far. If the policy-makers in Sikkim believe that the quality of education in schools here is inadequate, then, the first thing they will have to do is identify the gap that spans between schools in Sikkim and schools that deliver quality education here or elsewhere. Since China seems to be devising ways to deliver results on issues that India continues to only aspire for and pay lip-service to, perhaps even in this case, Sikkim should take a leaf out from how its northern neighbour achieved this end. China, with a human resource base rivaled only by India, realised that knowledge was the strongest weapon in the new millennium. Many other countries, including India, have realised this but only China appears to have addressed the issue with any intelligence and long-term commitment. One might add here that the Chinese experiment was with regard to higher education in universities. That said, the model could be adapted for school-level education as well. Recognising that the quality of its universities could use some 'quality' enhancement, the first thing that China did was carry out an honest and earnest 'Academic Ranking of World Universities' in the year 2003. The universities were graded according to the quality/ qualification of its faculty, the range of research undertaken by its students, the academic output of its staff [research papers, dissertations etc], number of awards tagged against the names of faculty and amount of future involvement of its students in path-breaking research. Then the Chinese studied the world leaders among the universities and tried to replicate their management and academic models at home. Higher education in China is already improving at a fast nip.

Sikkim needs to do something similar. It has to commission its own ranking of schools that deliver quality education and then send its officials from the HRD Department to these schools to learn how they deliver quality. While Sikkim learns what quality education is and how it can be delivered, it could also free the sector from all unproductive influence. Politics, for instance, should only influence the policy directions, not the actual human resource management and bureaucrats should be facilitators, not directors of the effort. Appointments and transfer of teachers should be freed from influence of any kind. A basic problem with government schools in Sikkim is their retention failure - their inadequacy to retain students [reflected in high drop-out rates] or even the teachers [manifested in high absenteeism, some schools without enough teachers and others with overstaffed faculty rolls]. This problem might get redressed if students had classes taught by qualified teachers to go to and if teachers had schools with at least the basic infrastructure to impart education in. If this is achieved, education would have become uniformly accessible in Sikkim and then can begin the process of improving the quality.

# The demonization of Caster Semenya continues

aster Semenya, one of the world's greatest feumale middle-distance runners, may be forced to quit the event she has dominated for a decade. After easily winning the 800-metre race at an international meet in Doha on May 3, the South African athlete was defiant in saying she won't comply with new restrictions that will be placed on her at future competitions.

"No man, or any other human, can stop me from running," she said after the race, her first — and possibly last — competition since a controversial ruling by the supreme court of international sport.

Her defiant words were in reaction to a horrible ruling by the Court of Arbitration for Sport, which denied an appeal by Semenya against the policy of track and field's international governing body.

The International Association of Athletics Federations (IAAF) had previously ruled that female athletes like Semenya who have naturally high levels of testosterone must now take hormone-suppressing drugs to compete in any event between 400 metres and one mile. (There are five such events at the international level.) The court decision means the IAAF rules go into effect May 8.

The IAAF policy is based on bad science, flies in the face of best practice in policy making, overrides human rights and will cause tremendous anxiety and even harm among the female athletes in the world, particularly those in the Global South.

**RULES COULD CAUSE HARM** 

Even the Court of Arbitration for Sport cautions that there are serious problems with the IAAF policy, including the potential for harmful side effects that hormonal treatment could cause for the athletes who must now take the medication to compete.

The Canadian Centre for Ethics in Sports, which directs Canada's anti-doping program, the Canadian Association for the Advancement of Women and Sports and AthletesCAN, the association of Canadian national team athletes, have condemned the decision. Athletics Canada has said it won't implement the policy in Canada.

Before the judgment was rendered, independent experts for the UN Human Rights group wrote the IAAF urging it to cancel the policy. But some track and field athletes came out to support the

policy, insisting that female athletes with high levels of testosterone have a "colossal" advantage.

WHY HAS SEMENYA BEEN SO DEMONIZED?

As a professor of kinesiology and physical education who competed in athletics at the 1964 Olympics, it's my view the explanation is to be found in a misunderstanding of natural testosterone, a narrow misreading of the Olympic values, the distrust engendered by almost century of sex testing in international sports and a failure of leadership on the part of the IAAF.

Synthetic testosterone is justly banned from Canadian and international sports (except for approved therapeutic purposes). If taken carefully, at the time of hard training, it can enable significant strength and speed gains and reduce the risk of injury.

#### **NOT A RELIABLE MEASURE**

But natural testosterone is not the same thing. It may aid performance, but it may not. As Yale University researcher Katrina Karkazis has argued, there is no predictable relationship between natural testosterone and improved performance. Even in the same person, testosterone levels can change over time, depending on a range of factors. It's not a reliable measure, and it will be very difficult, if not impossible, to monitor without frequent, invasive testing.

Then there's the ethical question. On what basis do you exclude athletes because of who they are? Natural testosterone is a human condition. When I used to urge athletes against doping, I often said "play with your own chemicals." Now the IAAF is banning female athletes who play with their own chemicals. The Court of Arbitration for Sport emphasized that Semenya was not cheating, and that she should be admired for her athleticism and courage.

High natural testosterone occurs from a genetic mutation, not unlike the hundreds of other genetic mutations that confer advantage in sports, such as exceptional height, reach and ability to draw oxygen into the blood stream. Virtually every top athlete has at least one of these inherent advantages. The Olympic spirit is to rejoice in the diversity of humankind.

### FAIRNESS? LET'S ADDRESS THESE ISSUES

If the concern is really the fairness of condition, those who fear Semenya should address the huge international differences in personal and national

income, the most consistent factor determining athletic performance because of the advantages it can buy in better training facilities, nutrition, coaching, medical assistance and so on.

Why is no effort made to balance out these other factors? Would Canadians who support the IAAF against Semenya like it if they were required to train under the same conditions as their competitors from the Global South? Of course not.

Sadly, Semenya has not been the first highly successful female athlete to be accused of masculine qualities and to face banning from sports. In fact, from the very beginning of high-level women's sport, the best athletes have been so vilified. **SEX TESTING STARTED DECADES AGO** 

In the 1930s, the men who controlled sports claimed that such women were "abnormal" and introduced "gender verification" to police them. In the 1960s, when women from the Soviet Union and the newly independent nations of the Global South, many of whom didn't look like western women, began to win many of the medals, the test was made universal.

Every female athlete I know can recount the stress of "gender verification" and hundreds suffered from the stigma of false positives. Worldwide opposition led to the abolition of the universal sex test in 1999, but the very same people who administered it tried again when Semenya raced onto the scene. The legacy of this history continues to pit women against women and poison the sport.

What's most troubling is the way the IAAF leadership has aggressively campaigned for this test. Instead of standing up for Semenya, admiring her and conducting an educational campaign to clarify the issues, IAAF president Sebastian Coe has made it his personal crusade to chase her from the sport.

But history is on Semenya's side. As the Court of Arbitration for Sport's decision acknowledges, there are so many problems with the IAAF policy that no doubt another legal challenge will be mounted before long.

Let's hope that the next time, gender policing in sports will be abolished once and for all. And let's hope that more track and field athletes will recognize the justice of Semenya's cause and support her.

# Global inequality is 25% higher than it would have been in a climate-stable world

Those least responsible for glob-**L** al warming will suffer the most. Poorer countries - those that have contributed far less to climate change - tend to be situated in warmer regions, where additional warming causes the most devastation. Extreme weather events such as Syria's prolonged drought, South Asia's catastrophic monsoon floods, and Cyclone Idai in South-East Africa, the third deadliest cyclone on record, are becoming more likely and more severe.

These events are disproportionately bringing death, displacement, and crop failure. As a result of this, projections estimate that the economies of poorer, warmer countries will be gravely harmed by climate change over coming decades, while the cooler, richer countries responsible for the vast majority of the extra CO2 in the air may even benefit in the short term. But as new research reveals, this is not just a future concern - the economic injustice of climate change has already been operating for 60 years.

The study, published in the Proceedings of the National Academy of Sciences, compared different countries' GDP per capita - a measure of the average person's economic stan-

2010. It then used climate models to estimate what each country's GDP would have been without the effects of climate change. The findings are stark.

Many poorer countries' economies have rapidly grown in the last 50 years, albeit often at great social and environmental cost and to the benefit of the globalised economy. But even that growth has been held back substantially by climate change - the gap in GDP per capita between richer and poorer countries is 25% higher than it would have been in a climate-stable world. And with most richer countries sitting below and poorer countries above the 132 average annual temperature at which economic productivity peaks, global temperature rise is an immediate driver of this inequality.

Of the 36 countries with the lowest historical carbon emissions, which are also some of the poorest and hottest countries in the world, 34 have suffered an economic hit compared to a world without warming, losing on average 24% of GDP per capita. The poorest 40% of countries, much of which are located in sub-Saharan Africa, Asia, and Central and South America, have lost between 17 and 31% of GDP in the last

dard of living - between 1961 and per capita, has been regarded as an economic growth champion in recent decades - but climate change has slowed its progress by 30%. While the country's services sector has boomed, the agricultural sector which employs half of India's total workforce - has suffered greatly. A three-fold rise in extreme rainfall events and increased severe droughts have reduced crop yields and cause between \$9 and 10 billion in damage per year to the agricultural industry alone.

The same events also regularly bring India's urban economic hubs to a standstill. With 12m inhabitants, Mumbai has the world's largest population exposed to coastal flooding. Deluges in 2005 and 2014 forced the city's international airport and roads to close, and cost millions in

property damage. Increasingly intense Indian summers that now regularly hit above 452 reduce productivity, kill thousands, and cause thousands more to commit suicide. Add to this the multi-billion pound costs of rescue and rebuilding from cyclones such as 1999's Odisha storm, which left two million homeless, and it's easy to see how climate change can stunt the economic growth of India and similarly affected countries.

For the world's wealthiest coun-

tries however, climate change has added to the coffers - 14 of the 19 highest-emitting countries now find themselves in a better economic position than they would have been if the planet's temperature had stayed constant, with an average boost of 13%. The US economy has suffered, but by a miniscule 0.2%, while the UK finds itself 10% better off. The 2018 heatwave there posed its own risks to health and crops, but it also provided huge boosts to ice cream sales and tourism. **CANCEL DEBTS** 

As is becoming increasingly clear, there are no quick fixes or easy solutions to climate change or inequality. Reducing emissions is, sadly, not enough, and providing yet more high-interest loans to "help" poorer nations adapt to a warmer world will only deepen global inequality. Alongside radically changing the economies of the world's wealthiest nations, we must demand that reparations for past injustices be paid, that the debts of the Global South be cancelled, that privatisation of local industries and lands be reversed, and that the brutal border regimes surrounding the world's wealthy nations be torn down. Only then can global inequality truly be tackled.

# Modi should get "tight slap" of democracy: Mamata

RANIBANDH/RAGHU-NATHPUR (WB) MAY 7 (PTI): "Narendra Modi should get a tight slap of democracy," a furious TMC supremo Mamata Banerjee said Tuesday, hitting back at the prime minister for alleging repeatedly that her government is run by extortionist syndicates.

She also questioned the BJP's nationalistic and patriotic claims, saying it was an "RSS man" who killed Mahatma Gandhi.

"I do not bow my head in politics. When Modi alleges that Trinamool Congress is a party of syndicates...its government is run by syndicates, I feel he should get a tight slap of democracy (be defeated in election)," she said at a public meeting at Raghunathpur in Purulia.

Calling Modi a prime minister who is "known for telling lies", Banerjee said during his visits to West Bengal for election he says her government does not allow Durga Puja and other Hindu rituals to be performed. "Do



you believe those allegations?" she asked.

Joining issue with the prime minister over his claim that she does not allow people to chant "Jai Sri Ram" and throw those who do behind bars, she said, "I will not join them (the BJP) in shouting their slogan. I will rather

NEW DELHI. MAY 7 **(PTI):** State-owned steel maker SAIL Tuesday said it is supplying parallel beam electric poles for restoration works in the cyclone-affected areas of Odisha.

The Ministry of Steel has directed Steel Authority of India Ltd (SAIL) to ensure all-out efforts to meet the requirements of cyclone-hit Odisha, SAIL said in a statement.

"SAIL is moving special-quality wide parallel beam (WPB-160) electric poles on the topmost priority basis to cyclone Fani-affected areas in Odisha. SAIL moved the first consignment of 500 electric poles to the disaster-affected areas, another 5,000 poles have already moved to the affected areas," the firm said.

The company has assured to move a total of 15,000 such poles in a time-bound manner, it added.

Restoration of electricity is a priority and for this purpose, SAIL said it is mobilising all resources from various locations of the country

to move the electric poles on an urgent basis to the affected areas.

Cyclonic 'Fani' made a landfall on the Odisha coast on the morning of May 3, packing heavy rain and winds with speeds of up to 175 kmph.

Till Monday, death toll due to the cyclone rose to 35 in Odisha, as lakhs of people still grapple with water shortage and snapped power supply, three days after the storm barrelled through the coastal parts of the state.

# In Delhi-6, traders grapple with post-note ban woes; residents cite lack of infrastructure

ANJALI PILLAY AND SALONI BHATIA NEW DELHI, MAY 7 (PTI): Chandni Chowk, the famed Delhi-6 glamorised in Bollywood films, is not all about sheen. A lack of infrastructure and stalled redevelopment projects are among the issues residents and business community grapple with in this Lok Sabha seat.

The traders of Chandni Chowk are still struggling with the after-effects of GST and demonetisation and residents of the walled city complain about the shortage of basic facilities.

In the constituency comprising 10 assembly segments of Adarsh Nagar, Shalimar Bagh, Shakur Basti, Tri Nagar, Wazirpur, Model Town, Sadar Bazar, Chandni Chowk, Matia Mahal and Ballimaran, with 15,62,268 registered voters, traders and Muslim votes will hold the key. The Lok Sabha seat, which has been represented by the likes of senior Congress leader Kapil Sibal, Union minister Vijay Goel, is a perfect mix of commercial, residential, colonies, multi-storey flats and the heritage of old Delhi.

The markets in the constituency -- Chandni Chowk, Sadar Bazaar -- are known to be a shopper's paradise across the country. Traders in the constituency said they were hit by the 2016 demonetisation and found it difficult to comprehend the GST. Many were also affected by the sealing drive. "It's the traders like us who bear the brunt of it. GST was a welcome step, but its lack of uniformity was a disappointment," said Neeraj Jain, owner of Namo Traders in Chandni Chowk.

A representative of GD Jewellers in Kucha Mahajani said they are suffering because of the never-ending redevelopment project that is waiting for completion. "Several roads are blocked and customers, who want to buy in bulk, do not want to come here," the representative said. The parking infrastructure has been demolished and customers prefer to go to other areas, he said, adding that business has seen a decline by 60 per cent from December last year.

Yogesh Singhal, president of Delhi Bullions and Jewellers Association, said demonetisation and GST were good steps taken by the government but needed better implementation.

He said the indirect tax regime needs to be made more sound technically with reduction in the paperwork.

Ashish Nahar, another trader and also a resident of Chandni Chowk, said smaller businessmen had to pay Rs 5,000 to chartered accountants to get their GST returns filed.

Security of women is also an issue in the constituency. Locals said women also face harassment while walking down from Chandni Chowk metro station to the market due to encroachment and because of the large presence of cart sellers who ensure the narrow lanes become narrower and there is

bare minimum space to walk. Nahar also expressed concern over the dangling overhead electric wires that pose a threat to safety and complained how despite the locals agreeing to bear the costs of underground wiring system, authorities have been deaf. Complaining about bad roads and water issues, Anita Gupta, a resident of Nai Sadak, said ambulance cannot enter the narrow lanes incase of an emergency.

"It is scary to think what will happen if a fire breaks out since the fire-tenders won't be able to enter," she said. Political parties are seeking votes in the name of nationalism and full statehood for Delhi and some residents feel this Lok Sabha election is different. "This election is not about water, electricity or inflation. In fact, this election is being fought on nationalism," said Varun Khandelwal, a resident of Paharganj. Some traders said the Centre and the Delhi government are taking credit for some of the initiatives of the past Congress governments at the Centre as well as in the national capital.

"Even posh areas like Model Town have issues of clean water and sewage system," said Gauri Bhatia, a resident of Model Town and a teacher of a school in Ashok Vihar. The constituency is seeing a three-corner fight between the BJP, Congress and the Aam Aadmi Party.

Incumbent BJP MP Harsh Vardhan is pitted against Congress' old-timer I P Agarwal, who represented the seat in 1984, 1989 and 1996 and AAP's Pankaj Gupta who is making his electoral debut. Agarwal said he is fighting on all the issues be it sealing, GST and demonetisation. "Government did not do anything to help traders who were fed up with demonetisation and GST," he said.

Vardhan blamed the AAP government for not cooperating in several developmental projects, including the Shahjahanabad redevelopment project.

"Look at the Rani Jhansi flyover, it was lingering on for almost 10 years. I took up this project and every 15 days, I used to have a meeting and visit the project site. When there was some difficulty, I got Rs 86 crore sanctioned from the Centre to ensure that the municipal corporation does not run out of money," he said. If elected to power, AAP candidate Pankaj Gupta said he plans to convert parks in his constituency into "lungs" for the national capital.

"My constituency has the highest number of parks and if they are maintained properly then they can be made into lungs of this city and can also act as a tourist attraction," Gupta said.

Noting that sealing of shops has broken the backbone of the middle class community in his constituency, he said it has led to massive unemployment and that is another area he plans to work on. All the seven Lok Sabha seats of Delhi will go to polls in the sixth phase of the general election on May 12.

# Pep disciple Ten Hag takes Ajax to brink of historic final

AMSTERDAM, MAY 7 (AFP): There are few clubs with a history to match that of Ajax, but they are in the process of writing a new chapter in Amsterdam with Erik ten Hag taking them to within sight of a first treble since the days of Johan Cruyff. On Sunday, Ten Hag's spellbinding team secured the first leg as they beat Willem II 4-0 to win the Dutch Cup.

The battle with PSV Eindhoven for the Eredivisie title resumes this weekend, and by then Ajax could be through to their first Champions League final since 1996.

They take a 1-0 lead into their semi-final second leg against Tottenham Hotspur on Wednesday, with young stars like Matthijs de Ligt, Frenkie de Jong and Donny van de Beek mesmerising Europe on a run that has already seen them defeat Real Madrid and Juventus. Those players have dominated the headlines. but the work done by the 49-year-old Ten Hag has been remarkable, and entirely in keeping with his progress up until now.

His career as a player was unremarkable by comparison, with the 2001 Dutch Cup the only major trophy he won on the field. The midfielder



captained Twente to victory on penalties against PSV Eindhoven.

"He was the captain, he led by example and he always had a lot of confidence," Scott Booth, who played in that Twente side, told AFP.

Booth, a former Scotland striker, scored in the penalty shoot-out that day. He remembers Ten Hag as "not international class, but a very good club player."

"He was loyal to the club and to his teammates, he loved the game and he loved talking about the game."

Ten Hag was close to Fred Rutten, his coach at Twente, and after ending his playing career aged just 32, he later became Rutten's assistant at PSV. - GUARDIOLA SCHOOL -

Prior to that, though, he had a spell as an assistant to Steve McClaren at Twente, helping lay the groundwork for the Englishman to go on and win a first ever Dutch title with them in 2010. Europa League runners-up in 2017, Ajax were knocked out of both European competitions in the preliminary rounds last season, but Ten Hag steered them to a second-place finish. The foundations were laid for this season's run.

"What he is managing to do with such young players is remarkable," former striker Pierre van Hooijdonk, now a leading pundit, told TV station NOS. "The likes of De Ligt, De Jong and Van de Beek have only just come out of the academy and are already playing like veterans. Ten Hag deserves huge credit."

If they go on to win a first treble since 1972, when Cruyff was starring on the field, then Ten Hag will go down as a legend at a club that has had so many great names down

### Llong under BCCI scanner but unlikely to be removed from IPL final

NEW DELHI, MAY 7 (PTI): English umpire Nigel Llong could face the BC-CI's scrutiny for allegedly damaging the door of a stadium room after an argument with Virat Kohli but the Indian board is unlikely to remove him as an official for the IPL final on May 12.

Llong reportedly lost his cool after being confronted by Royal Challengers Bangalore skipper Kohli over a contentious no ball call against Hyderabad Sunrisers during an IPL match on Saturday in Bengaluru.

According to reports, the ICC Elite Panel official kicked the door of the umpires' room during the innings break and damaged it.

A BCCI official told PTI that Llong might have some explaining to do but the matter will not cost him his place as a designated umpire for the IPL final to be held in Hyderabad.

The BCCI, it is learnt, is in a dilemma on whether to even consider taking such a step "for a moment's indiscretion".

In Bengaluru, Karnataka State Cricket Association secretary R Sudhakar Rao said the KSCA has demanded action against Llong. Rao, however, did say that the 50-year-old paid for the damage caused.

"We have reported the matter to the Committee of Administrators (COA) and hopefully action will be taken against Nigel Llong. If the players are punished for their misdemeanour and fined their match fees then why not the umpires," he said.

"I didn't speak to umpire Llong but I spoke to match referee Narayanan Kutty. I am hopeful COA will take action," he added.

Llong paid Rs 5000 after he was confronted by the KSCA officials and had demanded a receipt of the payment.

Llong has stood in 56 Tests, 123 ODIs and 32 T20 Internationals in his career and will be standing in the upcoming World Cup in the United Kingdom, starting May 30.

# First woman to land on moon will be American: Pence

"That's why we assembled this Users' Advisories Group in the National Space Council, which, I'm proud to say has brought together some of the brightest minds and biggest talents in the



country to help accelerate innovation across the space enterprise," he said.

More than 15,000 scientists and industry representatives 105 countries, including India, are attending the four-day mega event beginning May 6 in Washington DC.

It is touted to be the largest commercial satellite industry event. It has featured headline keynote appearances from Amazon and Blue Origin founder and CEO Jeff Bezos, SpaceX founder and CEO Elon Musk, One Web founder Greg Wyler, among many other. Noting that other nations are joining the space race, Pence said while their capabilities increase, the truth of the matter is that there's no guarantee nations around the world share same values, ideals, or the US commitment to freedom and the rule of law and peace.

From anti-satellite weapons and airborne lasers, to highly threatening, on-orbit activities and evasive hypersonic missiles, our competitors and

THE HAGUE, MAY 7 (PTI): Kerala Chief Minister Pinarayi Vijayan will commence a four-nation tour of Europe with a visit to the Netherlands from May 8-12, at the invitation of the Dutch government to explore possibilities of cooperation in water management, flood prevention and agriculture.

The Netherlands, with 26 per cent of the country below sea levels is a world leader in the field of water management and flood control. It is also the world's second largest exporter of agriculture products.

Kerala witnessed the biggest floods in 100 years in August 2018.

"During the visit, the Kerala Chief Minister will meet Minister Cora van Nieuwenhuizen, Dutch minister for infrastructure and water management and Jan Kees Goet,

secretary general of the ministry of agriculture," a statement issued Tuesday by the Indian Embassy here said.

He will interact with

representatives of business community in a meeting organized by Hans De Boer, president VNO-NCW (Dutch employers' federation), it said. The chief minister will visit the port of Rotterdam to discuss inland water management and also see first hand measures taken for flood control and water management by the Dutch government, the statement said. "He will meet agricultural experts of the University of Wageningen to understand latest agricultural techniques in horticulture and flori-

### Trump awards highest US civilian honour to Tiger Woods

BY LALIT K JHA WASHINGTON, MAY 7 (PTI): US President Donald Trump on Monday bestowed Tiger Woods with the Presidential Medal of Freedom, the nation's highest civilian honour, describing the golfer as "one of the greatest athletes in the history of sports." Woods, 43, is only the fourth and the youngest golfer ever to have received the highest

American civilian award. Calling Woods, "a global symbol of American excellence, devotion and drive," the president said, "Tiger's determination and work ethic drove golf to new heights of athletic competition and popularity." In his remarks, Trump praised Woods as "one of the greatest athletes in the history of sports." Trump said, "we were in the presence of a true legend" who is "also a great person, a great guy".

"We can't wait to see what's next, Tiger," said Trump, an avid golfer and owner of several golf courses around the world. Woods choked up as he thanked his mother, his two children, his girlfriend and his caddy during the ceremony on Monday in the White House Rose Garden.

"You've seen the good and the bad, the highs and the lows, and I would not be in this position without all of your help," Woods said, who dominated the sport for more than a decade. He won his first major in nearly 11 years at last month's Masters Tournament, a comeback that captivated the sporting world.

Woods's Masters victory was his 15th major championship, during which he weathered a marital infidelity scandal that ended in divorce, a debilitating spine injury, an addiction to prescription painkillers and grave doubts about his athletic longevity.

Trump has long been a fan and recently, a business partner of Woods.

He announced his decision to give the award to Woods in a tweet, after Woods won the Masters tournament last month, his first major title since the 2008 US Open, capping a remarkable comeback from personal turmoil and physical injuries. Trump praised Woods' "relentless will to win, win, win". "These qualities embody the American spirit of pushing boundaries and defying limits," Trump said.

president The seemed particularly impressed by what he called "record setting ratings" on television. He noted that Woods has now won 81 PGA tournaments and the second most majors. He also praised him as a "devoted philanthropist," noting, "That's how I first met Tiger." He added, "We are inspired by everything you've become." Woods was given

standing ovation in the Rose Garden of the White House. According to ESPN, Woods is the 33rd sports figure and the fourth golfer to be honoured with the Presidential Medal of Freedom.

At the age of 43, he is by far the youngest living sports figure to be honoured. The other golfers were Arnold Palmer, 74, in 2004; Jack Nicklaus, 65, in 2005; and Charlie Sifford, 92, in 2014. Sifford was the first African American to play on the PGA tour.

## India, Germany, Brazil, Japan 'absolutely needed' at UNSC as permanent members: France

**UNITED NATIONS, MAY 7 (PTI):** India cient for the decades to come. and nations like Germany, Brazil and Japan are "absolutely needed" as permanent members of a reformed and enlarged UN Security Council to better reflect contemporary realities and the addition of these key members to the UN high-table is among France's "strategic" priorities, the French envoy to the UN has said.

India is at the forefront of efforts at the UN to push for the long-pending reform of the Security Council, emphasising that it rightly deserves a place at the UN high table as a permanent member.

"In terms of policy, France and Germany have strong policy which is to work together to enlarge the Security Council and to succeed in terms of the negotiations that should lead to the enlargement of the Security Council that we consider absolutely needed to better reflect the world as it is. There is no question about it, France's Permanent Representative to the UN Fran ois Delattre told reporters here last week.

Speaking along side German envoy to the UN Christoph Heusgen at the end of Germany's Presidency of the Council for April, Delattre emphasised that France considers that Germany, Japan, India, Brazil and a fair representation of Africa in particular are absolutely needed at the table to get towards a fairer representation of the Security Council. This is for us a matter of priority."

He underlined that Paris believes the enlargement of the Security Council with the addition of a few key members is "one of our strategic priorities."

Noting that when France and Germany launched their alliance for multi-materialism, he said it signifies that the two nations strongly believe in the UN as the core of today's global governance and that they strongly believe in "multi-lateralism and means that we are actively working to reform and in some respects to refound, reinvent multi-lateralism so that it is really effi-

India's Permanent Representative to the UN Ambassador Syed Akbaruddin, speaking at the informal meeting of the Plenary on the Intergovernmental negotiations on the question of equitable representation on and increase in the membership of the Security Council earlier this year, had said that on the issue of Categories of Membership', a total of 113 Member States, out of 122 who submitted their positions in the Framework Document, support expansion in both of the existing categories specified in the Charter.

In short, more than 90 per cent of the written submissions in the document are in favour of expansion in both categories of membership specified in the Charter, he had said.

Akbaruddin had said that while reform at the UN is a process rather than an event, there is no process known to us here that has traversed winding pathways in the manner as this process of the Reform of the Security Council."

In terms of inertia too, it has no peer. While the world is not what it was when we began the process, the objections to moving forward remain the same. While the global challenges of the 21st century have multiplied, we remain divided even about the process to adopt in order to move forward, he had said.

France has maintained that if the crises of recent times have confirmed the centrality of the UN, they have also reinforced the need to make the organisation more effective and more representative of the current balances in the world.

"That is why France pushes for the expansion of the Security Council by supporting the accession to a permanent seat of Germany, Brazil, India, Iapan, as well as a greater presence of African countries," according to the Permanent Mission of France.

Alexander Acosta told US

lawmakers. Testifying before a Congressional committee on annual budget of the Department of Labour for the fiscal year 2020 beginning October 1, 2019, Acosta, however, did not give details of the proposed increase in H-1B filing fee and as to which categories of applicants it would be en-

But given past experience, the Indian IT companies, which account for a large number of H-1B applications, are likely to face the additional financial burden because of this proposed increase in H-1B filing fees.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. The technology companies depend on it to hire tens of thousands of employees each year from countries like India and China Arguing that foreign-

ers hurt American workers by competing for jobs and driving down wages, the Trump administration has tighten the noose around the H-1B visa programme. The Seattle Times on Monday reported that last year immigration officials denied nearly one out of every four requests for new visas for skilled foreign workers.

In FY 2020, the Department's budget includes USD 160 million to continue our expansion of apprenticeship programmes, along with a proposal to increase H-1B fee revenues to fund additional apprenticeship activities, Acosta said in his testimony on May 2 before the Senate **Appropriations Commit**tee Subcommittee on Labour, Health and Human Services, Education and Related Agencies.

Acosta told lawmakers that last year the Department of Labour had launched the first-ever apprensector-based ticeship grant funding opportunity to invest USD 150 million to expand apprenticeships in those in-demand industry sectors most often filled by individuals on H-1B visas, such as information technology, health care and advanced manufacturing.

This grant funding opportunity introduced an innovative approach: a 35 percent private-sector match requirement. This brings the total investment to USD 202.5 million, USD 57.7 million coming from the private sector, he said.

"As a result of this private sector match requirement, educators have a greater incentive to join with industry to ensure curricula address the needs of our ever-changing workplace, investing in the latest technologies and techniques, and providing more in-demand opportunities for Americans,

Acosta said.

On July 18 last year, the Department of Labour had announced USD 150 million in H-1B funds to support sector-based approaches to expanding apprenticeships on a national scale

in key industry sectors. The focus is on inustries reliant on H-1B visas. It aims at expanding apprenticeships and increase the level of apprenticeship activity among a range of new employers within these industries, particularly small- and medium-sized businesses.


Acosta also told lawmakers that the Labour Department has also made changes to the H-1B application forms to ensure greater transparency and better protect American workers from employers seeking to misuse the programme.

In fiscal 2018, the Department concluded 649 non-immigrant visa programme cases and found violations in 553 of those cases.

In a news story, Breitbart News said that every year, more than 100,000 foreign workers are brought to the US on the H-1B visa and are allowed to stay for up to six years. There are about 650,000 H-1B visa foreign workers in the US at any given moment, it added.

"Let's put our citizens first and protect US workers and wages. Hard-working and highly-skilled American men and women share their stories about H-1B visa fraud and abuse, Congressman Paul Gosar said.
