Olympic medallist gymnast Miller hails Dipa for showing path to youngsters Mumbai, Ian 16 (PTI): Seven-time Olympic medallist gymnast Shannon Miller on Thursday said Indian trailblazer Dipa Karmakar has shown the young athletes that anything could be achieved with hard work and passion.

"What Dipa (Karmakar) has done has shown the next generation of young athletes all over India that it is possible

with hard-work and passion to go the height of Olympic Games and it is a great way to inspire youth of India," 42-year-old Miller, the event ambassador of Tata Mumbai Marathon, told reporters here on Thursday.

Miller, a former American artistic gymnast, was the 1993-94 world all-round champion, the 1996 Olympic balance beam champion, the 1995 Pan American Games champion and a member of gold-winning-magnificent seven team at the

Karmakar rose to fame during the 2016 Rio Olympics where she finished fourth in women's vault event. She was the first Indian woman gymnast to compete in the

1996 Olympics.

Speaking about her journey, inspirational Miller said, "We talk about success but it doesn't come without failure. It is essential to learn how to back yourself up, if not succeeding. For me, it is challenging myself every day to do something more than I usually do.

### India, Bangladesh hold discussions on joint study for proposed free trade pact proposed Comprehen-

New Delhi, Jan 16 (PTI): India and Bangladesh on Thursday held discussions on a joint study for the proposed free trade agreement and harmonisation of standards with a view to boost two-way commerce, the government said on Thursday.

"Both sides held extensive discussions on a variety of issues of mutual interest, like Border Haats, joint study for the sive Economic Partnership Agreement (CEPA), CEOs' Forum, sharing of trade data, regional connectivity initiatives, harmonization of standards, upgradation of border trading infrastructure and facilitation of business visas," the commerce ministry said in a statement.

The CEPA is a free trade agreement under which two trading partners significantly reduce or eliminate imports duties on maximum number of goods traded between them. They also liberalise norms to promote trade in services sector and boost investments. Before initiating formal negotiations for such pacts, trading partners undertake a joint study to see the potential benefits of such agreements. The two-day commerce secretary level meeting between the two

sides was concluded here on Thursday. The meeting, it said,

was preceded by the 12th meeting of the Joint Working Group on trade. In a separate state-

ment, the ministry said that the first session of India-Norway dialogue on trade and investment was convened here.

Both the sides discussed issues of various areas like blue economy, shipping and maritime, ICT, renewable energy and the micro, small and medium enterprises.

"Both the sides exchanged views on investment opportunities available in the respective countries," it said.

The Department for Promotion of Industry and Internal Trade (DPIIT) highlighted various policy initiatives of the government for promoting investment in the country.



Prof SK Neogy from ISI Delhi delivered a lecture over Skype for the participants. There were more than 50 participants (including the local participants from Sikkim) for the workshop from different institutions such as IITs, NITs and other reputed institutes including Sikkim University and Sikkim Manipal Institute of Technology.

This workshop is a continuation of the workshop organized in MAHE, Manipal by Centre for Advanced Research in Applied Mathematics and Statistics (CARAMS) in December 2018. The current workshop covered the necessary basics required for the new participants to follow the lectures.

The workshop started with the basics of game theory, stochastic matrices and covered matrix theory to introduce the linear complementarity problems and special matrices such as positive matrices, completely positive matrices, Q matrices, etc.

This workshop targeted PhD scholars, faculty working in Linear Algebra, Special Matrices, Game Theory, etc., and motivated final year MSc/MPhil students who are interested to pursue a career in matrix theory, game theory, stochastic matrices, and linear algebra.

# MHA convenes meet to discuss modalities for census, NPR

(PTI): The Union Home al Register of Citizens it. Ministry has convened a meeting on Friday to discuss the modalities for the 2020 Census and the National Population Register (NPR), officials said.

Union Minister of State for Home Nityanand Rai will chair the meeting which will be attended by Union Home Secretary Ajay Bhalla and Chief Secretaries and Census Directors of all states.

The meeting will discuss the modalities for the houselisting phase of the census and the NPR, to be carried out from April 1 to September 30, a Home Ministry official said.

West Bengal Chief Minister Mamata Banerjee has already announced that representatives from her state will not attend the meeting.

A few state governments, including West Bengal, have declared that they will not participate in the NPR exercise now as it is a prelude to

Officials said the objective of the NPR is to create a comprehensive identity database of every usual resident in the country. The database would contain demographic as well as biometric particulars, they said.

The notification for the houselisting and NPR exercise came amid furore over the contentious Citizenship Amendment Act (CAA).

The ministry officials said most states have notified provisions related to the NPR, which is a register of usual residents of the country. It is being prepared at the local (village/sub-town), subdistrict, district, state and national levels under provisions of the Citizenship Act, 1955 and the Citizenship (Registration of Citizens and Issue of National Identity Cards) Rules, 2003.

The data for NPR was last collected in 2010 along with the houselisting phase of the Census 2011. Updating of this data was done in 2015 by conducting door to door survey.

While updating the register in 2015, the government had asked for details like Aadhaar and mobile numbers. This time, the information related to their driving licence and voter ID card may also be gathered, the officials said, adding that PAN card details will not be collected as part of this

exercise. For the purposes of the NPR, a usual resident is defined as a person who has resided in a local area for the past six months or more, or a person who intends to reside in that area for the next six months.

The law compulsorily seeks to register every citizen of India identity card.

The NPR exercise will be carried out between April and September 2020 in all states and UTs, except Assam, along with the houselisting phase of the census ex-

Assam has been excluded because the National Register of Citizens (NRC) exercise has already been conducted in the state.

The demographic details of every individual are required for every usual resident: name, relationship to head of household, father's name, mother's name, spouse's name (if married), sex, date of birth, marital status, place of birth, nationality (as declared), present address of usual residence, duration of stay at present address, permanent residential address, occupation, educational qualification. The Union Cabinet has approved Rs 3,941.35 crore for the NPR exercise.

## Himachal IG suspended again in custodial death case

SHIMLA, JAN 16 (PTI): The Himachal Pradesh government has again suspended Inspector General of Police ZH Zaidi in a custodial death case, DGP Sitaram Mardi said Thursday.

Zaidi was suspended in 2017 after his arrest in connection with the custodial death of a Nepalese national in the Gudia rape and murder case.

The state government had revoked his suspension in November last year.

Earlier, it had rejected the application for revoking his suspension thrice.

Commenting on the development on the sidelines of a farewell function for Assembly Speaker Rajeev Bindal, Chief Minister Jai Ram Thakur said Zaidi was suspended on Wednesday.

The CM said he was suspended as former Shimla SP Soumya Sambasivan in a written statement before a CBI court in Chandigarh had alleged that Zaidi pressured her over the phone to change her statement in the custodial death case.

Thakur said the CBI forwarded the written statement of Sambasivan to the state DGP, who in turn sent it to state government, which decided to place him again under suspension.

Zaidi was posted as the CEO of the the state Wakf Board after his suspension was revoked last

Eight police personnel, including IG Zaidi and DSP Manoj Joshi, were arrested by the CBI on August 29, 2017 while former Shimla SP DW Negi was arrested on November 16, 2017 in connection with the custodial death.

Suraj, an accused in the Gudia rape and murder case, had died at the Kotkhai police station in July 2017.

Gudia (16) had gone

missing in Kotkhai on July 4, 2017 and her body was found from the Halaila forests two days later. The autopsy had confirmed rape and murder. Following a public outcry, a special investigation team, headed by Zaidi, was set up by the then Congress government. The SIT arrested six people and after the custodial death of Suraj, the High Court handed over the investigation of both cases to the CBI.

## Back to School

## Let's make this year genuinely about students, learning and schools

overnment schools across the State will soon be Gopening their gates to welcome students back to a new academic session after a shortened winter break. Some schools begin a new year in upgraded avatars, even as some primary schools will not be reopening this year because the low enrolment numbers just don't justify their continuation and the human resource can be much better deployed else-

The closure of anything is a difficult moment, especially when it is a place of learning and holds so many memories and significance for so many lives. But some closures are practical necessities, and it makes sense for the Education Department to focus on the schools which still retain students and staff them with the best of faculty and facilities. In this regard, Sikkim's falling fertility rate and growing awareness among the youth could prove a boon for the coming generations. If Sikkim can manage its resources well, then the young can now be lavished with infrastructure, resources and access much in excess of what their numbers require or the previous generation received. It is simple. There might be fewer students coming into schools, and maybe some schools will even shut down, but the number of books, libraries, laboratories, and most importantly, teachers, will not go down and if anything, will only increase. What this means is that if Sikkim's planners can, well, plan, then this abundance of learning resources can be assigned in ways that every child in a government school gets focused and dedicated attention. This is an opportunity which is pregnant with immense possibilities if it is taken as an opportunity and not rued as a down-

Meanwhile, the winter break ending soon, and thankfully the new holiday schedule has kicked in to ensure that academic breaks are not so long that too much time is wasted every new session just repairing academic connections for students. There is also a new transfer policy in place for the teachers and the promising EQUIP initiative is looking to expand its footprint. All of these make the start of a new academic year exciting and one hopes that the mood sustains. And the excitement is palpable in more obvious terms as well, as for instance, in the preparatory rush expected at stores dealing in uniforms and books and in the number of laundry-fresh uniforms all over the state as students and teachers return to class.

In the coming weeks, Sikkim will also learn whether the Department responsible for education in the State has done any learning while the students and teachers were away. The good news is that education has always been an expressed priority, and hopefully, some effective teacher transfers and primary education will now receive primary attention.

And what is it that schools, whether primary, secondary or senior secondary, should deliver?

If nothing else, then at least a generation that is better lettered, less parochial and more inquisitive. Look at it this way, Sikkim always had among the best per capita distribution of schools and the most enviable teacher-student ratios. It also now arguably has the highest per capita density of universities and children now have more options to explore by way of higher education. Without getting into the "quality" or reliability of the institutions of higher education, imagine a scenario where the schools here fostered a real thirst for knowledge that universities could help quench and expand. For far too long, schools have been about regimented teaching, and that has clearly not worked too well. How about the State started getting more liberal with the learning process? Open more minds, and they will not only take care of themselves, but also carry the state along. Now that there are fewer students in the classrooms and more options in the staff room, wider explorations are possible if the teachers were freed from clerical chores and inspired to work more with the students. With fewer schools to look after, the finances could also be invested more keenly on improving the learning environments at schools and making classrooms more student and learning friendly. One hopes that fewer teachers are borrowed out of classrooms to stand-in for tasks they are neither trained nor appointed for. One hopes that education-related problems will receive immediate attention and are not kept pending for the next winter holidays. One hopes that the process begins to make school interesting so that fewer students dropout. One hopes that there are fewer schools this year which are short-staffed and more teachers who motivate learning.

Wishful thinking? We wish the same towards the end of every Winter vacation and still continue hoping...

# Why the Gambia's plea for the Rohingya matters for international justice

In early December, the International Court of Jus-I tice heard arguments filed by the Gambia against Myanmar for violations of the Genocide Convention. This included a request for "provisional measures", asking that the UN court immediately order Myanmar to cease genocidal activities and to report to it within four months.

Under the 1948 Genocide Convention any member state can bring a claim against any other and be heard by the International Court of Justice. This is in keeping with the principle that the act of genocide harms all of humanity, not just those directly involved in it. Yet the case against Myanmar is only the third invocation of the Genocide Convention before the UN court. It is the first case ever to consider acts and actors of non-contiguous, non-war-

But even a successful judgement on provisional measures may still not bring relief to the minority Rohingya community in Myanmar or Bangladesh. Provisional measures against genocidal acts have an unfortunate history. The International Court of Justice issued them in 1993 against Serbia, for example, and this did not prevent the 1995 Srebrenica massacre.

Moreover, even though legally binding, enforcement of provisional measures will prove difficult. In the meantime the Rohingya are still being persecuted and killed in Myanmar. They are also increasingly unwelcome in Bangladesh.

Yet the Gambia's invocation of the Genocide Convention remains politically and legally significant, not least for the potential it signals about the application of international law by actors in the global south.

WHY THE GAMBIA?

The Gambia emerged from 22 years of dictatorship in 2016. President Adama Barrow came to power on a human rights and anti-corruption platform. He has embraced the case, which has been vigorously pursued by his justice minister, Abubacarr Tambadou.

In 2018 Barrow told the UN General Assembly that his government would "champion an accountability mechanism" for crimes against the Rohingva.

Tambadou worked for 13 years in the Office of the Prosecutor of the International Criminal Tribunal for Rwanda. In 2017, he travelled to Bangladesh for the annual meeting of the Or-

ganisation of Islamic Cooperation. This is an international organisation open to countries with a Muslim majority and which the Gambia currently chairs.

Meeting refugees in the settlement of Cox's Bazaar in Bangladesh convinced Tambadou of the need for his country to "use our voice" to assist the Rohingya.

THE ARGUMENTS

Two central points emerged from the December hearing on provisional measures. First, the hearing reiterated how Myanmar, in the person of the once-celebrated human rights advocate Aung San Suu Kyi, categorically denies the atrocities for which there is overwhelming evidence.

The Gambia, led by Tambadou, relied almost exclusively on evidence collected by UN fact-finding missions, which are officially constituted and rigorously vetted. Yet Aung San Suu Kyi rejected these findings in favour of Myanmar's internal investigations, and con-

"It would not be helpful for the international legal order if the impression takes hold that only resource-rich countries can conduct adequate domestic investigations and prosecutions, and that the domestic justice of countries still striving to cope with the burden of unhappy legacies and present challenges cannot be made good enough. The Gambia will also understand this challenge with which they too are confronted."

In this way, Aung San Suu Kyi borrowed from both neocolonialism and "fake news" populism in constructing her argument.

Second, the hearing emphasised how narrowly the International Court of Justice has previously drawn the definition of genocide. In the two previous cases invoking the Genocide Convention, the court declined to find state-sponsored genocide, due to its interpretation of the Convention's "intent" element. As the court stated in its 2007 judgment Bosnia-Herzegovina v Serbia:

"It is not enough that the members of the group are targeted because they belong to that group, that is because the perpetrator has a discriminatory intent. Something more is required. The acts listed must be done with intent to destroy the group as such in whole or

Aung San Suu Kyi specifically invoked this judicial history throughout her address to the

The prominent international law scholar appearing on behalf of Myanmar, William Schabas, pushed this definition even further. He argued that the International Court of Justice's jurisprudence suggested that the correct understanding for genocidal intent was necessarily the absence of any other explanation for a state's conduct.

"Myanmar submits that the information in the application and in the materials invoked in its support ... provide ample evidence to indicate alternative inferences.... Should the Court agree that there is ample support for an alternative explanation, then it cannot but conclude that the application has no reasonable chance of success on the merits. Not a 50 per cent chance. Not a 25 per cent chance. No

Schabas went on to cite the International Criminal Court's investigation into deportation of the Rohingya as a demonstration of the kinds of "alternate inferences" that would disallow the court to find the requisite genocidal

Schabas developed this definition through an analogy of how domestic criminal law categorises crime. This interpretation would destroy the possibility of finding states responsible for genocide, however. This is because it is impossible to intentionally destroy a group in whole or in part, which is the core of the legal definition of genocide, without committing other international crimes along the way.

This distortion of the Genocide Convention perverts both its purpose as well as the International Court of Justice's past jurisprudence, and seems unlikely to be adopted by the court. PROMISING NEW DIRECTION?

The Gambia and Myanmar are a world away from one another. Nevertheless, in bringing a case against Myanmar, the Gambia represents "humanity" rather than Africa or world Islam.

The curiosity and surprise that have met the Gambia's bold step remind us that this universal mantle is rarely worn by African countries. The Gambia's initiative signals a promising new direction.

# Screen time: Conclusions about the effects of digital media are often incomplete, irrelevant or wrong

There's a lot of talk about digital media. In-**▲** creasing screen time has created worries about media's impacts on democracy, addiction, depression, relationships, learning, health, privacy and much more. The effects are frequently assumed to be huge, even apocalyp-

Scientific data, however, often fail to confirm what seems true based on everyday experiences. In study after study, screen time is often not correlated with important effects at a magnitude that matches the concerns and expectations of media consumers, critics, teachers, parents, pediatricians and even the researchers themselves. For example, a recent review of over 200 studies about social media concluded there was almost no effect of greater screen time on psychological well-being. A comprehensive study of adolescents reported small effects of screen time on brain development, and no relationship between media use and cognitive performance. A review of 20 studies about the effects of multitasking with media - that is, using two or more screens at the same time - showed small declines in cognitive performance because of multitasking but also pointed out new studies that showed the opposite.

As communication, psychological and medical researchers interested in media effects, we are interested in how individuals' engagement with digital technology influences peoples' thoughts, emotions, behaviors, health and well-being.

MOVING BEYOND 'SCREEN TIME'

Has the power of media over modern life been overstated? Probably not, but no one knows, because there is a severe lack of knowledge about what people are actually seeing and doing on their screens.

Individuals all around the world are now all looking at pretty much the same screens and spending a lot of time with them. However, the similarities between us end there. Many different kinds of applications, games and messages flow across people's screens. And, because it is so easy to create customized personal threads of experiences, each person ends up viewing very different material at different times. No two people share the same media experiences.

To determine the effects of media on peo- one changing the interpretation of the other. ple's lives, whether beneficial or harmful, requires knowledge of what people are actualblunt metric - screen time.

Reports of screen time, the most common way to assess media use, are known to be terribly inaccurate and describe only total viewing time. Today, on a single screen, you can switch instantly between messaging a neighbor, watching the news, parenting a child, arranging for dinner delivery, planning a weekend trip, talking on an office video conference and even monitoring your car, home irrigation and lighting. Add to that more troublesome uses bullying a classmate, hate speech or reading fabricated news. Knowing someone's screen time - their total dose of media - will not diagnose problems with any of that content.

A media solution based only on screen time is like medical advice to someone taking multiple prescription medications to reduce their total number of pills by half. Which medications and when?Complex and unique nature of

What would be a better gauge of media consumption than screen time? Something that better captures the complexities of how individuals engage with media. Perhaps the details about specific categories of content - the names of the programs, software and websites - would be more informative. Sometimes that may be enough to highlight problems - playing a popular game more than intended, frequent visits to a suspicious political website or too much social time on Facebook.

Tracking big categories of content, however, is still not that helpful. My one hour of Facebook, for example, could be spent on self-expression and social comparison; yours could be filled with news, shopping, classes, games and videos. Further, our research finds that people now switch between content on their smartphones and laptops every 10 to 20 seconds on average. Many people average several hundred different smartphone sessions per day. The fast cadence certainly influences how people converse with each other and how engaged we are with information. And each bit of content is surrounded by other kinds of material. News read on Facebook sandwiches political content between social relationships, each

A CALL FOR A HUMAN SCREENOME PROJECT

In this era of technology and big data, we ly seeing and doing on those screens. But re- need a DVR for digital life that records the ensearchers often mistakenly depend on a rather tirety of individuals' screen media experiences - what we call the screenome, analogous to the genome, microbiome and other "omes" that define an individual's unique characteristics and exposures.

> An individual's screenome includes apps and websites, the specific content observed and created, all of the words, images and sounds on the screens, and their time of day, duration and sequencing. It includes whether the content is produced by the user or sent from others. And it includes characteristics of use, such as variations in how much one interacts with a screen, how quickly one switches between content, scrolls through screens, and turns the screen on and off.

> Without knowledge of the whole screenome, no one - including researchers, critics, educators, journalists or policymakers - can accurately describe the new media chaos. People need much better data - for science, policy, parenting and more. And it needs to be collected and supported by individuals and organizations who are motivated to share the information for all to analyze and apply.

> The benefits from studying the human genome required developing the field of genomics. The same will be true for the human screenome, the unique individual record of experiences that constitute psychological and social life on digital devices. Researchers now have the technologies to begin a serious study of screenomics, which we describe in the journal Nature. Now we need the data - a collective effort to produce, map and analyze a large and informative set of screenomes. A Human Screenome Project could inform academics, health professionals, educators, parents, advocacy groups, tech companies and policymakers about how to maximize the potential of media and remedy its most pernicious effects.

LONDON, [THEGUARDIAN]: The Watford bus was just about to leave Anfield but Sadio Mané had a message for Troy Deeney. "Take care of my boy," the Liverpool forward urged. "He's a shy boy, shy boy." Standing awkwardly in the background with his hands in his pockets and peering down at the floor, Ismaïla Sarr looked exactly that. "He just needs to speak English, he's working on it," came the reply

from Deeney. "He's a good

After a 2-0 defeat in Nigel Pearson's first match as manager on 14 December that left Watford six points from safety, Sarr had plenty of reasons to feel sorry for himself. The club's £30m record signing from Rennes last summer was beset by injury problems after his arrival in England and had just spurned a golden opportunity to record his second Premier League goal against Liverpool, embarrassingly missing the ball when it fell to him unwith the score level.

A month on, however, Mané's advice to Deeney seems to have paid off. Sarr has been an integral reason behind Watford's rapid rise up the table, having scored crucial goals in the wins over Manchester United and Aston Villa before setting up Abdoulaye Doucouré for the opening goal in the crucial victory against Bournemouth on Sunday. But the 21-year-old's performances have come as no surprise to Mady

'Justice Clock' to be set up at Calcutta High Court



KOLKATA, JAN 16 (PTI): A 'Justice Clock' is set to be introduced at the Calcutta High Court soon, displaying the status of cases before it and in subordinate courts of West Bengal, an official said here.

The electronic LED display board to be installed will also show the ranking of the high courts and district and subordinate courts. based on their performance in disposing of highest number of cases.

There are at least 22.81 lakh cases pending before different courts in the state, of which 17.7 lakh are criminal cases, according to the National Judicial Data Grid.

The 'Justice Clock' will be installed in the high court premises first and then in subordinate courts and people will be able to view status and pendency of cases before any court in the state, the official said.

The date of the installation of the clock is likely to be announced on Friday, the official said.

Of the total pending cases in the state, including civil and criminal, 3,16,902 cases are pending before different courts for more than 10 years, as per the grid.

There are 2,28,161 cases pending before the Calcutta High Court as on November 30, according to data provided by its administration.

Of these, 1,70,039 are civil and 38,302 are criminal cases pending before the appellate side of the high court, while 19,820 are original side civil matters.


## Bulls awe tamers, Jallikattu events in TN continue to be crowd-pullers

# How did a world champion squash player emerge from Réunion Island?

**JAMES WILLSTROP** LONDON, 16 [THEGUARDIAN]: "Bring some sweatshirts. It's winter here remember," Thierry Lincou, world squash champion back in 2004, tells me the day before I travel to meet him to play an exhibition event in his homeland, Réunion Island. Forty-eight hours later he is walking me down to the beach near Saint-Pierre, on the south of the island in blazing midday heat. In thick sweatpants, still coming to after 24 hours travelling, I stumble, bleary-eyed into the fire and suggest that he may have forgotten I am English. "I thought you said it was cold! This would practically be the hottest day in England's history."

Twelve hours later my shoulders were burned from a day at the beach, during which we lost ourselves in conversation, reminiscing like old men about our experiences on tour. In between we swam with the gorgeous fish - fish unperturbed by human invasion to their waters.

Here I was in Réunion, a French-speaking island in the Indian Ocean, just a short stretch from Mauritius and South Africa. The terrain steadily slopes upwards towards huge volcanoes that world champion squash

stand ominously as visual centrepieces of the island. From the seafront you can glance inland to capture the captivating

Thierry was the star of the squash festivities, which consisted of a demonstration event that ran alongside the Indian Ocean Games, a multisport event that is competed for on the island in early August. I was glad to be asked by my former compatriot and his team of organisers to support

Thierry retired from the game a few years ago. You wouldn't know it to look at him. He's in great shape and still manages to tuck me up on the court most times we play, as he did in the final of the event here. There's nothing like a good pre-season confidence booster, that's what I say.

Away from the court Thierry gave me a tour of his local haunts. We swam, caught too much sun, ate samosas - takeaway food stalls win over French brasseries here – and sat on rocks looking out to sea as we watched surfers. It was clear Thierry was in his element being back here. "No offence," I exclaimed, "but how the hell did you manage to become a



player coming

Thierry always played under the banner of France, so outsiders assume he learned the sport there. But no, he lived in Réunion for most of his young, developmental years in squash, only leaving for France when he was 18. It is outrageously difficult for players, certainly in squash, to come from countries with no system or track record. You don't suddenly see countries materialising in sports

at which they have never previously excelled. It would be difficult for Russia to suddenly become world beaters at cricket. There is no background, no history, no

In squash one player is currently materialising in Peru. The world junior champion, Diego Elías, is an outstanding prospect, but Peru have been relatively non-existent in world squash up until his first conjuring. It's a stunning achievement

Thierry took me along to see the club where he played as a kid, where he carved out his future career. He called it a squash club but behind the padlocked door was just an old, abandoned barn that was completely caked in bird shit. There were two bits of "space" that could have passed as squash courts. Some lines were almost visible but prison walls would have made better playing areas. There were remnants of an old club shop that once existed and there was an old advertising poster of Thierry.

He hadn't been in the place for years and was clearly excited to see it. He described to me, as I stood rapt, the atmosphere of the club that existed all those years ago. It must have been a harsh reminder what time can do as he remembered his training sessions and club nights with the fellow members and players. The interior was completely overrun with cobwebs and the clocks had stopped as the whole entity was left to fester. I almost expected some sort of Réunion Island version of Miss Havisham to appear in a wheelchair to welcome her Pip back.

I knew how much work it took for me to reach high levels in the game, and while I didn't exactly train in palatial facilities as a kid, I had a decent and welcoming club to go to, a family who were involved in the game, and in my dad I had an expert coach from whom to learn. There were a gaggle of young players to train and compete with and in England we had role models to emulate and copy. In other words, the opportunities, facilities and inspiration were there. It helped.

Thierry worked with a blank canvas. Only incredibly modest facilities were available to him, with no state of the art gyms in sight and no coaching expertise to bounce off. But maybe that's enough. Thierry proved that you don't necessarily need all this and you certainly don't need money. You just can't buy excellence, which in this age of fads and quick fixes is gratifying. Thierry told me how he would come down to the courts and train, and he said he had the foresight to train hard. I wondered how on earth he would have done it in this barn? "There were less cobwebs then!"

He was advised to move to France to join the French squads when he was 14 but he said no. People in Réunion and France justifiably thought that his advancement would then falter. I don't blame them. I can't stress enough how much the structures, systems and junior tournament play supported me and helped me to keep improving and eventually make it into the professional ranks. ThierFrance when he was 18.

We've heard of stories before like this. The Williams sisters spent some formative years on public courts which apparently had potholes and sometimes no nets. Last month Julius Yego became the first Kenyan to win a gold medal in the javelin, having coached himself in the beginning by watching YouTube videos. It's an unlikely story of success and is even more amazing when you think that Kenyan field athletes hardly exist. He was their only one at the London Olympics in 2012. These people prove that excellence in sport is less about means and resources and more about inclination.

Thierry is an inspirational athlete, perhaps unknown to many readers around the world. God knows, he was hardly even acknowledged in Saint-Pierre as we strode down the beach, me sweating in my heavy clothes. I thought it quite sad that he has done something so extraordinary on this small island and yet nobody knows to celebrate him. I can't imagine that Réunion has too many world champions. Walking along that beach he was just another local. It's probably the ry eventually moved to way he likes it.

# Finch expects India to fight back hard in second ODI

RAJKOT, JAN 16 (PTI): Australia captain Aaron Finch has no doubts that India will "fight back" in the second ODI here Friday after being battered in the series-opener in Mumbai.

Australia gave the hosts a reality check with a crushing 10-wicket win in the lung-opener on Tuesday, riding on David Warner and Finch's unbeaten hundreds.

But Finch said it would be silly to take India lightly as they boast of world-class players.

"That was a pretty good performance. I think our fielding was a little bit sloppy but all in all we ar really happy with how the boys went," he was quoted as saying by 'cricket.com.au' after the win in Mumbai.

"They (India) will fight back no doubt. They are a great side, got some world-class players," Finch said talking about what to expect from Friday's match.

Chasing a below-par 256, David Warner (128 not out) and Finch (110 not out) shared a record opening stand as Australia cantered home in the first ODI.

Asked about his opening partner's batting display, the Australia skipper said: "He (Warner) is playing unbelievably well I think. It's so hard to bowl to him once he gets in. He hits the ball all around the ground, so stopping him from scoring is so hard.

"He is so clear with how he is going to bat, his footwork is pretty good. His mental state is unbelievable when he is out in the middle. He is so clear with his thoughts and his game. He is in top shape."

While lauding his bowlers for their superb show in the middle overs, Finch hinted that Josh Hazzlewood could get a chance in the second ODI by resting either Pat Cummins or Mitchell Starc in an effort to manage their workload.

"To be able to control such a damaging top-order with their lengths is brilliant. The ball just swung enough to keep them in the game all the time. They were so accurate which you have to be in these conditions," he

"The bowling line-up will obviously be discussed with Josh (Hazzlewood) on the sidelines. With back-to-back games and pretty quick and a reasonably heavy Test load, I'm sure Josh will come in for one of them (Cummins or Starc) at some point. "(But) Unless it's a forced change with a niggle or injury, I don't think it would be much," he added.

# **Dhoni dropped from BCCI's** central contracts list

New Delhi, Jan 16 (PTI): Mahendra Singh Dhoni was on Thursday dropped from the BCCI's list of centrally contracted players, raising fresh doubts on the future of the former India captain who has not played since the World Cup semifinal loss to New Zealand last year.

The BCCI announced the central contracts for the period of October 2019 to September 2020. Dhoni was in the A category, which fetches a player Rs 5 crore, until last year.

Skipper Virat Kohli, his white-ball deputy Rohit Sharma and top pacer Jasprit Bumrah were retained in the highest A+ bracket of Rs 7 crore. Among others, batsman K L Rahul has been promoted from B grade to A.

Dhoni's contract not being renewed is not exactly a surprise as he has not played a competitive game since that includes the retired Am-World Cup semifinal on July 9. He has been on an sabbatical and has refused to divulge his future plans.

Head coach Ravi Shastri had recently said that Dhoni may soon end his ODI career but could be in contention for a spot in the T20 World Cup squad provided he does well in the IPL.

Test opener Mayank Agarwal, who has done well since making his debut during the tour of Australia in 2018-19, has been included in the list in Grade B, which also features Hardik Pandya and Yuzvendra Chahal along with two others

Pacer Navdeep Saini and T20 specialist Washington Sundar are new entrants in Grade C alongside Shreyas Iver, Deepak Chahar and Shardul Thakur.

ODIs and 98 T20 Internationals for India, accumulating over 17,000 runs and effecting a staggering 829 dismissals behind the stumps.

# How Charlton fans united and ousted the club's unfit owner

JAN [THEGUARDIAN]: In January 2014, an unknown businessman called Roland Duchâtelet bought Charlton Athletic for £14m. With the club sitting 19th in the Championship, there was excitement among Charlton fans that, in the modern age of billionaire foreign owners, they might just be on the cusp of something great. But it wasn't to be. Within two years, hundreds of Charlton fans were marching towards the Valley in a faux funeral procession, trailing behind a coffin that symbolised the death of the football club at the hands of its reckless

To many Charlton

fect example of how not to run a football club: belligerently pursuing an unrealistic vision without any consideration for the fans until the club has been driven to ruin, both on and off the pitch. His ambition was to incorporate

Charlton into a wider network of European clubs - a model not far from what the Pozzo family have done at Watford or even City Football Group's growing global empire. It would be a mutually beneficial, money-saving ment, in which players would move from club to club, developing and progressing. However, Duchâtelet's strategy underestimated the talent required to compete in the Championship. Charlton found themselves ill-equipped for the task, with poor players from mediocre teams in Duchâtelet's network, and were soon languishing in League One. Off the pitch, things

also took a turn for the worse. Duchâtelet and his choice of CEO, 29-year-old lawyer Katrien Meire, made a series of bizarre decisions and publicity blunders, which corroded Charlton Athletic's identity as a club. They signed new players without consulting the club's manager; they sold star striker Yann Kermorgant as he was deemed "too old for the Championship"; they

sacked managers who

refused to field the players in their network; they relied on a scout with no experience in football; they installed a fans' sofa for the supporters with the best dance moves; and, of course, they released fake footage of people "having sex" in their ground to inform fans that their pitch was available for hire.

Duchâtelet's destruction of the club was the catalyst for a wave of fan mobilisation. Charlton supporters have a track record of defending their club. When they were exiled from their stadium in the 1990s, fans set up a political party to run in the local election and fight for their return. With Duchâtelet ruining the club, they decided to

mobilise again.

Various pockets of supporters were unitunder the Coalied tion Against Roland Duchâtelet (CARD), resulting in a series of tactical protests, marches and demonstrations. The group coordinated opposition at matches to amplify their message and further project their discontent into the mainstream media.

These protests were as creative as they were determined. Whether it be the coffin with "RIP Charlton Athletic" inscribed on it, the thousands of plastic pigs that were thrown on to the pitch, or a "Taxi For Roland" that was driven all the way to Belgium. In their most ambitious Charlton fans marched Duchâtelet's through hometown of Sint-Truiden, delivering a message in person to a man who had not even visited the club he owned for several years. The sustained pres-

sure worked. The message sunk in eventually and the club was put up for sale. Duchâtelet sold the club at the end of the year to East Street Investments, a consortium comprised of two English businessmen backed by Abu Dhabi money. There is relief among fans as they wave goodbye to Duchâtelet, although it is mixed with both apprehension and excitement. Having been hurt before, it's hard for them not to be nervous.

# UN sounds alarm over unprecedented levels of hunger in southern Africa

NEW YORK, 16 JAN [THEGUARDIAN]: Southern Africa is in the throes of a climate emergency, with hunger levels in the region on a previously unseen scale, the UN has warned.

Years of drought, widespread flooding and economic disarray have left 45 million people facing severe food shortages, with women and children bearing the brunt of the crisis, said the World Food Programme (WFP).

Zimbabwe is already facing its worst hunger emergency in a decade, with 7.7 million people - half the population acutely food insecure. But there is evidence the situation has "deteriorated significantly" over the past few months.

About 20% of people in Zambia - a regional breadbasket - and Lesotho face acute food insecurity, as does 10% of the population of Namibia, WFP said. The crisis has been aggravated by surging food prices, largescale livestock losses and rising joblessness.

The 16 nations in the Southern African Development Community, a region identified as a climate "hotspot" by the Intergovernmental Panel on Climate Change, have experienced only one normal growing season in the past five years. Seasonal rains have been



late in many countries and UN experts predict, with 60% certainty, that another bad harvest is due in the coming months.

Central and western areas have been hit by the worst drought in 35 years during the growing

"The hunger crisis is on a scale we've never seen before and the evidence shows it's going to get worse," said Lola Castro, WFP's regional director for southern Africa. "The annual cyclone season has begun and we simply cannot afford a repeat of the devastation caused by last year's unprecedented storms."

Last March, Cyclone Idai hit Mozambique, Malawi and Zimbabwe, leaving 900 people dead, thousands displaced and more than 1 million short of food. Cyclone Kenneth hit

Mozambique six weeks later.

"While our most pressing priority is the millions in need of immediate support, building the resilience of the many more threatened by increasingly frequent and destructive droughts and storms is absolutely essential," Castro said.

WFP plans to provide lean season assistance to 8.3 million people struggling with "crisis" "emergency" levels of hunger in eight of the hardest-hit countries: Zimbabwe, Zambia, Mozambique, Madagascar, Namibia, Lesotho, Eswatini (formerly Swaziland) and Malawi.

Eddie Rowe, WFP's country director for Zimbabwe, said the agency had carried out its own, unofficial assessment of the food security situation in the past week.

Commodity prices have risen sharply, and said Rowe. "But it looks bad. We have told the government we need to present this unofficial data to donors. Our concern is there is a 60% chance we are going to see another failed harvest this year."

The climate emergency has altered the way WFP operates in Zimbabwe. Over the past three years, after the 2015-16 El Niño drought, almost half of the country's strategic plan is aimed at building resilience and mitigation of the impact of the climate crisis.

One pioneering insurance programme gets people to build boreholes and irrigation schemes in return for insurance coverage. It has reached 1,650 households, of mostly women. About 100,000 people are covered by a £6m national insurance policy, purchased by the Zimbabwe government and WFP, to protect the most vulnerable.

To date, the WFP has secured just \$205m (£157m) of the \$489m needed for southern Africa. If the organisation fails to get the full amount it will face "assisting fewer of those most in need with less", said Castro, who added that without the funding it would not be possible to expand activities to combat the climate emergency long-term.

# China reports first death from mystery pneumonia outbreak

become the first person to die in China from a respiratory illness believed caused by a new virus from the same family as SARS, which claimed hundreds of lives more than a decade ago, authorities said.

Forty-one with pneumonia-like symptoms have so far been diagnosed with the new virus in Wuhan, with one of the victims dying on Thursday, the central Chinese city's health commission said on its website on Saturday.

Seven others remained in serious condition, two were discharged from treatment, and the rest were stable, it added.

The episode has caused alarm due to the spectre of SARS, or Severe Acute Respiratory Syndrome, which in 2002-2003 killed 349 people in mainland China and another 299 in Hong Kong, whose economy was hit hard by the epidemic's devastating impact on tourism.

The Wuhan health commission said the man who died had purchased goods from a seafood market in the city identified by authorities as the centre of the outbreak. It was closed on January 1.

The man, who also had underlying health issues including chronic liver disease, died in hospital on Thursday of "respiratory failure and severe pneumonia", the commission added.

No new cases have been detected since January 3 nor any "clear evidence of human-to-human transmission", it

Chinese scientists investigating the outbreak said last week they believe the pathogen is a previously unknown type of coronavirus, a broad family ranging from the common cold to more serious illnesses like SARS.

Scientists in Hong Kong's Department of Health said Saturday that genetic sequencing of the virus found in one of the Wuhan patients and published online by a Chinese expert indicated it was 80 percent similar to SARS found in bats.

Speaking at a news conference in Hong Kong, they said it was too early to conclude definitively that it was a SARS strain, adding that the city needed to stay vigilant.

"We will remain alert as we believe the epidemic will continue to develop," said Wong Kahing, director of the department's Health Protection Centre.

Hong Kong authorities have taken a range of precautions including stepping up the disinfection of trains and planes, and checks of passen-

The offer is seen as an opportunity to open a window to an eventual peace deal for Afghanistan that would allow the United States to bring home its troops and end the 18-year war, America's longest conflict.

The cease-fire offer was handed to Zalmay Khalilzad, Washington's envoy for talks with the insurgents, late on Wednesday in Qatar, a Gulf Arab country where

Khalilzad has been pressing for a cease-fire but it wasn't immediately clear whether the Taliban proposal would be enough to allow for the on-again off-again talks between the Taliban and the US to restart, with the aim of eventually signing a peace deal.

# **Netflix's Aaron Hernandez Documentary Finally Talks About His Sexuality**

The new series Killer Inside explores the I role that queerness and denial might have played in Hernandez's life, death, and crimes.

The most compelling true crime stories aren't just forensic conundrums — they're mysteries about people. And since the death of former New England Patriot Aaron Hernandez in 2017, his story has only gotten more mysterious and multilayered.

Hernandez was convicted of first-degree murder in 2015 and then found not guilty two years later of a double murder in a drive-by shooting outside a nightclub. Yet despite two lengthy trials, the question of motive was always elusive. Hernandez's crimes appeared to have no clear impetus beyond a dangerous mixture of paranoia the mystery of his identity — more specifial that permeated his life. cally, his sexuality — hadn't become central to the story right before his death. He was outed as gay on a radio show soon after the 2017 "not guilty" verdict; two days after that, he killed himself in prison, taking his secrets to the grave.

Since then, the story of Hernandez's downfall has become big business for the true crime industrial complex as the subject of memoirs, books, podcasts, documentaries, and investigative series. Now comes a three-part Netflix doc, Killer Inside: The Mind of Aaron Hernandez, which premieres

Killer Inside is supposed to be an "objective" unspooling of the entire Hernandez story as it played out in the media. But it provides surprisingly intimate stories and insight into his relationship to his sexuality, which was completely ignored in other accounts. Killer Inside adds important (and not sensationalist) context to the role his queerness and denial might have played in his now-well-documented life, death, and

Killer Inside is part of a big wave of bingeable true crime content produced by Netflix. One of the limitations of these documentaries is that it's hard to provide new information or interpretations when they focus on already famous stories. And, in fact, there are no original interviews with most of the major players in the Hernandez story, like his brother, mother, fiancé, or coaches.

But thanks to the filmmakers' access to Hernandez's recorded conversations while in prison, interviews with some of his lovers and teammates, and a willingness to grapple and toxic masculinity. And the Hernandez frankly with his sexuality, the episodes offer saga might have been forgotten by now if new insight into the kind of trauma and deni-

Hernandez's father, Dennis, was originally positioned as a defining figure in his trajectory, credited with instilling the discipline and drive that turned his son into a promising Connecticut high school football prodigy. Killer Inside presents a different angle on Hernandez's boyhood, showing that his father wasn't just providing structure but taught him a model of masculinity built on anti-gay

Hernandez's brother, D.J., points out (in clips from a Dr. Oz interview) that the would-be-NFL player had wanted to be a cheerleader — inspired by his cousins - and their father, who felt there was a "feminine way" about Aaron, put a stop to it right away. Dennis SanSoucie, a classmate and football teammate, said he was the kind of dad who "would slap the faggot out of you."

# **'Dolittle': Film Review**

This fantastical adventure does very little to stoke the imag-**▲** ination, refashioning a literary classic about a veterinarian who can speak with animals into a frenetic, crass kids' flick. Director: Stephen Gaghan

It's been more than half a century since Rex Harrison spoke (and sang!) to animals as author Hugh Lofting's eloquent veterinarian (Richard Fleischer's 1967 musical film was nominated for nine Oscars, including best picture), and just over two decades since Eddie Murphy gave his own goofy modern portrayal. That's enough time for Dr. Dolittle to fade from kid audiences' collective consciousness, and just the right amount for Lofting's first two books to enter the public domain, which explains why a new studio — Universal, where the two earlier incarnations hailed from Fox — has opted to revive the character yet again, this time enlisting the intensely charismatic actor Robert Downey Jr. to play the title role.

Trouble is, this latest "Dolittle" is downright sloppy. Di-

rector Stephen Gaghan's period-set overhaul of the literary classic proves to be as predictable as it is obnoxious. its defense, the film evokes an arm's-length connection with its cute CG creature coterie and delivers heartening messages about psycho-

logical trauma, and yet, the charm-starved adaptation simultaneously tests audiences' patience with overly complicated, noisy scenarios. What should have been an awe-filled adventure quickly curdles into an awful one, thanks to a pedestrian formula and the filmmakers' fixation on fart jokes.

Dr. John Dolittle (Downey) has been squirreled away in his British countryside manor since the death of his wife years earlier. His lush, palatial estate has fallen into disrepair, overgrown with vines and greenery (a metaphor!) that provide a protective layer to shut out human company. Though he's cloaked in tattered clothing and sports an overgrown, ZZ Topstyle sadness beard, we spot a hint of the fantastical genius who once embraced the joys of living through his interactions with the furry, feathered, and seemingly ferocious animal companions rehabilitating on the property.

Dolittle's chosen life of solitude is interrupted one day by both Tommy Stubbins (Harry Collett), a young man compelled to become an apprentice, and Lady Rose (Carmel Laniado), the Queen's (Jessie Buckley) intrepid young daughter, who's been sent to enlist the eccentric doctor's aid. The Queen is on her deathbed and Lady Rose needs help not only to solve the mysterious circumstances surrounding her poisoning, but also to locate a potential antidote. The stakes are high for Dolittle since, if the queen perishes before the upcoming solar eclipse, he'll lose control of his animal sanctuary. Luckily, the doctor knows where to find a journal that tells the location of a cure. The treacherous journey will have Dolittle and company fending off a rogues' gallery of ne'er-do-wells, including the sniveling palace doctor and former Dolittle antagonist Dr. Blair Müdfly (Michael Sheen), crooked Lord Thomas Badgley (Jim Broadbent), and conniving King Rassouli (Antonio Banderas), who has ties to Dolittle's past.

Screenwriters Dan Gregor, Doug Mand, and Gaghan, work-

ing from a story by Thomas Shepherd, frequently go off-book in order to sketch their refurbished tale, borrowing only a waft of inspiration from the novels' versions of Dolittle and Stubbins. It's a shame that same level of evolving design wasn't applied to the new characters. The women in Dolittle's world demonstrate tenacity of spirit, but only to a limited degree: One of them is dead for the exclusive purpose of aiding two male characters' arcs, and the other gumption-fueled gal is left at home while the men adventure, satisfying traditionally feminine domestic constructs (nursing her ailing mother). Such faintly sexist leanings are slightly forgivable when the narrative is peppered with healthy sentiments about how to handle grief, anxiety, and disability, as well as the values of being vulnerable with each other and kind to animals. Still, those messages are garbled in execution and lack the proper breathing room to make them impactful on the character

s for more than a few seconds when conveniently utilized. Despite the good the picture attempts to put into the universe, there's much more that drags it down. The sheer volume of crass flatulence jokes and routines involving animal

> nether should get youngsters in the audience laughing, but will just as assuredly make grownups groan. Once the film wears out jokes with dog Jip (voiced by Tom Holland), cussing butts and scooting on the floor, you'd think the film would've reached its capacity. But no, there's

still more in store, as the film stoops to include a disgruntled tiger (Ralph Fiennes) getting kicked in the crotch and a dragon (Frances de la Tour) getting an enema.

The movie's elaborate — and, ultimately, repetitive — Rube Goldberg-inspired action sequences might have been more effective if streamlined, while the absurdist humor to be found in these moments is frequently undercut in favor of garish, pratfall-adjacent shenanigans. Editor Craig Alpert cuts away too quickly from a bit between rebellious fox Tutu (Marion Cotillard) and brave giraffe Betsy (Selena Gomez) about how they'll cover up Stubbins' death if he doesn't make it onto Dolittle's ship, one of many moments drowned out by Danny Elfman's overbearing score. Plus, the anachronistic dialogue from polar bear Yoshi (John Cena, who says "bro" a bunch) and an octopus who spews "snitches get stitches" clash with the immersive Victorian-era world the filmmakers have crafted.

All these misfired attempts at humor serve to dampen Downey's innate magnetism — so strikingly evident in his revival of the "Sherlock Holmes" franchise — which is completely lost in this back-to-the-book reboot. The compelling nuance of Dolittle facing his crippling sorrow yields little emotional wallop. And while one can make excuses for the non-uniformity of all those voiceover accents, seeing as how the animals hail from all over the globe, it's a puzzle trying to figure out Downey's mush-mouthed Welsh accent. Considering that Dolittle's signature is the fact he can talk to animals, it's a puzzle why Downey's performance sounds as if it were entirely looped in ADR. Now that the rights to Lofting's novels have lapsed, this surely won't be Hollywood's last Dolittle adaptation. Let's just hope whoever follows can write the right prescription, balancing between humor and heart to deliver a doctor worth celebrating.
