### Over 40k coronavirus cases recorded in India, highest in 111 davs

New Delhi, Mar 20 (PTI): India saw 40,953 new coronavirus infections being reported in a day, the highest single-day rise recorded in 111 days, taking the nationwide COVID-19 tally to 1,15,55,284, according to Union Health Ministry data updated on Saturday.

Registering an increase for the tenth day in a row, the total active caseload has reached 2,88,394, which now comprises 2.49 per cent of the total infections, while the recovery rate has further dropped to 96.12 per cent, the data stated.

India registered over one lakh cases in just three days. On Friday, 39,726 new cases were registered while 35,871 fresh cases were registered on Thursday. The daily rise in infections (40,953) was the highest recorded in 111 days, while the death toll increased to 1,59,558 with 188 new fatalities, the data updated at 8 am showed.

On November 29, 41,810 new infections were recorded in a span of 24 hours.

The number of people who have recuperated from the disease surged to 1,11,07,332, while the case fatality rate stood at 1.38 per cent, the data stated.

India's COVID-19 tally had crossed the 20 lakh mark on August 7, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past ?60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19. According to ICMR, 23,24,31,517 samples have been tested up to March 19 with ? 10,60,971 samples being tested on Friday.

The 188 new fatalities include 70 deaths from Maharashtra, 38 from Punjab and 17 from Kerala.

So far, 1,59,558 deaths have been reported in the country, including 53,208 from Maharashtra, 12,582 from Tamil Nadu, 12,425 from Karnataka, 10,953 from Delhi, 10,301 from West Bengal, 8.757 from Uttar Pradesh and 7.187 from Andhra Pradesh. The Health Ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.



# 5 new cases, 2576 more vaccinated against COVID

 $F^{\mathrm{ive}}$  new cases of coronavirus have been reported in the last 24 hours in Sikkim taking the state tally of confirmed cases of COVID-19 to 6204. Of the new five cases in the State, one is reported in East District and four from North District.

With just one recovery of COVID-19 in the last 24 hours the number of active cases of novel coronavirus in Sikkim stands at 53. The figure of recovered cases of COVID-19 is 5919.

In his daily health bulletin, Health Department State IEC Officer, Sonam Gyaltsen Bhutia mentioned that five new cases of coronavirus were found in the testing of 200 samples on Friday. He added that one case was detected in RT-PCR testing of 109 samples in North District tested pos-



and four in the rapid antigen testing of 91 samples.

While giving details of new cases in the State, he informed that one person from 8th Mile Lingdok in East District and four persons from Singhik, Mangan itive for COVID-19. He added that samples of primary contacts of positive persons from North District were also taken and their residences have been contained.

Meanwhile, 2576 persons in Sikkim were provided COVID vaccines in different

parts of the State on Friday. Out of 2576 persons, 2051 have received the first dose of vaccine and 525 persons have completed the vaccine schedule with the second dose of vaccine in the State.

Mr Bhutia informed that healthcare workers

[36 first dose & 75 second dose], 567 frontline workers [117 first dose & 450 second dose], 515 persons in age group of 45 to 59 years with comorbidities and 1383 persons in age group of 60 years and above were vaccinated yesterday in the State.

district-wise figures, he further informed that 1374 persons [1036 first dose & 338 second dose] in East District, 1093 persons [908 first dose & 185 second dose] in West District, 89 persons [87 first dose & 02 second dose] in North District and 20 persons [all first dose] in South District were provided with vaccine shots.

As per break-up of vaccinations category-wise, East District has registered vaccination of 84 healthcare workers [28 first dose & 56 second dose], 341 frontline workers

[59 first dose & 282 second dose], 185 persons in age group of 45 to 59 years and 764 persons in age group of 60 years & above, while 24 healthcare workers [7 first dose & 17 second dose], 200 frontline workers [32 first dose & 168 second dose], While giving details of 300 persons in age group of 45 to 59 years and 569 persons in age group of 60 years & above were also vaccinated for COVID-19 in West District.

### Can't be indifferent to **Myanmar refugees: Mizoram CM to Centre**

AIZAWL, 20 MAR [PTI]: Urging the Centre to review its order to four Myanmar-bordering northeastern states including Mizoram to prevent illegal immigration from the neighbouring country and ensure expeditious deportation, Chief Minister Zoramthanga has asserted that the people of his state, who share ethnic ties with the refugees from Chin communities, can't remain indifferent to their plight. The Mizo National

Front (MNF) chief, in a letter to Prime Minister Narendra Modi on March 18, requested him to personally intervene in the matter to provide asylum to the political refugees on humanitarian grounds, an official at the Chief Minister"s Office said on Saturday.

He said the MHA's March 10 advisory to Nagaland, Mizoram, Arunachal Pradesh and Manipur was not acceptable to his state.

Though the MNF is a part of the BJP-led North East Democratic Alliance (NEDA), it does not have an alliance with the BJP in the state.

"This (MHA advisory) is not acceptable to Mizoram. I understand that there are certain foreign policy issues where India needs to cautiously. proceed However, we cannot ignore this humanitarian Zoramthanga said in the letter, a copy of which is available with the PTI.

He said the areas in Myanmar bordering Mizoram are inhabited by Chin communities who share ethnic ties and have had close contact with the people of the state even before India was independent.

Zoramthanga said a human catastrophe of gigantic proportions is happening in Myanmar and innocent citizens are being killed by the military, which is supposed to protect them.

Every day, terrified Myanmarese people are struggling to cross over into Mizoram in search of shelter and protection, he said.

"Therefore, Mizoram cannot just remain indifferent to their sufferings. India cannot turn a blind eye to this humanitarian crisis unfolding right in front of us in our own backyard," the letter read.

Zoramthanga said that India, as the world's largest democracy and Myanmar''s immediate neighbour, must act in this matter.

Meanwhile, Mizoram Rajya Sabha member K Vanlalvena told PTI that the number of Myanmarese refugees taking shelter in the northeastern state has soared to over 1,000.

An officer in the state Criminal Investigation Department (CID), however, said that as per official records, a total of 547 Myanmarese have entered Mizoram since the coup on February 1.

He said that the actual number may be higher as many Mizoram residents have accommodated Myanmarese refugees without informing the authorities.

Myanmarese people fleeing the coup have taken shelter in eight districts and most of them are being handled by local NGOs, he said.

Several outfits, including the state"s apex student body Mizo Zirlai Pawl (MZP), are raising money to support the refugees.

### Screening of COVID-19 "superspreaders" begins in Ahmedabad

AHMEDABAD, 20 MAR **[PTI]:** In a bid to contain the spread of coronavirus in Ahmedabad, one of the cities in Gujarat where the number of infection cases is rising, the civic body today said it has decided to once again launch its drive to screen the virus "super-spreaders".

"Super-spreaders" are those people, who are likely to spread the infection to a large number of people.

People such as vegetable vendors, medicine store owners, grocers, auto-rick-

shaw drivers, saloon owners, and masons will have to obtain identity cards after getting themselves tested for the virus across 18 urban health centres in the city, the Ahmedabad Municipal Corporation (AMC) said. They will be screened through rapid antigen tests and issued COVID-19 negative identity cards, said the civic body in a release.

Apart from them, food delivery boys and those working in super markets will have to get their RT-PCR test done.

It will be up to the

agencies recruiting them or the units where they work which will be responsible for them to get their tests done at private laboratories, it further said. A list of private laboratories, where they can get their RT-PCR tests done are provided by the AMC on its website, it said.

The drive to identify the "super-spreaders" comes at a time when the city has witnessed a spike in daily cases of late, which took its number of active cases to 784, as per the update issued on Friday evening.

### BJP "biggest extortionist" in the world: Mamata

Kolkata, 20 Mar [PTI]: West Bengal Chief Minister Mamata Banerjee on Saturday slammed the BJP, branding it as the "biggest extortionist" in the world, which should never be allowed to rule the state.

Ms Banerjee, speaking at an election rally in Haldia in East Midnapore district, also accused the BJP of orchestrating riots, killing people and torturing Dalit girls.

"BJP is the biggest "tolabaz" (extortionist) in the world... Just see the amount of money it collected under the PM Cares Fund. If the people of West Bengal want peace and a state free from riots, then the Trinamool Congress is the only option," she asserted.

"A party that creates riots to kill people should never be allowed to rule Bengal. Even women in the BJP are not safe," the TMC boss alleged.

Ms Banerjee said the BJP cannot fight elections in a democratic manner and it "thrives by giving threats". The eight-phase West Bengal Assembly polls will get

underway on March 27. The chief minister, bound to a wheelchair after suffering injures during campaigning earlier in the month, also accused Prime Minister Narendra Modi of embarking on a "selling spree". "The PM has sold ev-

erything. He has devastated the Indian economy. The government is already privatising the railways, coal sector, BSNL, the insurance space and banks. Someday, the Haldia dock might get sold, too," she said.

Ms Banerjee exhorted TMC supporters to guard the EVMs after the voting process is over in each phase.

The EVMs should be tested 30 times before the start of the polls to ensure there is no foul play. But, If any machine develops faults, please remain calm until it is repaired," she said.

Ms Banerjee also said her government will construct a bridge between Haldia and Nandigram to boost connectivity.

"A centre for development of fish will be set up at Haldia. A deepsea port at Tajpur is also being built at a cost of ₹ 15,000 crore, which will generate 25,000 jobs," the TMC supremo said.

The chief minister said financial assistance to farmers of the state will be raised from ₹ 6,000 to ₹ 10,000 per year and free ration delivered at their doorsteps.

### 'Dangerous Attack'': Yale, MIT, Harvard academics on Pratap Bhanu Mehta's Ashoka exit

NEW DELHI, 20 MAR [NDTV]: Around 150 renowned intellectuals from the world's best known centres of academic excellence have written an open letter to the trustees, administrators, and faculty of Ashoka University, Sonepat, expressing solidarity with Professor Pratap Bhanu Mehta who recently quit the institution citing Founders' insecurities over his criticism of the government.

Signatories to the short letter, titled "A Dangerous Attack on Academic Freedom" include Homi K Bhabha of Harvard University, Erwin Chemerinsky of the Berkeley School of Law, Rogers Smith of the University of Pennsylvania, Milan Vaishnav of Carnegie Endowment for International Peace, and Kate O'Regan of Oxford University.

"A prominent critic of the current Indian government and defender of academic freedom, he had become a target for his writings. It seems that Ashoka's Trustees, who should have treated

defending him as their institutional duty, instead all but forced his resignation," the letter says.

"The university must be a home for fearless inquiry and criticism. We support Pratap Bhanu Mehta in his practice of the highest values of intellectual inquiry and public life," it says.

Mr Mehta, who had earlier quit as Ashoka University Vice-Chancellor in July 2019, abruptly resigned from his faculty position on Tuesday, saying, "...my association with the University may be considered a political liability." Two days later, the Prime

Minister's former Chief Economic Advisor, Arvind Subramaniam, resigned as faculty at the institution, citing the circumstances under which his colleague had to quit.

Former Reserve Bank of India chief Raghuram Rajan, too, expressed solidarity with Mr Mehta. "Free speech is the soul of a great university. By compromising on it, the founders have bartered away its soul," he said.

### "Must unitedly defeat" BJP in Assam, says jailed activist Akhil Gogoi GUWAHATI, 20 MAR

[PTI]: Jailed Raijor Dal chief Akhil Gogoi today through an open letter appealed to the people of Assam to vote for the strongest non-BJP candidate in every constituency in the upcoming assembly election to "save Assam".

Akhil Gogoi, contesting from the Sibsagar constituency, sent from jail an open letter that was read out by his political outfit's advisor Dr Sitanath Kahkar at a press conference.

"I am sending this letter from jail to save Assam and its people's future from the anti-democratic BJP," Akhil Gogoi said. Asserting that the future of Assam and its people is "dark under BJP rule", the Raijor Dal leader urged all those who oppose the Citizenship Amendment Act (CAA) and the BJP to unitedly vote against the BJP in this 2021 assembly election.

"Assam's future will depend on the people and they have to take the final decision to save the state. If Assam is to be saved then do not vote for BIP or those in favour of CAA," he appealed.

"This party has sold the assets of Assam and kept the future of the state in custody of Delhi. Therefore, we must unitedly defeat BJP and its alliance partners in the election. It is the call of the times and our duty to do so. It is a matter of life and death," Akhil Gogoi said.

He said before the elections discussions were held with anti-CAA political parties, including Congress and newly formed Assam Jatiya Parishad and decisions were even taken to field joint candidates "but suddenly they turned around and they put up their own contestants having failed to hear the voice of the people and perceive their hopes and aspirations".

Akhil Gogoi said that since BJP came to power in 2016. "they have kept me in jail for nearly two years of their five-year term."

"I am spending extreme mental and physical trauma in jail during this period. Don't know what my future holds but understood that the future of Assam and its people is dark under BIP rule," he claimed.

#### Vaccines should give protection from COVID-19 for 8-10 months: AIIMS Director New DELHI:

COVID-19 vaccine should be able to give good protection from the infection for eight to ten months, AIIMS director Randeep Guleria said today. He also said that no major side-effect of the vaccine has been recorded.

The COVID-19 vaccine should be able to give good protection from the infection for eight to ten months and maybe, even more, Dr Guleria said at an event organised by the IPS (Central) Association.

He said the biggest reason for the surge in cases is that people feel the pandemic is over and they are not following COVID-appropriate behaviour.

"There are multiple reasons for the surge, but the main reason is that there is change in people's attitude and they feel coronavirus is over. People should still restrict non-essential travel for some more time," the official asserted.

NITI Aayog member (Health) VK Paul said the chain of transmission has to be stopped and for that vaccine is one tool but another is containment and surveillance strategy.

the surge," he said. Responding to

question on vaccinating more people, Paul said the issue is vaccines are limited and that is why, prioritisation has been

"If we had unlimited supply, we would open the vaccination for everyone. That is the reason, not everyone, is getting vaccinated. Most countries in the world are not able to go beyond priority group because of this reason," he said.

The NITI Aayog member also said that the highest mortality was seen among people with co-morbidities and older age groups.

"These people must not delay taking the vaccine. So the message is that they need it more than others. That is the reason they have been prioritised for getting the COVID-19 vaccine," he

Talking about the effectiveness of the available COVID-19 vaccines, Covaxin and Covishield. Dr Guleria said, "If we look at the two vaccines, they produce equal antibodies and are very robust. We should take the vaccine available to us because both are equally effective in terms of efficacy and long-term protection.

Over four crore people in the country have been vaccinated against the disease till now. Under the current phase of the inoculation drive, people above 60 years of age and those in the 45-59 years age bracket with co-morbidities, are being vaccinated.

### Save the Young from Obscurity

#### Demand better from education

little over a decade ago, an obscure man, then in **A**his mid-30s, hailing from a nondescript Andhra village, blazed a trail with his apparently crazy move. This "obscure man" was one called Narasing Lal Butt, and his "crazy move" was to claim "damages" through the human rights commission from his village school for its failure to provide him quality education. Education of even reasonable quality could have established him in life, but in his 30's he found himself ill-equipped and under-prepared for anything worthwhile, hence the claim for damages.

Google searches lead nowhere when it comes to ferreting out what happened of his petition. Most probably nothing. In all probability, Narasing has withdrawn into his obscurity only to be occasionally invoked in publications in distant Sikkim. But his petition was obviously never really about receiving damages, and was always about holding up the mirror. A decade since, the mirror still reflects the same image of a broken education system which is still as listless and continues to mass-produce mediocrity. The litigant had sued his school for making him so, well, 'obscure'. And although his complaint most probably secured him no reprieve, he "blazed a trail" in that he went to the human rights commission and not the consumer redressal courts. Even his incomplete education informed him well enough to recognise that education was not a commodity, but a Right, a human right.

Education, whether free, subsidized or exorbitantly paid for, should be better regulated and any lapses on this front should be seen as a violation of a whole generation's human rights. Fact remains that too few people are paying enough attention to education. Yes, there are huge budgets, there are many schools and literacy is on the rise, but what are the schools really churning out? The success stories of Indian academics [which are only a minuscule proportion of the studying population] are fuelled by individual drive and not institutional support or grooming. To blame the teachers would be too easy, they are only part players in a system which is failing, policy interventions have remained ineffectual and uninspiring. It is worrying that education and schools continue to be seen as readying people for employment when the first priority should always have been learning. In the more worrying trends, new policies have also been destructive, trying to dismantle institutions to suit new moulds.

What the nation now needs are more Narasing Lal Butts; more people from the masses to take the policy framers and deliverers to task; to demand better. May be then things will start improving.



# Time to make nature studies a compulsory school subject – before it's too late

The UK government is reported to be seriously I considering making "nature studies" a compulsory subject for all pupils. It's a move that was recommended in the recent government-commissioned Dasgupta review, a detailed analysis of the "economics of biodiversity".

The review is long and technical, but in among the tables and statistics, there are some radical suggestions that go beyond a focus on economics alone, recommendations designed to transform our relationship with the natural world before it is too late. Among options for rethinking supply chains, measures of economic progress and financial regulation, right at the end is a brief focus on education:

"Every child in every country is owed the teaching of natural history, to be introduced to the awe and wonder of the natural world, to appreciate how it contributes to our lives."

The review calls for environmental education programmes from primary school all the way through to university.

REDISCOVERING OUR CONNECTION TO NA-

Would it really make any difference? As an academic who teaches, writes and undertakes research on the social and psychological significance of contact with nature, especially in the context of our ongoing ecological crisis, I believe there's good reason to think it could.

Take the idea of an "extinction of experience", which refers to how each subsequent generation has less sensory contact with diverse natural environments. As meaningful connection disappears, our sense of what is normal is gradually redefined - the "shifting baseline syndrome", to borrow a related concept. As standard experiences of nature

become increasingly narrow and empty, the fear is have transformed natural landscapes across the that we also lose our ability to understand, care for and defend the natural world, and a rapid cycle of mutual decline is underway.

Experience-based environmental education could be an important tool for reversing this shift. Recent research confirms common sense in this regard - repeated, positive (which does not mean unchallenging) experiences of natural environments in early childhood underpin a deep and lifelong attachment to nature into adulthood.

To counter the extinction of experience, it makes sense to proactively design an education system that will foster an attachment to nature. There are positive precedents here already, not least the growth of Forest Schools, which originated in Scandinavia but are now a global movement advocating the social and educational value of spending part of the school day in nature. Continuing the study of ecology into adulthood also seems like a necessary step if we are to collectively address the shifting baseline syndrome, by actively facing up to what is being lost.

NATURE STUDIES FOR THE ANTHROPOCENE

Nature studies should not shy away from the fact that natural environments are in retreat as a result of human activities. In that sense, natural history is also social history, and nature studies is social studies. Many areas of a secondary curriculum could recognise this fact without necessarily introducing compulsory natural history lessons, but while still incorporating experiences of being

Also, when we start to think about human history and the kinds of activities responsible for the biodiversity and climate crisis, things get a little more complicated. Empire, colonialism, the slave trade, industrialism, capitalism, communism and intensive agriculture are all central to how "we"

planet in the age of the "Anthropocene".

Along the way, important practices and worldviews that have sophisticated and deeply held understandings of nature have often been trampled upon and marginalised. These traditions continue in many indigenous communities, and inform collective resistance to environmentally destructive activities and a defence of the rights of nature.

"Nature studies" could learn a lot from these longer, deep-rooted and ongoing connections to nature, just as it could from people working with nature in different ways such as farmers, rangers, conservationists and activists. A key lesson we must learn is that nature is alive, and something we are a part of and depend upon - not an external and inert resource to plunder without consequence. Again, for me this seems to require a radical approach to education across the curriculum science, history, literature, geography, economics, psychology, even religious studies - rather than something that can be contained within a compulsory subject.

Despite these reservations, I still think an experience-based nature studies education, woven into a progressive curriculum, is a fantastic idea. Meaningful human-nature interactions are a much stronger foundation for action than lecturing people about why they should care for nature.

It could be part of an essential toolkit for a sustainable future, and for creating a groundswell of people willing to care for and actively defend nature. If it really were compulsory, who knows how powerful the collective nurturing of a childhood sense of awe and wonder, and a deep, secure, attachment to nature might be, were it allowed to bloom and flourish?

# What is a hate crime? The narrow legal definition makes it hard to charge and convict

white man travels to one business and Awhite man davers to one 2...

Kills several workers. He then kills more people at a similar business.

Six of the eight people he killed are Asian women, leading many people to call for him to be charged under the new state hate crime law. Authorities resist, saying they aren't sure that racial bias motivated the man's crimes.

That's the situation unfolding in the Atlanta area in Georgia, right now. But there is often a gap between public opinion and law enforcement when people believe a hate crime has been committed, whether against LGBTQ people, racial minorities or Jewish people.

Hate crimes and hate murders are rising across the U.S., but long-term polling data suggests that most Americans are horrified by bias-motivated violence. They also support hate crime legislation, an effort to deter such attacks.

Yet officials often resist the quick classification of incidents as a hate crime. Hate crimes have precise qualities, which must be met in order to satisfy legal requirements. And even when police and prosecutors believe the elements of a hate crime are present, such crimes can be difficult to prove in court.

WHAT IS A HATE CRIME?

I have studied hate crime and police for over 20 years.

Hate crimes are crimes motivated by bias on the basis of race, religion, sexual orientation or ethnicity. In some states, gender, age and gender identity are also included. Hate crime laws have been passed by 47 states and the federal government since the 1980s, when activists first be-

gan to press state legislatures to recognize the role of bias in violence against minority groups, Today, only Arkansas, South Carolina and Wyoming do not have hate crime laws.

In order to be charged as a hate crime, attacks - whether assault, killings or vanthat they may not win in court.

It can and does happen, though. In June 2020, Shepard Hoehn placed a burning cross and a sign with racial slurs and epithets facing the construction site where his new neighbor, who is Black, was build-



dalism - must be directed at individuals because of the prohibited biases. Hate crimes, in other words, punish motive; the prosecutor must convince the judge or jury that the victim was targeted because of their race, religion, sexual orientation or other protected characteristic.

If the defendant is found to have acted with bias motivation, hate crimes often add an additional penalty to the underlying charge. Charging people with a hate crime, then, presents additional layers of complexity to what may otherwise be a straightforward case for prosecutors. Bias motivation can be hard to prove, and prosecutors can be reluctant to take cases that ing a house.

Hoehn was charged with and later pleaded guilty to federal hate crime charges in Indiana. A few months later, Maurice Diggins was convicted by a federal jury of a 2018 hate crime for breaking the jaw of a Sudanese man in Maine while shouting racial epithets.

HOW TO CHARGE A HATE CRIME

The first use of the term "hate crime" in federal legislation was the Hate Crimes Statistics Act of 1990. This was not a criminal statute but rather a data-gathering requirement that mandated that the U.S. attorney general collect data on crimes that "evidenced prejudice based on race, religion, sexual orientation, or ethnicity."

Soon, states began passing their own laws recognizing bias crimes. But hate crime legislation has not led to as many charges and convictions as activists may have hoped.

Law enforcement struggle to identify hate crime and prosecute the offenders. Even though 47 states have hate crime laws, 86.1% of law enforcement agencies reported to the FBI that not a single hate crime had occurred in their jurisdiction in 2019, according to the latest FBI data collected.

In many cases, police have received inadequate training in making hate crime

"What weights do you give to race, dope, territory? These things are 90% gray - there are no black-and-white incidents," said one 20-year veteran police officer in a 1996 study of hate crime.

But I've also found that police departments are rarely organized in a way that allows them to develop the expertise necessary to effectively investigate hate crimes. When police departments have specialized police units and prosecutors who are committed to taking on hate crime, they can develop the routines that allow them to investigate hate crime in a manner that supports victims.

In the late 1990s I studied a specialized police hate crime unit in a city I called, for the purposes of anonymity, "Center City." My study revealed that those detectives could distinguish non-hate crimes - for instance, when the perpetrator angrily used the n-word in a fight from cases that are truly hate crimes, as when the perpetrator used it during a targeted attack on a Black person.

Without the right training and organizational structure, officers are unclear about common markers of bias motivation, and tend to assume that they must go to extraordinary lengths to figure out why suspects committed the crime.

"We don't have time to psychoanalyze people," said the same veteran police officer in 1996.

Even law enforcement officers specifically trained in bias crime identification still may not name incidents as hate crime that, to the general public, seem obviously bias-driven. This may be the result of po-

LIMITS OF THE LAW

Advocates for hate crime victims maintain that police and prosecutors can do much more to identify and punish hate

Empirical evidence supports their claims. The FBI's 2019 report contains 8,559 bias crimes reported by law enforcement agencies. But in the National Crime Victimization Survey, victims say that they experienced, on average, more than 200,000 hate crimes each year. This suggests that police are missing many hate crimes that have occurred.

Distrust of police, especially in Black communities, may dissuade minorities from even calling the police when they are victimized by hate crime for fear they could also become victims of police violence.

All this means that perpetrators of hate crimes may not be caught and can reoffend, further victimizing communities that are meant to be protected by hate

Hate crime laws reflect American ideals of fairness, justice and equity. But if crimes motivated by bias aren't reported, well investigated, charged or brought to trial, it matters little what state law says.

### SU Mass Comm students complete Rural Communication project

Third semester stu-**▲** dents from Department of Mass Communication of Sikkim University had worked on a project 'Rural Communication' to understand the problems related to communication for rural development. Students divided into different groups had carried out the six-month long study under the guidance of Assistant Professor Dr Pooja Basnett.

### World Bank approves \$75 million for Nepal to buy Covid-19 vaccines and the World Bank on

KATHMANDU, 20 MAR [KATHMANDUPOST]: The World Bank on Friday approved \$75 million from the International Development Association to support access to safe and effective Covid-19 vaccines and equitable vaccine distribution by strengthening Nepal's health and vaccination system.

The financing is expected to facilitate vaccination of at least onethird of the population through an equitable distribution plan.

"The pandemic presents immense challenges and an uncertain environment, particularly in the purchase, supply and distribution of vaccines," said Faris Hadad-Zervos, World Bank Country Director for Maldives, Nepal, and Sri Lanka.

"It is a testament to our strong partnership with Nepal that the Bank has been able to move quickly to support the government's ambitious plans to vaccinate at least 72 percent of the population."

The additional financing builds on the \$29 million for the original Covid-19 Emergency Response and Health Systems Preparedness Project that was approved in April 2020, the existing Bank-supported health programmes, and confirmed support of other development partners in the context of the government's overall Covid-19 response, the multilateral funding agency said in a press statement.

Most of the new financing (90 percent) will go towards the purchase of Covid-19 vaccines and deployment for prioritized populations beyond the 20 percent that will be vaccinated through COVAX. The rest of the financ-

ing will help strengthen the health system to support the Covid-19 vaccination effort and procure other Covid-19-related supplies such as diagnostic tests, laboratory equipment and therapeutics.

The additional financing also supports community engagement and risk communication, and strengthening existing digital technology-based pandemic data, surveillance and monitoring systems.

"This support is critical for Nepal to safeguard the physical health of its people and economic health of the nation," said Gail Richardson, World Bank Practice Manager for South Asia for the Health, Nutrition and Population Global Prac-

tice. "Providing fast and fair access to the approved Covid-19 vaccines for the most vulnerable people will expedite population-level immunity, which is central to resilient recovery from the devastating effects of Covid-19."

Meanwhile,

Friday signed loan and grant agreements for the \$24 million Forests for Prosperity Project (\$6.1 million as grant and \$17.9 million as concessional loan) that will help Nepal advance sustainable forest management.

The project will contribute to transforming Nepal's forest sector by improving sustainable forest management and developing a strong forest-based private sector.

These activities will result in multiple benefits for forest-dependent people in selected municipalities in Province 2 and Lumbini Province, including inclusive economic benefits, ecosystem services, and greater climate resilience.

It will help strengthen ongoing community-based conservation efforts while promoting inclusive sustainable use.

"Strengthening local communities, for whom forests are a traditional safety net during times of crisis, is especially important in the Covid-19 era. In that same spirit, the project will facilitate Nepal's forest-based private sector to invest in jobs and reduce dependence on timber imports," said Sishir Kumar Dhungana, Finance Secretary.

"The project will also provide timely support to the institutions at the provincial and local levels to strengthen natural resource governance."

### Nagaland gears up for Noksen byelection

KOHIMA, MAR 20 (PTI): Nagaland has geared up to conduct a free and fair byelection to the Noksen assembly seat, scheduled on April 17.

State Chief Electoral Officer Abhijit Sinha on Friday held closed-door meetings with representatives of political parties, officials of Tuensang district where the constituency is located, and journalists.

Filing of nominations will commence on March 23 and the last date for submission of the documents is March 30, Sinha told reporters.

The constituency has 11,819 electors, of which 11,788 are general voters (6,163 males and 5,625 females) and 31 are service electors.

There are 23 polling stations in the constitu-



ency with Yangpi polling station having the highest number of voters at 953 and Yukumsang compound polling station having the lowest number of electors at 113, Sinha said.

A total of 138 polling personnel will be requisitioned and 69 others will be kept on reserve. The byelection was necessitated by the death of Minister for Environment, Forest and Climate Change, and Justice and Law, C M Chang on October 12 last year while undergoing treatment for COVID-19.

# Revenue on track, reserves down in FIFA virus-era accounts

expects to hit its four-year revenue target of 6.44 billion up to the 2022 World Cup in Qatar despite the coronavirus pandemic.

Total spending of 1.04 billion in 2020 included 270 million in grants to soccer bodies worldwide as part of a COVID-19 relief plan, FIFA's annual financial report said on Friday.

It also included a 10 million donation to the World Health Organization.

FIFA again awarded its president Gianni Infantino a 1 million annual bonus to raise his overall pre-tax pay above 3 million in 2020, matching his 2019 income.

The pandemic relief payments helped reduce FIFA's reserves by 705 million in 2020. They stood at almost 1.9 billion by the end of the year.

FIFA gets most of its money from the four-yearly men's World Cup, and said on Friday it already sealed 92% of its income target from broadcasting rights.

Contracted income from all sources to the end of 2020 was more than 5.1 billion, or 80% of revenue budgeted for the 2019-2022 financial period, according to the FIFA document. Fewer sponsor slots for the 2022 World Cup have been



sold compared to the same stage before previous editions of the tournament.

After a near-total shutdown FIFA advanced money due to its 211 national member federations and the six continental governing bodies.

Hundreds of millions of dollars more was made available in grants and loans for specific projects.

FIFA made savings by the forced cancellations of youth tournaments, its annual con-

gress scheduled in Ethiopia. and the annual awards ceremony in Milan.

"Travel was reduced to the of soccer worldwide last year, bare minimum, and a largescale switch to online meetings and training produced significant cost savings," the FIFA financial report said.

staged a remarkable comeback after losing the opening game to notch up a 16-21 21-16 21-19 win over world number five Yamaguchi in a pulsating contest that lasted an hour and 16 minutes to make only her second semifinals appearance at All England on Friday night.

The Indian had come into the match with a 10-7 head-to-head count against the Japanese even though she had lost the last three meetings. So. it was Sindhu's first win in last four meetings with Yamaguchi.

"I am playing against her after quite a long time, I think 2019. We haven't played at all. I'm sure she would have trained very hard. Today's match was a good, tough long match I would say," Sindhu, currently ranked world number seven, said after the

"In the first game I was making a lot of errors and hitting them out because I was on the side with the stronger drift. The second game, it was in my favour. A lot of long rallies. It was important to get that second game.

"In the third game, it was very crucial. My coach was very supportive, he was making sure I controlled the shuttle well. Each point was very important. Overall, it was anybody's game but I am happy to be on the winning side."

treaty protecting women and killing of women is on the rise in Turkey, according to rights groups.

A total of 77 women have been killed since the start of the year, according to the We Will Stop Femicide Platform. At least 409 women were killed in 2020, according to the group.

Turkey was first country to sign the Council of Europe's "Convention on preventing and combating violence against women and domestic violence" at a committee of ministers meeting in Istanbul in 2011.

### **Spectators** from abroad to be barred from Tokyo Olympics Tokyo (AP): Specta-

tors from abroad will be barred from the Tokyo Olympics when they open in four months, the IOC and local organizers said Saturday.

The decision was announced after an online meeting of the International Olympic Committee, the Japanese government, the Tokyo government, the International Paralympic Committee, and local organizers.

The move was expected and rumored for several months. Officials said the risk was too great to admit ticket holders from overseas during a pandemic, an idea strongly opposed by the Japanese public. Japan has attributed about 8,800 deaths to COVID-19 and has controlled the virus better than most countries.

"In order to give claritv to ticket holders living overseas and to enable them to adjust their travel plans at this stage, the parties on the Japanese side have come to the conclusion that they will not be able to enter into Japan at the time of the Olympic and Paralympic Games," the Tokyo organizing committee said in a statement.

About 1 million tickets are reported to have been sold to fans from outside Japan. Organizers have promised refunds, but this will be determined by so-called Authorized Ticket Resellers that handle sales outside Japan. These dealers charge fees of up to 20% above the ticket price. It is not clear if the fees will be refunded.

"We could wait until the very last moment to decide, except for the spectators," said Seiko Hashimoto, the president of the organizing committee. "They have to secure accommodations and flights. So we have to decide early otherwise we will cause a lot of inconvenience from them. I know this is a very tough issue."

IOC President Thomas Bach called it a "difficult decision."

"We have to take decisions that may need sacrifice from everybody," he said. The financial burden of lost ticket sales falls on Japan. The local organizing committee budget called from \$800 million income from ticket sales, the third largest income source in the privately finance budget. Any shortfall in the budget will have to be made up by Japanese government entities.

Overall, Japan is officially spending \$15.4 billion to organize the Olympics. Several government audits say the actual cost may be twice that much. All but \$6.7 billion is public money.

About 4.45 million tickets were sold to Japan residents. Organizers are expected next month to announce the capacity at venues, which will be filled by local residents.

The ban on fans from abroad comes just days before the Olympic torch relay starts Thursday from Fukushima prefecture in northeastern Japan.

# Critics of Brazil's president being targeted by security law

SAO PAULO, MAR 20 (AP): Police in Brazil are starting to employ a dictatorship-era national security law against critics of President Jair Bolsonaro, while lawyers and activists rally to provide them with legal help and accuse the government of trying to silence dissent.

On Friday, demonstrators challenged police in the capital by parading with anti-Bolsonaro signs a day after four protesters were detained. They had called the president genocidal for his handling of the coronavirus pandemic and displayed a cartoon depicting him as a Nazi. Officers took no action Friday as about 40 people protested for an

The national security law, which dates from 1983, near the end of the country's military dictatorship, makes it a crime to harm the heads of the three branches of government or expose them to danger. The vague measure has recently been used to detain or investigate Bolsonaro critics.

Geography teacher Katia Garcia said she showed up in front of the president's office Friday because the arrests had inspired her.

They were jailed because the description genocidal' suits our president very well, Garcia said, wearing a face mask and face shield. He has contributed to our health care system collapsing, for the lack of vaccines. Police can't si-

There have been previous news-making charges against prominent critics of the president, including a newspaper



columnist, a political cartoonist and a popular YouTube star, but the law is increasingly being employed against ordinary citizens. Courts haven't upheld any of the arrests so far, but lawyers are expressing alarm that the tactic is becoming commonplace.

Both demonstrations in Brasilia called for Bolsonaro's impeachment due to his administration's alleged failings in the pandemic, which has caused almost 290,000 deaths in Brazil. The country has reported nearly 3,000 deaths each day this week.

On several instances, the president has complained that he is being unfairly vilified, most recently Thursday night during a live Facebook broadcast.

They call me a dictator. I want you to point at one thing I did in two years and two months that was autocratic, he said while complaining about a newspaper column that used the word genocidal to describe him.

Brasilia police said Thursday that the four detained protesters violated the national security law as they showed a Swastika in association to the symbol of the president of the Republic. But Brazil's federal police force, which decides whether cases brought by local police deserve to go ahead in national security crimes, dismissed the case and released three of the four demonstrators. One was held on an outstanding warrant from a previous case.

Federal police have conducted more than 80 investigations under the security law during Bolsonaro's first two years, and more than 10 in the first 45 days of 2021, according to the newspaper O Globo. The yearly average before the conservative leader took office was 11.

The cases appear to almost entirely target Bolsonaro's critics, human rights organizations and activists say. One case last year involved

On Monday, police invoked the national security law to force Felipe Neto, a popular YouTuber, to give testimony after he referred to Bolsonaro as "genocidal" in one of his broadcasts. Federal police dismissed the case two days later amid a public outcry.

Neto, who was named by Time magazine lasts year as one of the world's 100 most influential people, was also targeted in November with allegations of corrupting minors. Those charges were also dropped.

From the start, I knew that this attempt at intimidation was not aimed at scaring me. It was to scare the Brazilian people, Neto told The Associated Press by phone.

I have means to defend myself, but most teachers, journalists and members of civil society do not, added Neto, who this week set up a legal defense fund to help anyone who faces similar charges for criticizing Bolsonaro and needs an attorney.

O Globo said in an editorial Friday that the spirit of the national security law runs counter to Brazil's constitution in the promotion of civil liberties.

The national security Gomes said the federal police law should be revoked and replaced by a more modern tool that is capable of reconciliating the protection of the rule of law and the respect to individual rights, the newspaper said. Among those are the full and essential freedom of speech.

# Striking Myanmar rail workers move out as protests continue

MANDALAY, MYANMAR (AP): Residents of Myanmar's second-biggest city helped striking railway workers move out of their state-supplied housing Saturday after the authorities said they would have to leave if they kept supporting the protest movement against last month's military coup.

Mandalay residents carried the workers' furniture and other household items to trucks, van and pickup trucks.

The state railway workers last month went on strike as key and early supporters of the civil disobedience movement against the Feb. 1 coup that toppled the elected government of Aung San Suu Kyi. The military regime has sought to force them back to work through intimidation, which included a nighttime, gun-firing patrol last month through their housing area in Mandalay and a raid in the railway workers' housing area in Yangon.

Protests against the coup continued Saturday in cities and town across the country, including in Mandalay and Yangon.

The coup reversed years of slow progress toward democracy in Myanmar after five decades of military rule. In the face of persistent strikes and protests against the takeover, the junta has responded with an increasingly violent crackdown and efforts to severely limit the information reaching the outside world.

Internet access has been severely restricted, private newspapers have been barred from publishing, and protesters,



journalists and politicians have been arrested in large numbers.

The independent Assistance Association for Political Prisoners has verified 235 deaths and has said the actual total — including ones where verification has been difficult —"is likely much higher." It said it has confirmed that 2,330 people have been arrested or charged since the coup, with 1,980 still detained or remaining charged.

In addition to using lethal force to try to break up demonstrations, the security forces have been carrying out a campaign of harassment, stealing from homes they raid, said the group, which also charged that security forces have used people they arrested as human shields as they sought to break up demonstrations.

Numerous reports on social media, including videos, have shown security forces vandalizing cars parked on the street.

The U.N. agencies UNICEF and UNESCO, along with the private humanitarian group Save the Children, on Friday

issued a statement criticizing the occupation of education facilities across Myanmar by security forces as a serious violation of children's rights. It said security forces have reportedly occupied more than 60 schools and university campuses in 13 states and regions. "It will exacerbate the

learning crisis for almost 12 million children and youth in Myanmar, which was already under tremendous pressure as a result of the COVID-19 pandemic and ensuing widespread school closures," said the statement. "Save the Children, UNESCO and UNICEF call on security forces to vacate occupied premises immediately and ensure that schools and educational facilities are not used by military or security personnel.

"Schools must be not used by security forces under any circumstances," it declared.

Calls for international action to halt the violence continue to mount. "The junta can't de-

drews, the U.N.'s dependent expert on human rights for Myanmar, wrote on Twitter on Friday. "Desperate, it launches ruthless attacks to provoke a violent response to try and justify even more violence. It's not working. The world must respond by cutting their access to money & weapons. Now." Unexpectedly strong statements were issued Friday by two of Myanmar's fellow countries in the 10-member Association of Southeast Asian Nations.

Indonesian President Joko Widodo urged a halt to violence and asked other regional leaders to hold a summit on the crisis.

Widodo's move came after ASEAN foreign ministers held a March 2 meeting that reached no consensus on the crisis.

Malaysia's Prime Minister Muhyiddin Yassin issued a statement supporting Widodo's call for as ASEAN summit, saying he was "appalled by the persistent use of lethal violence against unarmed civilians which has resulted in a high number of deaths and injuries, as well as suffer-

ISLAMABAD, MAR 20 (PTI): Pakistan on Saturday recorded its highest single-day increase in the coronavirus infections this year with 3,876 new cases as the positivity rate reached 9.4 per cent in the country.

The national tally of cases reached 623,135 while the death toll 40 patients died in the last 24 hours, the health ministry said. The data showed that 579,760 people recovered so far but some 2,122 were in a critical condition.

The Sindh province reported majority 262,796 cases, followed by Punjab with 195,087 Khyber-Pakh-


abad 50,843, Balochistan 19,306, Pakistan-occupied Kashmir 11,483 and Gilgit-Baltistan 4,967 cases. Islamabad Deputy Commissioner Hamza Shafqaat tweeted that 747 new coronavirus cases were detected in the capital on Friday, the highest number of daily jumped to 13,799 as infections ever recorded in the city.
