### Modi, Shah are a drag on Indian democracy: Sibal

New Delhi, Jan 21 (PTI): Congress leader Kapil Sibal on Tuesday said the nationwide protests against the amended citizenship law reflected that Prime Minister Narendra Modi and Union Home Minister Amit Shah were a "drag on Indian democracy".

Sibal's comments come after the International Monetary Fund (IMF) had on Monday lowered India's economic growth estimate for the current fiscal to 4.8 per cent and listed the much-lowcountry's er-than-expected GDP numbers as the single-biggest drag on its global growth forecast for two years.

"IMF lowers India's GDP for 2019 to 4.8%. Calls it a drag on the world economy," Sibal tweeted.

"Protests of people, young and old, across India (who can't be recognised by the clothes they wear) Reflect that the duo Modiji and Amit Shah are a drag on Indian Democracy," the Congress leader added.

Ahead of the start of the World Economic Forum (WEF) annual summit in Davos, Switzerland, India-born IMF chief economist Gita Gopinath had said growth in the country slowed sharply owing to stress in the non-bank financial sector and weak rural income growth.

India's growth is estimated at 4.8 per cent in 2019, projected to improve to 5.8 per cent in 2020 and 6.5 percent in 2021 (1.2 and 0.9 percentage point lower than in the October WEO), supported by monetary and fiscal stimulus as well as subdued oil prices, the IMF said.

SC seeks response of Centre, EC on plea seeking stay on electoral bond scheme

New Delhi, Jan 20 (PTI): The Supreme Court on Monday sought response of the Centre and the Election Commission on a plea seeking stay on the electoral bond scheme meant for funding political parties.

The top court, however, refused to grant an interim stay on the electoral bond scheme.

A bench comprising Chief Justice S A Bobde and justices B R Gavai and Surya Kant asked the Centre and the Election Commission to file their responses within two weeks to the interim application filed by NGO 'Association for Democratic Reforms' for staying the scheme.

### POLITICAL SECY TO CM HOLDS UP SIKKIM STATE PUBLIC SERVICES ACT TO CLAIM PROPRIETY

oming under fire on Cthe appointment of a non-local as an OSD to the Chief Minister, political secretary to the CM, Jacob Khaling, today rejected the allegations as "unfounded and utterly misleading."

While there was some mild criticism when Prof Mahendra P Lama was appointed the Chief Economic Advisor to the CM last year, the latest round of condemnations appears to have gained some traction at least on social media platforms.

Interestingly, even this appointment appears to have been made at around the same time as Prof Lama but word about it got out only recently. It is being claimed that one Sunil Saroagi was appointed OSD to the CM in July last year but most people learned of it only recently, and almost immediately strong condemnations come from some quarters ruing that this violation of Rule 4/4 which protects jobs in Sikkim for locals comes from a party which had assured local protection and had

made much noise against a similar appointment under the previous government.

Responding to these criticisms in his capacity as the Political Secretary to the CM, Mr Khaling, in a social media post today refuted the allegations in the strongest terms and demanded that "such mischief of leveling false charges against a constitutionally elected government for political gains should not be entertained nor encouraged and should be refuted our intellectuals,

civil societies and the Press faternity as it obvious that the entire allegations are politically motivated and intended to defame the new Government."

While confirming the appointment, Mr Khaling claims that to claim that these were in violation of Rule 4/4 was "immature, untrue and misleading."

"Both the appointments were made keeping in mind the state government rules for employment and the role they were required to play in the national arena." he states.

Mr Saroagi's appointment, he informs, was made under powers conferred by Sub-section (1) of Section 3 of the Sikkim State Public Services Act 2006 which allows the State Government to "from time to time employ such person whom it may consider suitable to render advisory or other similar services in connection with the af-

fairs of the state." Mr Khaling quotes this rule to claim that the appointment was hence "very much legal and in no manner violates any other Rule or Act enforced in the state."

He goes on to add that Mr Saroagi's appointment was on "purely honorary basis" and since he was not eligible for salary or other facilities accorded to a State Govt employee, he cannot be considered a State Govt employee and therefore his appointment cannot be termed as a violation to Rule 4/4.

### Cong joins condemnation of non-local being appointed OSD to the CM

Cikkim Pradesh Con-**S**gress Committee [SPCC] president, Bharat Basnet, has strongly condemned the appointment of Sunil Saraogi as Officer on Special Duty [OSD] to the Chief Minister. Contending that the appointment, given that Mr Saraogi is a non-local, was a direct violation of the Old Laws of Sikkim in general and Rule 4(4) in particular, he demanded that the State government immediately repeal its appointment order.

Addressing a press conference here today, the SPCC president alleged that the Sikkim Krantikari Morcha government has been working against promises made before the elections.

He pointed out that SKM had promised a Local Protection Act but was now working against Congress party also strongly condemns such a work culture manifesting in the state government and expressed hope that the State government will correct its mistakes.

Mr Basnet pointed out that SKM, when in the opposition, had launched a strong campaign against the appointment of Anita Gupta as an OSD in the Capacity

## SC to hear pleas challenging CAA on Wednesday

New Delhi, Jan 21 (PTI): The Supreme Court is scheduled to hear on Wednesday a batch of pleas seeking to examine the constitutional validity of the Citizenship (Amendment) Act (CAA).

A bench, comprising Chief Justice S A Bobde and Justices S Abdul Nazeer and Sanjiv Khanna, which had issued notice to the Centre on various pleas is likely to hear 132 petitions, including those filed by the Indian Union Muslim League (IUML) and Congress leader Jairam Ramesh.

CAA seeks to grant citizenship to non-Muslim migrants belonging to Hindu, Sikh, Buddhist, Christian, Jain and Parsi communities who came to the country from Pakistan, Bangladesh and Afghanistan on or before December 31, 2014.

Some of the petitions filed later have also sought a stay on the operation of the legislation which came into force on January 10. The apex court had on January 9 refused to entertain



a plea seeking that the CAA be declared constitutional, saying the country is going through difficult times and there is so much violence that endeavour should be for peace.

IUML said in its plea that CAA violates the fundamental Right to Equality and intends to grant citizenship to a section of illegal immigrants by making an exclusion on the basis of religion.

President Ram Nath Kovind

gave assent to the Citizenship (Amendment) Bill, 2019 on December 12, turning it into an Act.

IUML seeks an interim stay on the operation of CAA and the Foreigner Amendment (Order), 2015 and Passport (Entry Into Rules), Amendment Rules, 2015.

The petition had alleged that the government's CAA was against the basic structure of the Constitution and intended to explicitly discriminate against Muslims as the Act extended benefits only to Hindus, Sikhs, Buddhists, Jains, Parsis and Christians.

The plea filed by Congress leader Jairam Ramesh, said the Act is a "brazen attack" on core fundamental rights envisaged under the Constitution and treats "equals as unequal".

### Heroin worth Rs 105 crore seized in Kolkata

KOLKATA, JAN 21 (PTI): In one of the biggest drug seizures in the East in recent history, the Kolkata Police on Tuesday arrested two persons with 25 kilogram of heroin worth more than Rs 105 crore in the international market, a senior officer said.

Acting on a tip-off, the Special Task Force of the Kolkata Police raided a house in Paikpara area in the northern part of the city in the early hours of Tuesday and nabbed Ut- ing to mix the heroin tar Pradesh-based drug with some other drugs. dealer Juber and his accomplice from Manipur, Moulana Fayazuddin, the officer said.

"We have seized heroin weighing 25.255 kg. This is one of the biggest seizures of heroin not only in Kolkata but also in West Bengal and the

Northeast," he said. Preliminary investigation revealed that while Juber was working as a hawker in the city, Faiyazuddin was an agricultural labourer. Both the accused were drug carriers for dealers based in Uttar Pradesh and the Northeast. Juber possessed 20 kg heroin and Faiyazuddin 5.255, the officer said.

"It is suspected that the accused were intend-They were planning to distribute them to smaller dealers," he said.

Both the accused have been booked under the Narcotic Drugs and Psychotropic Substances Act, 1985 and an investigation is on, the officer added.

# Despite protests, CAA will not be withdrawn: Amit Shah

LUCKNOW, JAN 21 (PTI): Attacking the opposi-"misleading" tion for people on the Citizenship Amendment Act, Union Home Minister Amit Shah on Tuesday said the law will not be scrapped despite the protests over it.

Addressing a rally here in support of the CAA, Shah also declared that the construction of a Ram temple touching the skies in Ayodhya will begin within three

The minister accused the Congress of not implementing the suggestions that came from its own leaders in the past on granting citizenship to minority Hindus in Pakistan, Bangladesh (then East Pakistan) and Afghanistan after Partition.

He also targeted West Bengal chief minister and Trinamool Congress leader Mamata Banerjee, saying she is now opposing Indian citizenship for Dalit Bengalis.

At the same meeting, Uttar Pradesh Chief Minister Yogi Adityanath alleged that the Congress is shelling out money for arson and protests over the CAA.

Amit Shah said there is no provision in the amended law for taking anyone's citizenship away. A canard is being spread against the CAA by the Congress, SP, BSP, and Trinamool Congress

The CAA is a law to grant citizenship, he added.

I want to say that irrespective of the protests it will not be withdrawn," he added. Shah challenged op-

position leaders to hold a discussion with him on the CAA at a public forum.

He named Congress leader Rahul Gandhi, Samajwadi Party's Akhilesh Yadav, Bahujan Samaj Party's Mayawati and TMC chief Mamata Banerjee while throwing the challenge.

"If any clause of the CAA takes away the citizenship of anyone, including Muslims, they can tell me. The agitations and sit-ins, which are being organised in the country against it, are wrong," he said.

"The Congress has become blind due to vote bank politics," he said, and also blamed the party for Partition.

"Rahul baba open your ears and listen carefully. Because of the sins of your party in 1947, the country's partition on religious basis was accepted. Mentioning figures, he said the proportion of Hindus, Sikhs, Buddhists and Jains in Pakistan and Bangladesh dropped drastically after Partition.

"Where have they gone? They were either killed, converted or came to India as refugees. These blind people cannot see that atrocities were committed on crores of people," he said.

Shah asked opposition parties where they were when crores of people were killed in Pakistan, Afghanistan and Bangladesh on the basis of religion. He said

five lakh Pandits were displaced from Kashmir, but these parties did not utter a word.

Now, because of PM Modi, a new chapter has begun in the lives of these people," he said.

Shah referred to the recent Supreme Court verdict that allows the construction of a Ram temple at the disputed Ayodhya site. The crowd cheered when he said the construction will begin in three months.

Accusing the opposition of speaking the language of Pakistan prime minister Imran Khan, the BJP leader said, "I don't know what relation they have with Khan."

Shah claimed that Mahatma Gandhi, Jawaharlal Nehru, Sardar Patel and Indira Gandhi

advocated citizenship to Hindus from Pakistan but their Congress party never implemented the suggestion.

On Mamata Banerjee, he charged, "She was demanding citizenship for Dalit Bengalis. Now when the citizenship is being given to them, she has problems."

Shah claimed that during the Rajasthan assembly elections, the Congress had advocated citizenship to Hindus from Pakistan.

The CAA allows easier citizenship for Hindus, Sikhs, Buddhists, Christians, Parsis and Jains who entered India from three neighbouring countries before 2015 after facing religious persecution. Muslim migrants don't figure on this list.

### No mention of chancellor in CU concovation invite

KOLKATA, JAN 21 (PTI): Amid the ongoing rift between the Mamata Banerjee dispensation and Governor Jagdeep Dhankhar, the Calcutta University, in a departure from its tradition, has issued its annual convocation card with no mention of a chief guest or chancellor.

A week ago, state education minister Partha Chatterjee had said that the programme, this year, might be held without Dhankhar, who is also the university chancellor, in the wake of his "consistent" attacks on the TMC government.

According to sources, the varsity, for the first time in recent memory, did not name any chief guest or chair in its invite for annual convocation, scheduled to be held on January 28 at state-run Nazrul Manch.

In the past few years, CU had invited its chancellor as chief guest for

the ceremony.

"The vice-chancellor and the (university) senate request your gracious presence at Annual Convocation of the University of Calcutta," the invitation card said.

During its senate meeting last month, CU had declared that Nobel laureate Abhijit Vinayak Banerjee will be conferred with the honorary D Litt (honoris causa) during its convocation ceremony.

Despite multiple attempts, Vice-Chancellor Sonali Chakraborty did not respond to calls or reply to Whatsapp messages by PTI.

Last month, TMC employees' union had blocked Dhankhar's entry into Jadavpur University (JU), where he had gone to attend its annual convocation. The governor had said "Universities are in captivity... caged by the state government.

### Pall of gloom envelops Kerala as 8 tourists die in Nepal

THIRUVANANTHAPURAM/ KOZHIKODE, JAN 21 (PTI): A pall of gloom enveloped the neighbourhood of the two couples, who died along with their four minor children at a resort in Nepal on Tuesday.

They were part of a 15-member group from Kerala to Pokhara, a popular mountainous tourist destination.

The deceased were identified as Prabin Kumar Nayar (39), Sharanya (34), Ranjit Kumar TB (39), Indu Ranjit (34), Shree Bhadra (9), Abinab Soraya (9), Abi Nayar (7), and Baishnab Ranjit (2), The Kathmandu Post report said. Both IT professionals, Prabin Kumar Nair and Ranjit were engineering college classmates and friends and the tour was arranged after a get-together with old friends in Delhi, a family member said.

Prabin, who hails from Chempazhanthi in Thiruvananthapuram, was an engineer in Dubai, while his wife, Sharanya, was staying at Kochi along with 3 children and is a nursing student.

A neighbour said Prabin and family had visited their home here where his aged parents

are staying, during the Onam festival in September last year and were active in all functions.

A family friend said Prabin's parents were only told that they had met with an accident.

"We have not told them about the tragedy that had befallen." he told television channels.

Ranjit was working in an IT firm at Thiruvananthapuram, while his wife, Indu, an accountant in a cooperative bank at Kozhikode, a family member said. Ranjit's elder son Madhav had a lucky escape as he was sleeping in another room.

Expressing shock over the tragedy, Kerala tourism minister Kadakampally Surendran said the government has given directions to the state DGP to get in touch with the Nepal police and take necessary steps. "Also talked to union minister V Muraleedharan over phone. He ensured all necessary intervention to bring the mortal remains to the state as early as possible,"

According to media reports, the Indian tourists died after they fell unconscious due to a possible gas leak in their room at a resort in Nepal.

### Woman IPS officer assaulted, molested by AR rifleman in Manipur



IMPHAL, JAN 21 (PTI): A woman IPS officer has alleged that a rifleman of Assam Rifles physically assaulted and molested her at a check post near Moreh town in Manipur's Tengnoupal district, police said on Tuesday.

Based on a written complaint of the IPS officer, an FIR has been registered against rifleman P K Pandey and a summon has been issued to him to appear before the concerned police station, the police said.

Manipur DGP L M Khaute told reporters on Monday, "We have made contacts with the Assam Rifles authorities. A complaint has been lodged by the officer."

In her complaint, the IPS officer said that on reaching Khudengtabi check post on Sunday afternoon one of her escorts, who was not in uniform, told the frisking party of Assam Rifles to register their entry.

Despite showing their identity cards, the rifleman allegedly detained them, she said.

"We offered to search ourselves and the vehicle, but he was not interested", she said.

The rifleman began hitting the official vehicle and "misbehaved, humiliated, harassed and assaulted me and my escort personnel," she alleged.

The IPS officer also alleged that the rifleman molested her and when her escorts tried to intervene, he thrashed them.

She further accused the rifleman of making "sexually coloured" remarks against her, using abusive language and even tried to snatch her phone when she tried to call her senior officers.

The issue brought under control after the matter was reported to the Brigadier of 26th Assam Rifles and the Major of the D-company of 12th AR, police said.

### Action against IIT-G students for supporting teacher who raised graft charges

GUWAHATI, JAN 21 (PTI): The IIT-Guwahati has initiated disciplinary proceedings against nine students for organising a protest march and a hunger strike in support of a faculty member who was given "compulsory retirement" for raising several corruption charges against the institute.

Issuing notices to the students on Monday, the Assistant Registrar of Students' Affairs of the Indian Institute of Technology-Guwahati asked them to appear before a committee on Wednesday.

"As directed, you are advised to attend an SDC meeting to be held in the office of the Dean of Students' Affairs on 22.01.2020 at 5 PM (in connection with Protest March by students on 17.11.2019 and recent hunger strike) where your presence disposition is considered necessary," an email to the students said.

Vikrant Singh, one of the students who was served the notice, shot back a reply stating that protest is a constitutional right of every citizen and "as such, calling an SDC (students' disciplinary committee) for peaceful protest is against the law of the land and also contempt of the court".

Students at the IIT-G

have been protesting against the disciplinary action taken against Brijesh Kumar Rai, an Assistant Professor of **Electrical and Electronics** Engineering Department, after he raised corruption charges against the administration and filed hundreds of RTIs.

Rai was

given

"compulsory retirement" through an IIT-G order on January 1 for his "misconduct" alleged on three counts -- an altercation with a fellow faculty member, writing an email to ISRO without maintaining the official protocol and a complaint in January 2018 by his department head alleging dereliction of duty.

Protesting against this order, Singh along with another student Himanchal Singh sat on an indefinite hunger strike from January 4 and they were admitted to the Gauhati Medical College and Hospital after three days when their condition deteriorated.

Immediately they began the hunger strike, IIT-G Director T G Sitharam wrote a mail to the duo and warned them of action for "interfering disciplinary the proceedings" against Rai.

"You both (students) not supposed interfere in the disciplinary proceedings followed through diligent process, failing which violation of student code of conduct as well as institute code will be applicable to you both," he said. On November 17 last year, hundreds of students took out a candlelight march inside the campus in support of Rai and against any possible disciplinary

action against him. Meanwhile, approached the Gauhati High Court on Monday and sought a stay order "compulsory on his retirement".

Rai joined the IIT-G in 2011 and has been raising questions over "irregularities" on the campus.

"I noticed various of corruption kinds taking place on the campus. When I started asking about them, the authority became vindictive... So far, I have filed around 200 RTI applications about various IITs, the MHRD and other educationrelated centres since 2015," Rai told PTI.

The IIT-G clarified its position on the corruption charges by Rai by uploading a statement on its official website and described accusations as "baseless, unverified and his own assumptions" and said he filed "unnecessary" RTI applications.



# Tobacco, the Ignored Challenge

### We speak of teenage smoking here

Anew academic session is about to begin, and the time right to initiate some discussion on issues concerning students. Today, we speak of tobacco use in the present instance.

The Global Youth Tobacco Survey [GYTS] conducted a survey among students in the 13 to 15 years age-group in Sikkim in the year 2001 covering students from grade VIII to X. Yes, the statistics are now 19 years old, but it would be safe to venture that not much has changed on ground because let's also accept it that Sikkim has not really done much to address the situation beyond pushing smoking away from public places. If anything, like with the rest of the country, the prevalence of teenage smoking would have increased in Sikkim as well.

Further, the age-group we are speaking of here was not really smoking in public to begin with any way. The survey was a first of its kind for India and maybe it is time for another round of such a data collection exercise. But that would have required Sikkim to have done benefitted from the statistics collated back in 2001.

Did it?

The findings should have scared every parent, invoked institutions to address the situation and convinced policy-makers to get real about the task of arresting the trend. Nearly two decades since and a follow-up survey later, tobacco use among the barely teens in Sikkim does not even figure significantly in the social or health sector interventions here. The disinterest is inexcusable because the data is disturbing.

The GYTS survey of 2001 revealed that 55% of students in the 13 to 15 age-group consumed some form of tobacco - while 18% smoked cigarettes, 38% used other forms of tobacco like Gutka. A huge prospective bank of chemically dependent is being groomed, and worryingly, there is no concerted effort underway to wean the young away from tobacco and nothing effective on the field to prevent more to enter their teens with a taste for tobacco. Agreed, the sale of Gutka and even paan masalas is banned, but it's no secret that these can still be procured. There are laws against smoking in public places or selling tobacco products to minors, but save some select public spaces, the former is lightly monitored and no one has really bothered with the latter provision with any consistency. With this data, the worrying absence of social involvement and people's initiatives in Sikkim gets reinforced. Tobacco use among the young is not a challenge that governments can surmount, this, like most other aspects of social conduct, this needs the initiative and involvement of the people and people's groups.

Why are so many of the young turning to tobacco? An obvious reason is because they are in an age when they experiment and are trying out tobacco because they can do so easily. Then there is peer pressure which converts still more and from there on it's a snowball effect. The GYTS data reveals that 70% of the tobacco users among the surveyed teens lived in homes where others smoked. It can thus be safely vouched that they also ran errands for the smokers in the family like fetching cigarettes from the neighbourhood dokan. It was only a matter of time before they siphon away one stick for themselves. There are two things wrong in this picture- one, it suggests that smoking is okay since children can be sent to buy cigarettes, and two, despite a standing law against selling cigarettes to minors, parents and elders themselves compromise its implementation. National statistics reveal that 56.2% of the minors who bought cigarettes from a shop were not refused purchase because of their age. This number would be even higher in Sikkim where one has never seen a teen being turned away. What is also worrying is that one in four smokers in the 13 to 15 years age-band wants to quit, but doesn't know how and don't know where to access help. The national data reveals that 95% of the smokers never received help to quit smoking even though 67% of the teen smokers want to quit and 67% actually tried on their own! More than 70% of these young smokers know the harmful effects of smoking, and yet, as the data reveals, most remain hooked. We are messing up too much with very young minds with our indifference.

# Academics Can Change the World – if they stop talking only to their peers

Research and creative thinking can change the world. This means that academics have enormous power. But, as academics Asit Biswas and Julian Kirchherr have warned, the overwhelming majority are not shaping today's public debates.

Instead, their work is largely sitting in academic journals that are read almost exclusively by their peers. Biswas and Kirchherr estimate that an average journal article is "read completely by no more than ten people". They write:

"Up to 1.5 million peer-reviewed articles are published annually. However, many are ignored even within scientific communities – 82% of articles published in humanities [journals] are not even cited once."

This suggests that a lot of great thinking and many potentially world altering ideas are not getting into the public domain. Why, then, are academics not doing more to share their work with the broader public?

The answer appears to be threefold: a narrow idea of what academics should or shouldn't do; a lack of incentives from universities or governments; and a lack of training in the art of explaining complex concepts to a lay audience.

#### THE 'INTELLECTUAL MISSION'

Some academics insist that it's not their job to write for the general public. They suggest that doing so would mean they're "abandoning their mission as intellectuals". They don't want to feel like they're "dumbing down" complex thinking and arguments.

The counter argument is that academics can't operate in isolation from the world's very real problems

They may be producing important ideas and innovations that could help people understand and perhaps even begin to address issues like climate change, conflict, food insecurity and disease. **NO INCENTIVES** 

Universities also don't do a great deal to encourage academics to step beyond lecture halls and laboratories. There are globally very few institutions that offer incentives to their academics to write in the popular media, appear on TV or radio, or share their research findings and opinions with the public via these platforms.

In South Africa, where I conduct research and teach, incentives are limited to more "formal" publication methods. Individual institutions and the Department of Higher Education and Training offer rewards for publishing books, book chapters, monographs or articles in accredited, peer-reviewed journals.

The department pays universities more than R100,000 per full publication unit – for example, one journal article. These funds are given to universities, which then use their own subsidy disbursement schemes to split the funds between the institution, the faculty in which the author works and the author. In some cases, academics receive more funding for articles published in international journals than in local journals.

Catriona Macleod of Rhodes University in South Africa has argued that these financial incentives are an example of the "commodification of research" and that this is "bad for scholarship". Macleod told University World News:

"The incentive system is a blunt instrument that serves the purposes of increasing university income rather than supporting scholarship and knowledge production in South Africa."

There is nothing in the department's policy that urges academics to share their research beyond academic spaces. There's no suggestion that public outreach or engagement is valued. And this situation is not unique to South Africa: the "publish or perish" culture is a reality at universities all over the world.

Academics have no choice but to go along with

this system. Their careers and promotions depend almost entirely on their journal publication record, so why even consider engaging with the general public? **LEARNING TO WRITE** 

There is a third factor holding academics back from writing for broader lay audiences: even if they'd like to, they may not know where to start and how to do it.

Writing an article for an academic journal is a very different process to penning one for those outside the academy. Naomi Wolf and Sacha Kopp, in an article examining the issue, wrote:

"Academic writing has the benefit of scholarly rigour, full documentation and original thinking. But the transmission of our ideas is routinely hampered ... by a great deal of peer-oriented jargon."

Universities have a role to play here by offering workshops and courses to their academics and students. This can help develop creative non-fiction writing skills.

#### TIME FOR A CHANGE

Academics need to start playing a more prominent role in society instead of largely remaining observers who write about the world from within ivory towers and publish their findings in journals hidden behind expensive digital paywalls.

Government and university policies need to become more prescriptive in what they expect from academics. Publishing research in peer-reviewed journals is and will remain highly important. But incentives should be added to encourage academics to share their research with the general public.

Doing this sort of work ought to count towards promotions and should yield rewards for both universities and individual academics.

Quality academic research and innovation are crucial. It is equally important, though, to get ideas out into the world beyond academia. It could make a real difference in people's lives.

# The First Step in Managing Plastic Waste is Measuring it – here's how we did it for one Caribbean country

Countries around the world throw away millions of tons of plastic trash every year. Finding ways to manage plastic waste is daunting even for wealthy nations, but for smaller and less-developed countries it can be overwhelming.

We recently carried out a study for the Caribbean island nation of Trinidad and Tobago that applied economic principles to its plastics management challenge. Some of what we did can be used anywhere.

Our backgrounds are in business management and sustainability. Although Trinidad and Tobago is a tiny country whose economy is based on beach tourism and the petroleum industry, and we had relatively little data on plastic production, use and disposal available, we see this as a useful case study. Trinidad and Tobago is not the only place where data is limited or expensive.

Because Trinidad and Tobago's population is just 1.2 million, we were able to look at its complete economy. It belongs to Caricom, the Caribbean Community, a regional organization that includes 16 million people, giving it access to larger markets. And it struggles with the same problems many large countries face: lack of landfill space. The disposal problem is urgent.

PLASTIC ARRIVES AS PACKAGING

The first step to solving any problem is to measure it. This is often challenging for plastics, due to lack of data on where they come from and end up. A major part of our analysis was repurposing trade statistics to make up for limited data.

Material flow analysis helps quantify the flow of products and wastes. This process was developed in the late 1990s by industrial ecologists for waste management. They have applied it to track materials like metals and products like computers at national and international scales.

The analysis combines different kinds of data. It tracks imported or newly manufactured products entering economies to their use and reuse, including recycling, export or disposal in landfills. Academics and government agencies conduct material flow analysis to inform environmental management.

The most surprising finding from our study was that most of the plastic entering the country's landfills – a total of 49,000 tons per year – was not produced or imported. Rather, it entered the country as packaging around imported products. In other words, the largest amount of landfilled plastic "came along for the ride" with other things.

### RECYCLE, BURN OR BAN

Much plastic waste ends up in landfills (or the ocean), but there are better solutions. One is recycling.

One promising finding from our study is that people in Trinidad and

Tobago throw away 26,000 tons of PET plastic bottles every year – enough to make building a domestic recycling facility economically efficient. There is also enough domestic demand for PET bottles to use the plastic that would come from a recycling facility to make more bottles.

A second solution is finding an alternative use for plastic waste. Plastic can be burned for energy, with proper scrubbing and cleaning, as is done in Sweden, where about half of all garbage is burned for energy.

Some companies elsewhere, such as Lehigh Northeast Cement Co. in Glens Falls, New York, are starting to burn plastic as a fuel in cement plants. Cement production is energy intensive, and plastic can substitute for a large portion of the fossil fuels used. Trinidad and Tobago has a cement plant of sufficient size to burn around 29,000 tons of plastic waste.

Whether this option would work depends on whether there are other uses for the plastic and how much plastic the cement plant there would take. There are economic motivations to find out: Using waste plastic can increase profits at cement plants while reducing the amount of plastic going into landfills by roughly 30%.

A third solution is banning some plastic items. We determined that a ban on ubiquitous polystyrene shopping bags could reduce plastic waste in Trinidad and Tobago by 2,000 tons per year. Along with several oth-

er Caricom countries, Trinidad and Tobago has banned the use of these bags and other single-use plastics starting Jan. 1, 2020.

### MEASURING THE FLOW OF PLASTIC: A UNIVERSAL SOLUTION

While these results are specific to Trinidad and Tobago, material flow analysis can be used in any country. This approach clarifies the real outcome of efforts to manage plastic. For example, it showed us that banning single-use plastic bags and plastic straws could be worthwhile, but should be part of a larger strategy that identifies and manages larger sources of waste plastic.

This kind of analysis does not have to be be expensive. Our study was based on publicly available data on imports and exports, manufacturing, and waste flows into landfills. Our results, although incomplete, were sufficient to spotlight workable solutions.

The main barriers to using material flow analysis are awareness and expertise. The method is not yet widely known, and relatively few people have been trained to do it. But in a globalized world, where huge quantities of goods and materials are constantly moving across borders, it is a valuable tool for tackling urgent waste management challenges.

### Efforts on to make Tripura model state: CM

AGARTALA, JAN 21 (PTI): Chief Minister Biplab Kumar Deb on Tuesday said a lot remained to be done to address the developmental challenges, but efforts were on to make Tripura a model state.

Deb, on the occasion of Tripura's 48th State-hood Day, said his government would strive hard to make the state economically self-reliant.

"Tripura had attained statehood on Jan 21, 1972, but we are yet to fulfill many aspirations of people. We strive to make Tripura a model state in the country in terms of development," Deb said on the occasion.

Since the BJP-IPFT dispensation came to power 23 months ago, revenue collections have increased 26% from 8.9%, the state achieved 100 per cent electrification and eradicated malaria, Deb said, enlisting his government's accomplishments.

The state, in an attempt to ensure transparency, introduced e-tendering system for procuring goods and services and distributed gas cylinders to at least 91 per cent of the households, as part of the Centre's Ujjwala Yojana, the chief minister claimed.

The CM also said that the Centre has sanctioned Rs 8000 crore for widening of National Highways in the state, the work for which is underway.

"Tripura now has access to Chittagong port in Bangladesh. The government is constructing a four-lane bridge over Feni river in Sabroom subdivision will reduce the distance between the state and Chittagong port to just about 70 km," he explained.

Prime Minister Narendra Modi, earlier in the day, greeted the people of Manipur, Meghalaya and Tripura on their Statehood Day and hailed the traditions and culture of the three northeast states. On this day in 1972, all the three states became full-fledged states under the North Eastern Region (Reorganisation) Act, 1971.

# Irrawaddy Dolphins sighted in new areas of Chilika lake

**BHUBANESWAR, JAN 21 (PTI):** A large number of endangered Irrawaddy Dolphins were sighted in new areas of the Chilika lake, the largest brackish water lagoon in the country, officials said.

The total dolphins sighted during the annual census on Sunday was 146, said Susant Nanda, the Chief Executive Officer of Chilika Development Authority.

He said the good news is that the dolphins are now sighted in new areas like the central and southern sector of the lagoon which is spread over 1,165 square kilometre in three districts of Khurda, Puri and Ganjam.

"The areas near Kalijai island and Rambha are new places where the dolphins for the first



time have been sighted. Earlier, they were mostly confined to Satpada area near Brahmagiri," the official said the dolphin population in the lake is now stabilizing above 150 as expected.

"We are also optimistic about an increase in dolphin population in


the lake in next couple of years," Nanda said, adding that there are enough sign of dolphins migrating from Satpada side to other areas within the lake.

Apart from Satpada, dolphins have been this time sighted in five other places, three places around Kalijai island within the lake and two sites close to Samal, he said.

Wildlife experts opine that the dolphins sighting in new areas is possible due to clearing of prawn gheries from within the lake.

Apart from the annual census, the CDA used to undertake dolphin counting by using hydrophones. Last years census says that there were 151 dolphins in Chilika.

In the hydrophone method, a microphone is used to record or listen to underwater sound. This method of counting has indicated that the highest 20 to 25 number of dolphins are found near Rajhans island followed by Magarmukh and Malatikuda, 17 to 20 each.



### Prince Harry leaves UK to rejoin Meghan and Archie in Canada: reports

LONDON, JAN 21 (AFP): Prince Harry left the UK to rejoin his wife Meghan and son Archie in Canada Monday, British media reported, as the couple start a new life after their shock exit from the royal fold.

"The Duke of Sussex is understood to have left the UK for Canada on Monday evening following one of his final official engagements as a working royal," Britain's Daily Telegraph newspaper reported.

Harry boarded a 5.30 pm flight to Vancouver from London's Heathrow airport, the Sun tabloid said, and is expected to be reunited with his wife and son in Canada -- where the couple are expected to make their home -- on Tuesday.

"His departure for Canada will be deemed symbolic, coming just two days after Buckingham Palace announced that it was severing all official ties with the Sussexes as they walk away from public life," the Telegraph said.

Earlier, Queen Elizabeth II's grandson, who remains sixth in line to the throne, attended the UK-Africa Investment Summit in London, seeming in good spirits as he met the presidents of Malawi and Mozambique, and the Moroccan prime minister.

He also had an in-20-minute formal private meeting with British Prime Minister Boris Johnson, who hosted the event.

Harry skipped a summit dinner for visiting African leaders at Buckingham Palace in order not to overshadow his brother William's hosting of the event, the Daily Mail reported.

Harry and his wife Meghan -- currently known as the Duke and Duchess of Sussex -- are bowing out entirely from representing the British monarchy, in a crisis that has shaken the centuries-old institution.

He said on Sunday night they did not want to quit their royal duties but reluctantly accepted there was "no other option" if they wanted to cut loose from public funding and seek their own income in pursuit of a more independent life.

# For Manchester United the gulf to Liverpool is cause for major concern

LONDON, 21 JAN [THEGUARDIAN]: Liverpool are brilliant. They are top of the league by 16 points with a game in hand and will probably have the title wrapped up by the end of March. And yet at the same time, while acknowledging how preposterous it is to offer any criticism of a side that has taken 64 points from 22 games this season, there must be a sense that of late they've become a little bit sloppy.

In their past two league games, against Tottenham last week and then against Manchester United at Anfield on Sunday, they have come extremely close to drawing games they have dominated almost entirelv. Giovani Lo Celso and Anthony Martial both missed extremely presentable chances to make it 1-1. In both games Liverpool ended up under pressure in the final 10 minutes on Sunday at least until Mohamed Salah added a second on the break deep in injury time. Tottenham they had broadly held at arm's length, in a performance of great control; United they had pummelled for roughly a third of each half. And yet in each two points could have slipped from their grasp.

Not that it really matters to Liverpool, of course, for anything other than the pursuit of records. At this stage their lead is unassailable and would be even if it were only 12 points. Perhaps that fallibility offers a note of caution before the Champions League knockouts, where a single goal carelessly conceded can have profound consequences. But actually the greater impact of the past two games may be for the losing sides. Those late rallies perhaps conjured the impression that all is not



too far awry. But for United in particular, the gulf to Liverpool should be cause for major concern.

This was 2-0 going on 5-1. Liverpool's opening goal may have come slightly against the run of play but, in the 20 minutes that followed, United were overwhelmed. It was the same story in the 12 minutes of the second half from kick-off to Fred's chance. In both spells Liverpool were quicker, sharper, stronger and cleverer. In both they could have scored two or three times without it seeming outrageous. There were goals ruled out for marginal decisions, the woodwork was struck and Salah somehow scuffed wide from eight yards

with the whole goal at which to aim. Without being anything like the best football they have played this season, that was the level Liverpool can reach when they put their foot down - and it was a level high above United's capacity.

Injuries do not help, of course. United are without their two best central midfielders and their best forward. That would destabilise any side. But then Liverpool had been without their first-choice holding midfielder from the end of November until eight minutes from time on Sunday – and their response to that has been 11 clean sheets in 15 games (and two of the games when they

conceded came within 24 hours of each other). Their first-choice goalkeeper missed 11 games with a calf injury. Good teams with well-constructed squads overcome misfortune; weaker ones wallow in it.

Ole Gunnar Solskjær is becoming a master of discovering filaments of silver lining in the bleakest of clouds. If football management does not work out for him, a job in forensic pathology surely awaits. Here he talked of how well Fred had played, how committed United had been, how they had fought back after the barrage at the beginning of the second half. None of which was untrue and Fred's form over the past couple

of months is arguably the brightest aspect of this season for United.

But there is a bigger picture. This was not quite taking consolation from Manchester City having sufficient respect for United that they picked a strong team against them in the Carabao Cup but it was rhetoric of the mid-table manager trying to draw positives from an entirely predictable defeat against a much better side.

And that is where United stand not in terms of resources or stadium or fanbase or cachet, of course, but in terms of form.

They may lie fifth in the Premier League and the gap to fourth and implausible Champions League qualification may be only five points but from their 34 points from 23 games one can extrapolate that to 56 for the season. That would have been enough for fifth in 2003-04 but every other season in the past 20 years it would leave United seventh, eighth or ninth. It is eight points fewer than they got in their first post-Ferguson season, when David Moyes was sacked four games from the end of the season.

There is an understandable willingness for Solskjær to succeed and the manager is not the only problem, perhaps not even the biggest problem, at Old Trafford. Patience, without question, is a rare virtue in football but it does not take much for the search for positives to become a hunt for excuses. United have just been well beaten by a Liverpool side 30 points ahead of them and the message seems to be that they should be grateful it was not worse. United are sleepwalking towards mediocrity: somebody, some time, is going to have to wake them up.

### Djokovic thanks Ivanisevic tips after flurry of aces



MELBOURNE, JAN 21 (AFP): Defending champion Novak Diokovic said he had been taking tips from serving maestro Goran Ivanisevic after he hammered down a series of aces in his first-up win at the Australian Open.

Djokovic smacked 14 aces and had a first-serve percentage of 65 per cent in his grinding 7-6 (7/5)6-2 2-6 6-1 win over Germany's Jan-Lennard Struff in round one.

The Serb credited his work with Croatia's Ivanisevic, who served up more than 10,000 aces in his career and joined the 16-time Grand Slam winner's team last year.

"Throughout my career my serve was maybe a little bit underestimated because of the quality of the returns and the baseline play," he told reporters late on Monday.

"There were times I was struggling with an elbow injury and I had to change the technique of my serve and a lot of things were happening, but in the last year-anda-half I feel great serving.

"Obviously I pray to have serving days like I had today all of the time. I know it's not possible but I can back up my serving game from the back of the court."

The 32-year-old came through a mid-match lapse against Struff, the world number 37, and said he was glad to have an early test as he goes for a record-extending eighth Australian Open crown

"Historically I had a lot of success in the Grand Slams where I had a tough opponent in the first round, because it gets me going from the beginning," he said.

"I have to be alert, I have to be on a high level and I think I was. Of course, you can always play better and I expect myself to be better as the tournament progresses.

With US markets closed for a holiday, traders struggled to find fresh catalysts to continue a long-running rally fuelled by the China-US trade pact, lowered Brexit tensions, central bank easing and an improving global outlook.

Hong Kong was the standout on Tuesday, plunging more than two

percent a day after Moody's said it had lowered its rating in a fresh blow to the financial hub, which has likely fallen into recession owing to the unrest as well as the China-US

In a statement, the firm said: "The absence of tangible plans to address either the political or economic and social concerns of the Hong Kong population that have come to the fore in the past nine months may reflect weaker inherent institutional capacity than Moody's had previously assessed."

The move comes as the business community grows increasingly worried that the features that give Hong Kong more political and economic autonomy are weakening under pressure from Beijing.

The decision came four months after a similar move by Fitch, which cited the demonstrations and uncertainty caused by closer integration with the Chinese mainland.

Among other markets, Tokyo ended 0.9 percent lower, while Shanghai, Singapore, Seoul and Manila all sank more than one

Sydney lost 0.2 percent, while Mumbai, Bangkok and Jakarta were also in the red.

- 'A building concern' -

There is a growing unease about the spread of a virus from the Chinese city of Wuhan, which has now claimed four lives and infected more than 200.

The new coronavirus strain has caused alarm because of its connection to Severe Acute Respiratory Syndrome (SARS), which killed nearly 650 people across mainland



China and Hong Kong in 2002-2003.

It also comes as China prepares for the Lunar New Year holiday, which sees hundreds of millions of people travel across the country, with a top scientist at the country's National Health Commission saying the virus has now been found to pass between

The World Health Organization will meet Wednesday to determine whether to declare the outbreak "a public health emergency of international concern" -- a rare designation only used for the gravest epidemics.

Cities across Asia have ramped up their defences, with mandatory screenings at airports of arrivals from high-risk areas of China after cases were reported in Thailand, Japan and South Korea.

AxiCorp analyst Stephen Innes said the latest developments were "a building concern".

"The cost to the global economy can be quite staggering in negative GDP terms if this outbreak reaches epidemic proportions as until this week, the market was underestimating the potential of the flu spreading," he said in a note.

"But it's an essential enough development that the market will continue to monitor on the risk radar, as if things turn critical it could provide a massive blow to the airline industry and a knockout punch to local tourism."

Tourism-linked shares plunged in Hong Kong, with Cathay Pacific losing more than four percent and casino operator Wynn Macau down 4.8 percent.

The nervousness on trading floors saw investors shift out of higher-yielding, riskisafe-haven yen, while gold, another go-to asset in times of uncertainty, was also up.

While there is a general optimism that the world economic slowdown is easing, the International Monetary Fund said in its latest outlook report that it expected global growth to come in slightly weaker than pre-

### **UK to end early release of terror prisoners**

LONDON, JAN 21 (AFP): Britain on Tuesday unveiled plans to end the early release of terrorism prisoners and increase their sentences, following last year's London Bridge attack by convicted terrorist Usman Khan.

The government said it would launch a "major review" of how convicted terrorists are managed in response to the November 29 violence, which saw Khan kill two people before being shot dead by police.

The attack, which occurred during the general election campaign, immediately became highly politicised as Khan had already served timed for terror offences before being released early.

The reforms announced aim to ensure those convicted of serious offences, such as preparing acts of terrorism or directing a terrorist organisation, spend at

least 14 years in prison. They will also force such offenders to serve

their whole sentence behind bars -- rather than be eligible for early release -- and overhaul the terrorist licensing rules.

"The senseless terror attack... in November confronted us with some hard truths about how we deal with terrorist offenders," Home Secretary (interior minister) Priti Patel said in a statement.

"Today we are... giving police and probation officers the resources they need to investigate and track offenders, introducing tougher sentences, and launching major reviews into how offenders are managed after they are released."

Jonathan Hall, the government's independent reviewer of terrorism legislation, will oversee "a sweeping independent review" of the multi-agen-

cy system dealing with terrorism offenders, the statement added. The proposed bill will double the number of probation officers specialising in terrorism prisoners and introduce measures such as polygraph testing.

It will increase the number of places available in probation hostels so officials can keep closer tabs on terrorists in the weeks after their release from prison.

The government said it would also review the support available to victims of terrorism, pledging to invest 500,000 pounds (USD 650,000, 586,000 euros) "to ensure more victims get the support and advice they need, faster".

It will simultaneously increase the counter-terrorism police budget by 90 million pounds to 906 million pounds in the coming financial year.

## Boris Johnson's Brexit bill hits last-minute hiccup



LONDON, IAN 21 (AP): British Prime Minister Boris Johnson's Brexit plans hit a hurdle Monday when Parliament's upper chamber told the government to give European Union citizens living in the UK physical proof of their right to remain after the country leaves the bloc.

The House of Lords voted by 270-229 to amend the government bill that paves the way for Britain's departure from the EU on Jan 31 the first of three votes that went against the government. The amendment

says EU citizens living in Britain should be given a document confirming their right of residence.

At present EU nationals can register online to confirm their settled status, but receive no physical proof.

Liberal Democrat peer Jonny Oates said the lack of a hard document could leave EU residents "severely disadvantaged" in dealings with landlords and other officials.

The House of Lords is debating the government's Withdrawal Agreement Bill, which sets the terms of Britain's departure from the 28-nation EU. It must be passed by both houses of Parliament before Ian 31 if the UK is to leave the EU on schedule and become the first nation ever to quit the bloc.

As well as the vote on EU citizens'rights, the Lords voted for two amendments intended to restrict government powers to ignore European court judgments after Brexit without consulting UK courts first.

Monday's defeats won't stop the bill becoming law, because the House of Commons has already approved it, and the elected lower chamber can overturn decisions by the Lords.

But it means it must return to the Commons later this week rather than automatically becoming law once it's passed by the Lords on Tuesday.

Britain voted nar-

rowly to leave the EU in a 2016 referendum, but as the years went on UK lawmakers repeatedly defeated attempts by both Johnson and predecessor Theresa May to secure backing for their Brexit blueprints.

That changed when Johnson's Conservatives won a strong majority in a parliamentary election last month, giving the government the ability to override the objections of opposition parties.

The European Parliament also must approve the Brexit divorce deal with Britain before Jan 31. A vote is expected next week.

Despite Johnson's repeated promise to get Brexit done on Jan 31, the departure will only mark the start of the first stage of the country's EU exit.

Britain and the EU will then launch into negotiations on their future ties, racing to strike new relationships for trade, security and a host of other areas by the end of 2020.

# Impeachment arguments as seen Democrats,

WASHINGTON, JAN 21 (AP): Legal filings to the Senate have laid out the arguments that will be made in President Donald Trump's impeachment trial, where he faces two distinct allegations of abuse of power and obstruction of Congress.

A look at the main points Democrats are making as they argue for Trump's removal from office, and Trump's response as the defense team pushes for his speedy acquittal.

The GOP arguments have already raised charges of distortion.

Democrats Trump abused the power of his office by urging Ukrainian President Volodymyr Zelenskiy in a July 25 phone call to announce an investigation of political rival Joe Biden and the Democrats. At the time, Trump was withholding hundreds of millions of dollar in military aid to the country.

The sought-after investigation into Biden, as well as into a baseless theory that Ukraine had interfered in the 2016 presidential election, was a solicitation to interfere in U.S. politics and served the political interests of the president rather than the national security interests of America, Democrats say, Trump's lawyers, meanwhile, contend there's no evidence beyond hearsay that the president conditioned the release of aid on Ukraine agreeing to an investigation.

The money was released without any investigations being undertaken and, they say, Zelenskiy didn't even know it had been suspended until shortly before it was released, even though U.S. officials testified to House investigators that Ukraine had inquired about the delay.

The legal team says that Trump had legitimate concerns about corruption in Ukraine and that it was appropriate for him to bring up Biden on the call since his son Hunter sat on the board of a gas company, Burisma, that was suspected of corruption.

Trump has sought, without evidence, to implicate the Bidens in the kind of corruption that has long plagued Ukraine. Hunter Biden served on the board of Burisma at the same time his father was leading the Obama administration's diplomatic dealings with

Though the timing raised concerns among anti-corruption

cates, there has been no evidence of wrongdoing by either the former vice president or his son.

In any event, Trump's lawyers said pauses on foreign aid are neither unusual nor inappropriate, and it's a decision that rests squarely with the commander of chief. Presidents have the right to exert their authority without their political opponents second-guessing their motive or intent, they argue.

The Trump administration obstructed Congress every step of the way during the impeachment investigation, directing witnesses not to testify or turn over documents, according to House Democrats who pointedly note that it is the House and not the White House that gets to determine the scope of a such an inquiry.

They say that witnesses who did choose to come forward, either publicly or privately, endured public statements from the president that appeared aimed at discouraging them from cooperating. And multiple government agencies, including the State and departments, Energy followed the lead of the White House and refused

to turn over documents.

says there's nothing novel about the administration's defiance. The lawyers said close and senior advis-

ers to the president have long been understood to be immune from congressional testimony. On Monday, they pointed to opinions from the Justice Department's Office of Legal Opinion that supported that stance.

The lawyers noted that lawmakers began issuing subpoenas to witnesses even before the full House had formally voted on rules for the impeachment inquiry, something the Justice Department says makes those subpoenas legally unenforceable.

Democrats say the House has the sole power of impeachment, so the process can't be second-guessed by the administration. When White House officials blocked Trump's advisers from testifying or turning over documents, defense lawyers say, they were protecting the prerogative of the presidency and not obstructing an investigation.

The Trump legal team created the mechanism to impeach and remove a president from power. Not only that, they described it in a filing as the framers' worst nightmare. The Constitution sets a standard of Treason, Bribery, or other high Crimes and Misdemeanors" for impeachment, and according to Democrats, it's a flexible enough threshold to reach the full range of potential Presidential misconduct."

Whether the allegations need not amount to crimes is a very significant point of contention. Trump's lawyers state contend that an impeachable offense requires especially egregious conduct that threatens the constitutional order and, specifically, that it requires a violation of established law."

Nothing the president is accused of, they say, comes close to meeting that standard.

And removing Trump from office under these facts would dilute the standards of impeachment, permanently weaken the power of the presidency and allow a hostile House to attack almost any presidential action by challenging a President's subjective motives."
